(57) **CLAIM**

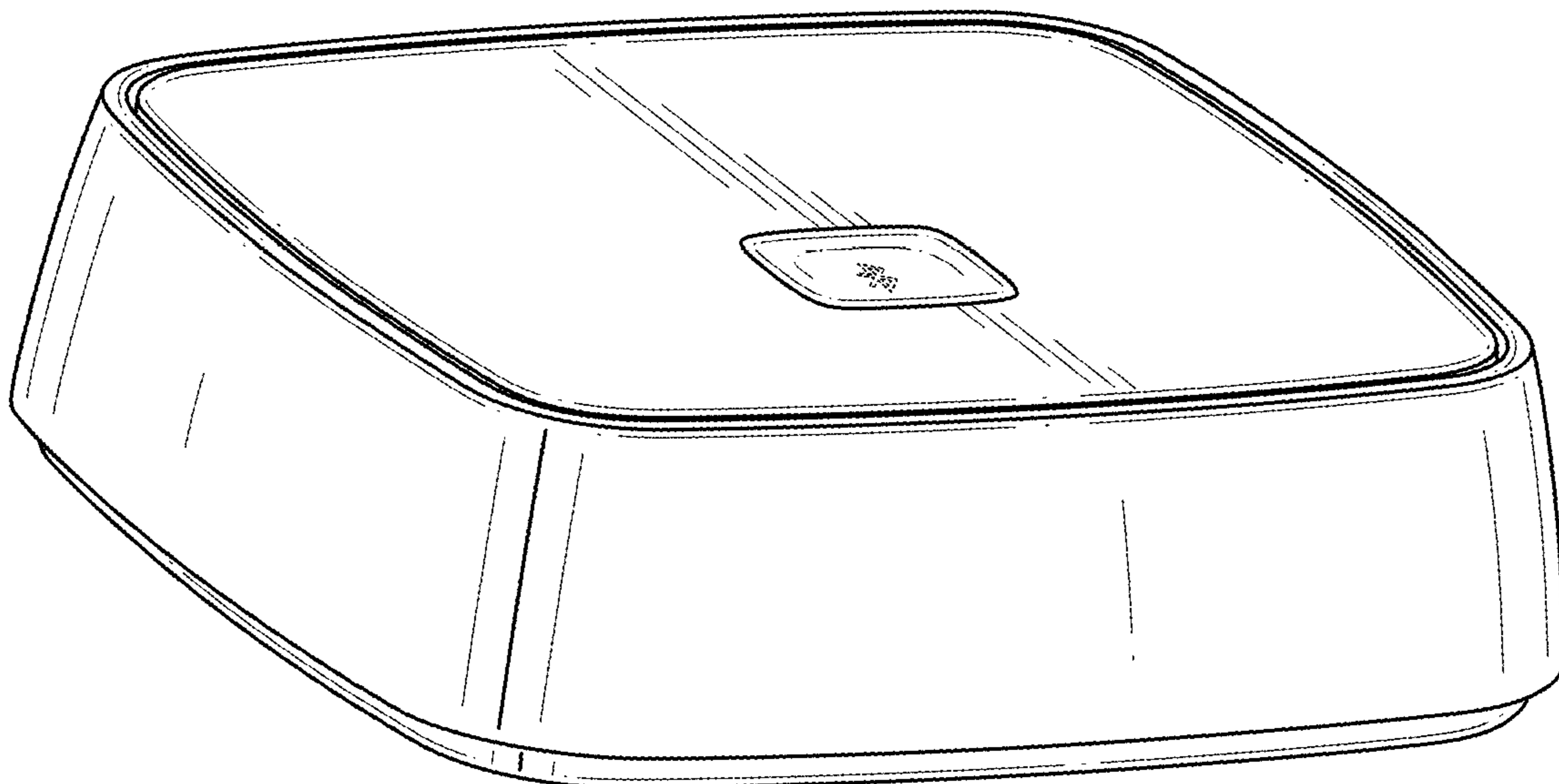
The ornamental design for a wireless audio adapter, substantially as shown and described.

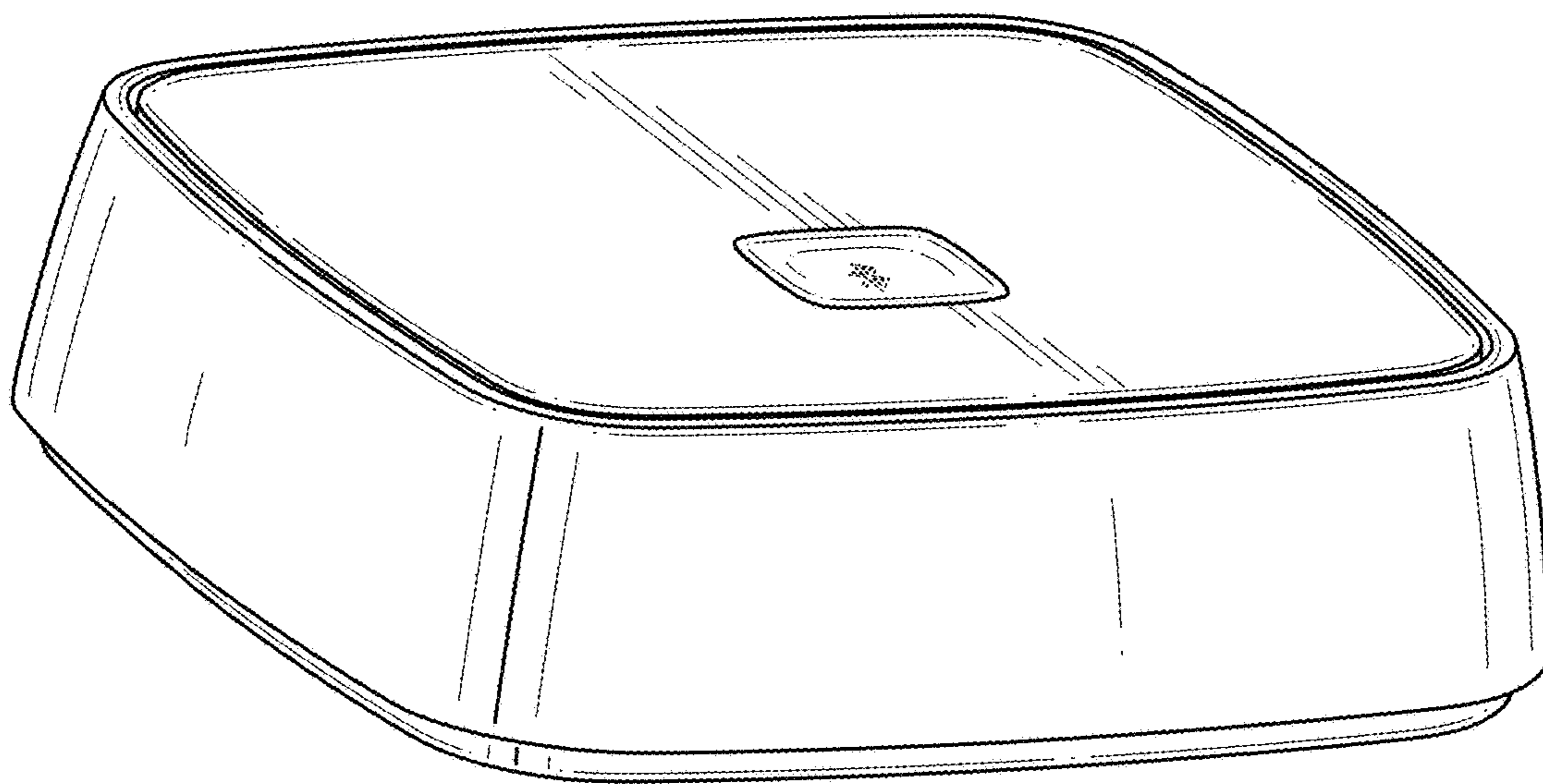

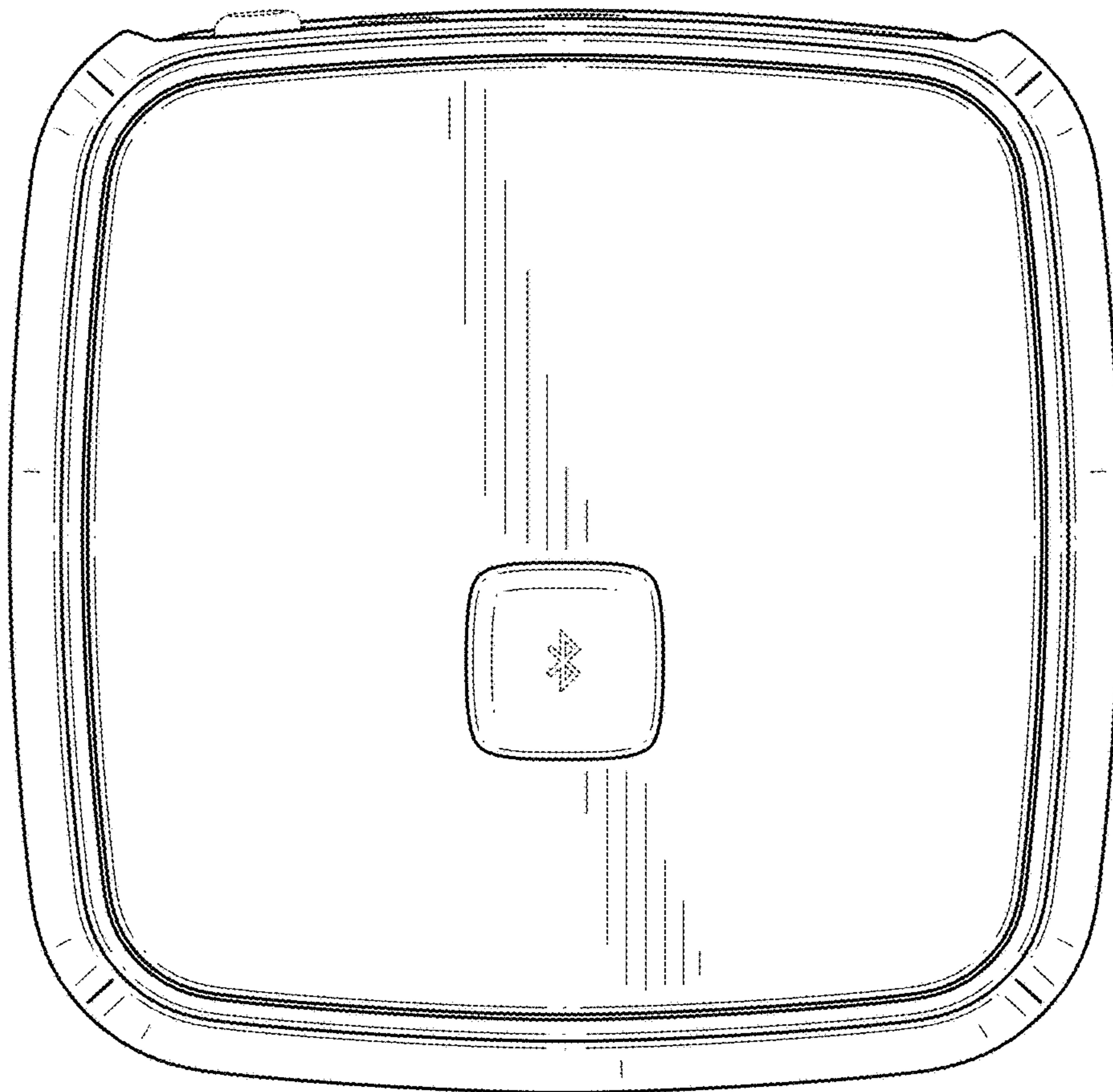

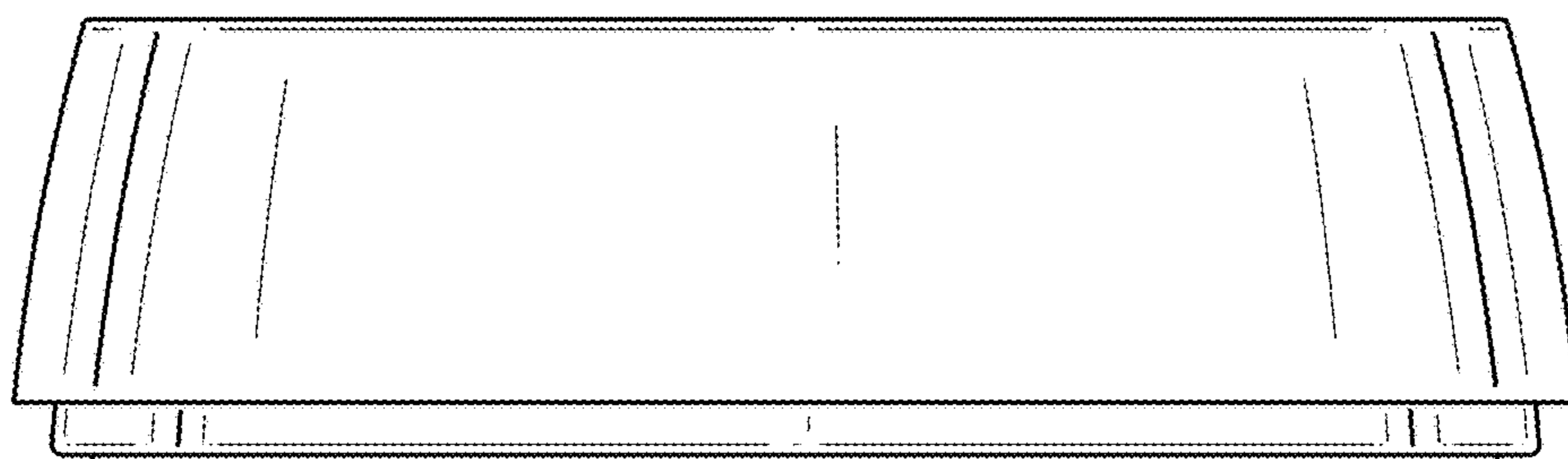

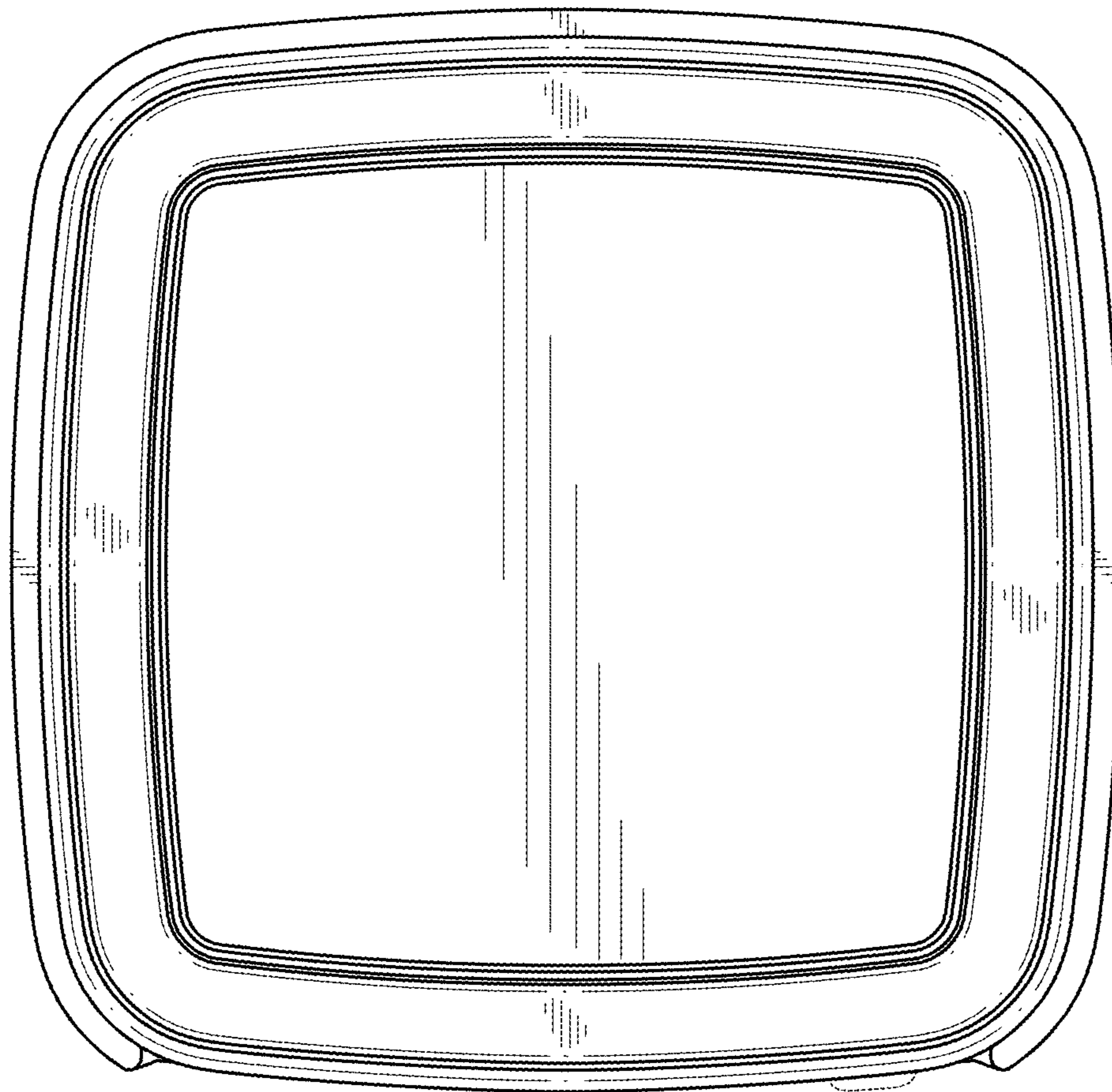

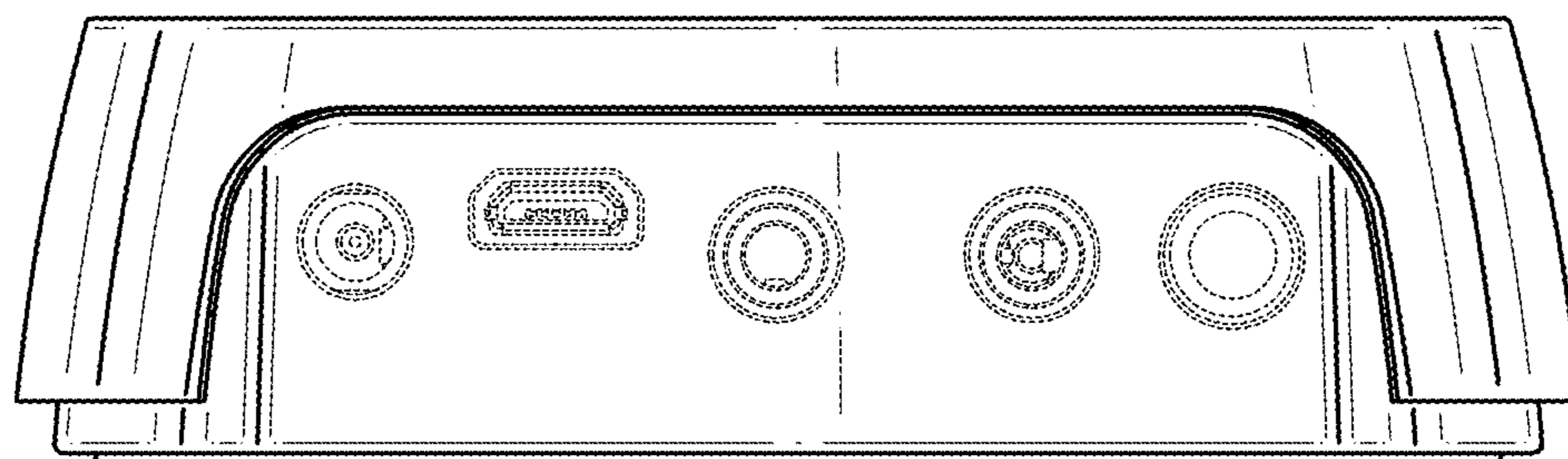

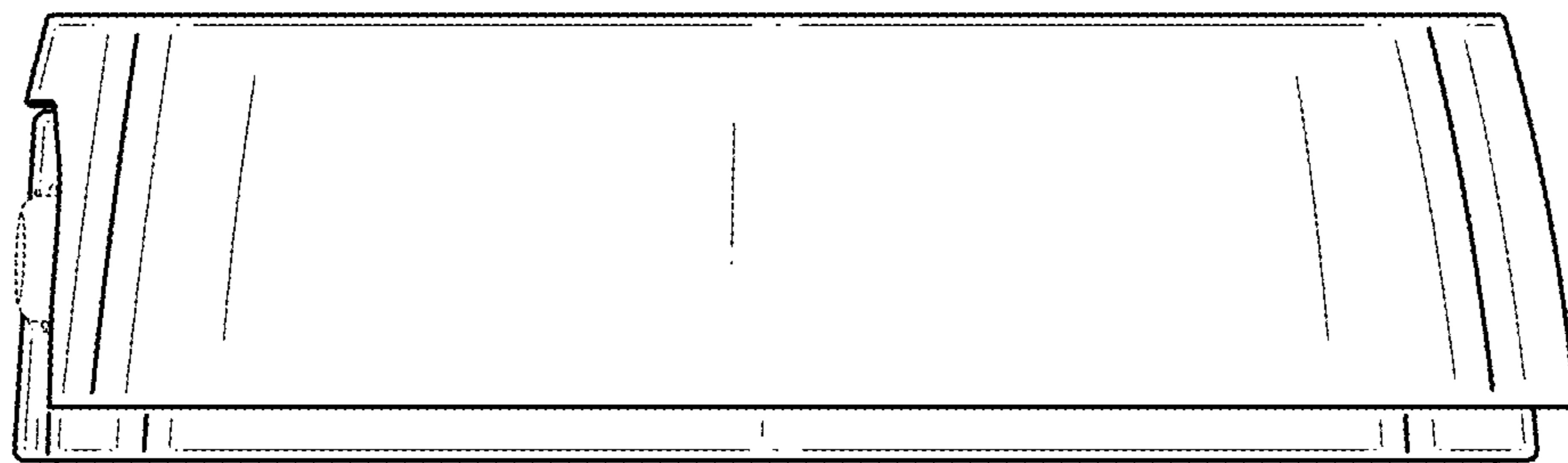

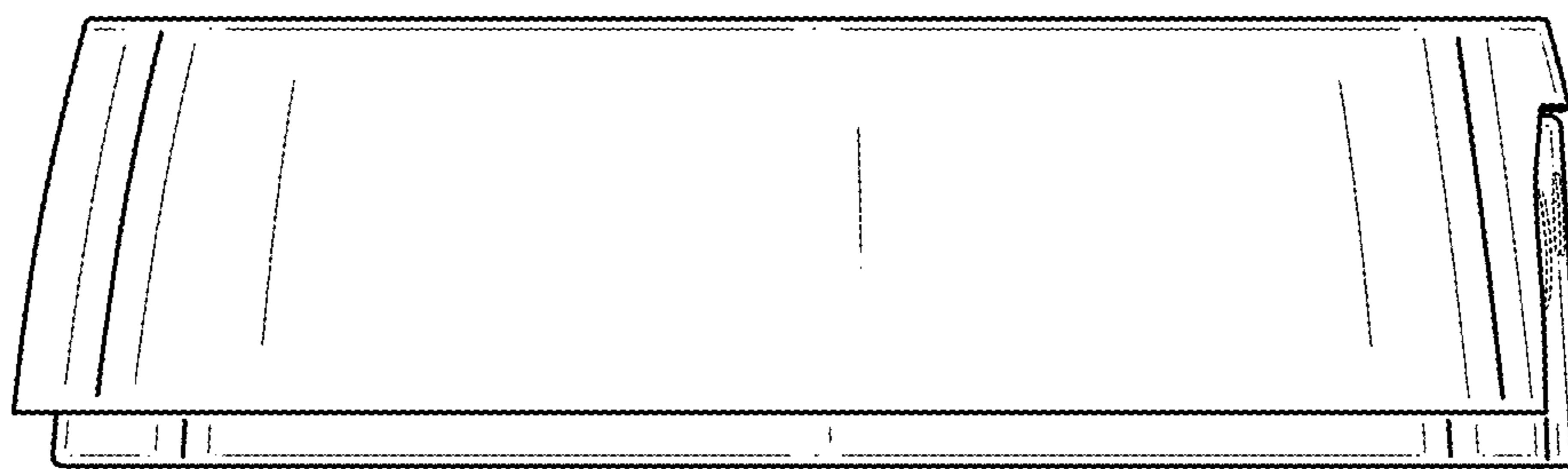
