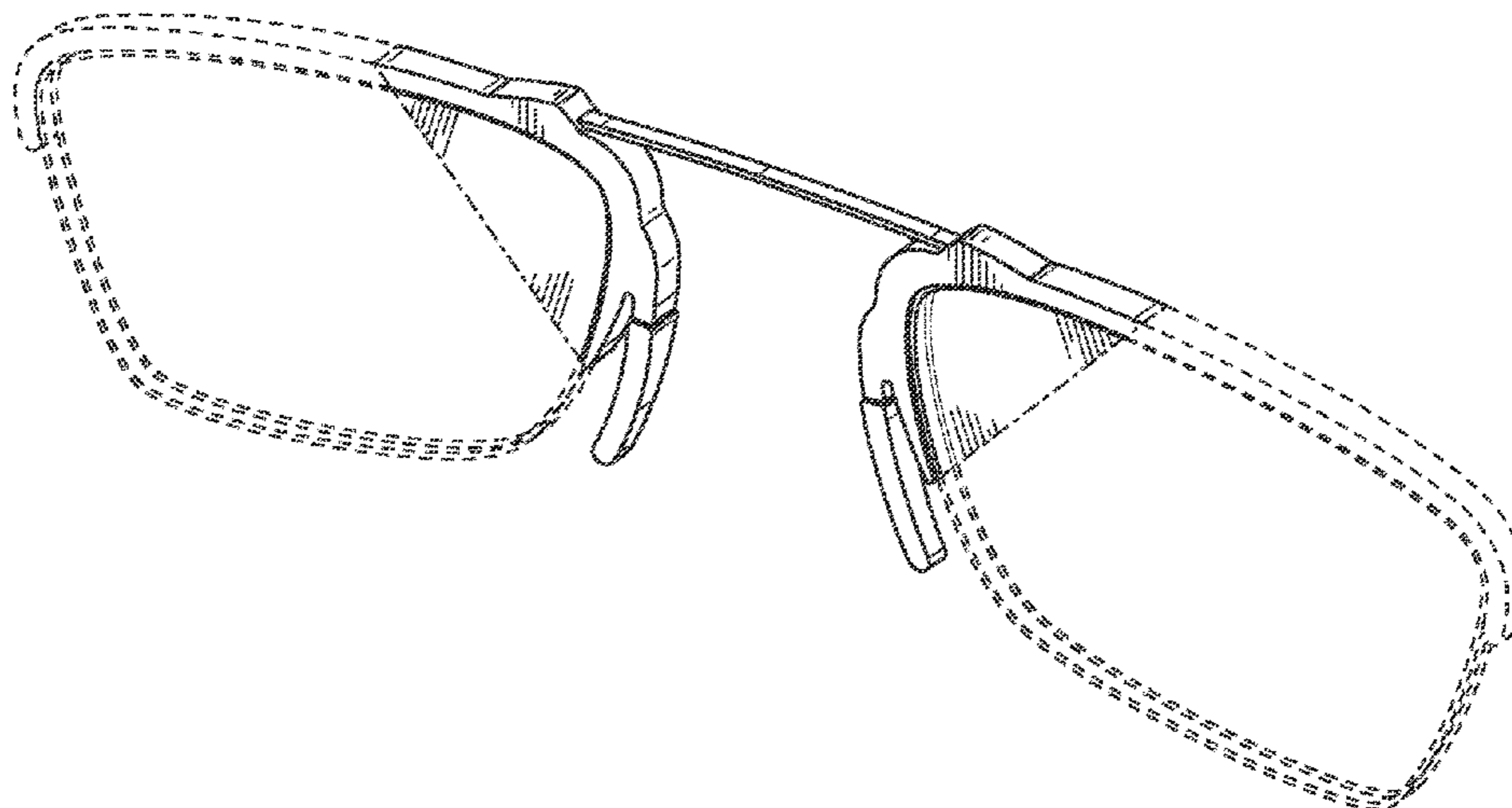

(57) **CLAIM**
The ornamental design for reading glasses, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, top perspective view of reading glasses showing my design therefor;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof.
FIG. 6 is a right side elevational view thereof; and,
FIG. 7 is a left side elevational view thereof.
The broken lines consisting of unevenly sized dashes define the boundary of the claim, which extends to the boundary but does not include the boundary; while the remaining broken line depict portions of the reading glasses form no part of the claim. All broken lines form no part of the claim.

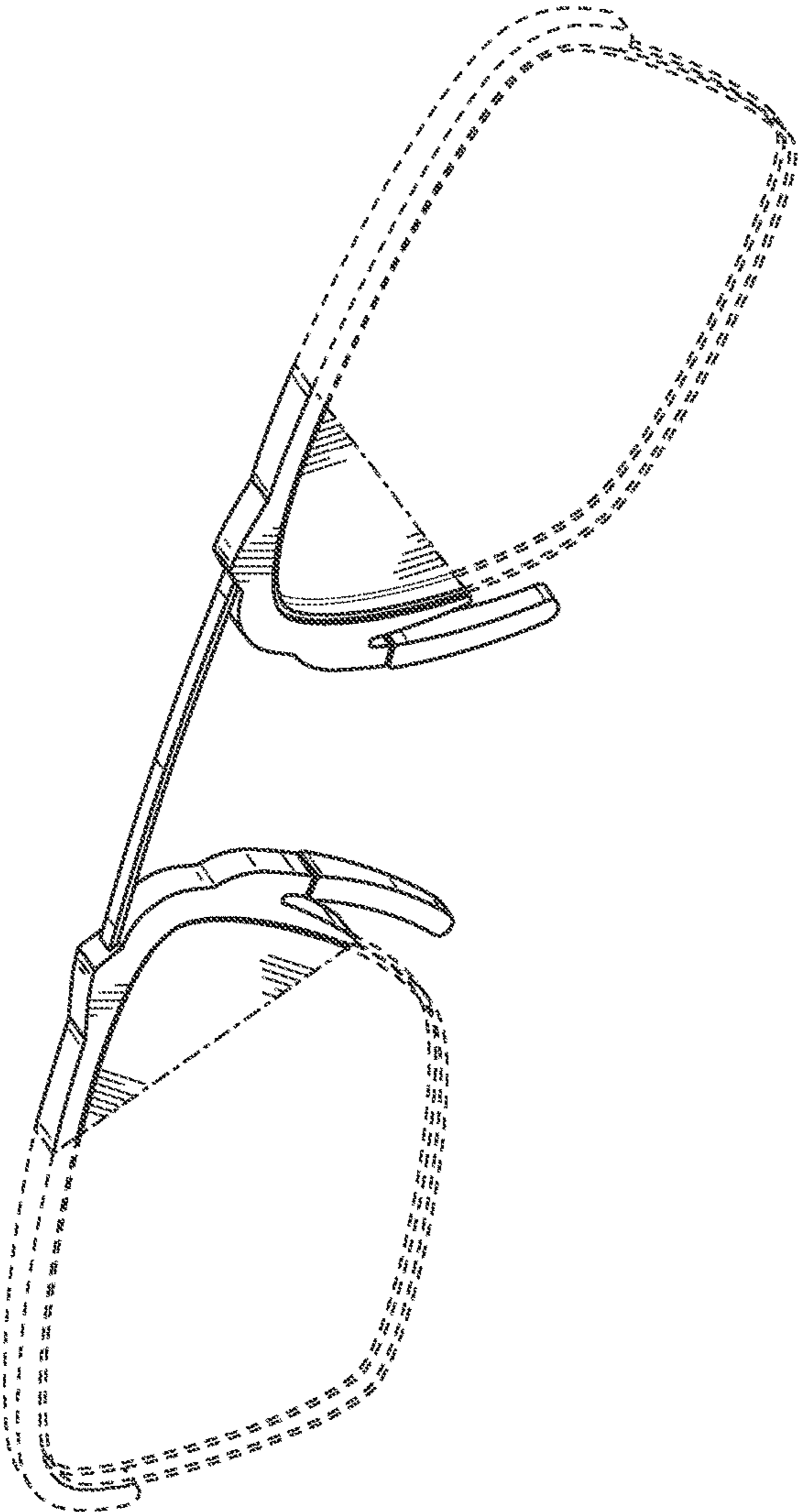

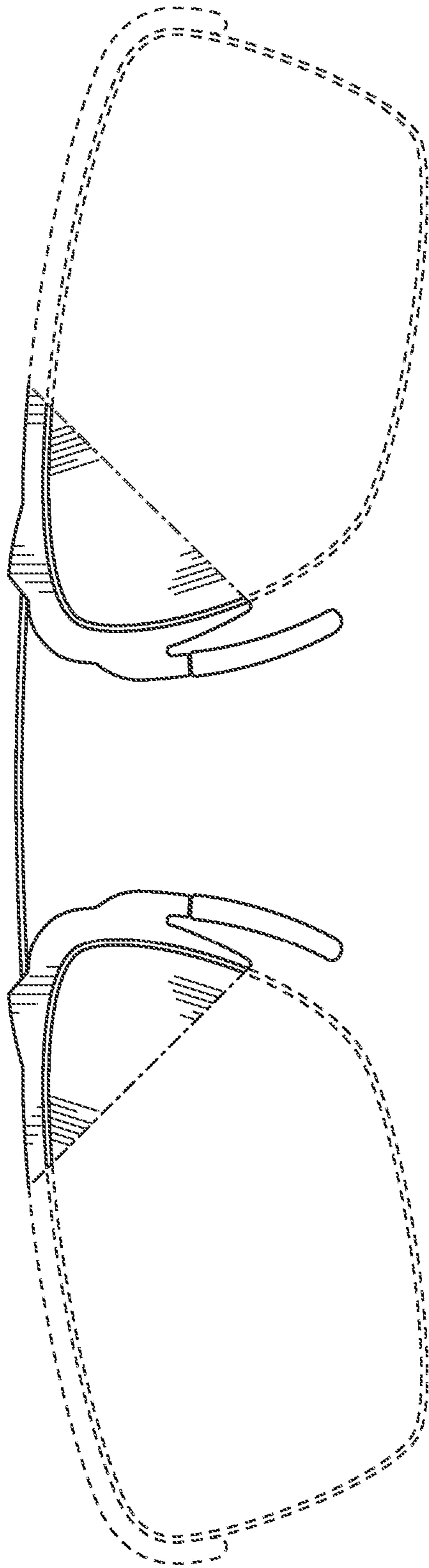

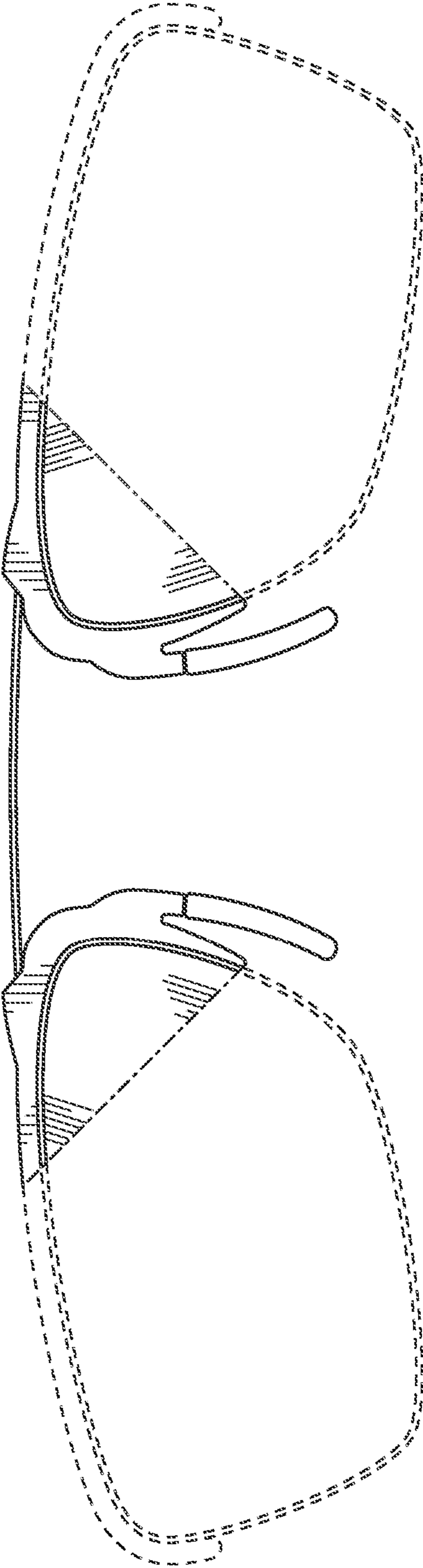

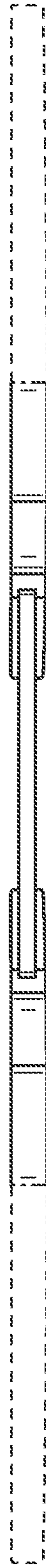

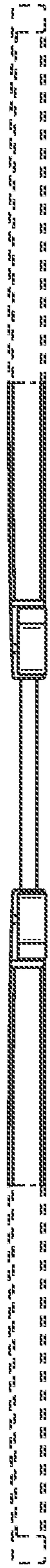

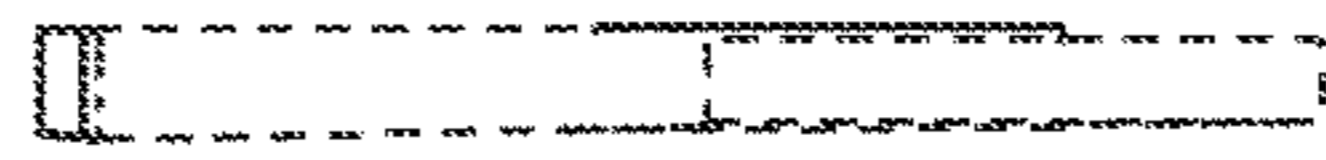

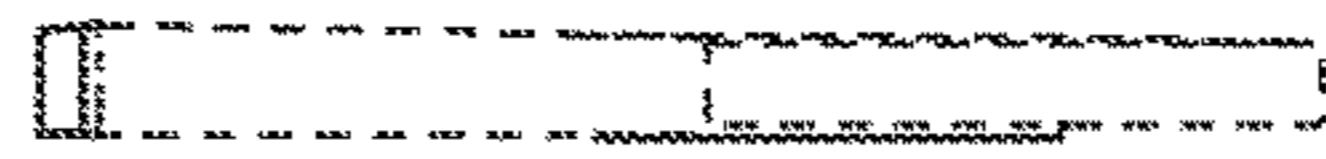
