The ornamental design for business stationery with cut-out, substantially as shown and described.

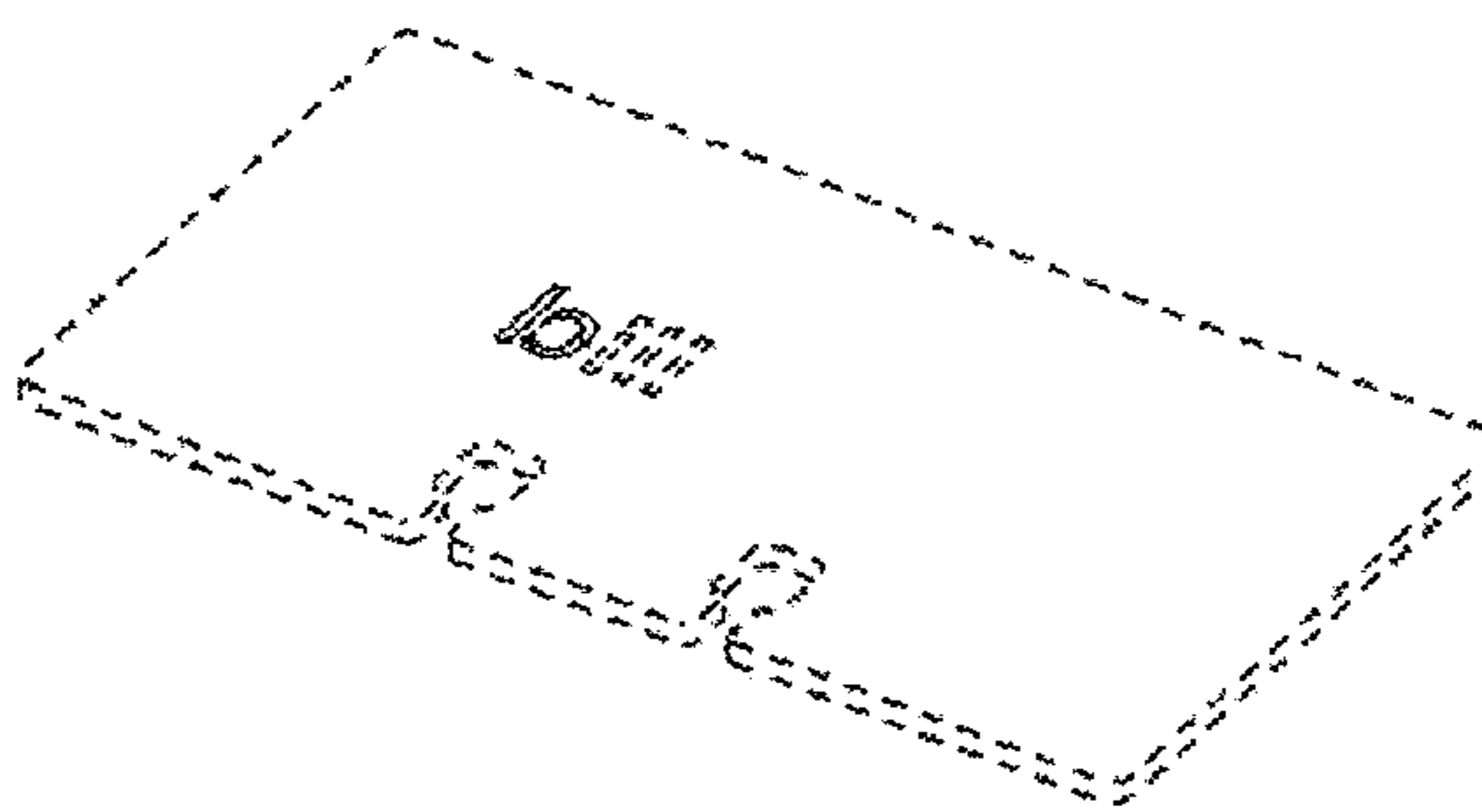
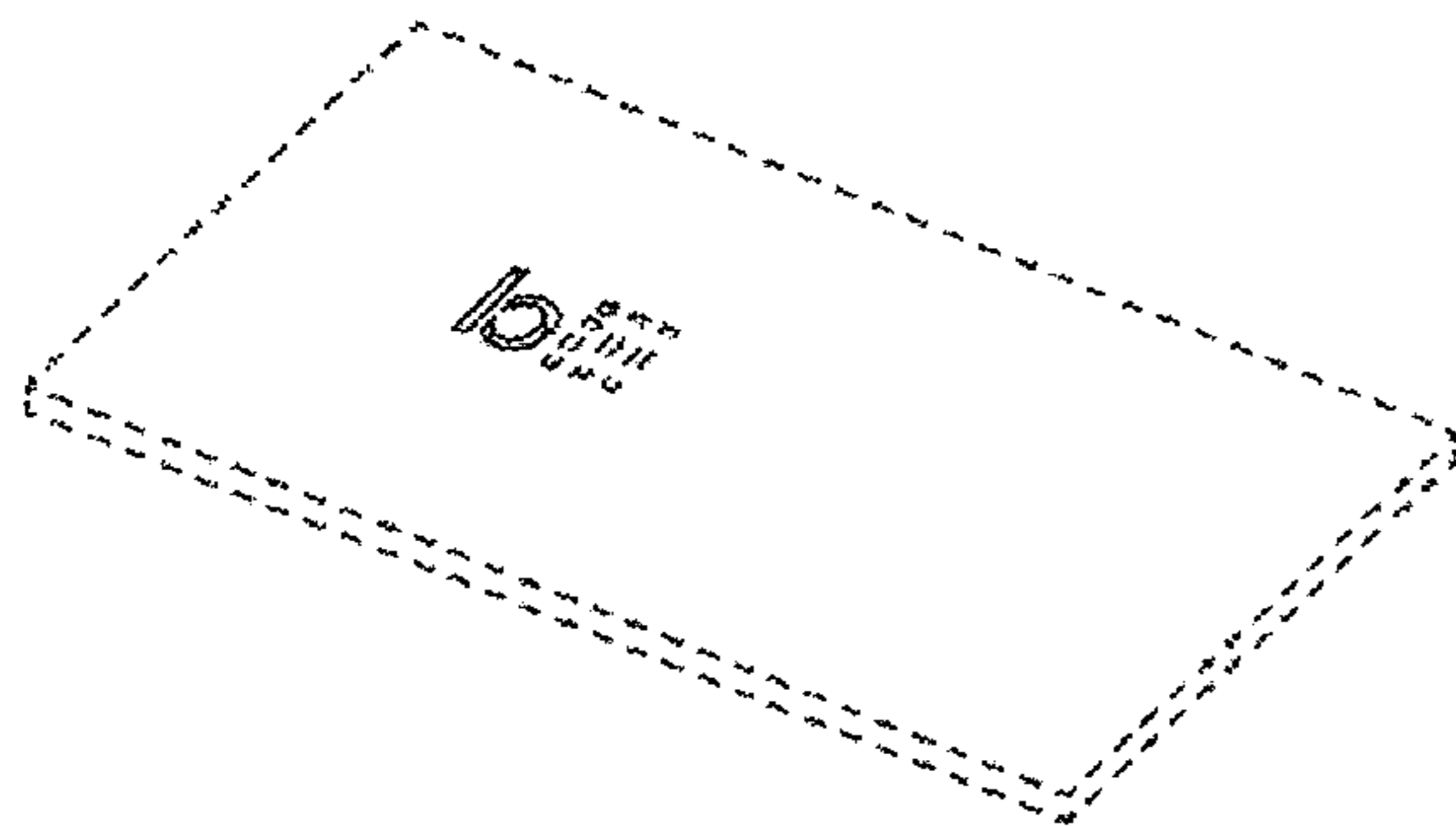
DESCRIPTION

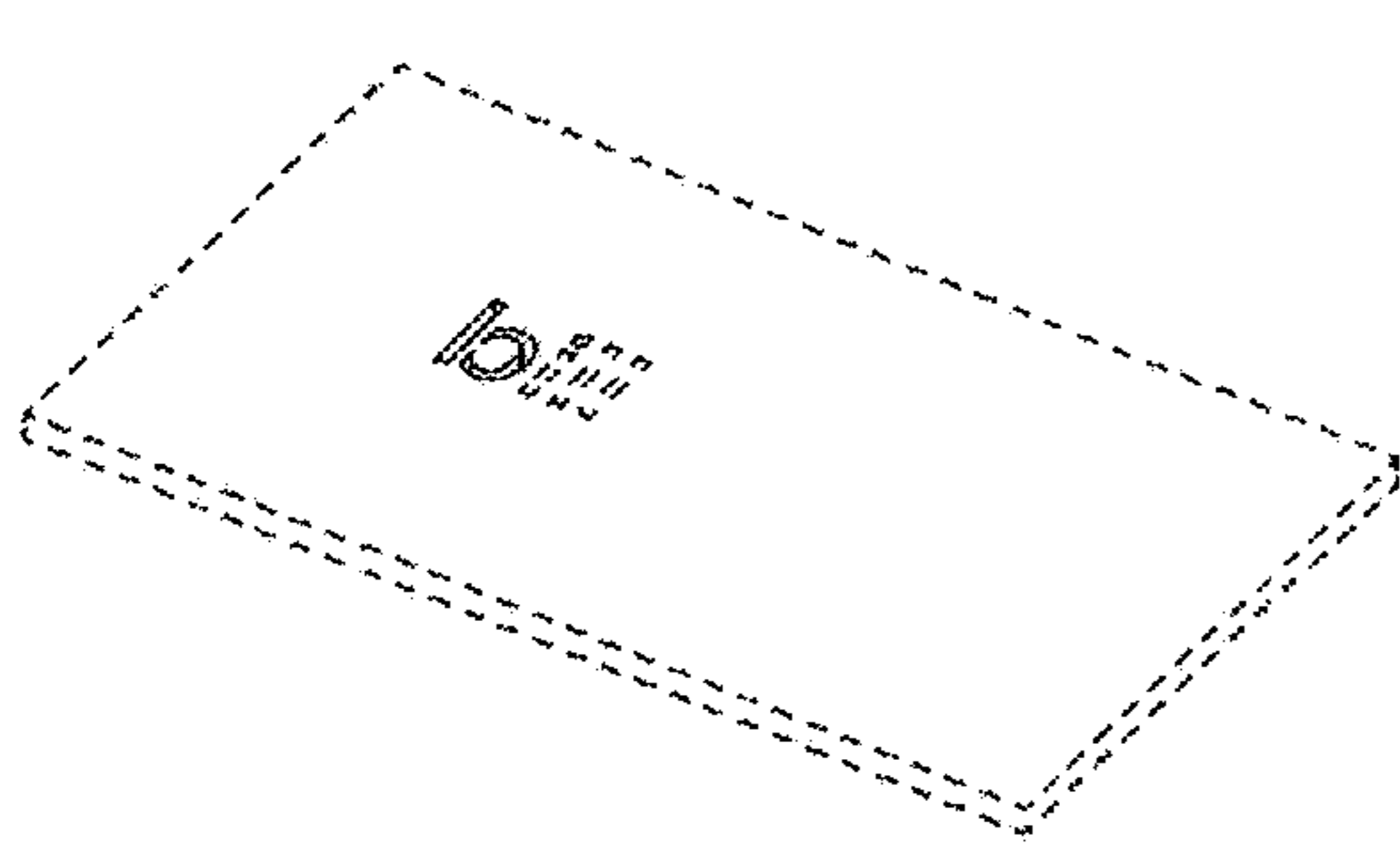

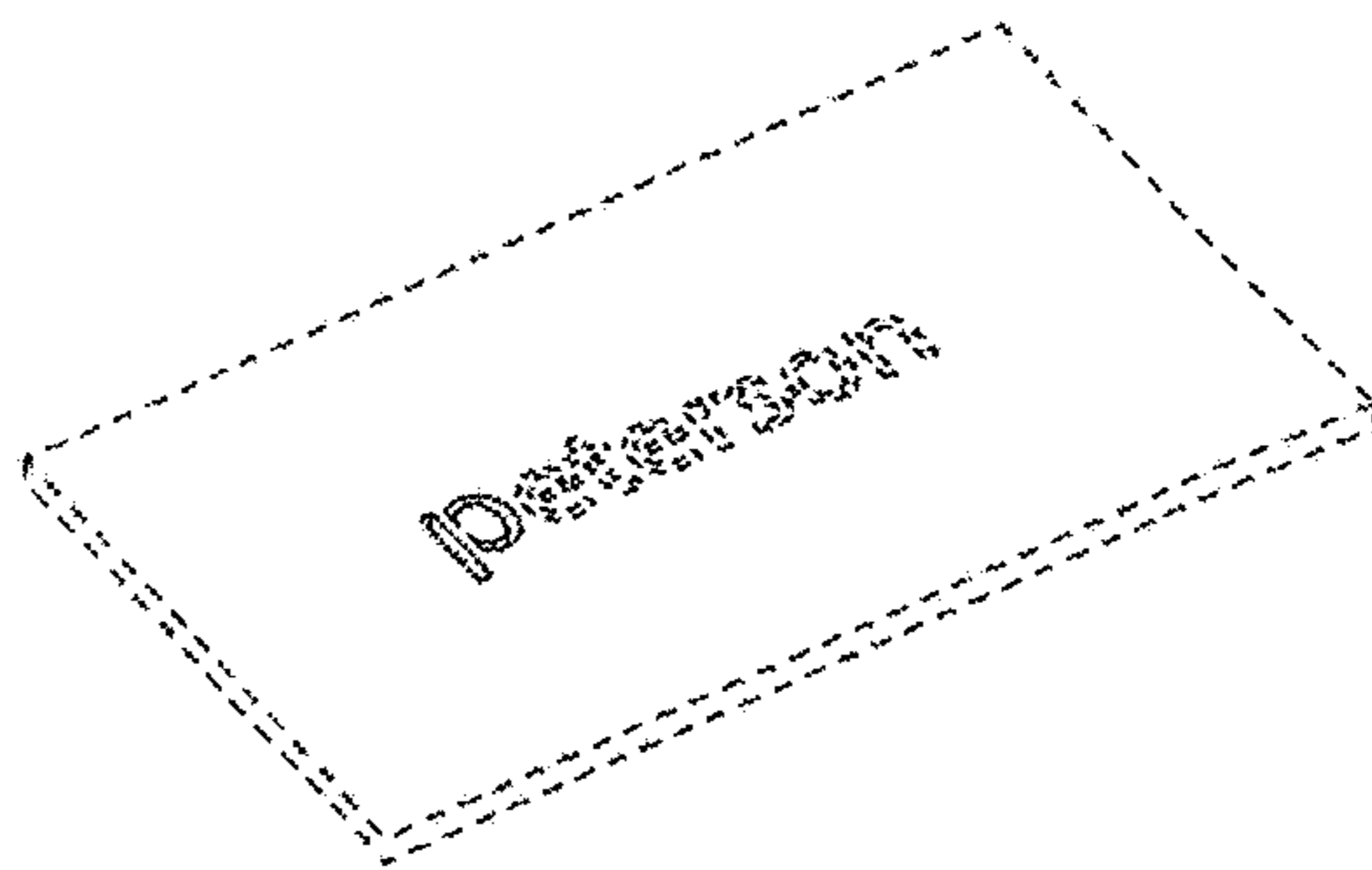

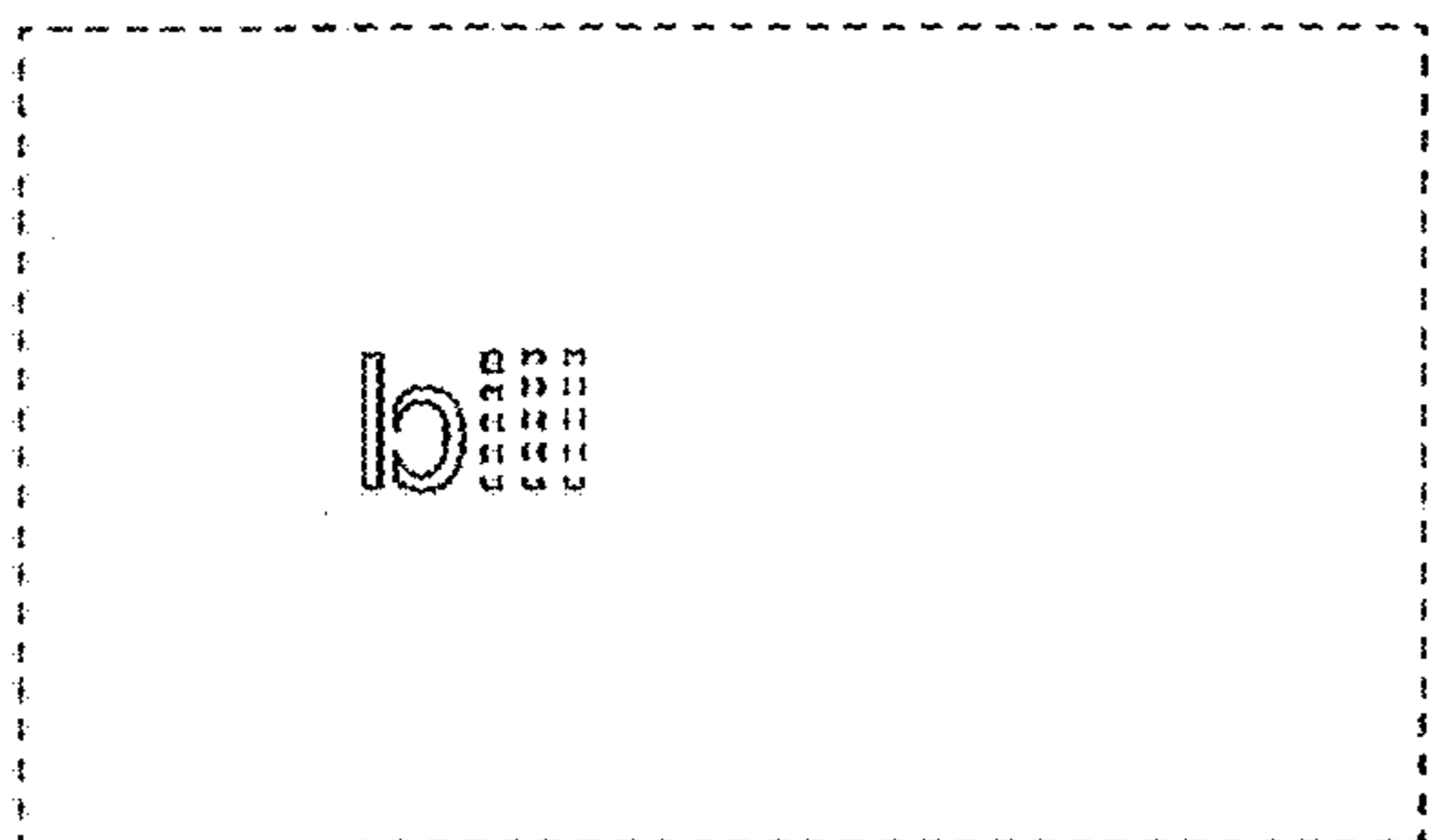

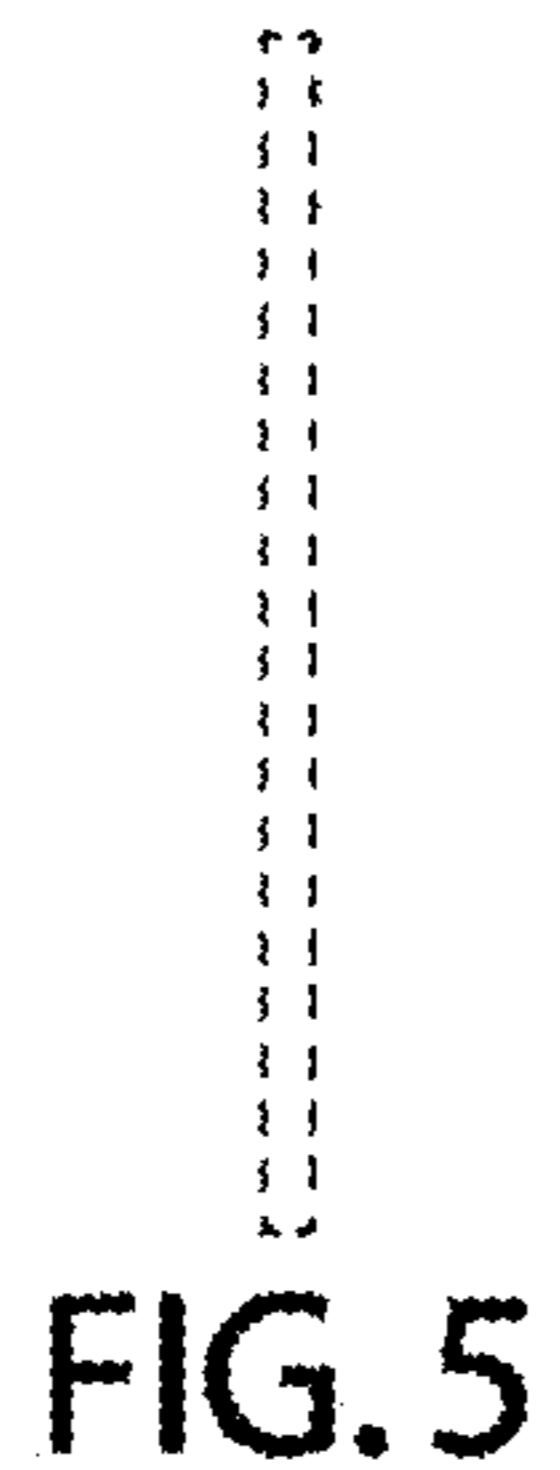

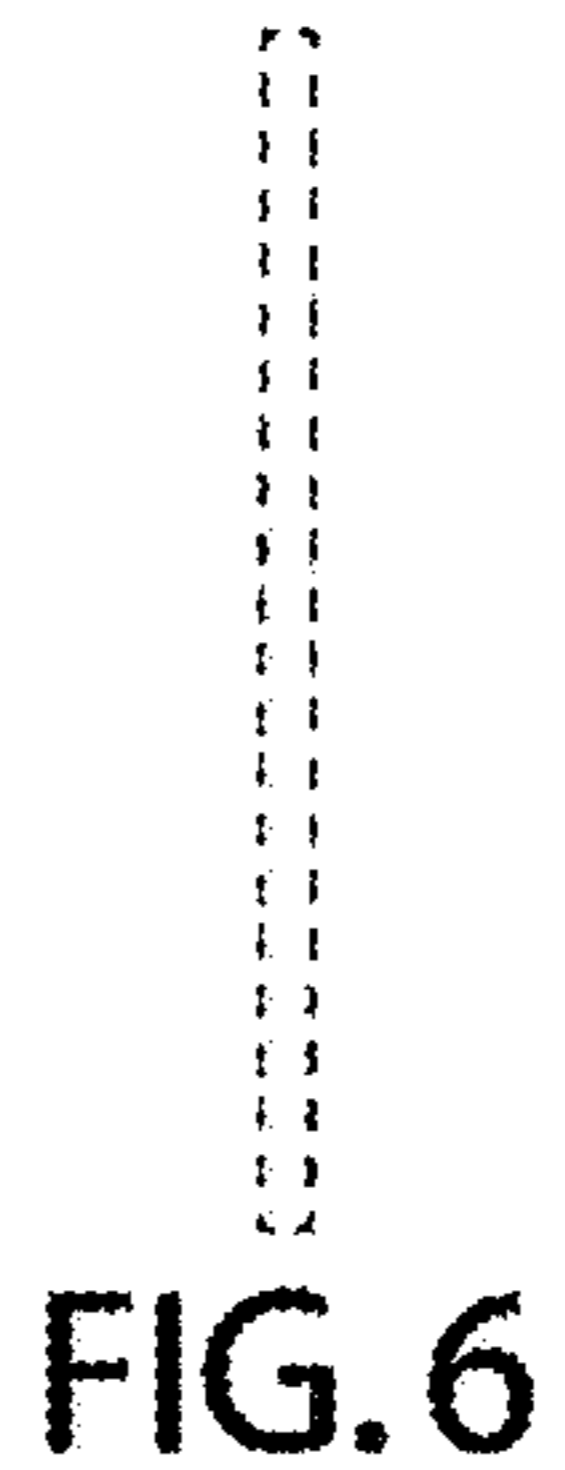

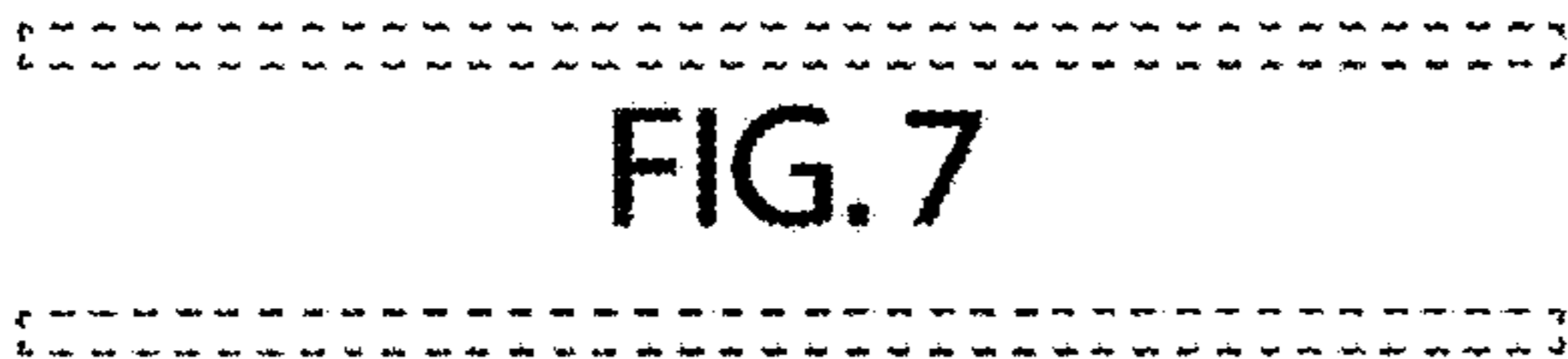

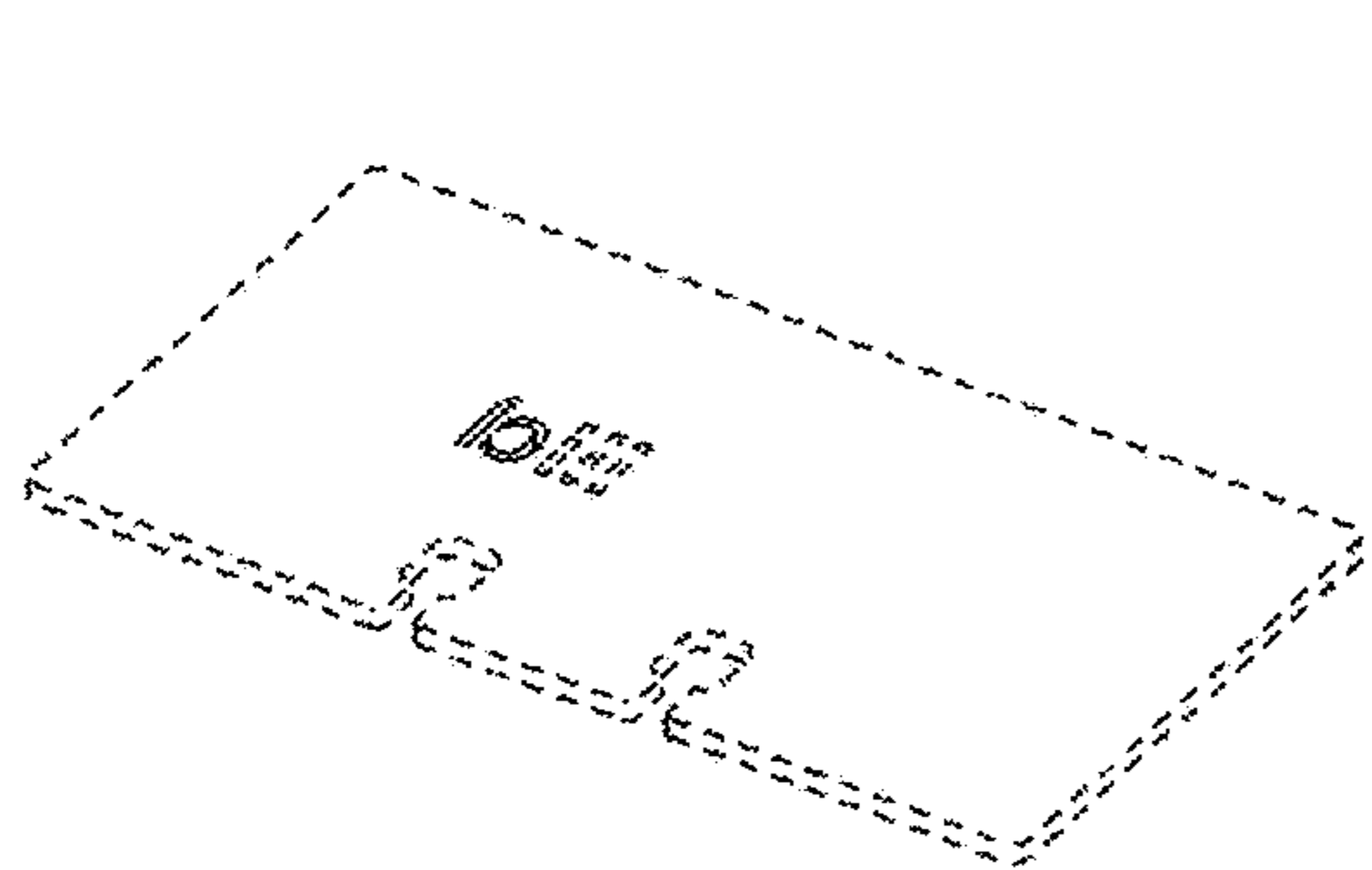

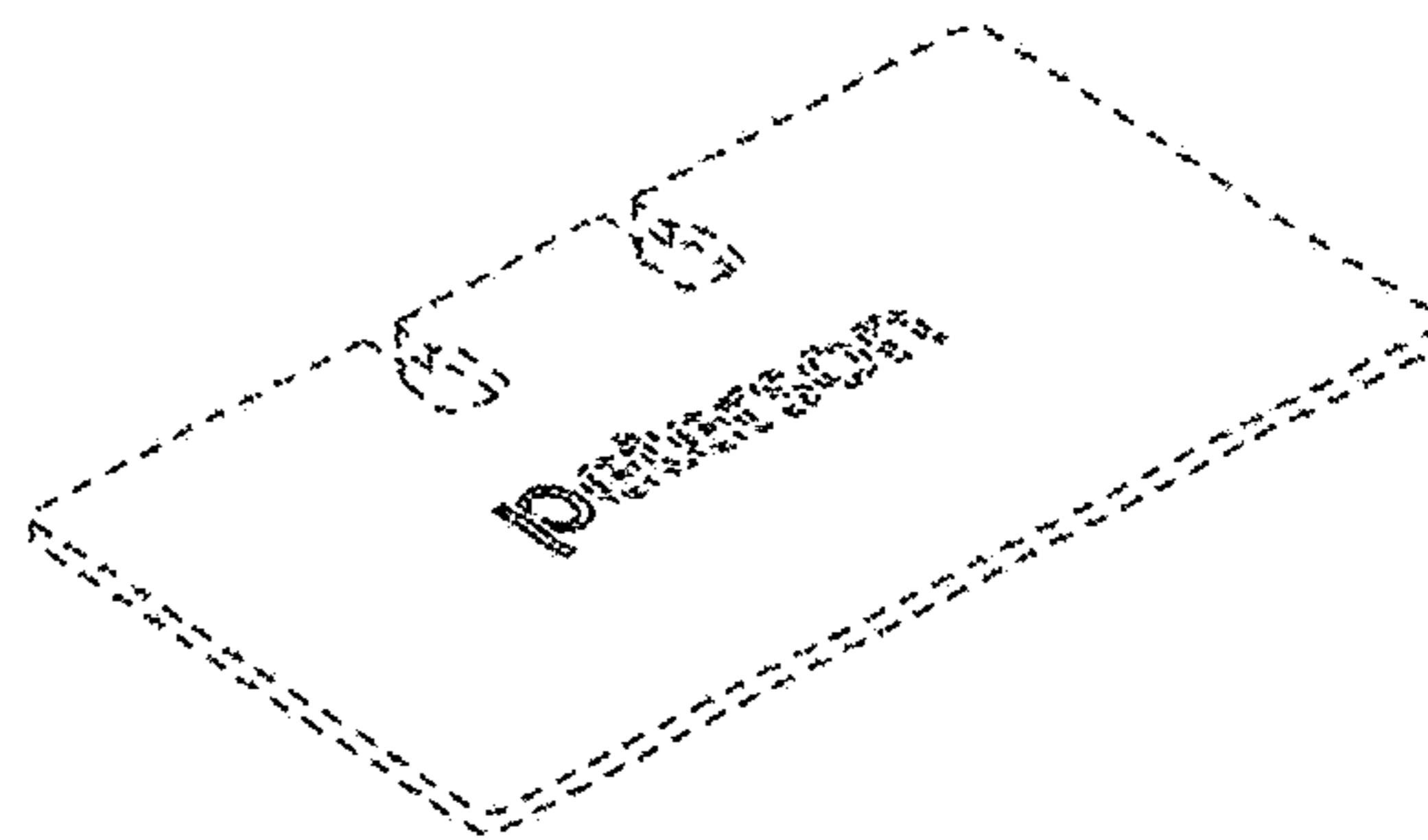

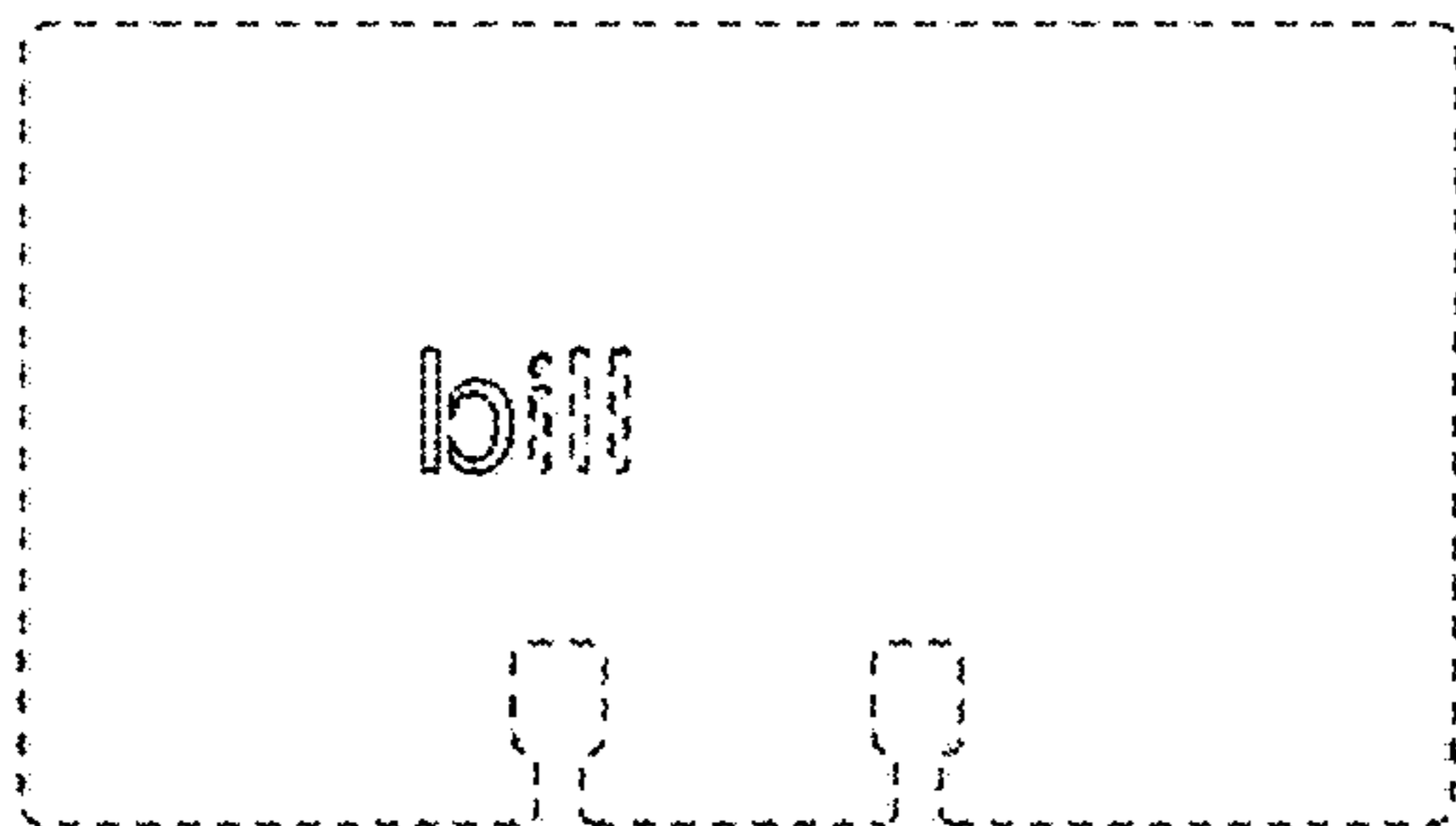

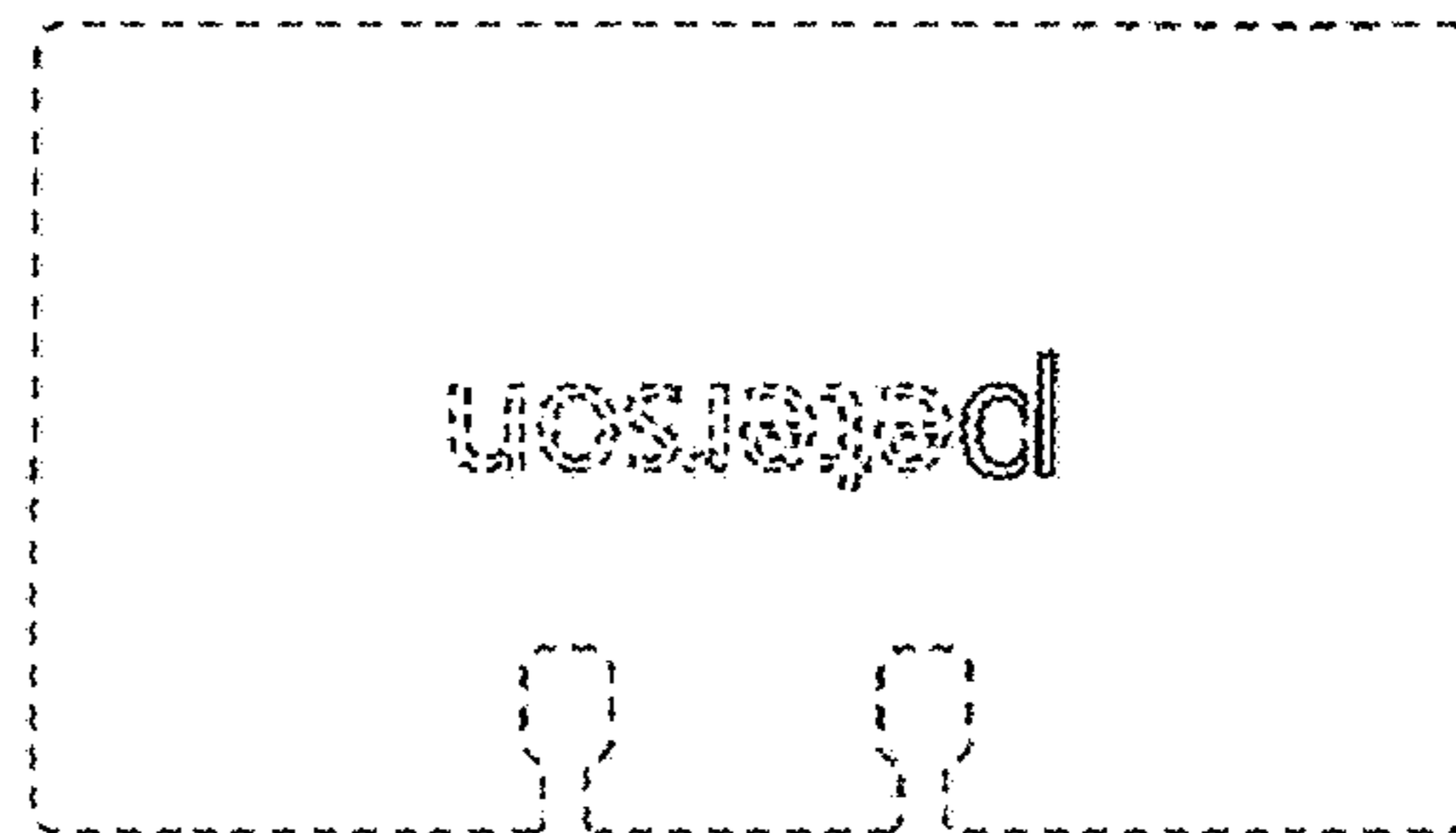

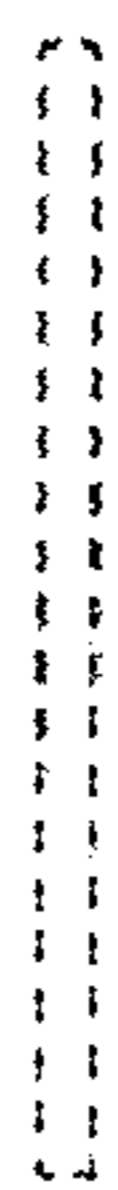

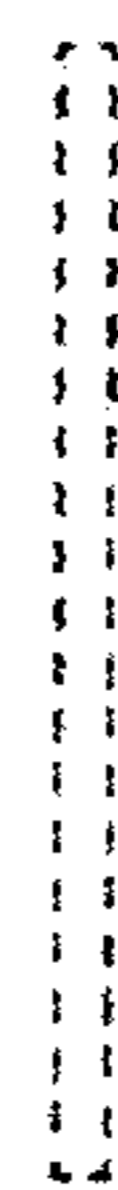

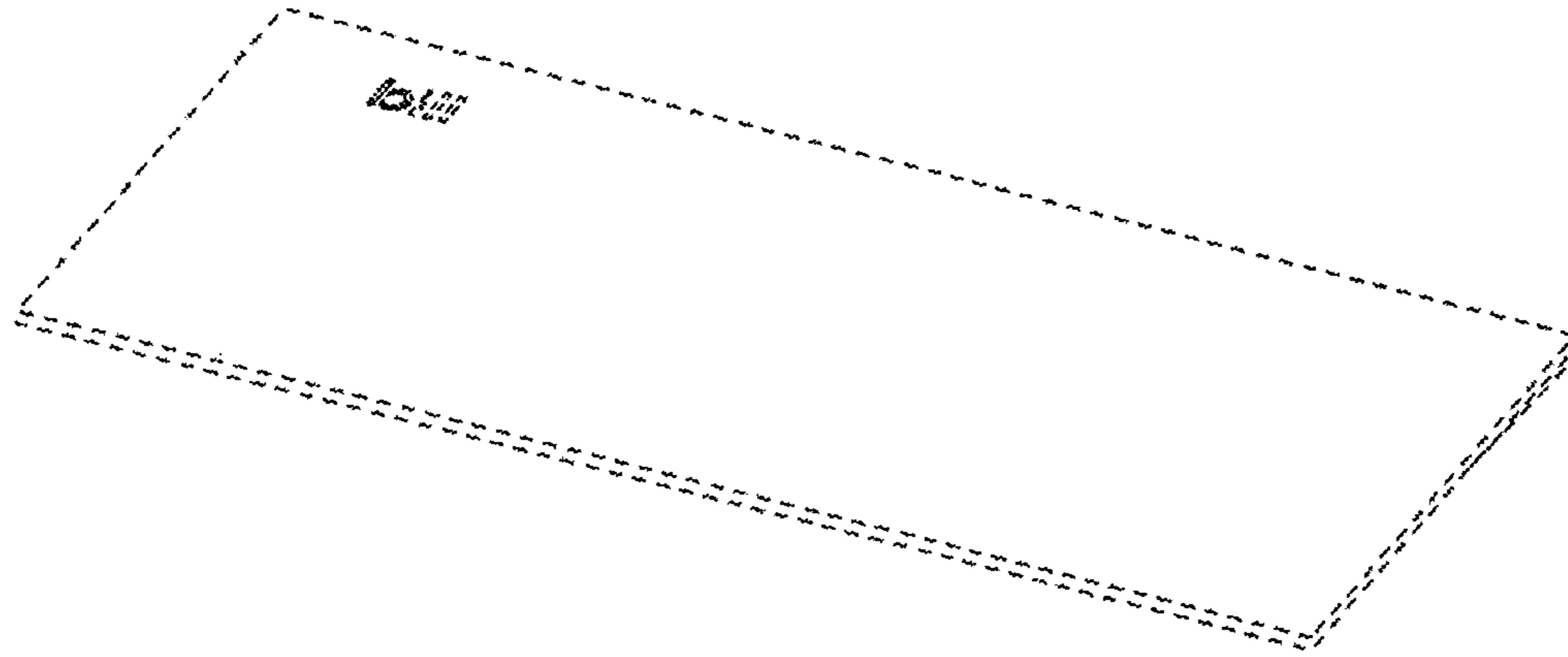

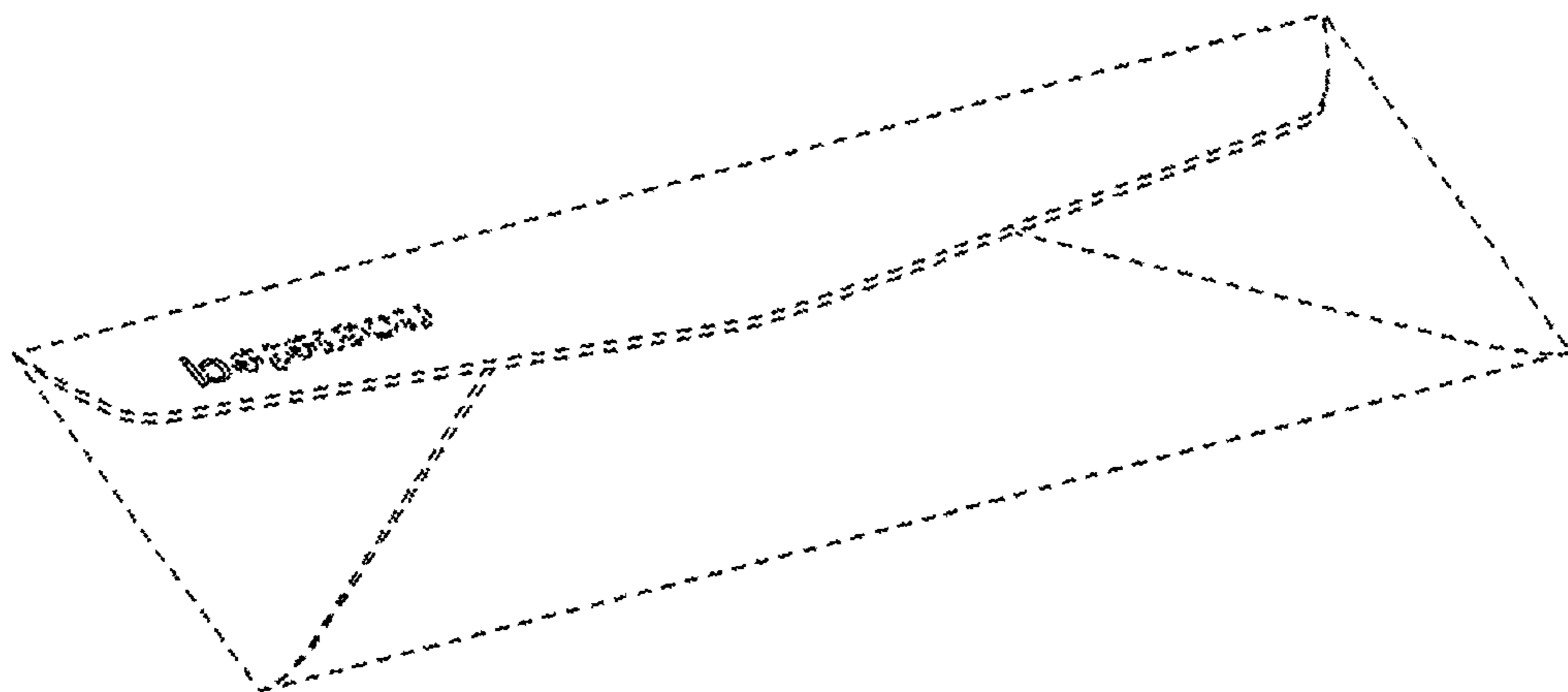

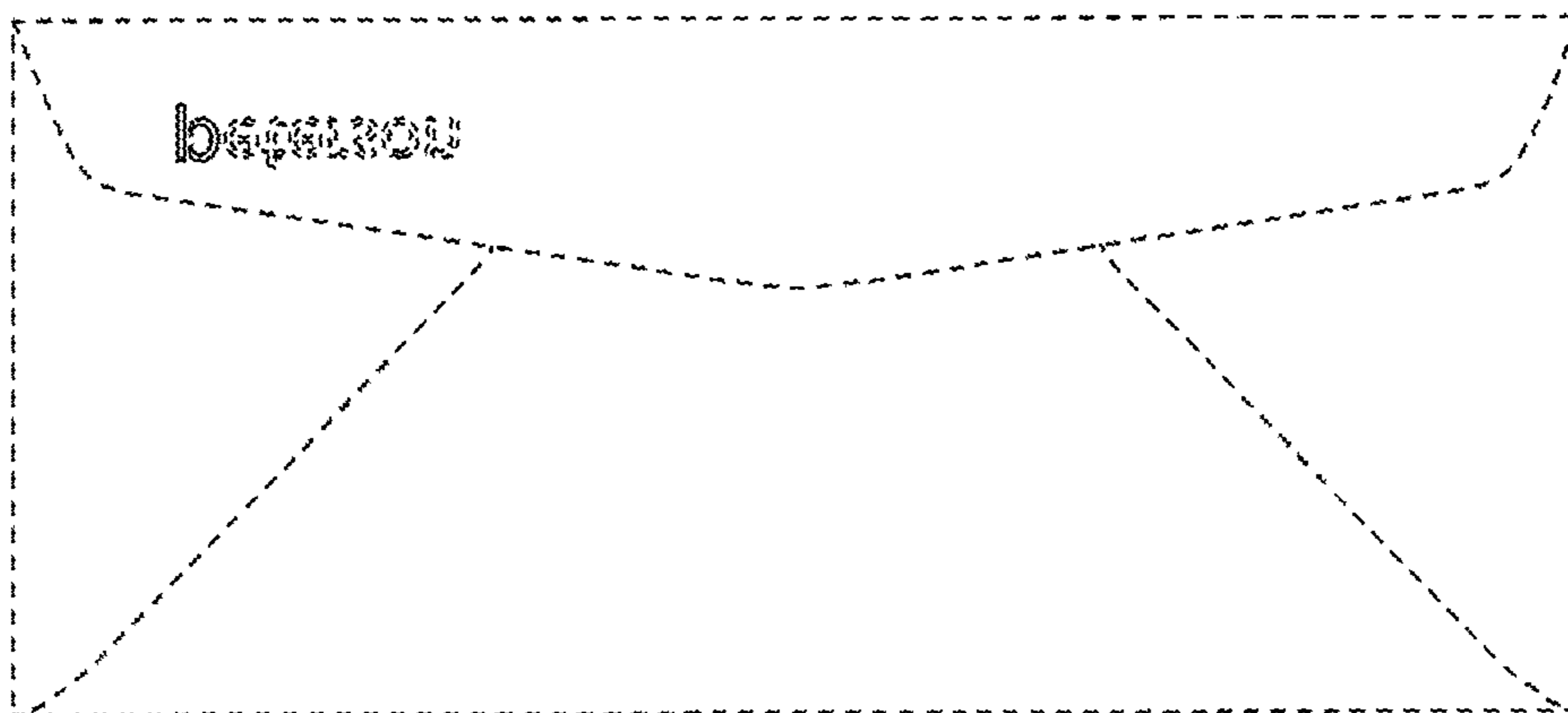

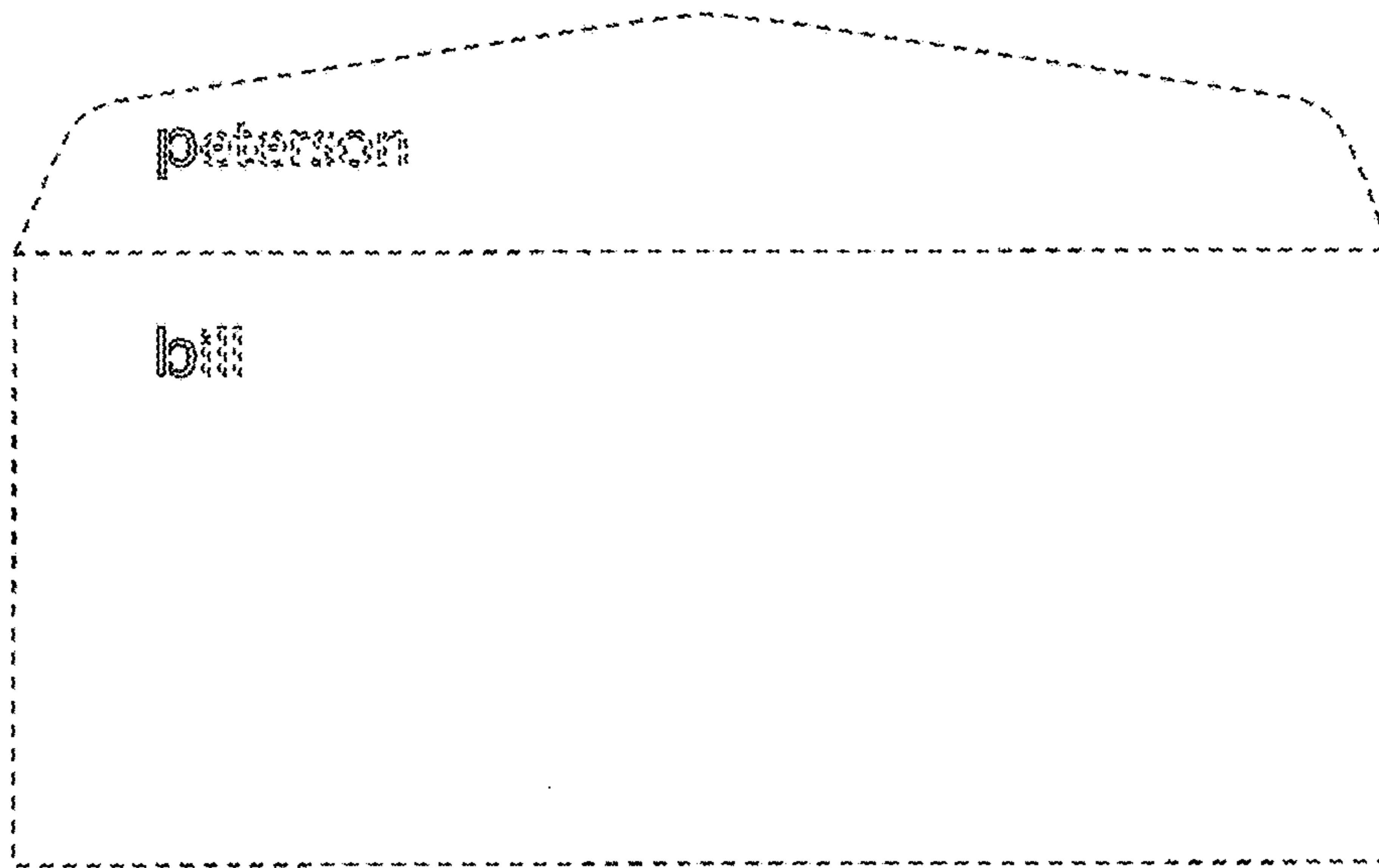

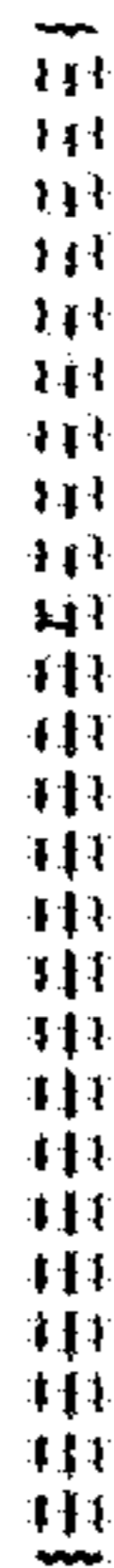

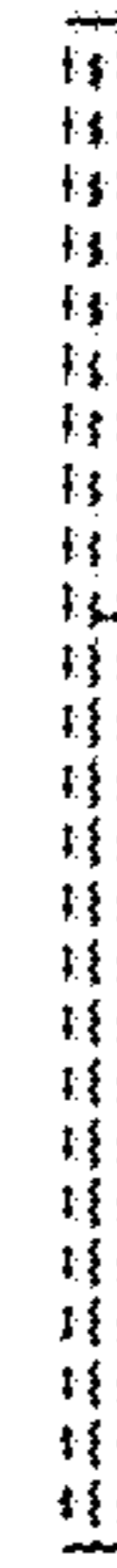

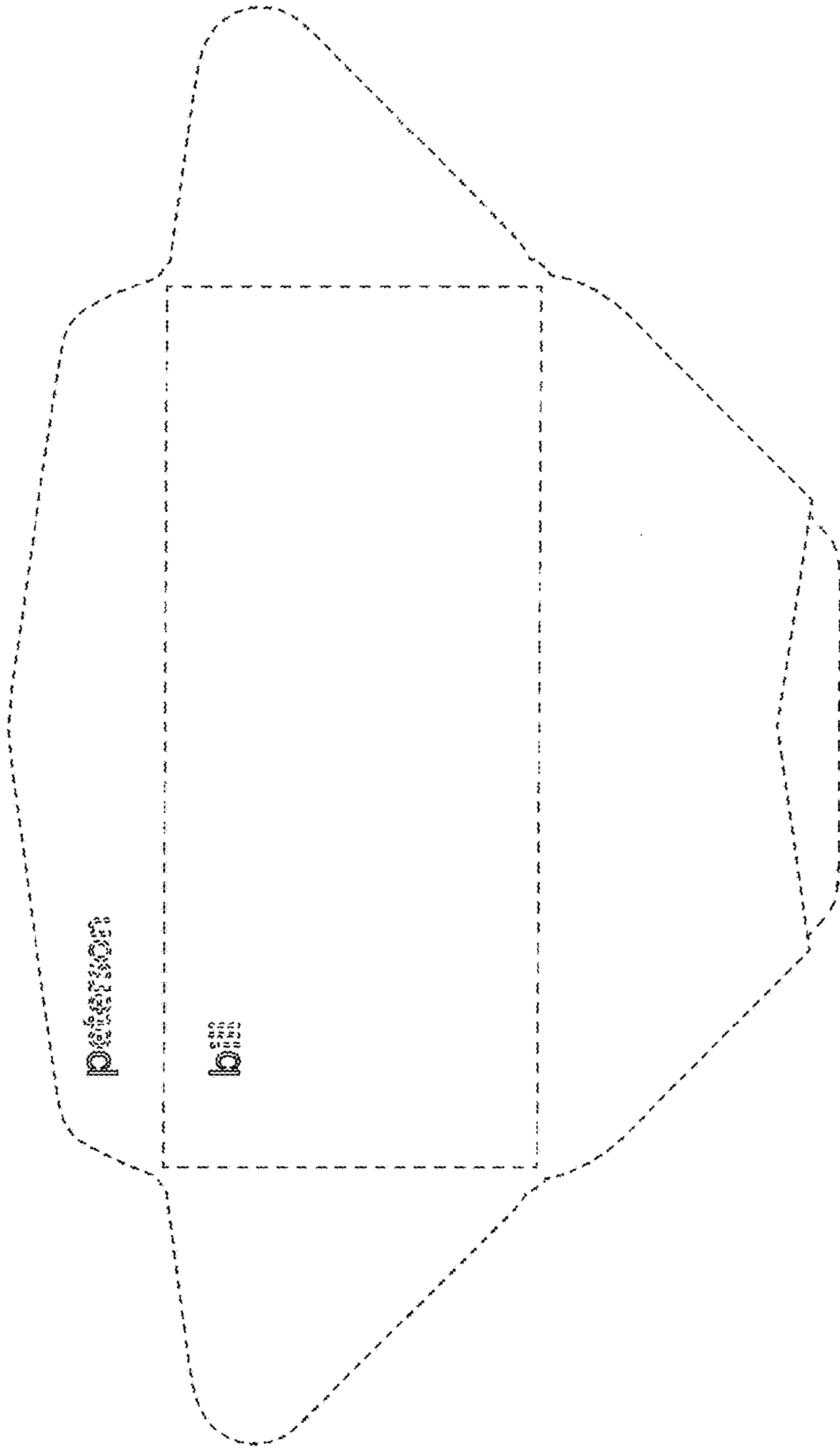

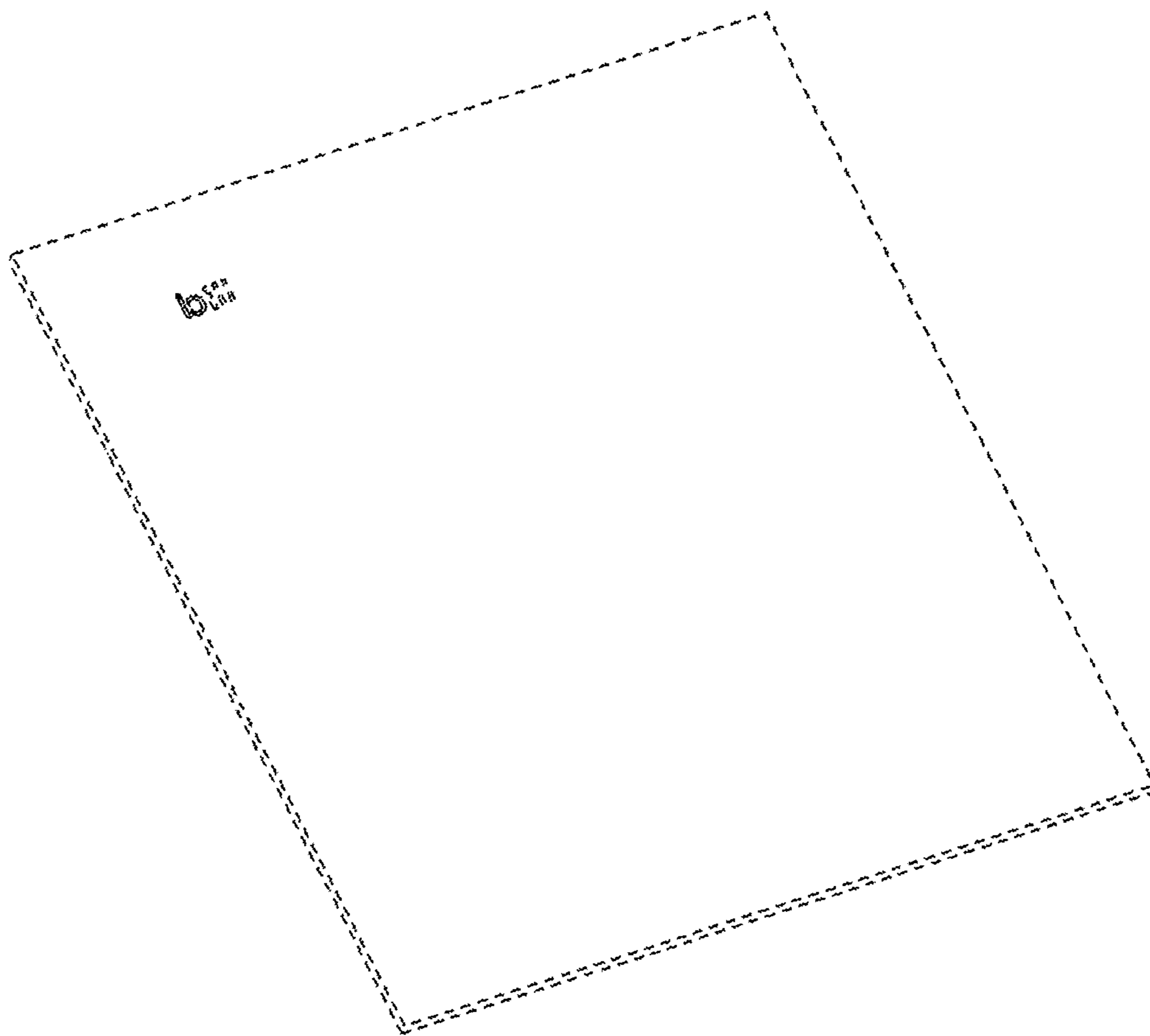

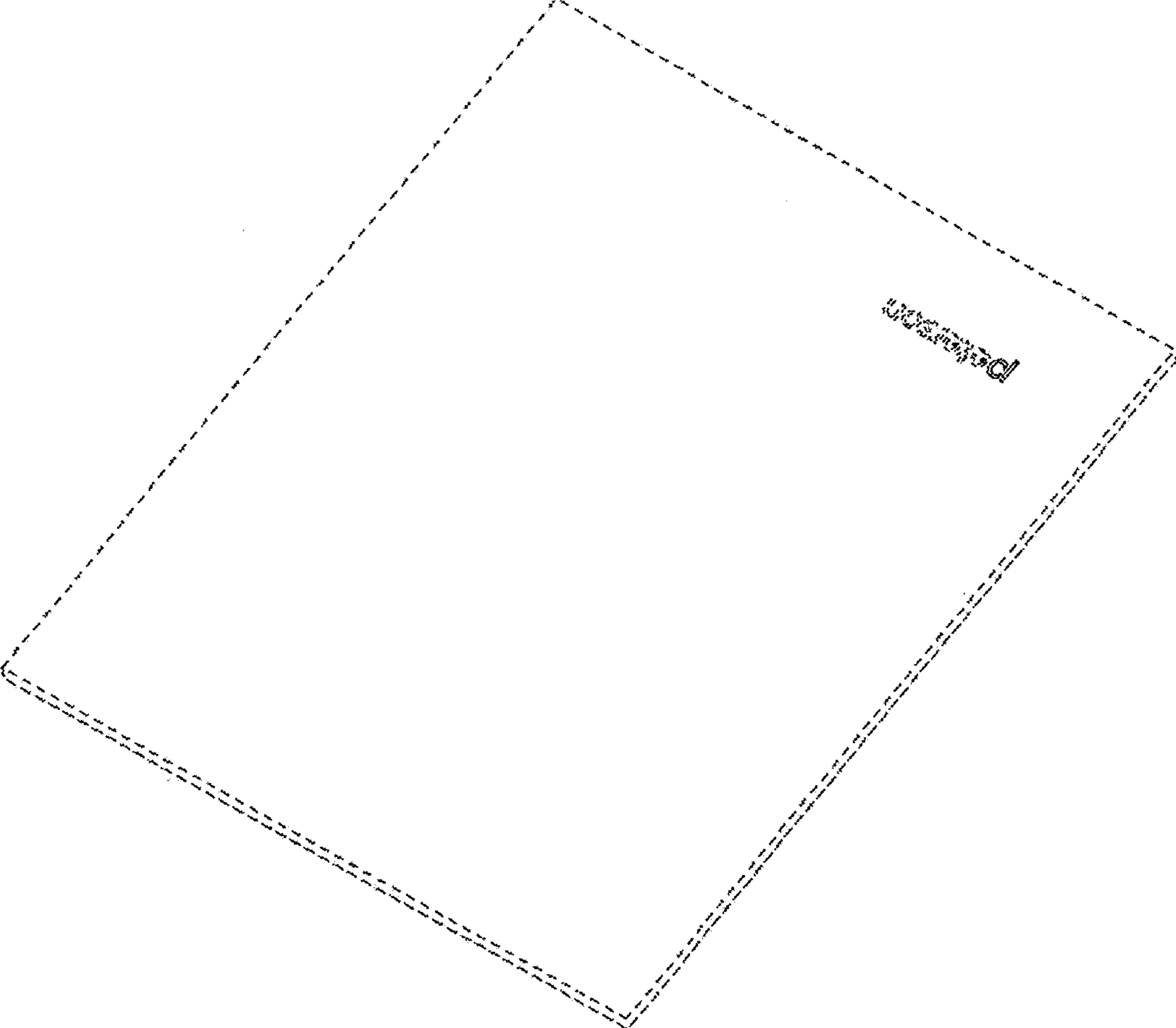

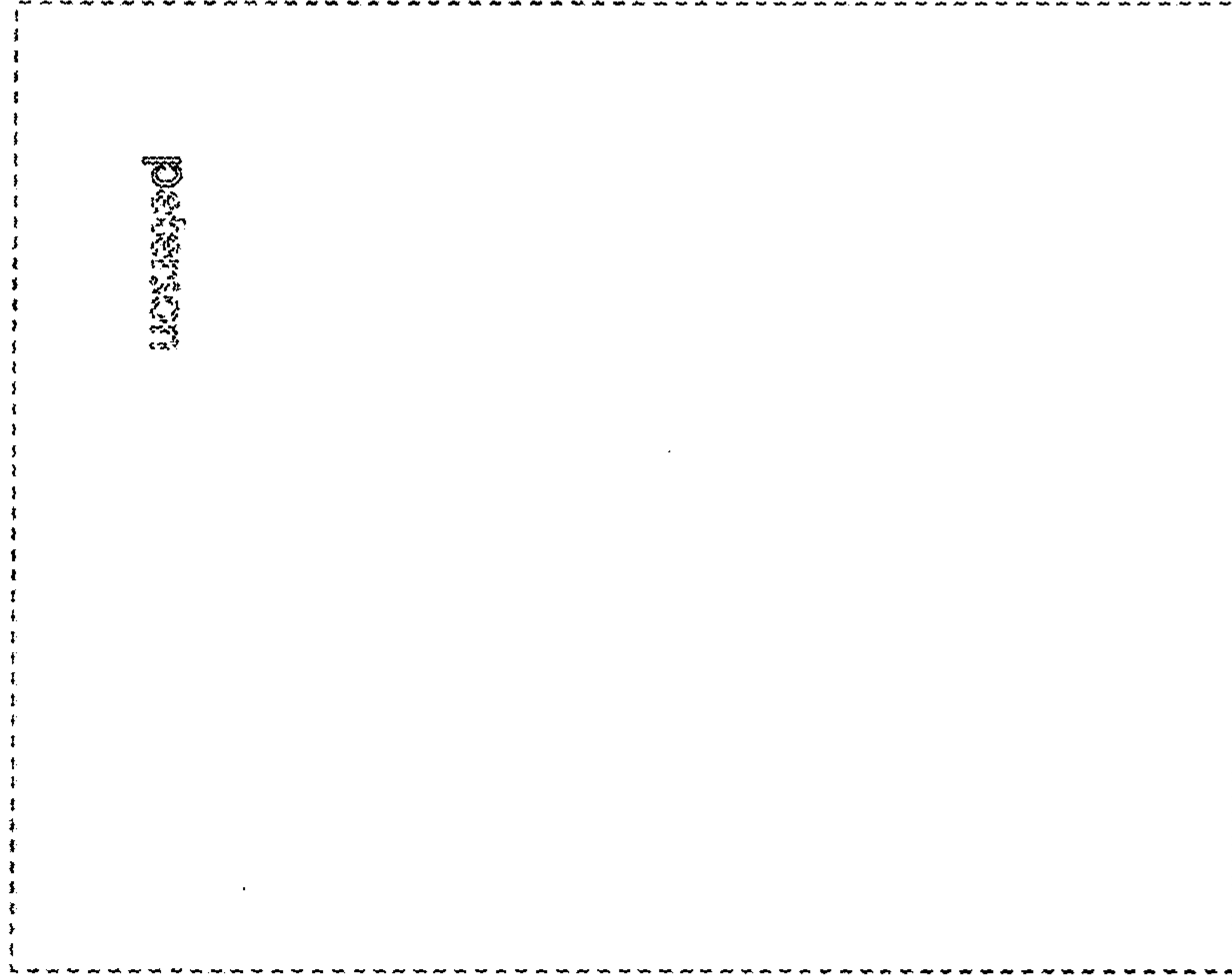

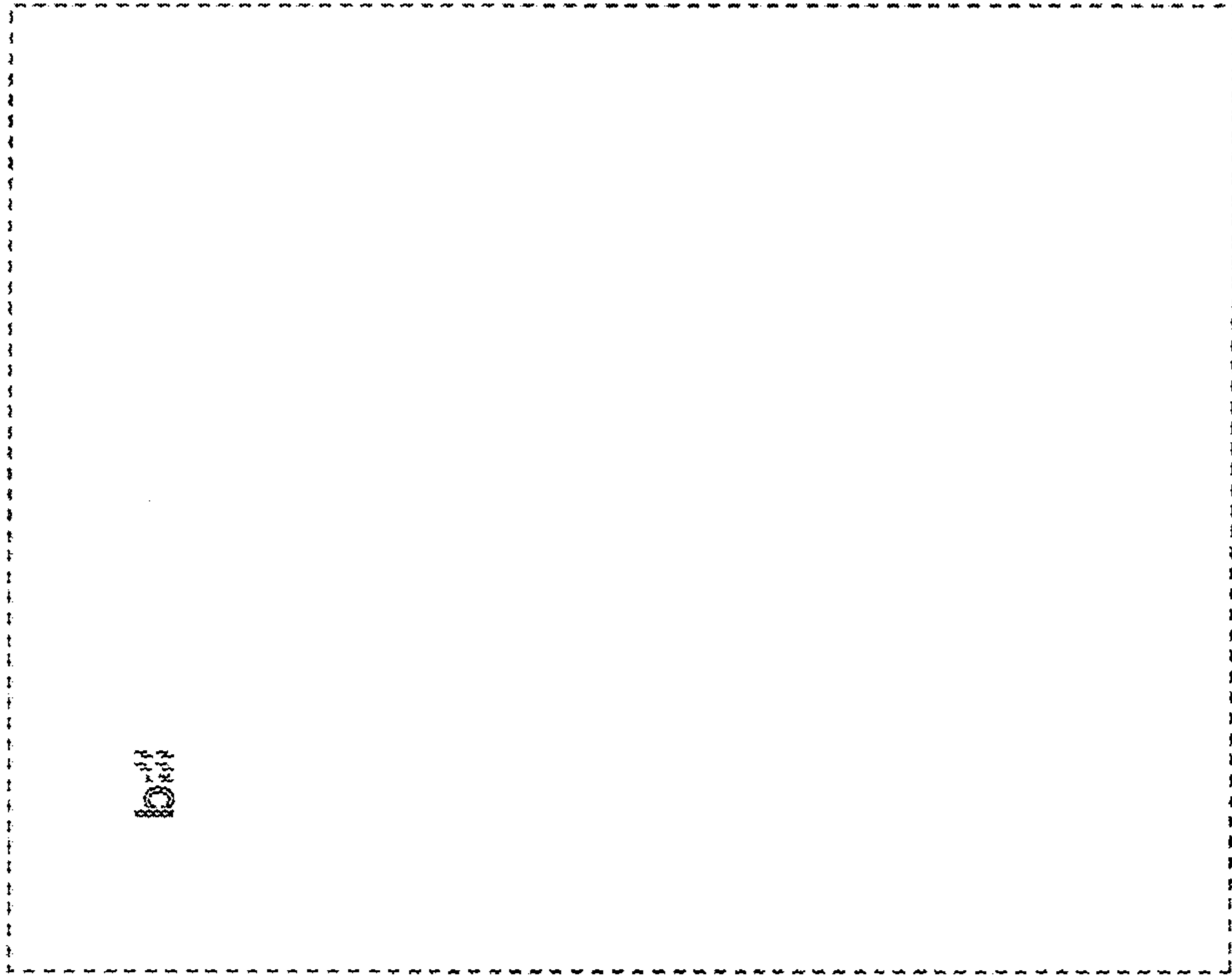

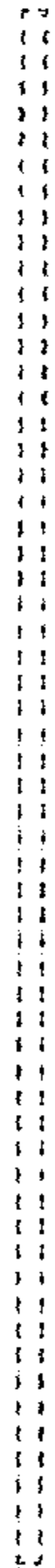

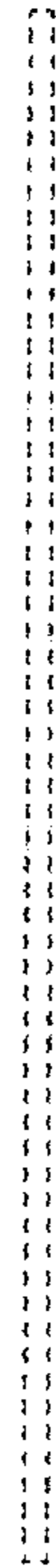

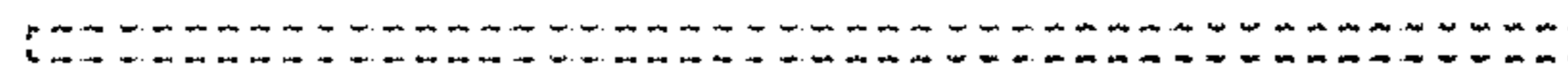

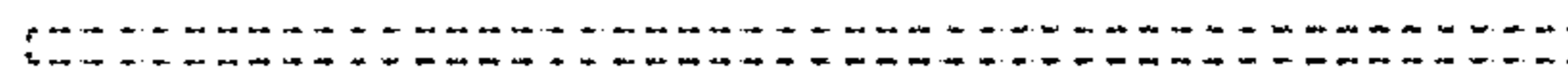
