We claim the ornamental design for a housing of an exercise device, as shown and described.

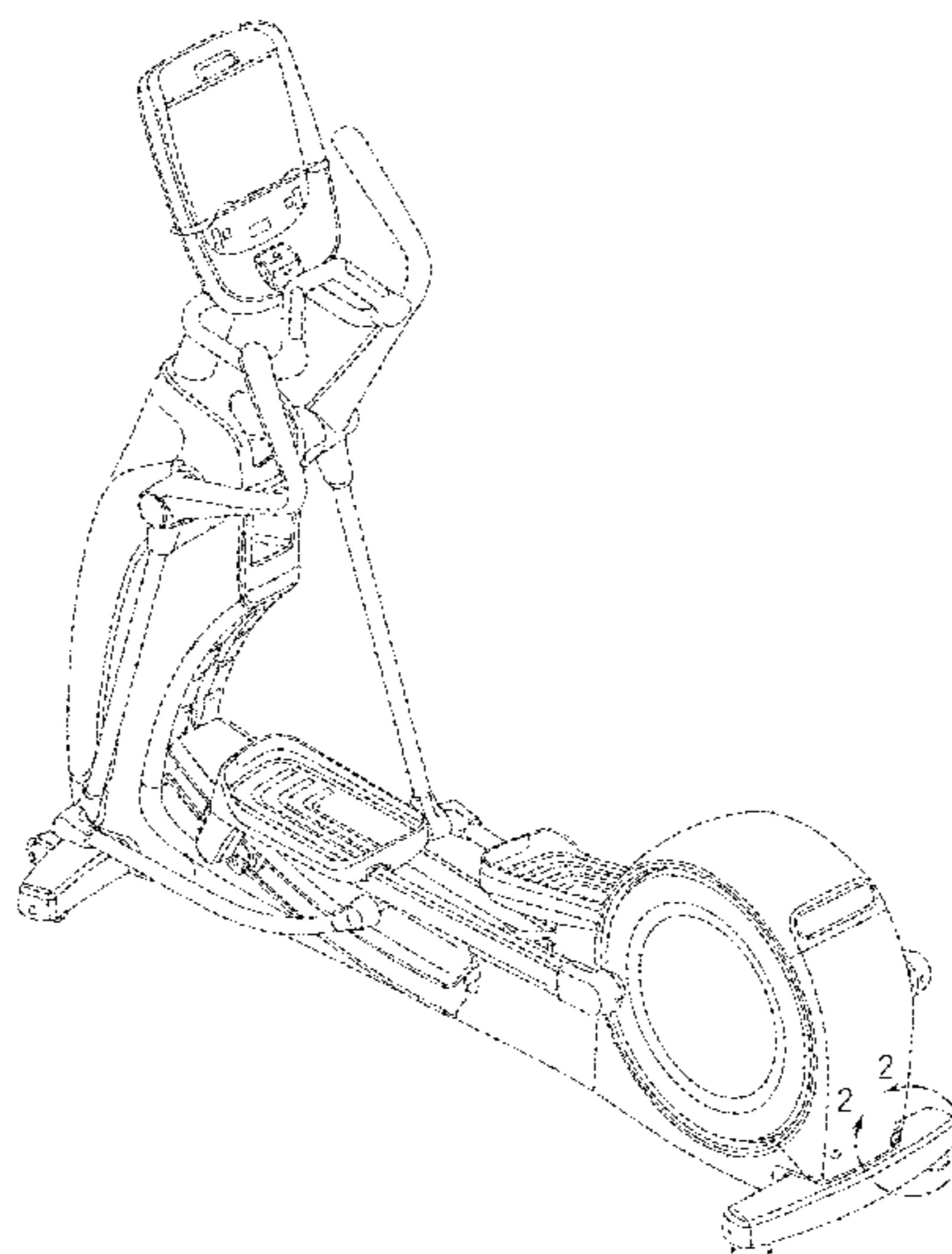
**DESCRIPTION**

FIG. 1 a side, top perspective view of a housing of an exercise device;  
FIG. 2 is a close-up perspective view of the housing of the exercise device of FIG. 1;  
FIG. 3 is a rear perspective view of the housing of the exercise device of FIG. 1;  
FIG. 4 is a first side view of the housing of the exercise device of FIG. 1;  
FIG. 5 is close up side view of the housing of the exercise device of FIG. 4; and,  
FIG. 6 is a rear view of the housing of the exercise device of FIG. 1.

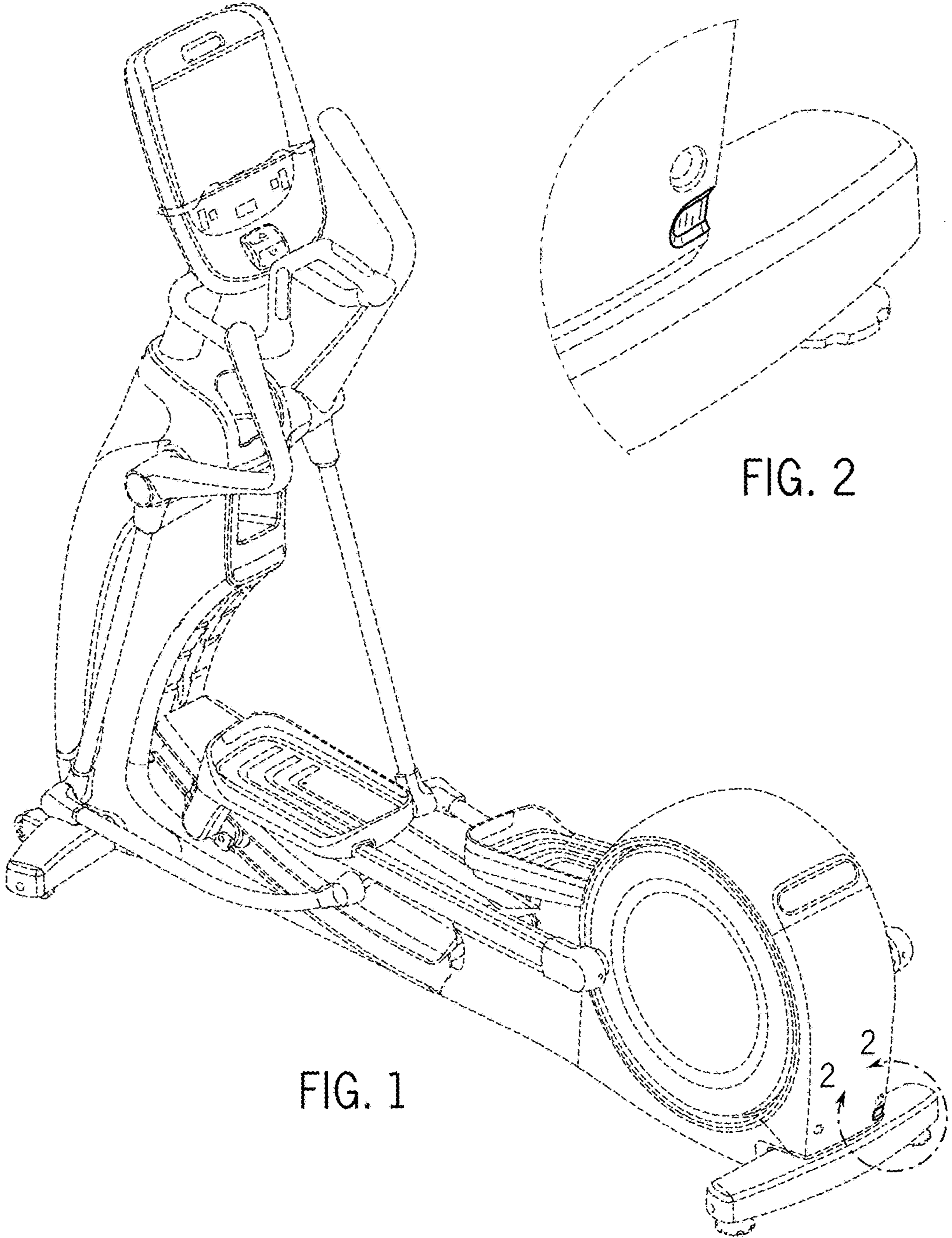

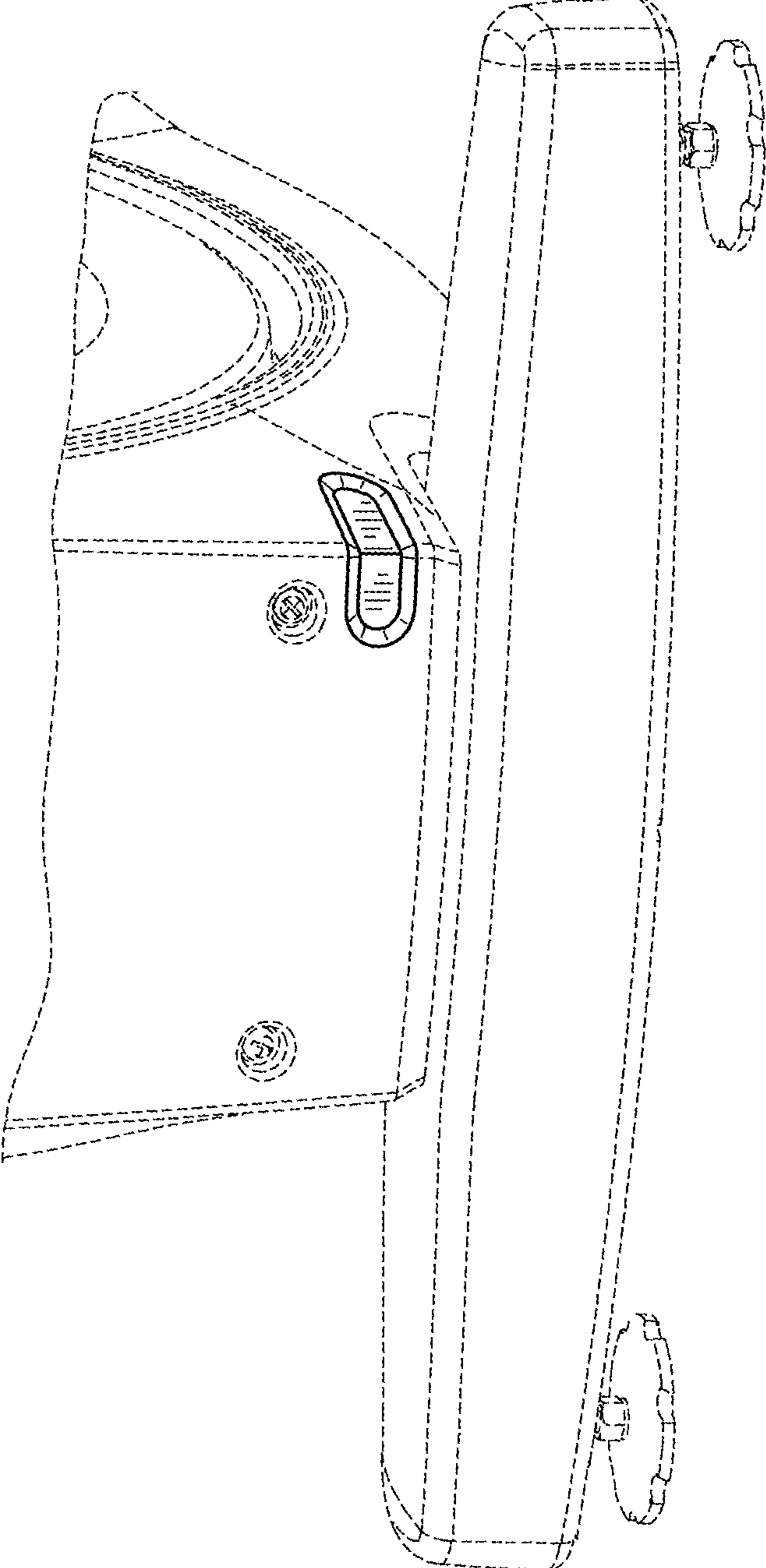
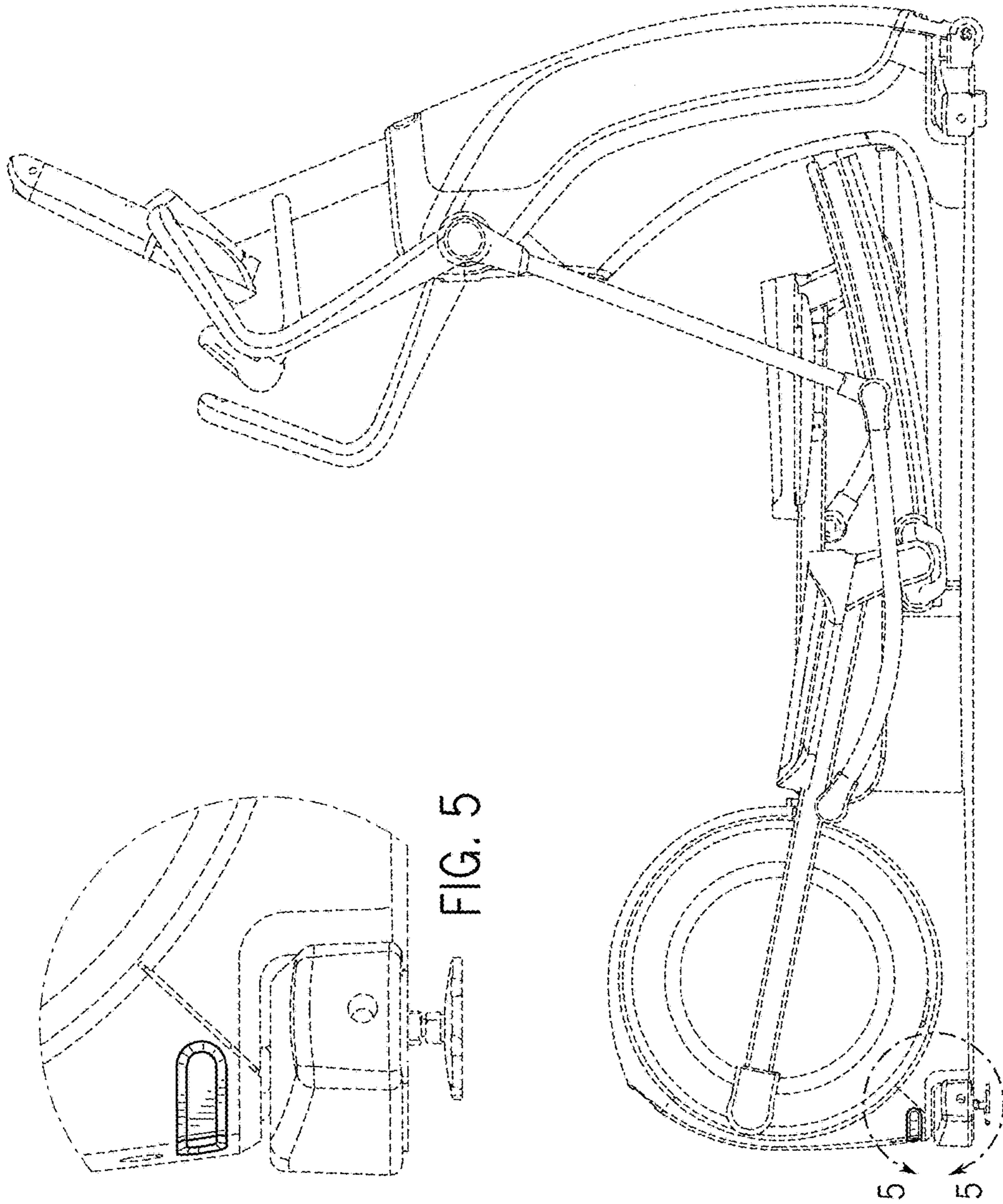

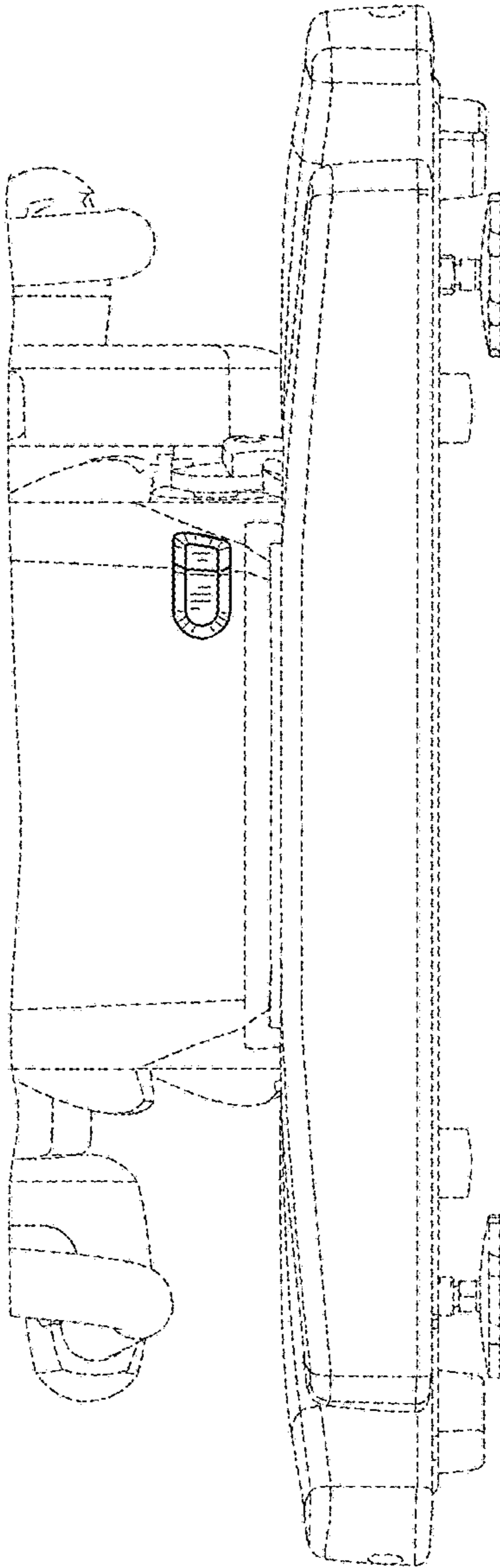
