(57) **CLAIM**

The ornamental design for a lacrosse head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an embodiment of a lacrosse head showing our design.

FIG. 2 is a bottom perspective view of the lacrosse head of FIG. 1.

FIG. 3 is a right side view of the lacrosse head of FIG. 1.

FIG. 4 is a front view of the lacrosse head of FIG. 1.

FIG. 5 is a left side view of the lacrosse head of FIG. 1.

FIG. 6 is a back view of the lacrosse head of FIG. 1.

FIG. 7 is a top view of the lacrosse head of FIG. 1; and, FIG. 8 is a bottom of the portion view of the lacrosse head of FIG. 1.

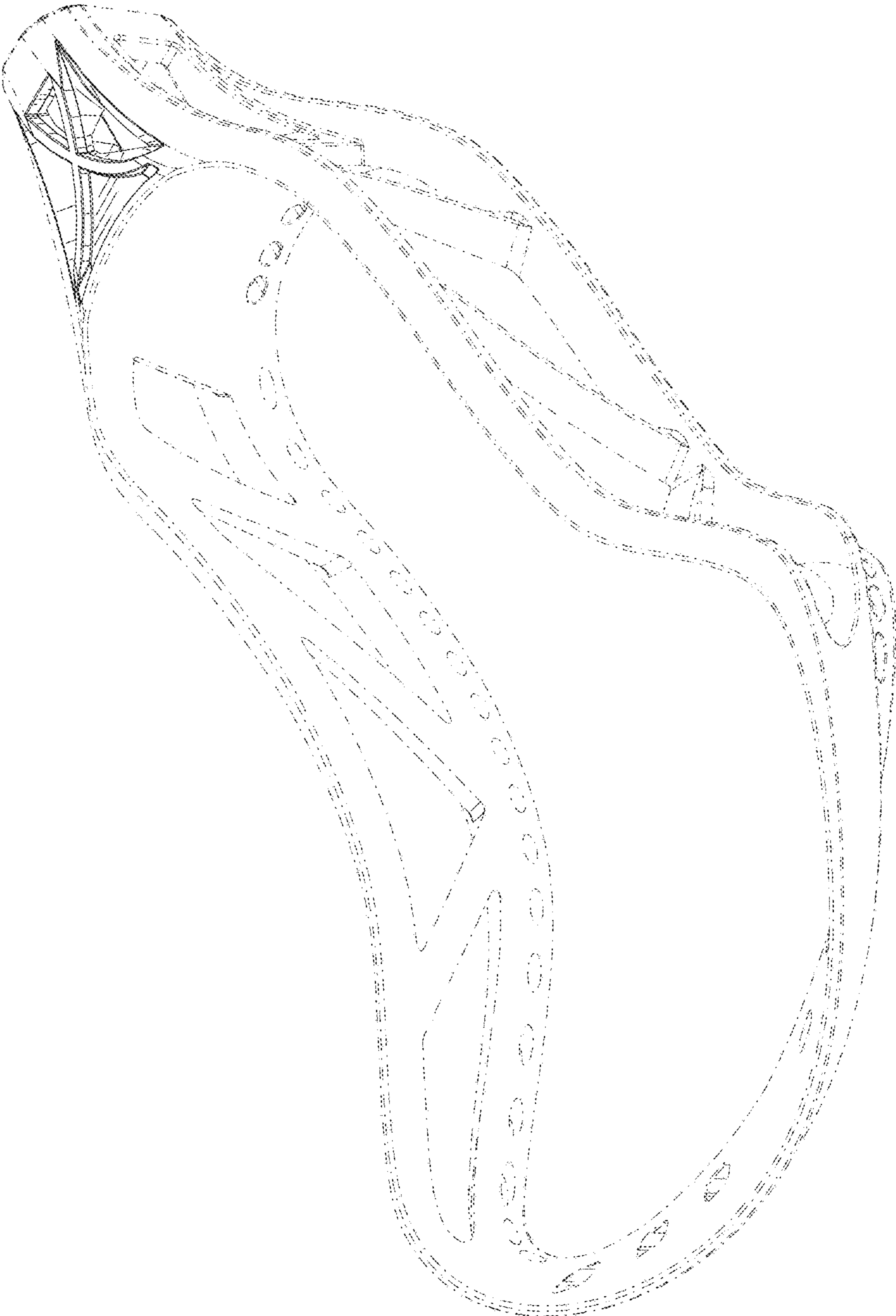

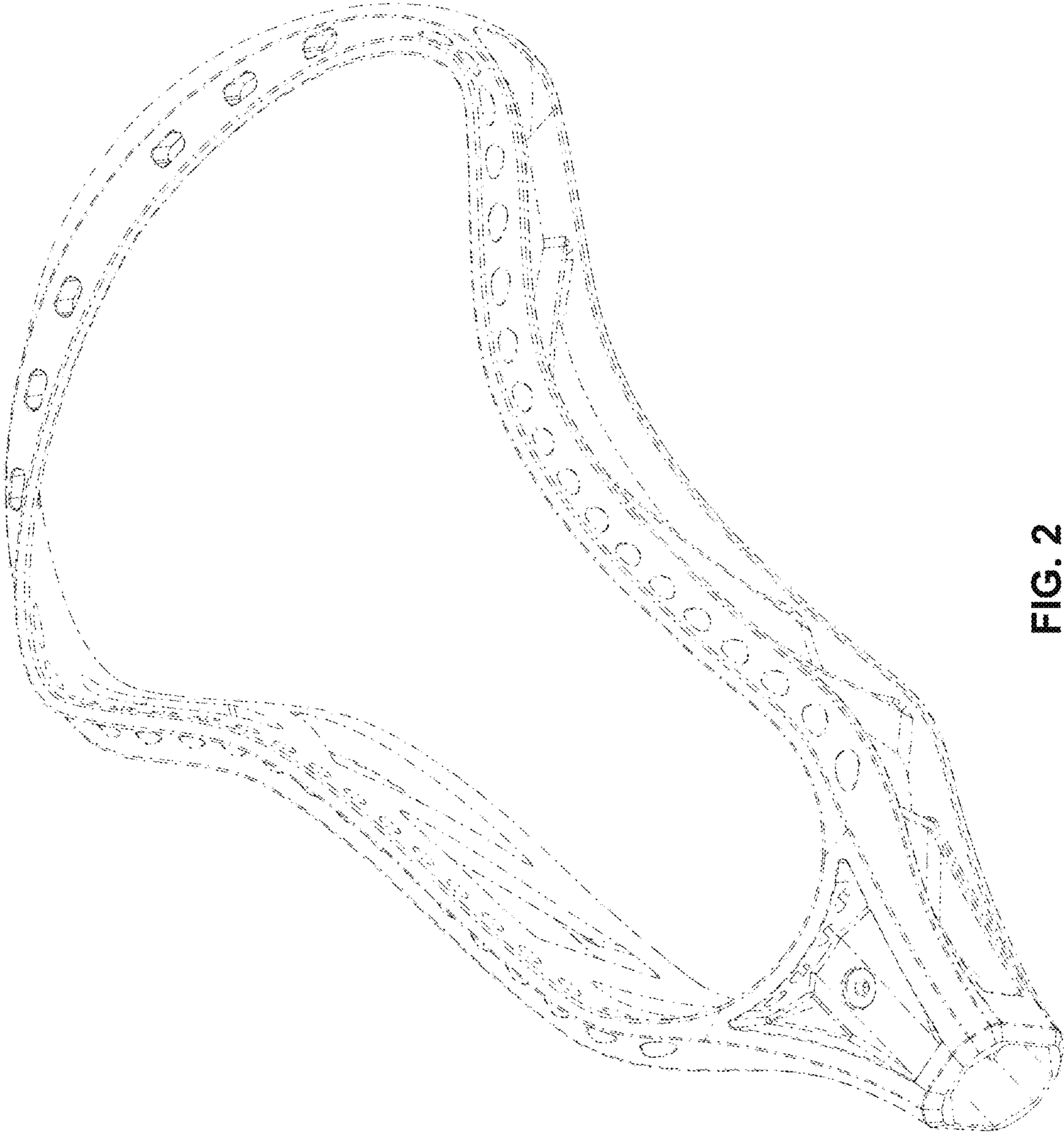

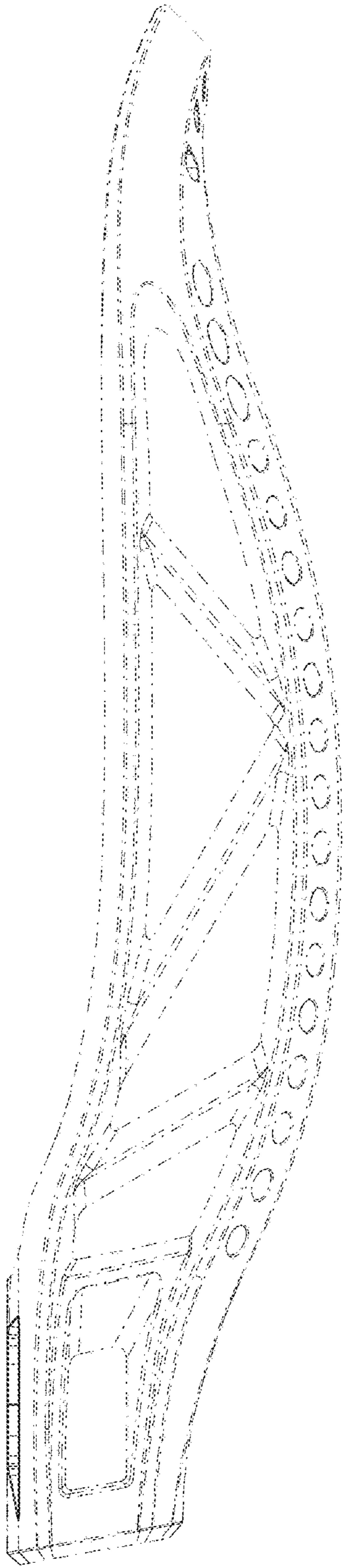

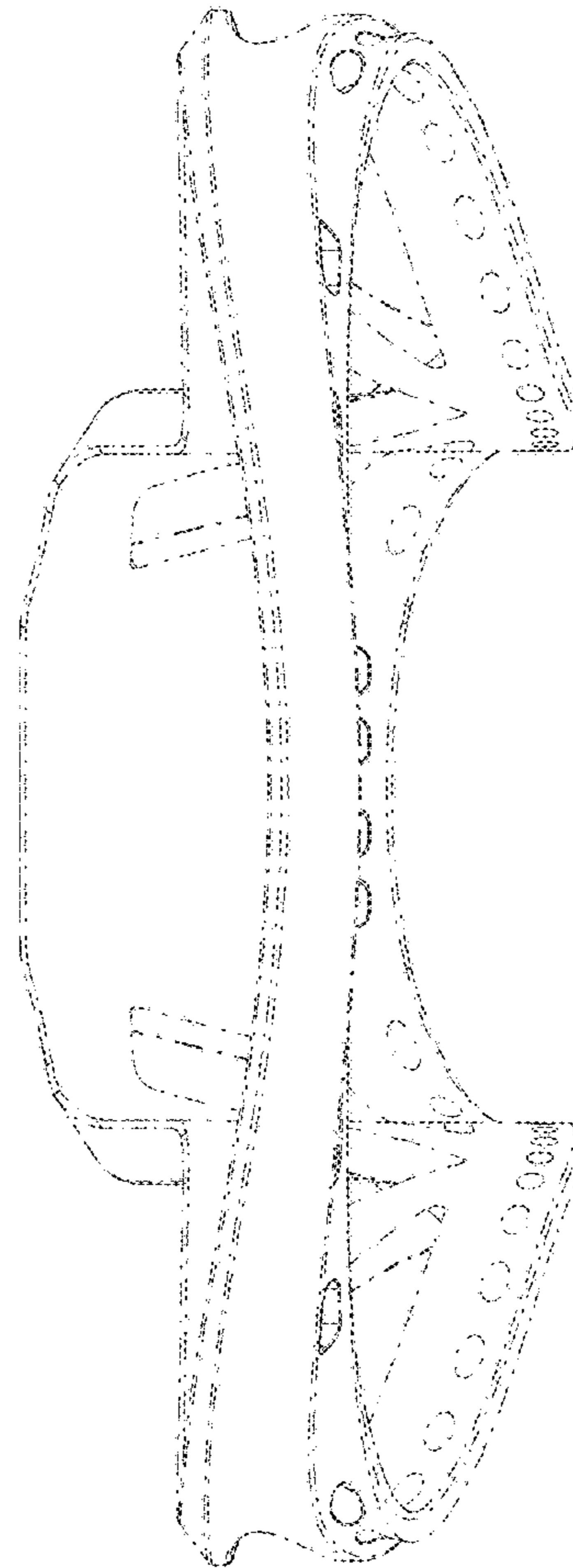

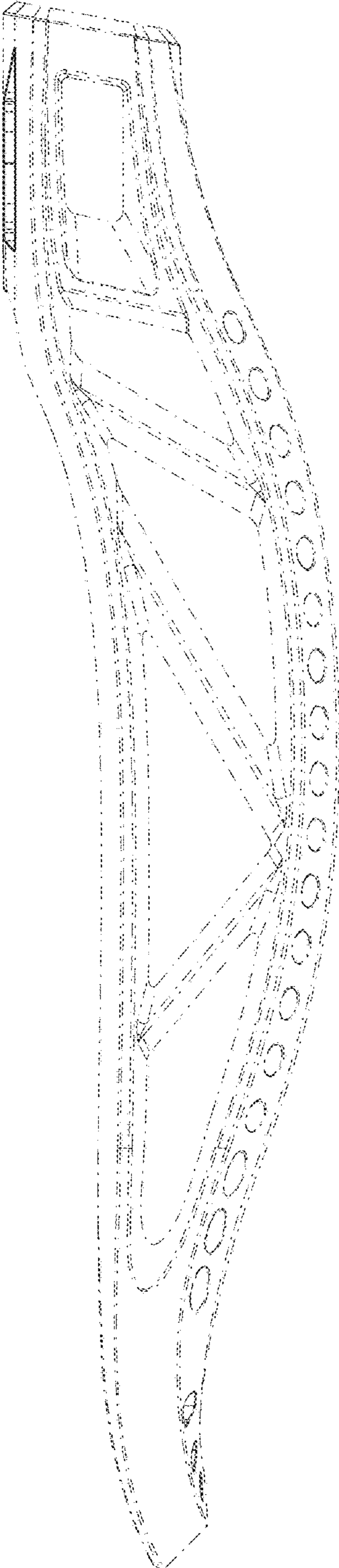

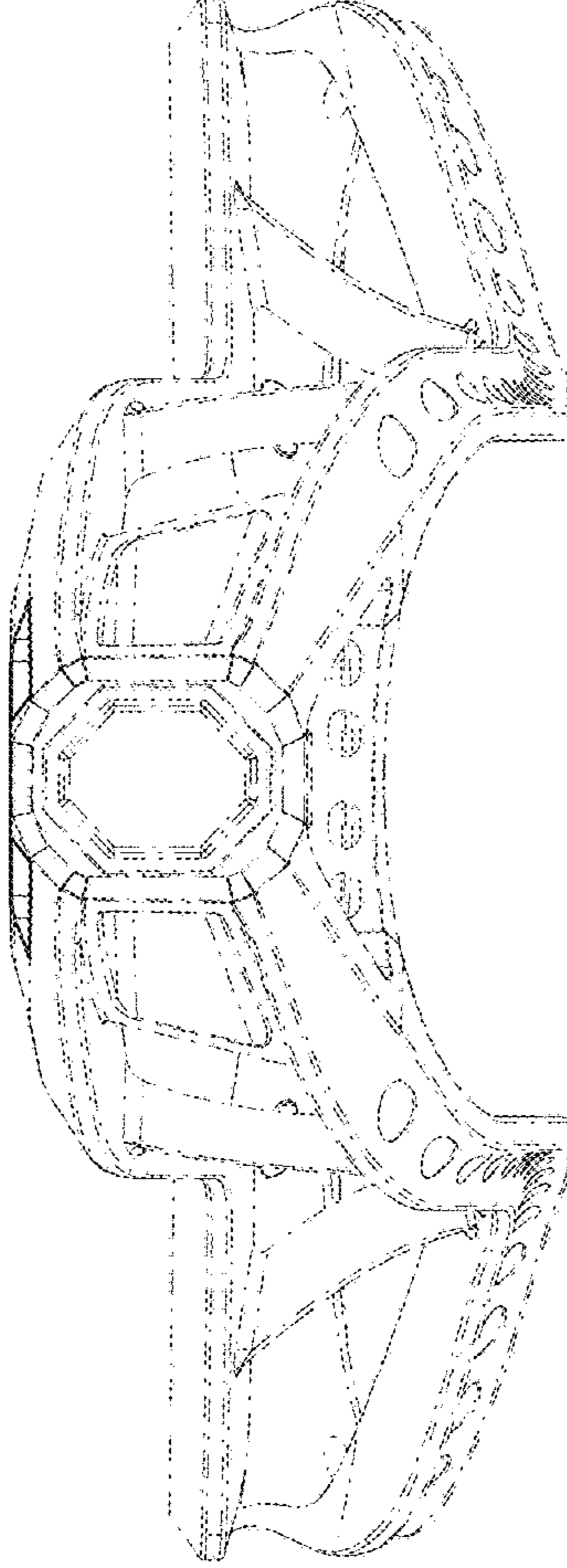

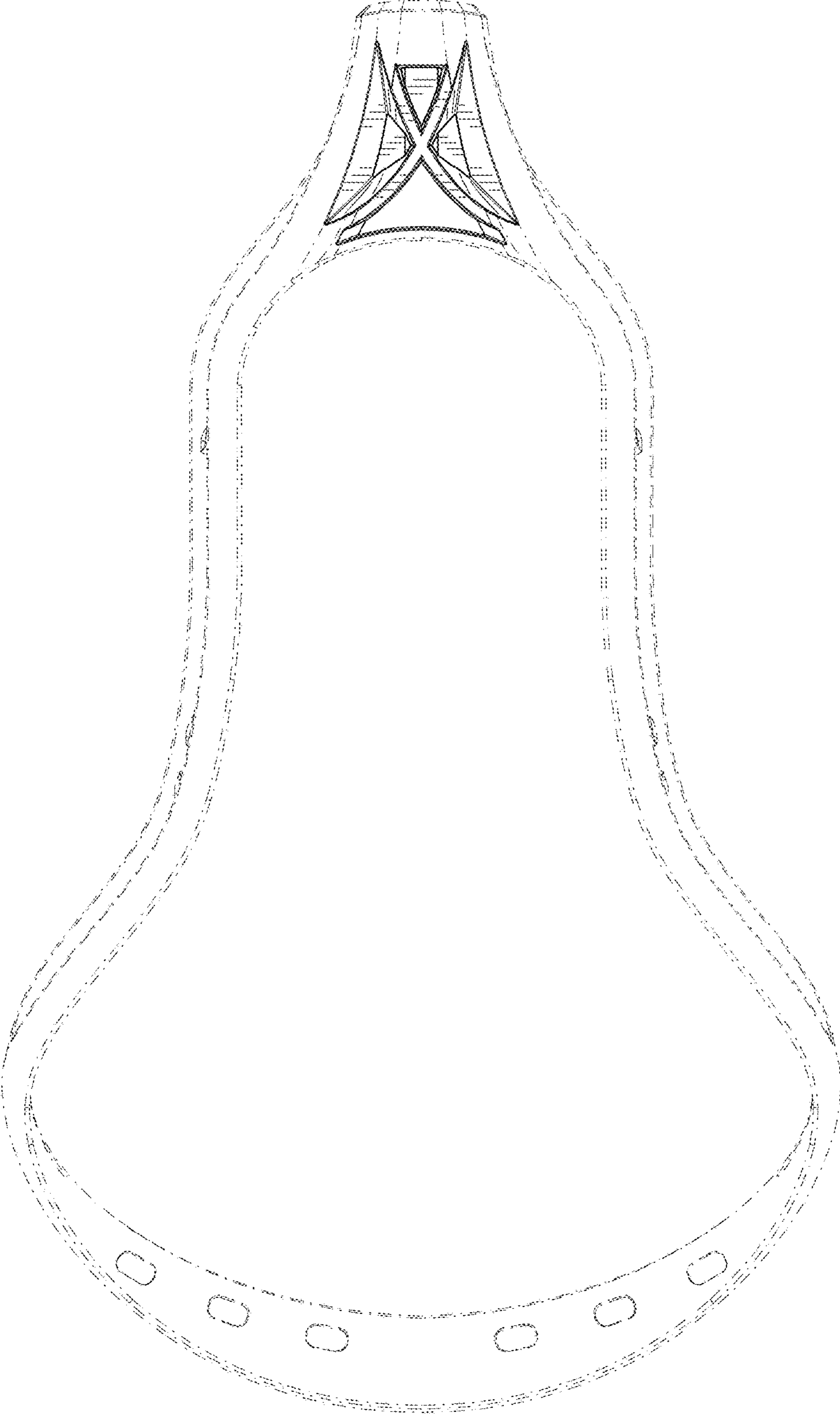

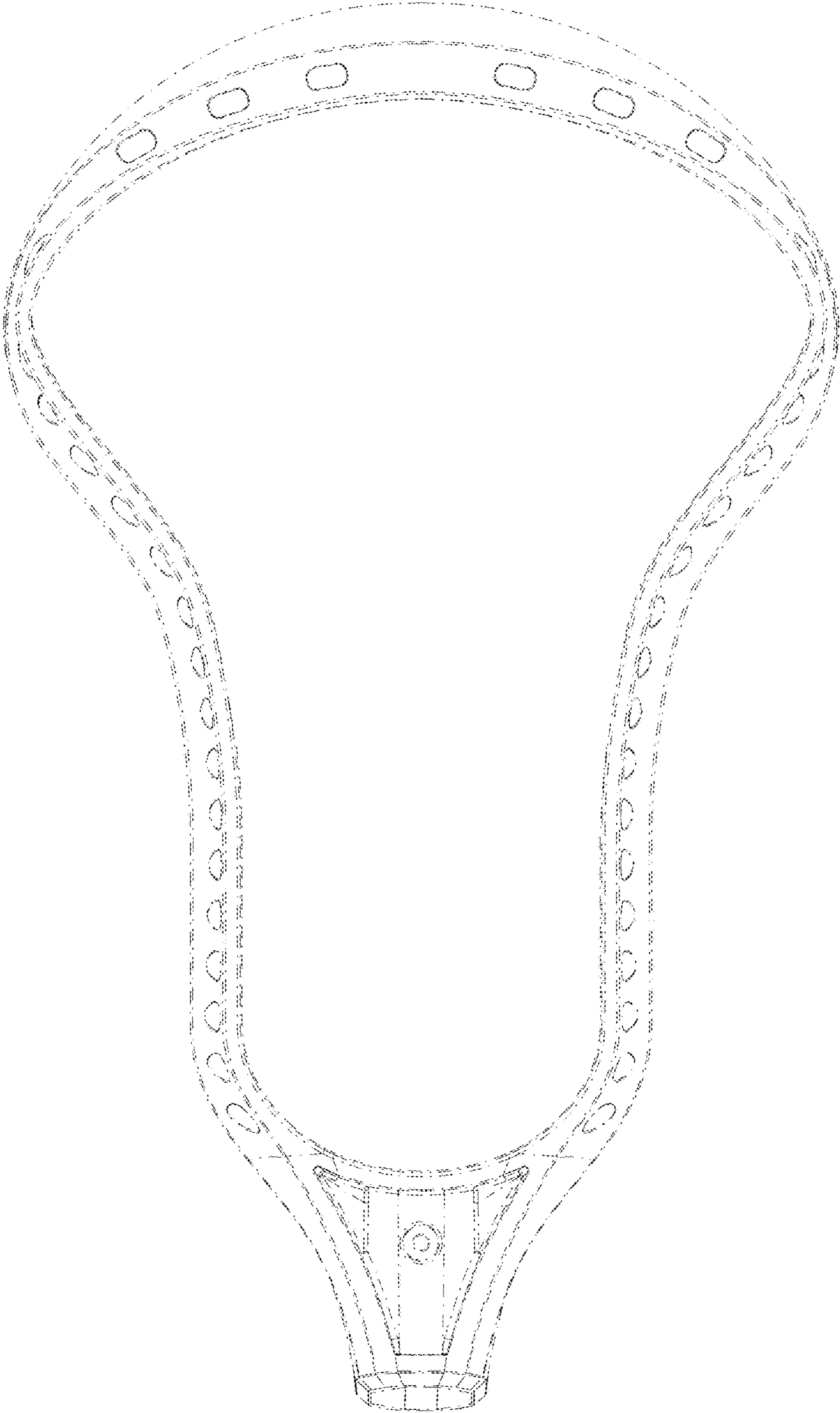
