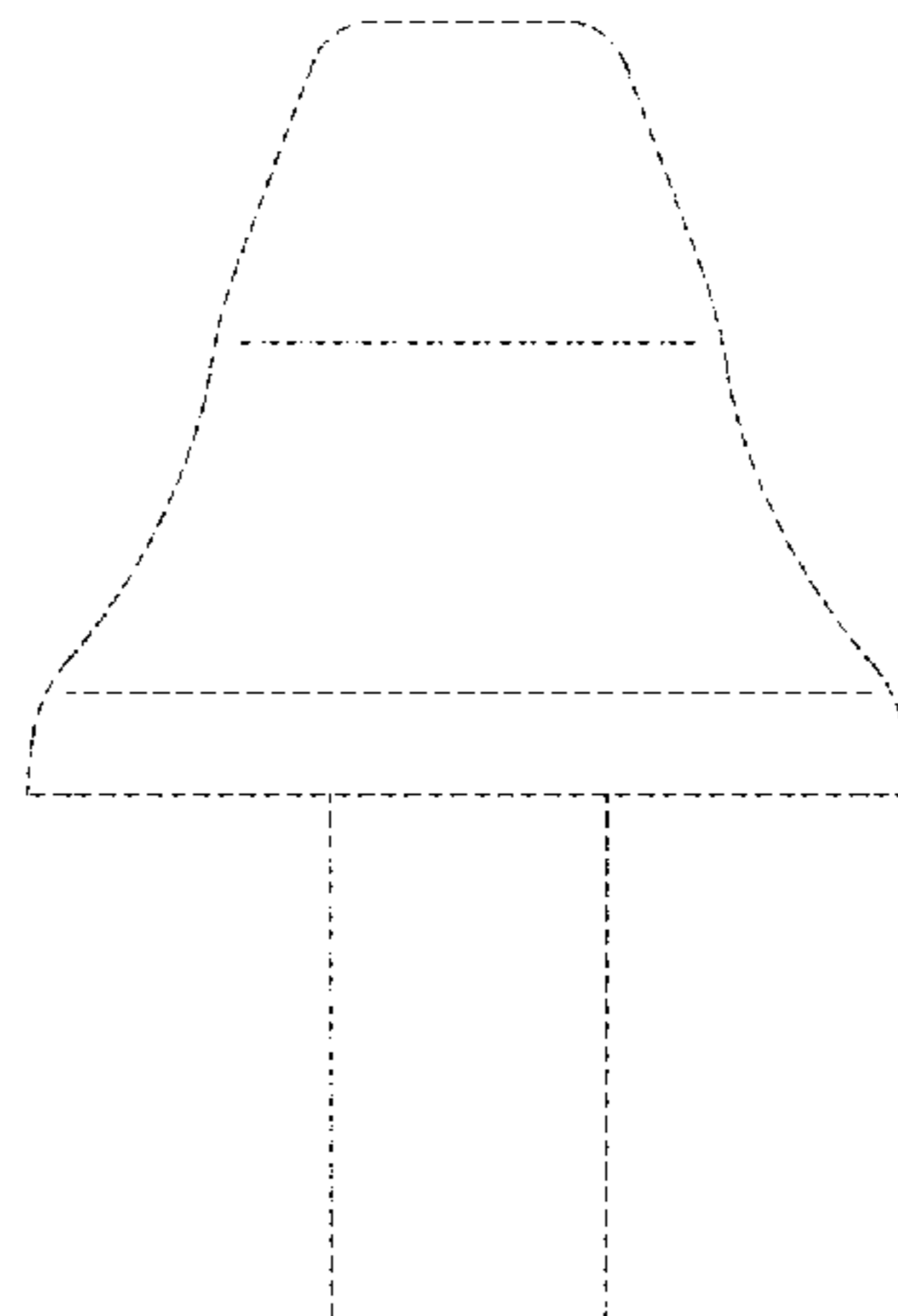
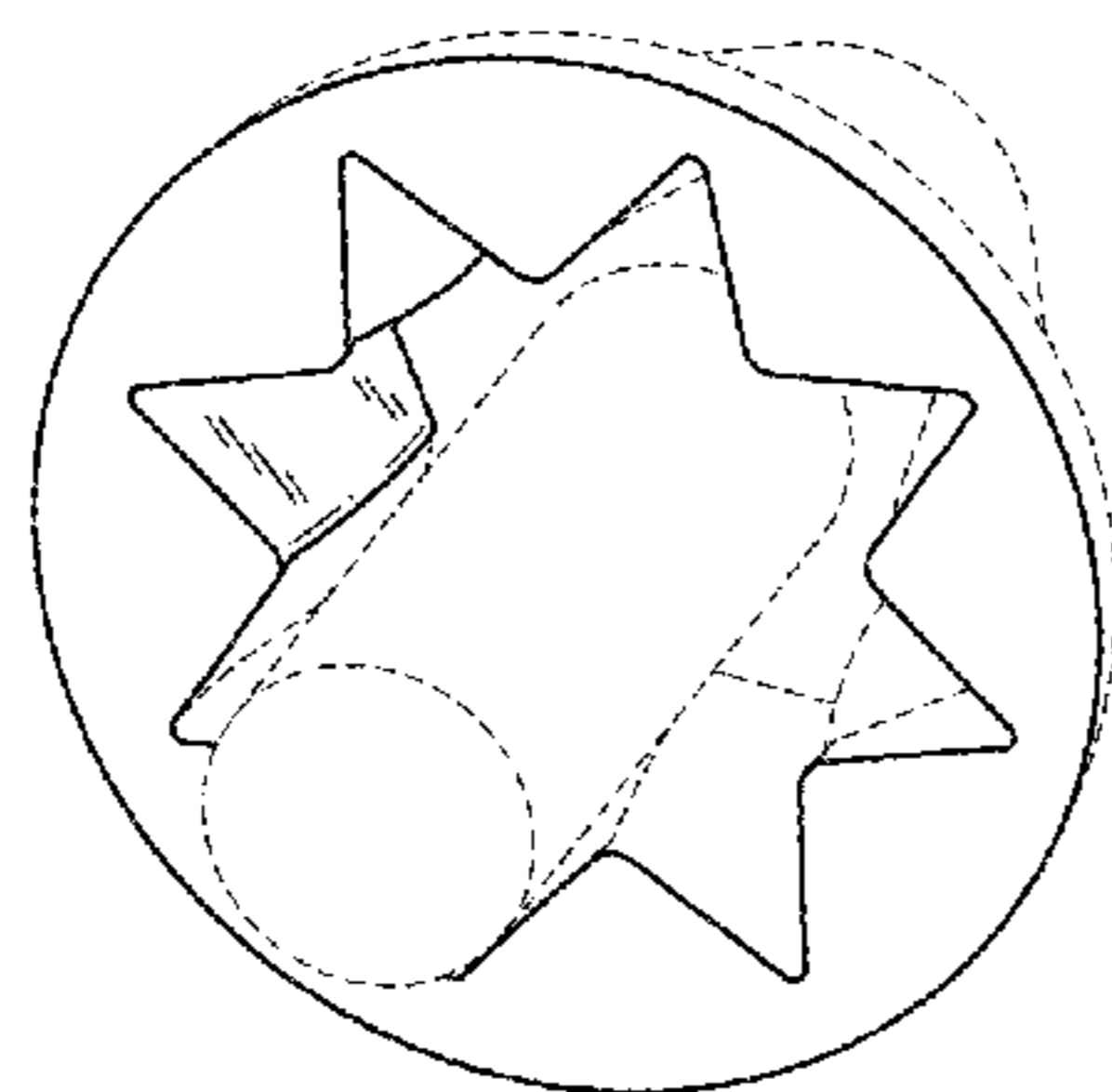
The ornamental design for an earplug, as shown and described.

FIG. 2 is a bottom view thereof;

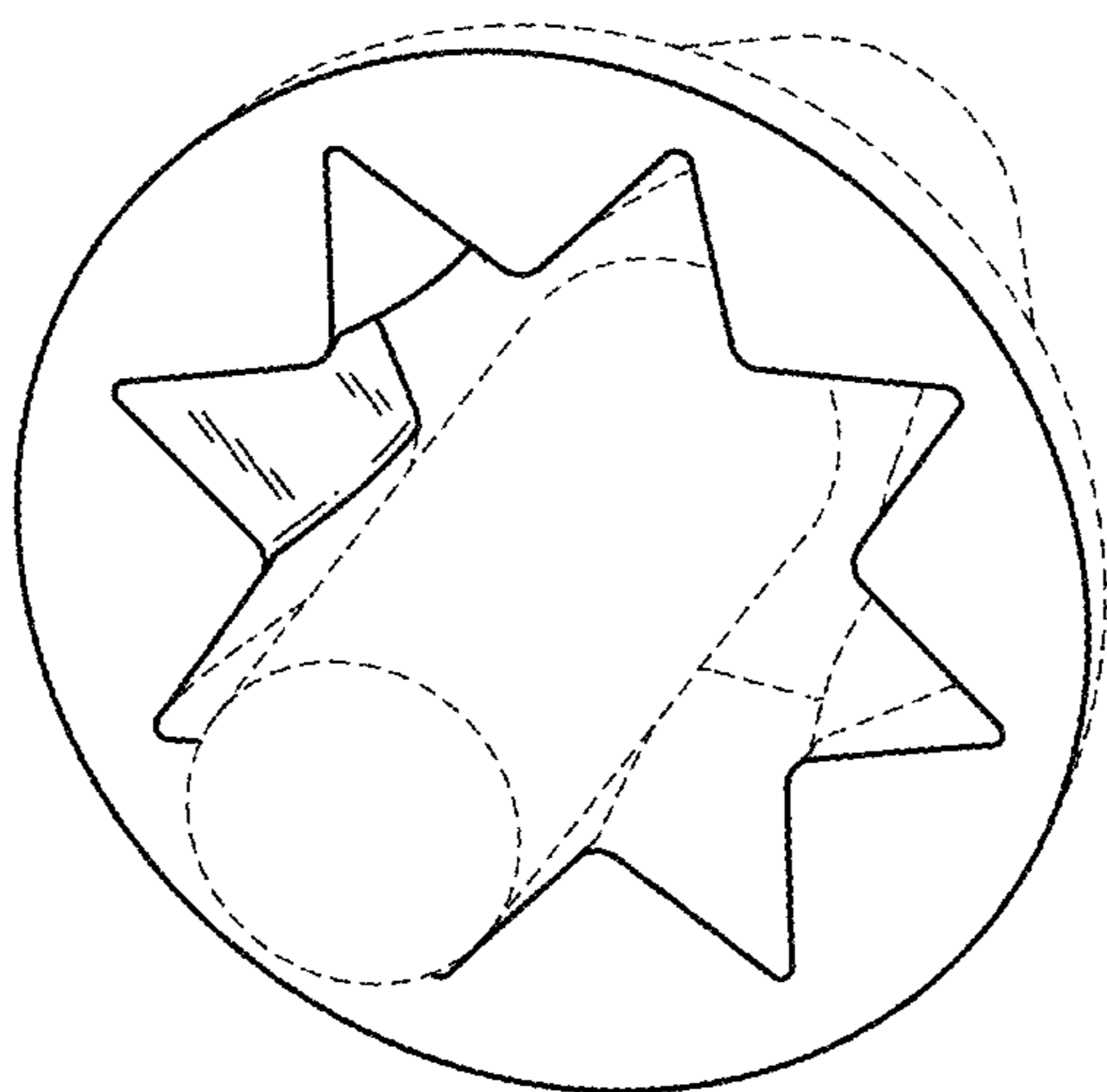

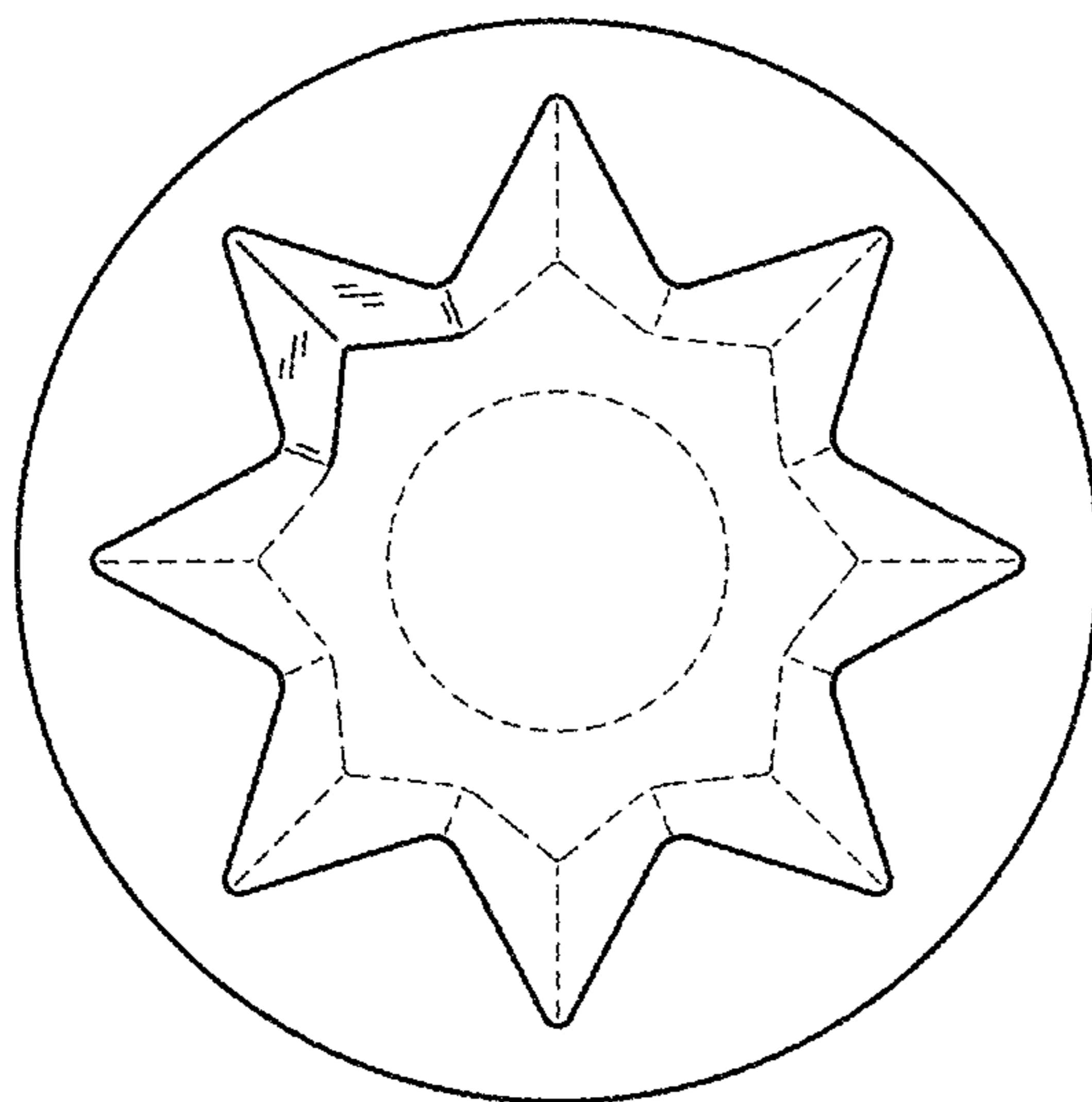

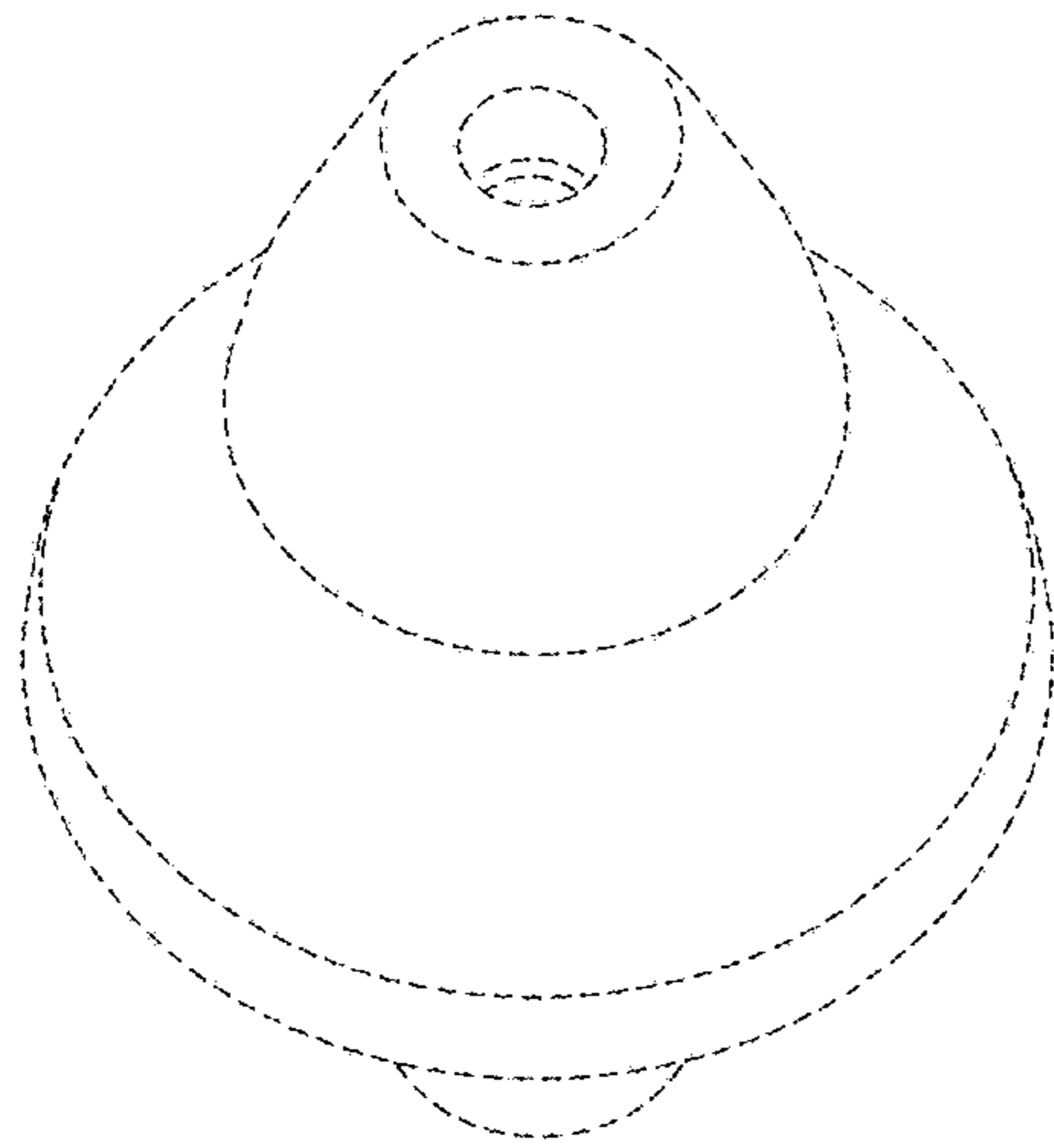

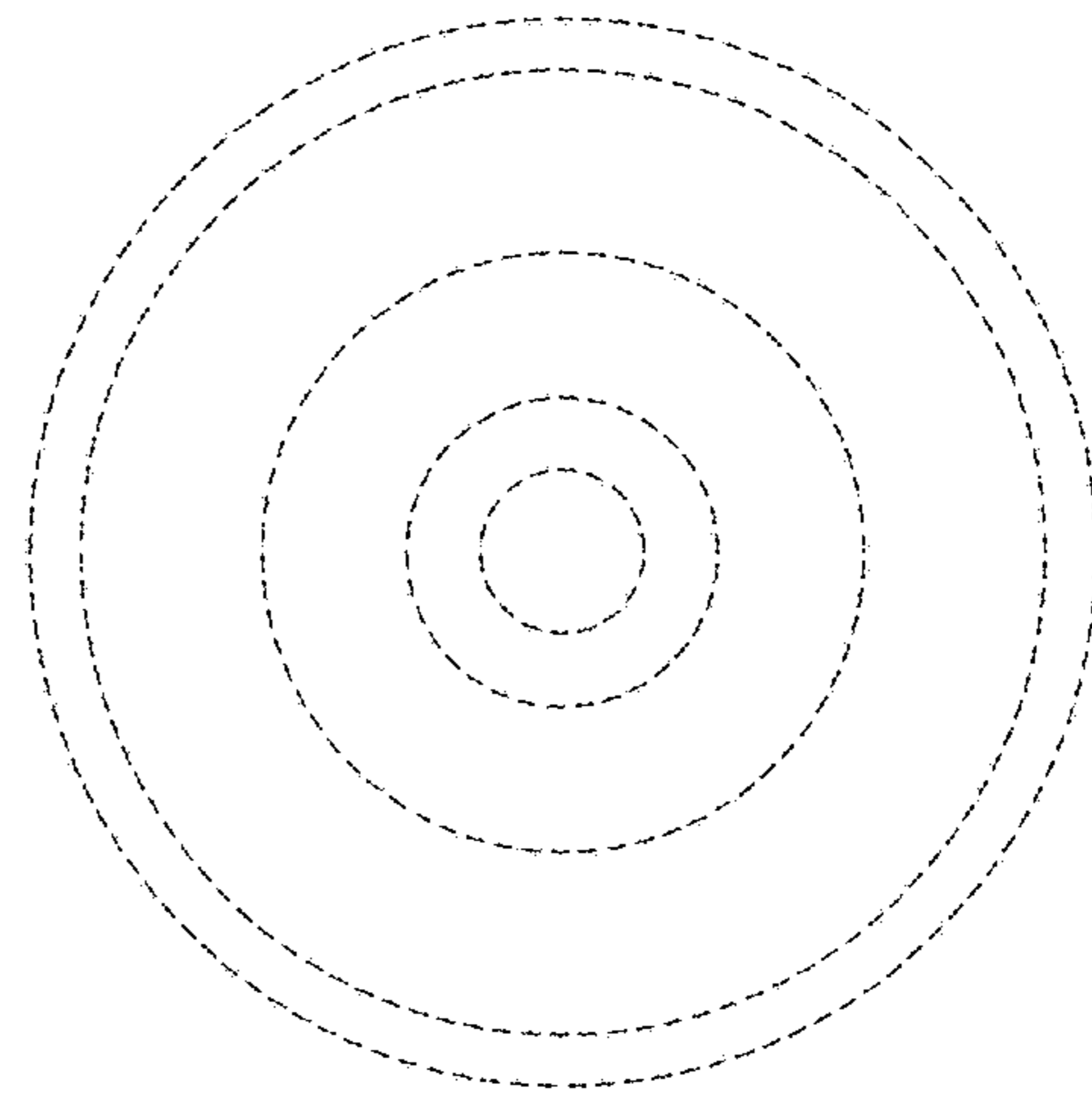

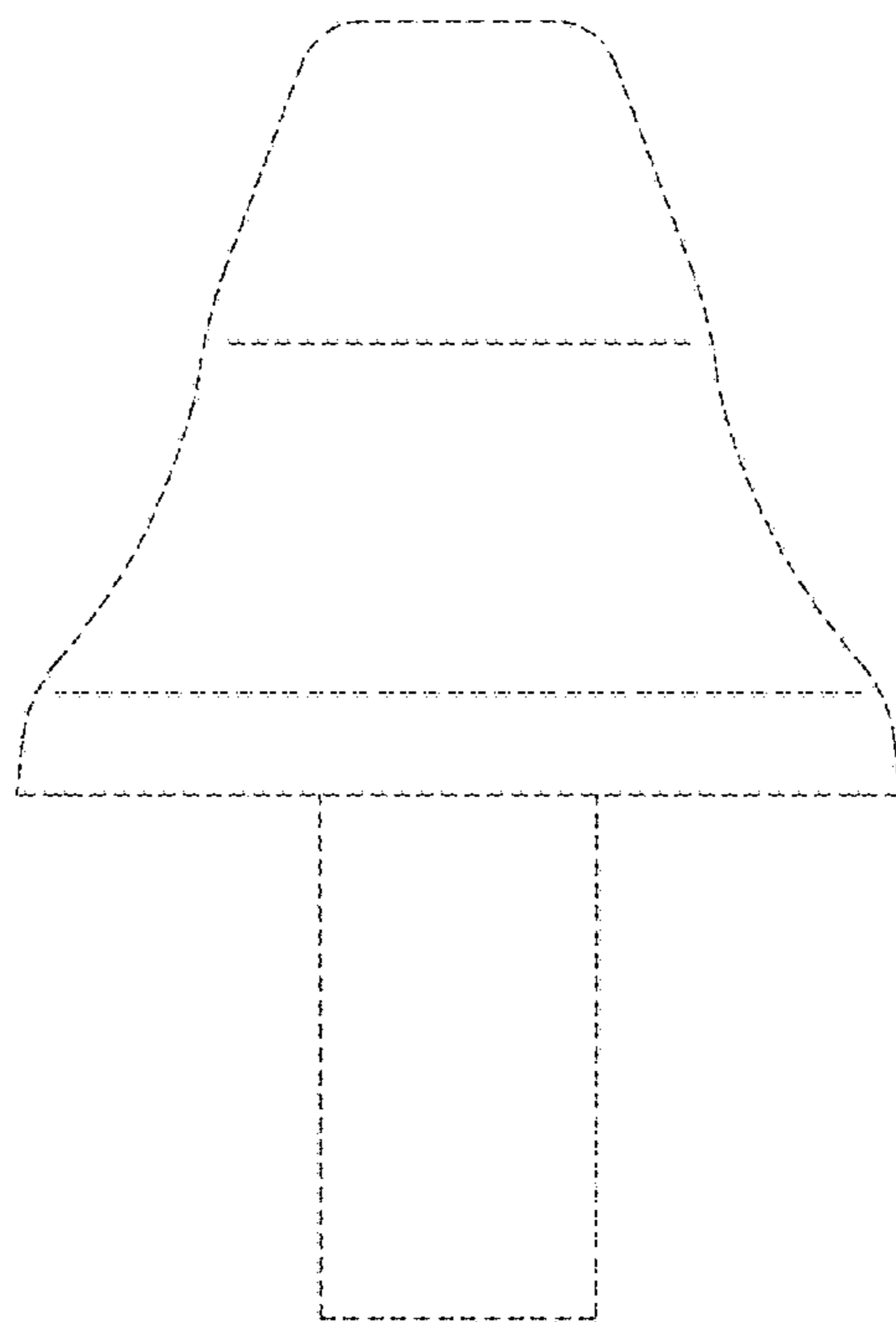
