The ornamental design for a heel protector, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of a heel protector.  
FIG. 2 is a second perspective view the heel protector of FIG. 1 showing the straps in an alternative configuration.  
FIG. 3 is a front view of the heel protector in the position of FIG. 2.  
FIG. 4 is a back view of the heel protector of FIG. 1.  
FIG. 5 is a right-side view of the heel protector of FIG. 1.  
FIG. 6 is a left-side view of the heel protector of FIG. 1.  
FIG. 7 is a top view of the heel protector of FIG. 1; and,  
FIG. 8 is a bottom view of the heel protector of FIG. 1.

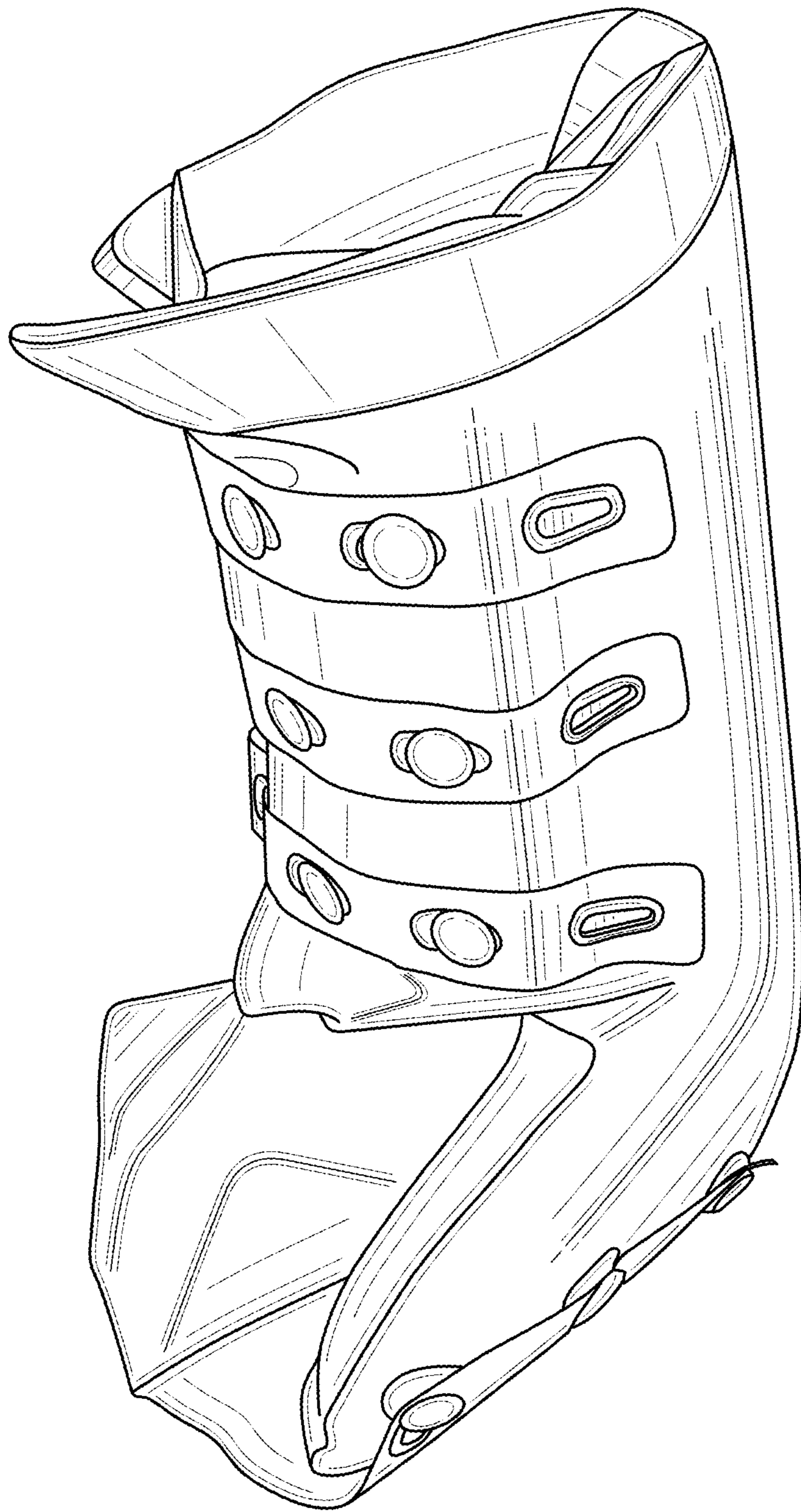

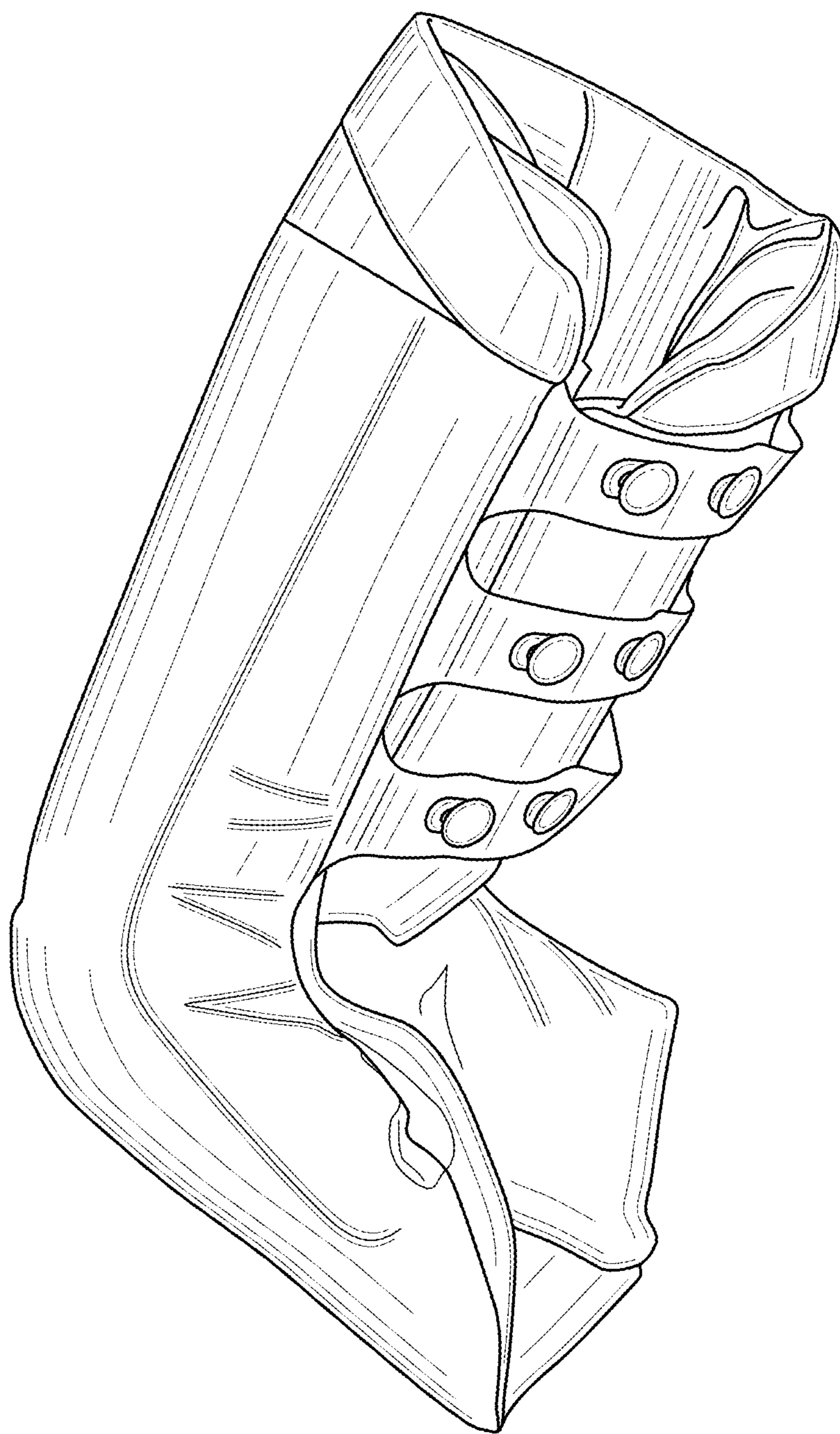

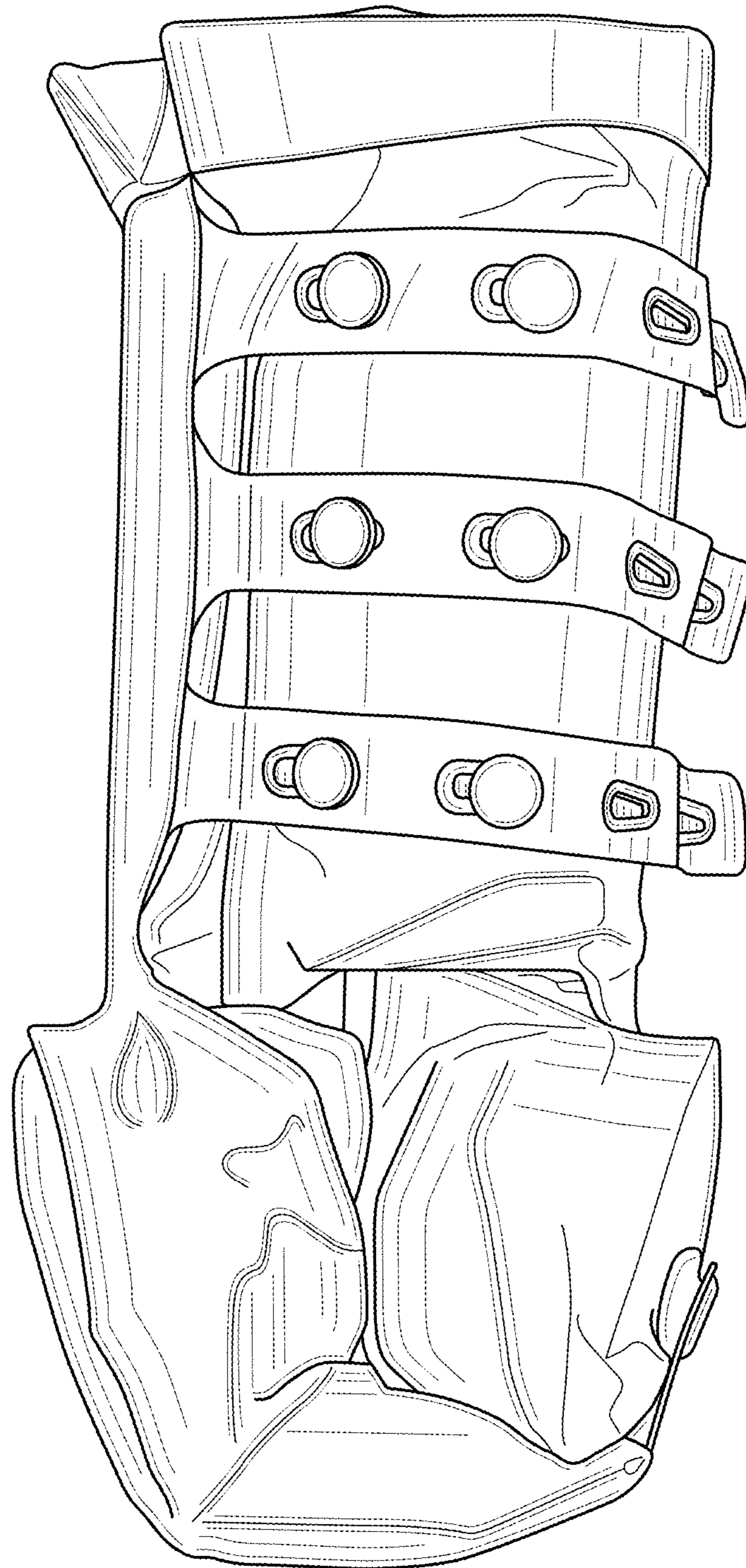

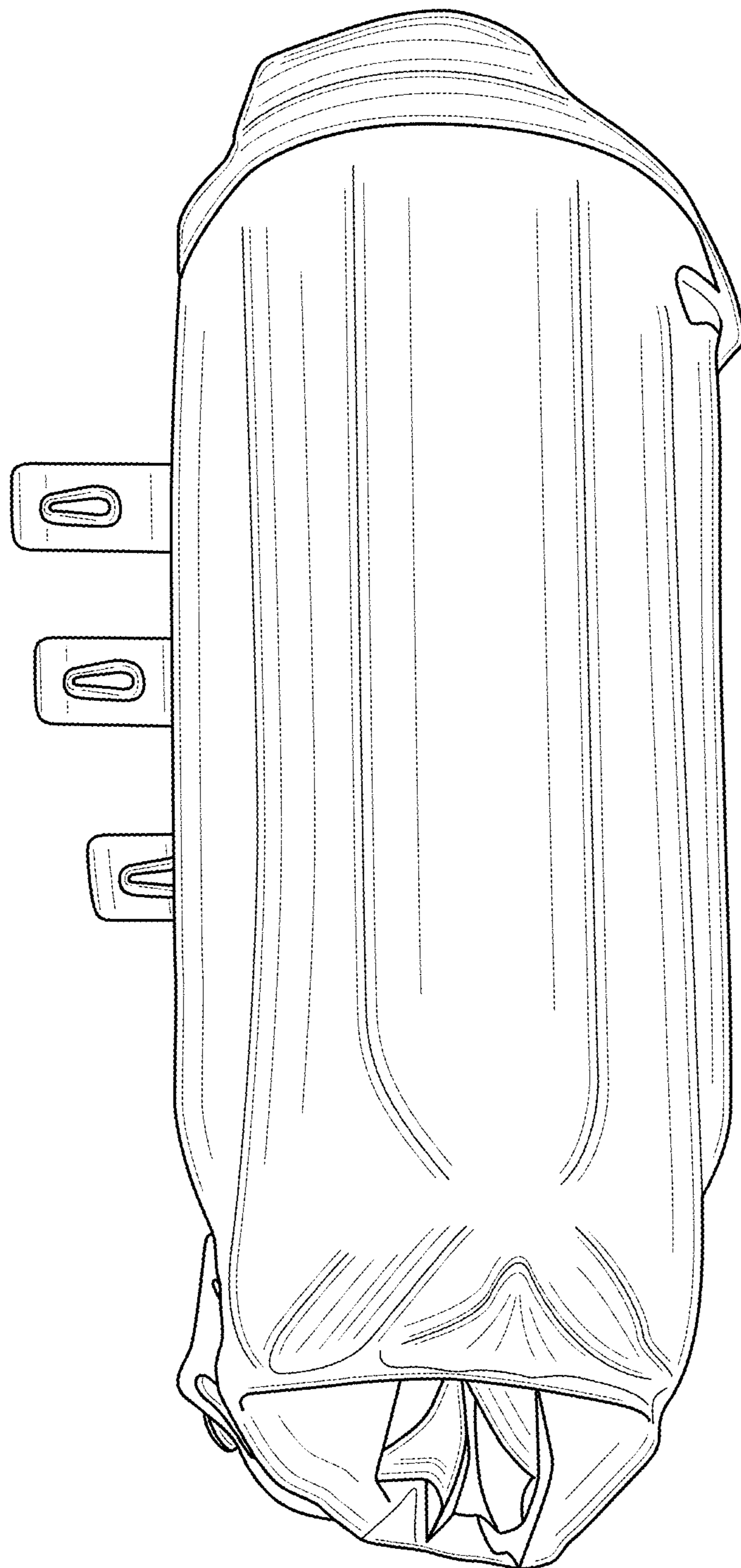

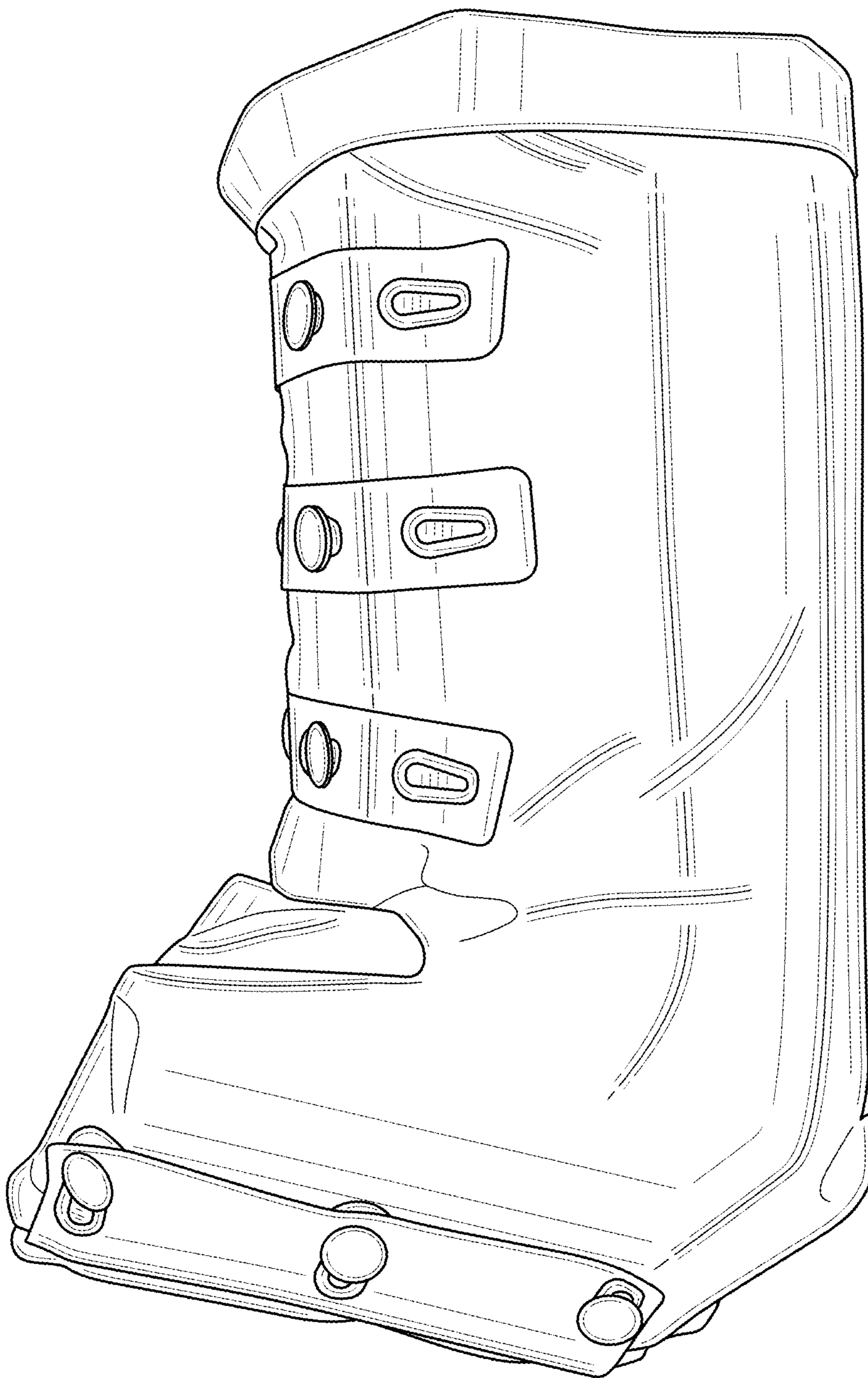

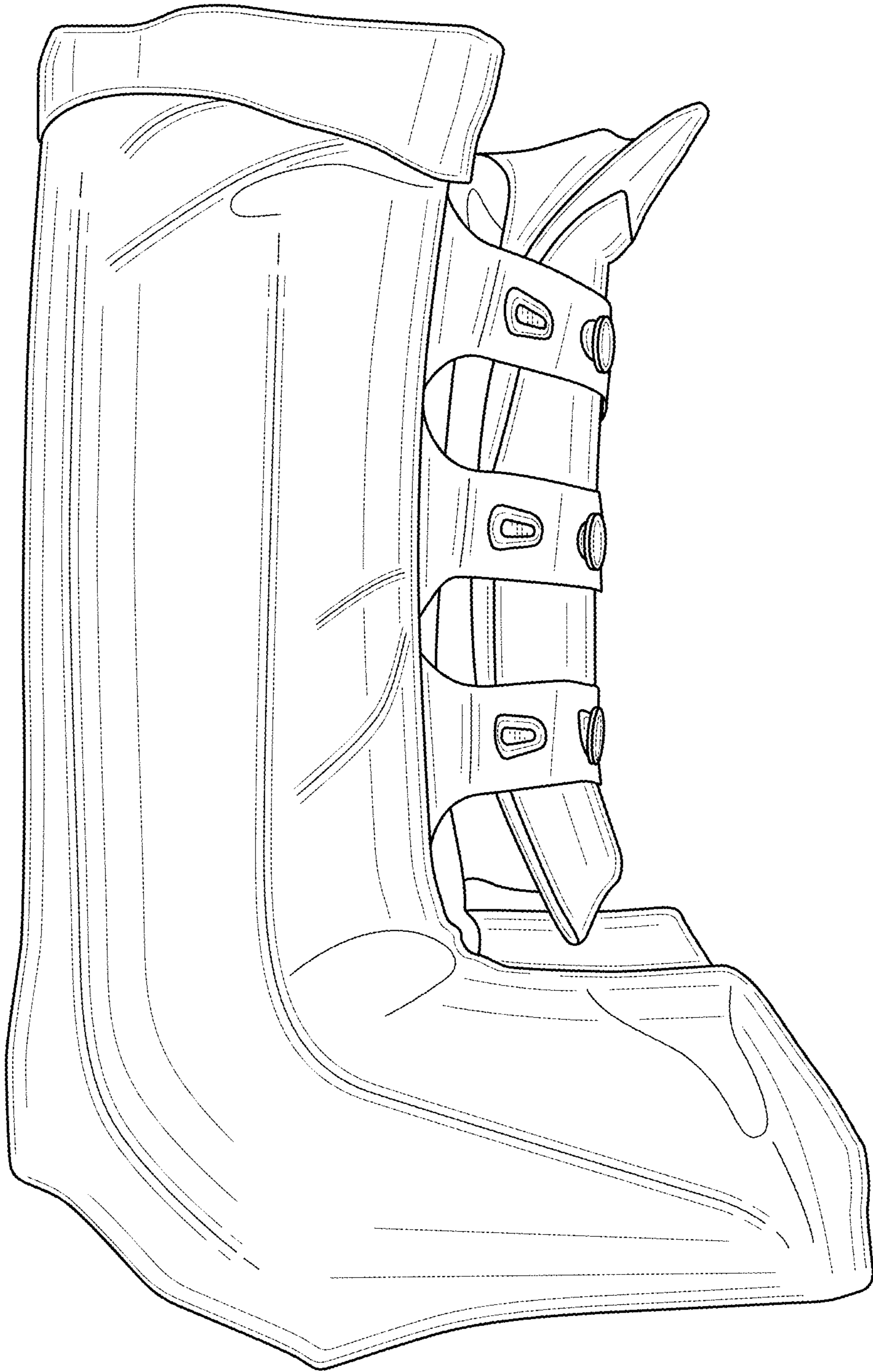

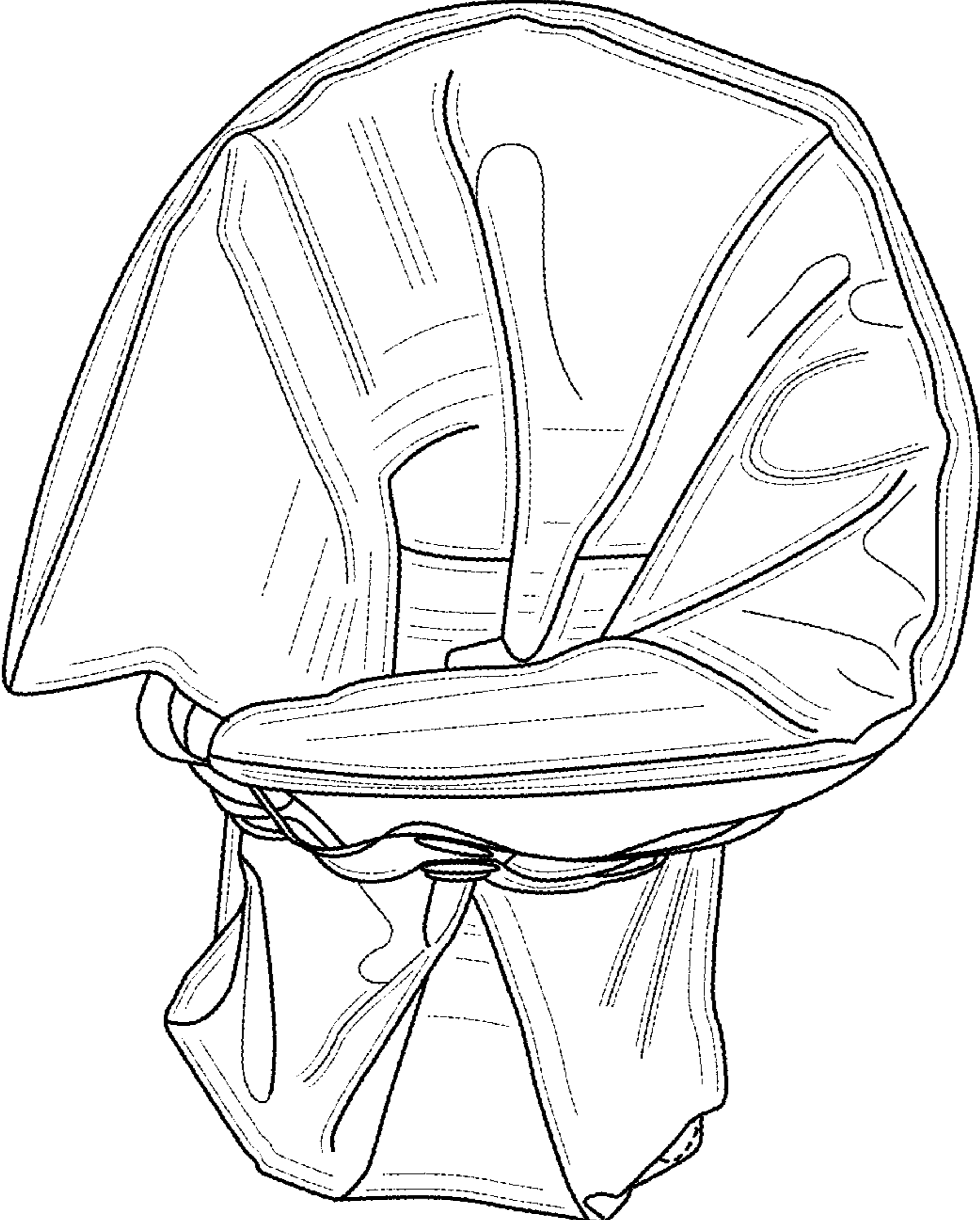

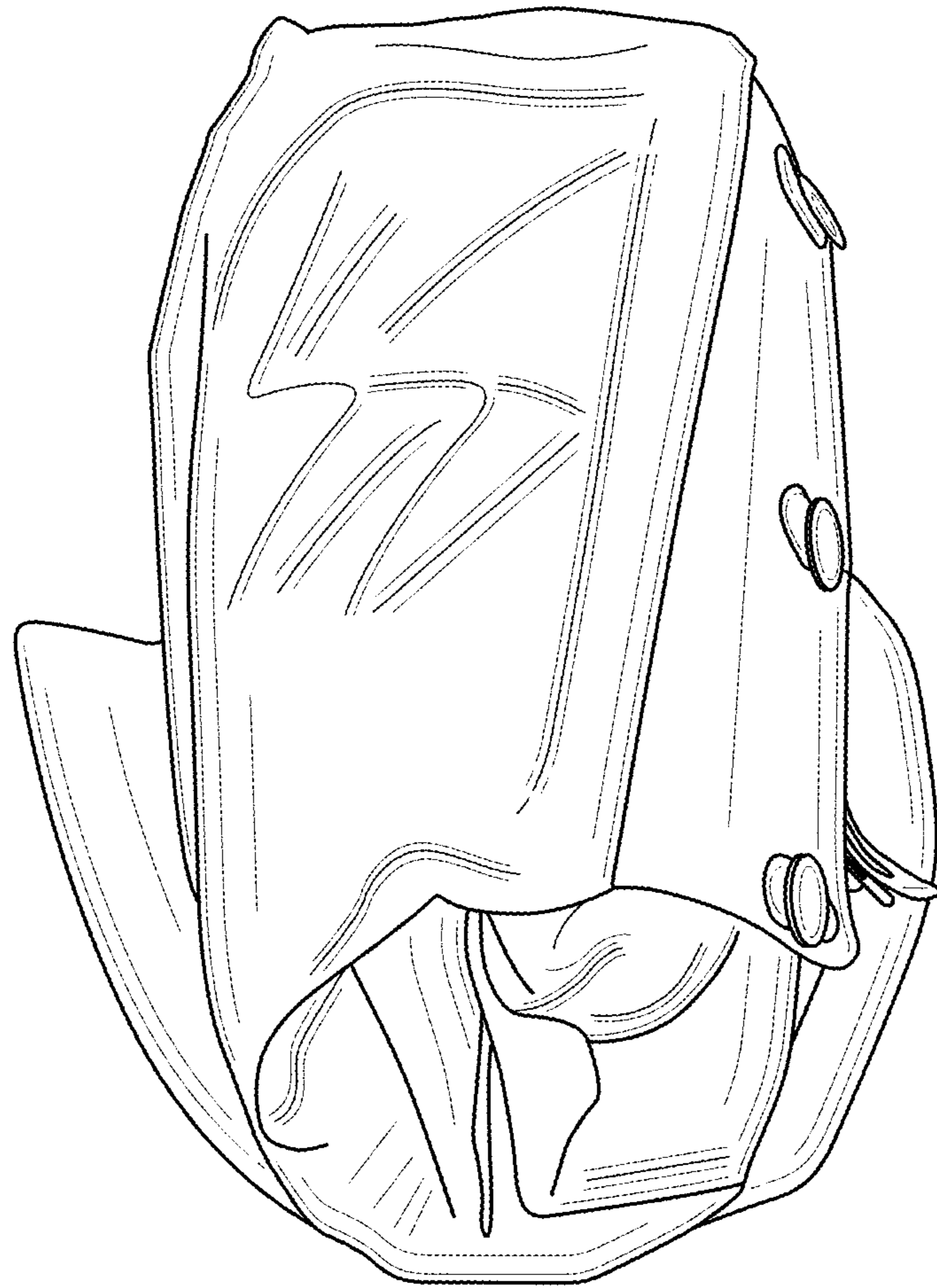
