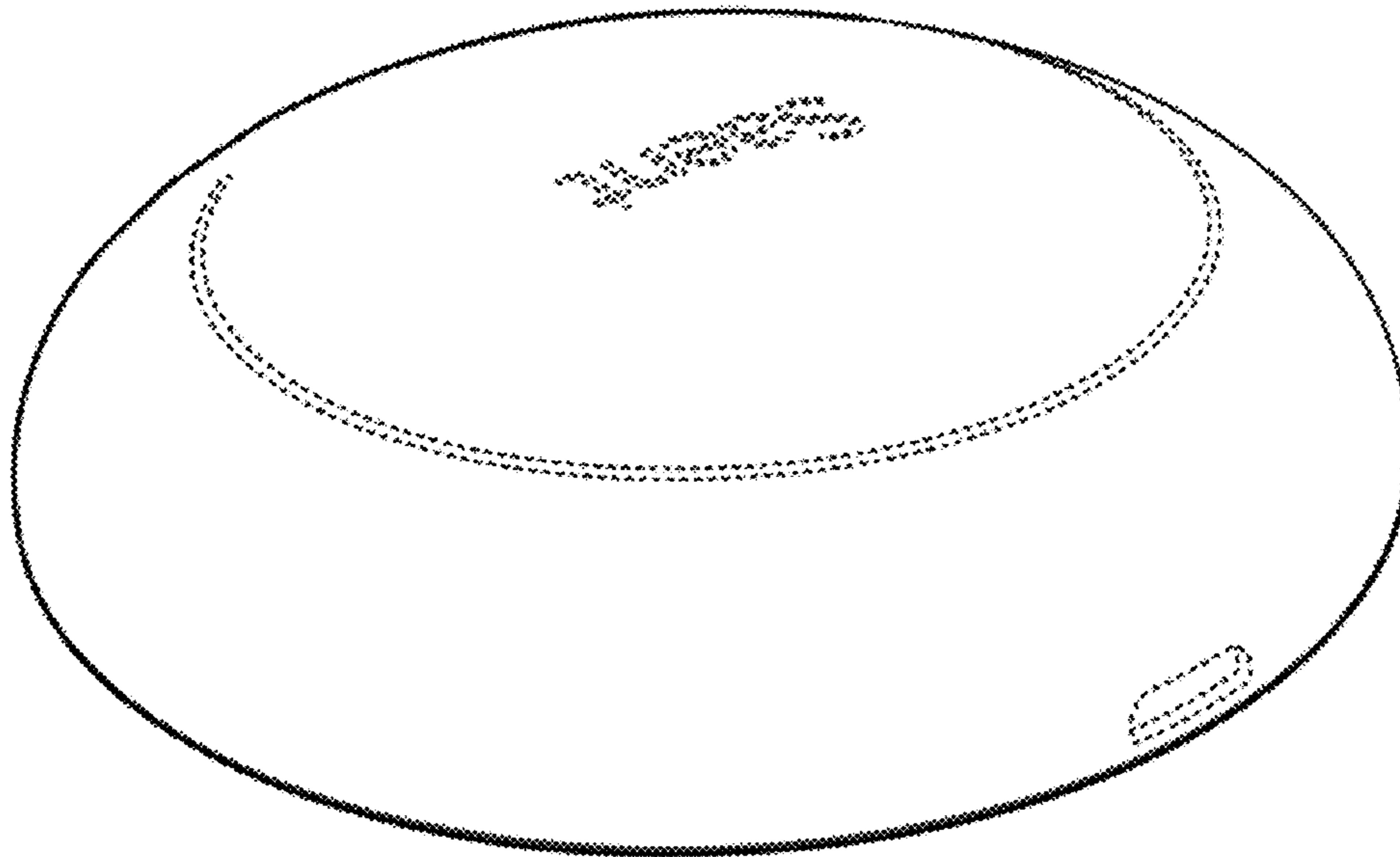
The broken line disclosure represents portions of the button which forms no part of the claimed design.

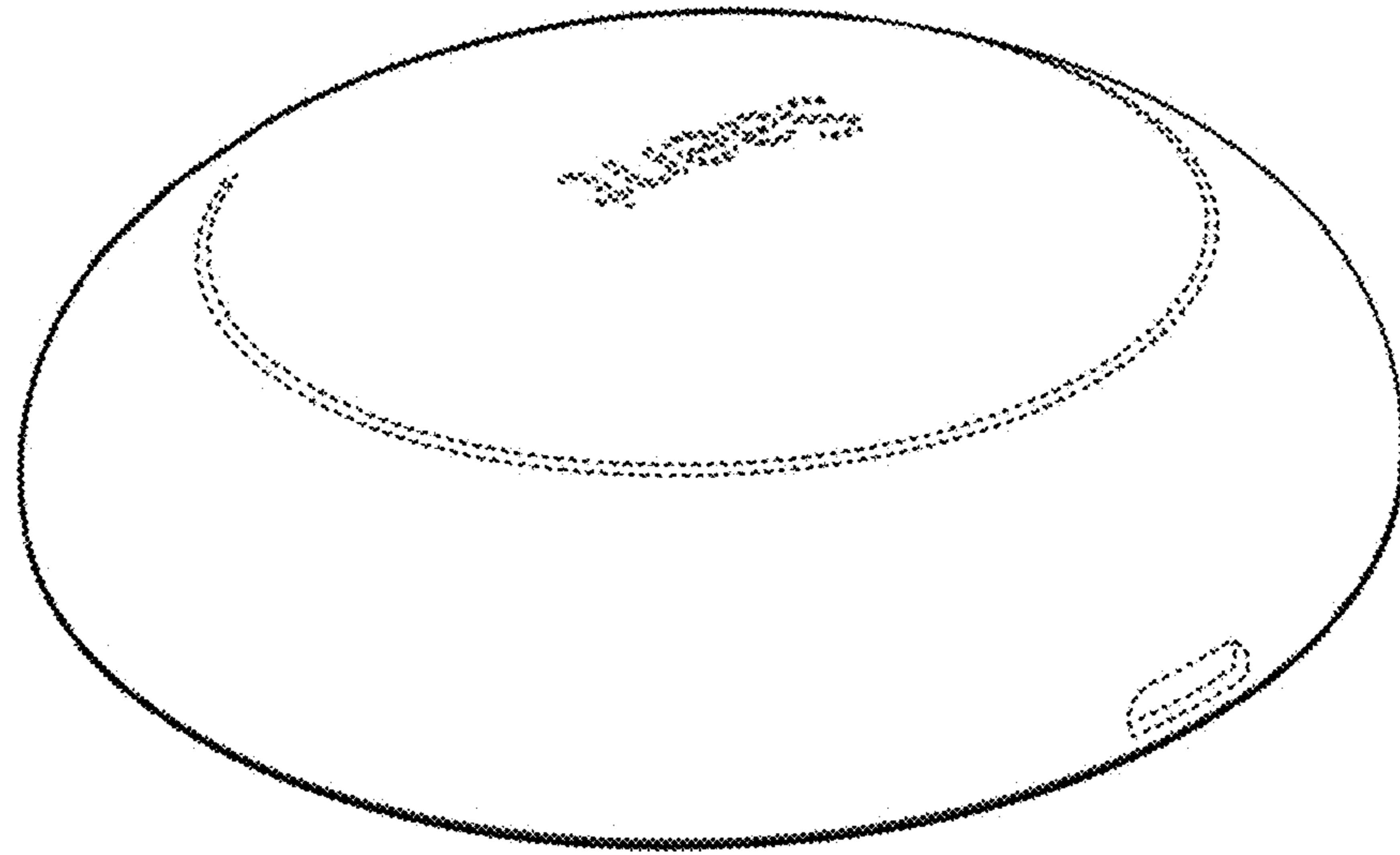

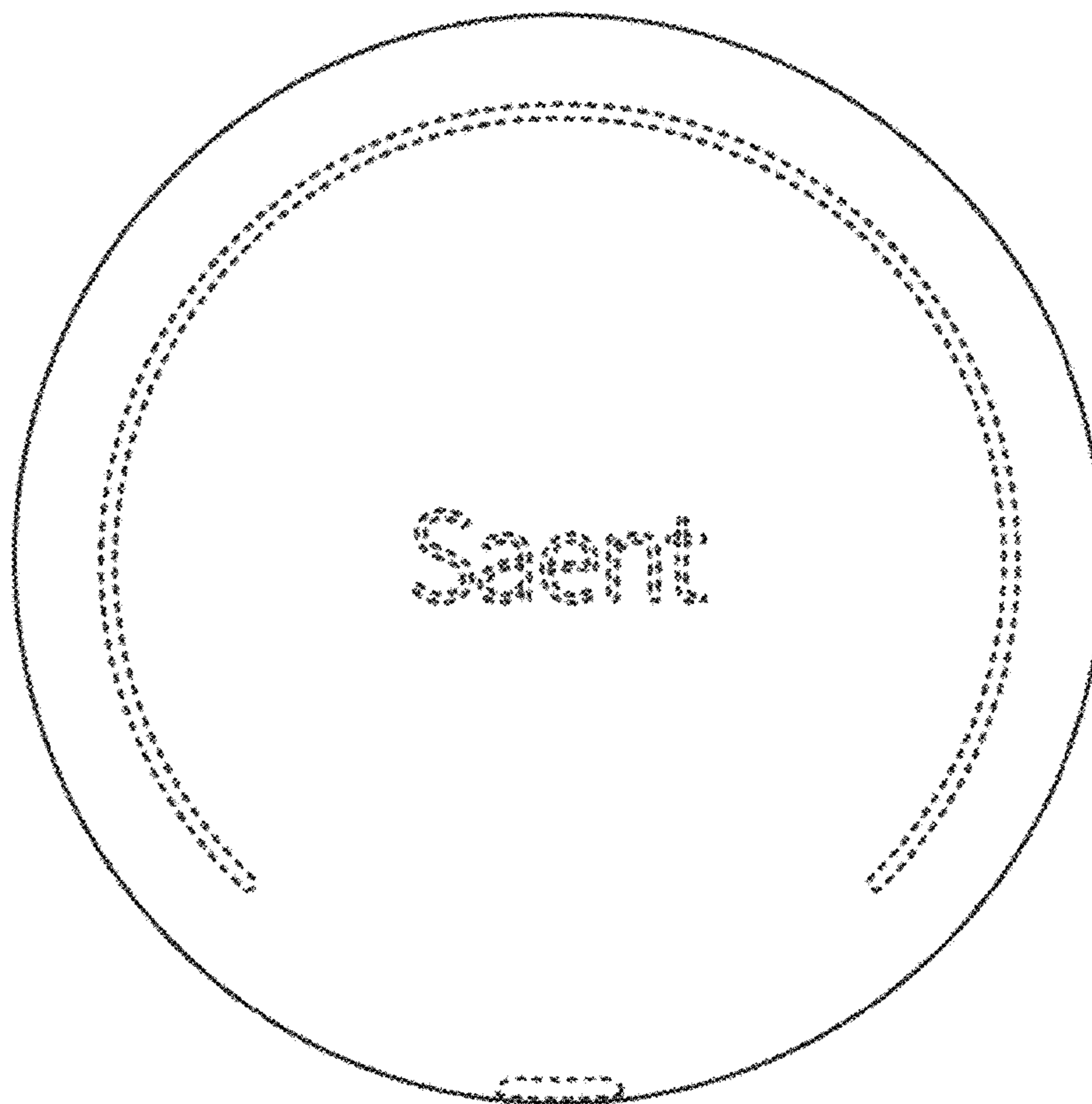

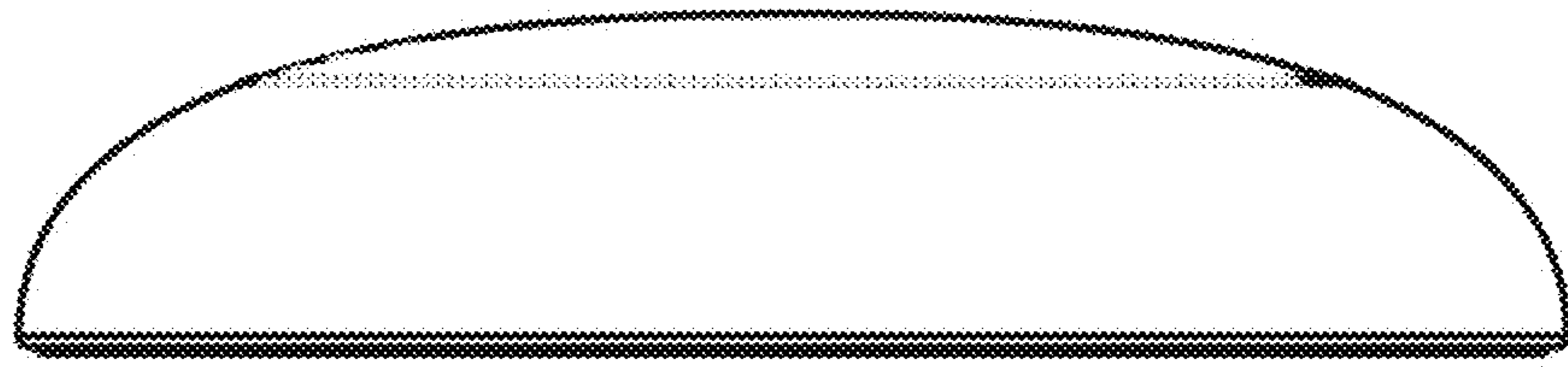

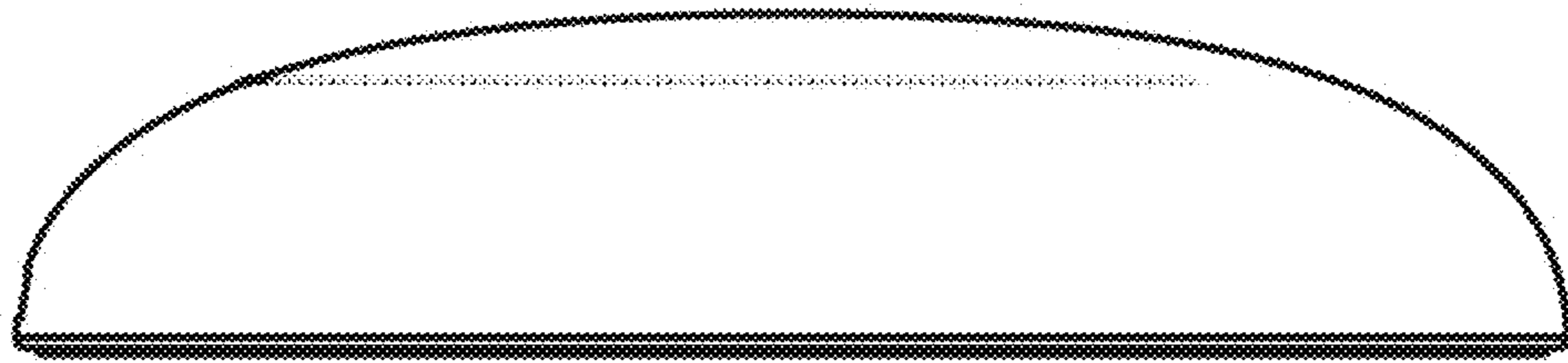

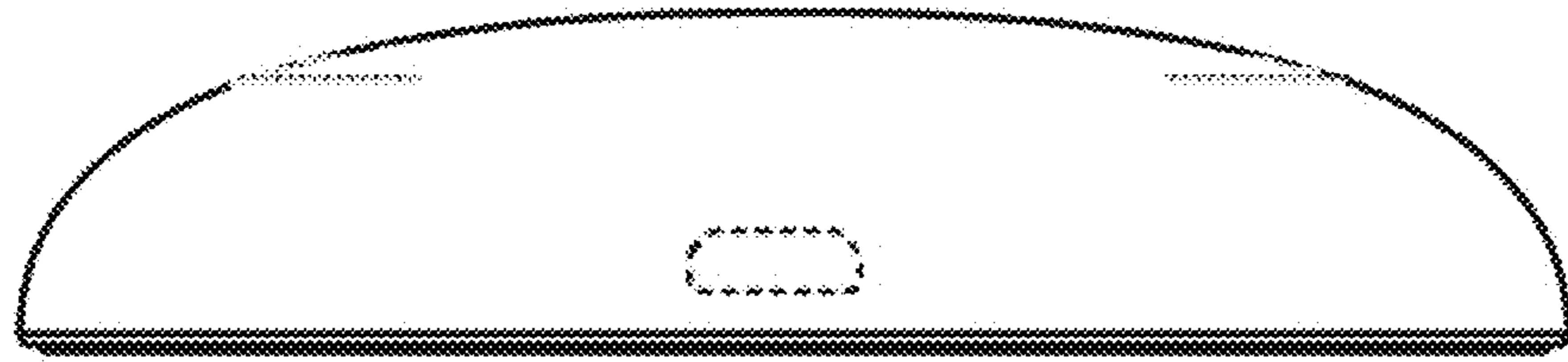

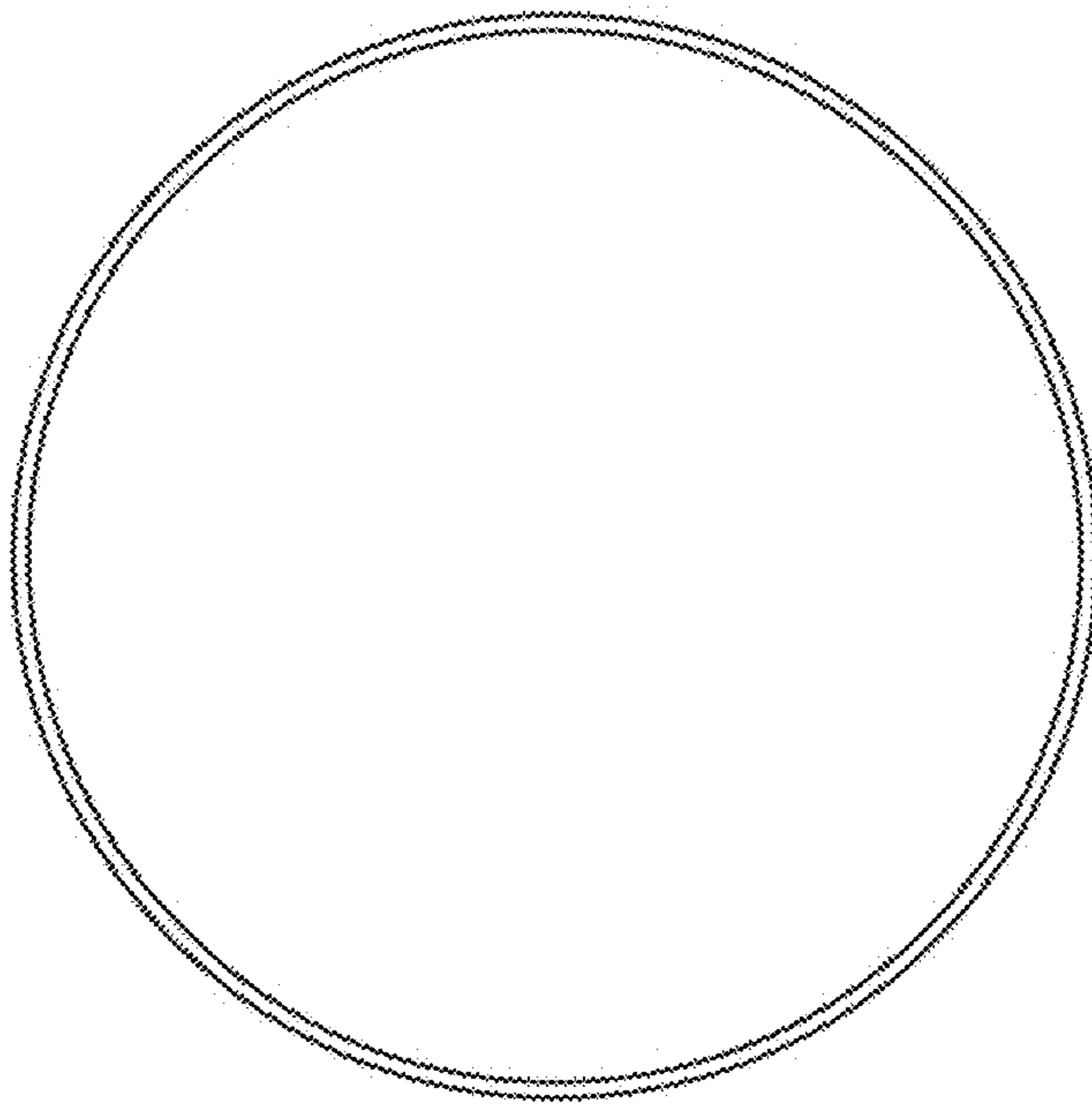
