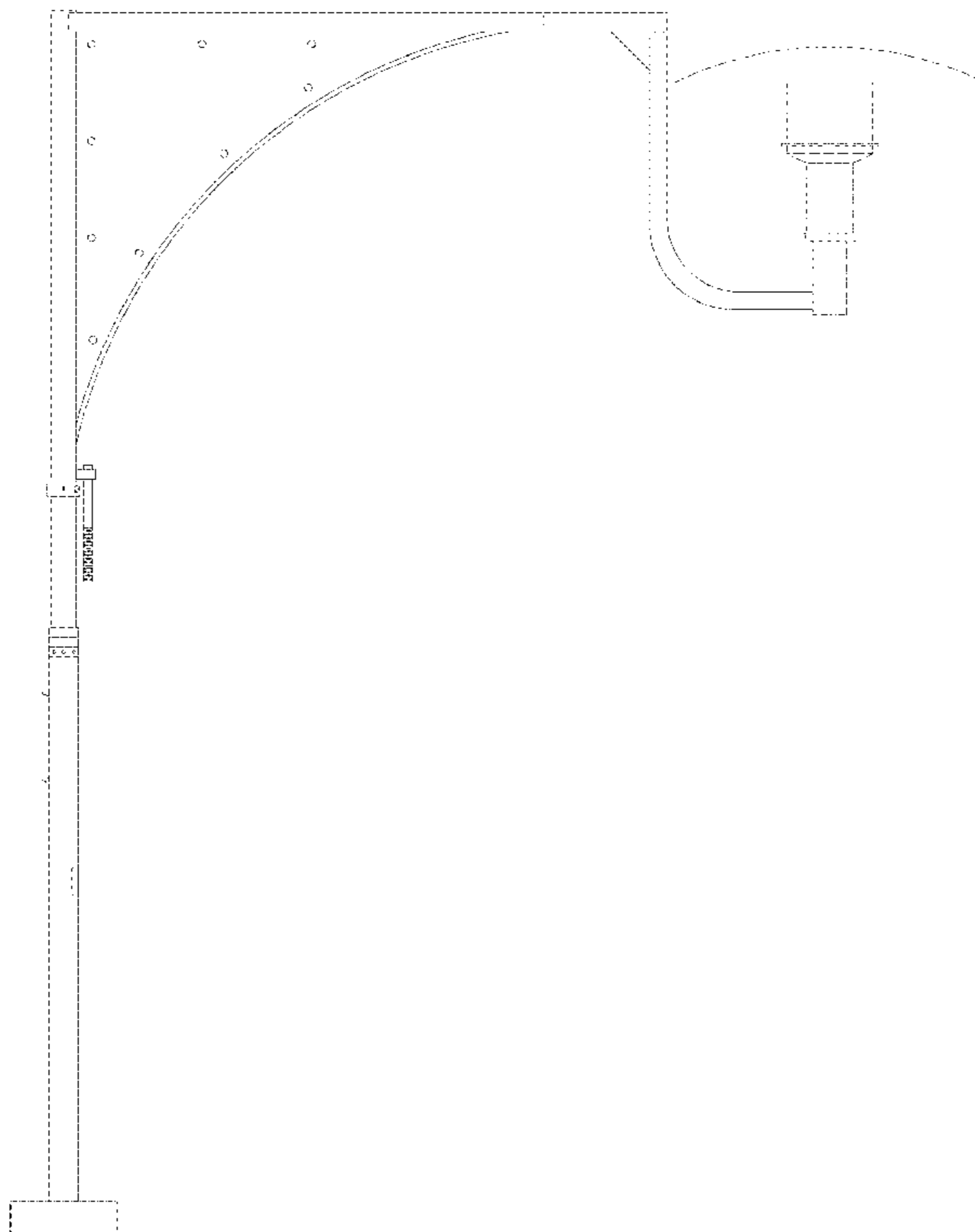

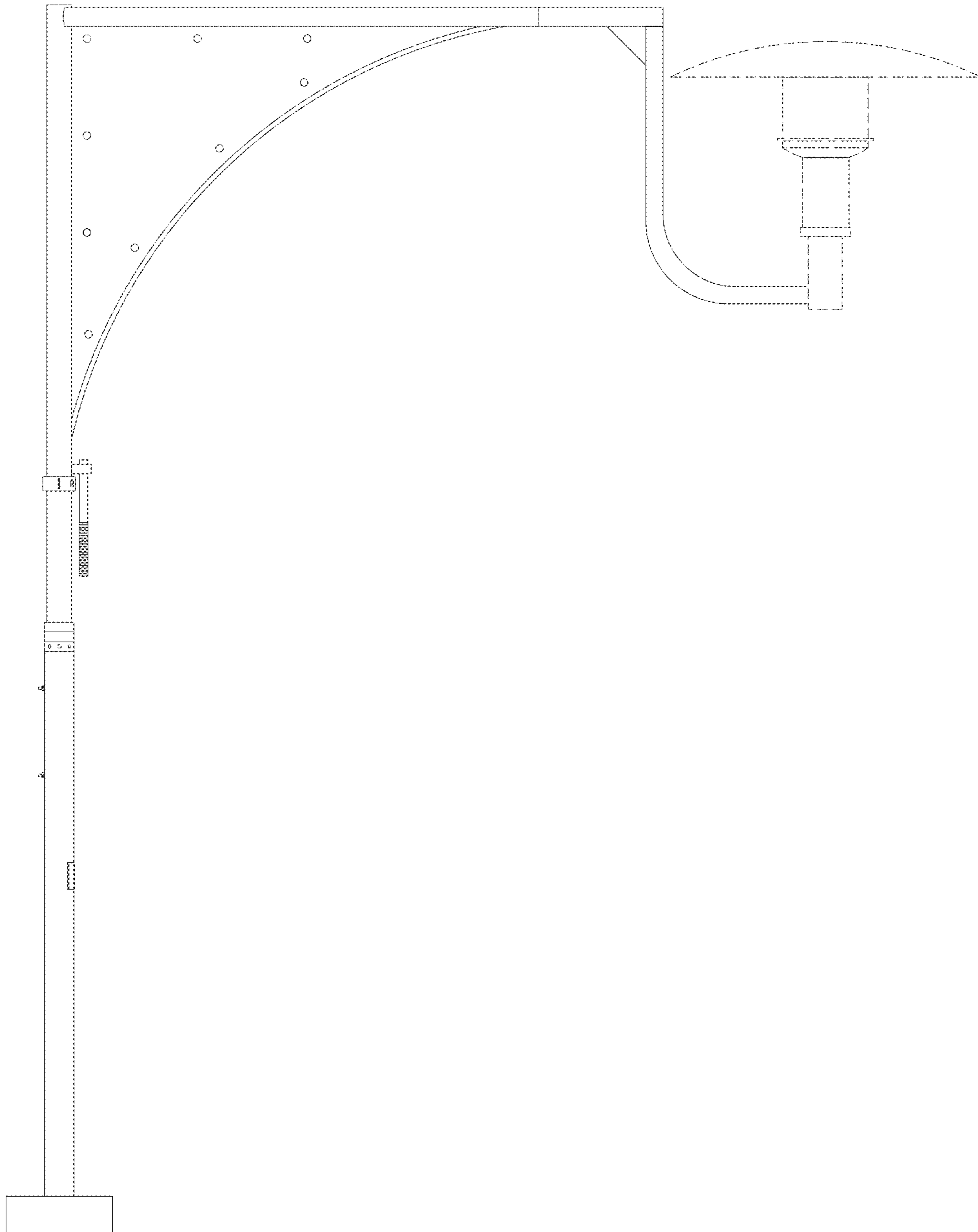
The ornamental design for a swiveling support arm, as

**DESCRIPTION**

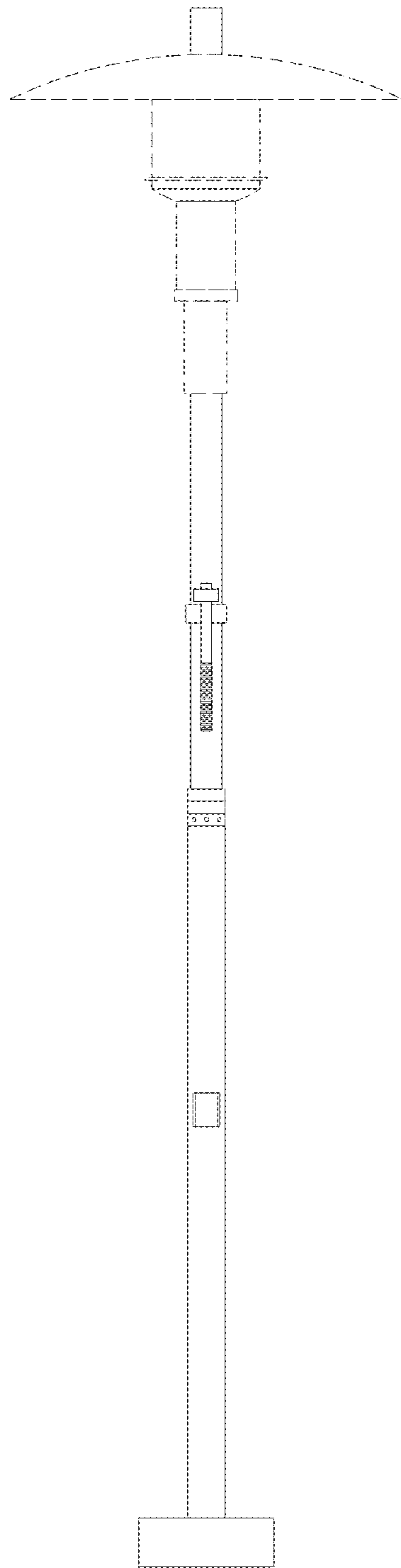
FIG. 1 is a side view of a swiveling support arm showing my

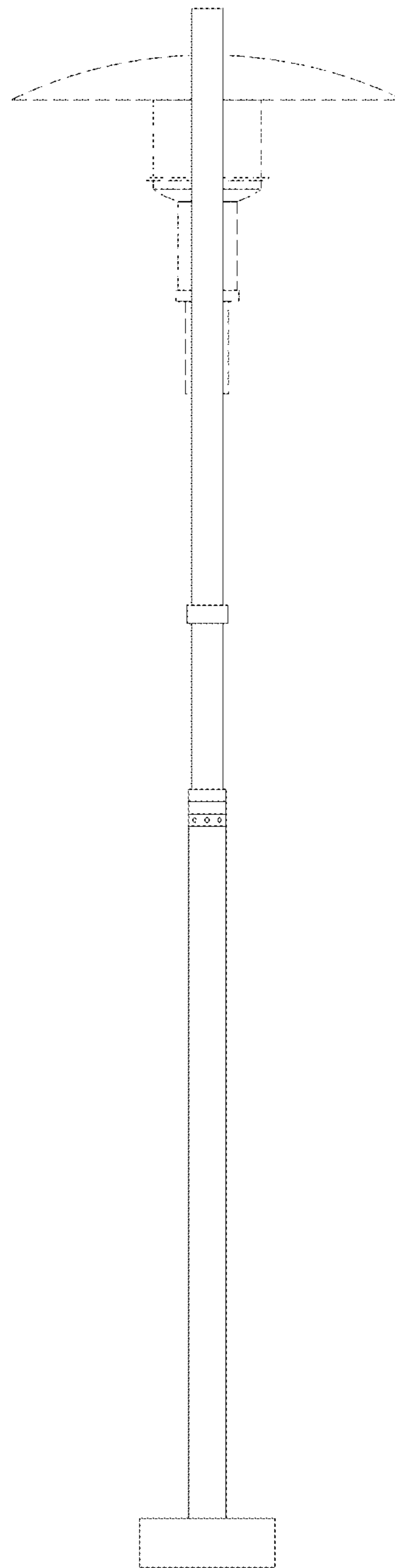




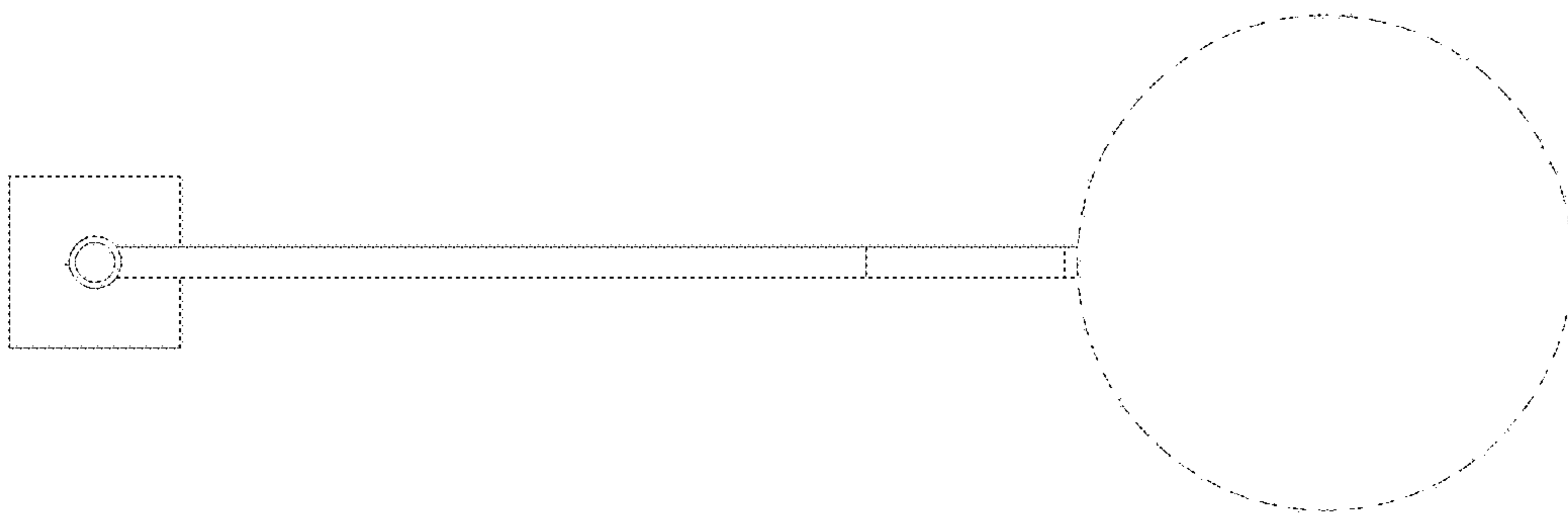

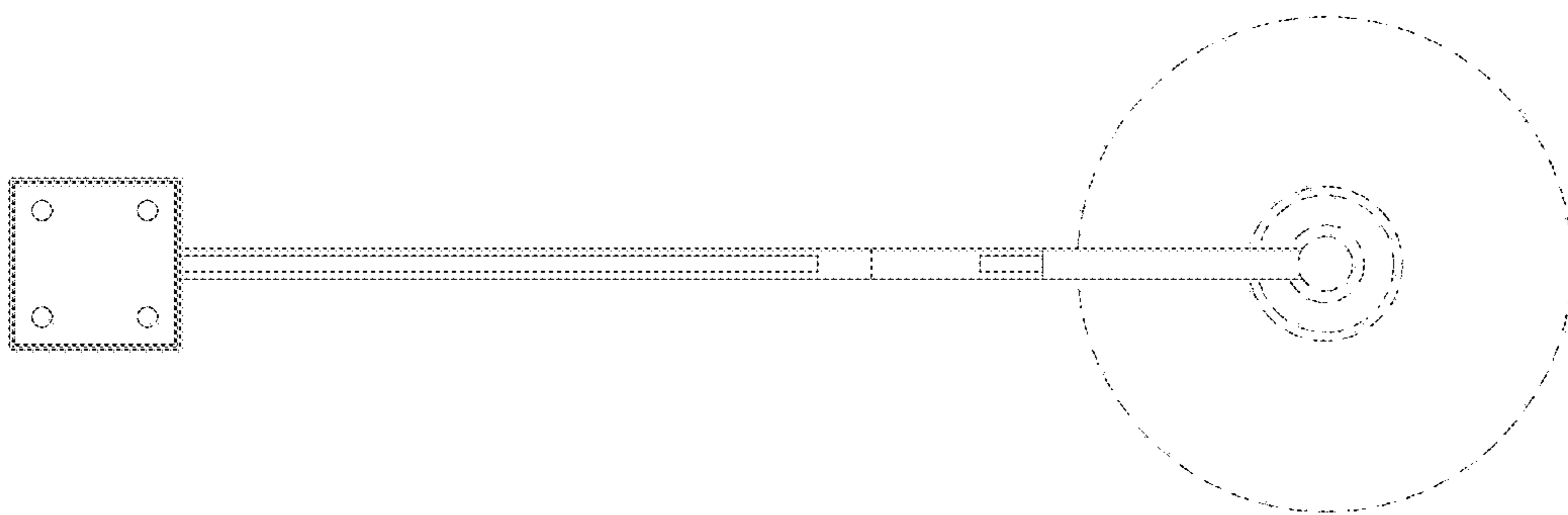
