The ornamental design for a bra with two rows of back snaps, as shown and described.

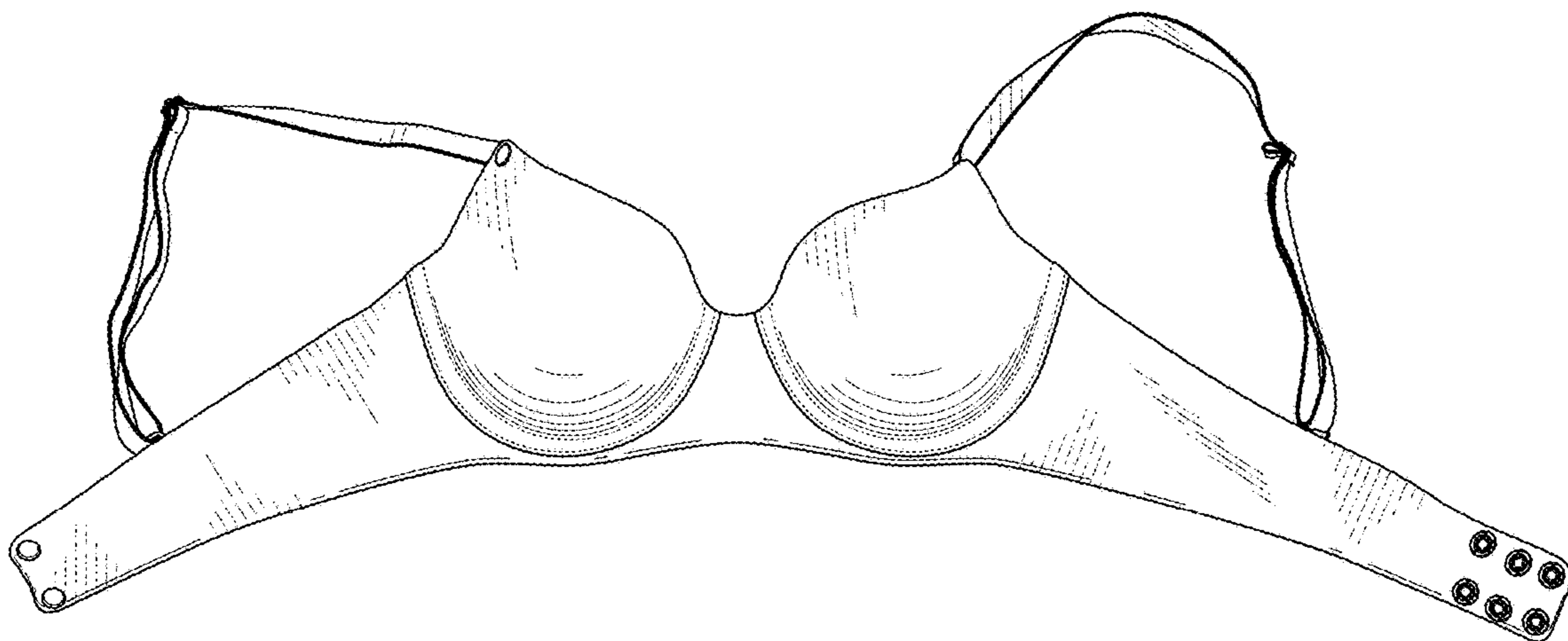
DESCRIPTION

FIG. 1 is a front view of a bra with two rows of back snaps showing a new design;
FIG. 2 is a back view thereof;
FIG. 3 is a front perspective view thereof;
FIG. 4 is a front right perspective view thereof;
FIG. 5 is a right side view with the left side being a mirror image thereof;
FIG. 6 is a back right view thereof;
FIG. 7 is a back view thereof;
FIG. 8 is an enlarged view of back snaps shown separately for ease of illustration;
FIG. 9 is a left front perspective view thereof;
FIG. 10 is a top view thereof; and,
FIG. 11 is a bottom view thereof.

The broken lines shown in the drawings represent stitching in the fabric and form no part of the claimed design.

The broken lines of the mannequin shown in FIGS. 3-7 and 9 are included for the purpose of illustrating environmental structure and form no part of the claimed design.

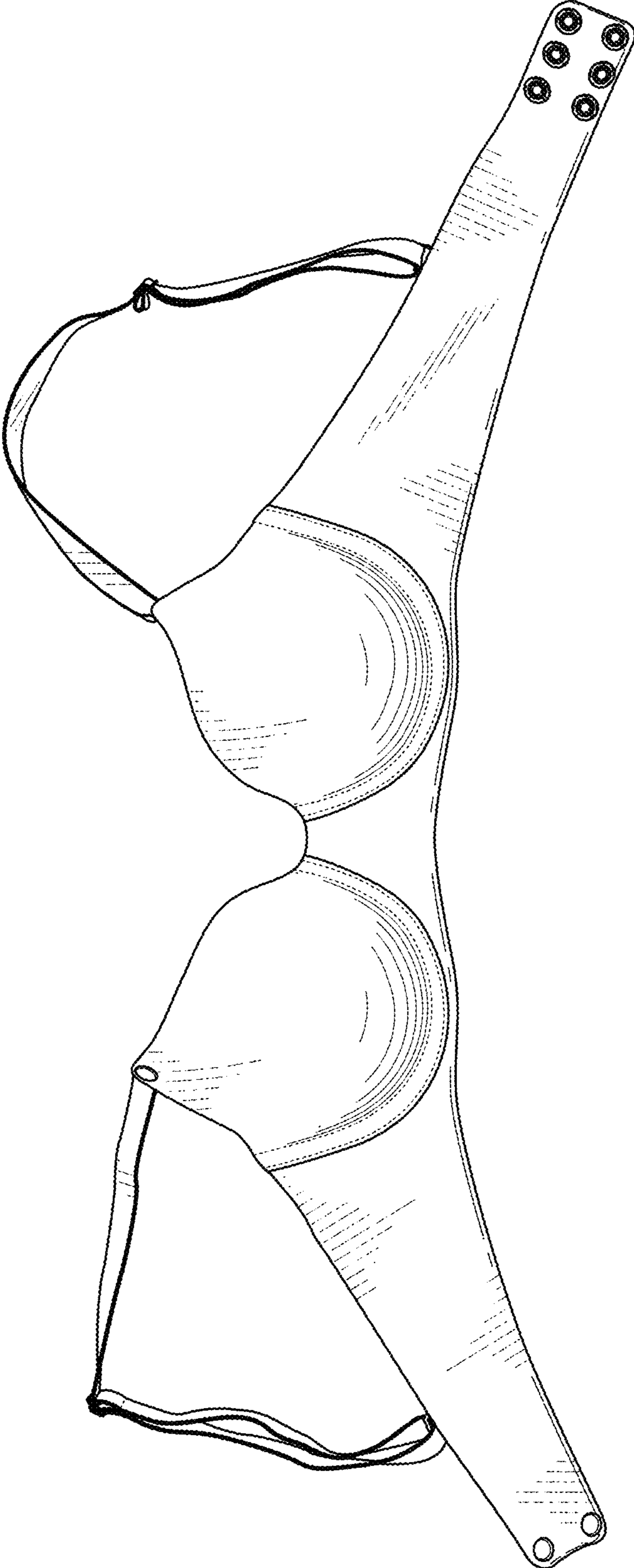

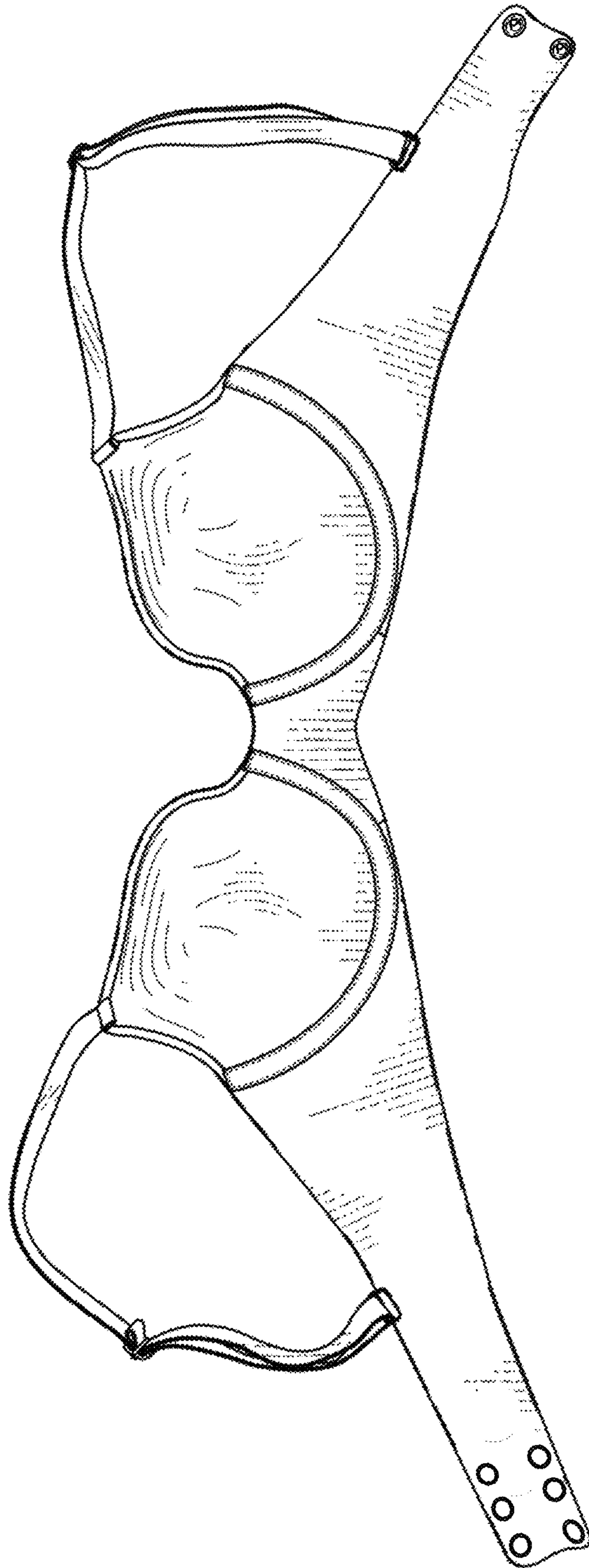

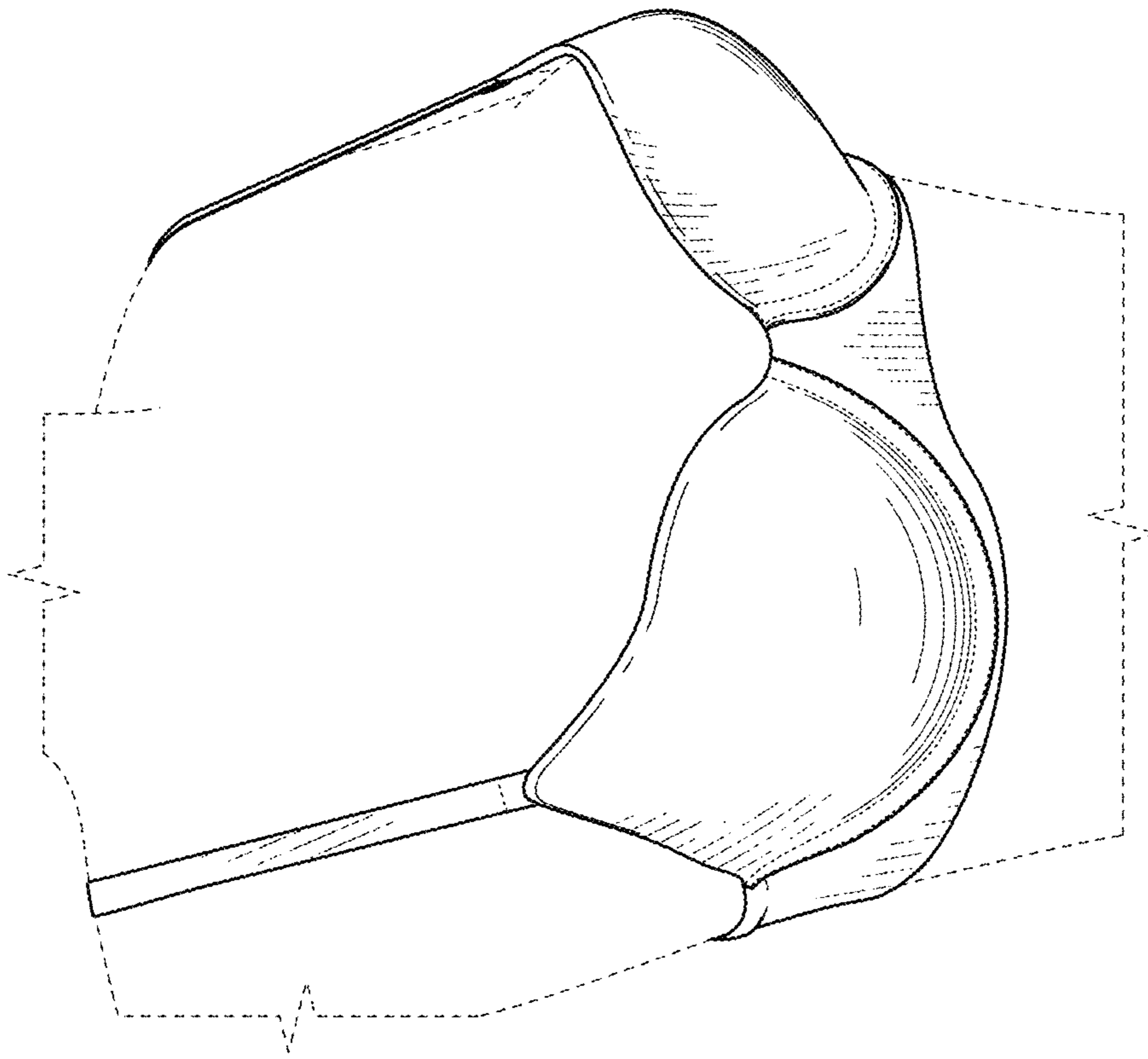

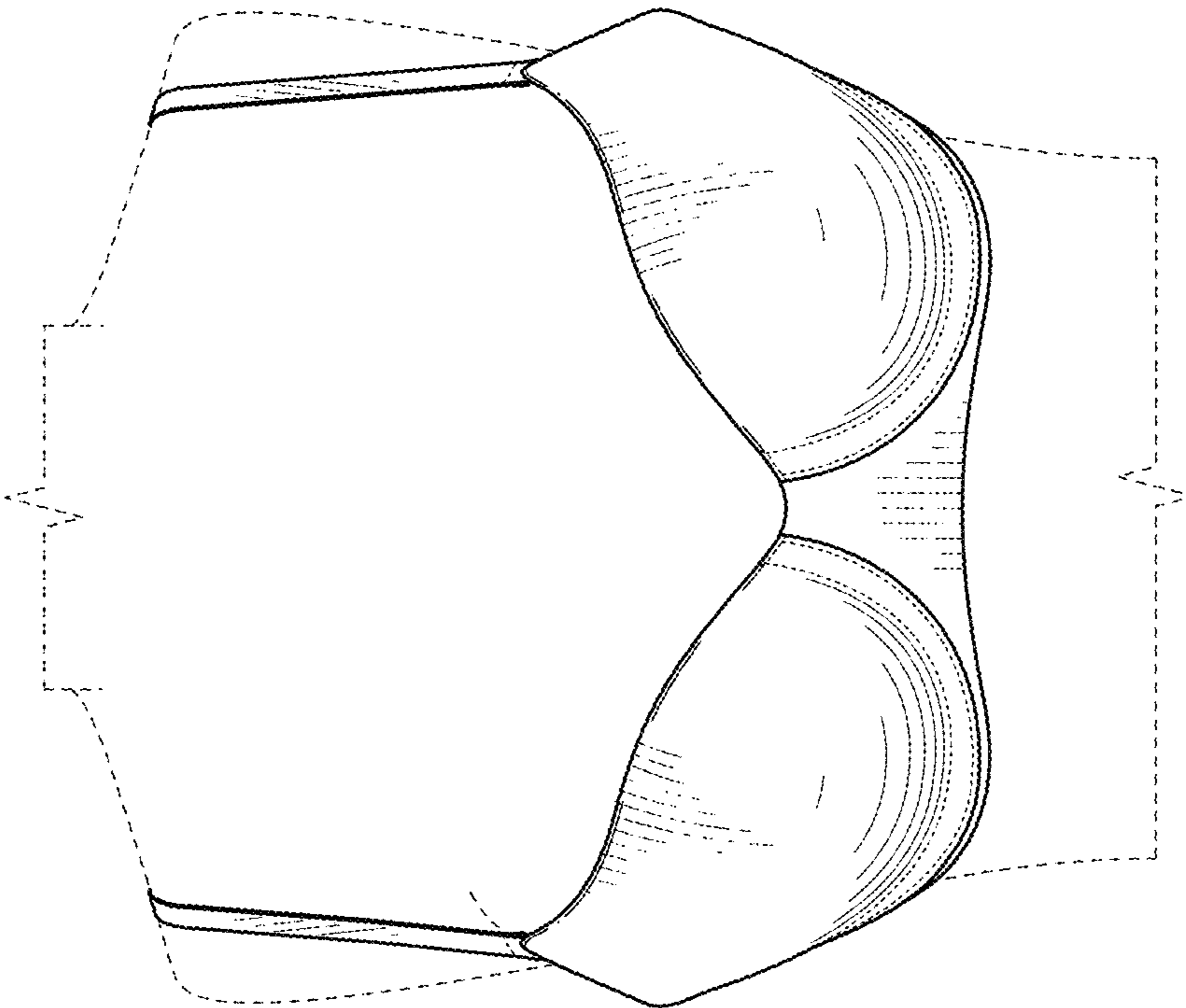

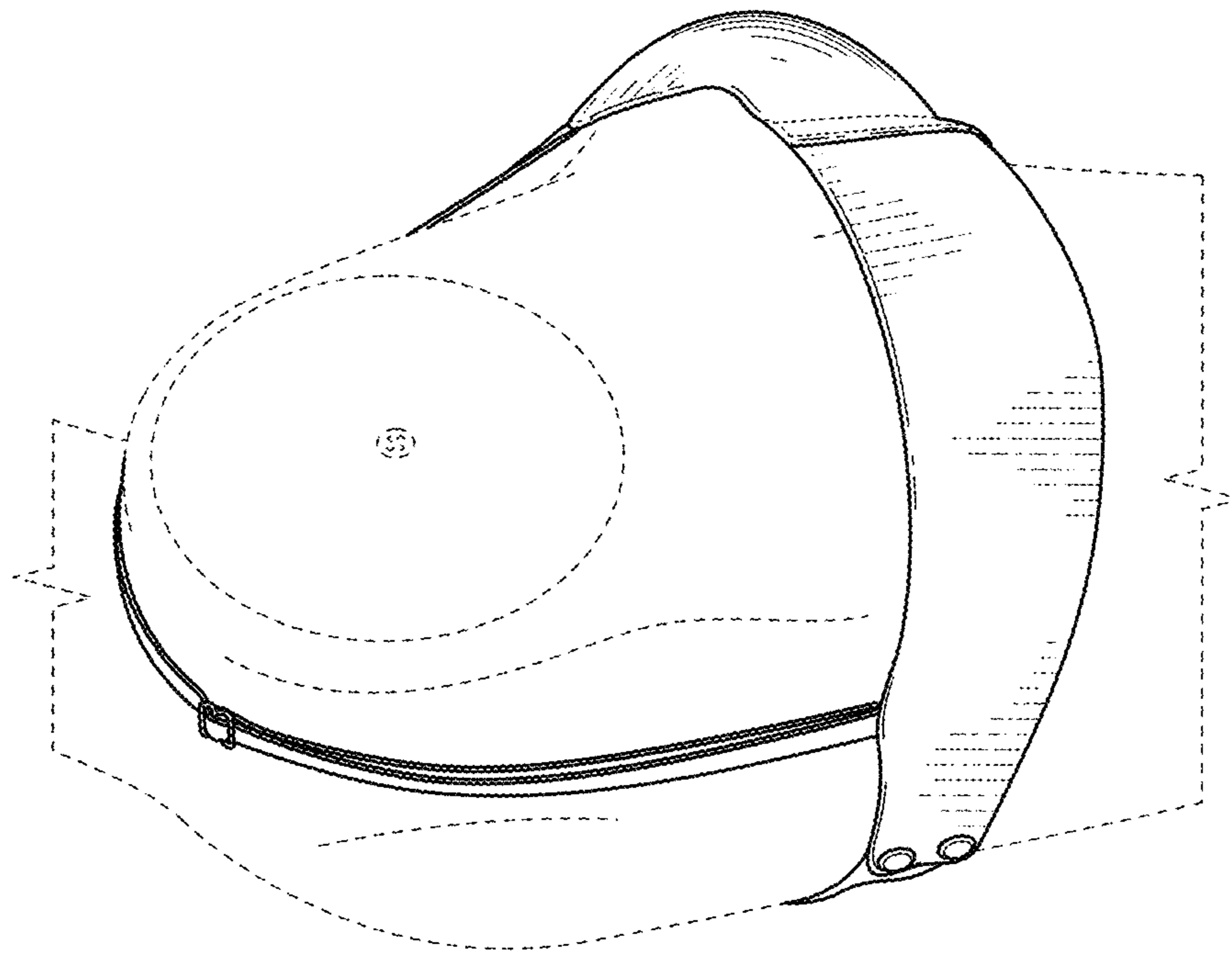

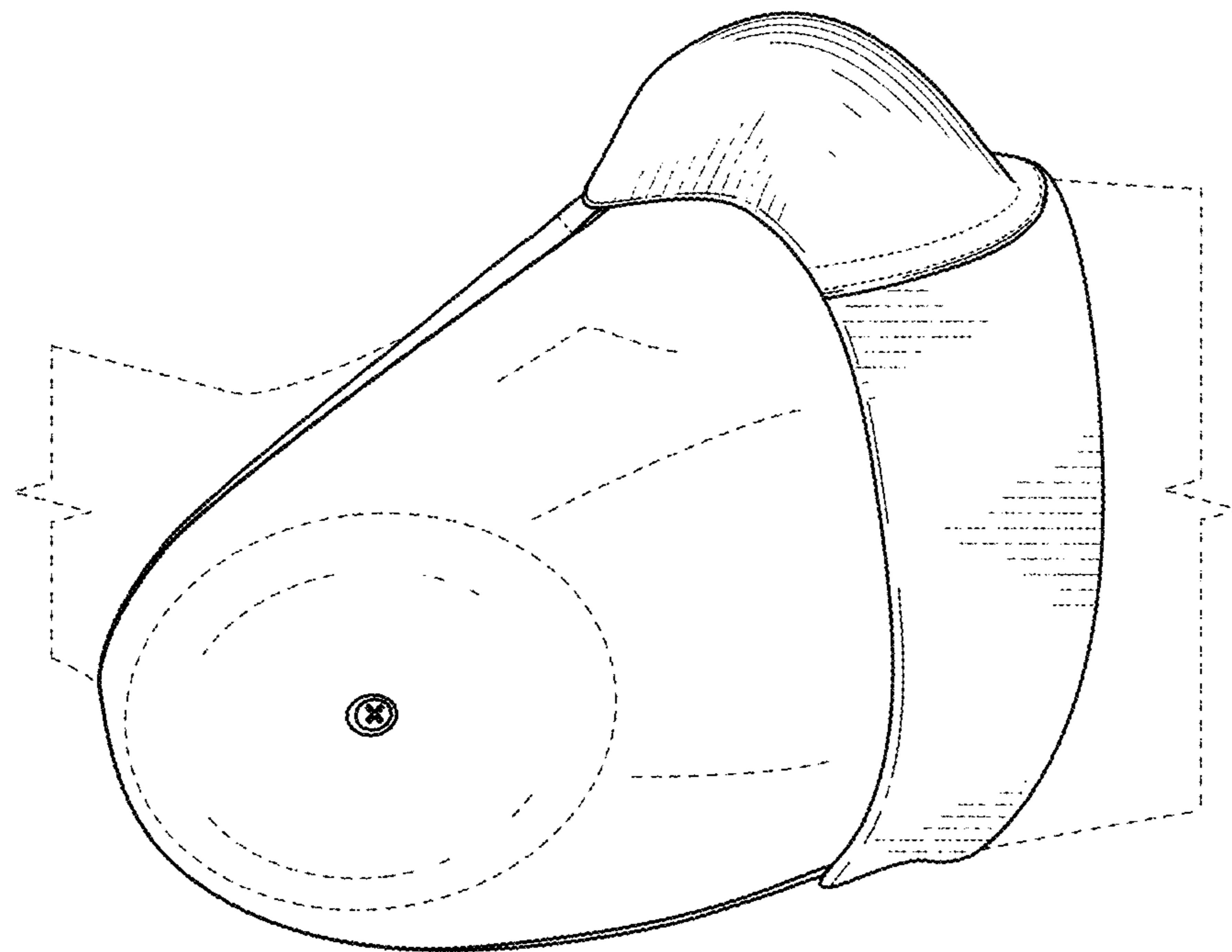

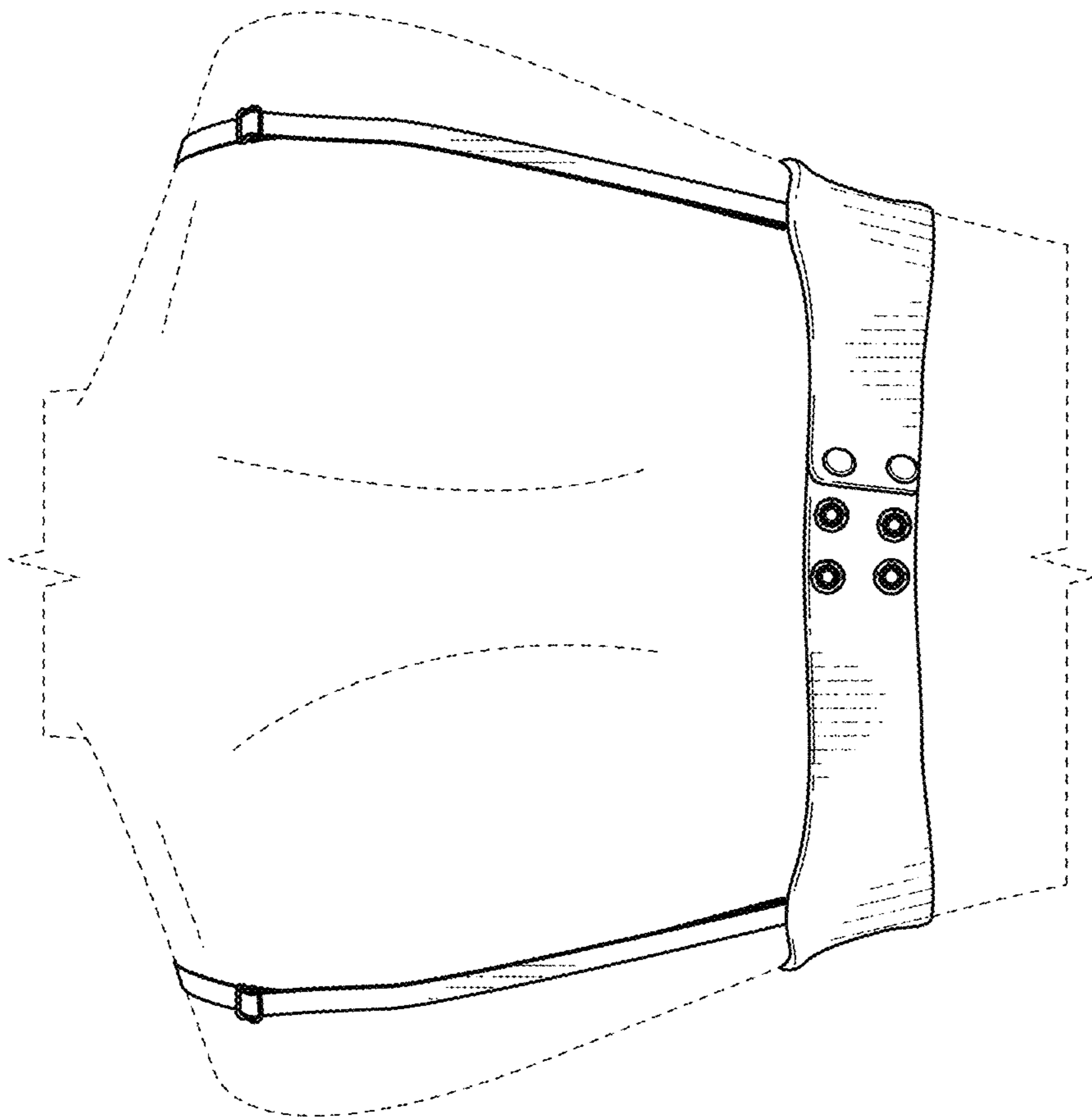

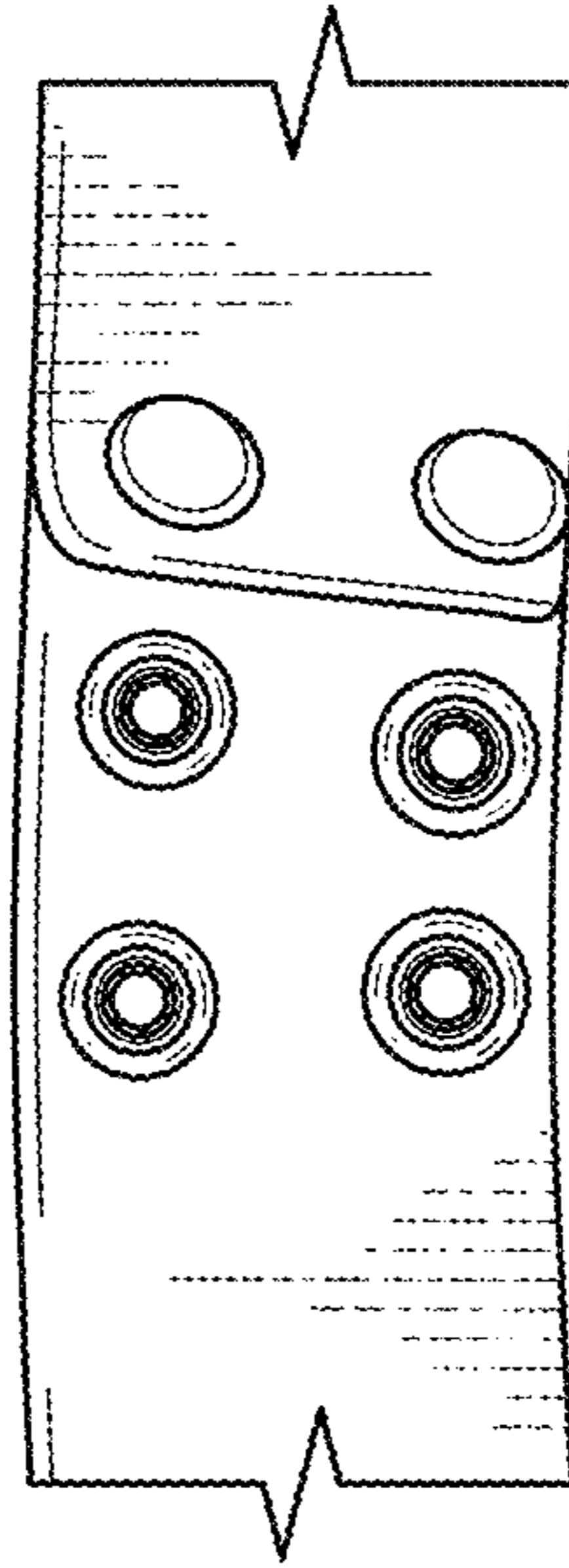

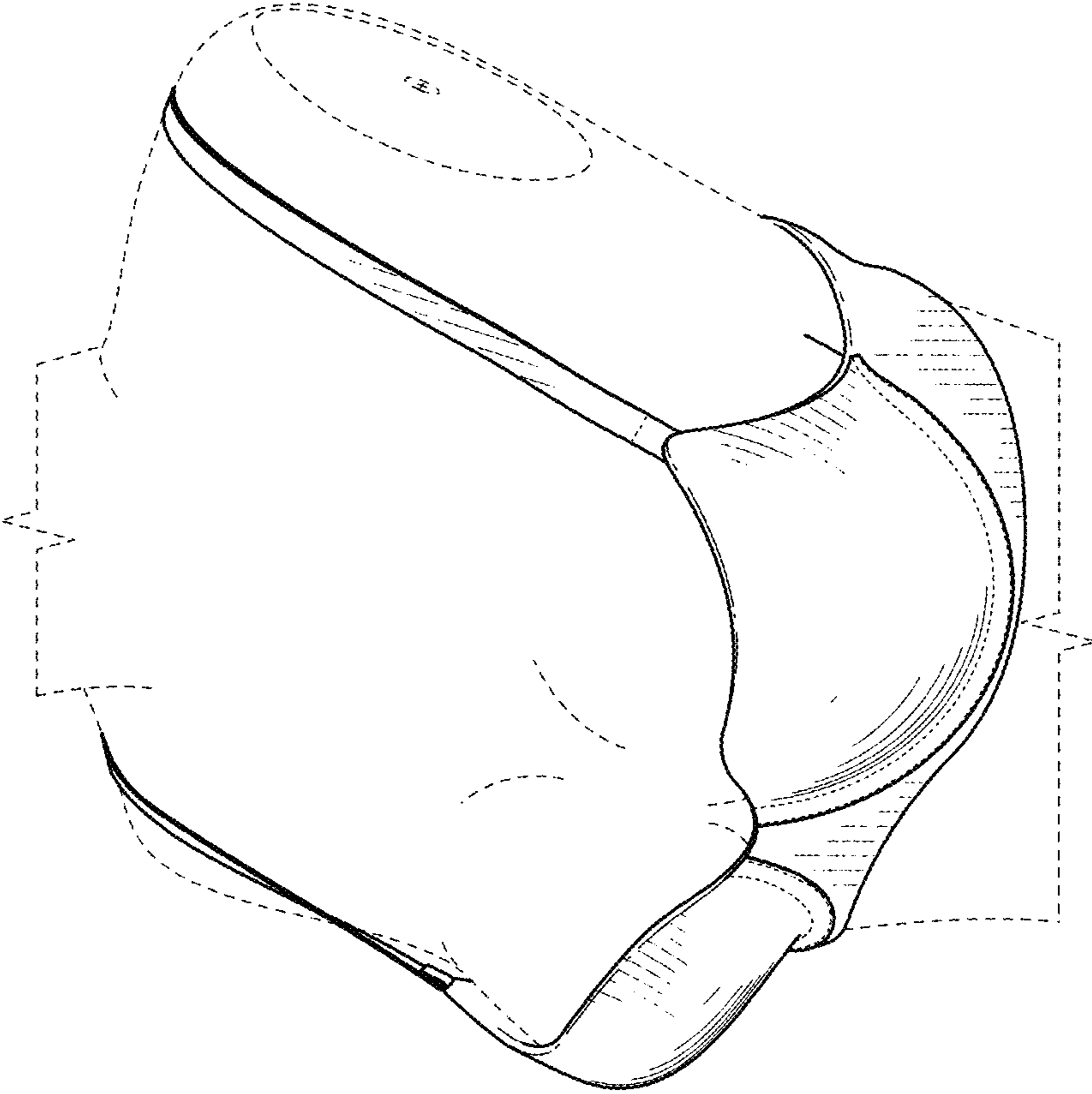

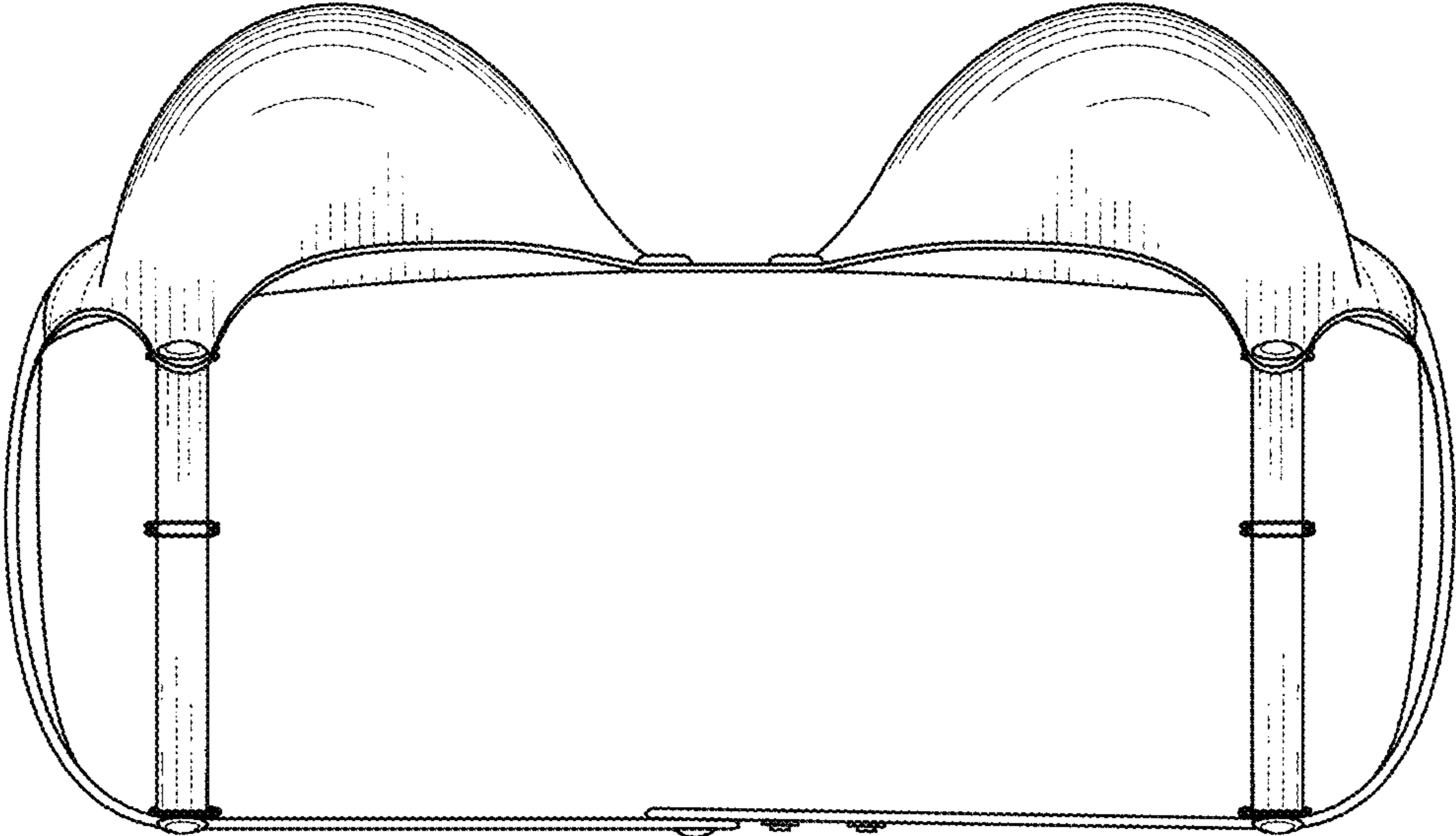

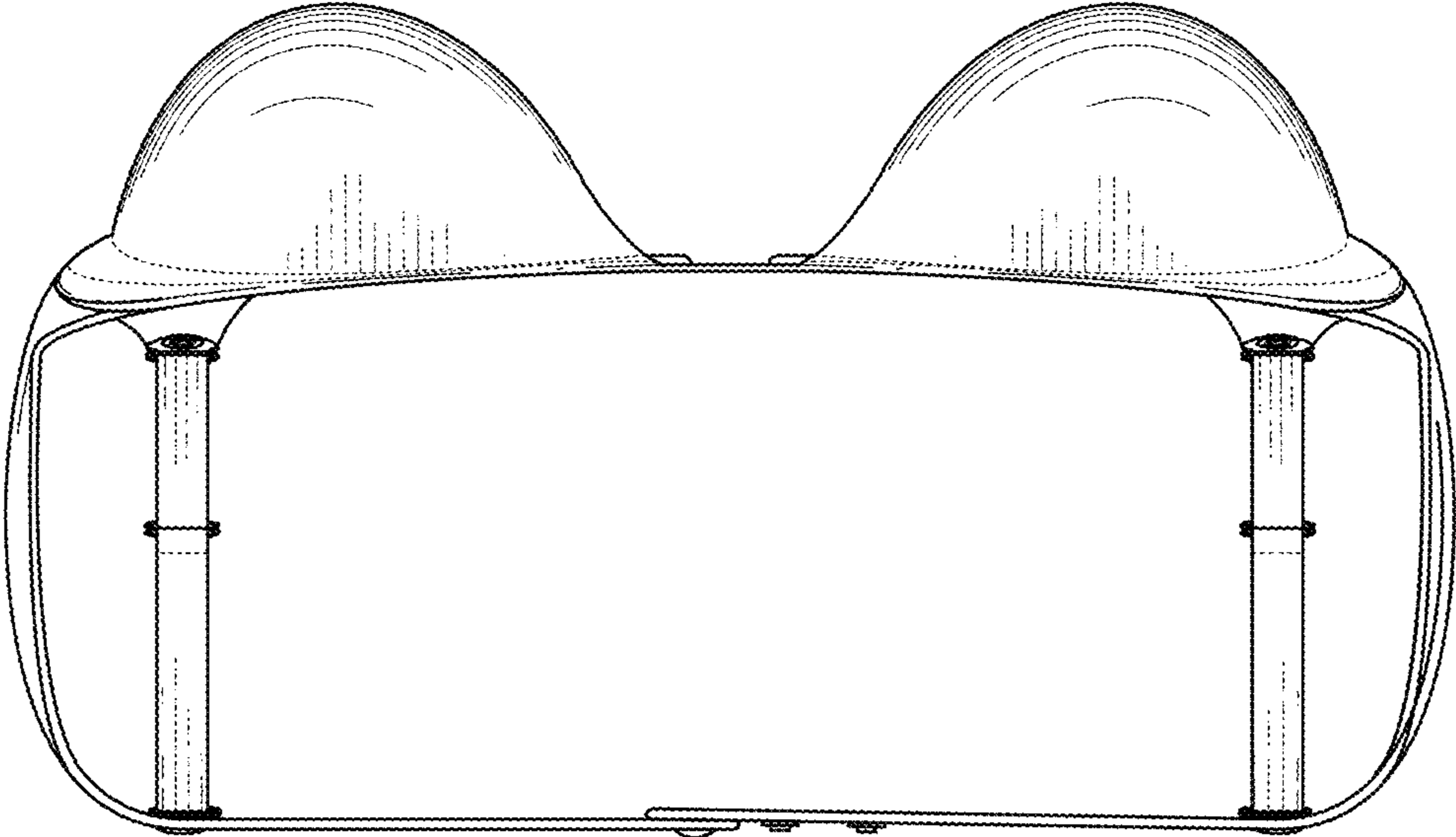
