DESCRIPTION

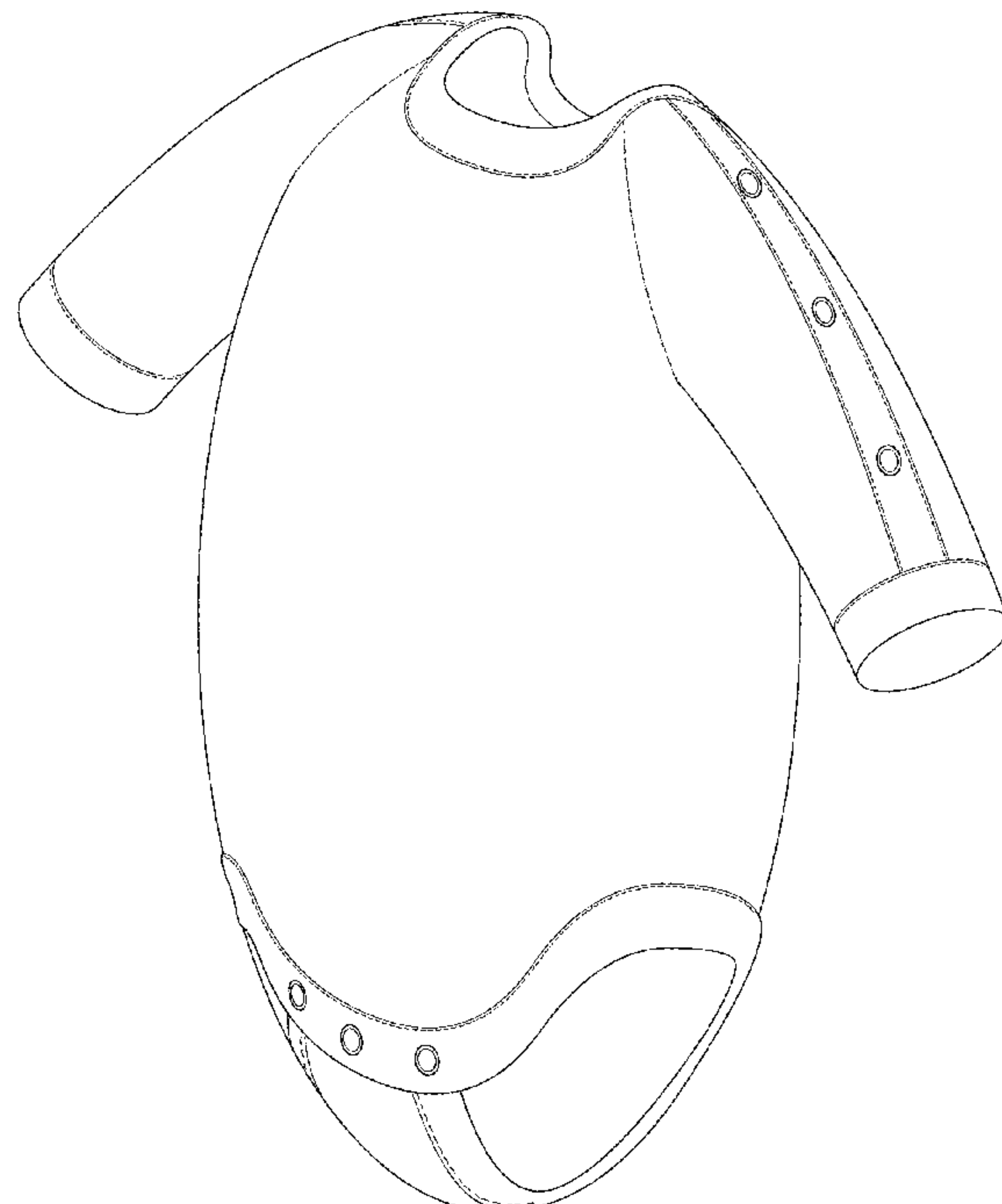

The broken lines showing a child represent environmental structure and form no part of the claimed design. The remaining broken lines within the garment represent stitching and are part of the claimed design.

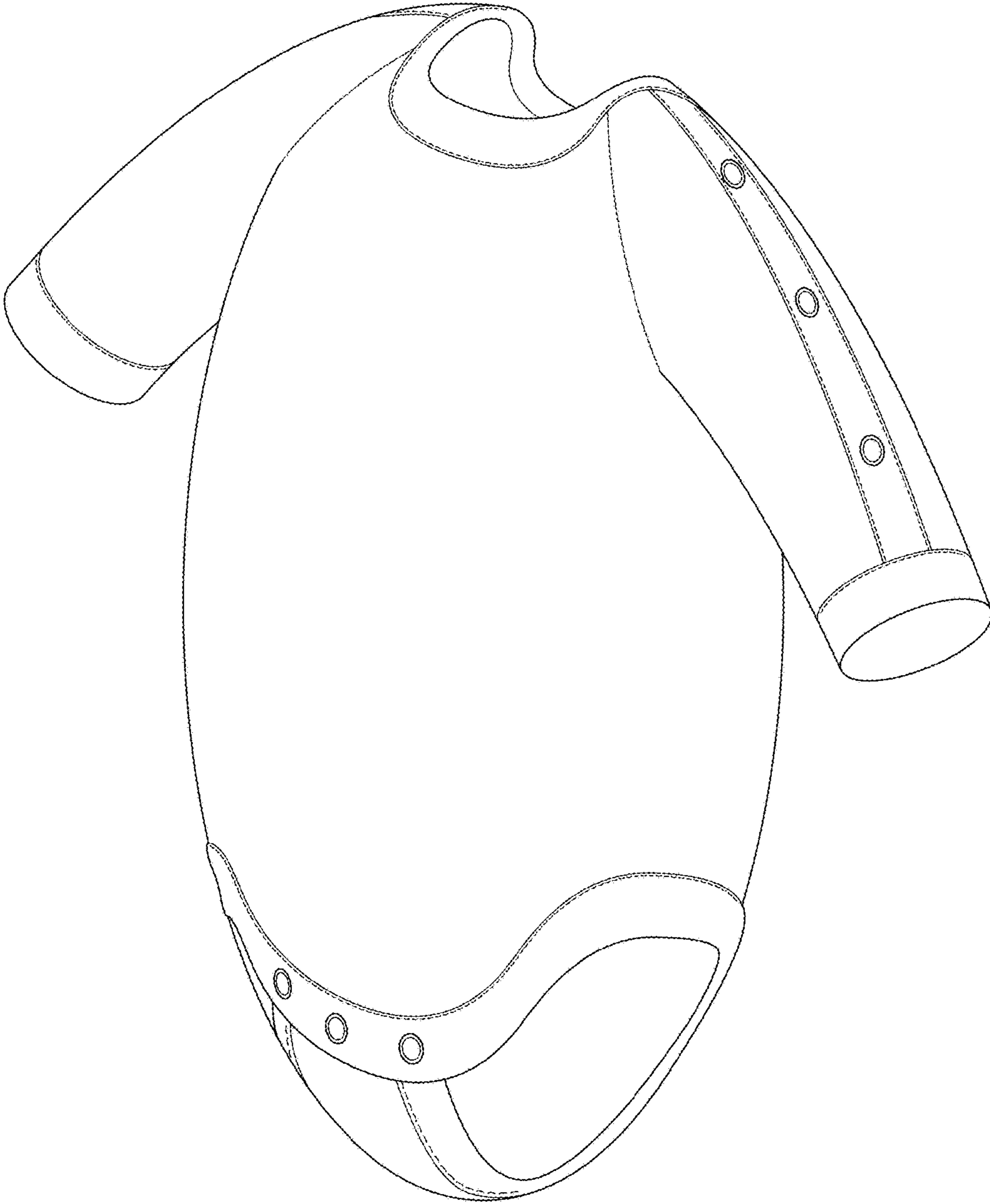

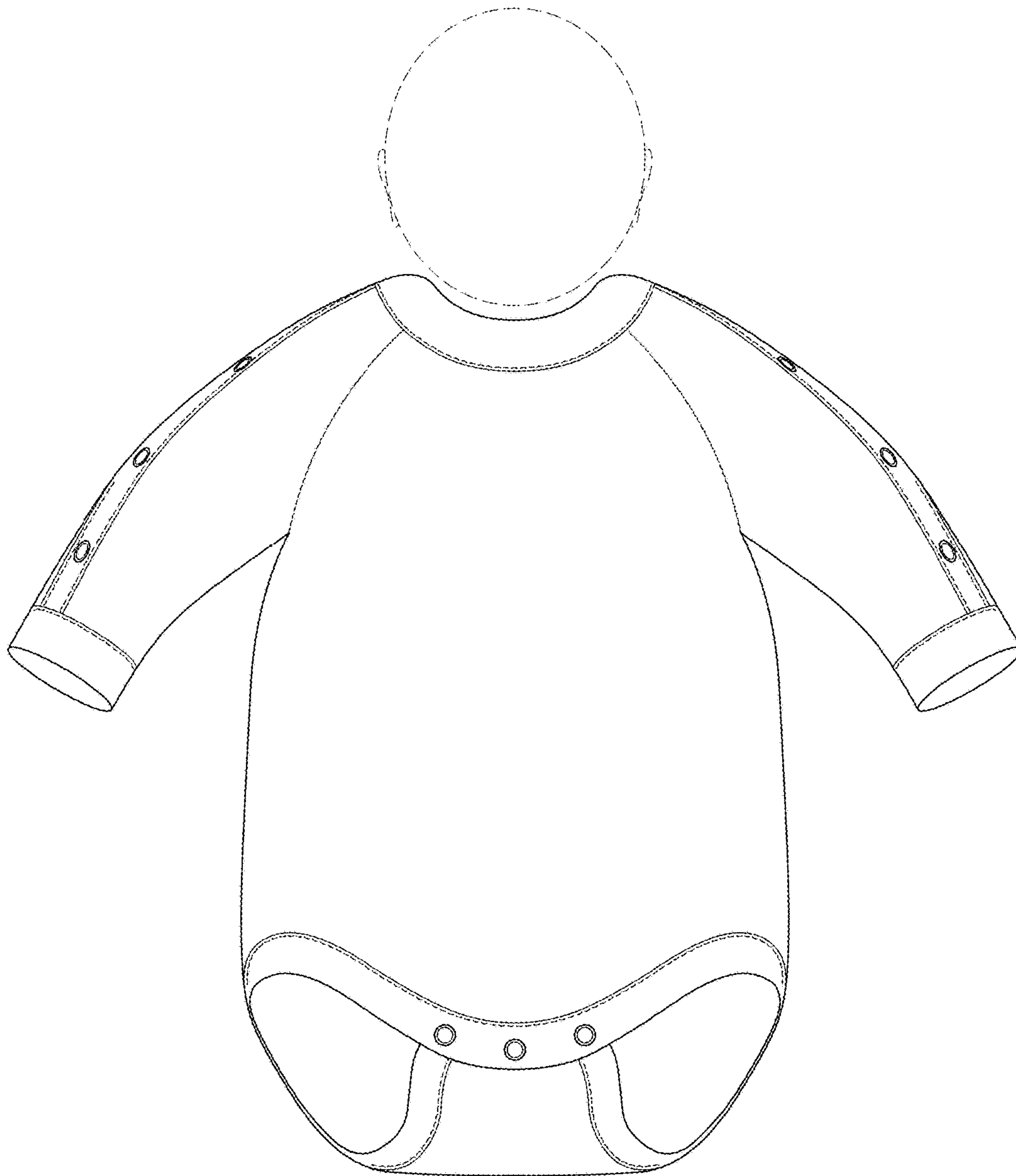

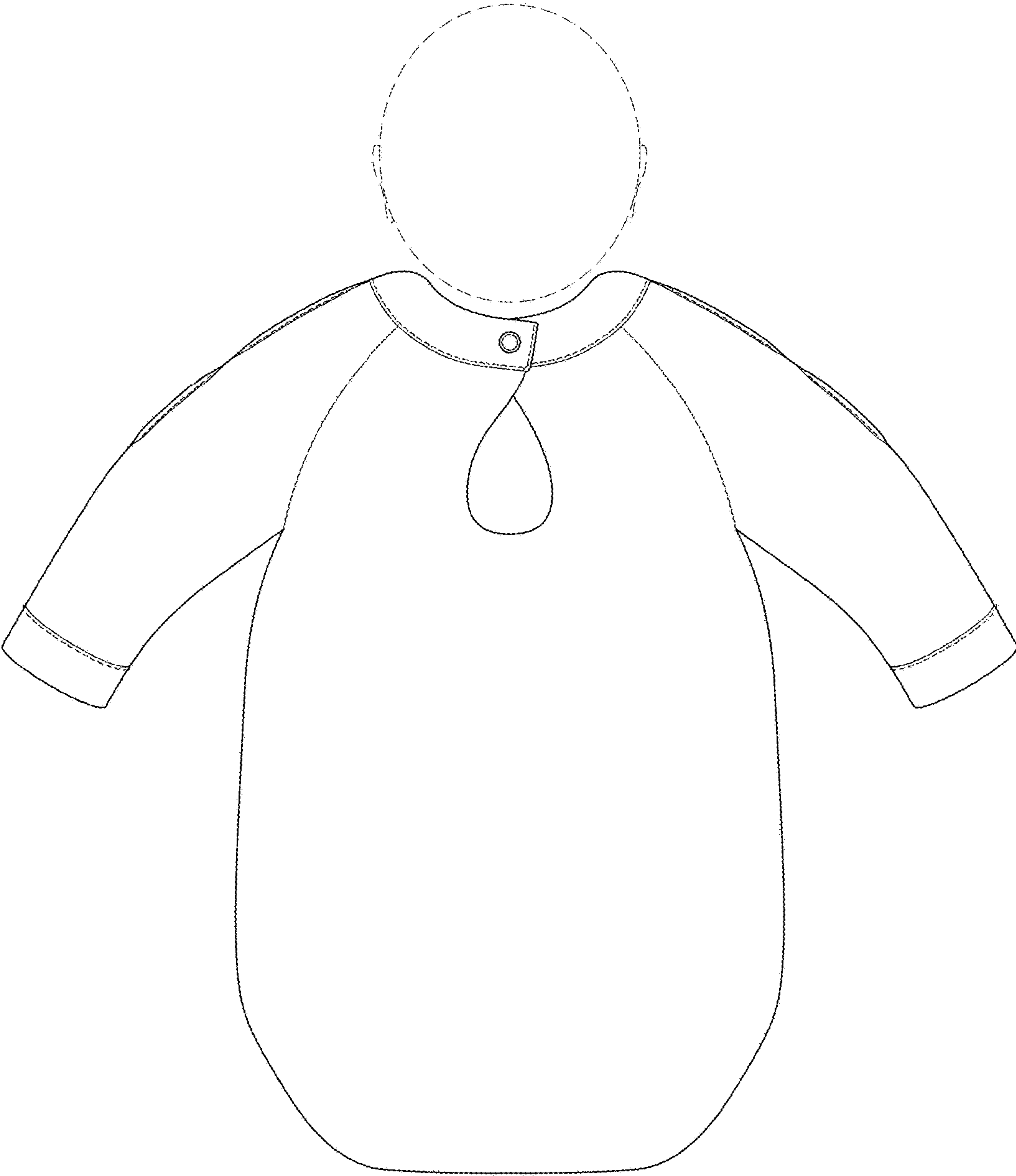

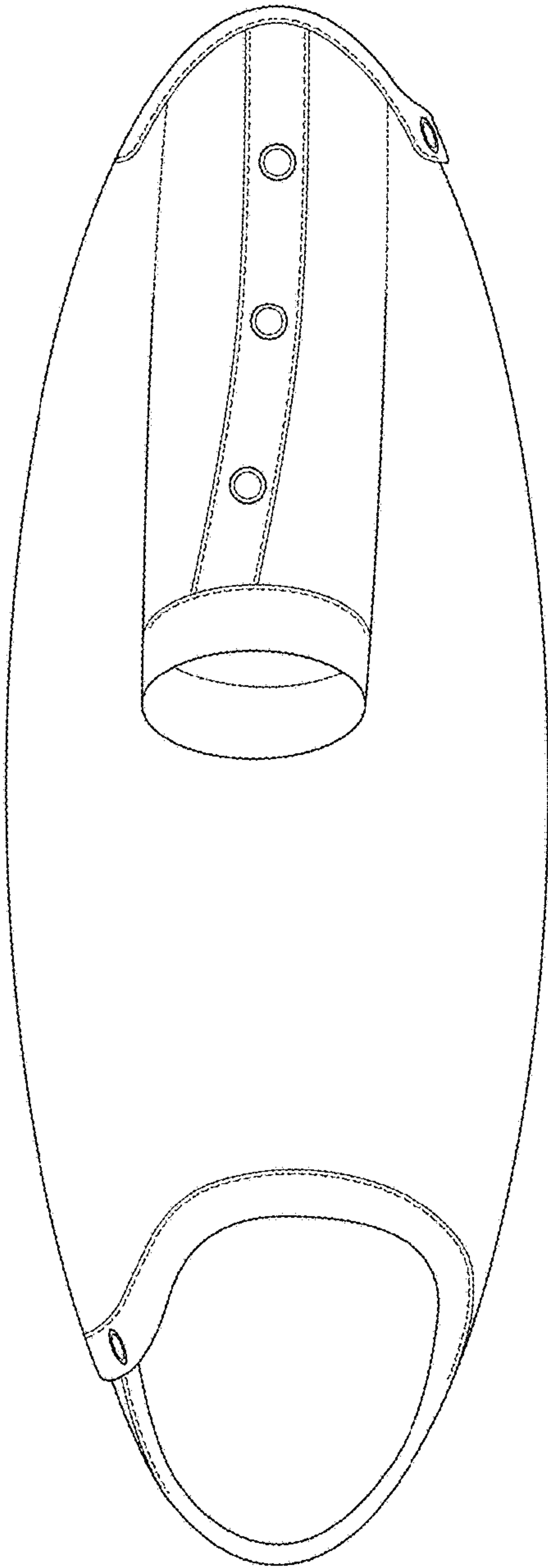

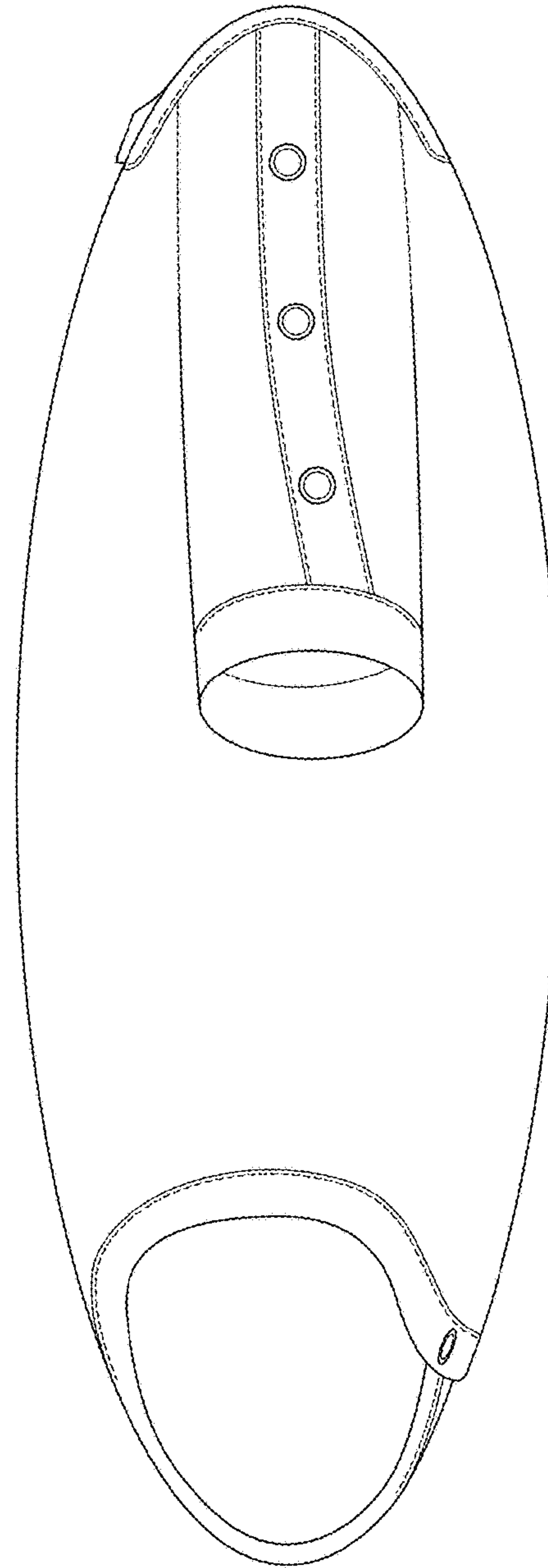

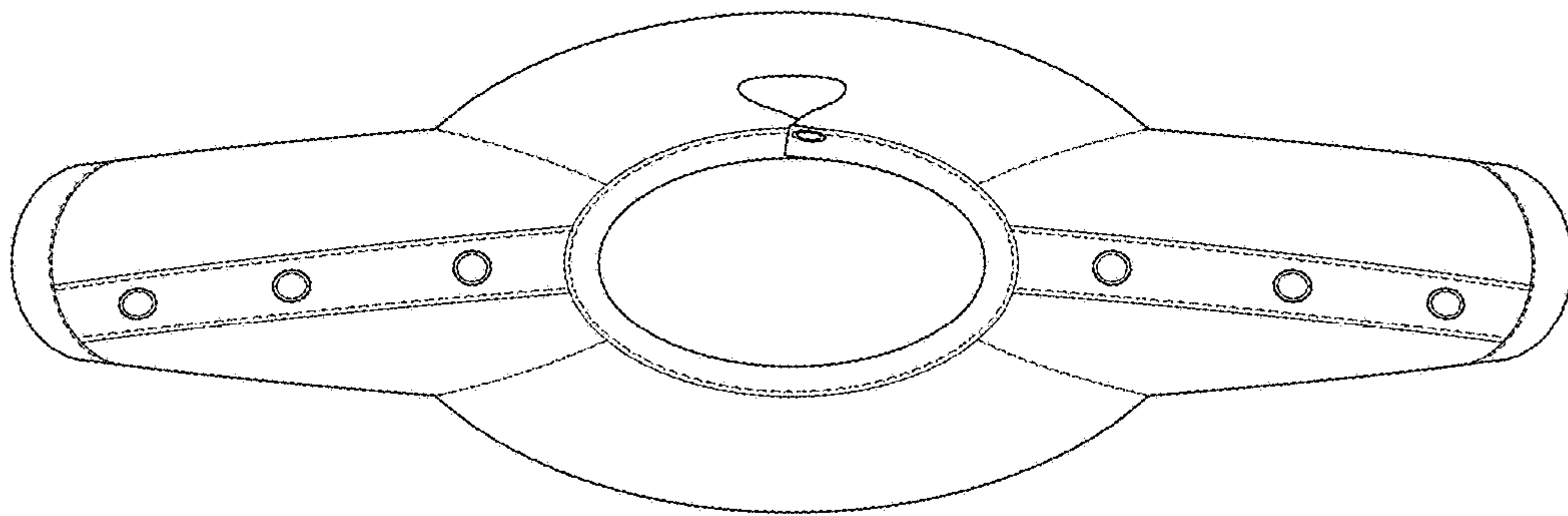

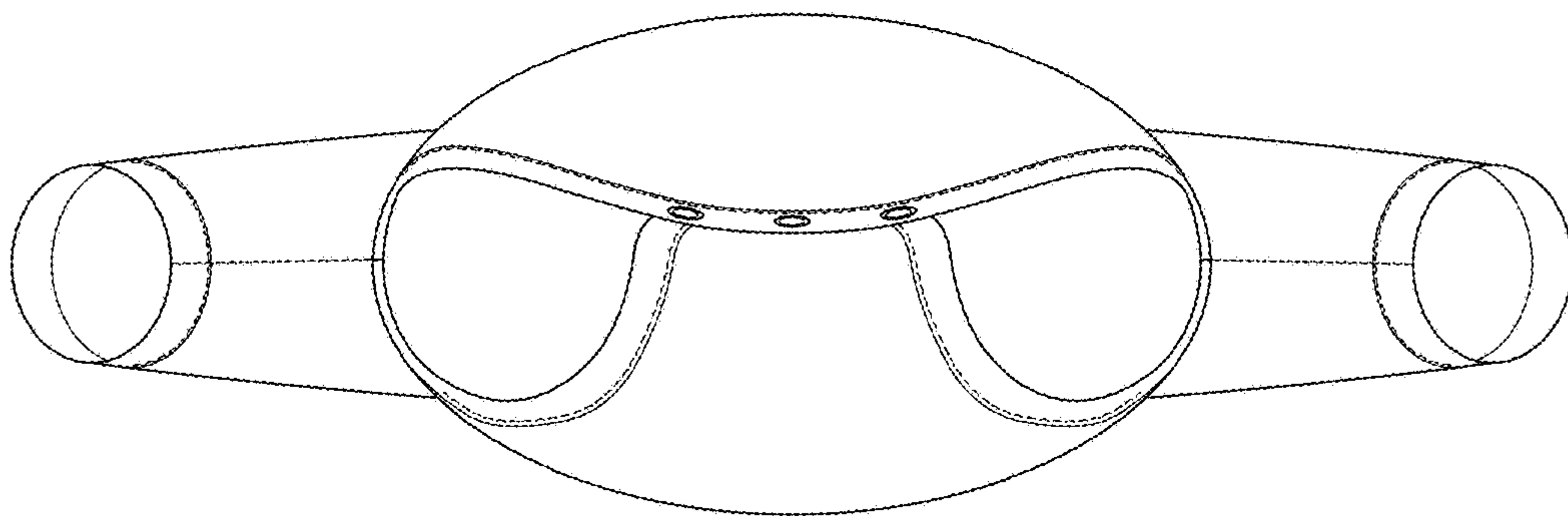
