**DESCRIPTION**

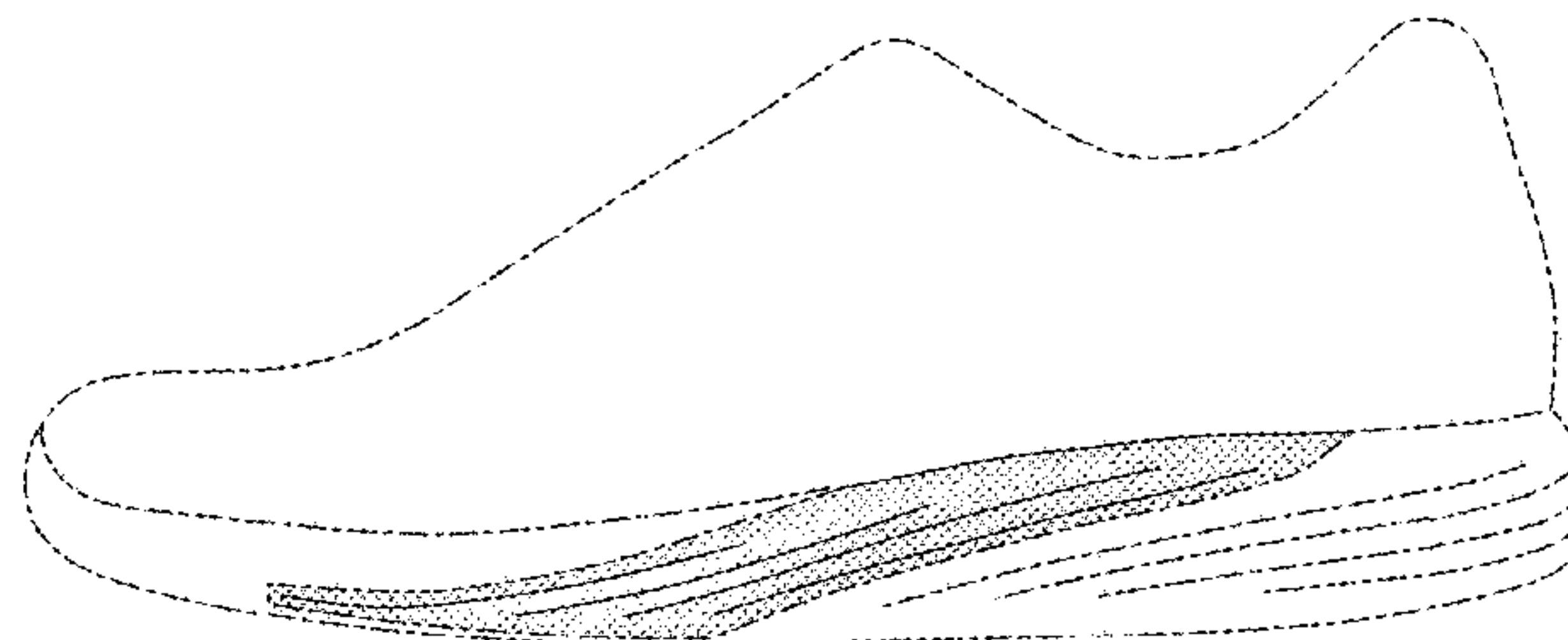
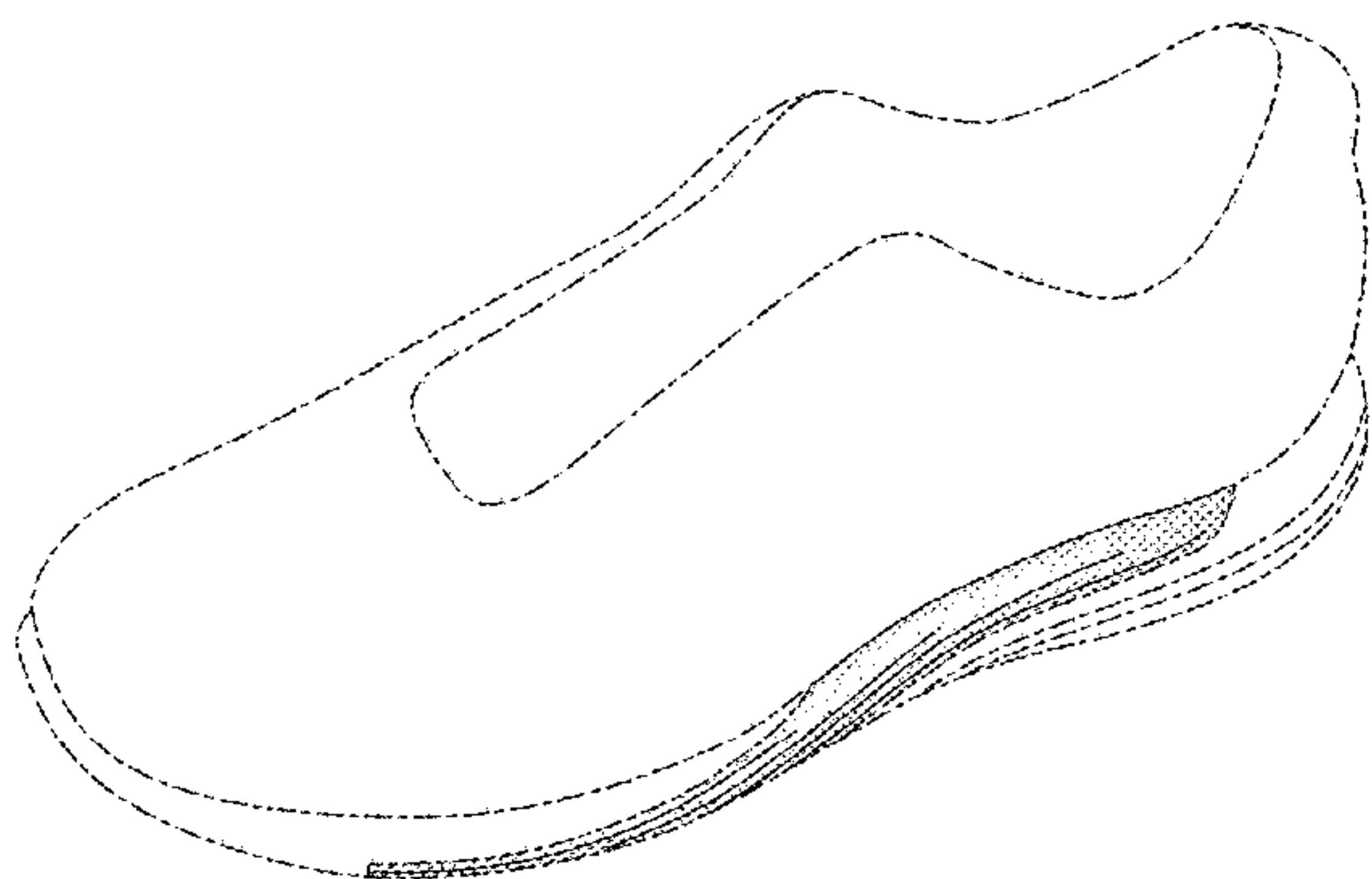
FIG. 1 is a front perspective view of a shoe midsole showing our new design;

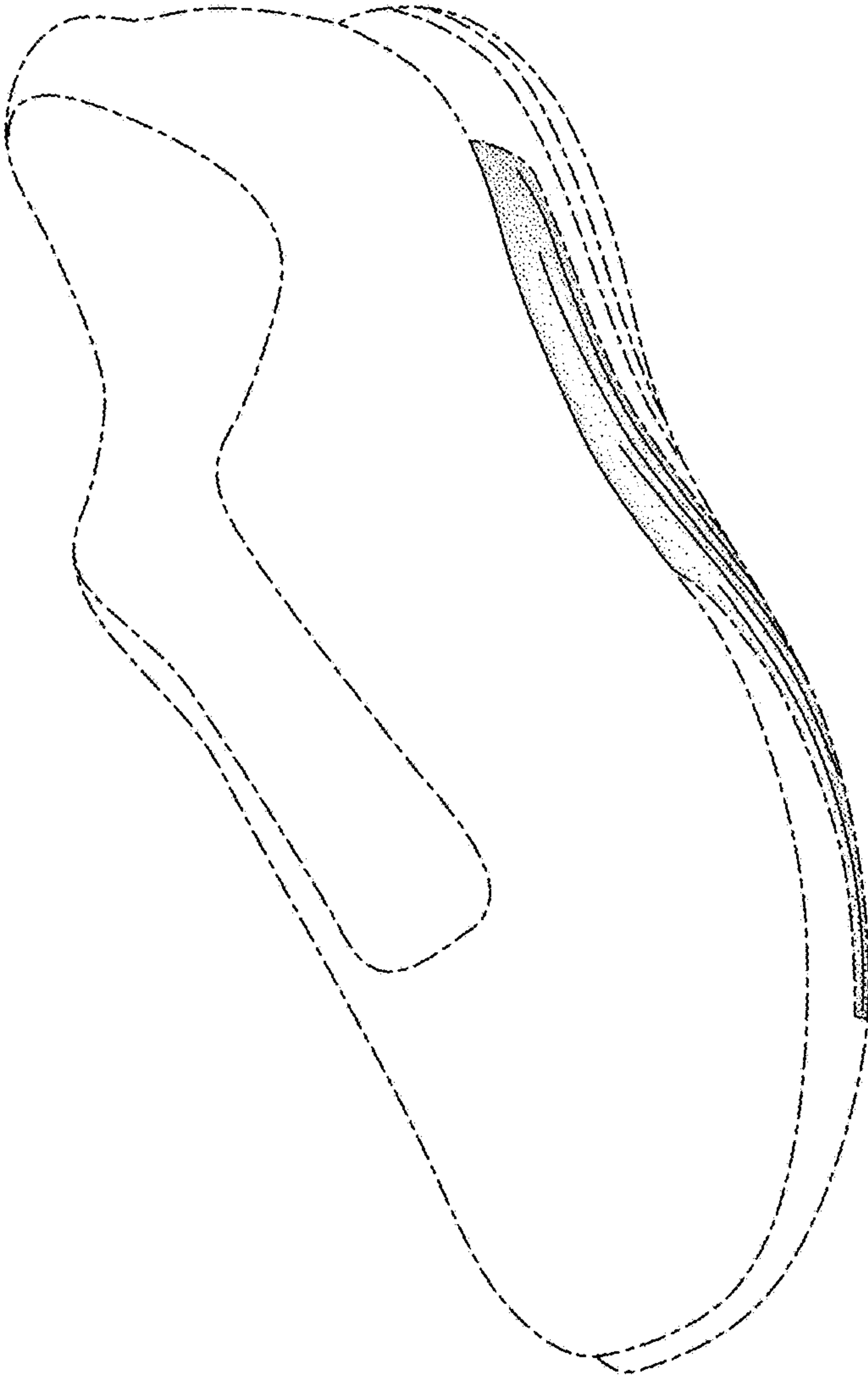

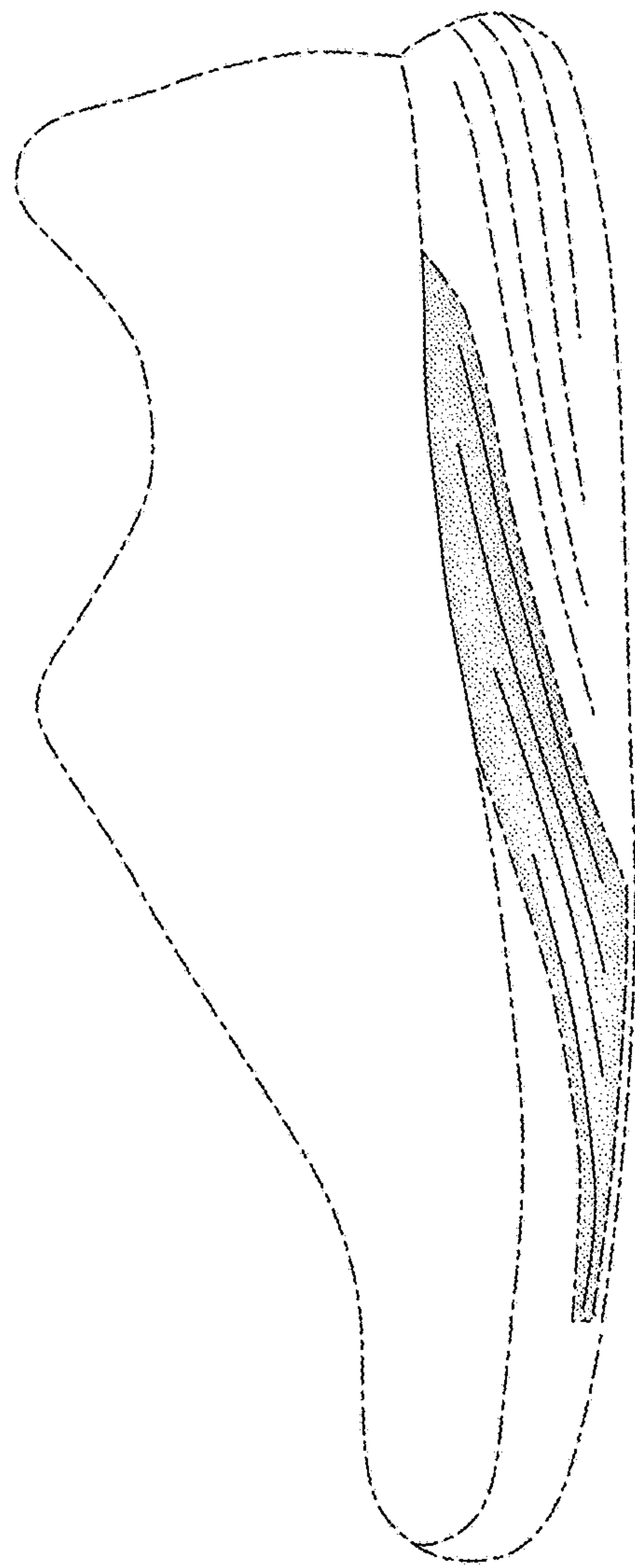

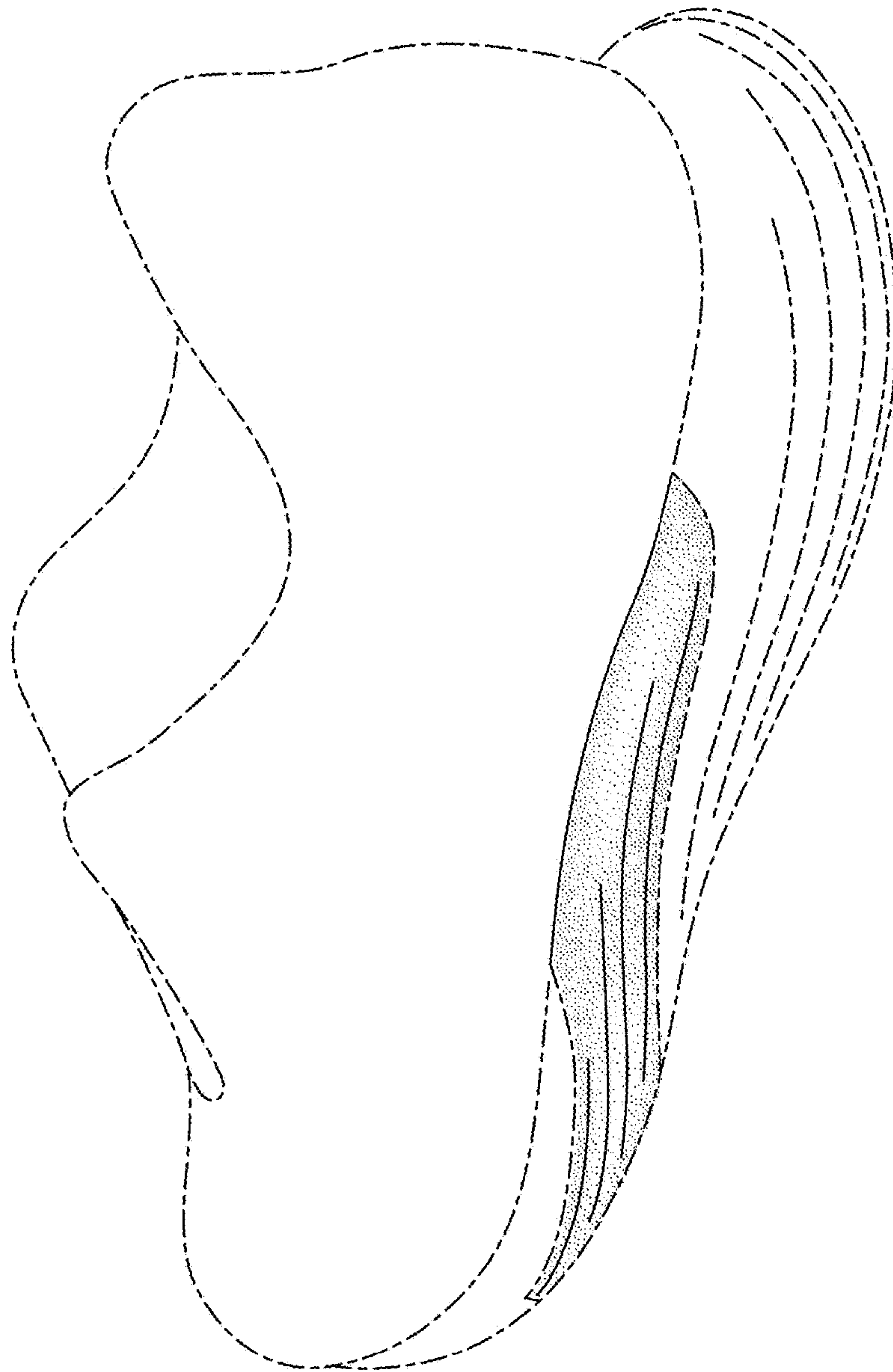

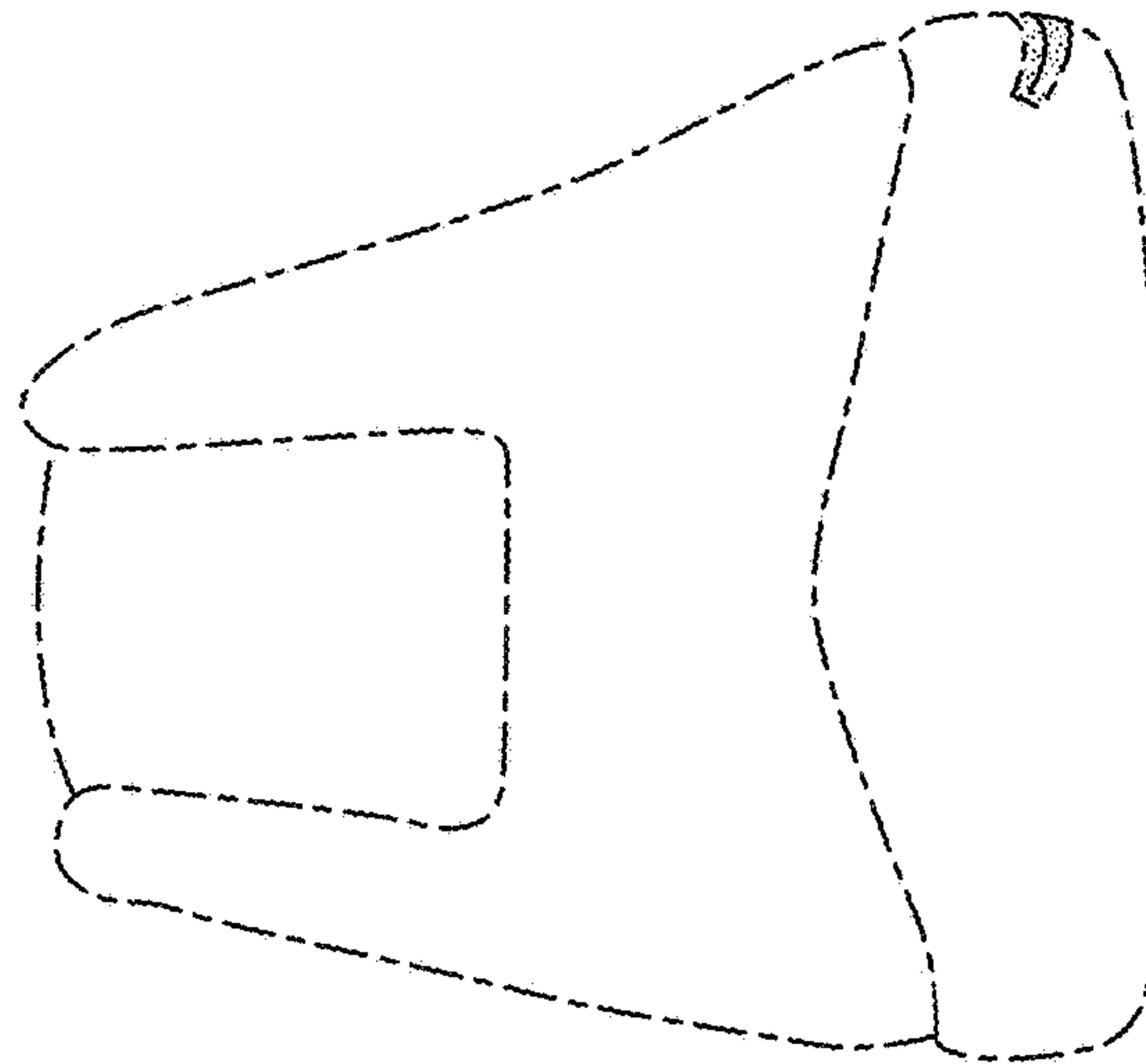

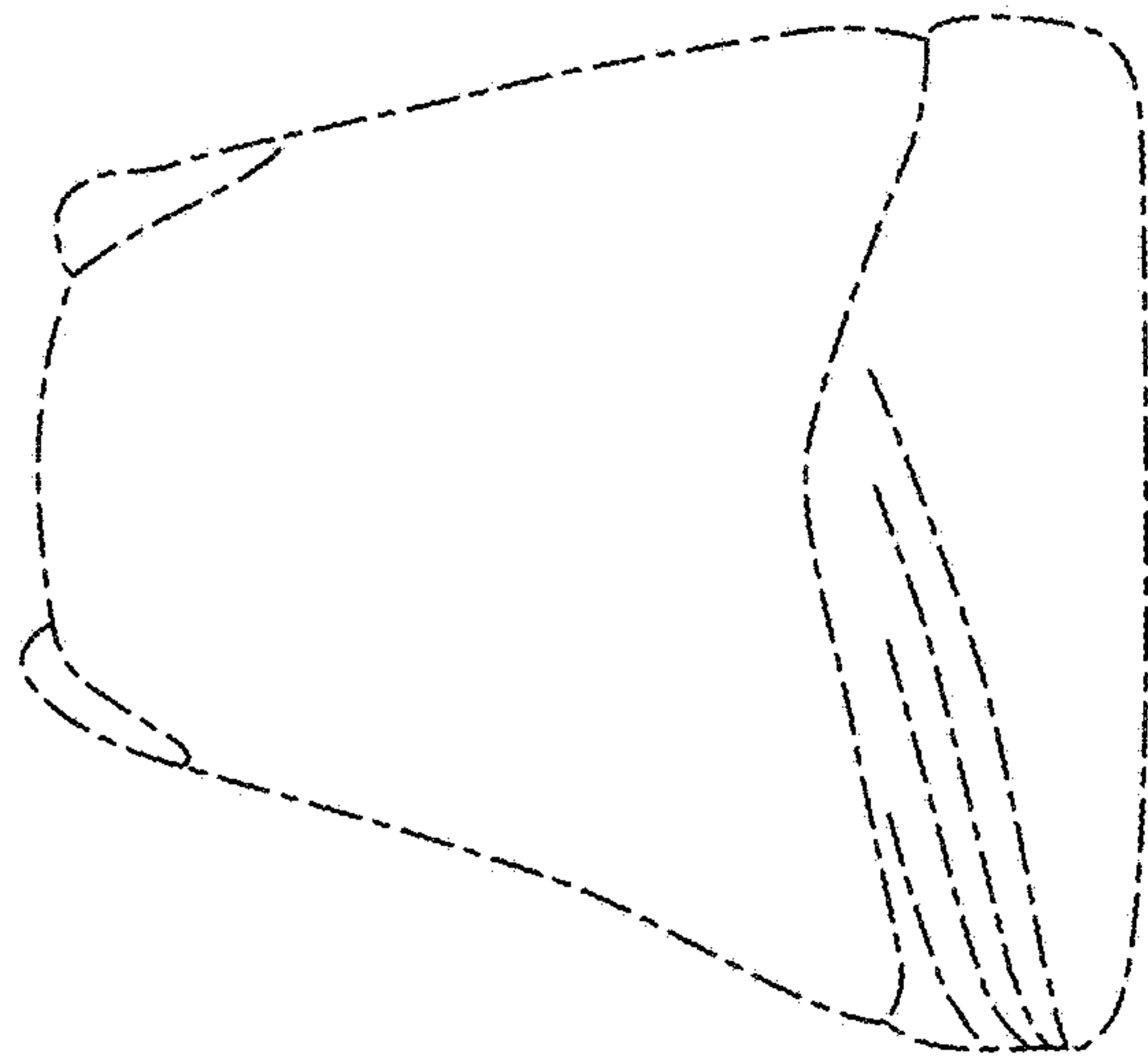

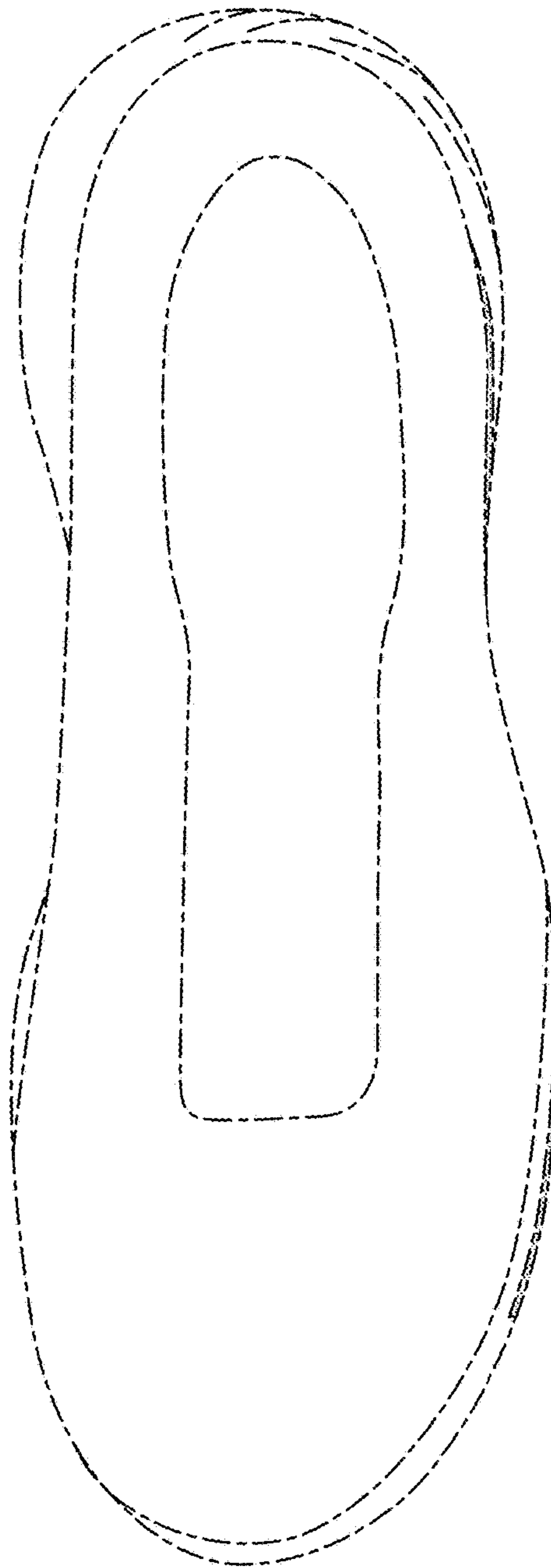
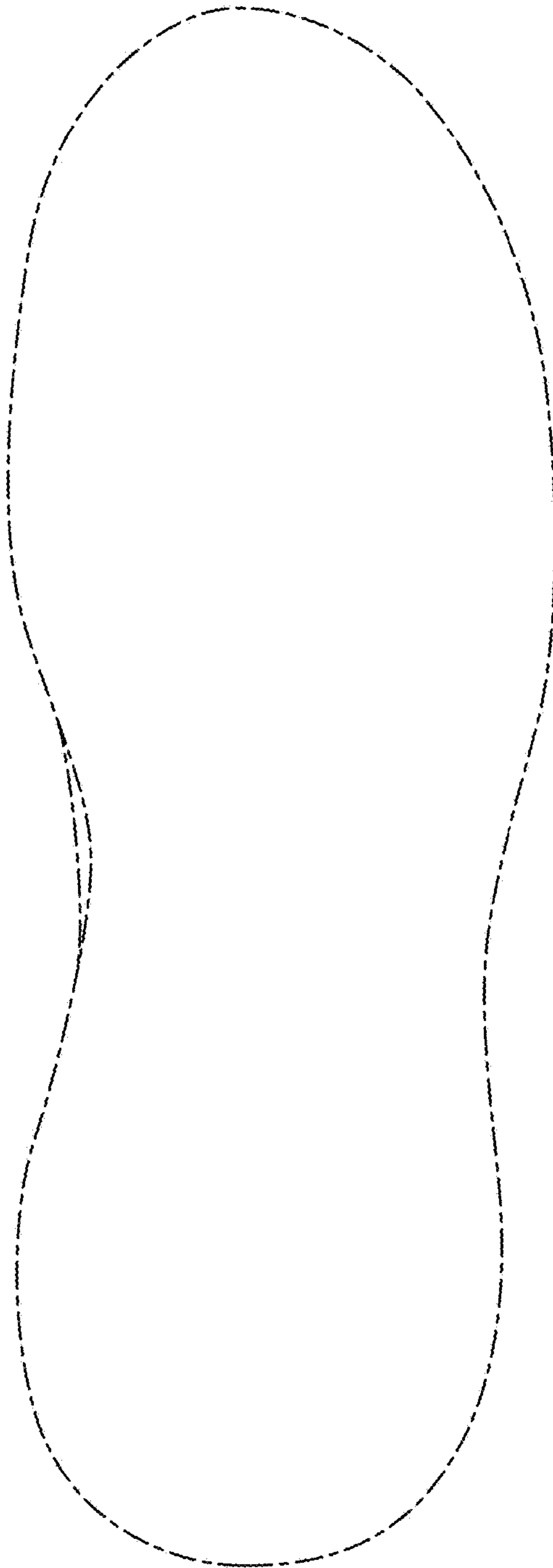

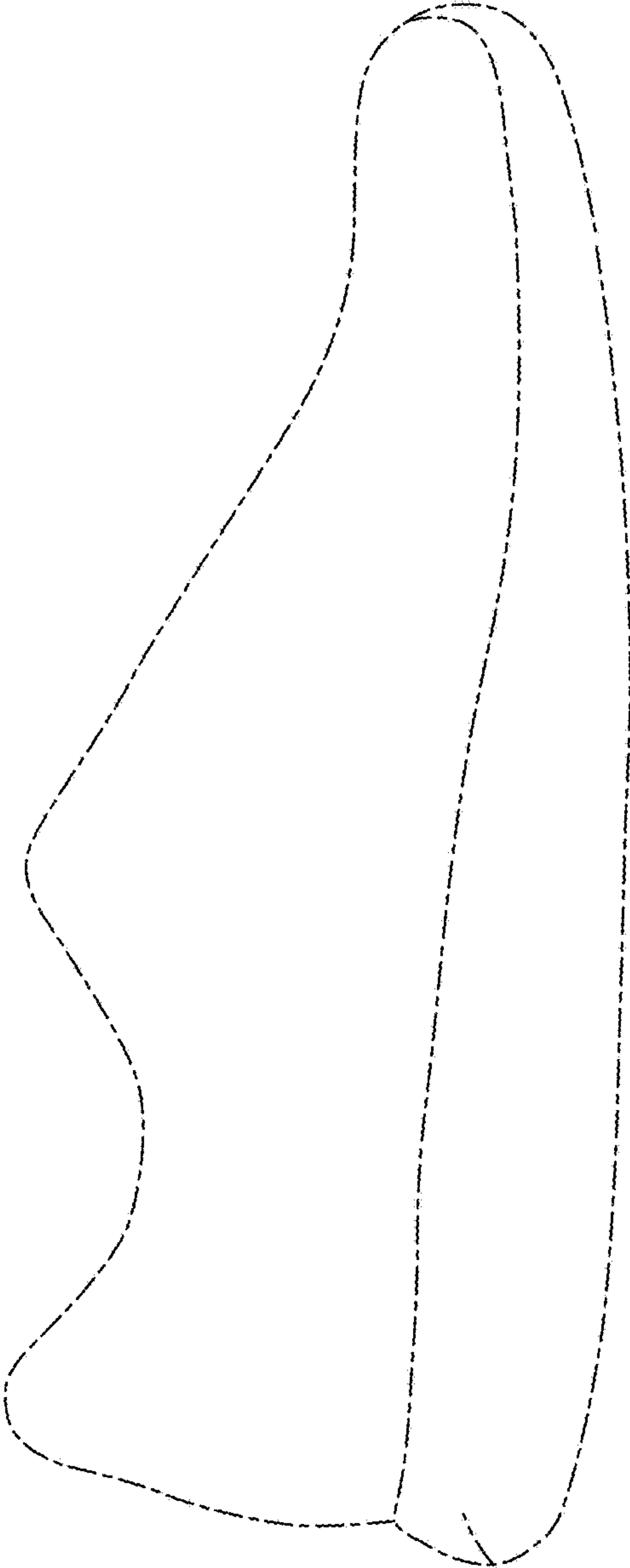

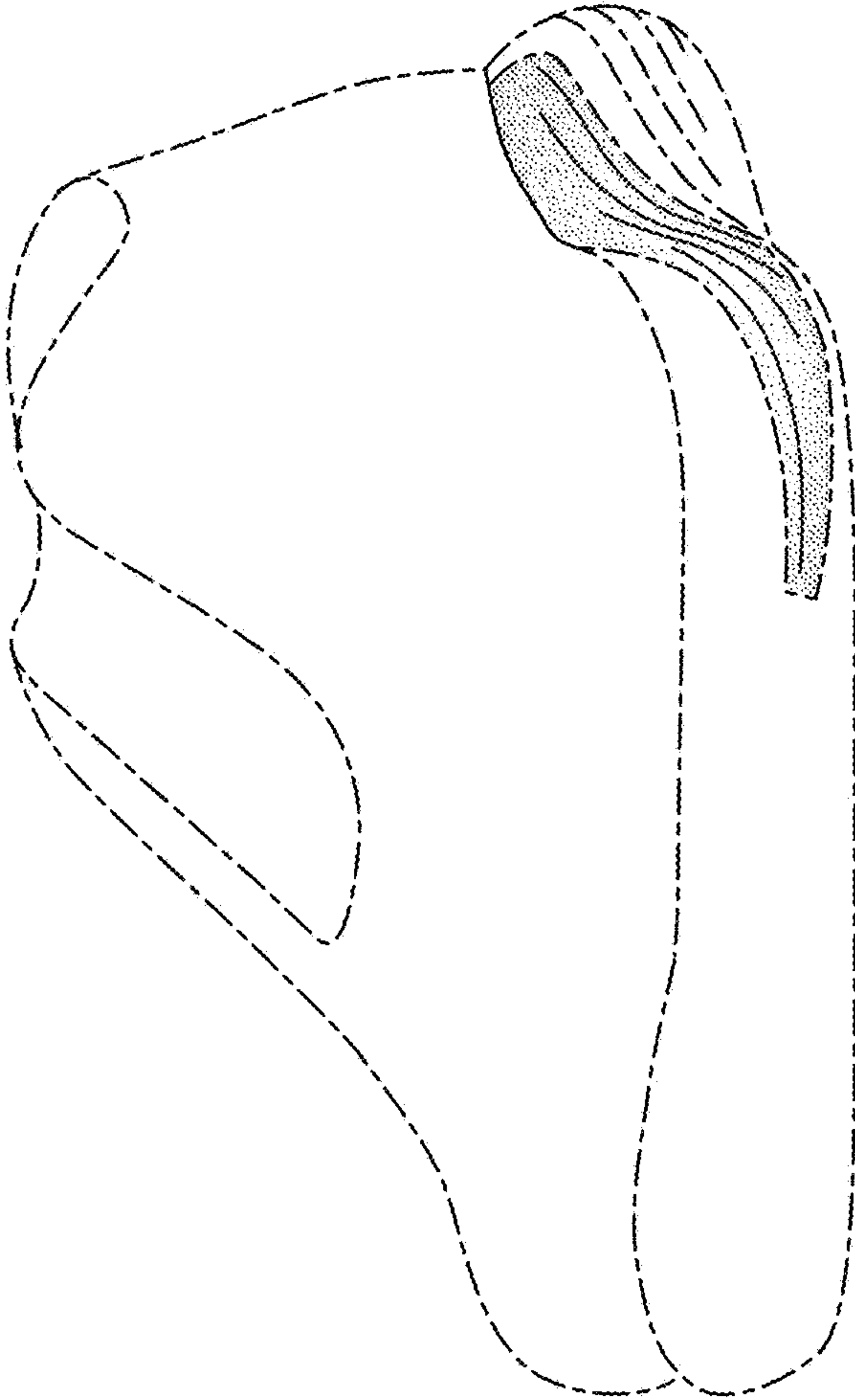

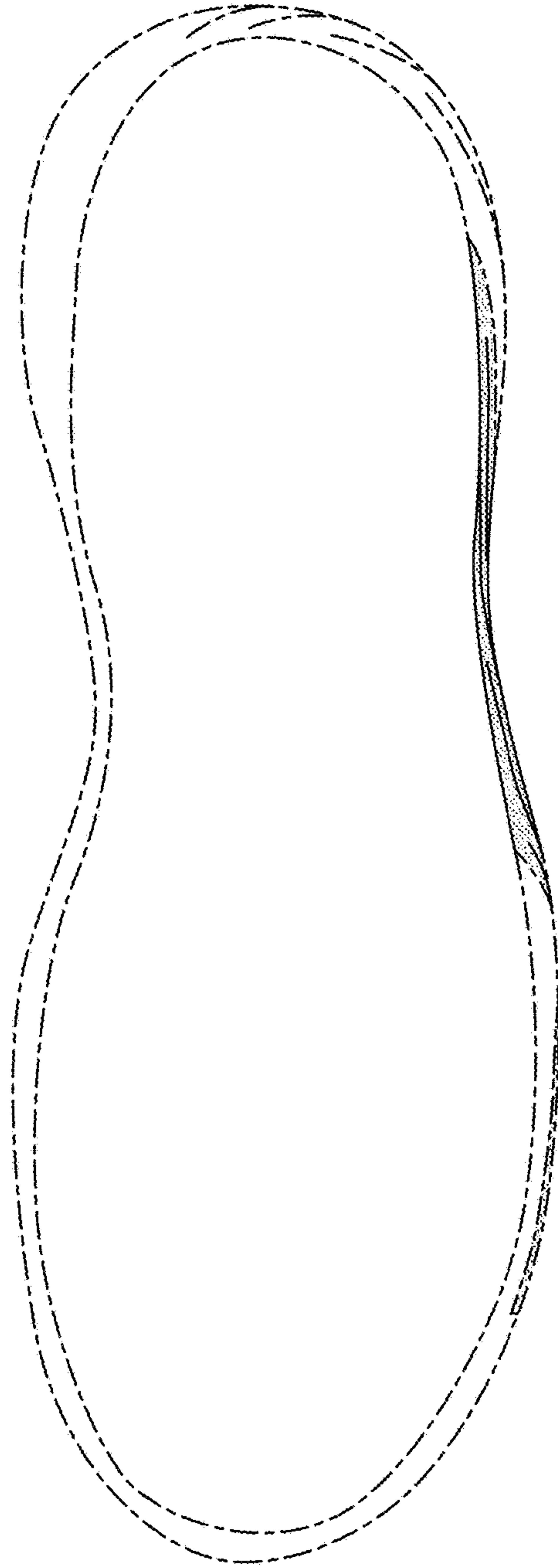
