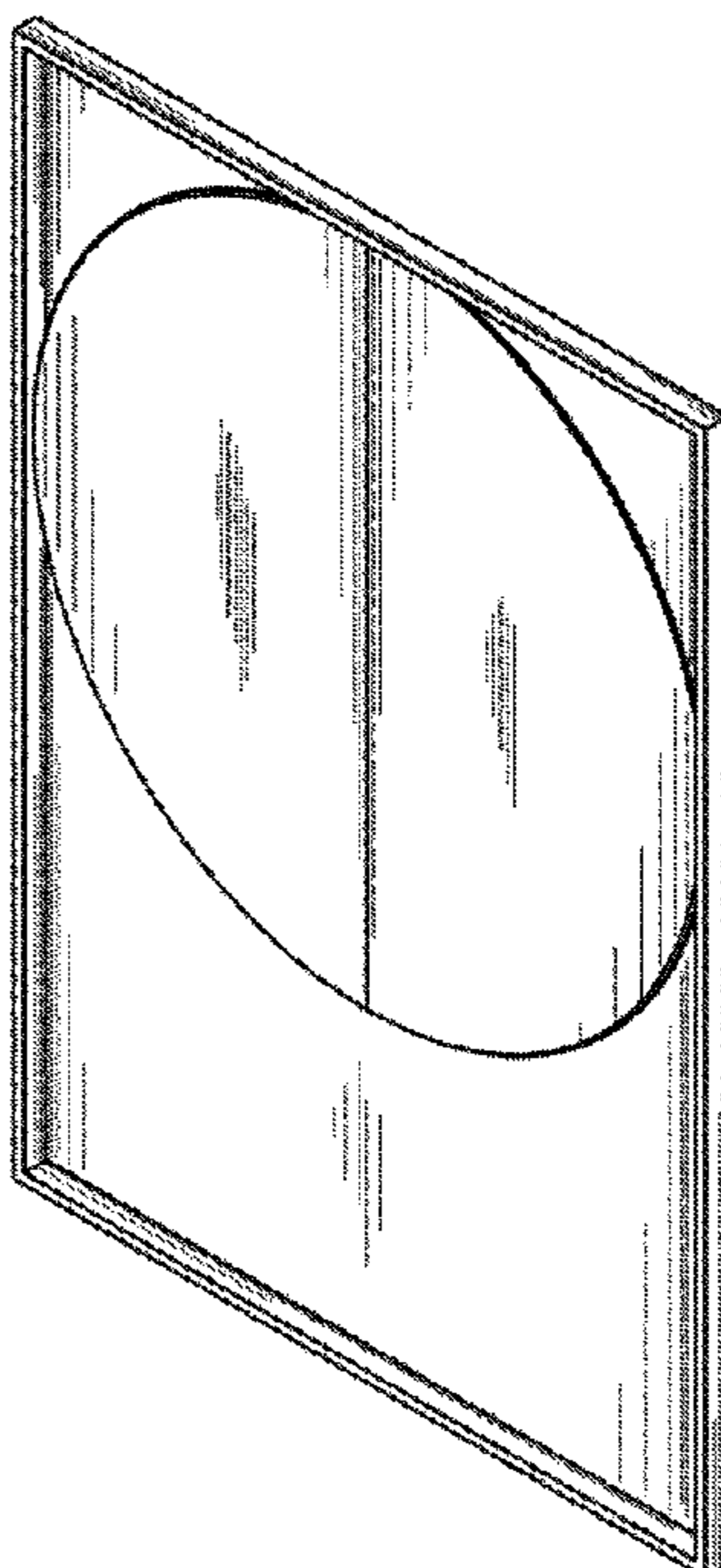

- 1.4 is a top view thereof.

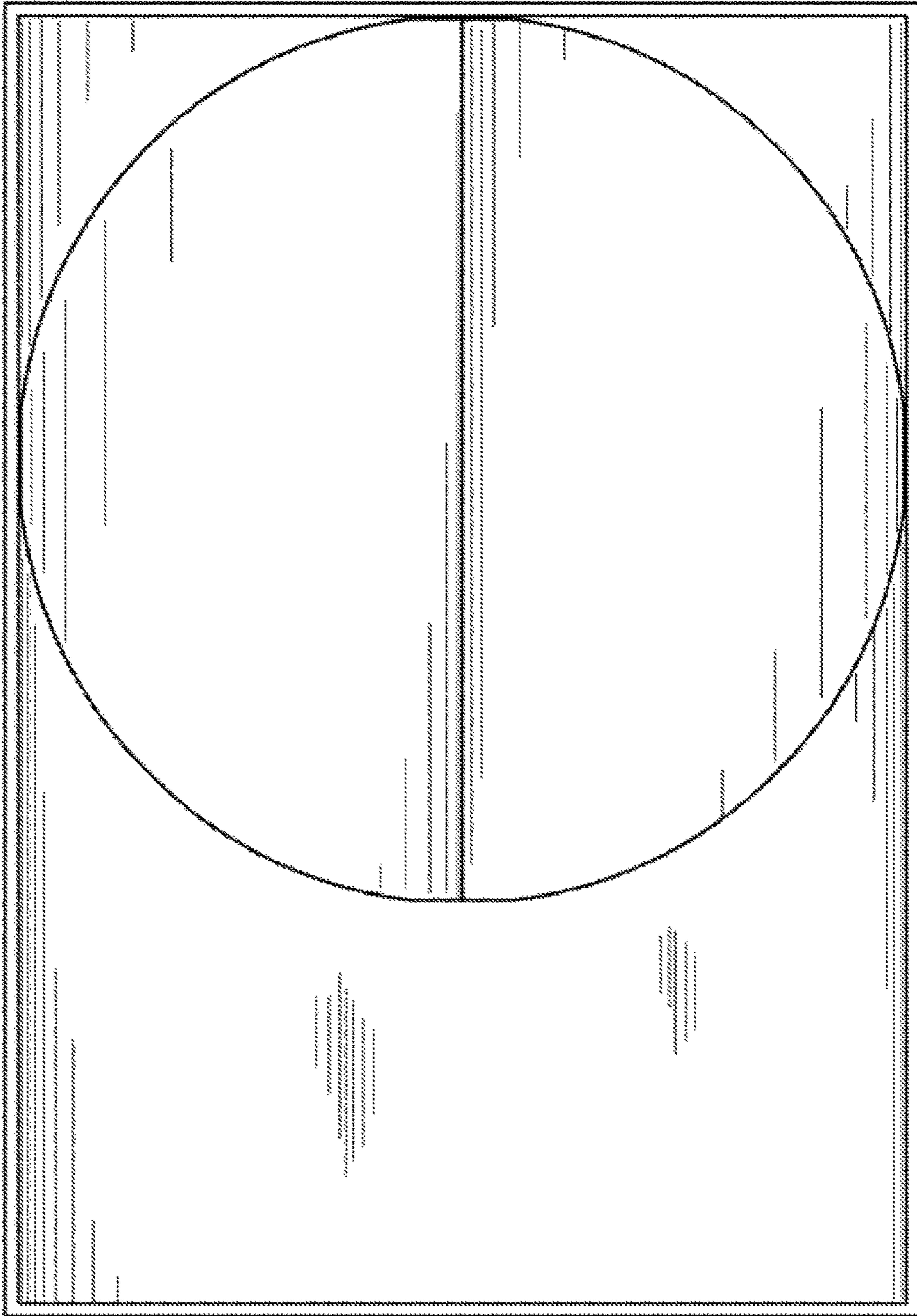

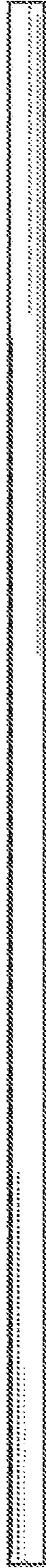
