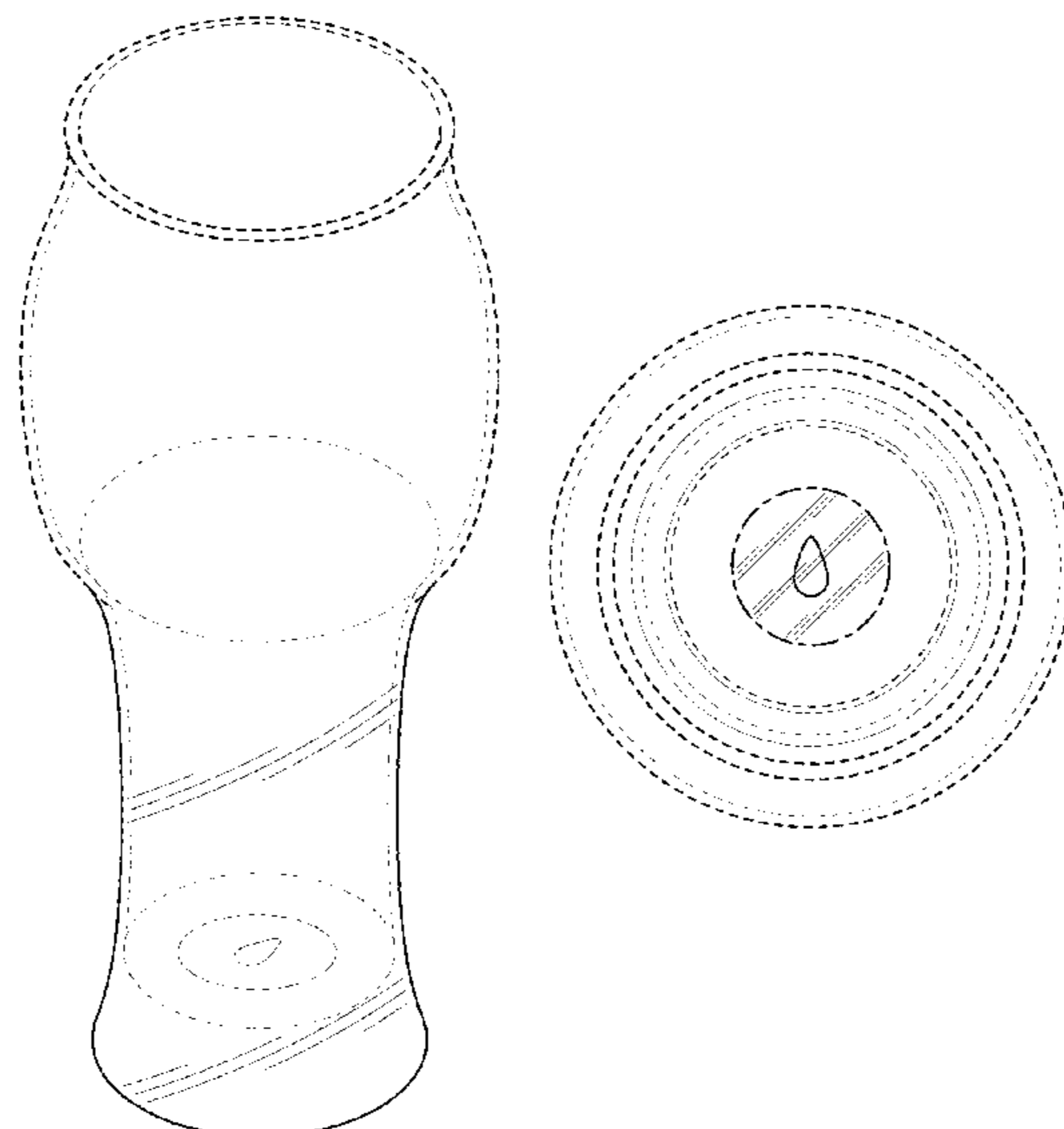
(57) **CLAIM**

The ornamental design for a beverage drinking vessel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a beverage drinking vessel showing our new design; FIG. 2 is a front view thereof, the left side view and right side view being identical to the front view; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; and FIG. 5 is a cross-sectional view showing a section taken along line 5-5 of FIG. 2; FIG. 6 is a perspective view of a second embodiment of a beverage drinking vessel; FIG. 7 is a front view thereof, the left side view and right side view being identical to the front view; FIG. 8 is a top view thereof; FIG. 9 is a bottom view thereof; and, FIG. 10 is a cross-sectional view showing a section taken along line 10-10 of FIG. 7. The surface shading shown in FIG. 3 indicates that the claimed beverage drinking vessel is transparent. The surface shading shown in FIG. 8 indicates that the claimed beverage drinking vessel is opaque. The broken lines in the drawing depict portions of the beverage drinking vessel that form no part of the claimed design. The dash-dot lines in the drawing depict bounds of the claimed design that form no part of the claimed design.

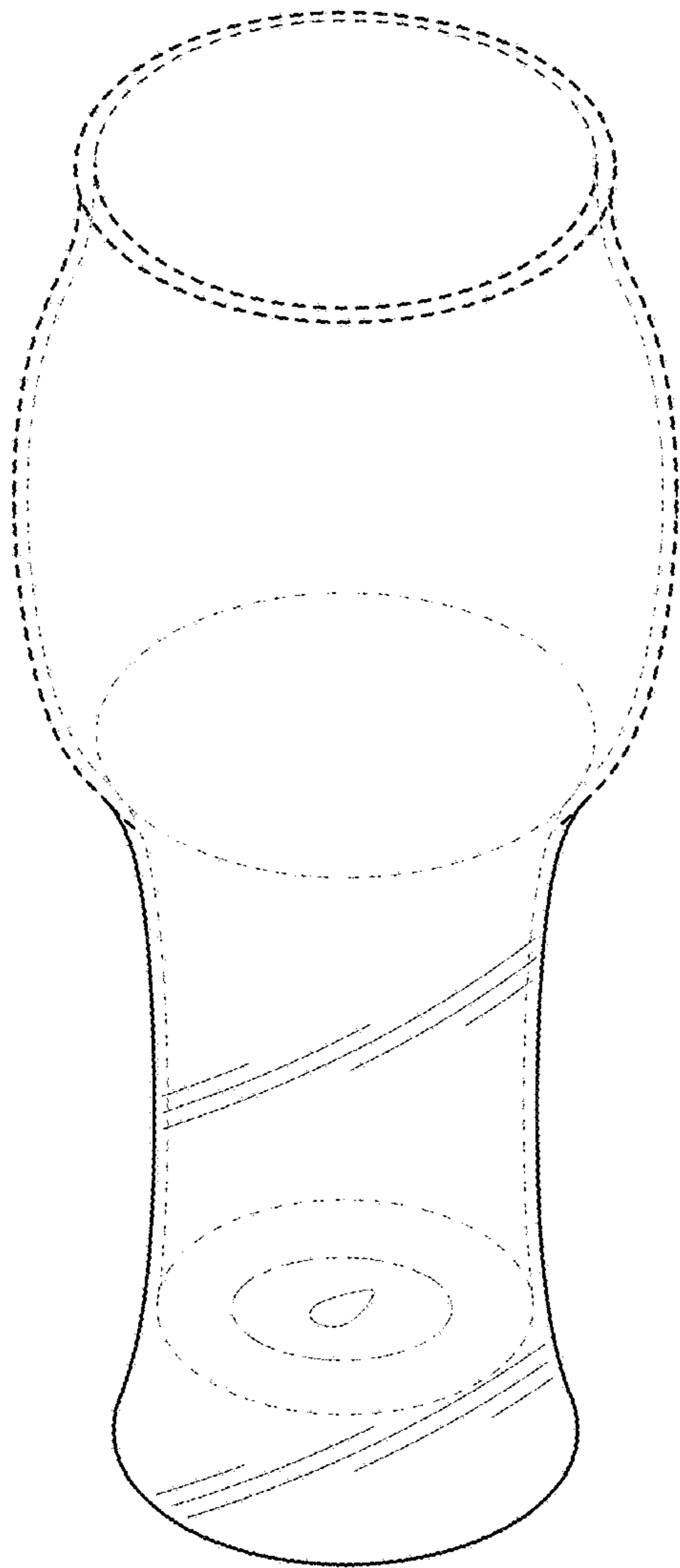

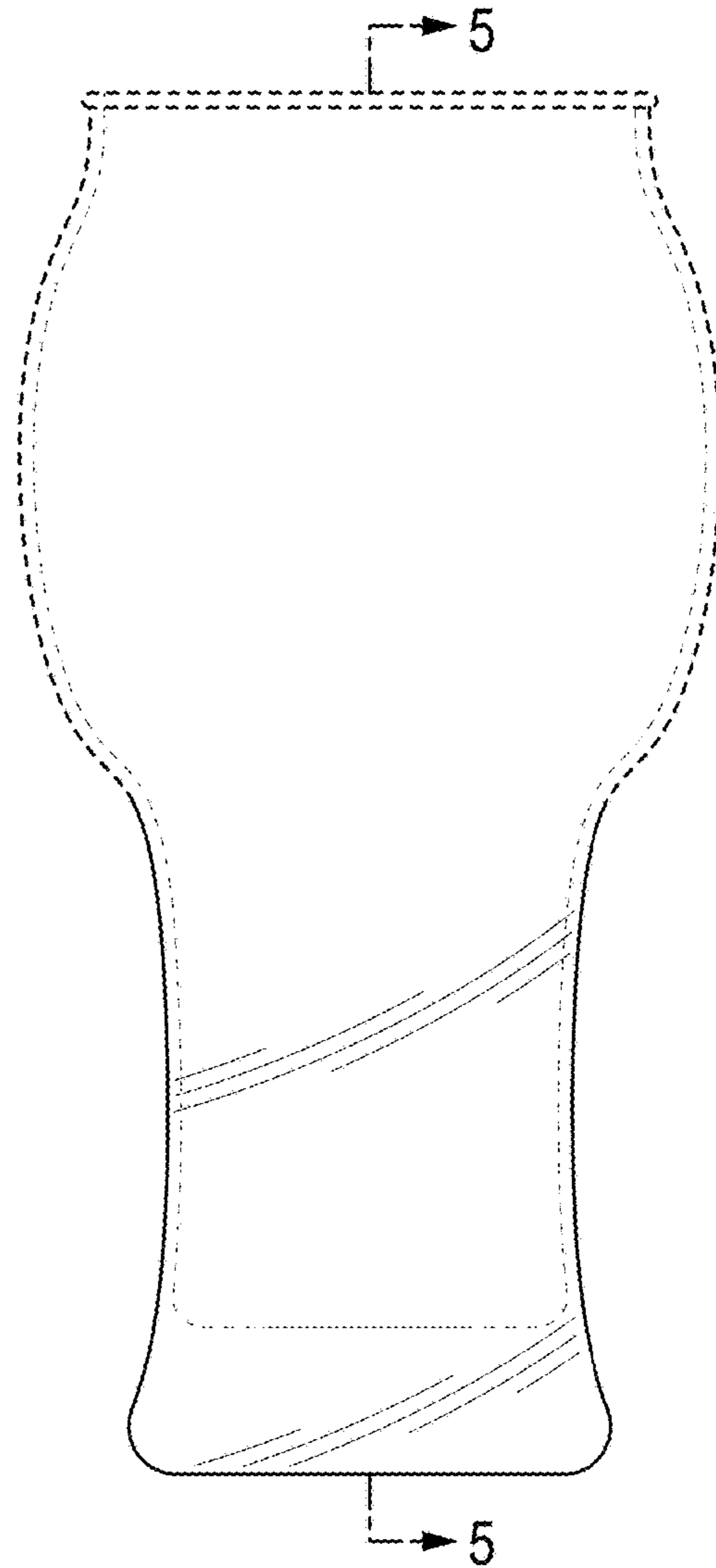

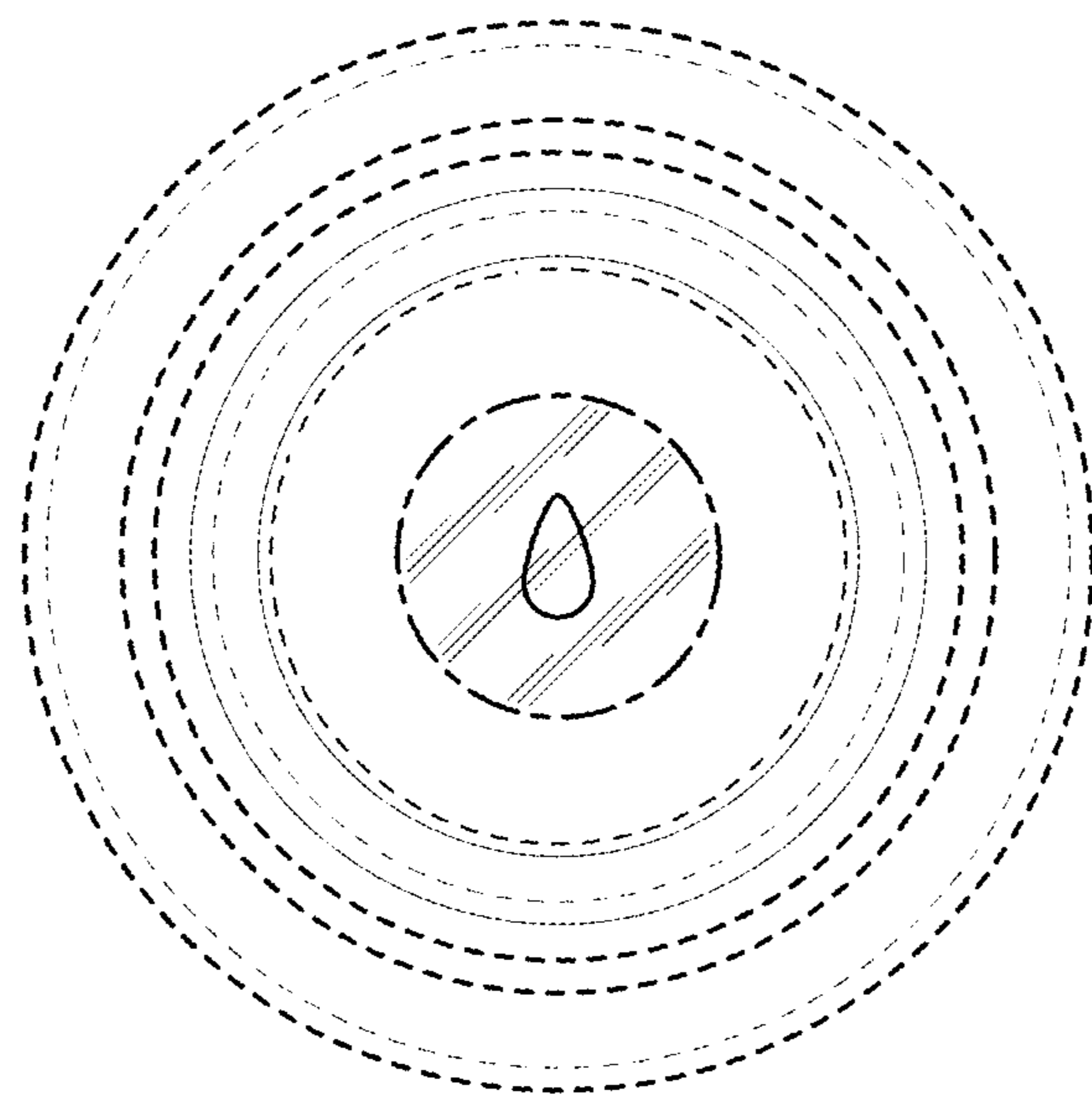

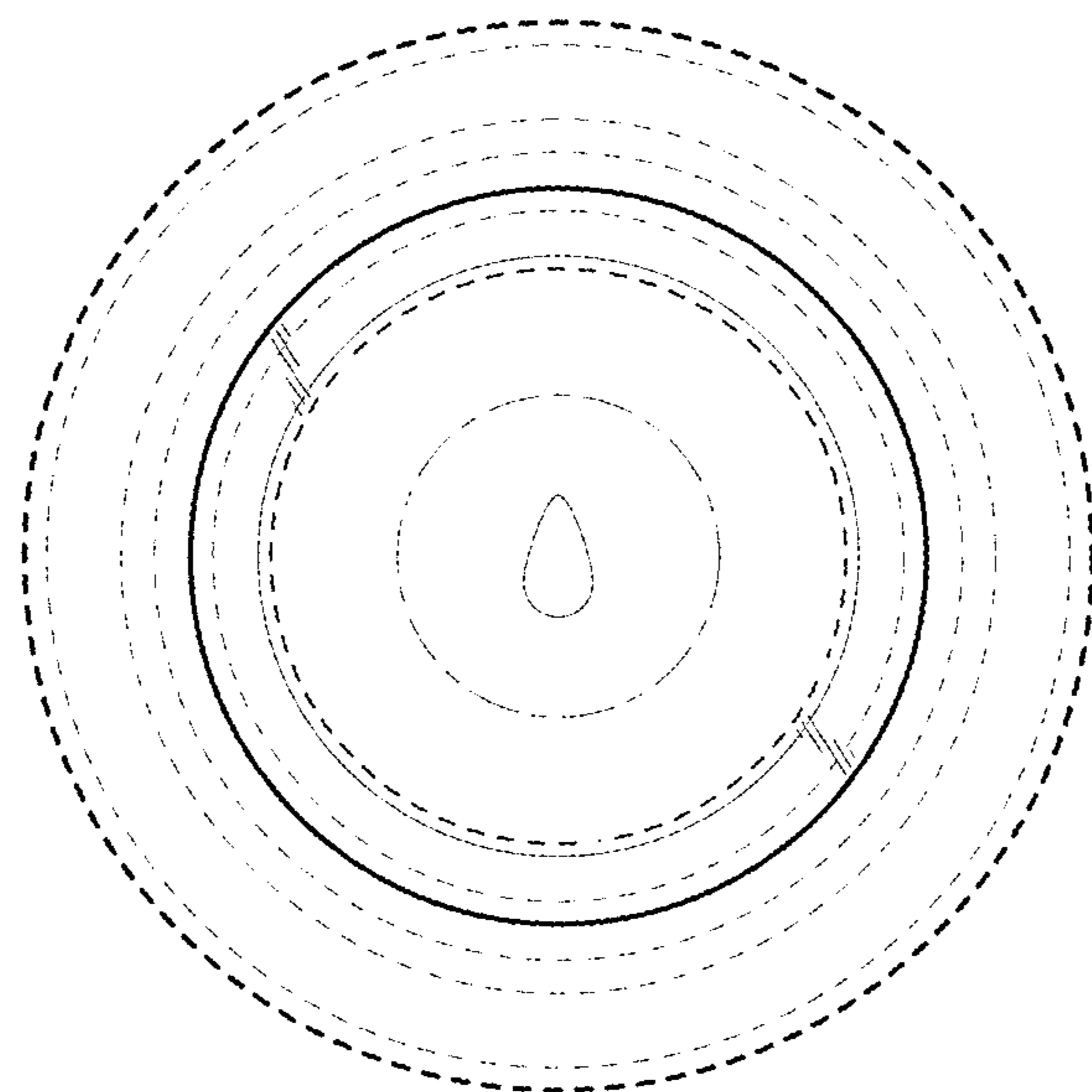

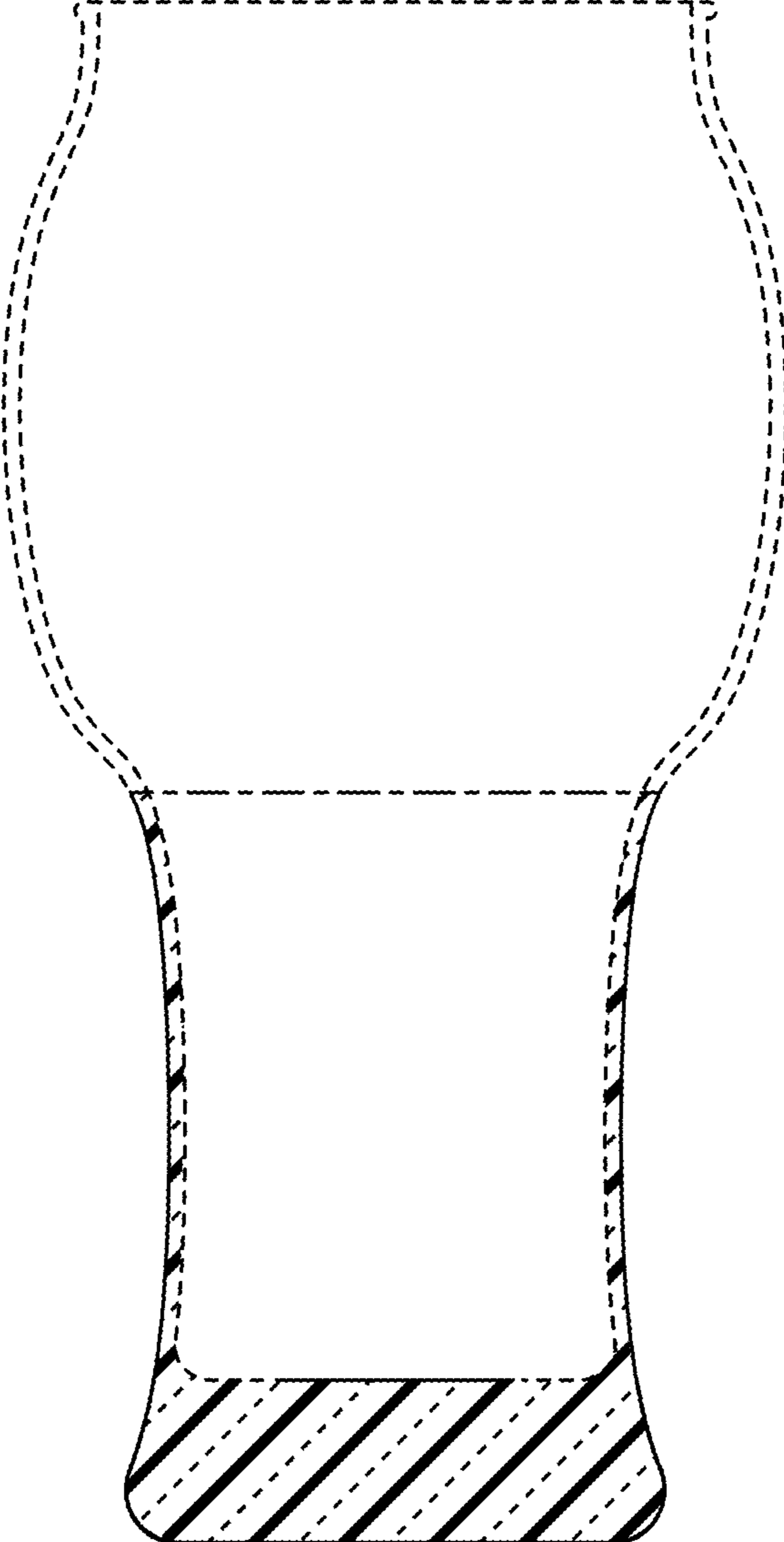

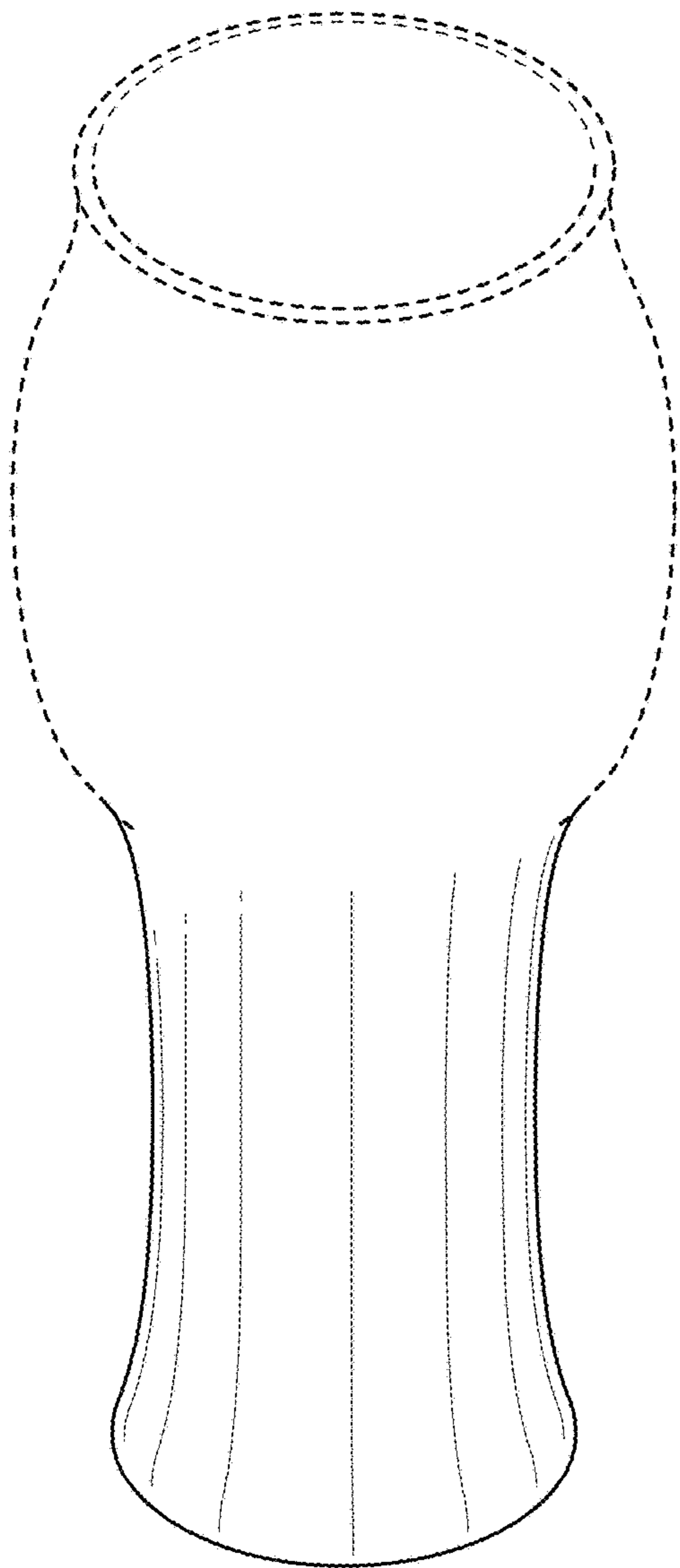

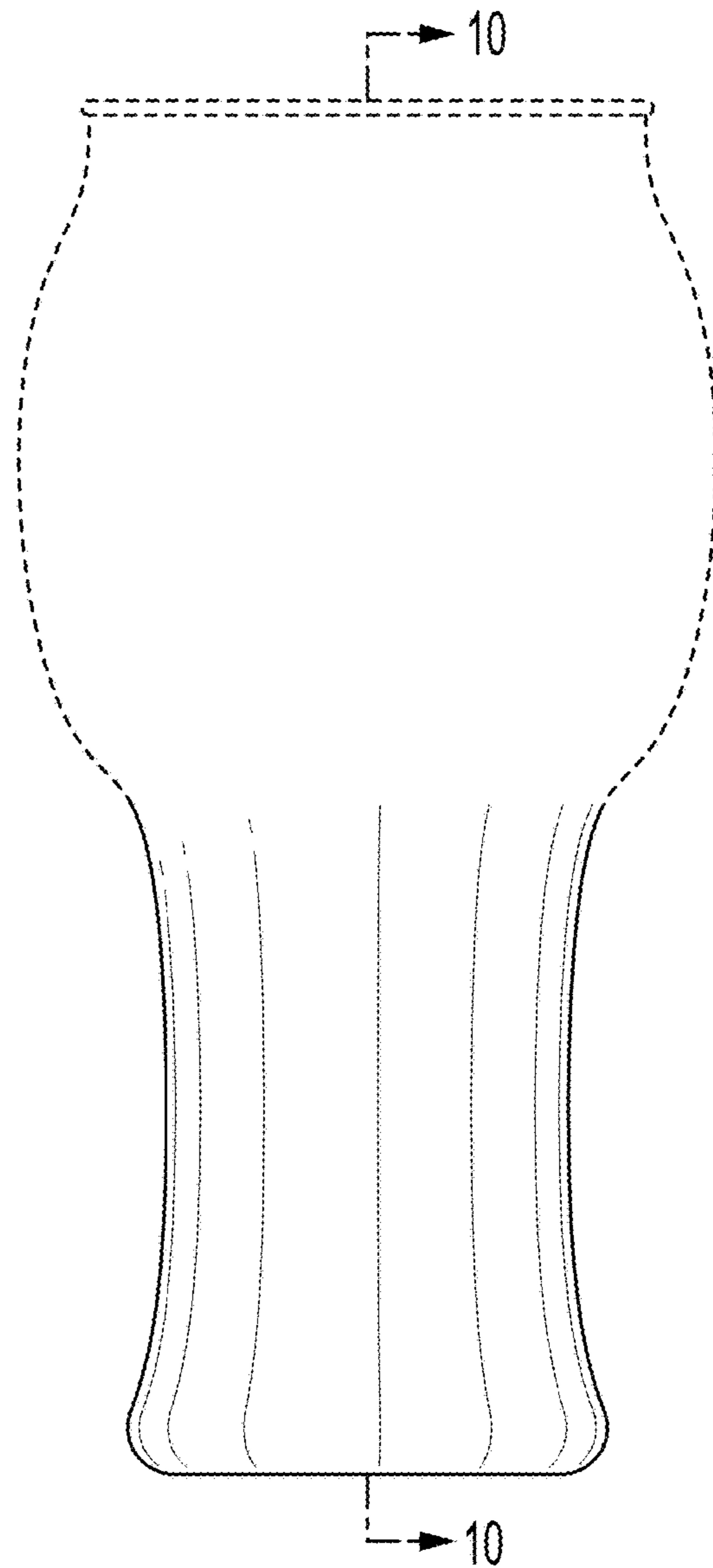

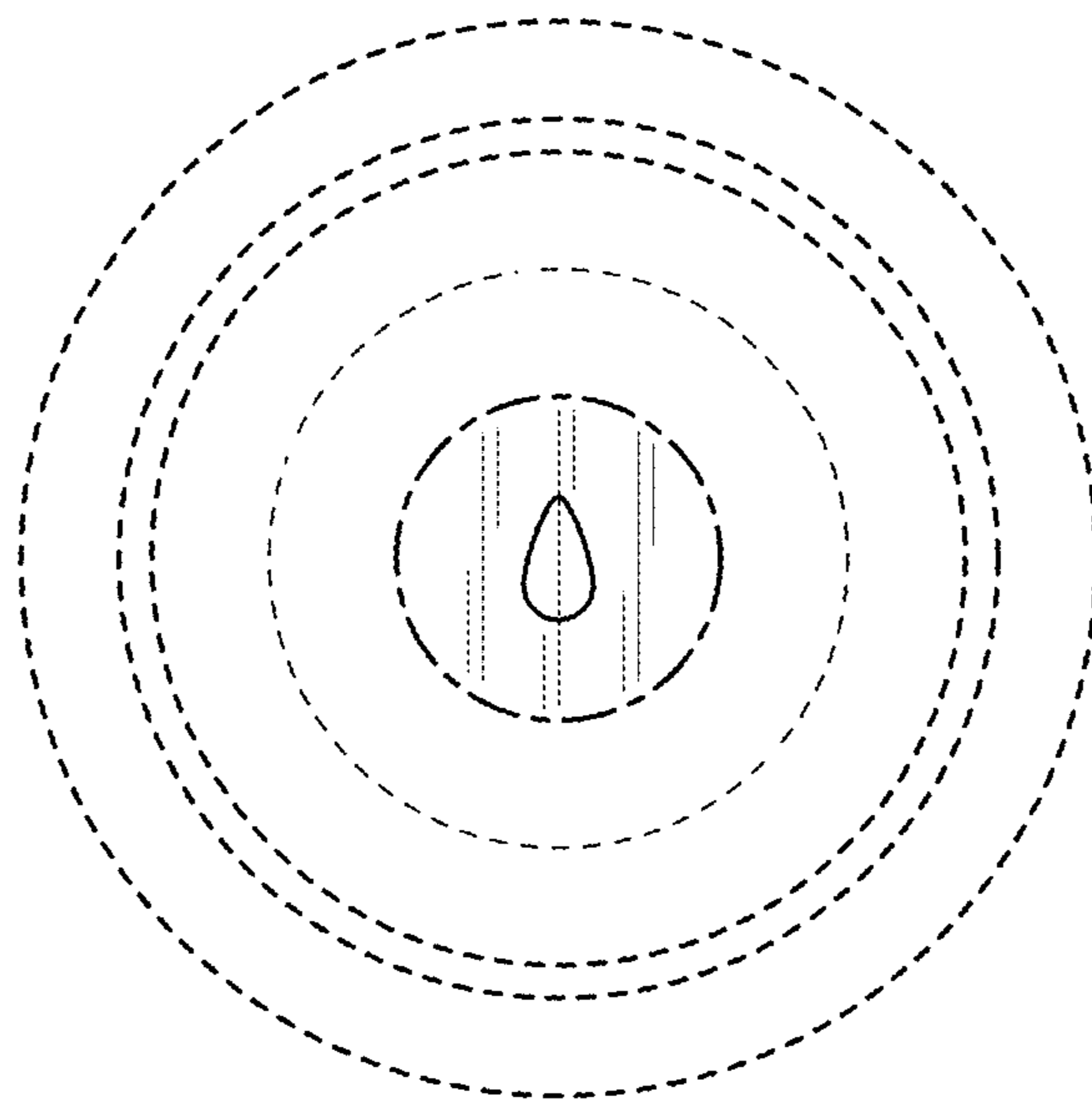

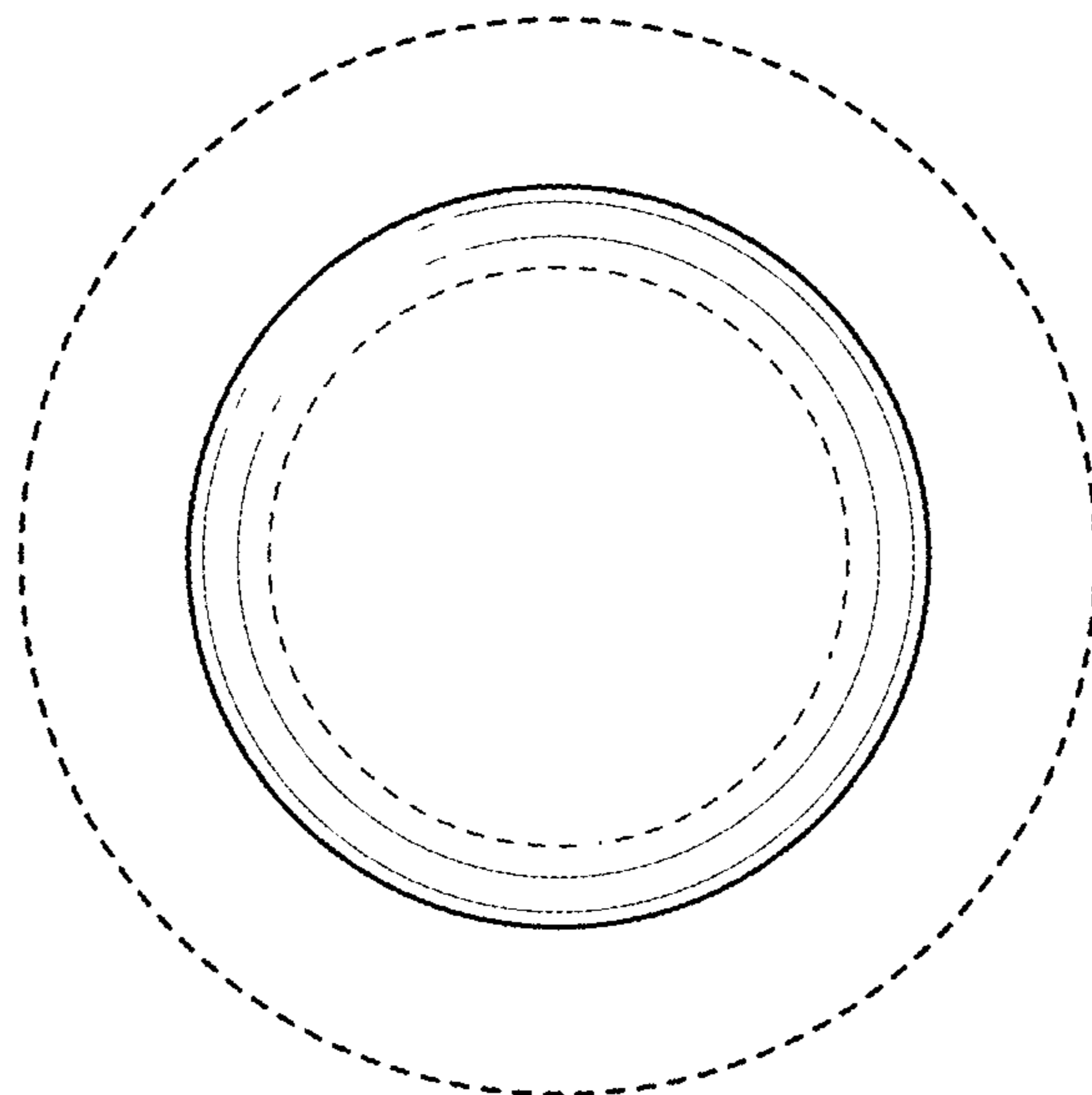

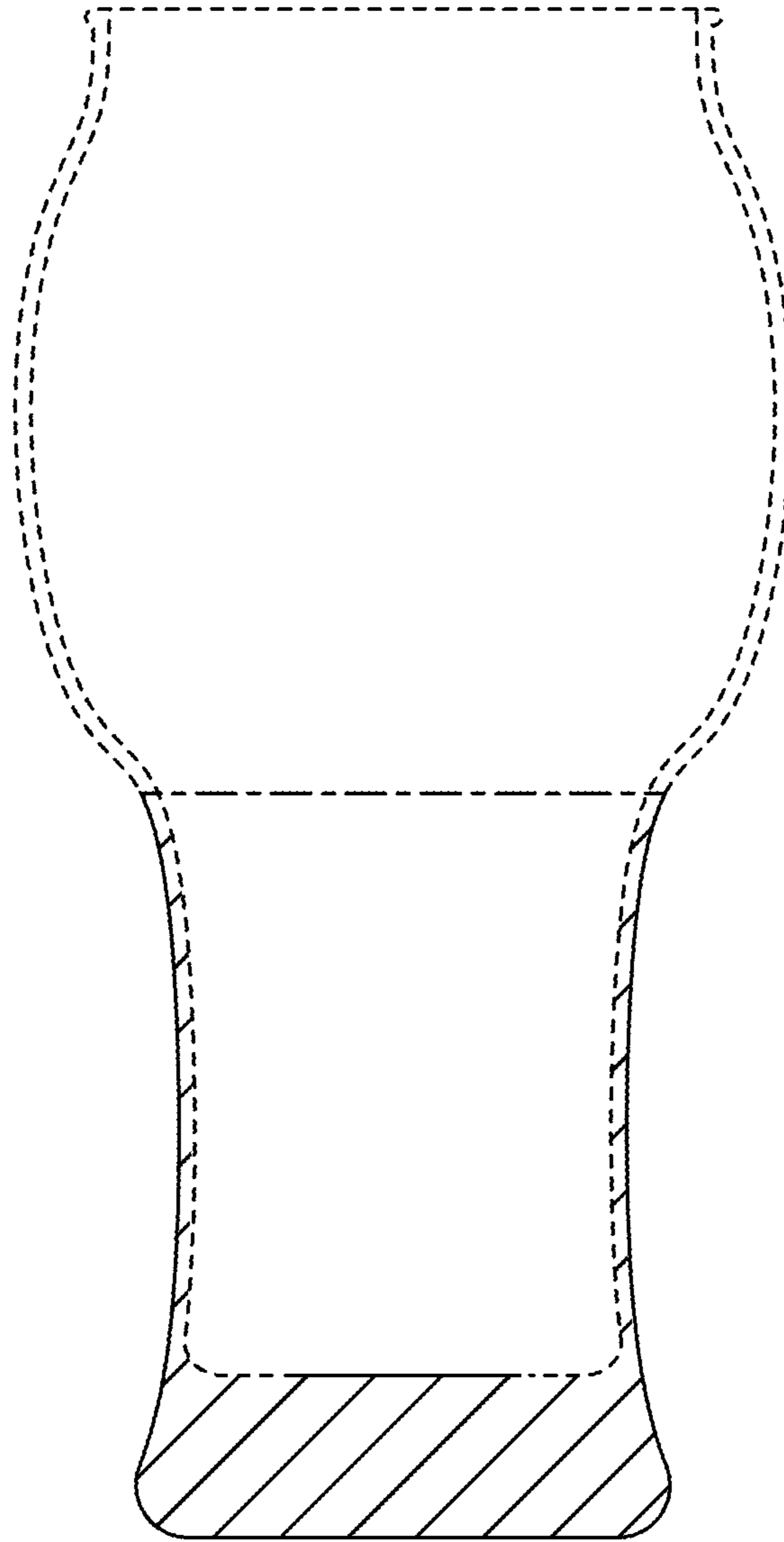
