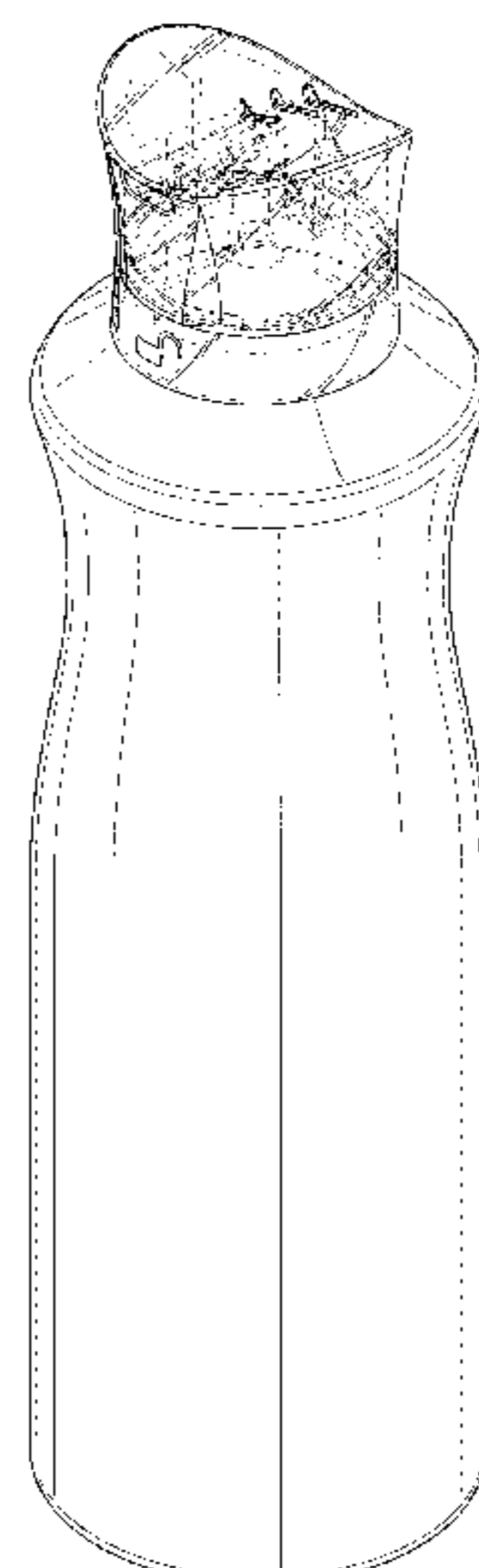
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle, showing our new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a perspective view similar to FIG. 1, but showing the band at the base of the closure rotated to the unlocked position; and,  
FIG. 9 is a perspective view similar to FIG. 8, but showing the cap portion without broken lines therein.  
The broken lines are included for the purpose of illustrating environmental structure that forms no part of the claimed design.

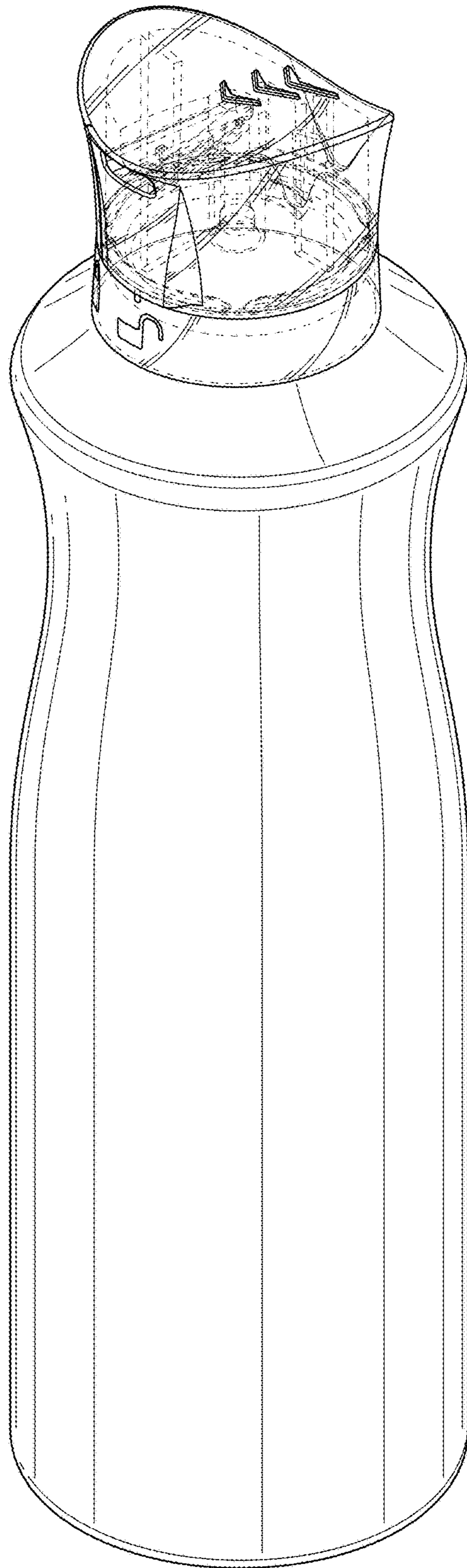

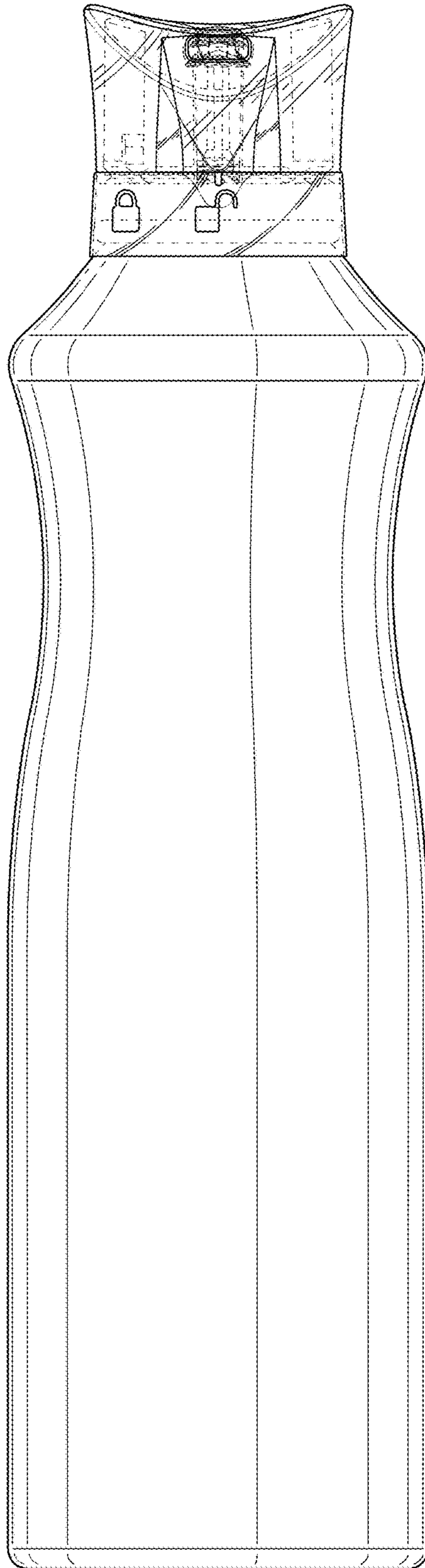

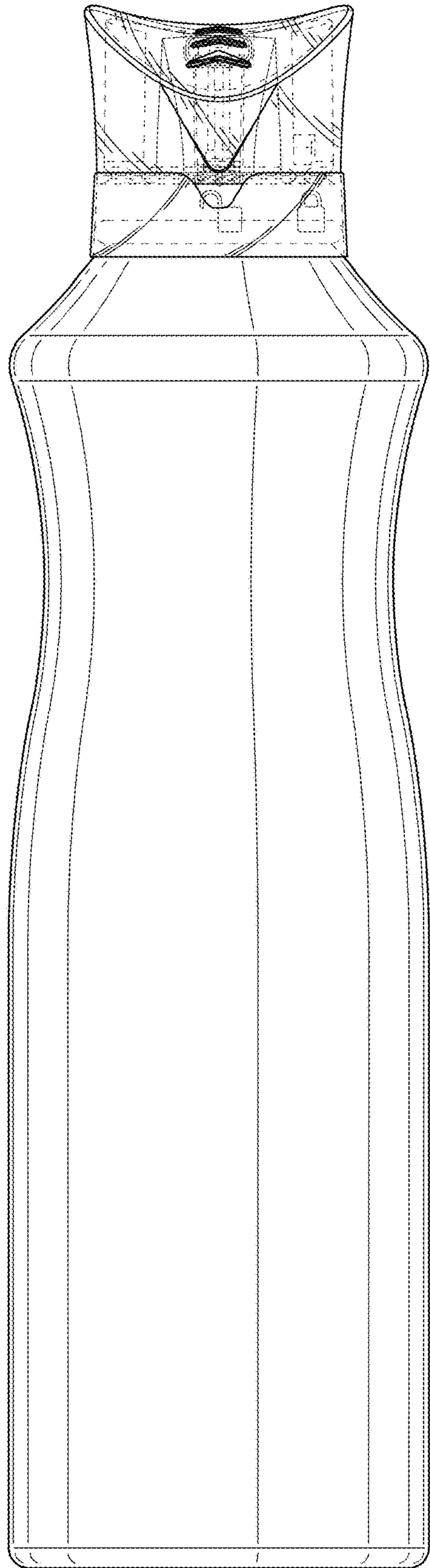

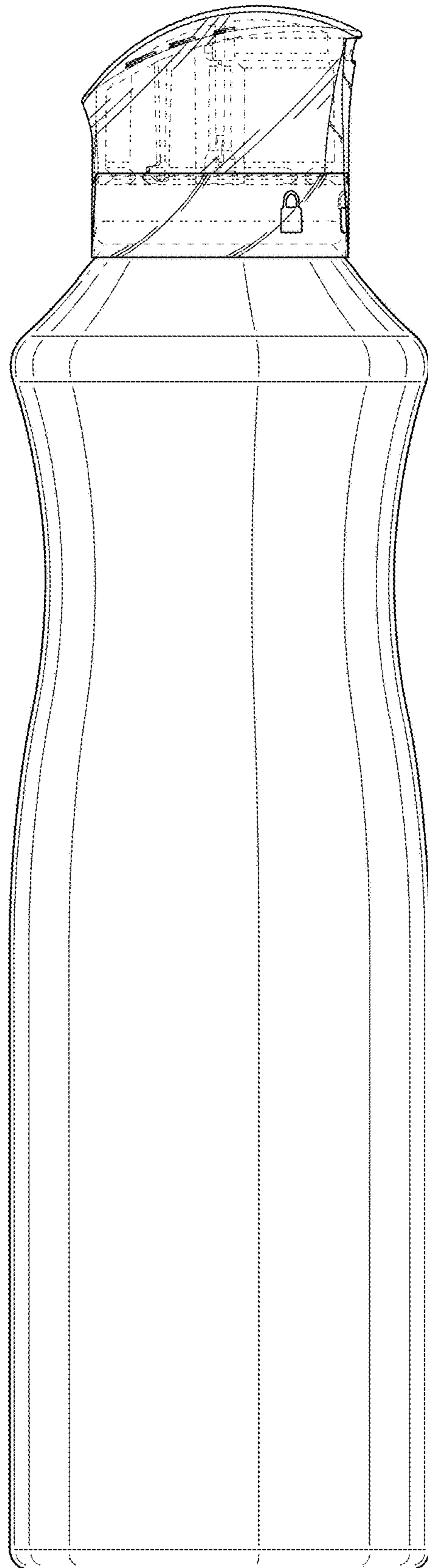

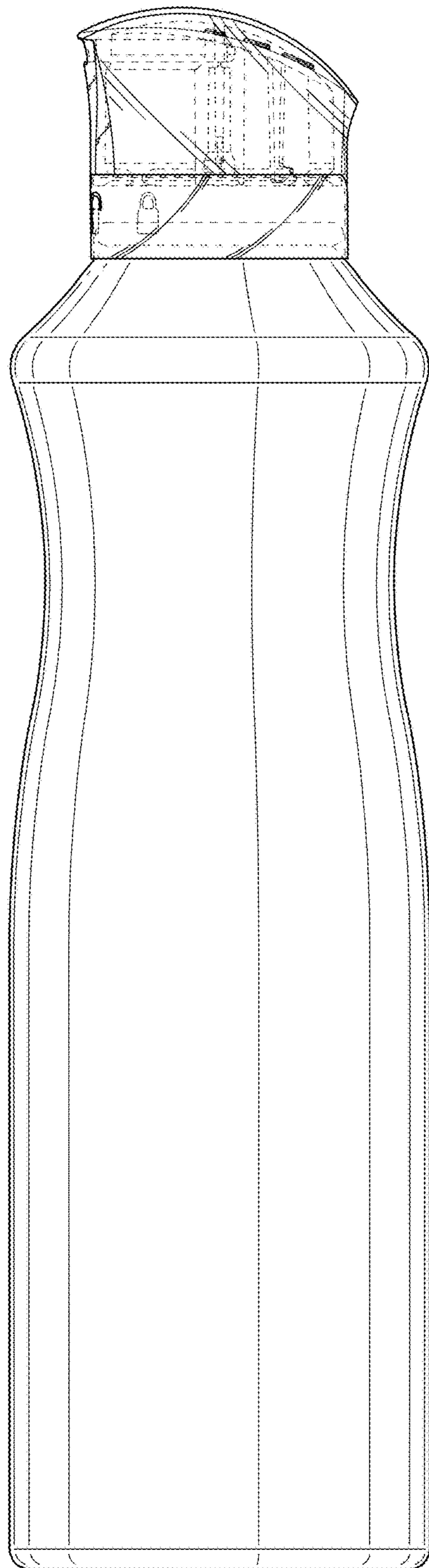

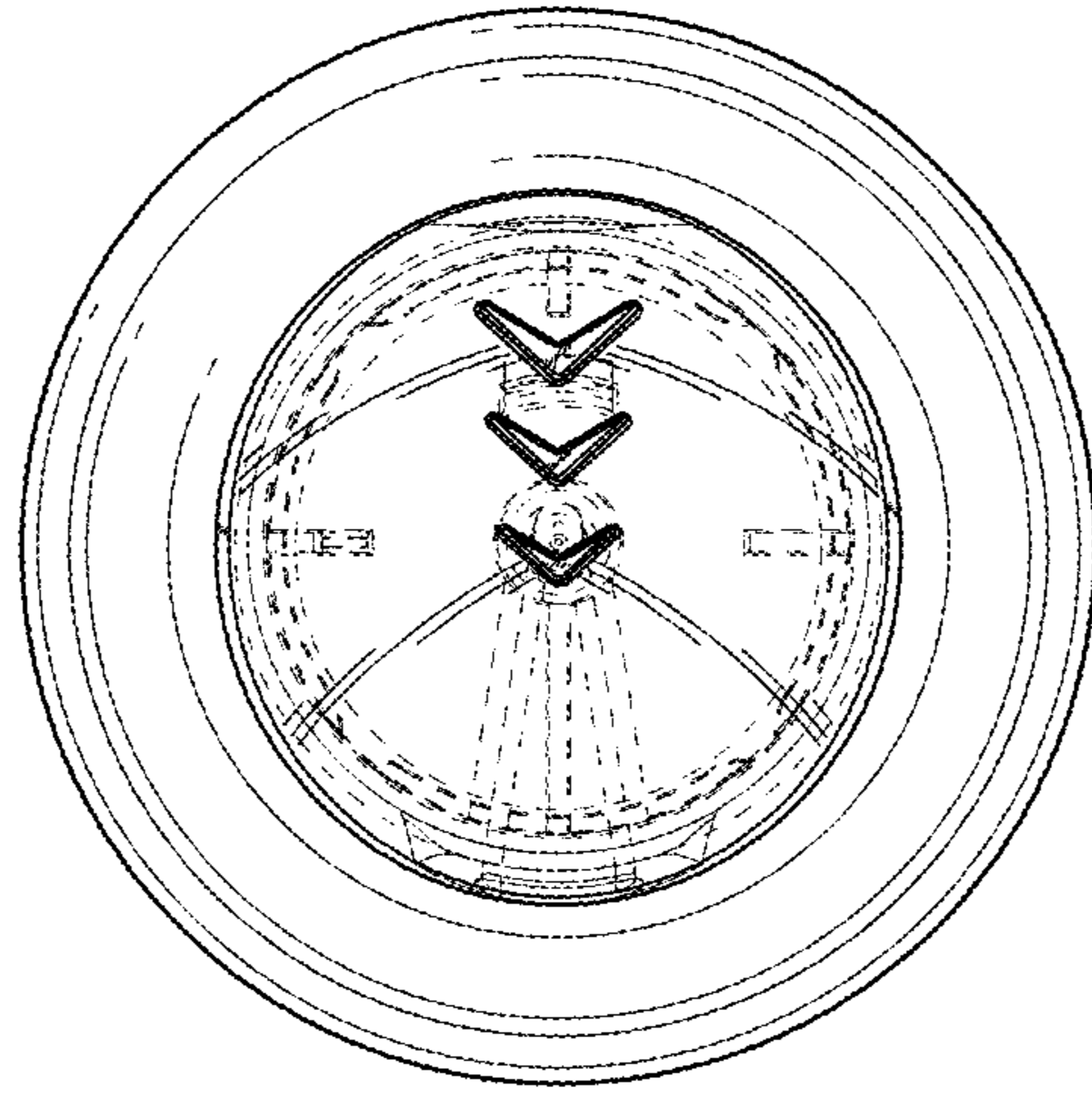

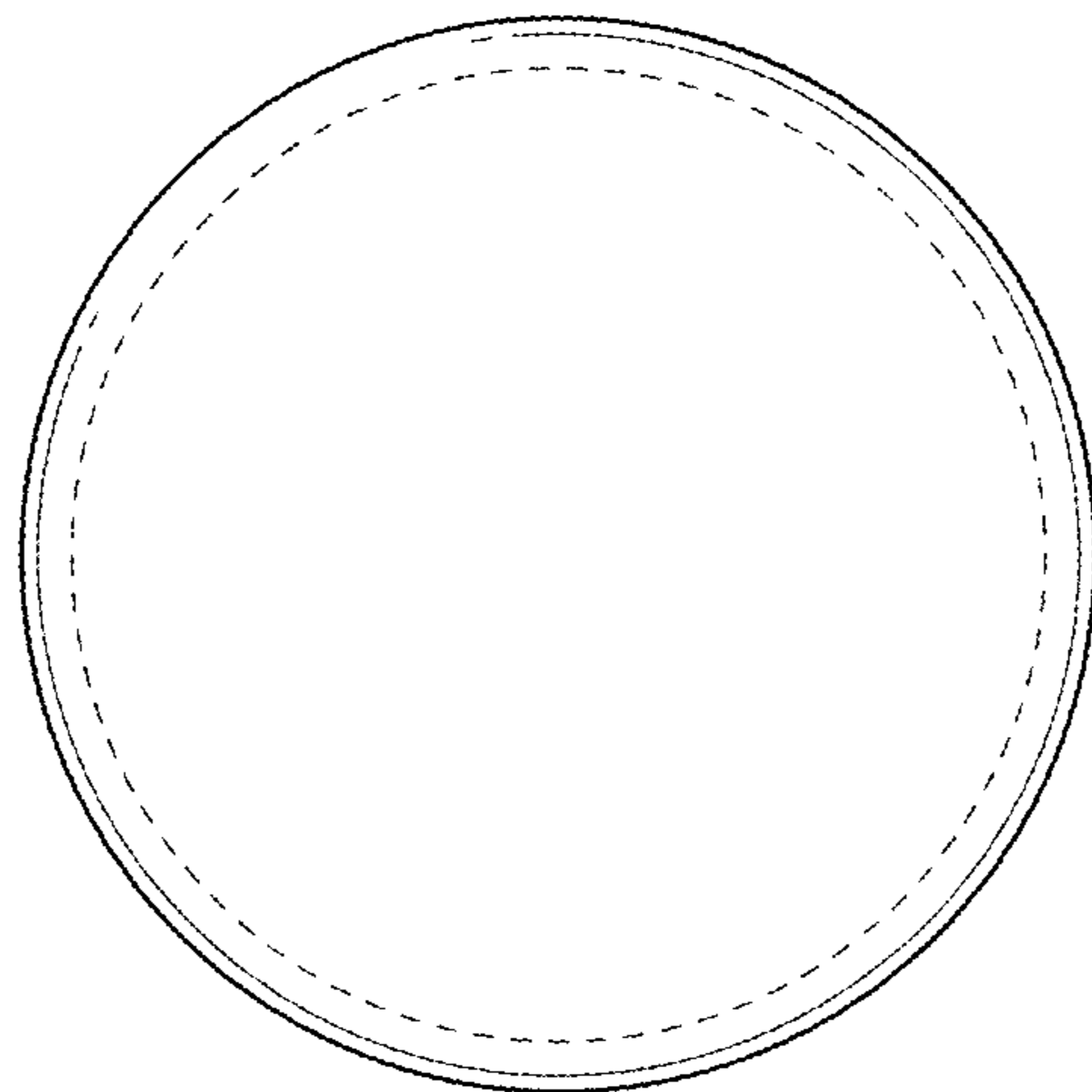

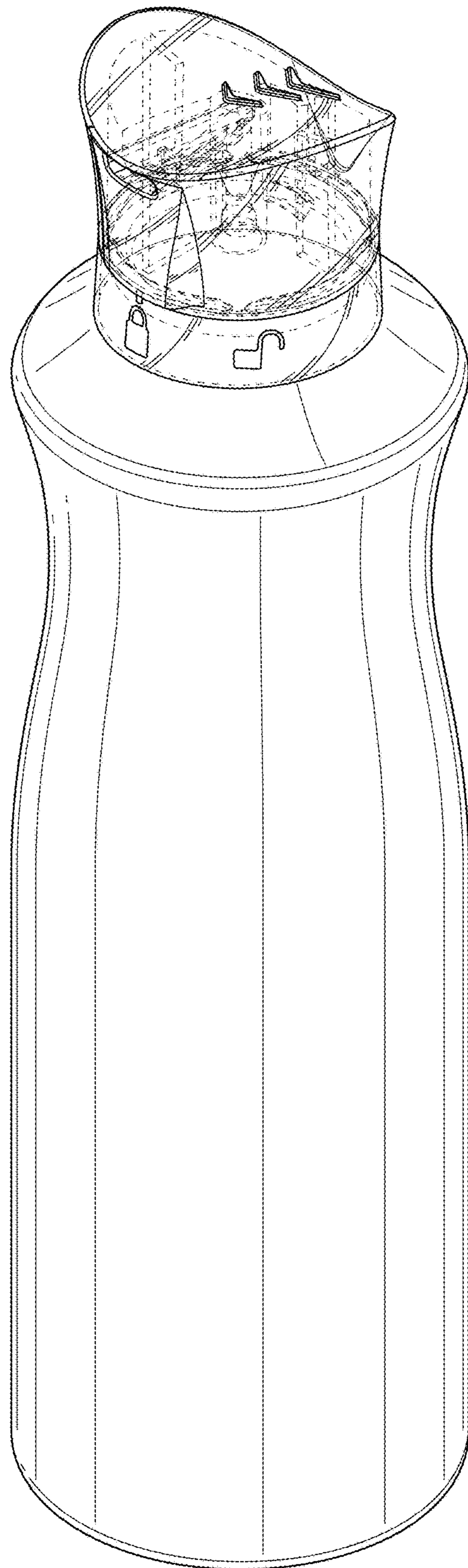

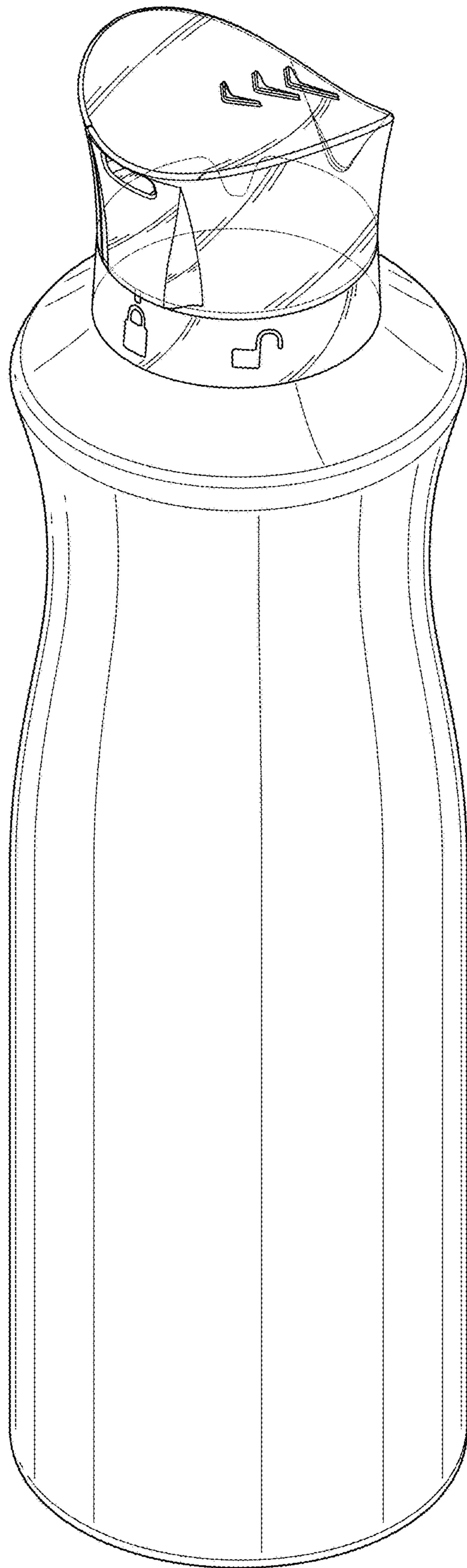
