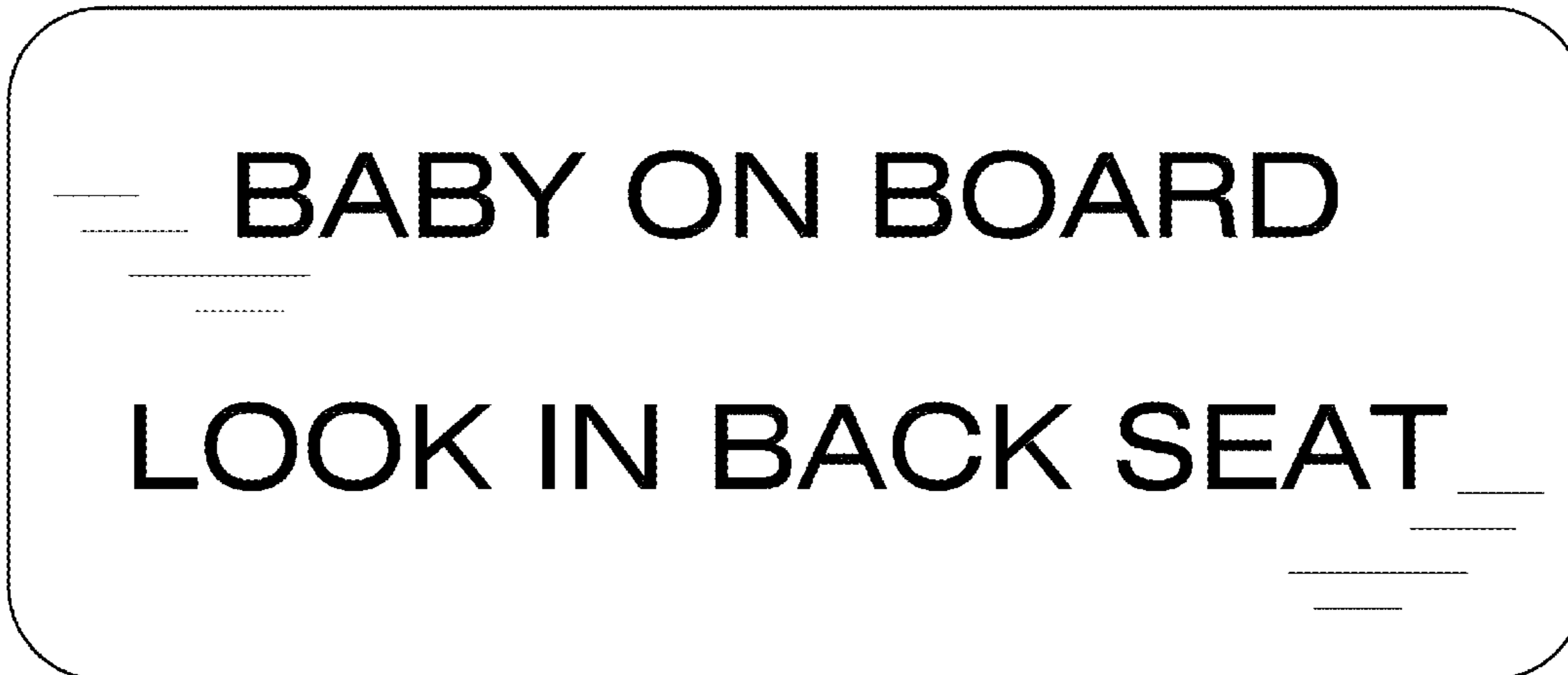
(57) **CLAIM**

I claim the ornamental design for a steering wheel note board, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the steering wheel note board, showing my new design;

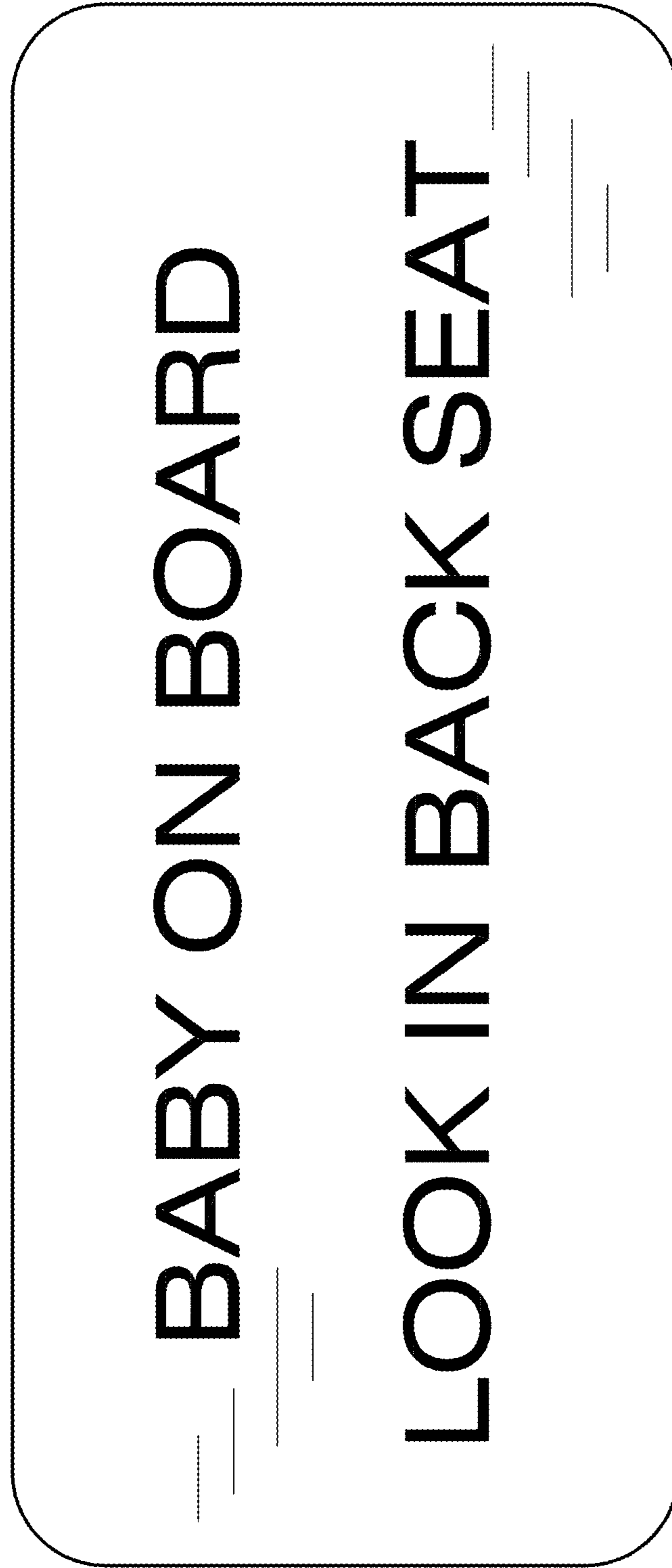

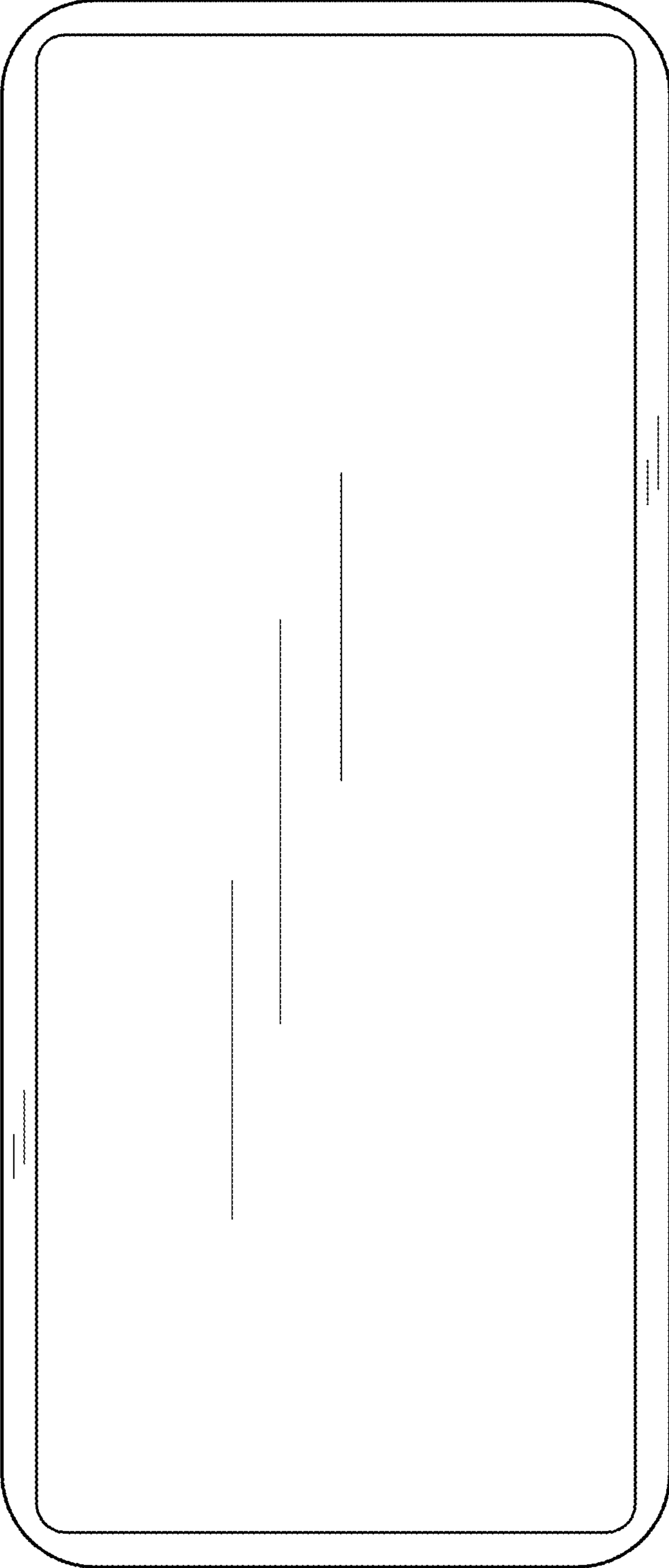

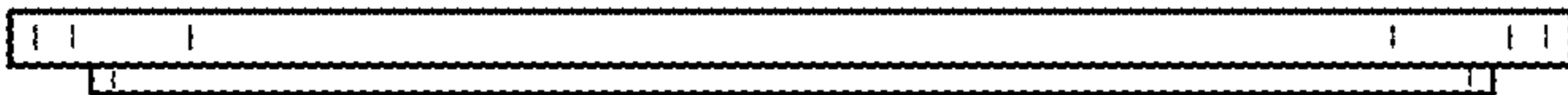

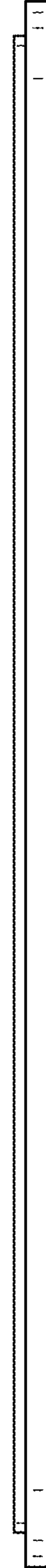

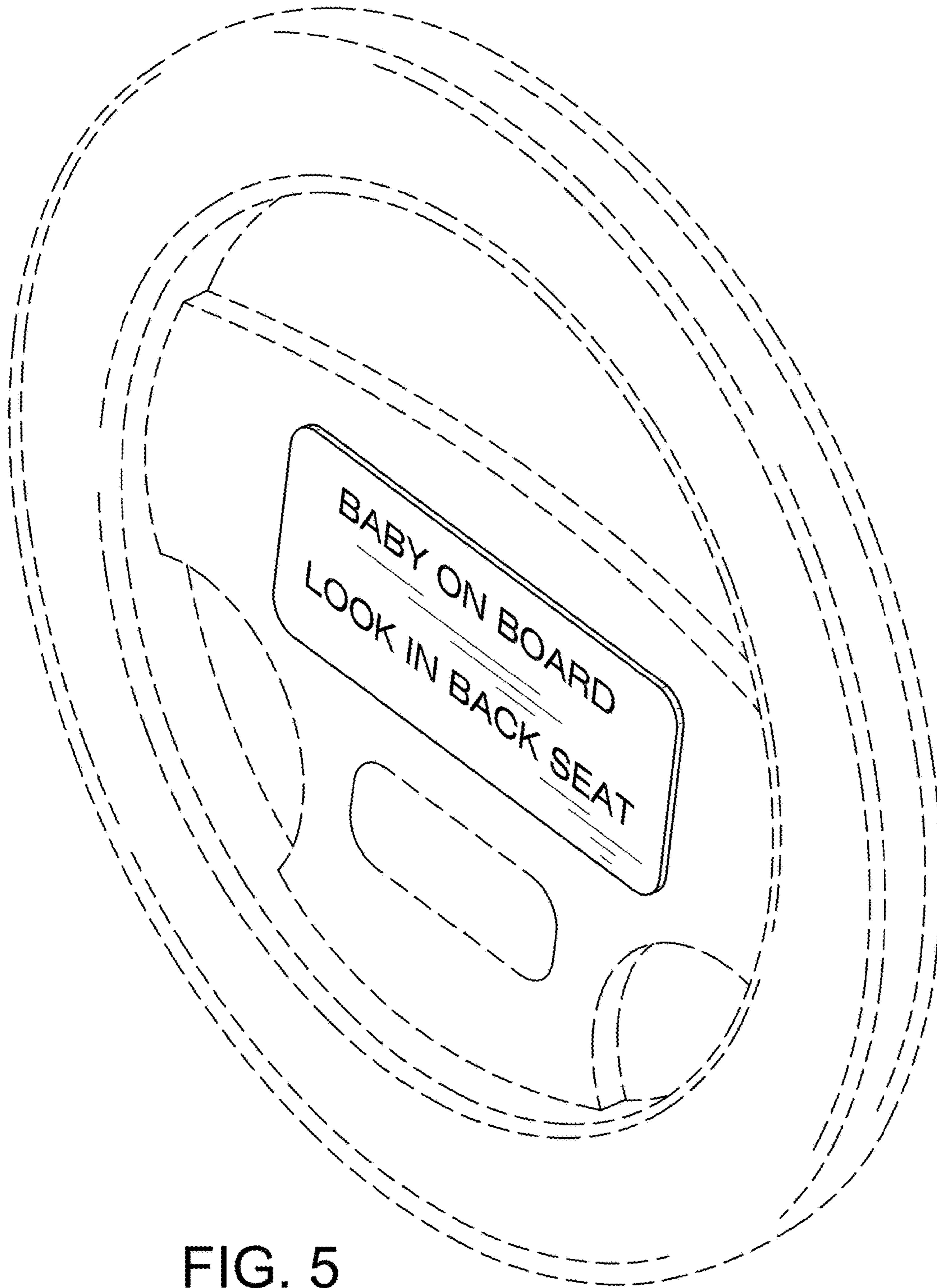
