

(57) **CLAIM**

The ornamental design for an electronic device holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an electronic device holder showing my new design;
FIG. 2 is a front view of the first embodiment of the electronic device holder shown in FIG. 1;
FIG. 3 is a rear view of the first embodiment of the electronic device holder shown in FIG. 1;
FIG. 4 is a left side view of the first embodiment of the electronic device holder shown in FIG. 1;


























