FIG. 1 is a front view of a portion of a display screen with icon showing our new design;

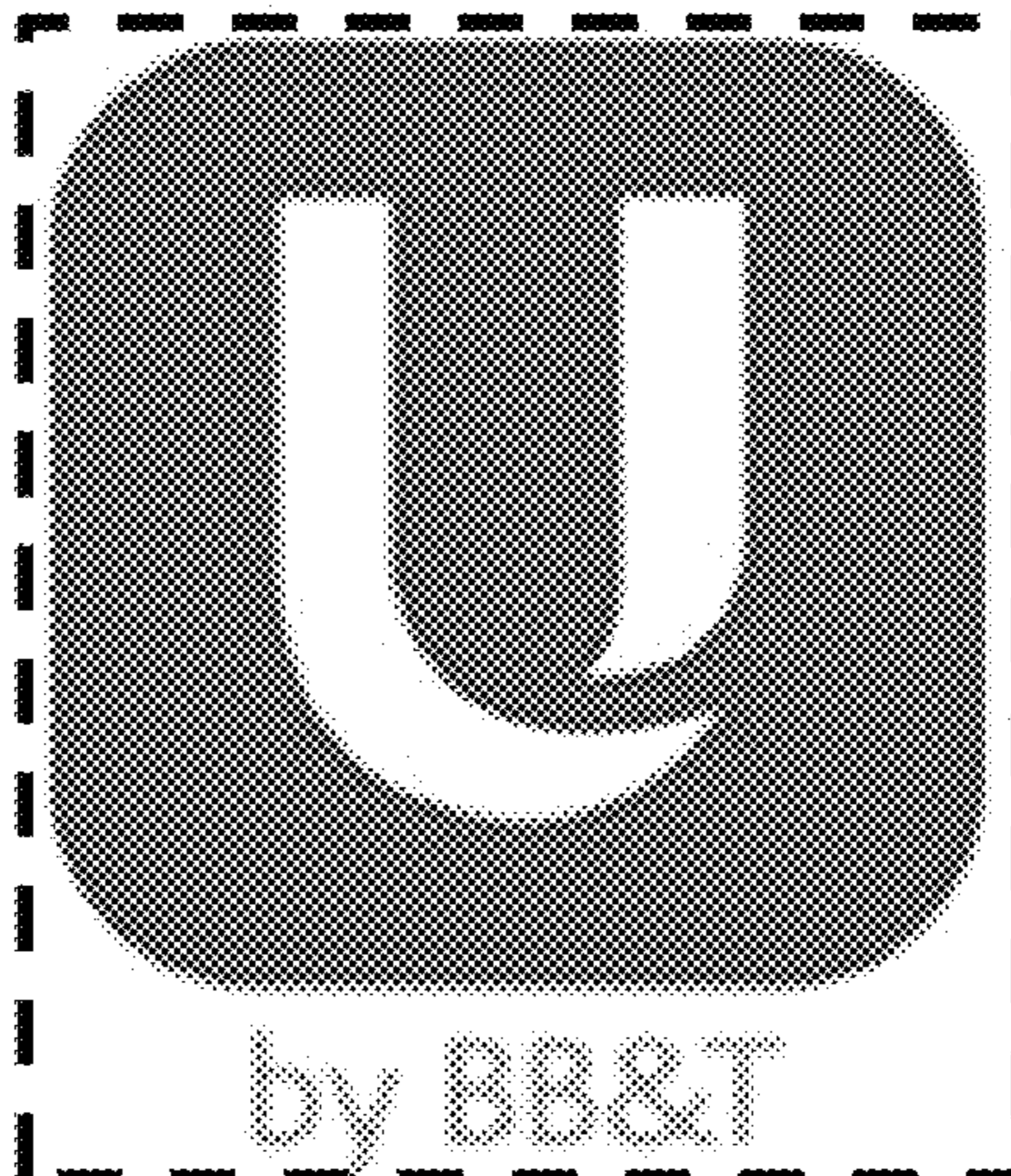
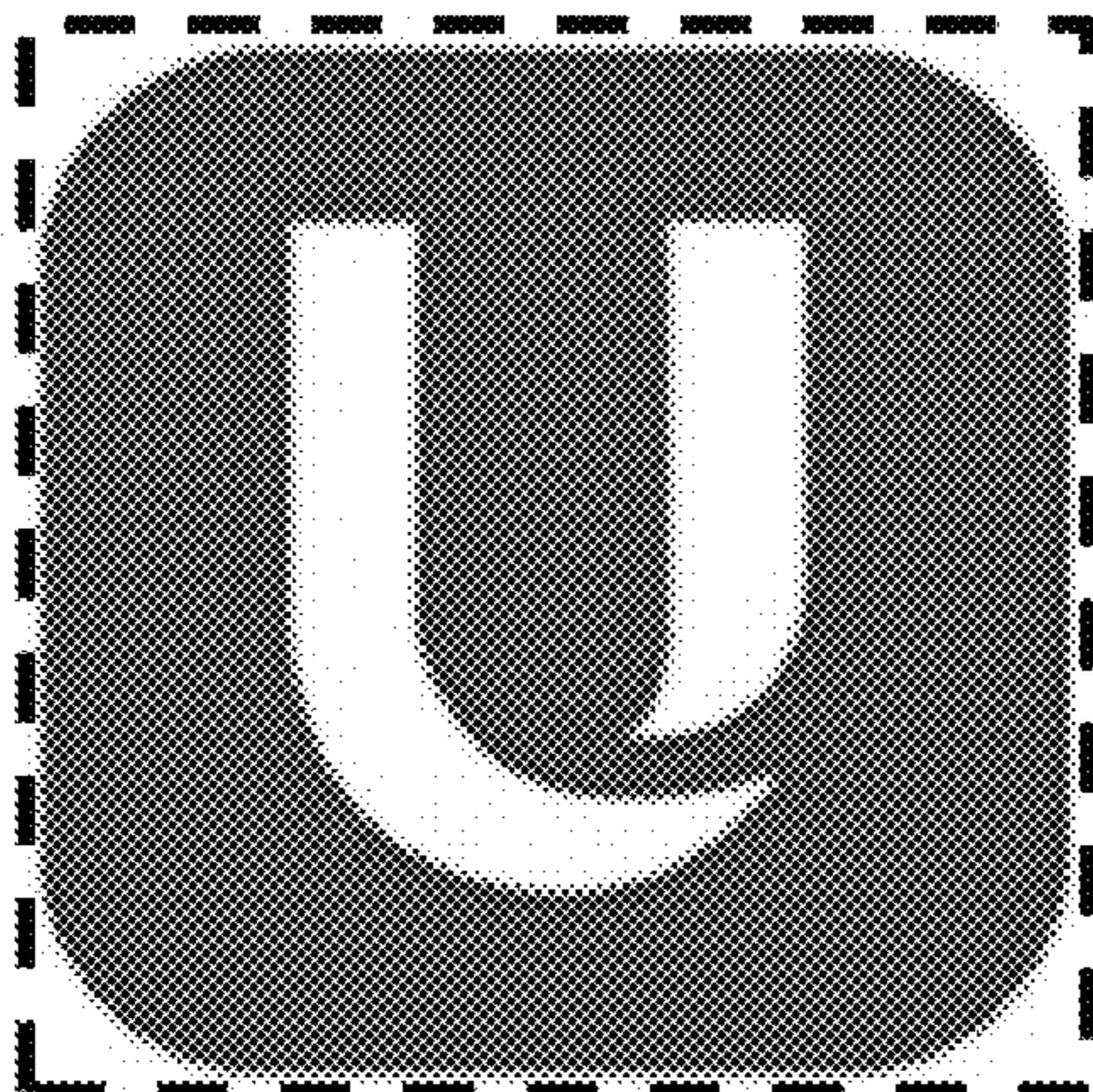
FIG. 2 is a front view of a second embodiment of a portion of a display screen with icon;

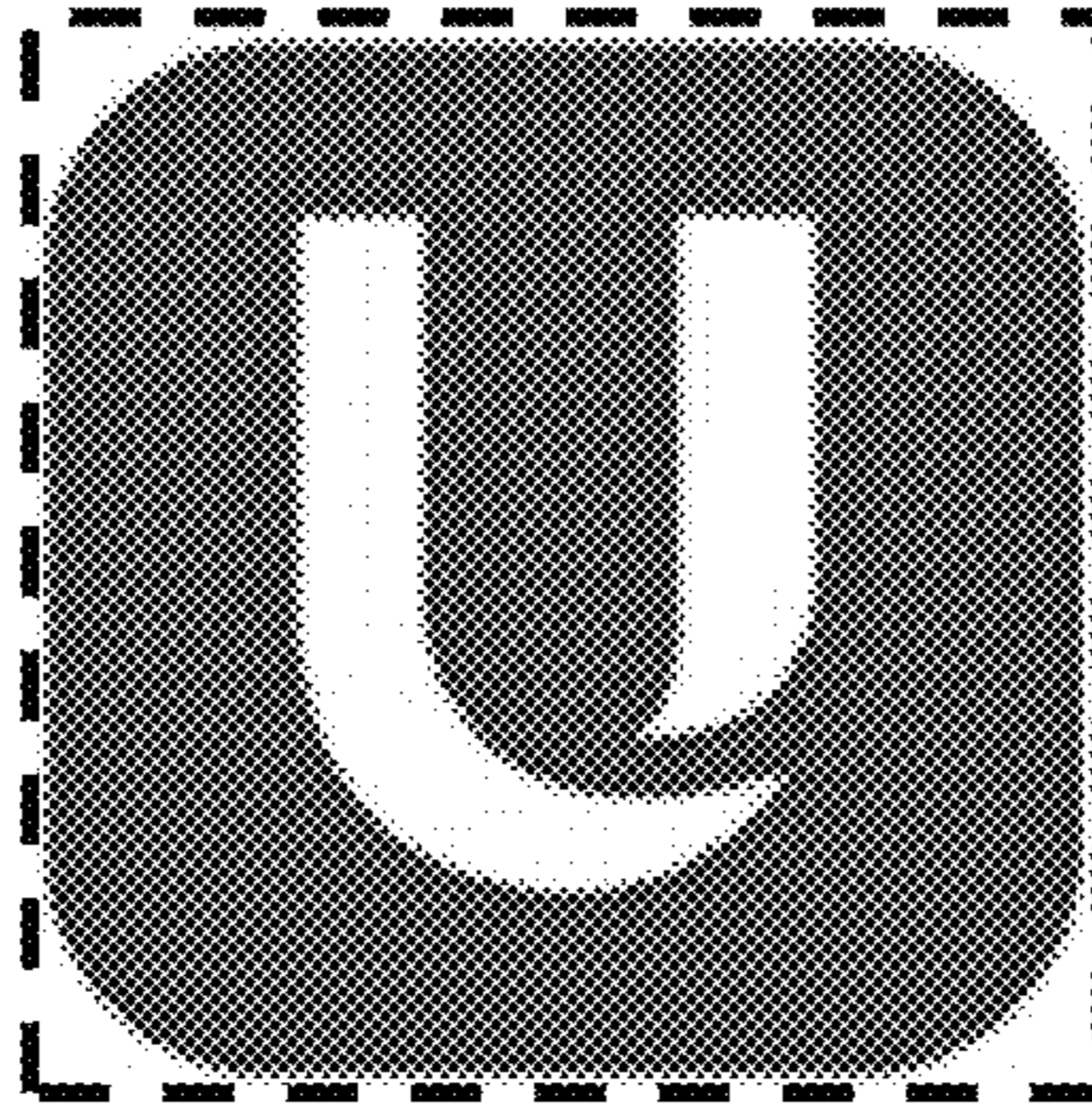

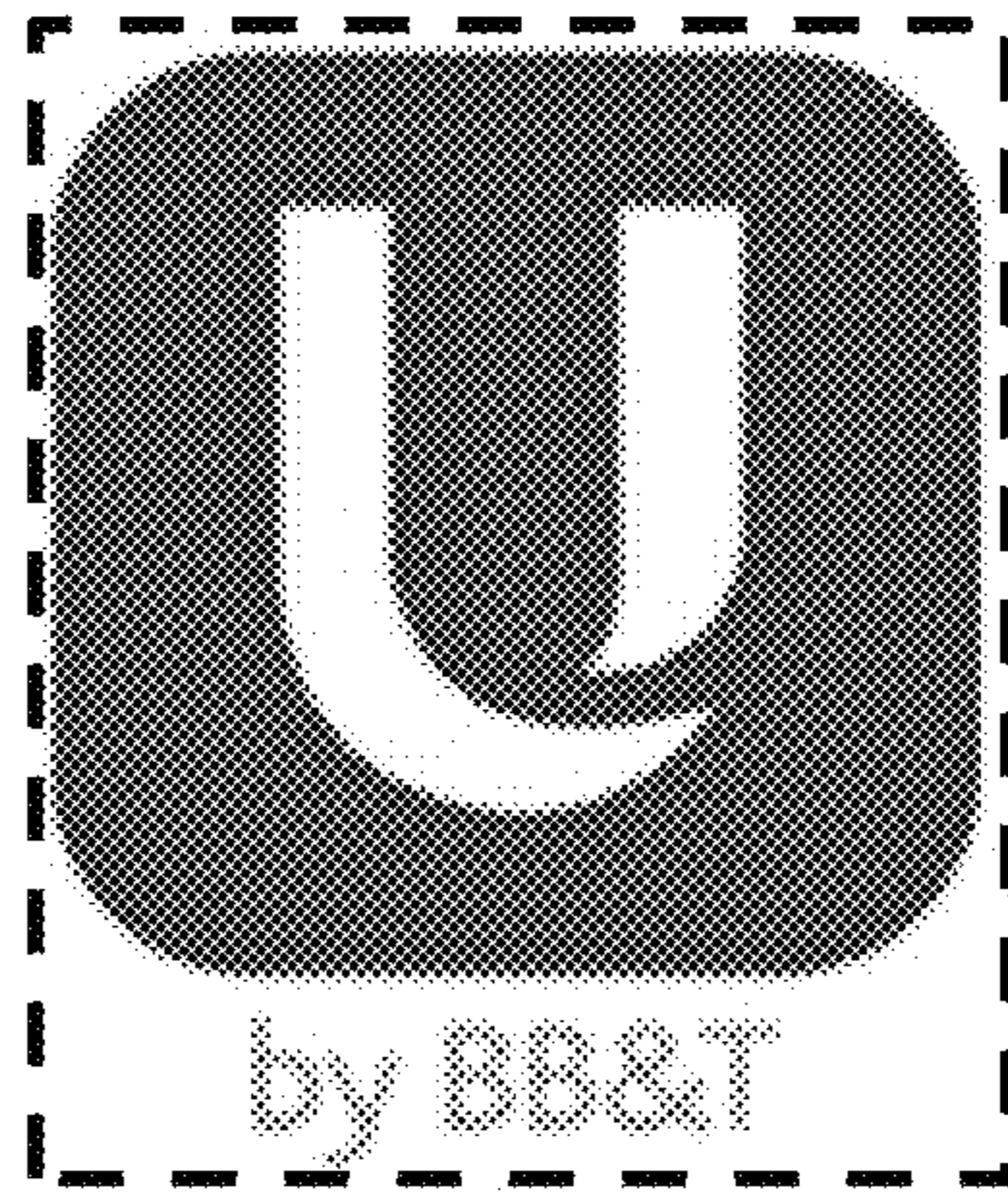
