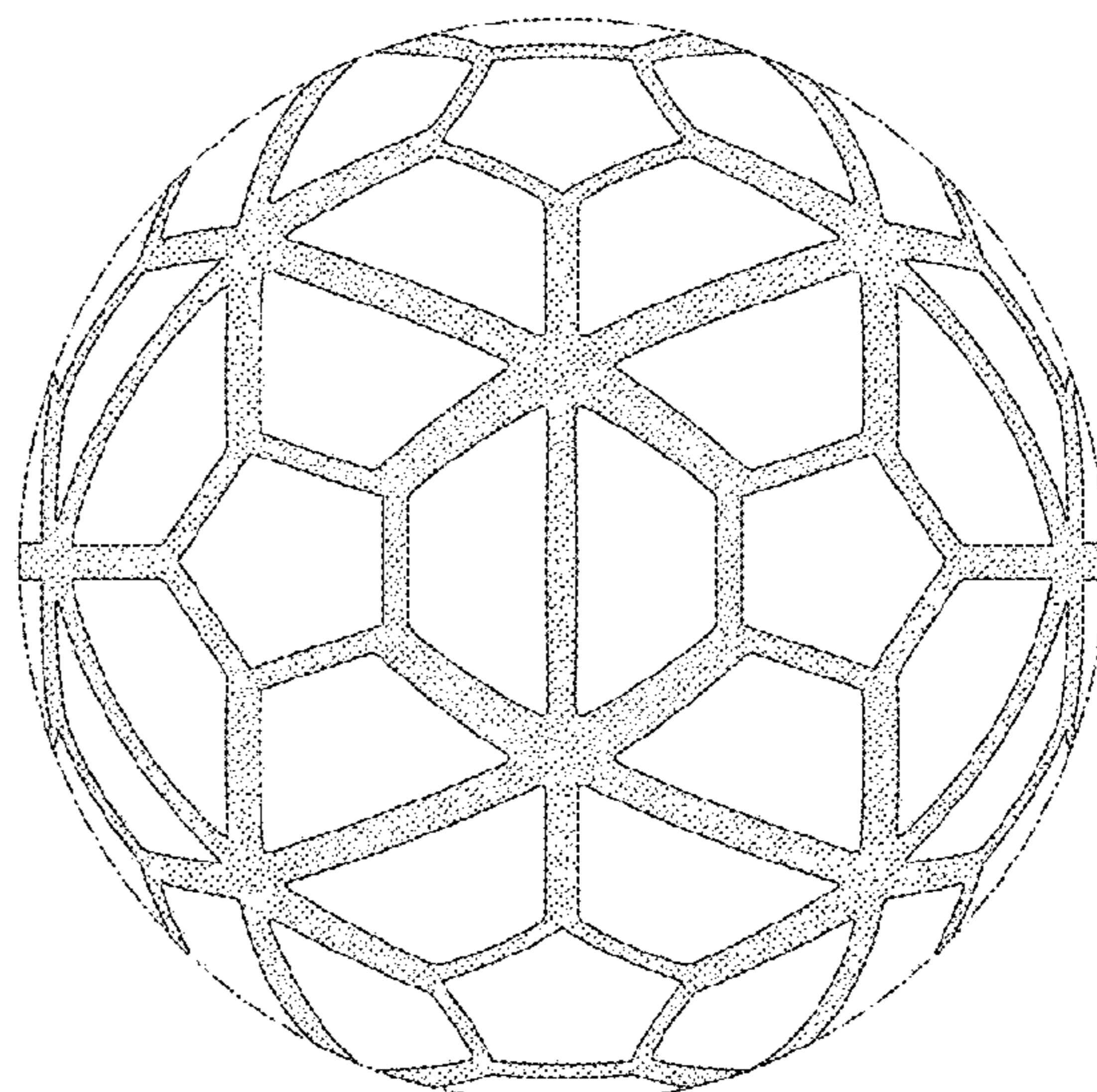
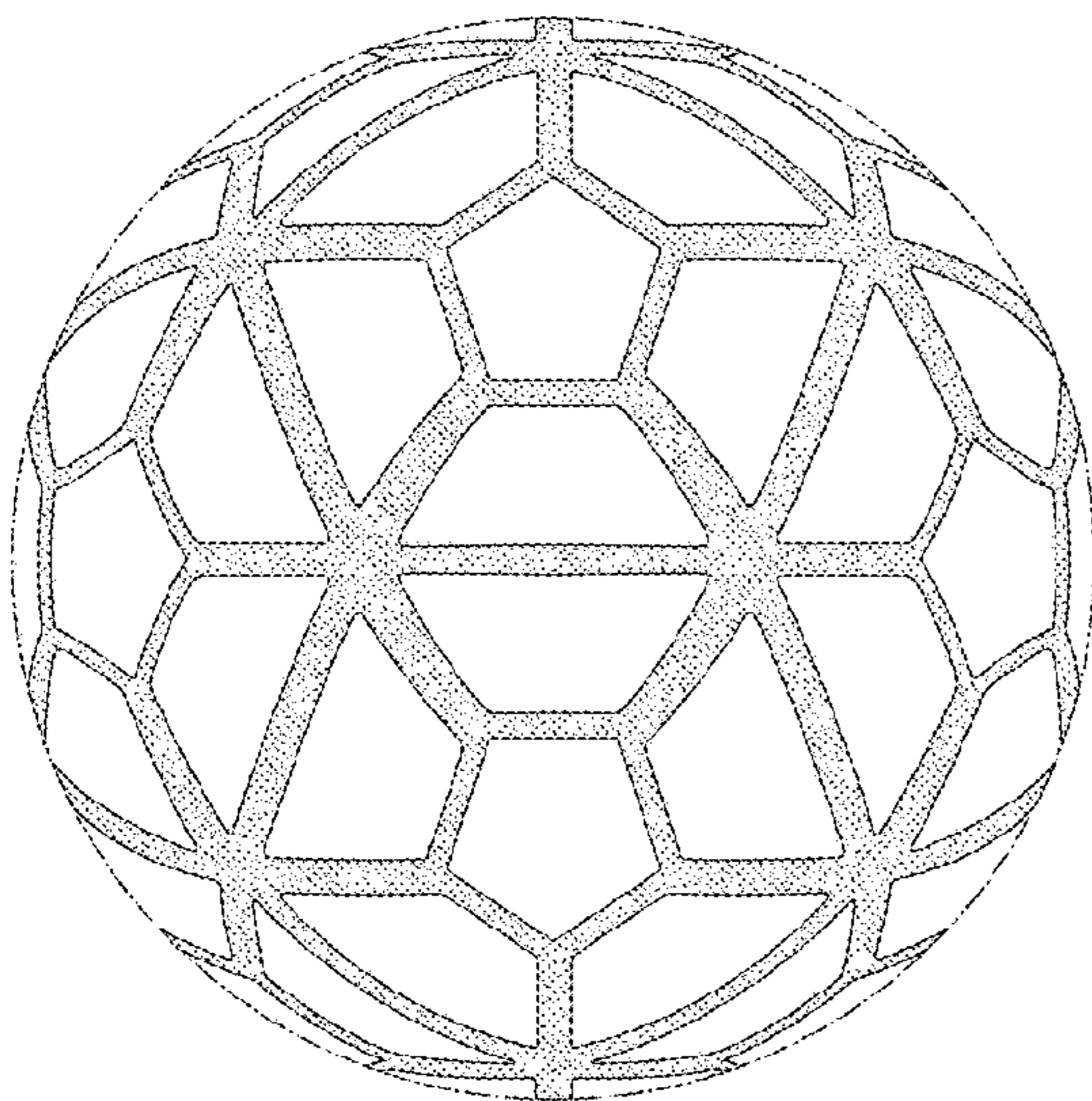
The ornamental design for a ball with surface ornamentation pattern, as shown and described.

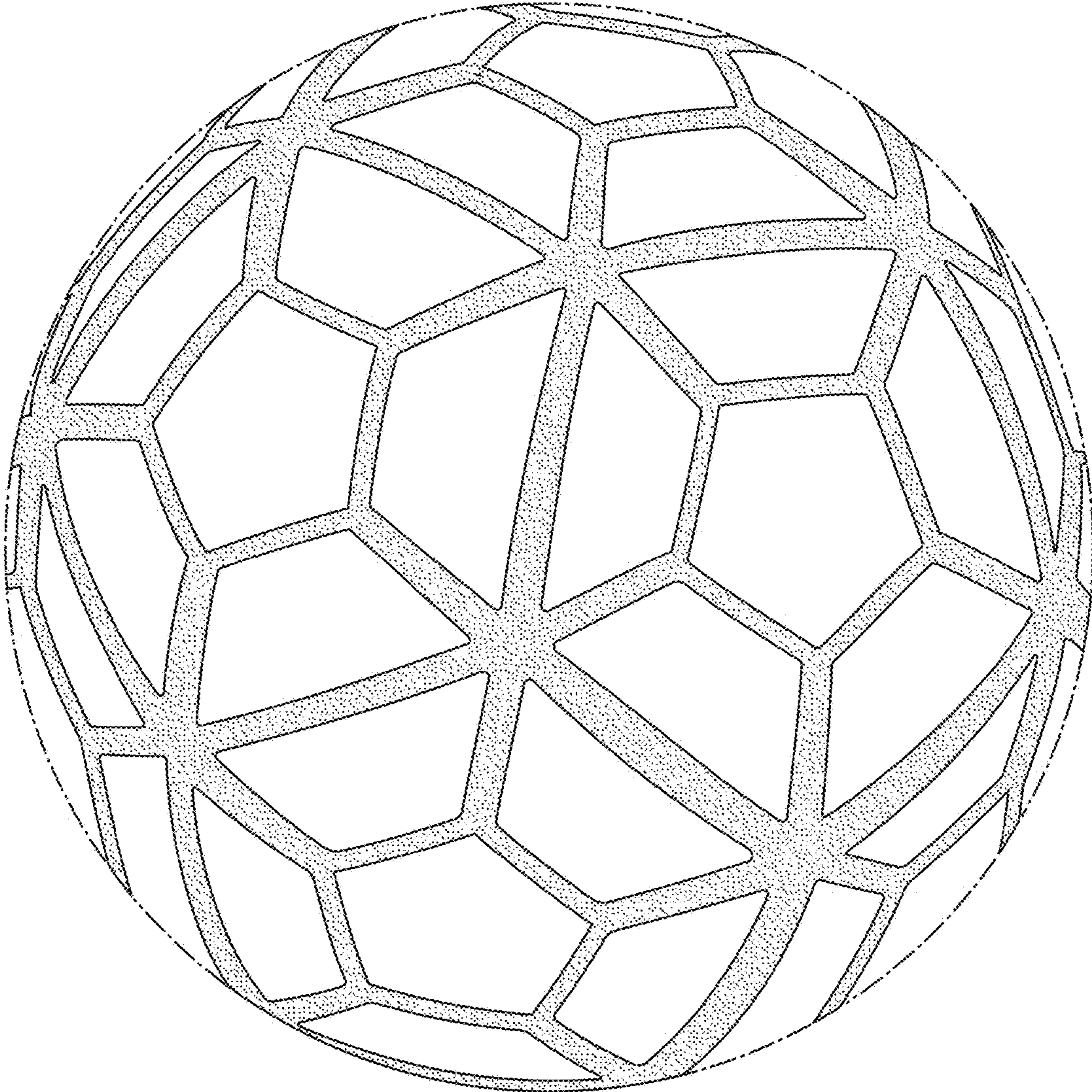

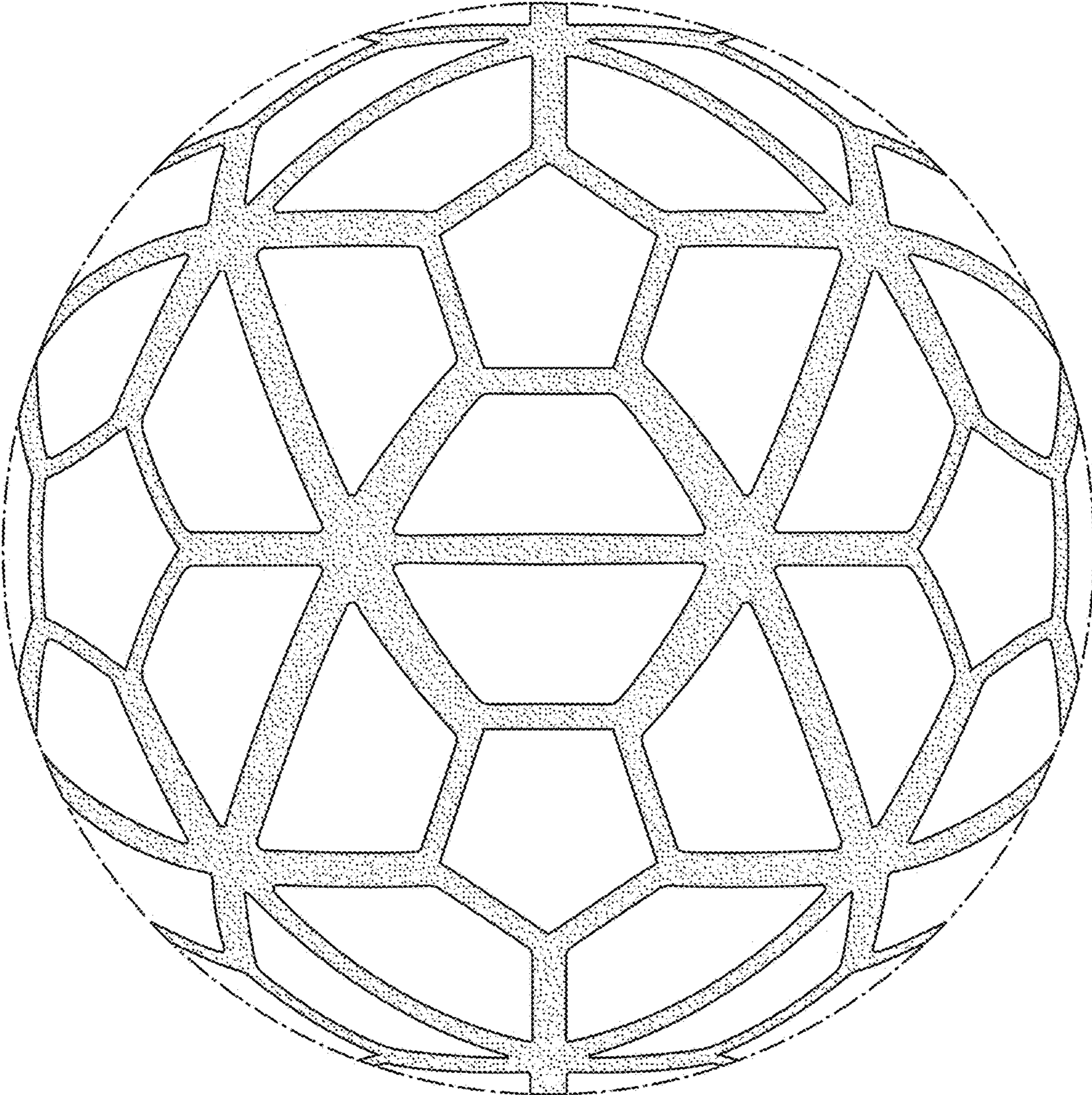

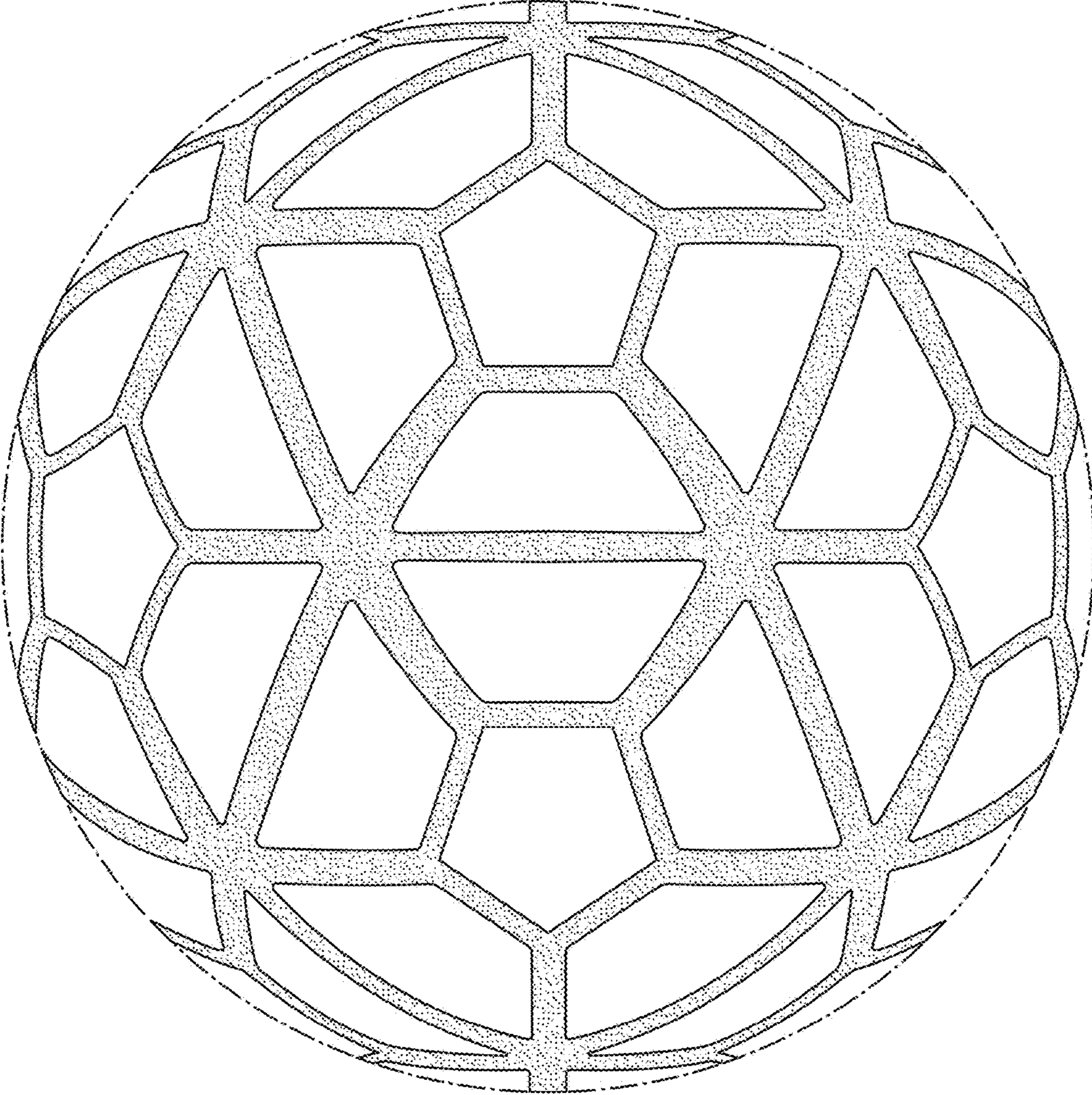

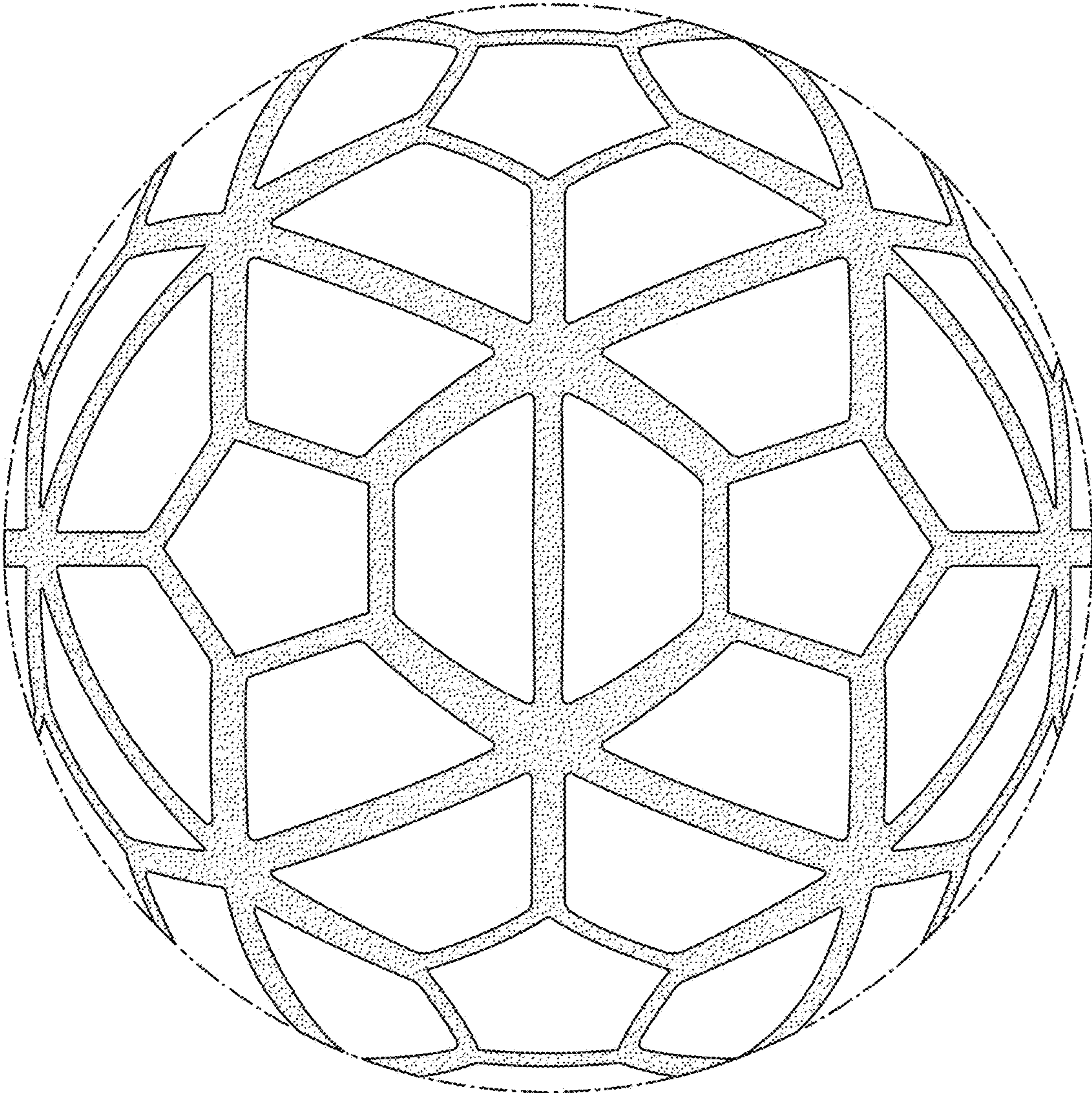

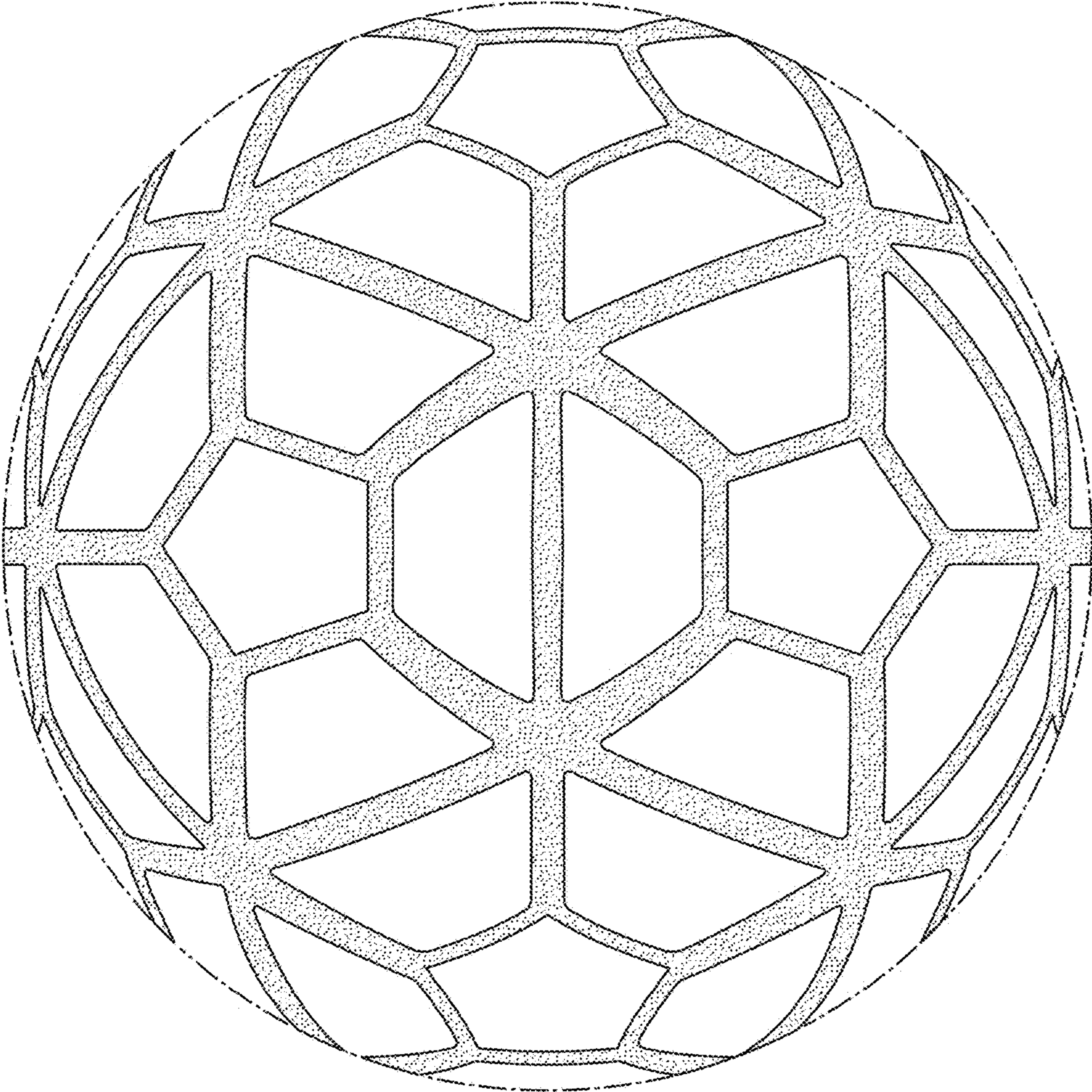

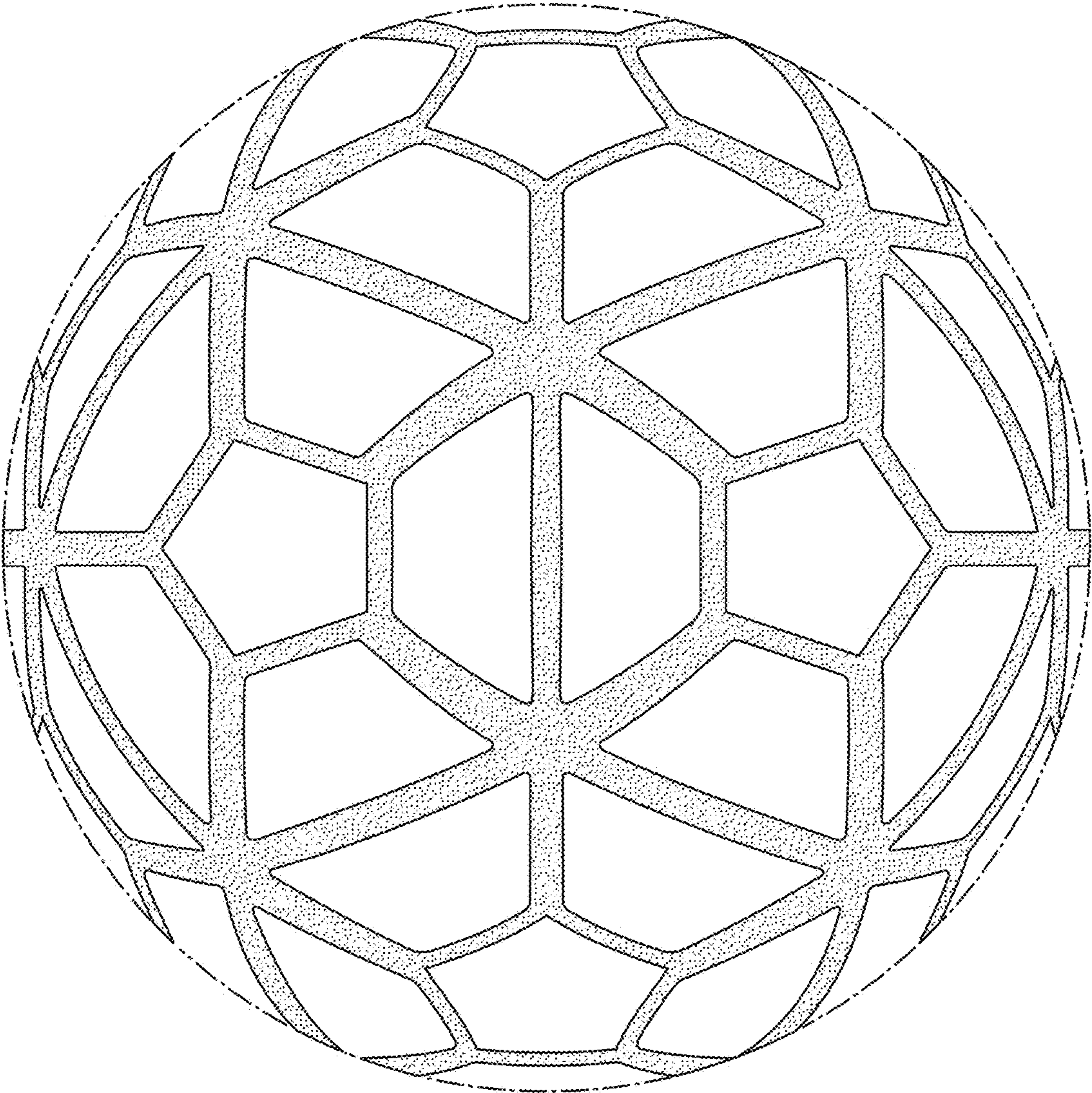

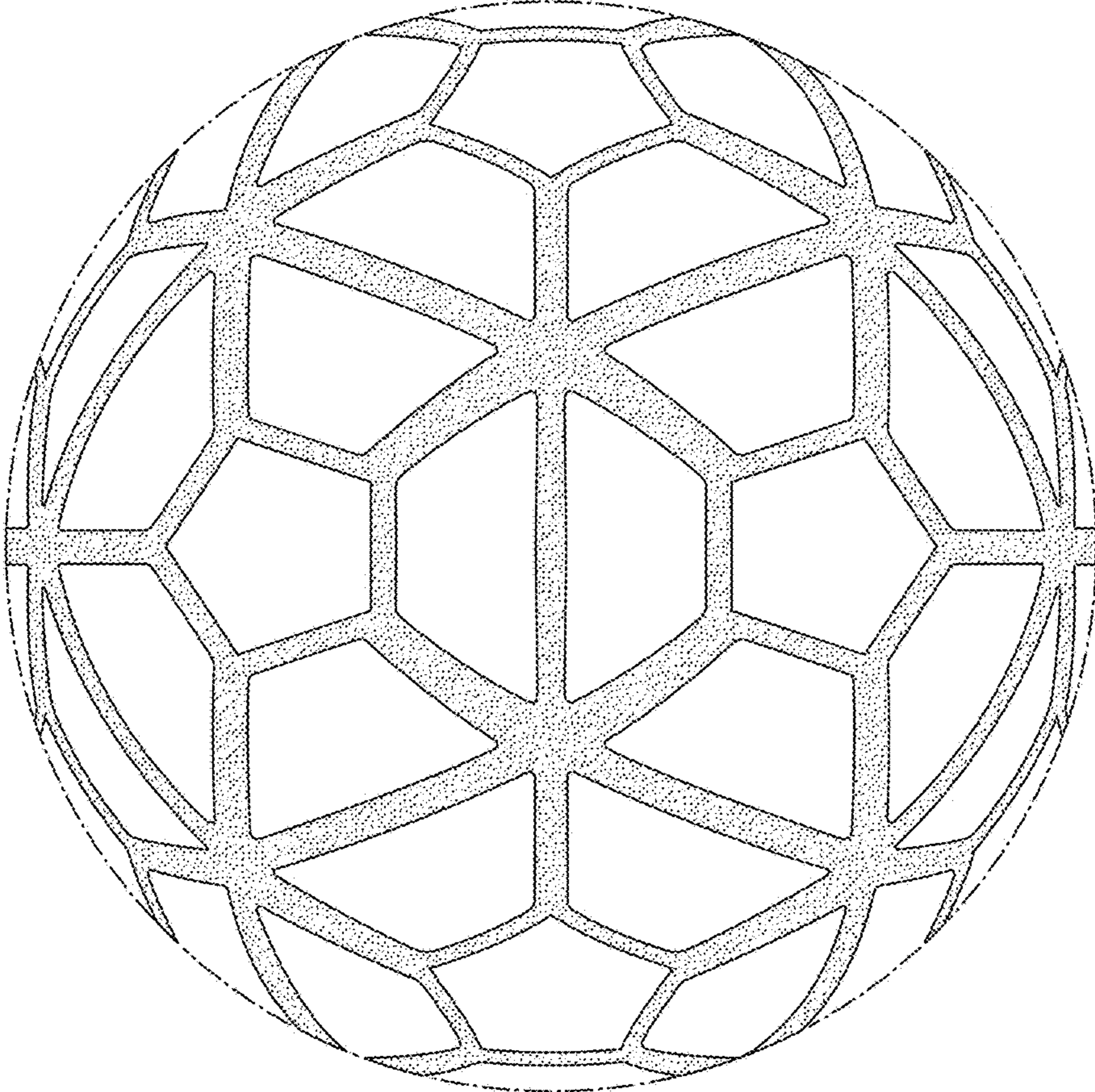
