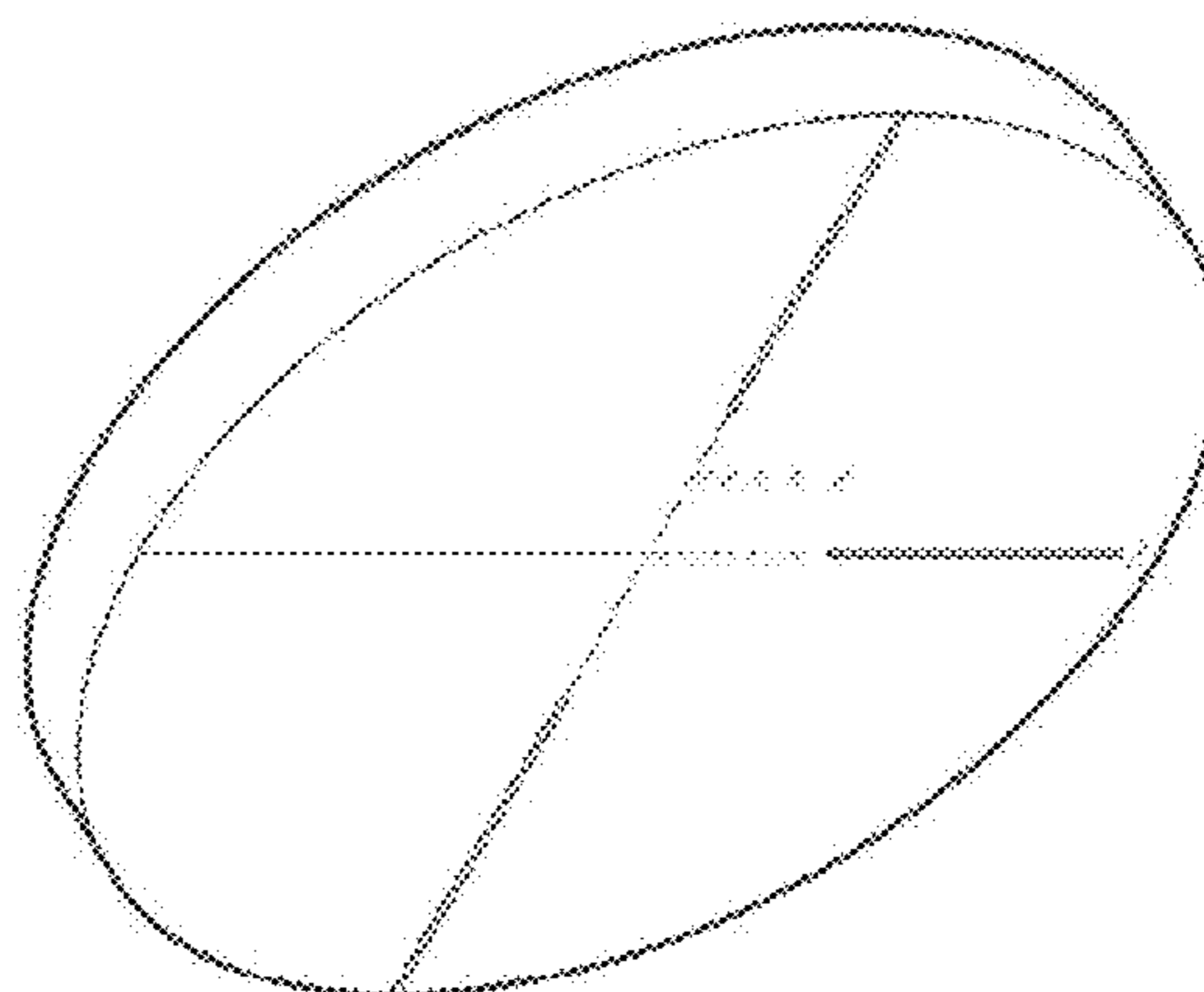
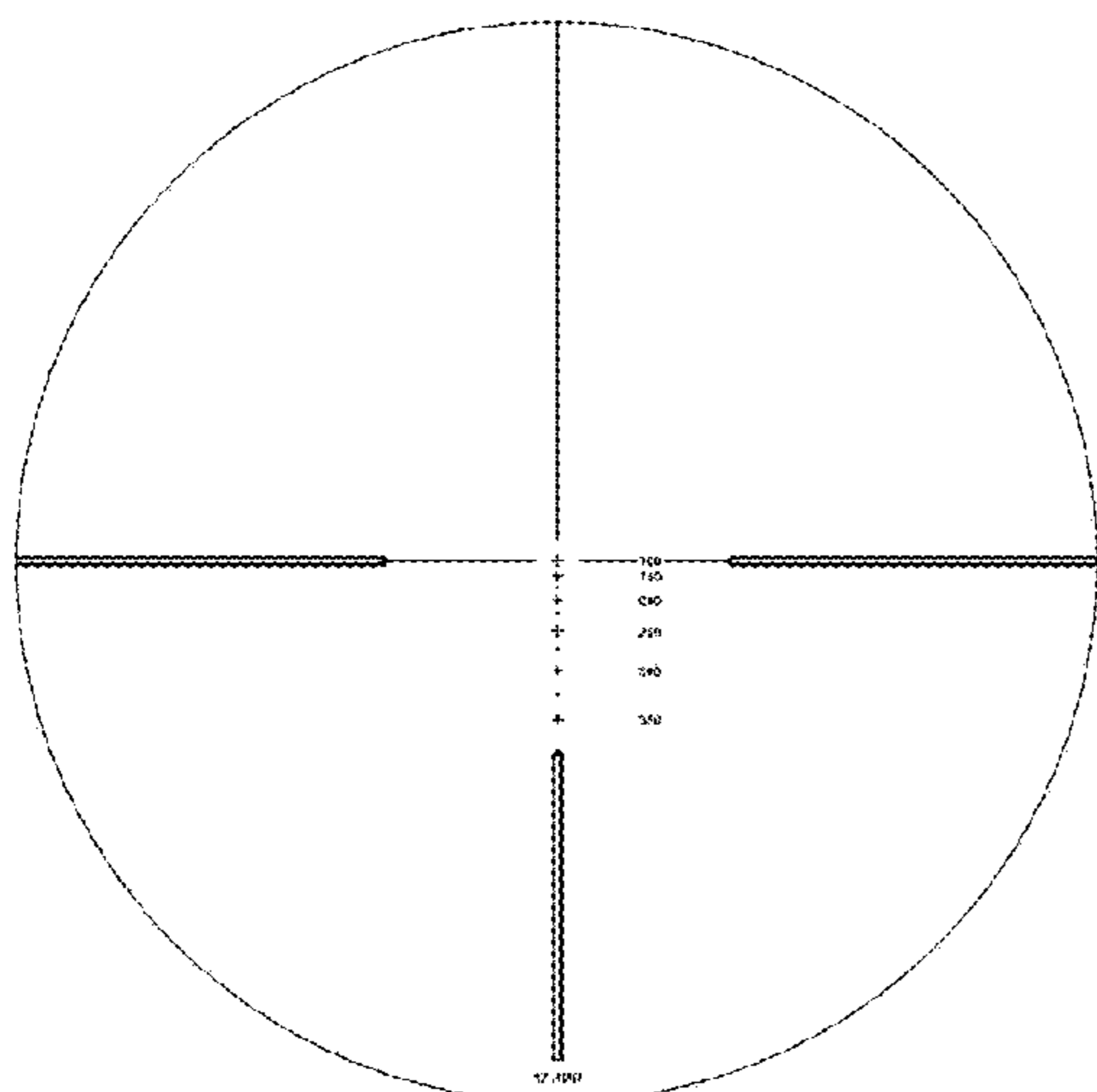
(57) **CLAIM**

I claim the ornamental design for a 12MAG 17 HMR rim fire reticle, as shown and described.

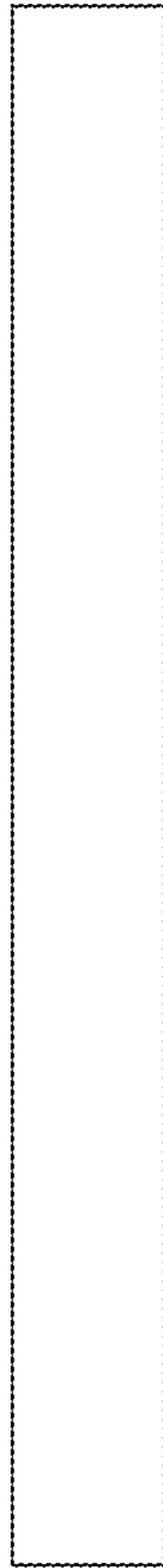

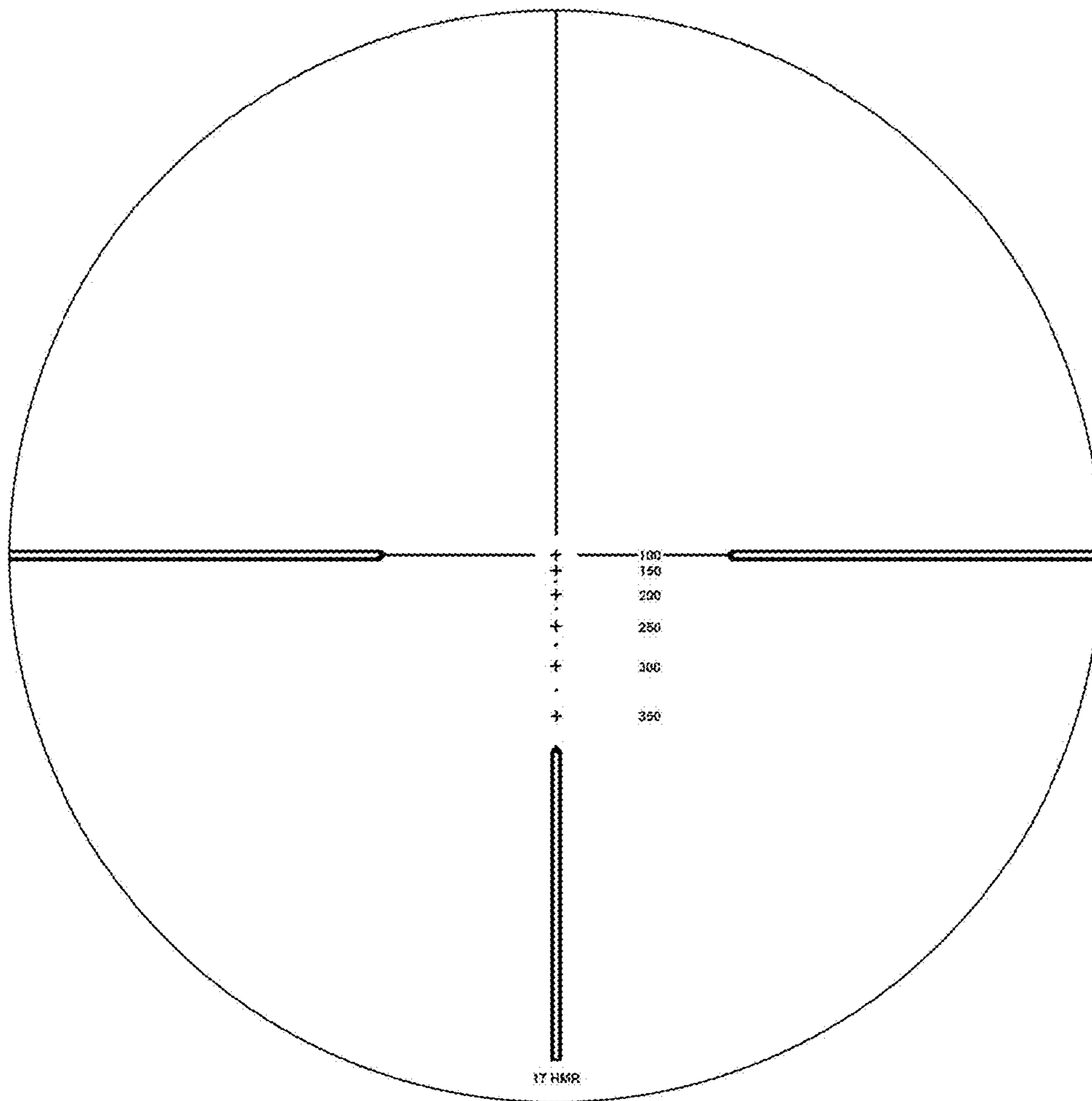

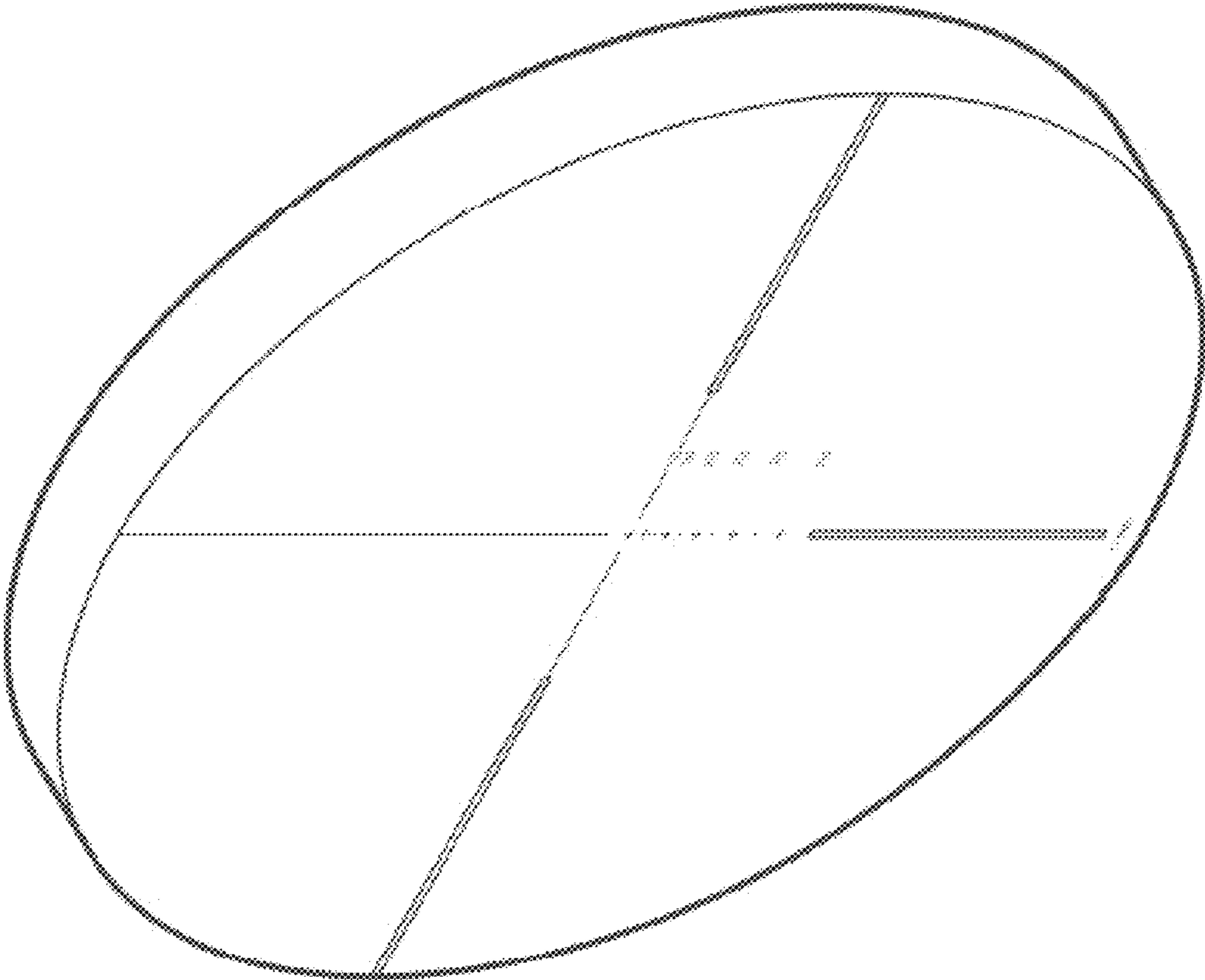

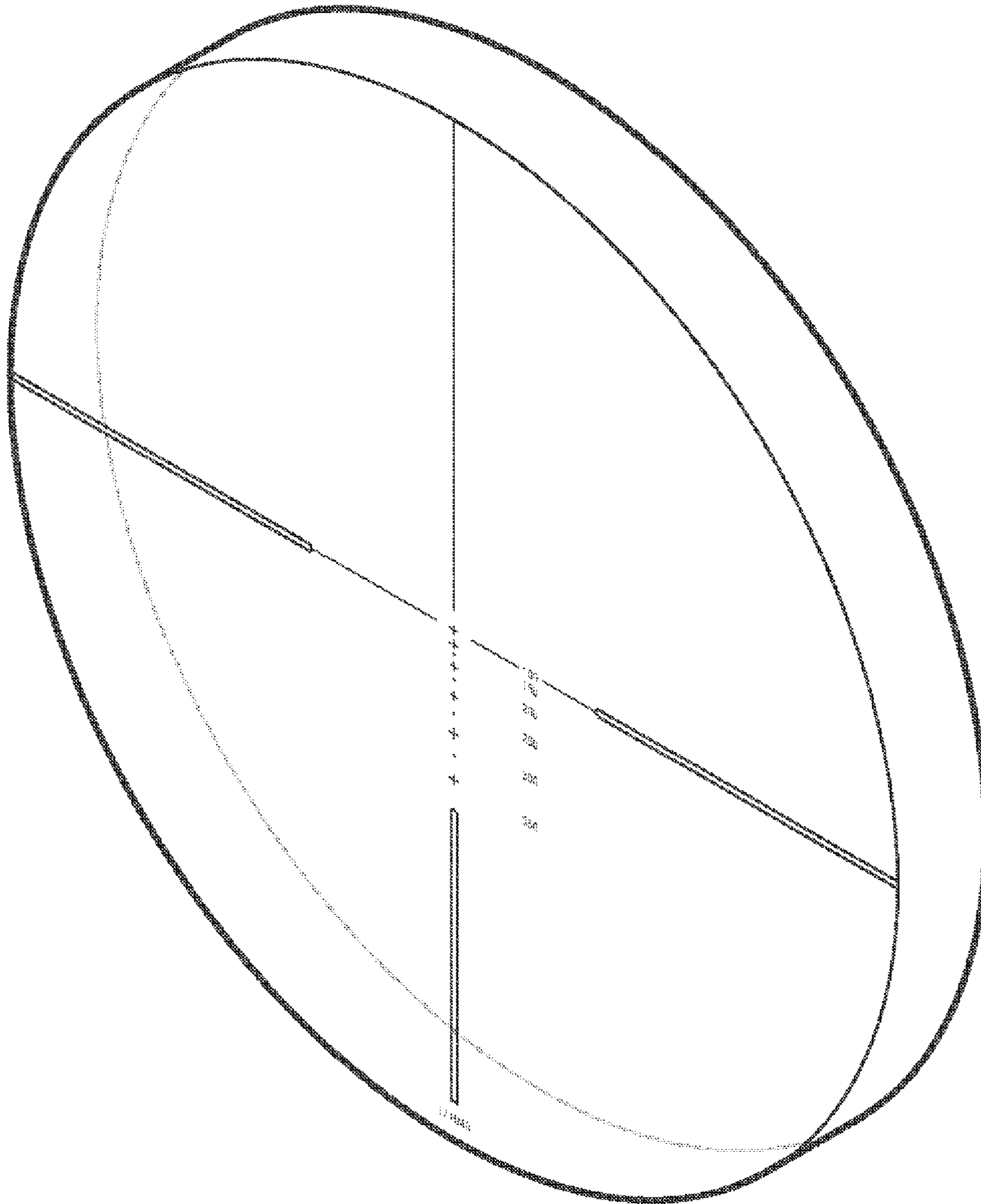
