FIG. 5 is a front side view of the ceiling fan of FIG. 1;

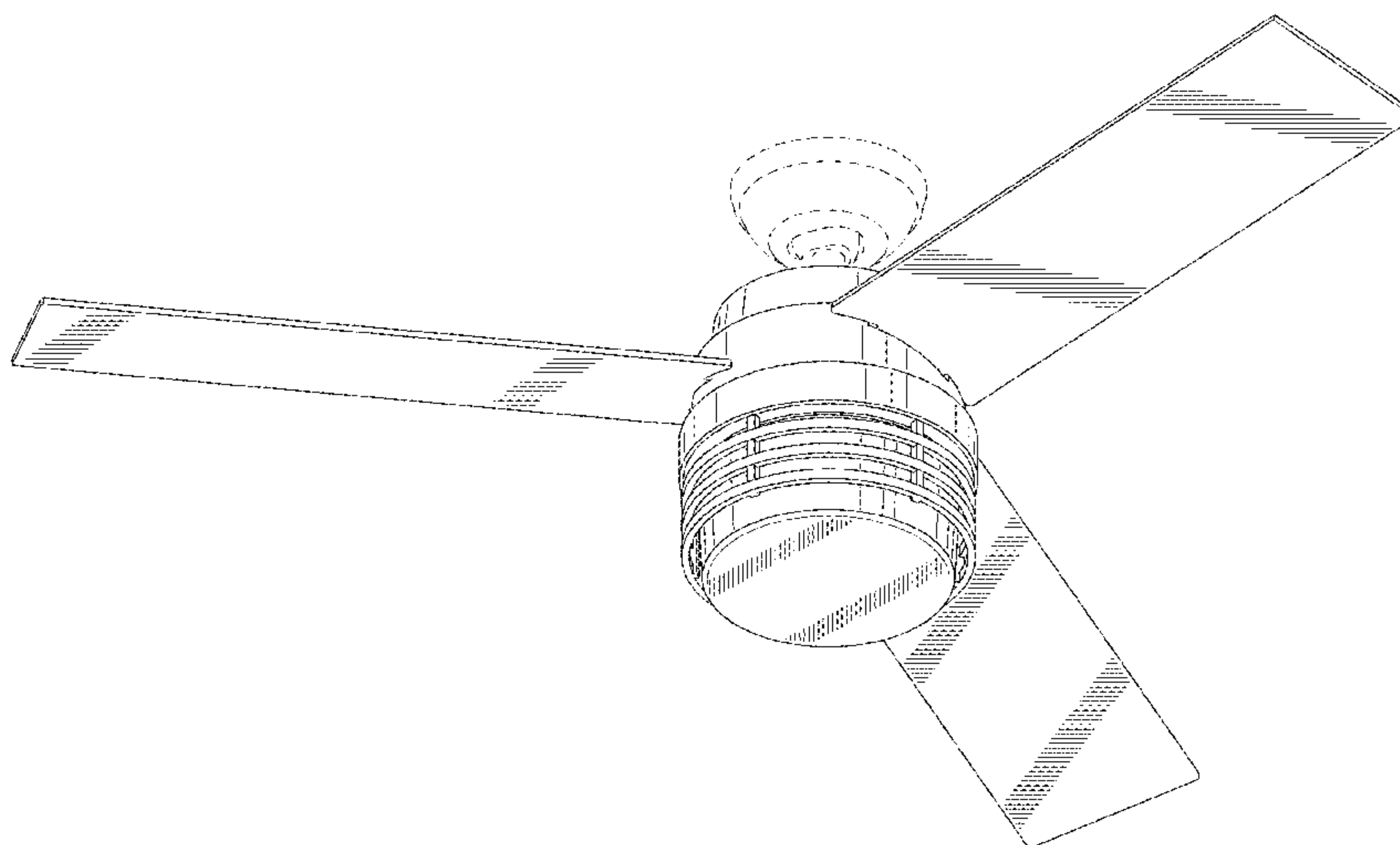
FIG. 6 is a rear side view of the ceiling fan of FIG. 1;

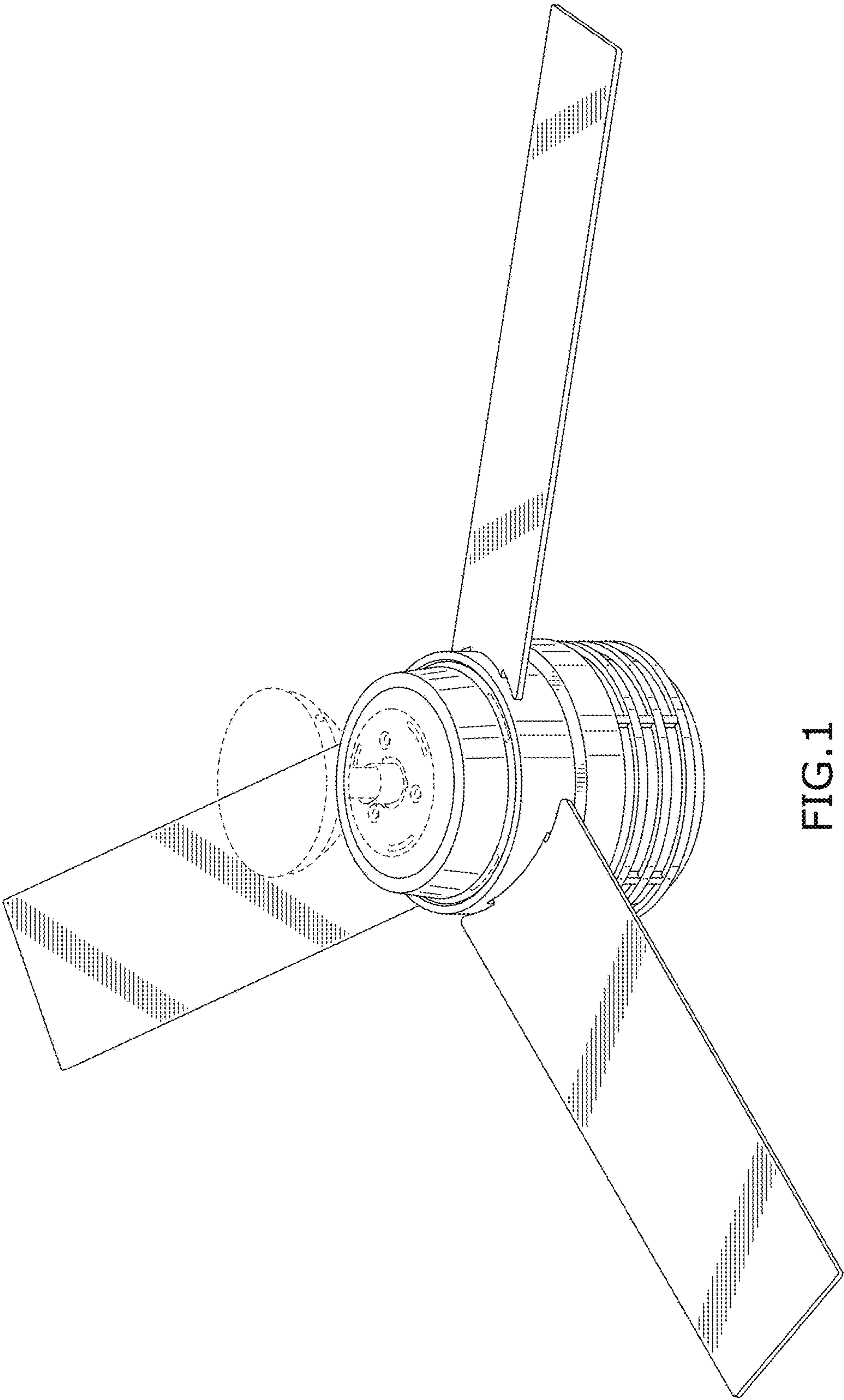

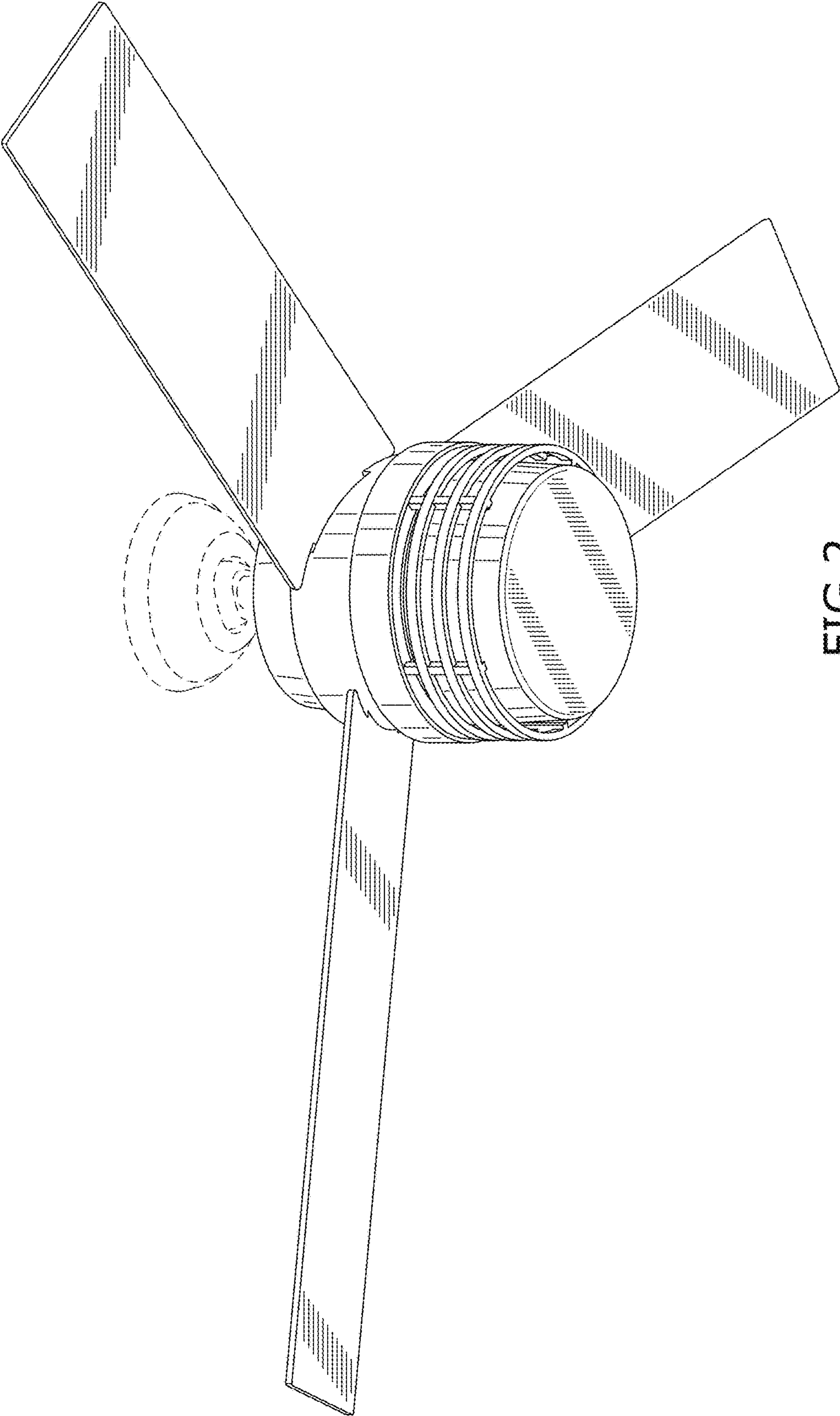

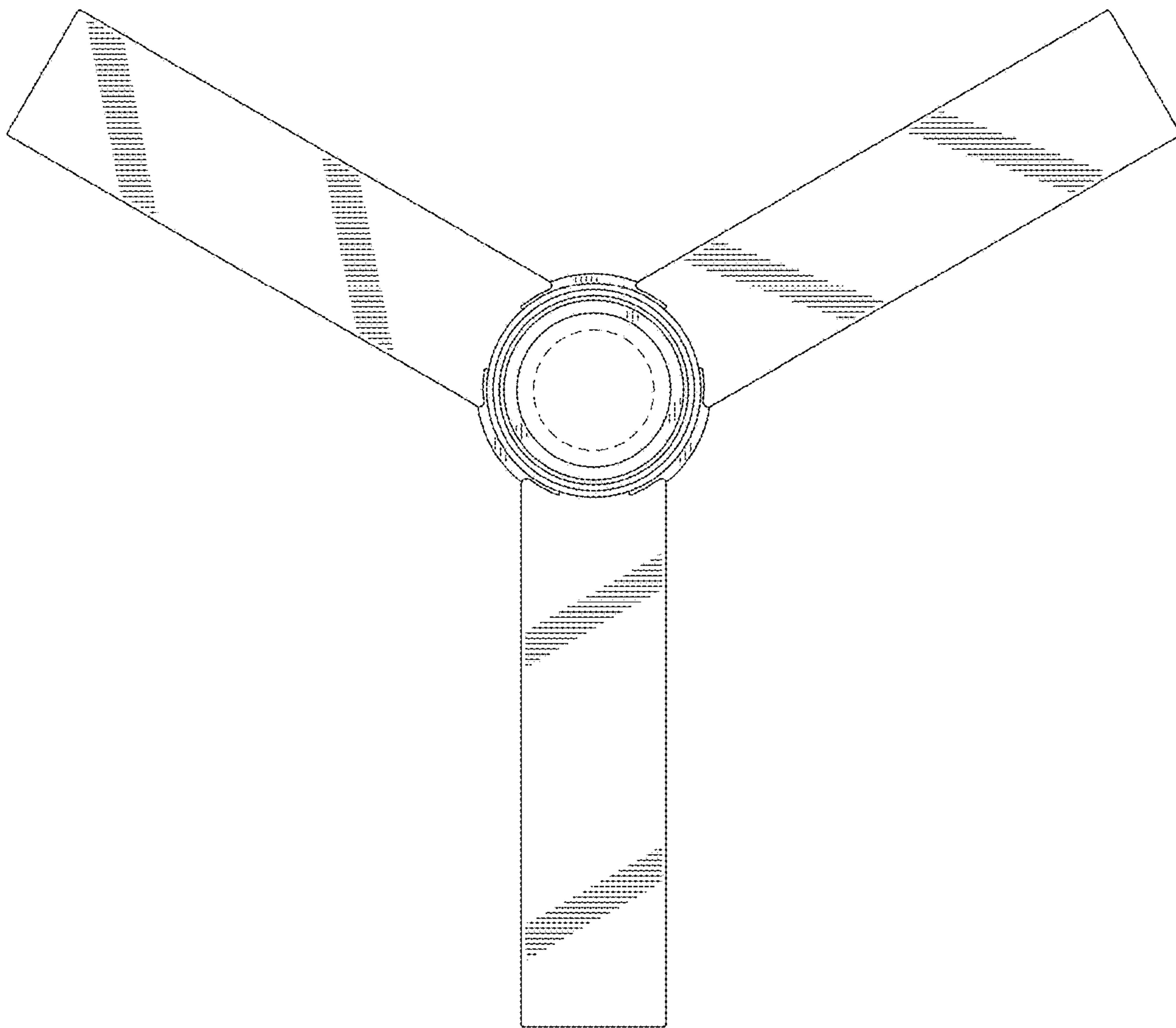

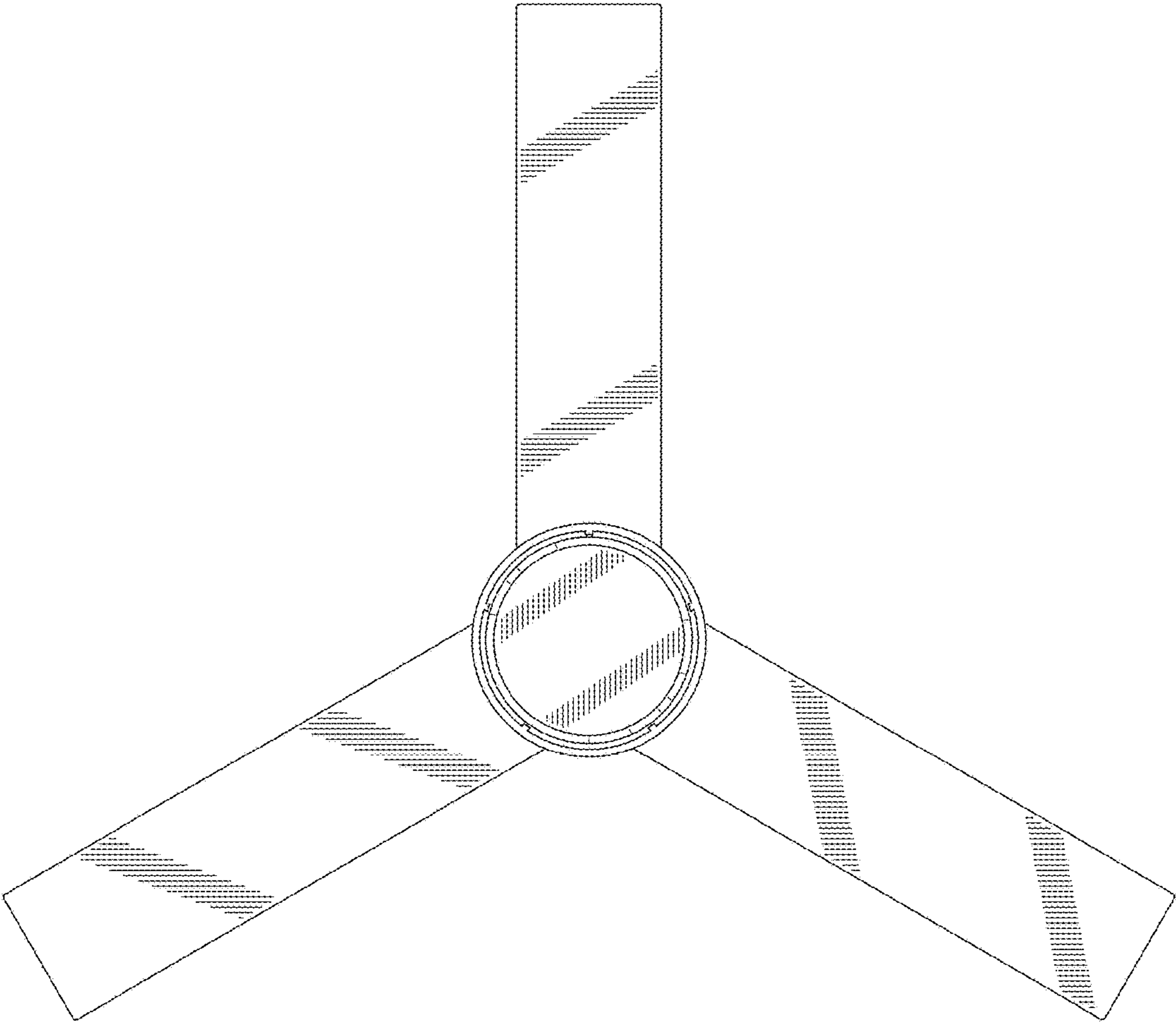

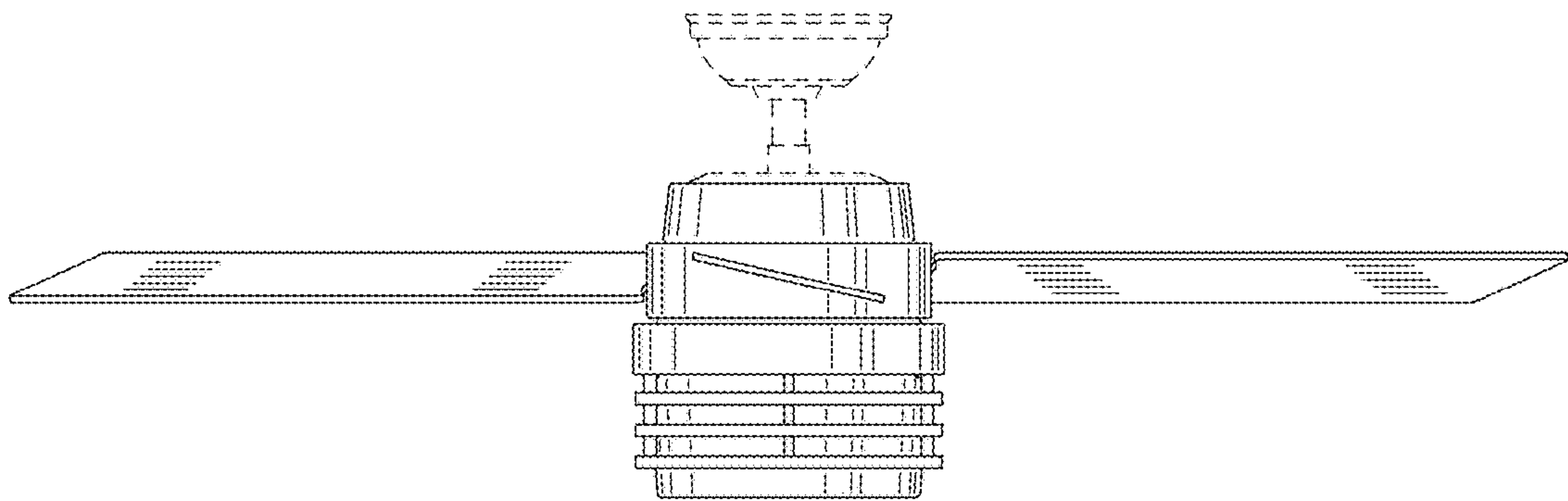

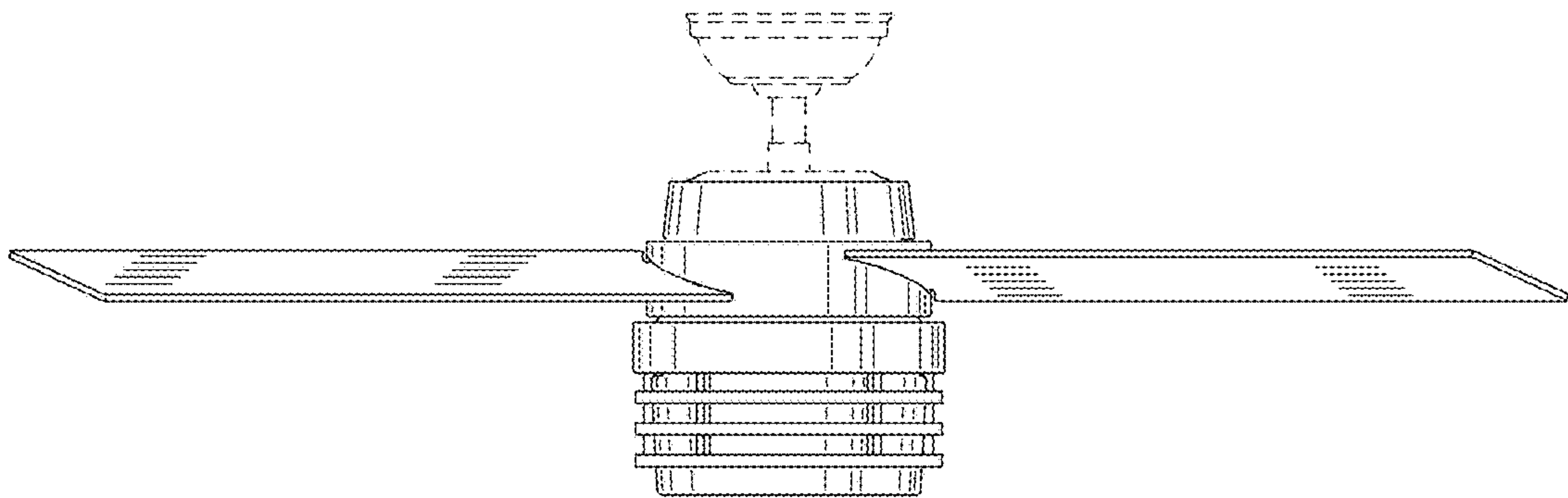

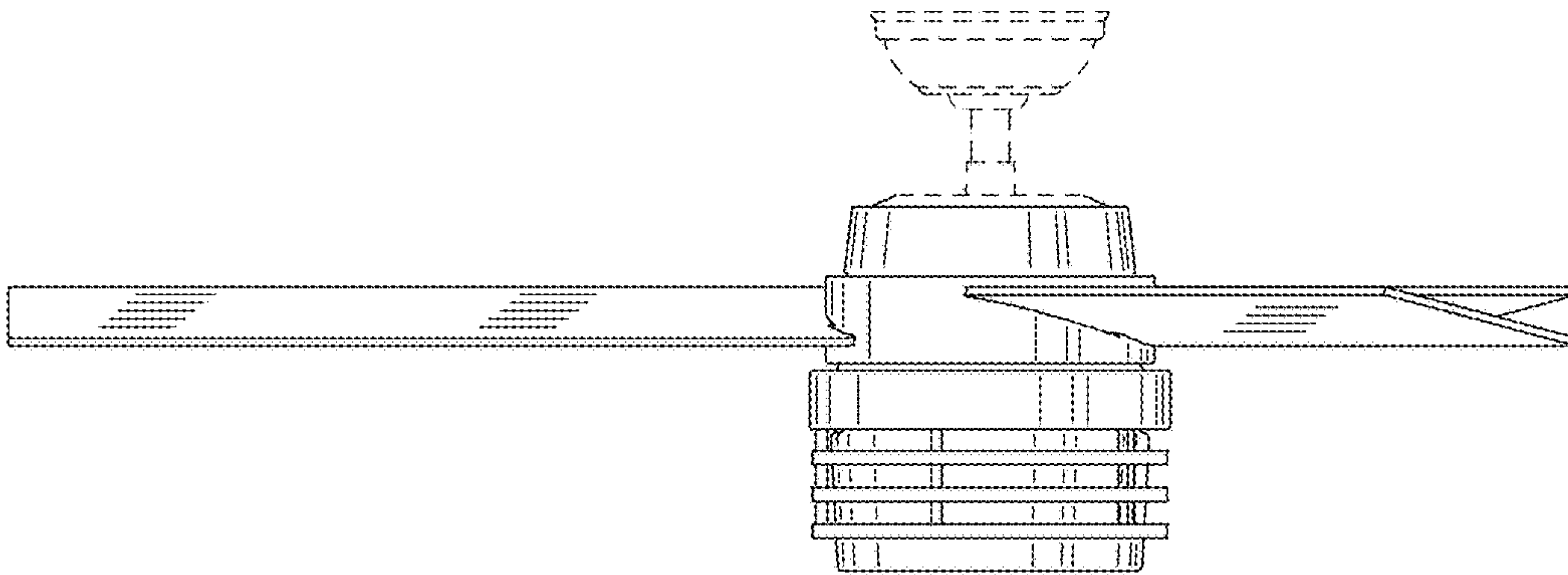

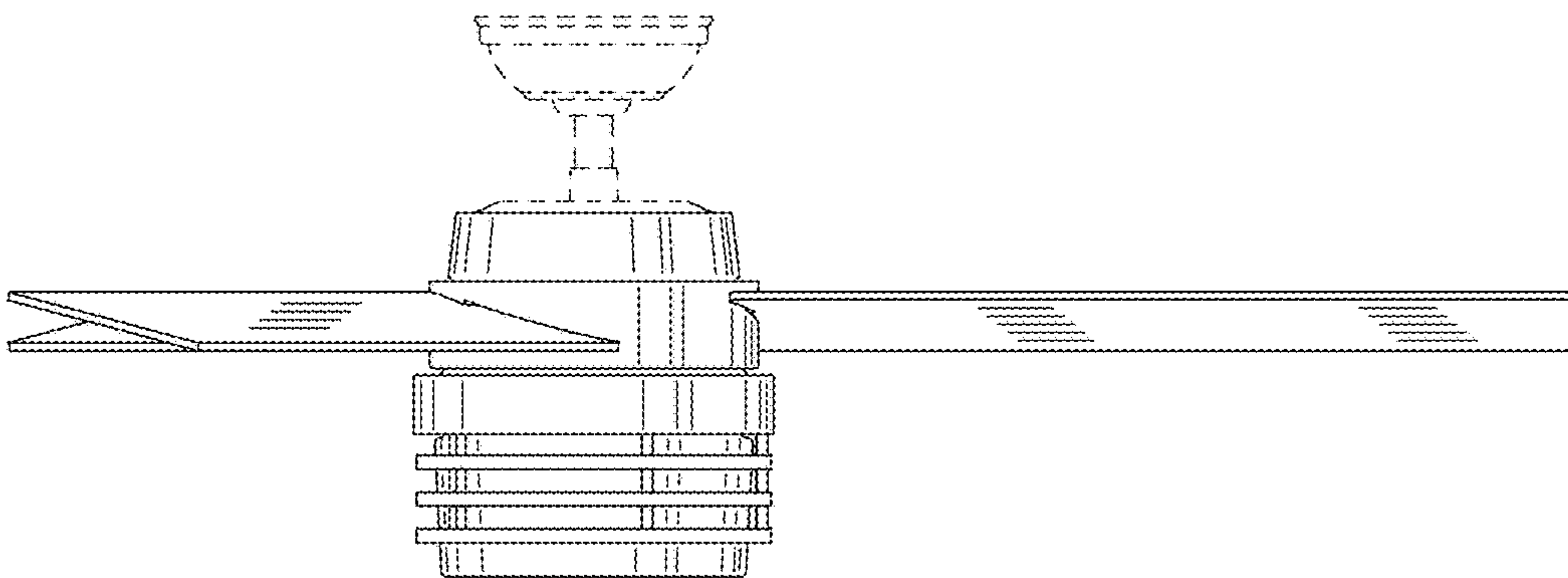
