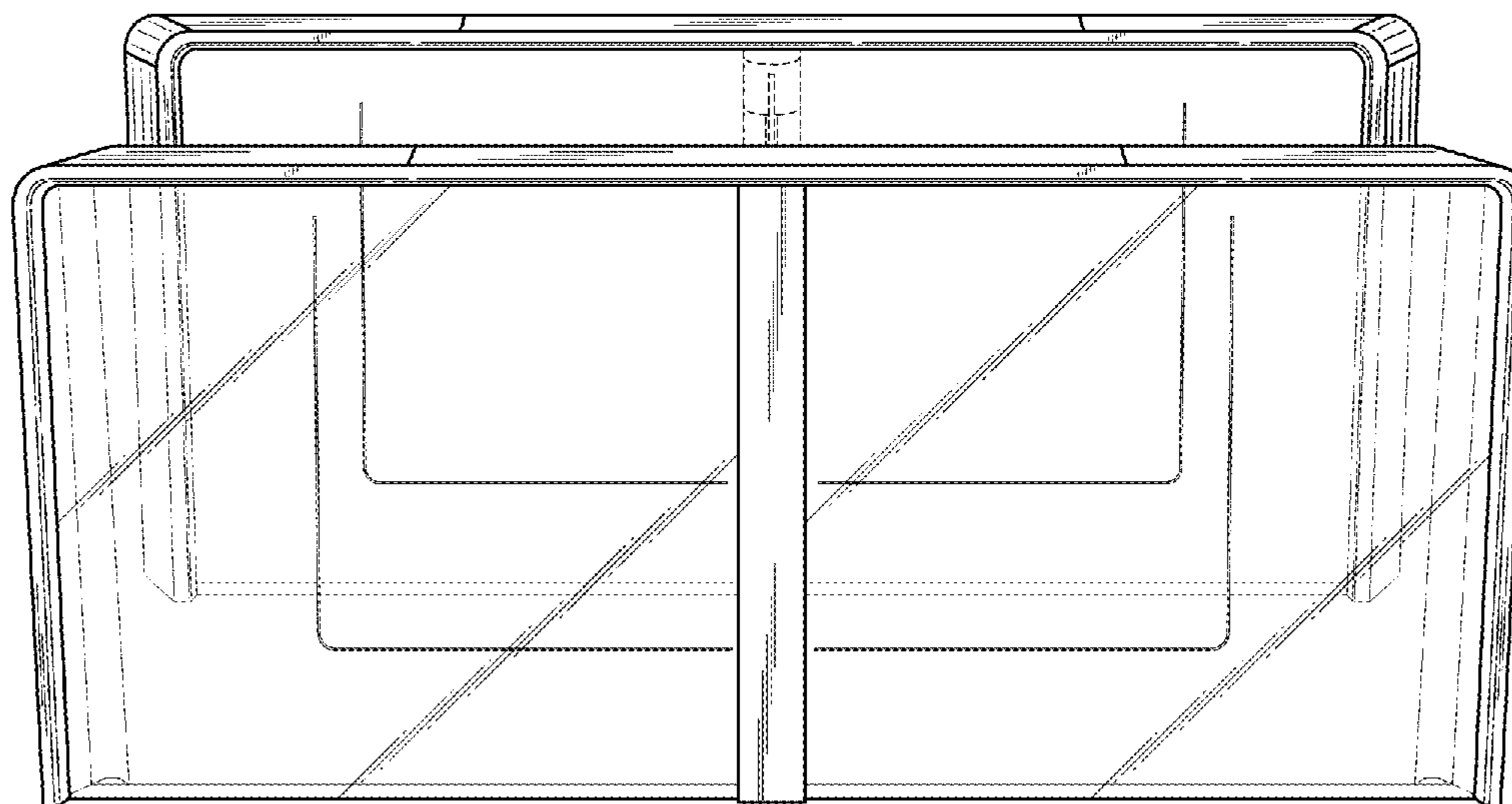
(57) **CLAIM**

We claim the ornamental design for an access gate, as shown and described.

DESCRIPTION

FIG. 1 is a front and back elevation view, which views are mirror images, of an access gate showing our new design; FIG. 2 is a right and left side perspective view thereof, which views are mirror images; FIG. 3 is a right and left side elevation view thereof, which views are mirror images; and, FIG. 4 is top view thereof. The broken lines depict portions of the access gate that form no part of the claimed design.

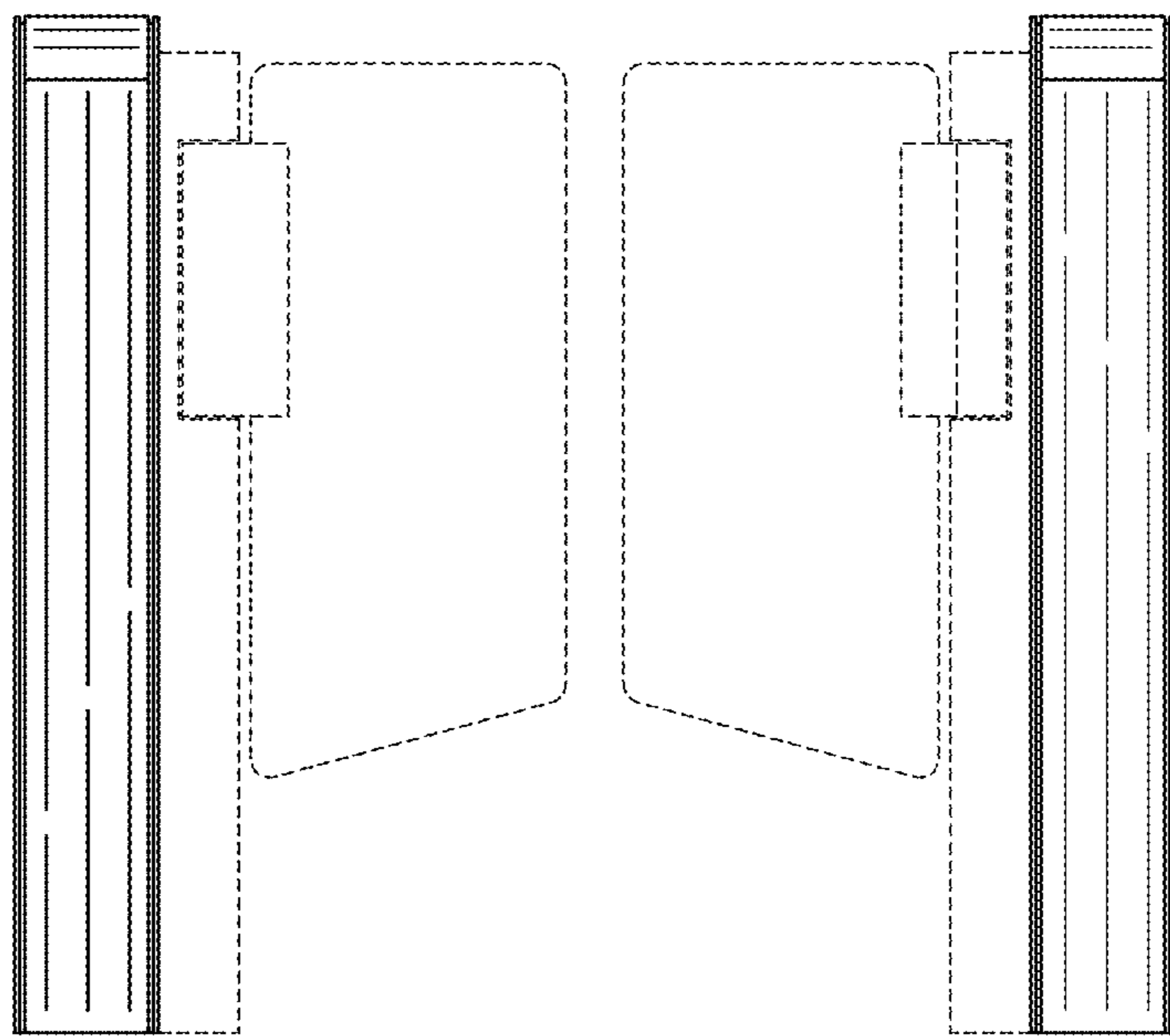

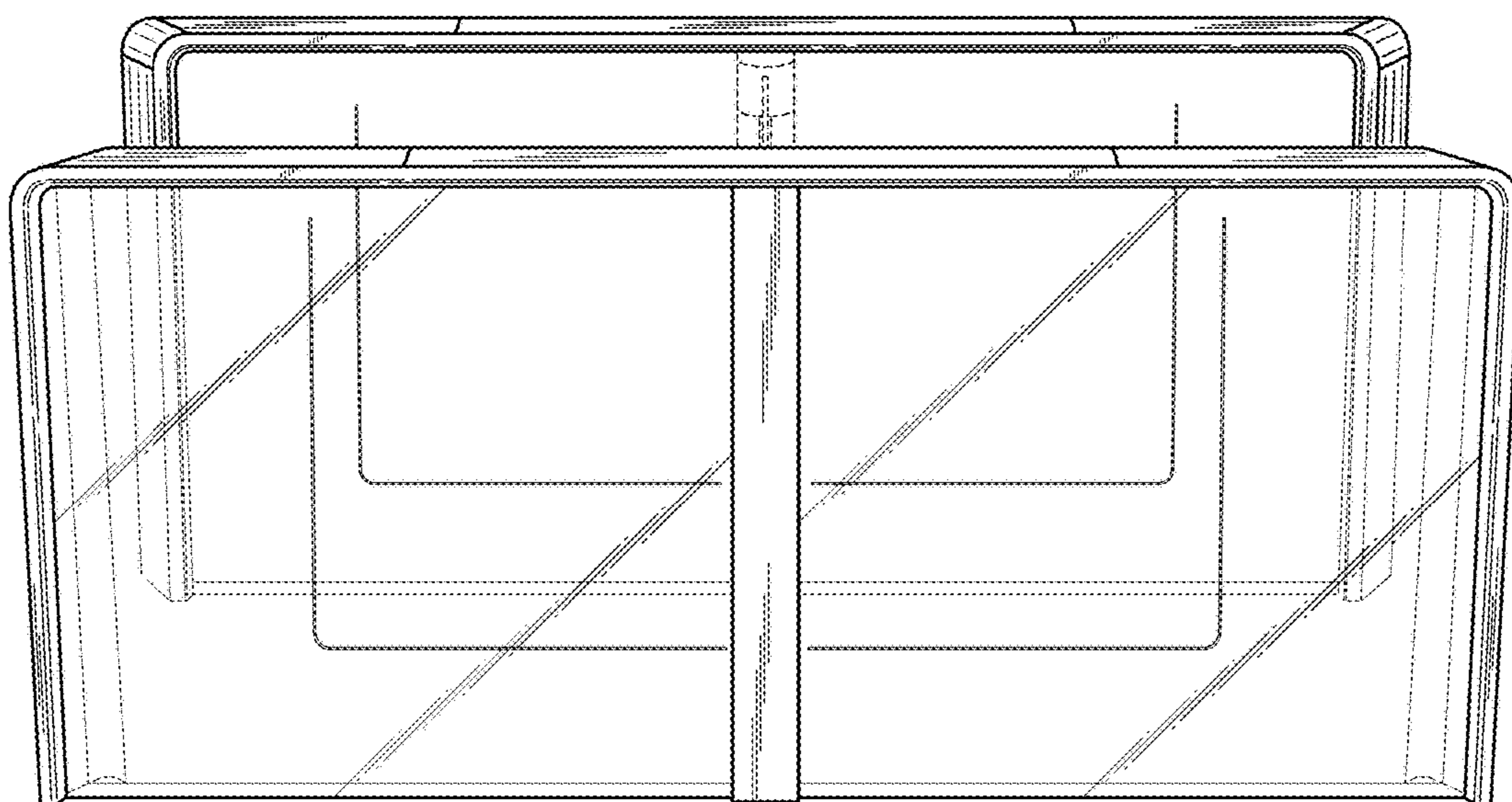

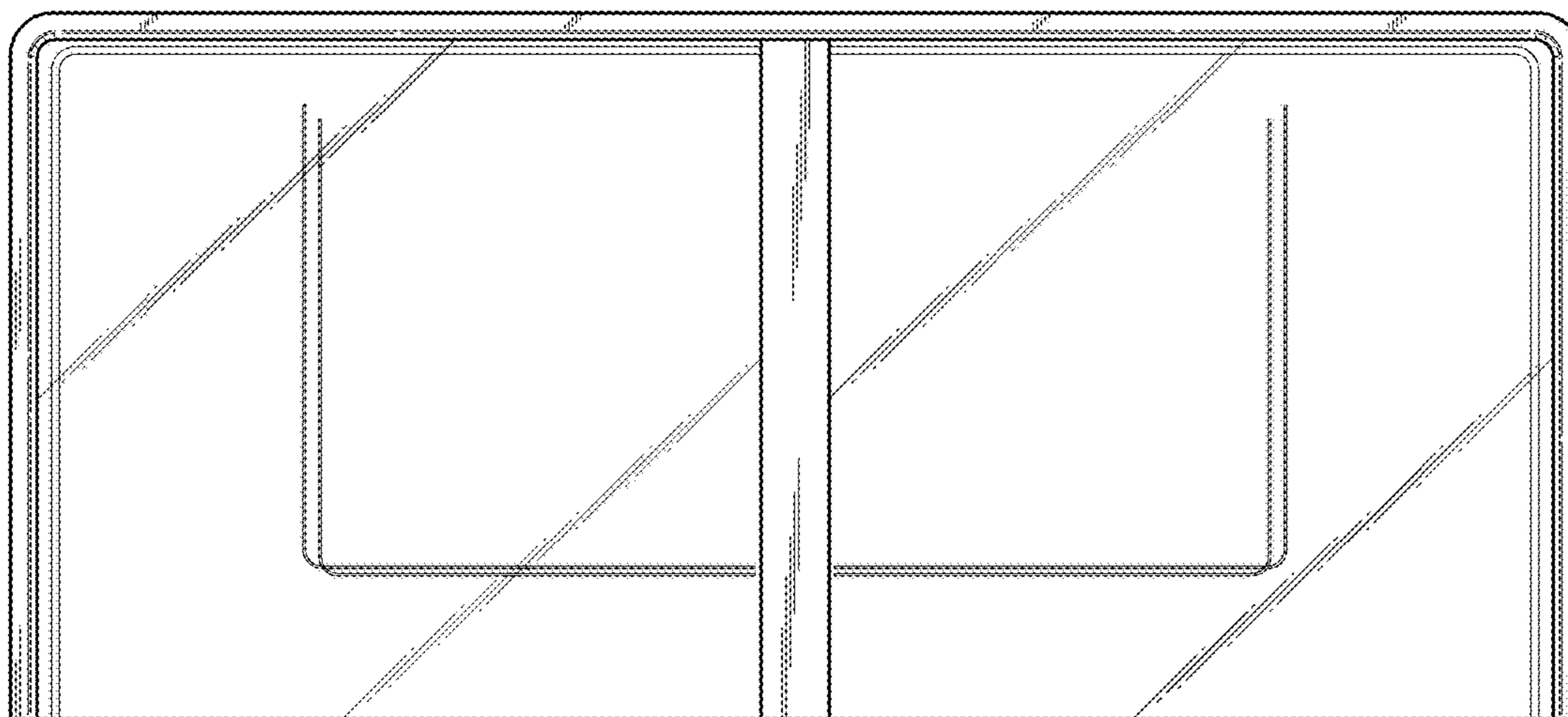

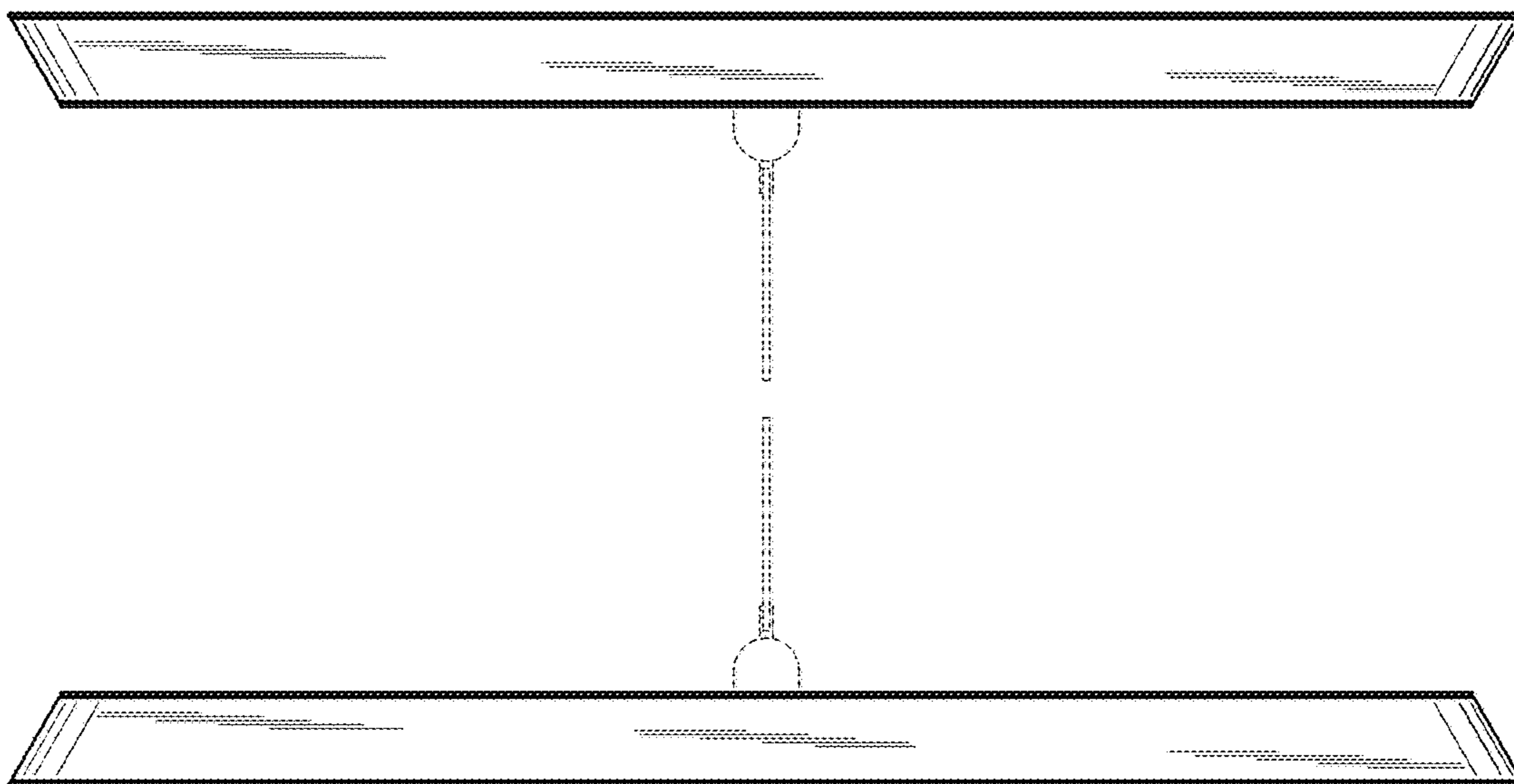
