DESCRIPTION

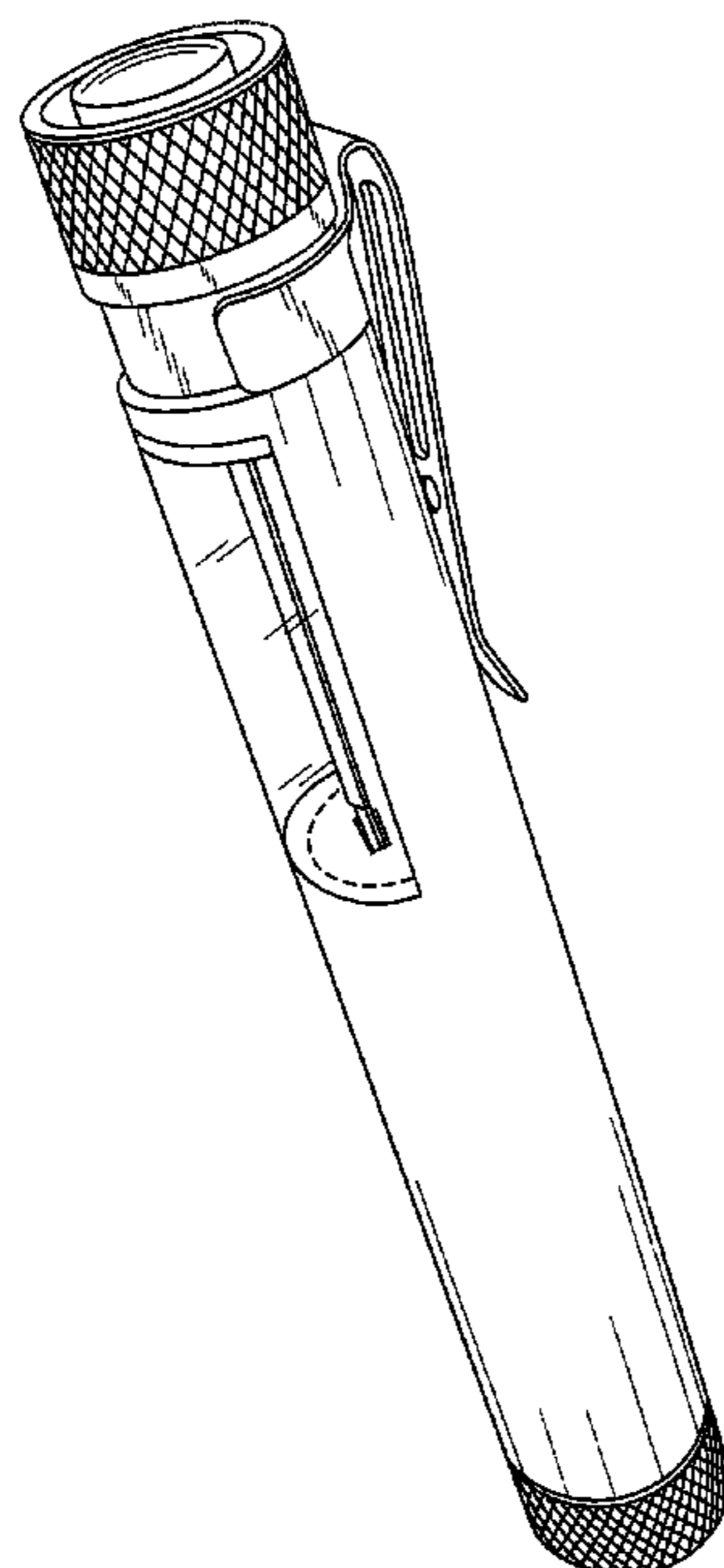
FIG. 1 is a top rear, left side perspective view of the flashlight with magnet, showing my new design;

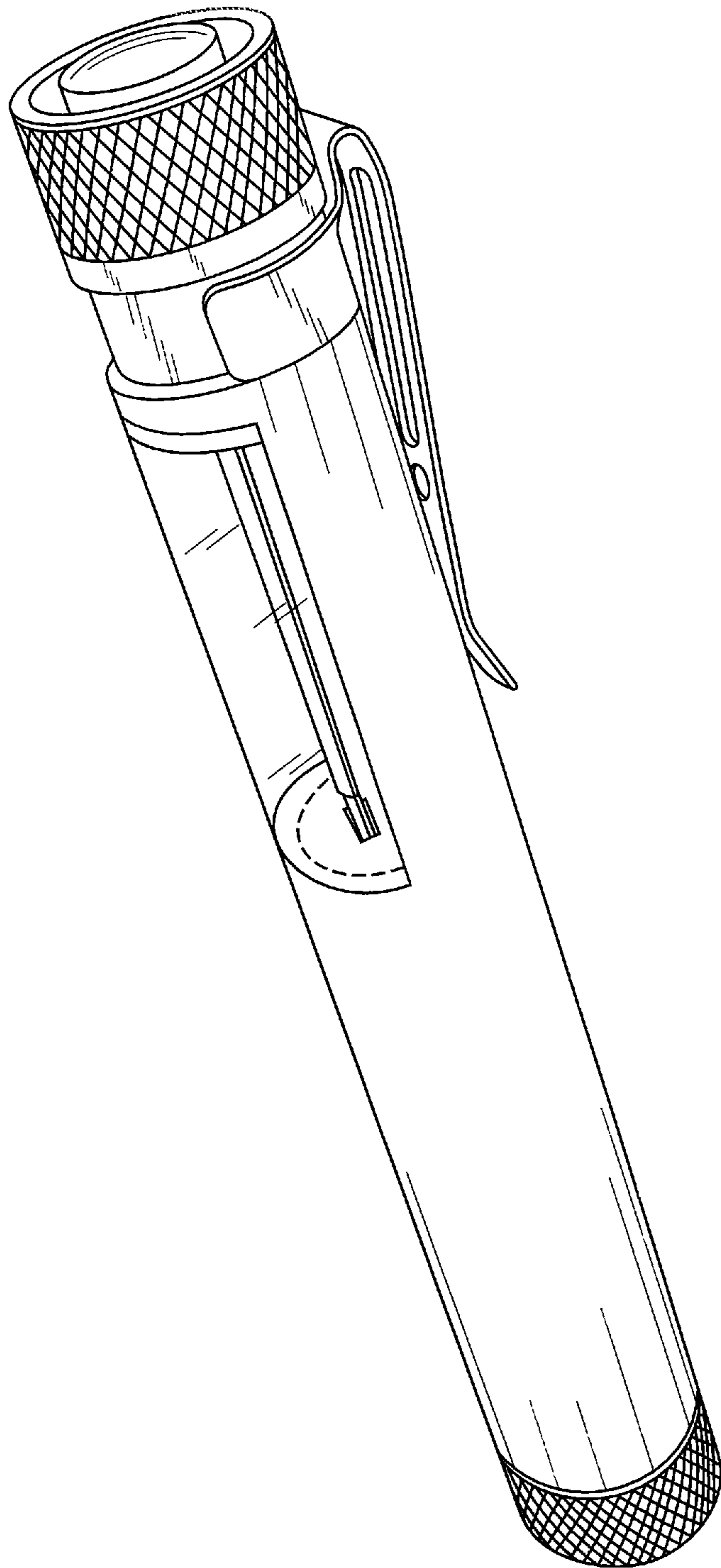

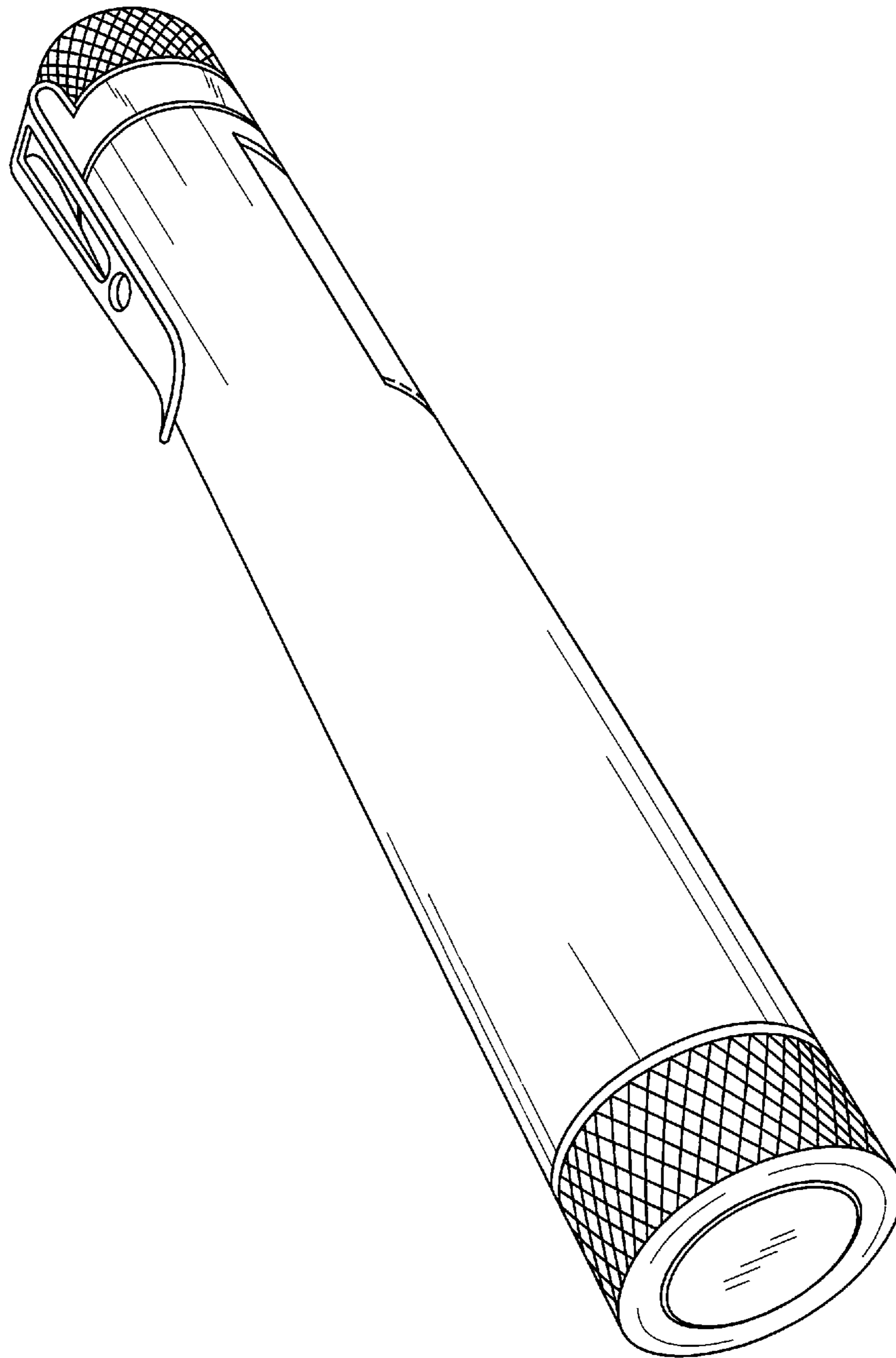

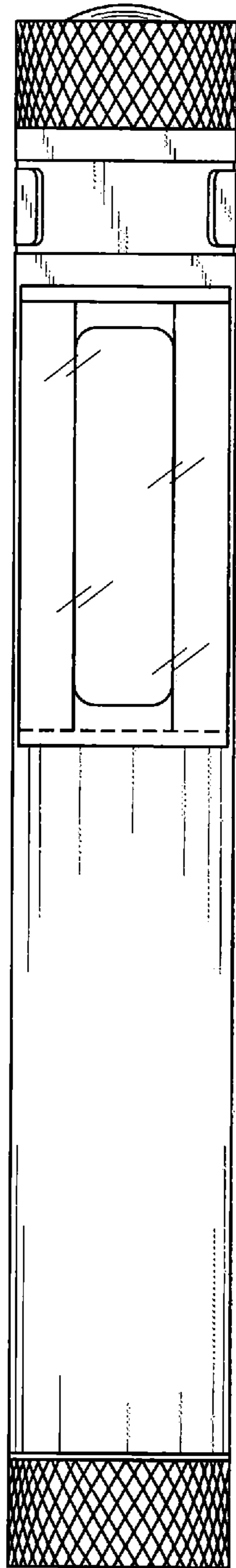

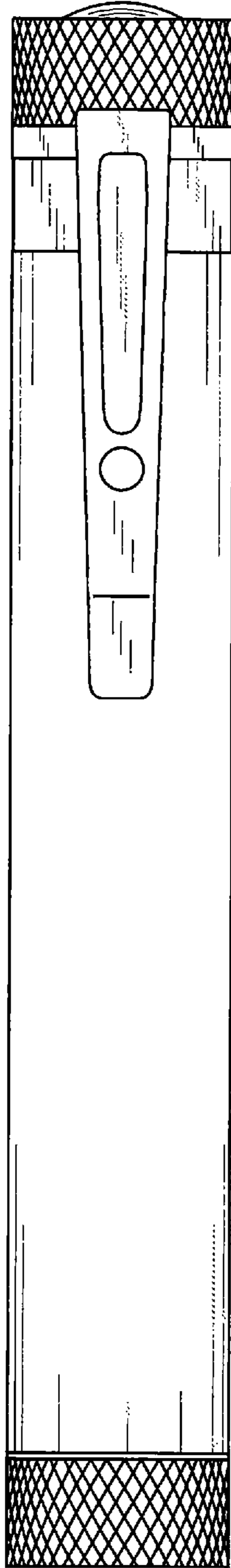

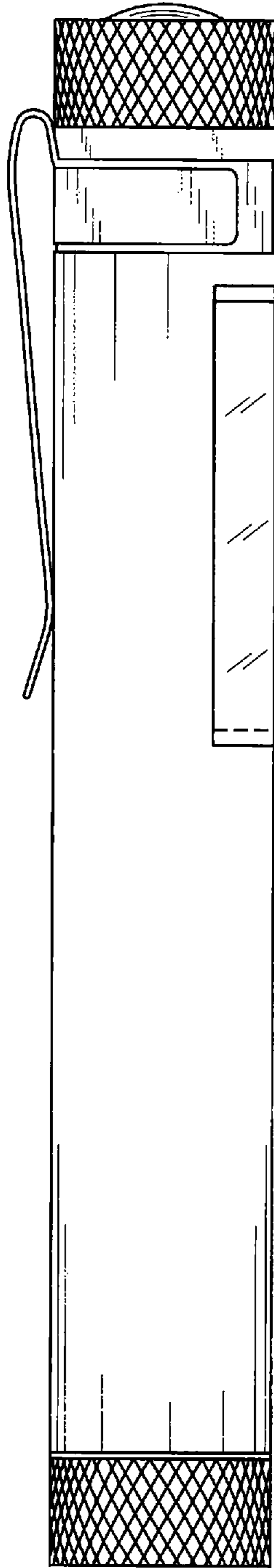

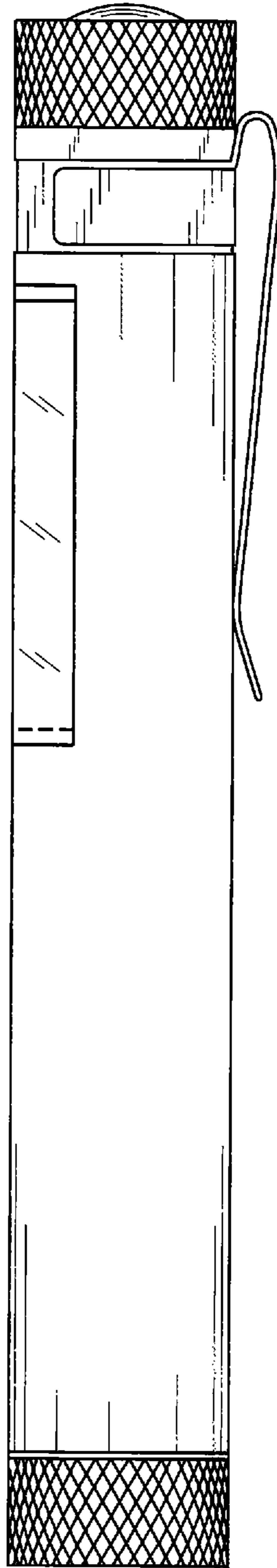

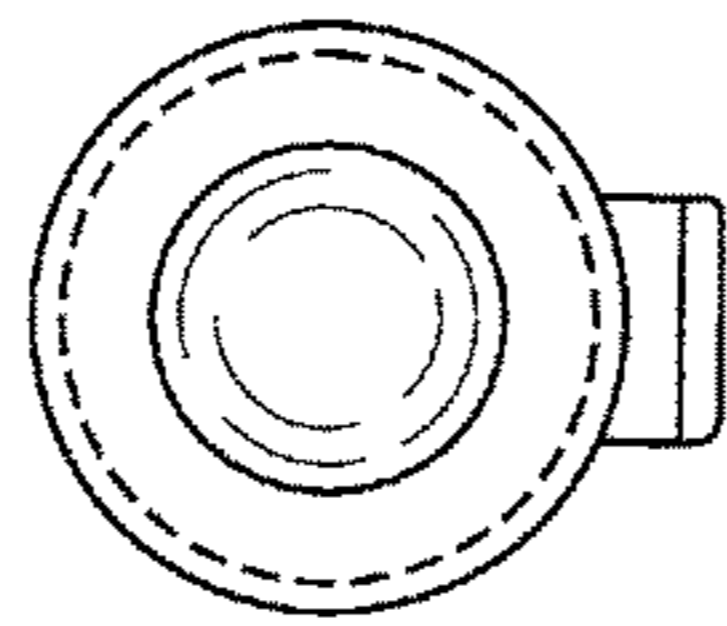

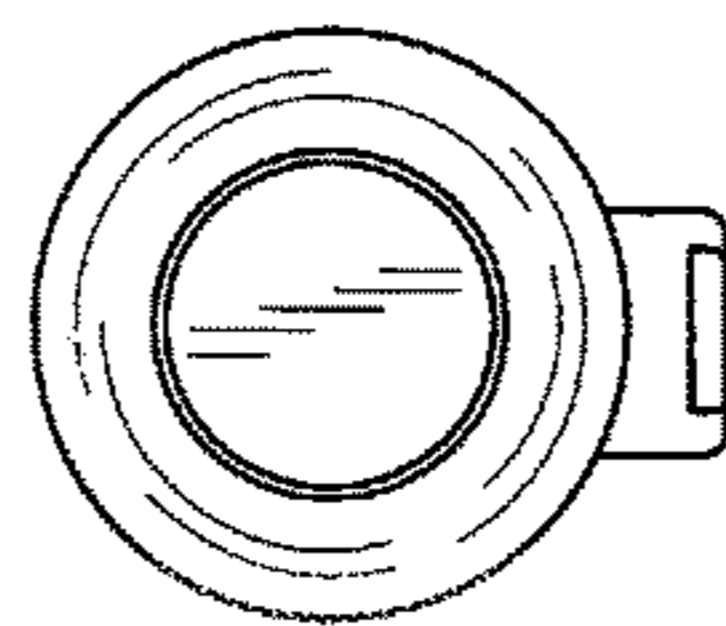
