(57) **CLAIM**

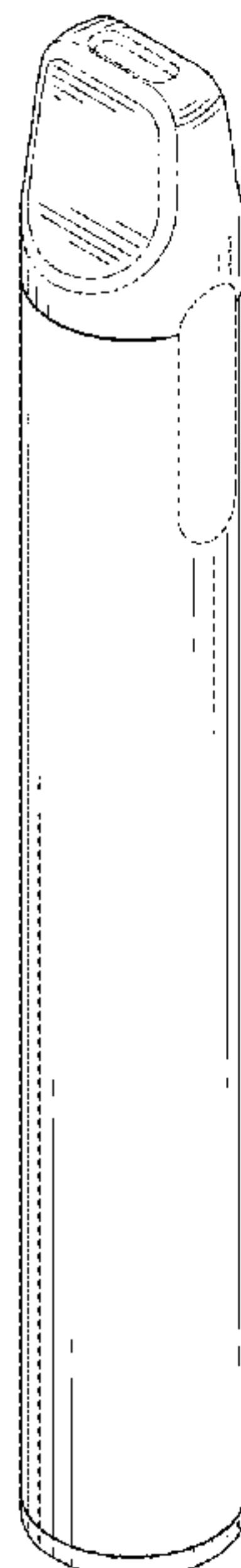
I claim the ornamental design for an electronic cigarette,

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of an
electronic cigarette showing my new design;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a left elevational view thereof;
FIG. 5 is a right elevational view thereof;

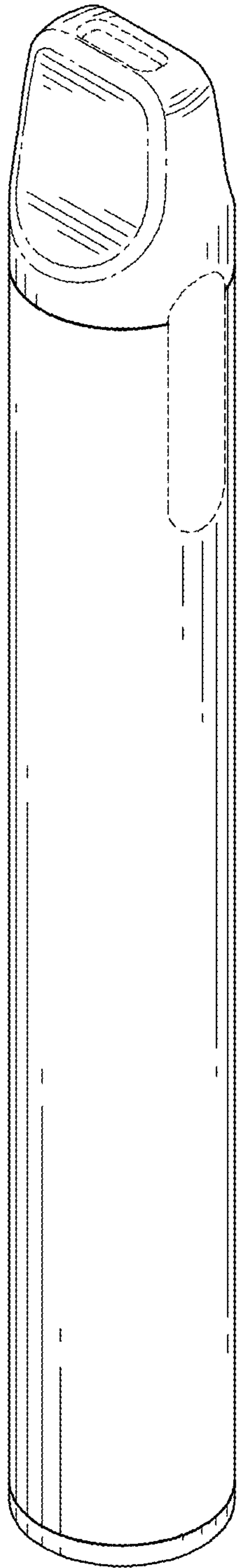

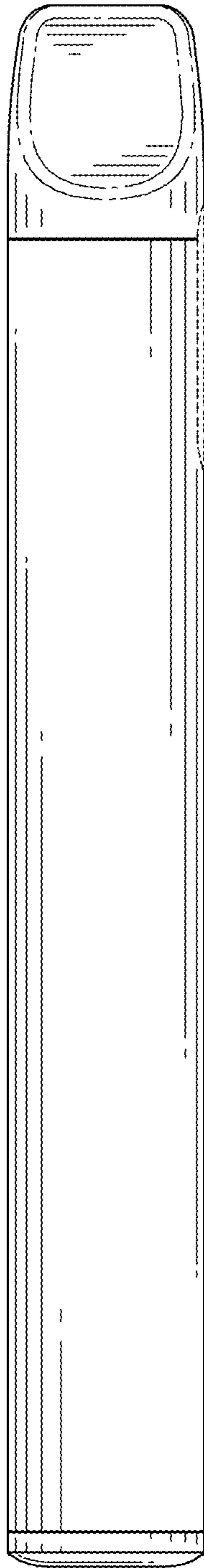

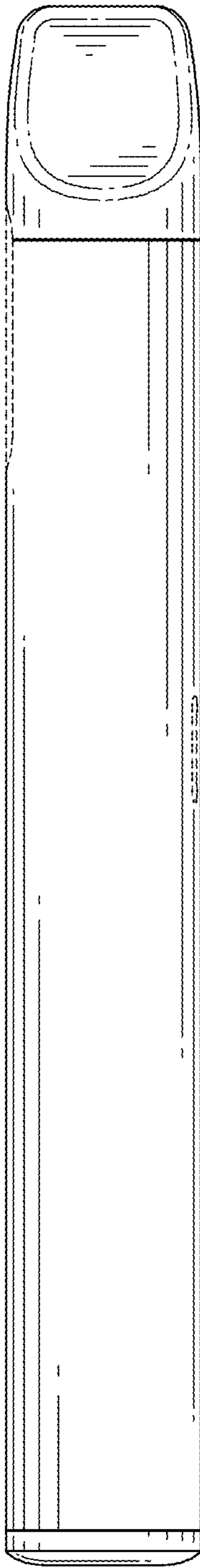

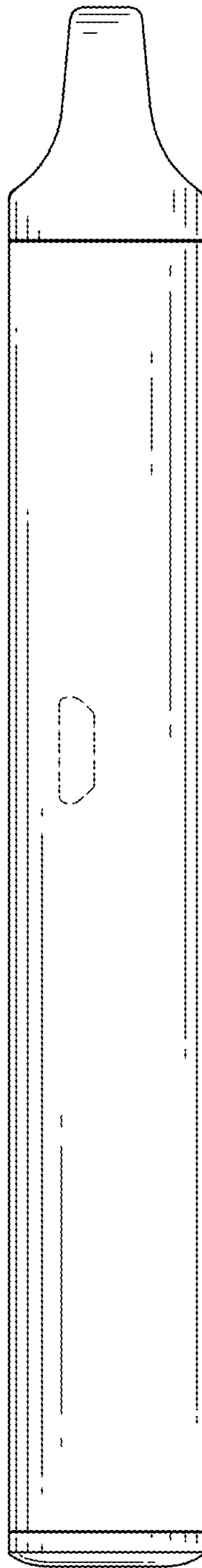

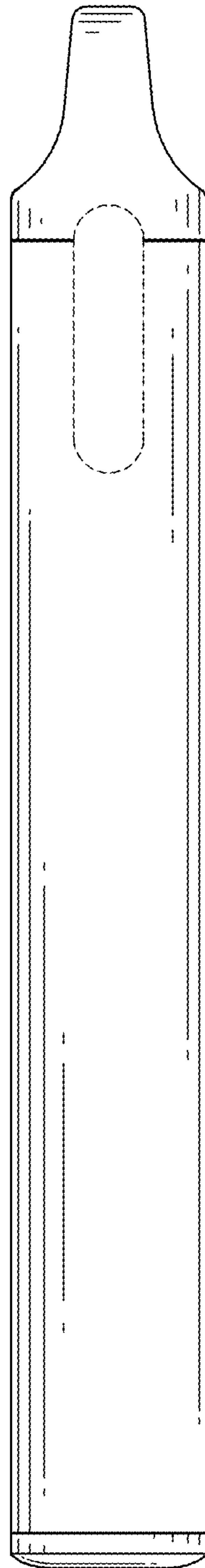

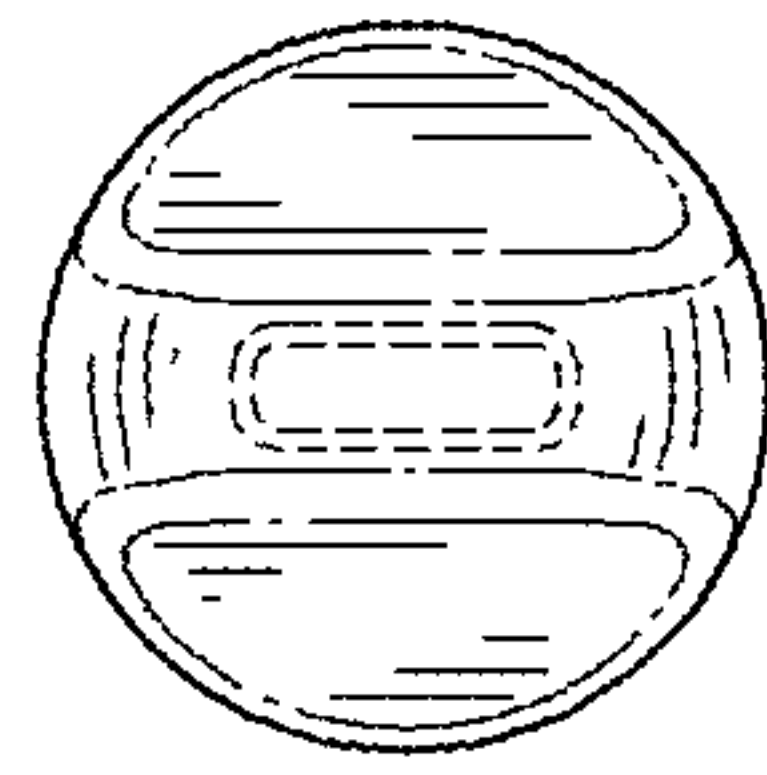

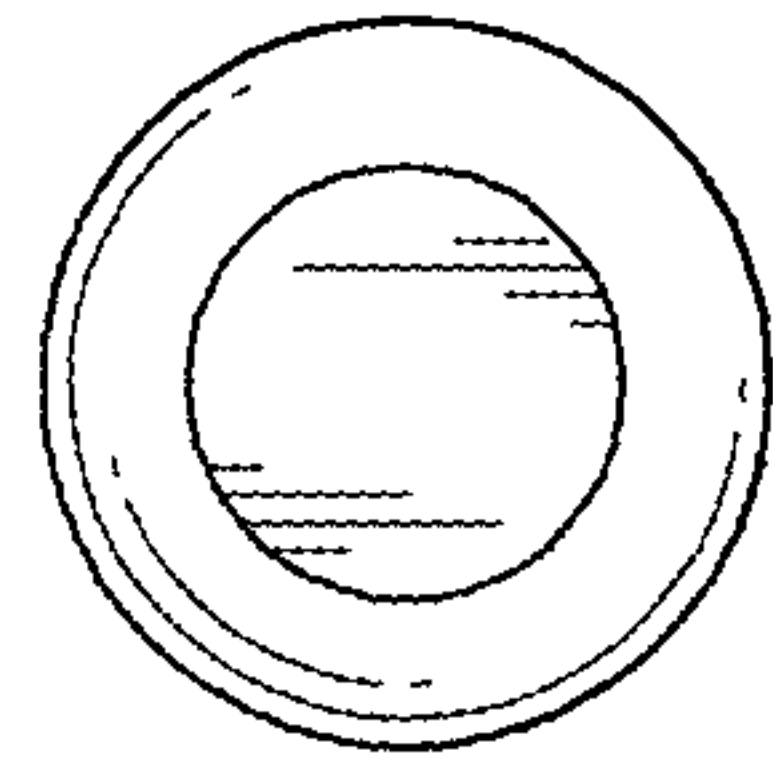
