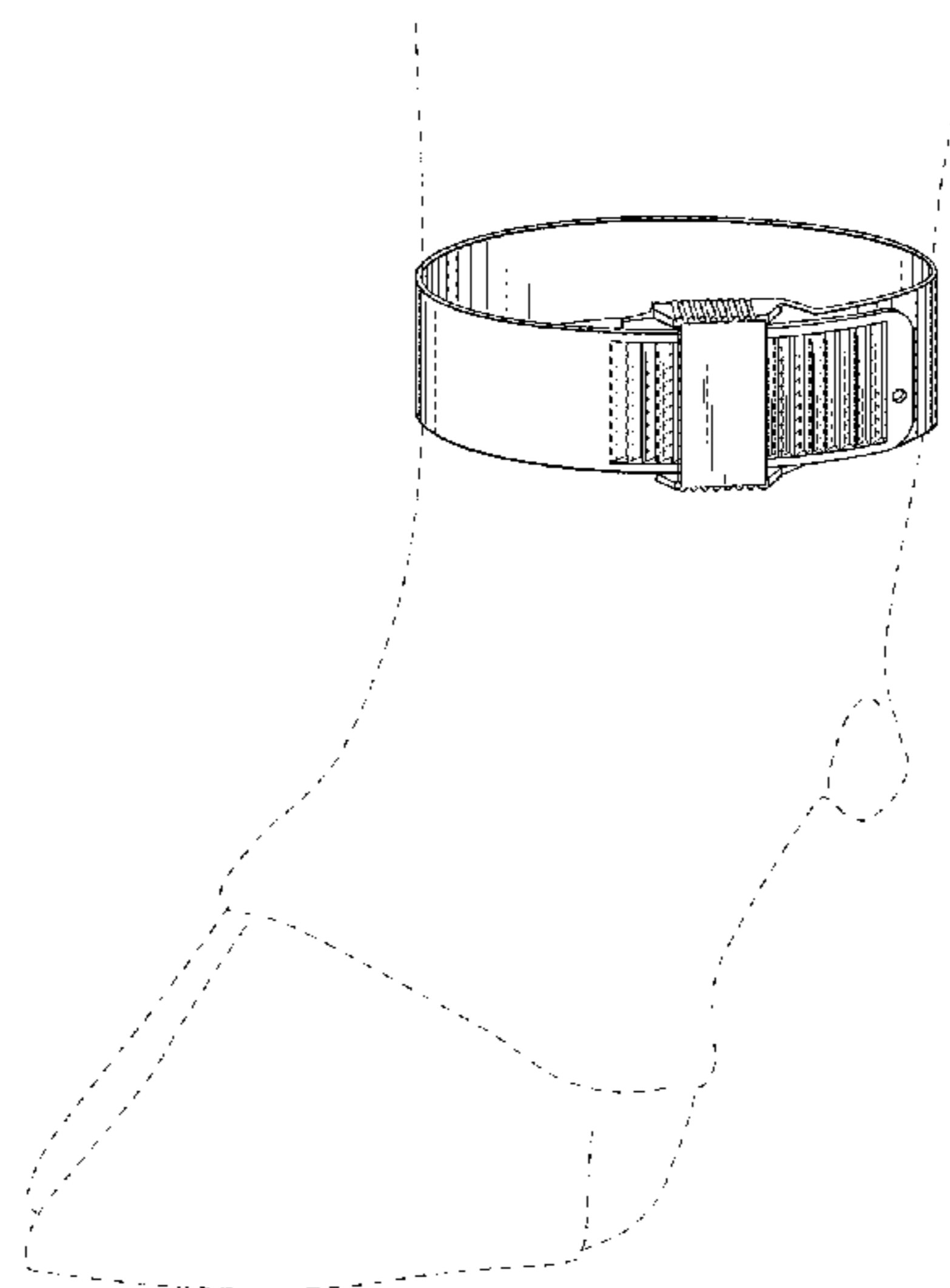
(57) **CLAIM**

The ornamental design for an animal identification band, as
shown and described.

DESCRIPTION

FIG. 1 is a front and side perspective view of an animal
identification band showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left, strap end elevation view thereof;
FIG. 5 is a right, clasp end elevation view thereof;
FIG. 6 is a side elevation view thereof;
FIG. 7 is a section view taken along line 7-7 of FIG. 2; and,
FIG. 8 is a perspective view thereof showing attachment to
a leg of a cow.

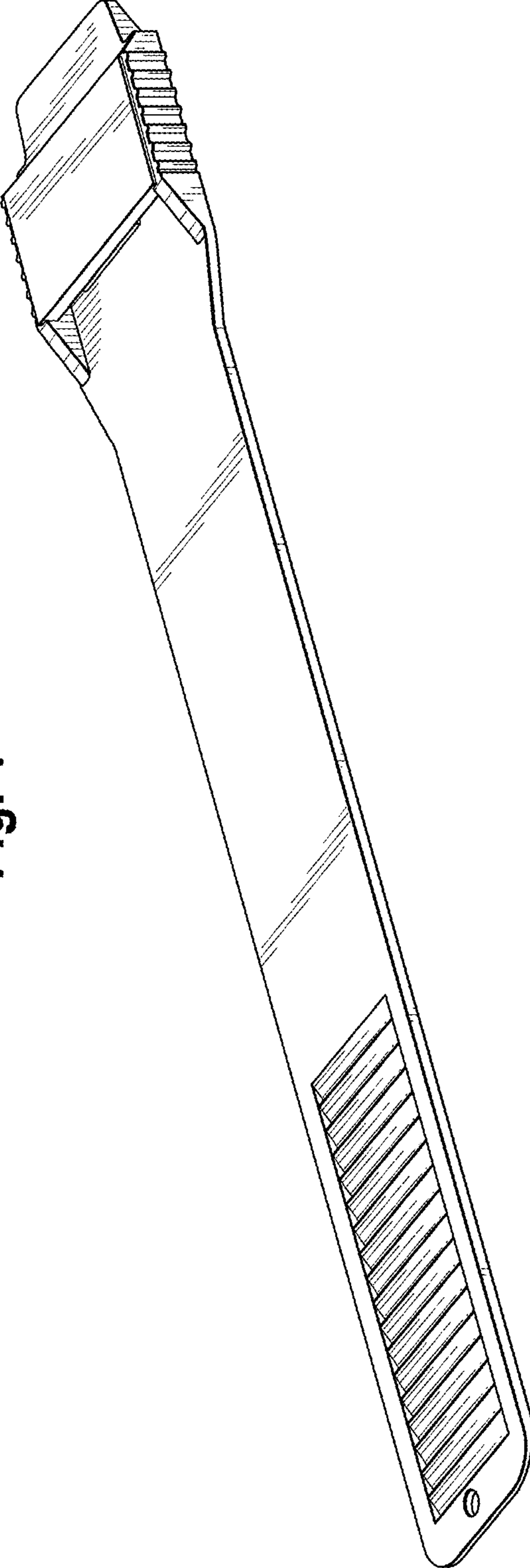

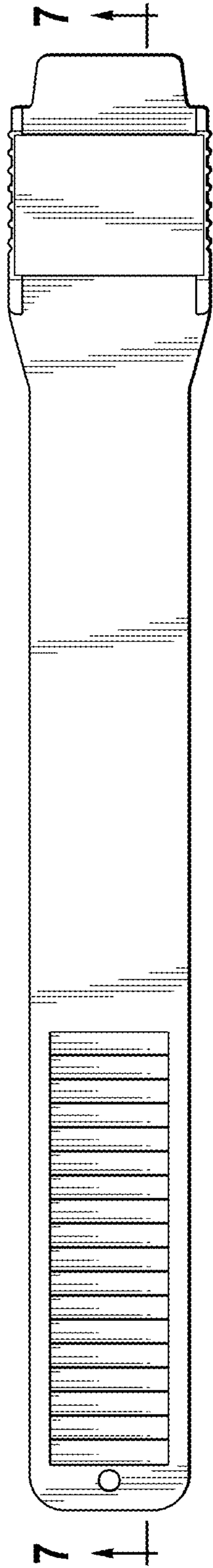

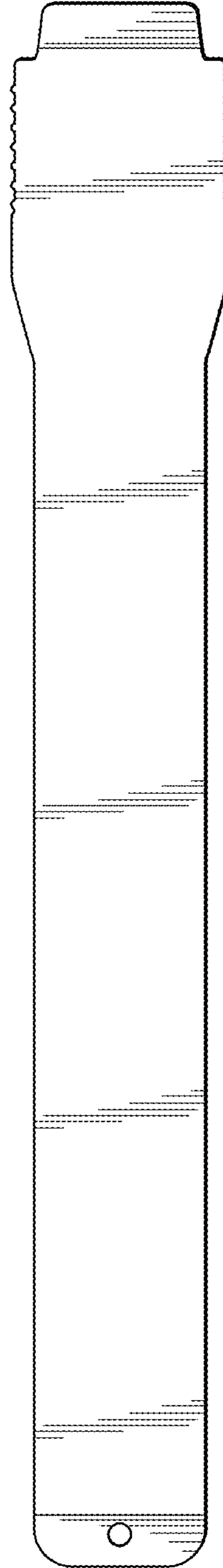
