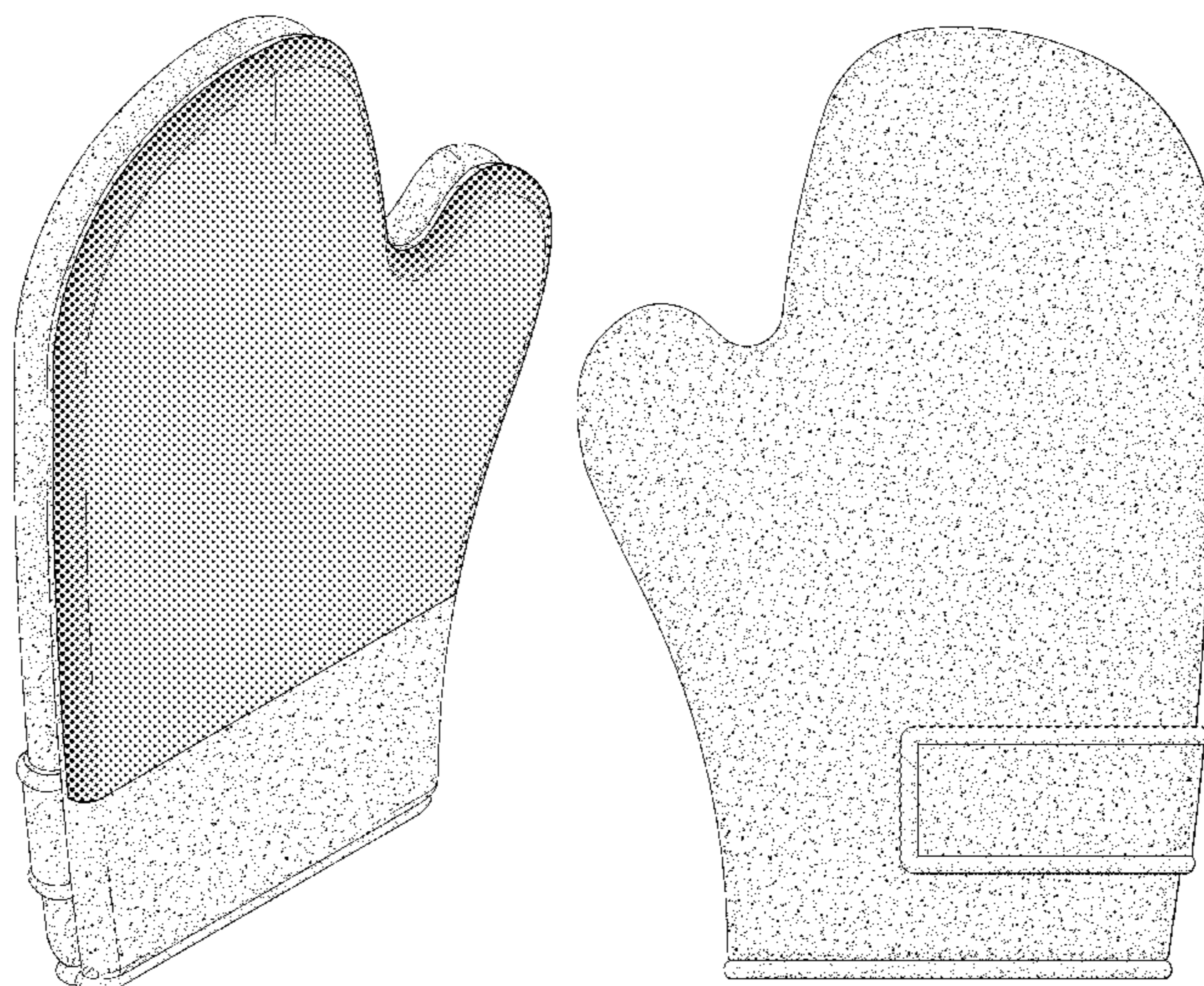
(57) **CLAIM**

The ornamental design for a cleaning glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cleaning glove showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
Where included, the use of stippling and shading is provided to show contrast in materials.  
The broken lines in the figures show portions of the cleaning glove that form no part of the claimed design.

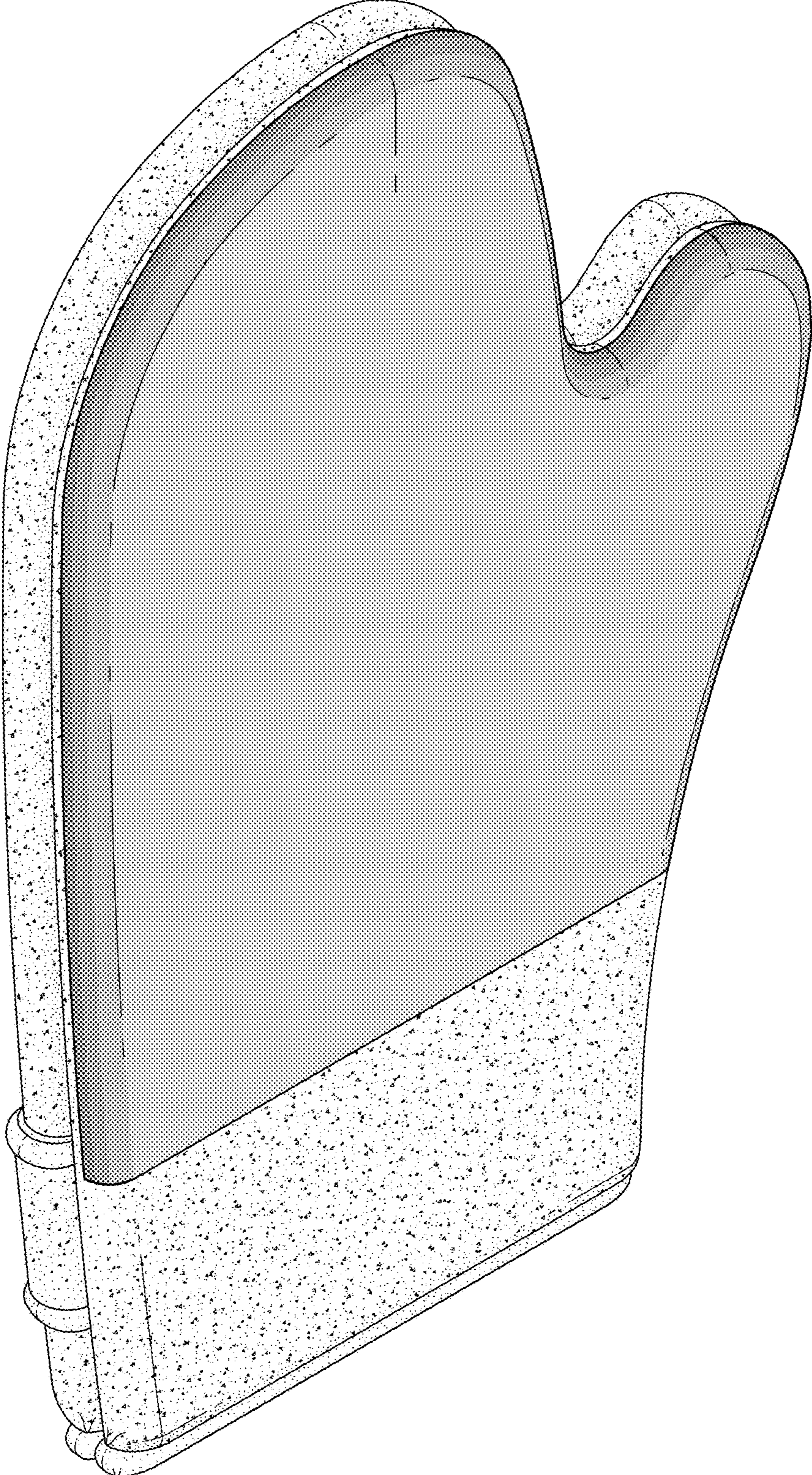

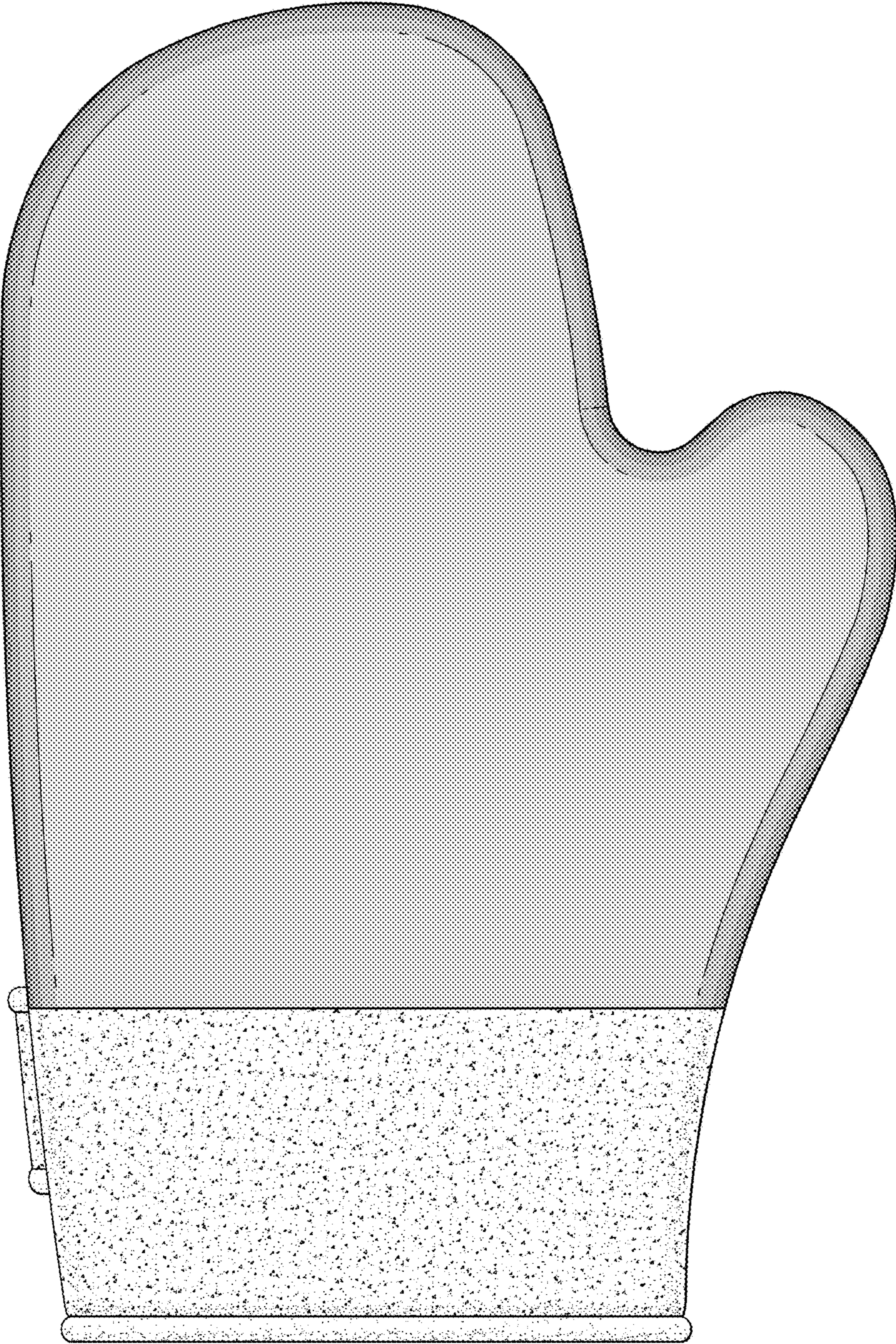

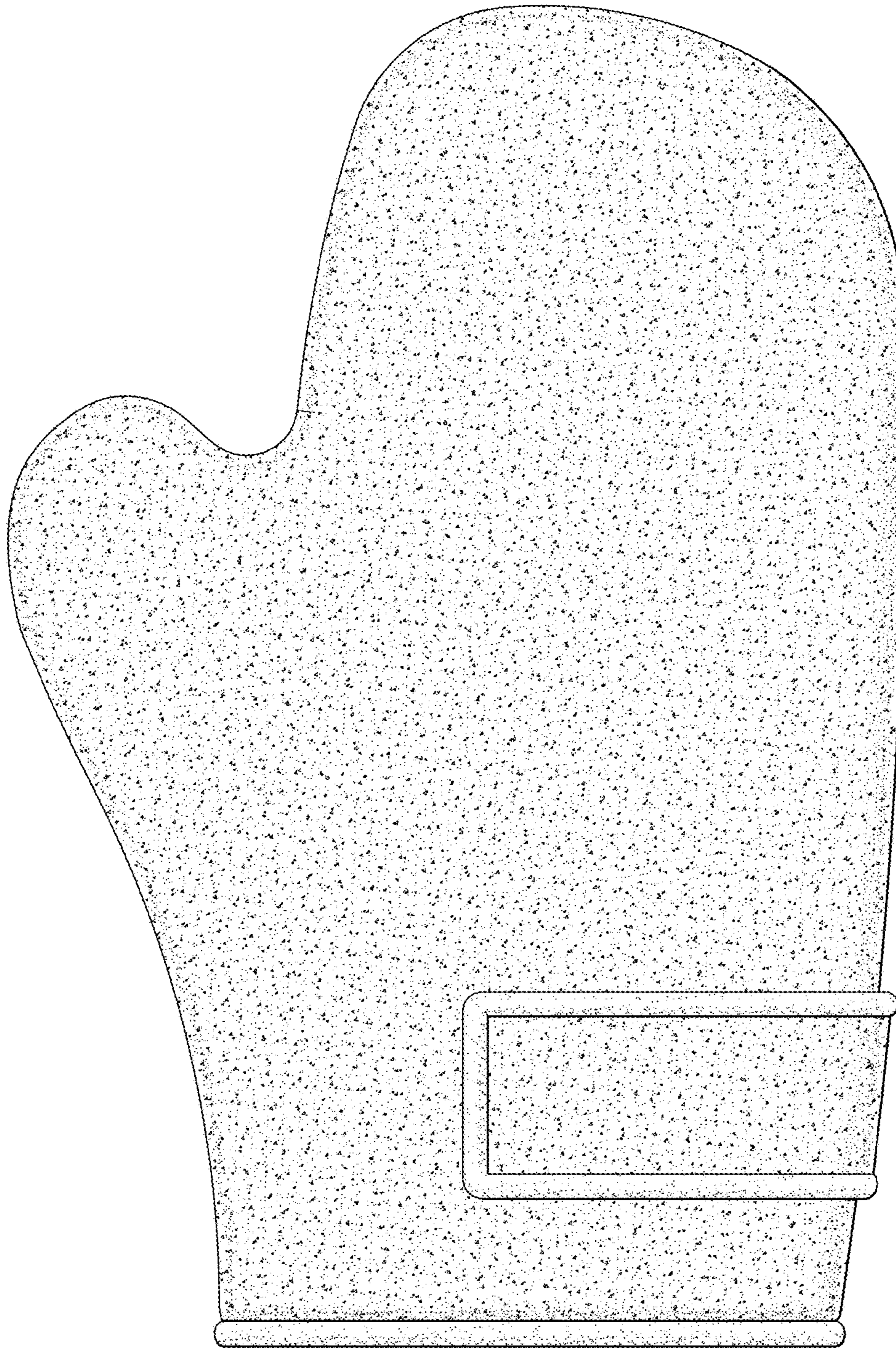

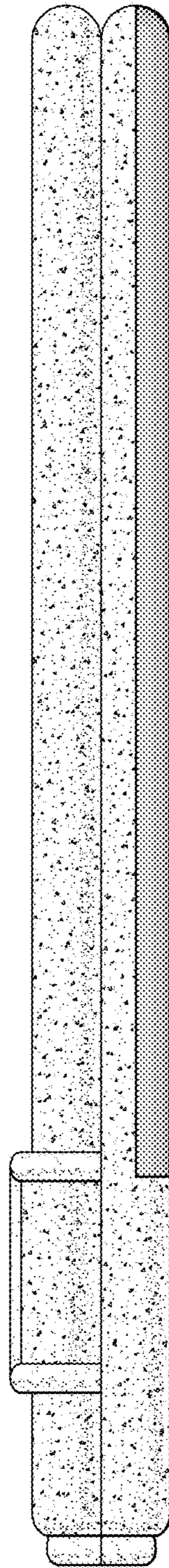

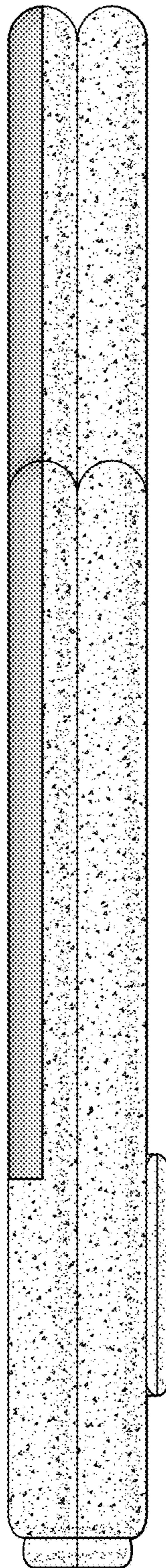

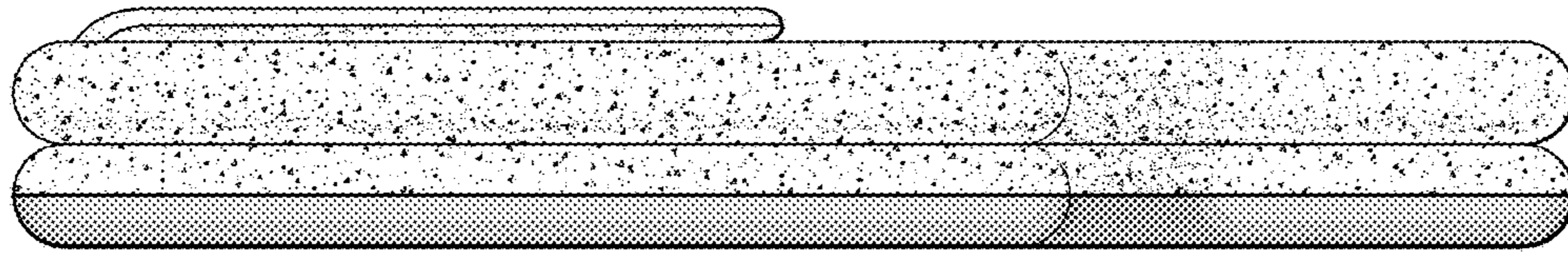

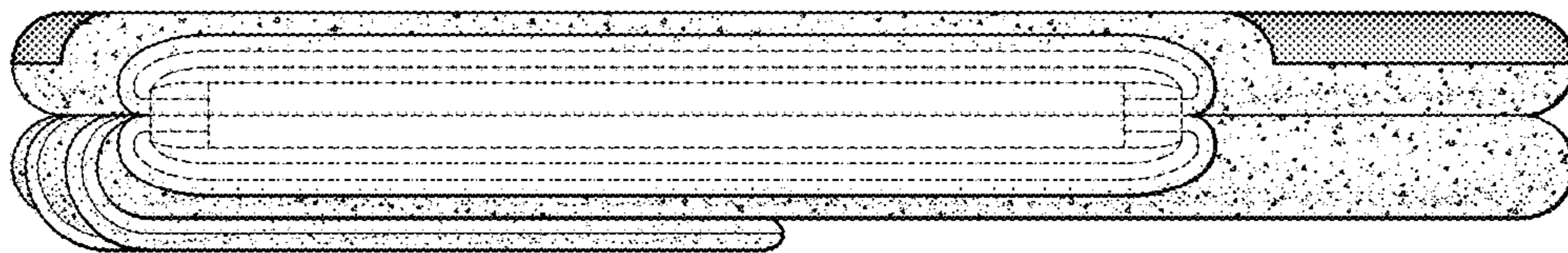
