(57) **CLAIM**

The ornamental design for a garment, as shown and described.

DESCRIPTION

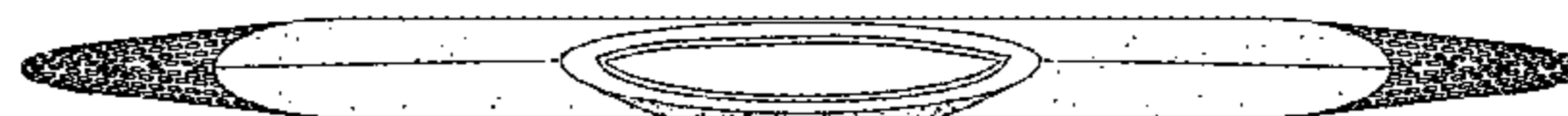
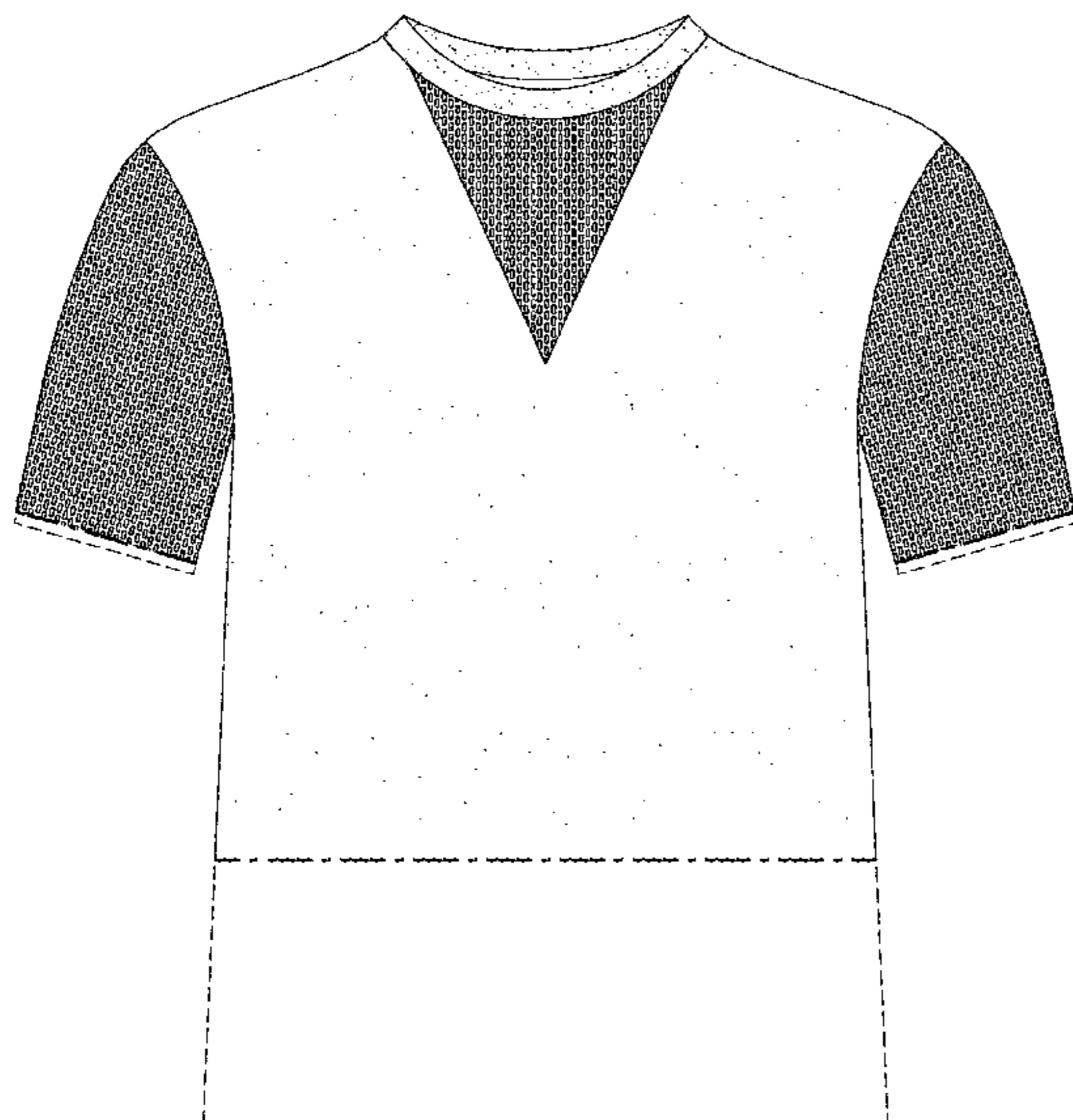
FIG. 1 is a back, right perspective view of the garment, showing the present design in a closed configuration; FIG. 2 is a back, right perspective view of the garment of FIG. 1, shown in an open configuration; FIG. 3 is a front view thereof; FIG. 4 is a top view thereof; FIG. 5 is a back view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a right view thereof; and, FIG. 8 is a left view thereof.

The depictions of the sleeves and the triangular panel on the chest reflect a generic mesh pattern spanning these parts of the garment, and no specific mesh pattern is claimed. But the right to claim a specific mesh pattern by one or more divisional and/or continuation applications is reserved.

The evenly spaced broken lines shown in the drawings are directed to environment, are for informational purposes only, and form no part of the claimed design.

The long and short broken lines are boundary lines, which define bounds of the claimed design. These boundaries do not exist in reality in the article embodying the design. It is understood that the claimed design extends to these boundaries but does not include the boundaries.

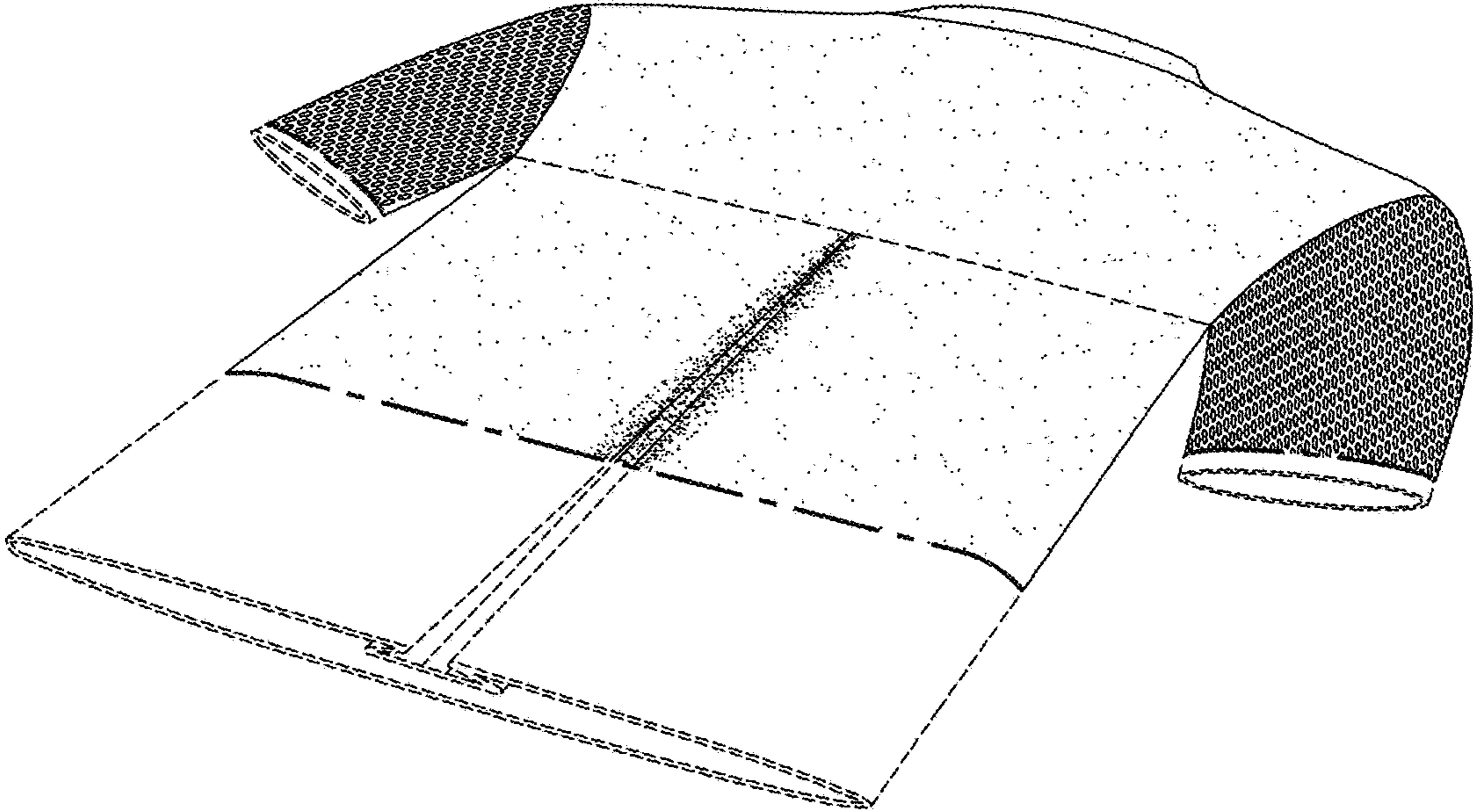

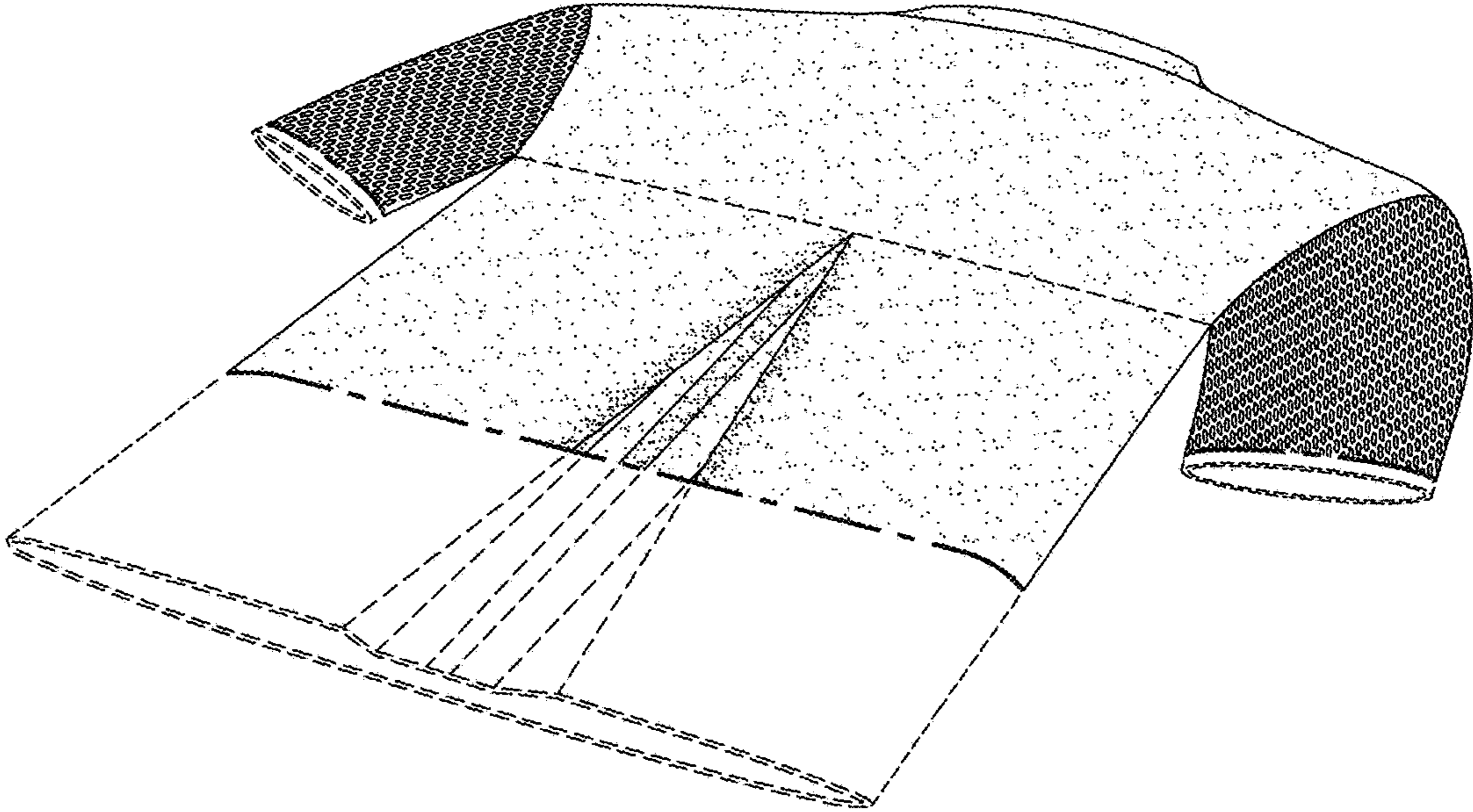

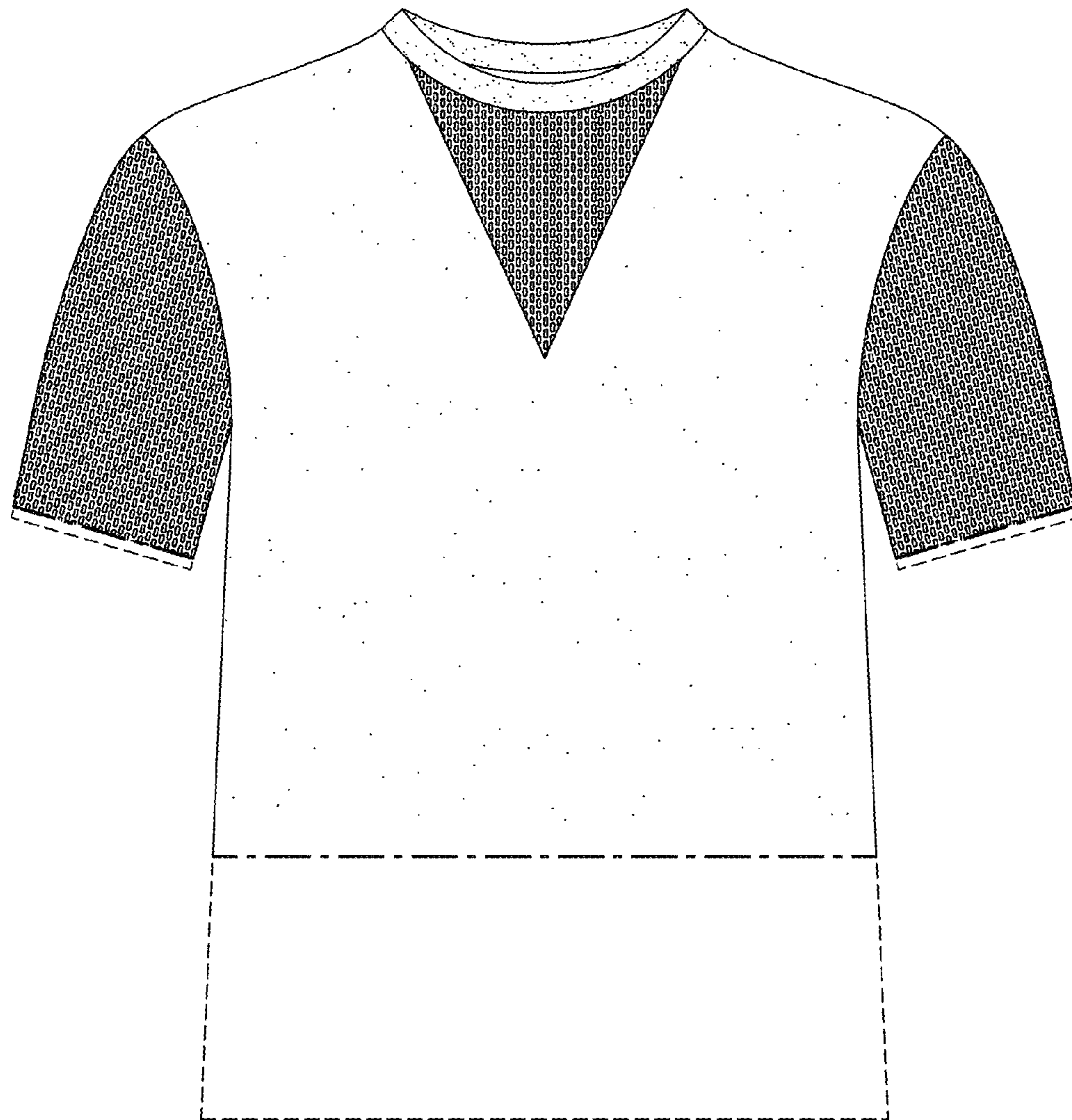

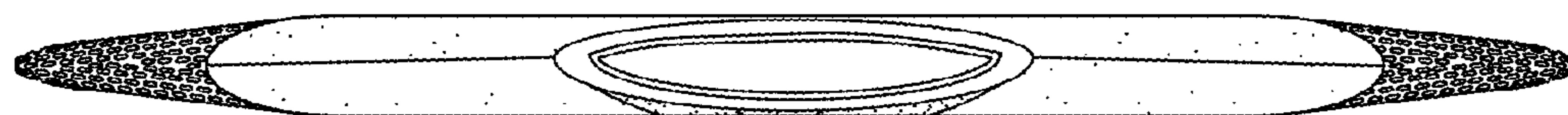

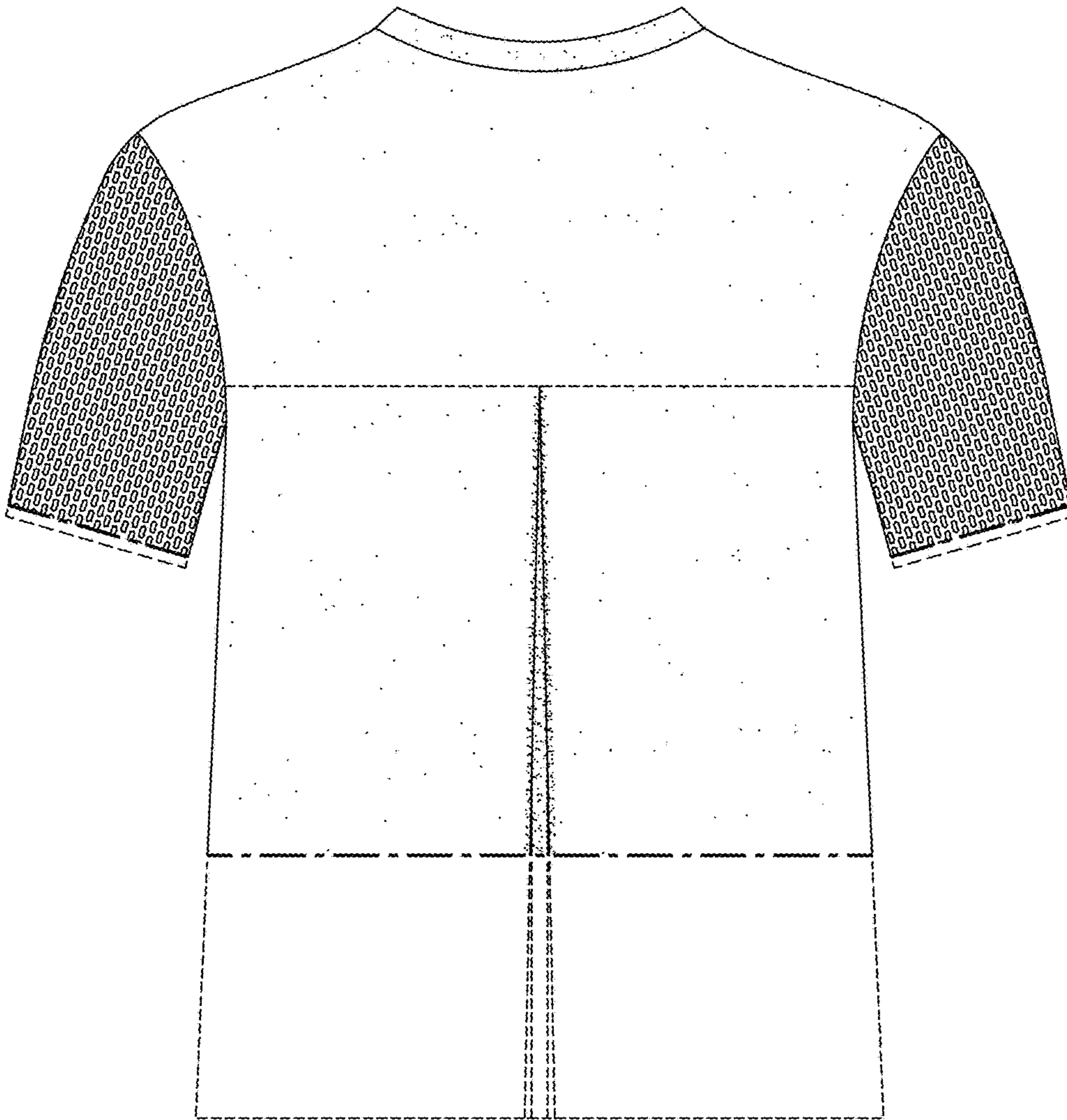

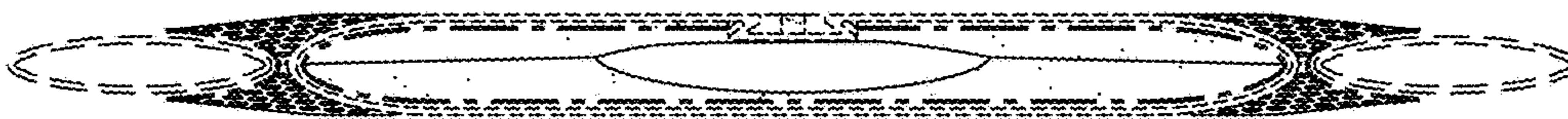
