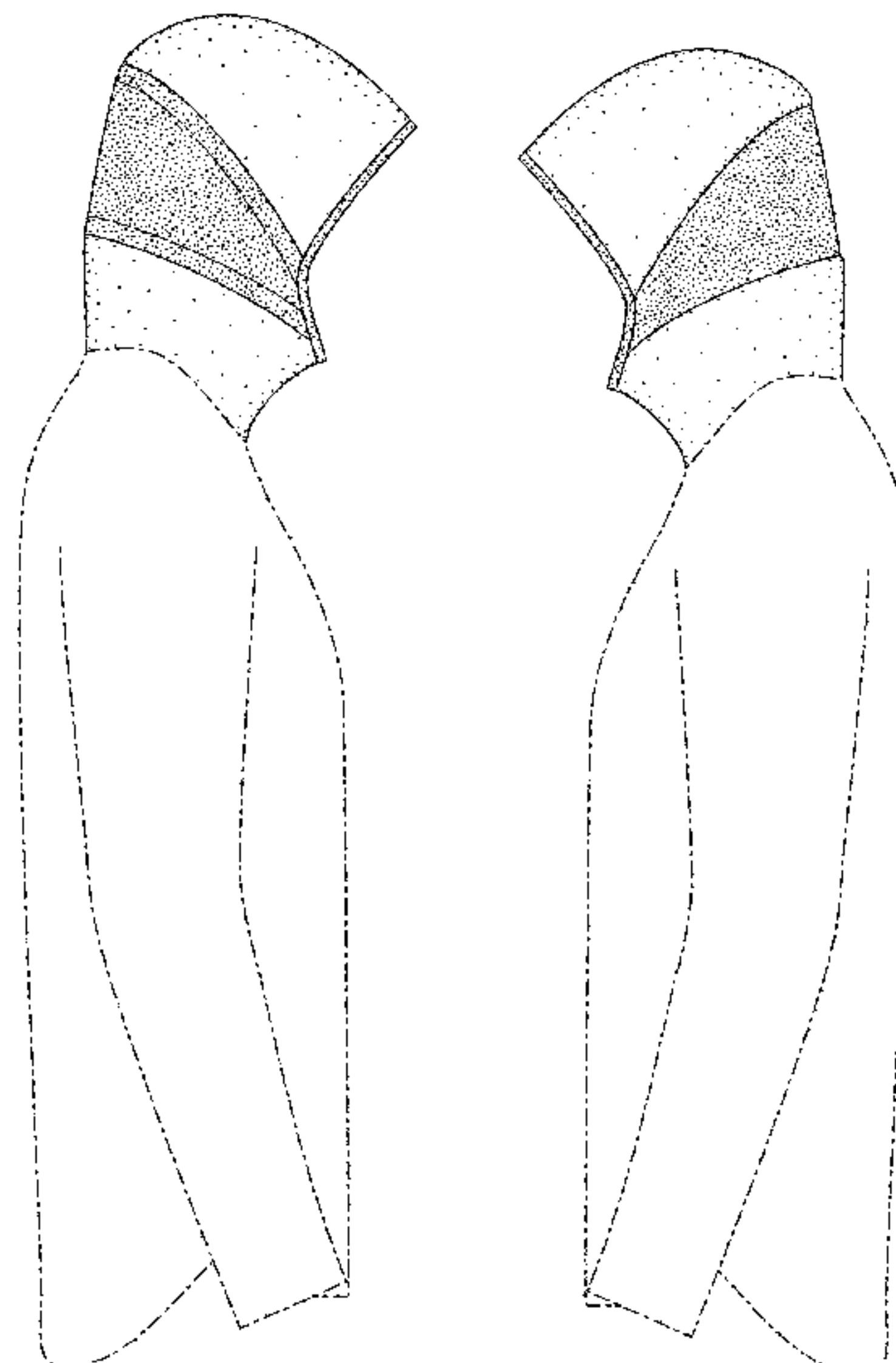
The ornamental design for a garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear right perspective view of a garment showing our new design;

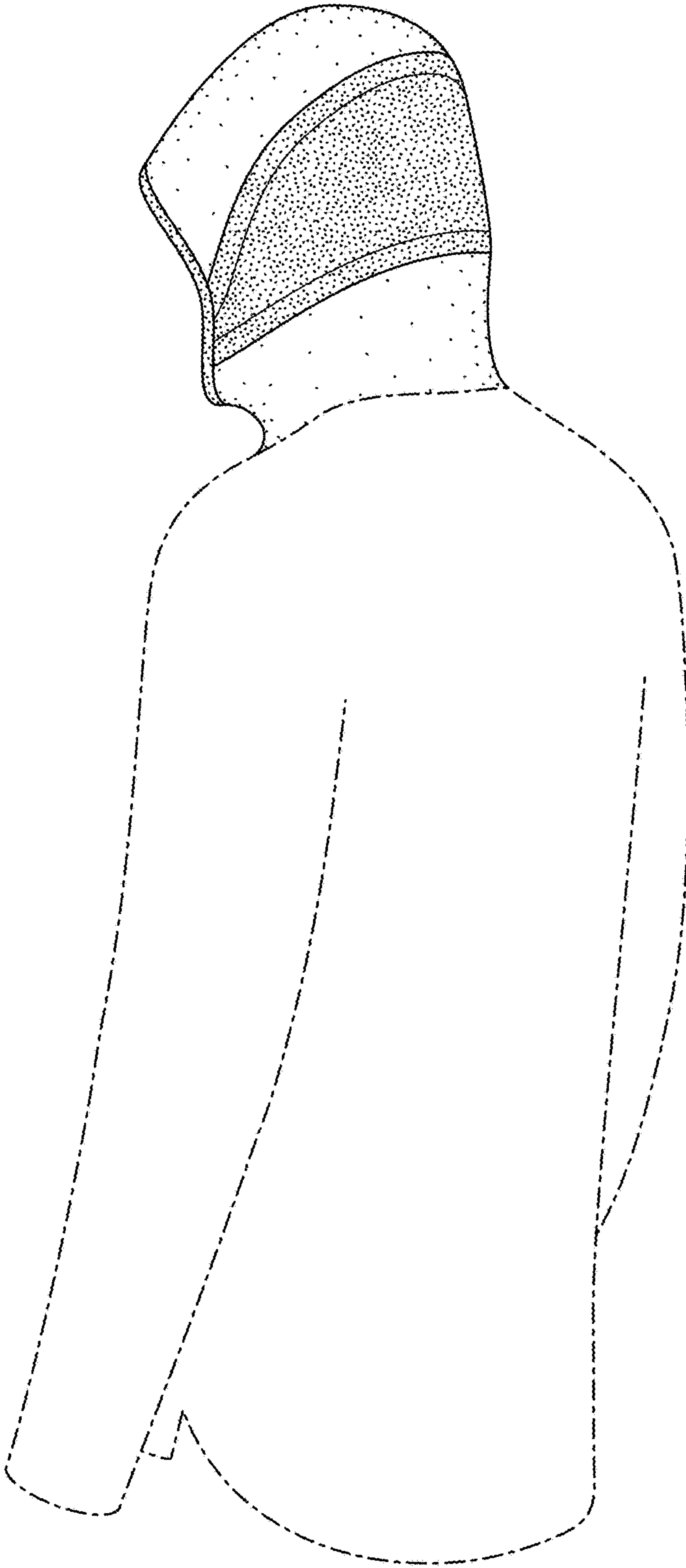

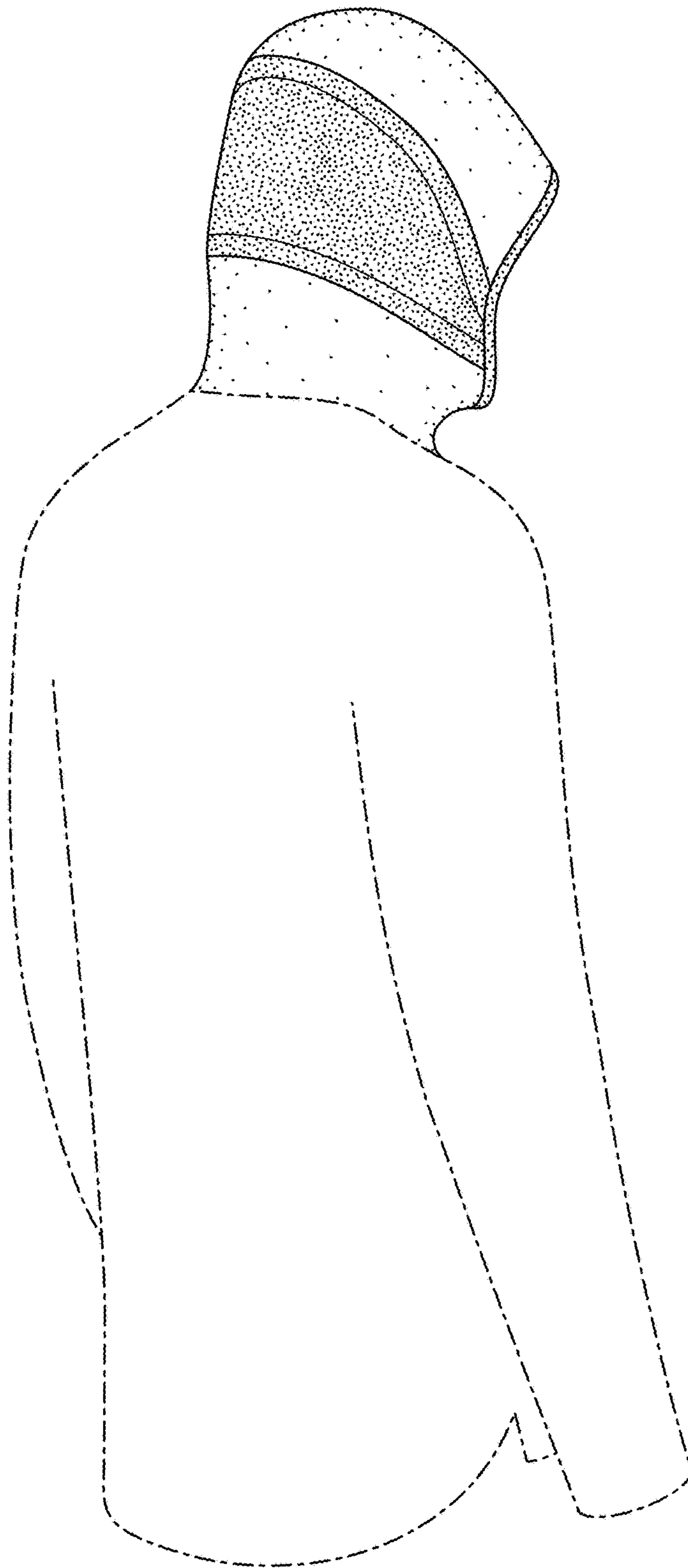

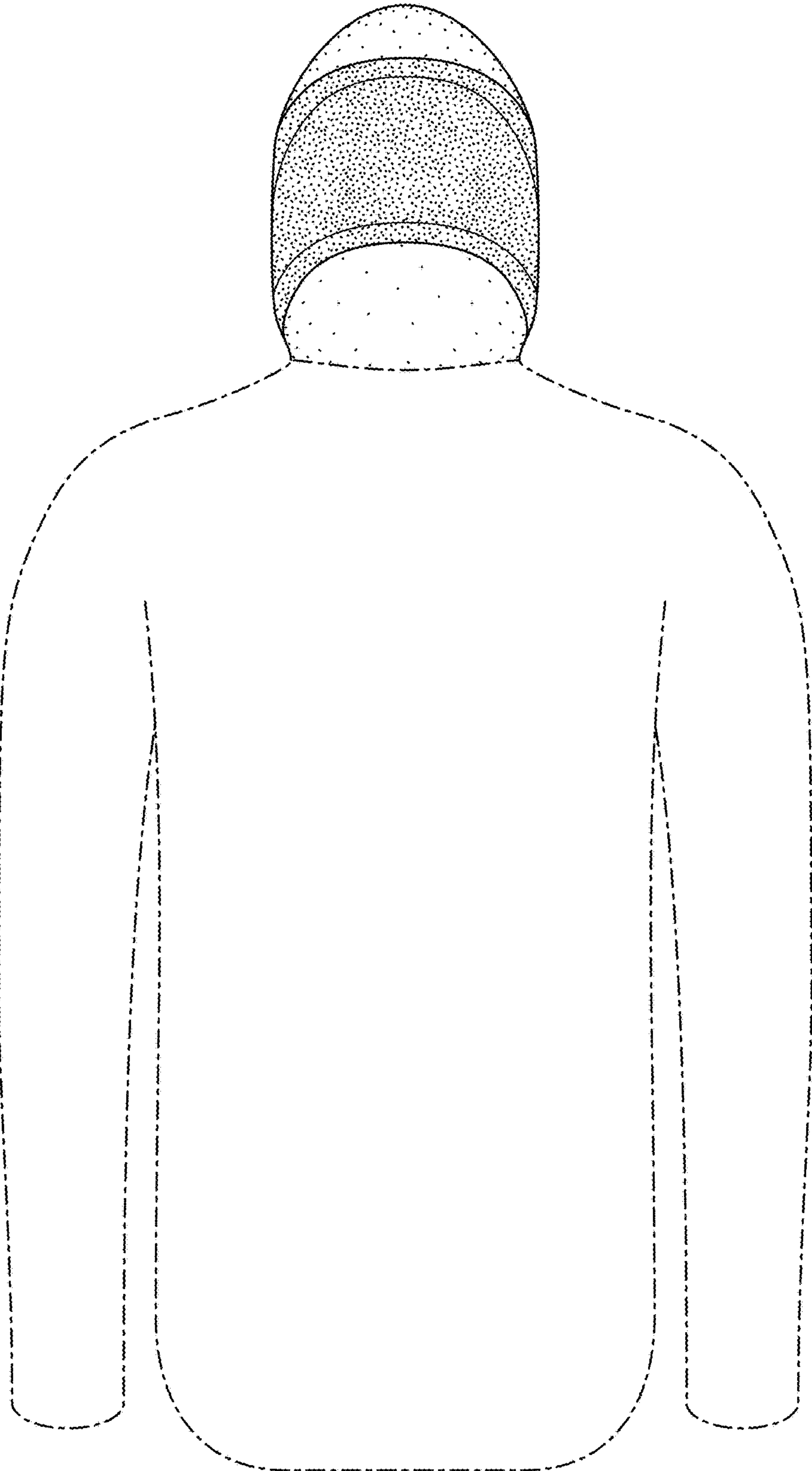

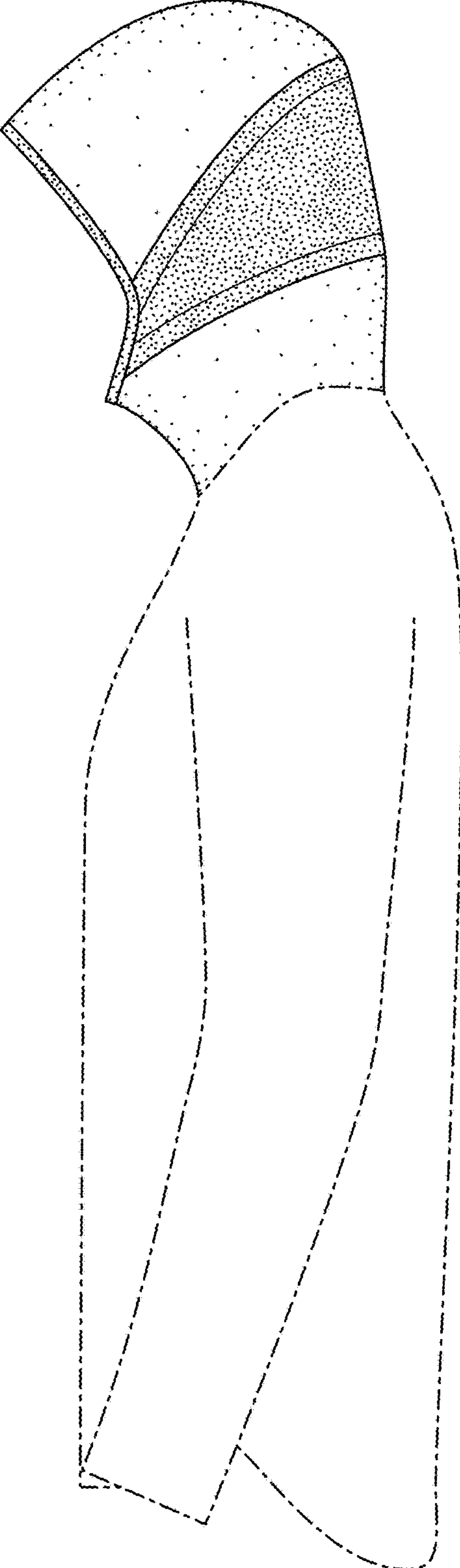

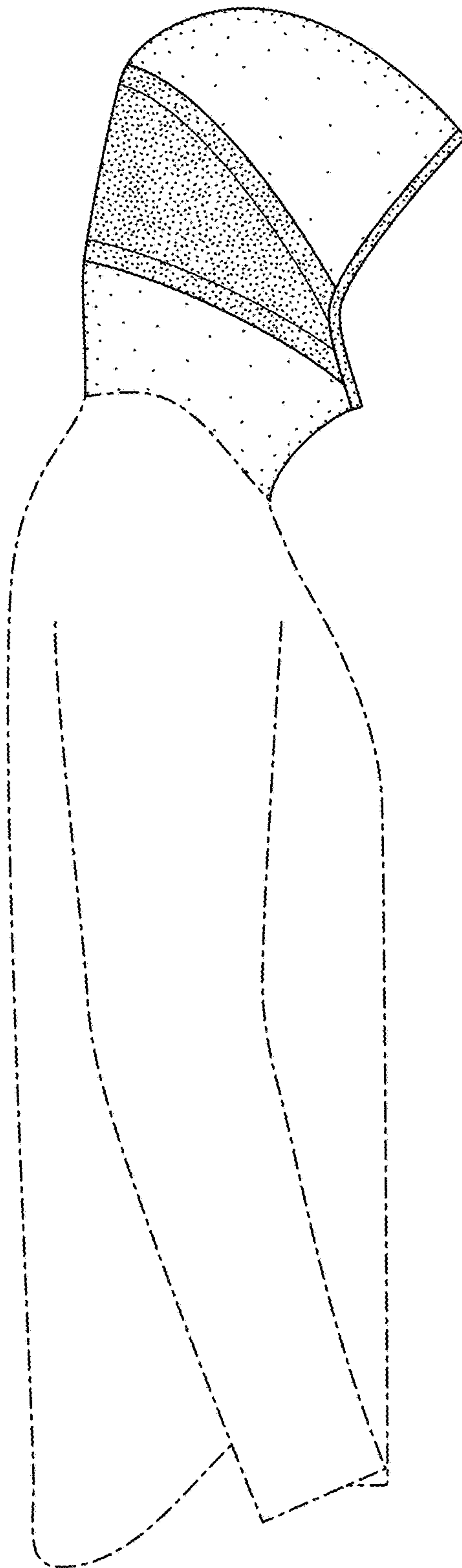

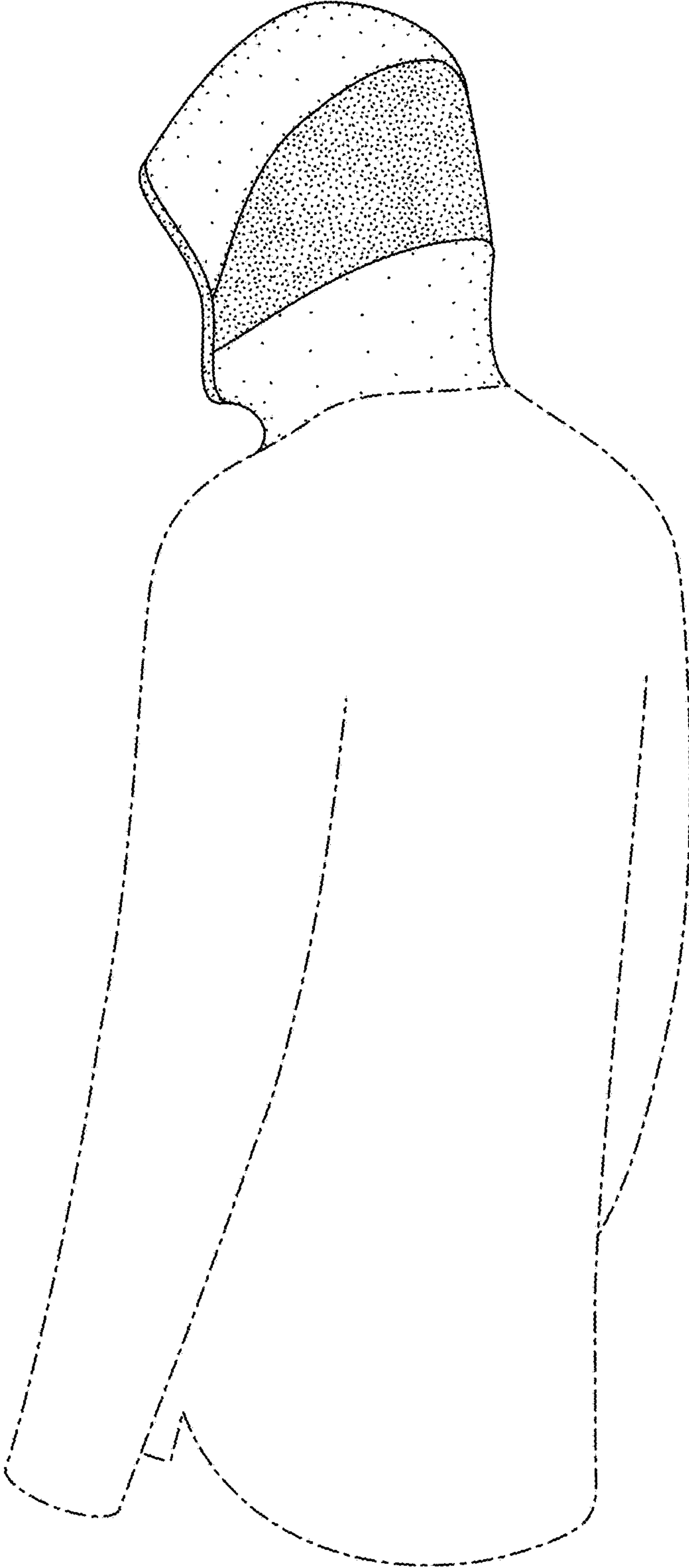

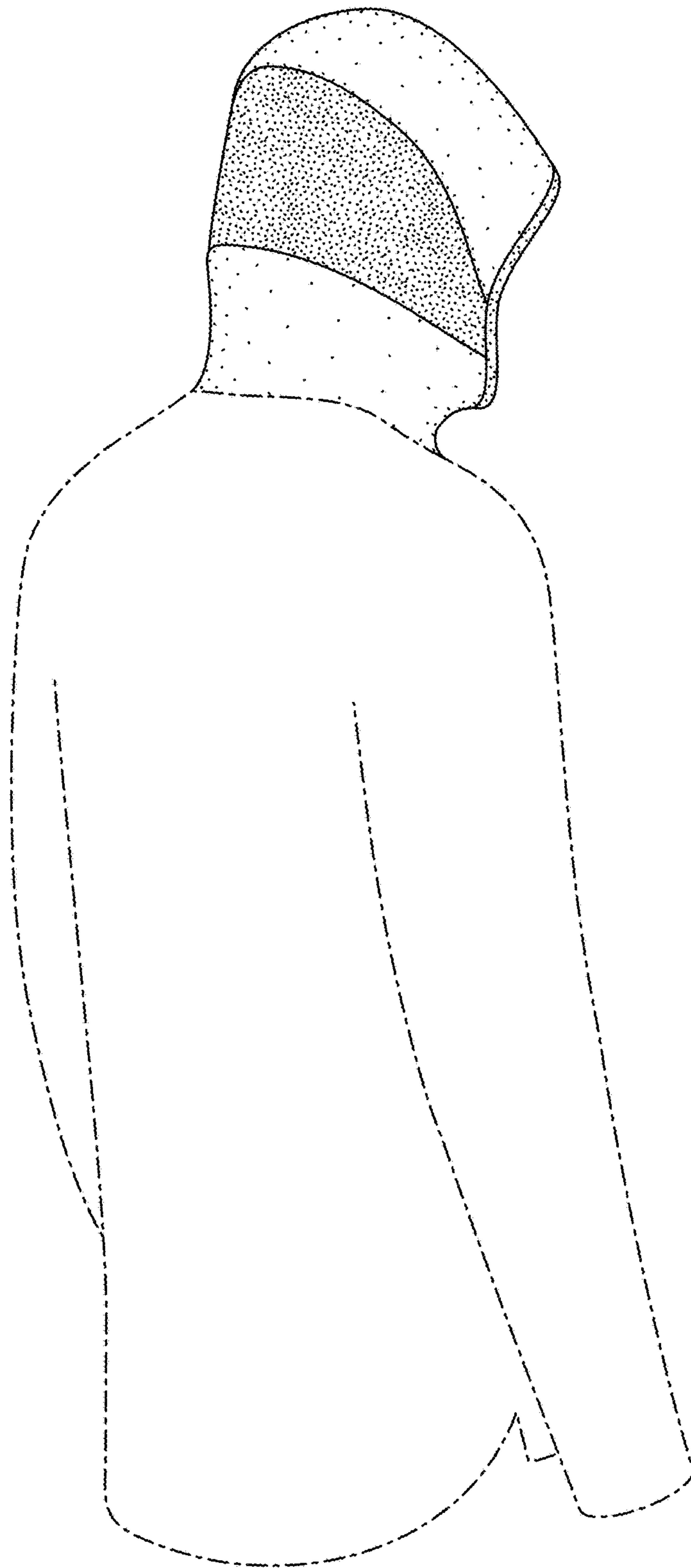

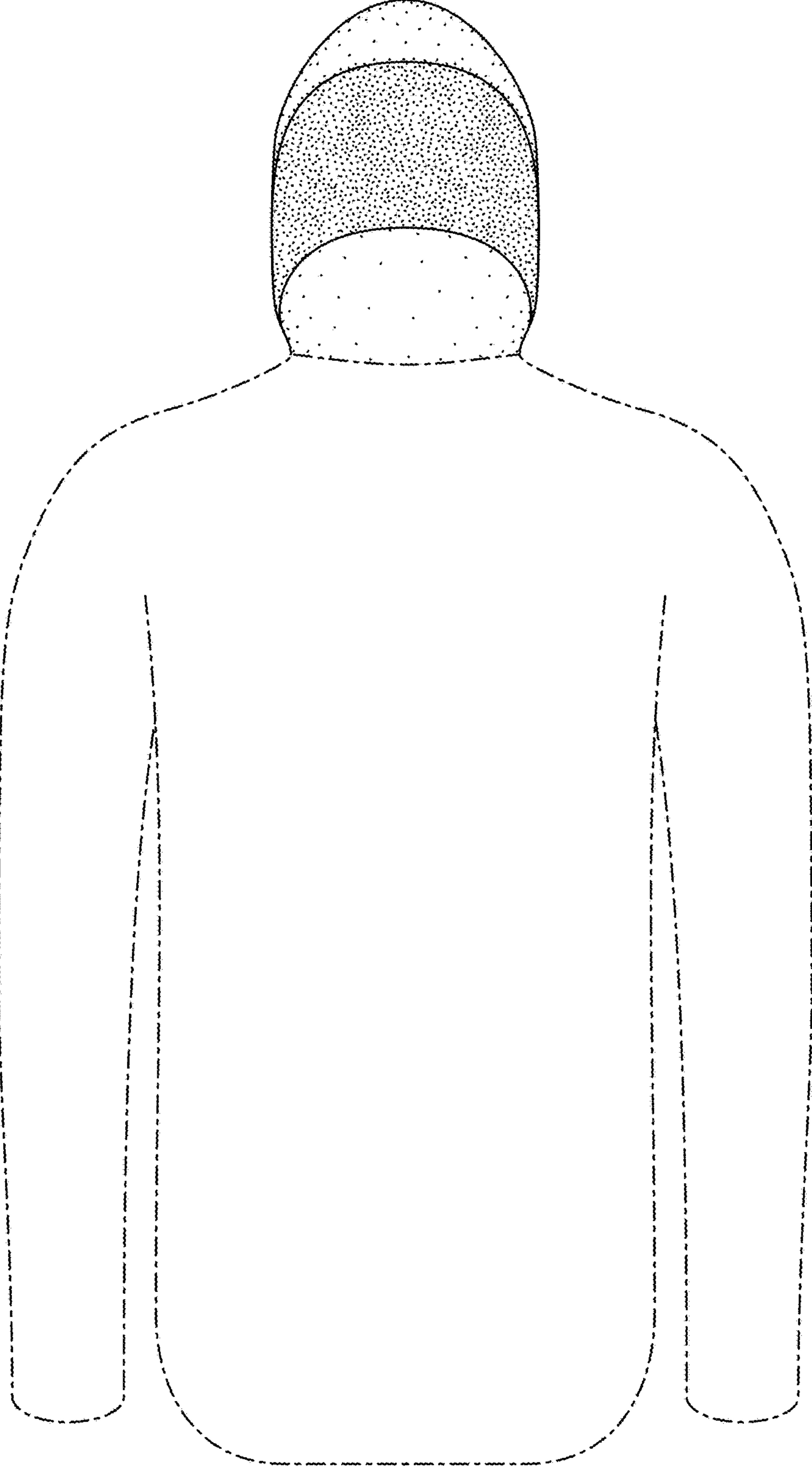

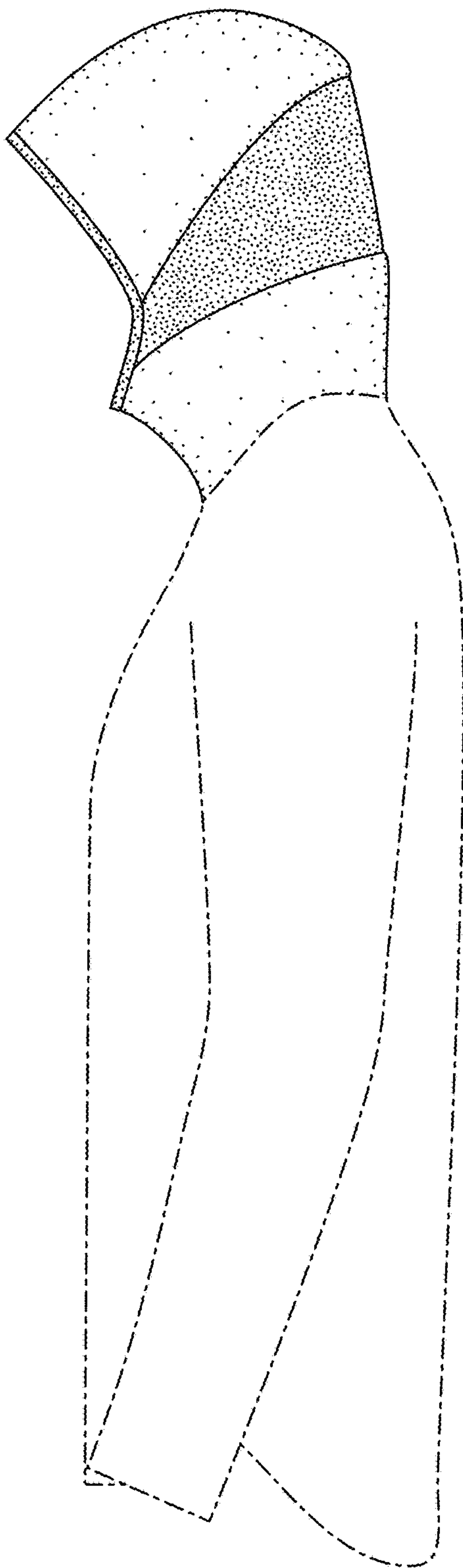

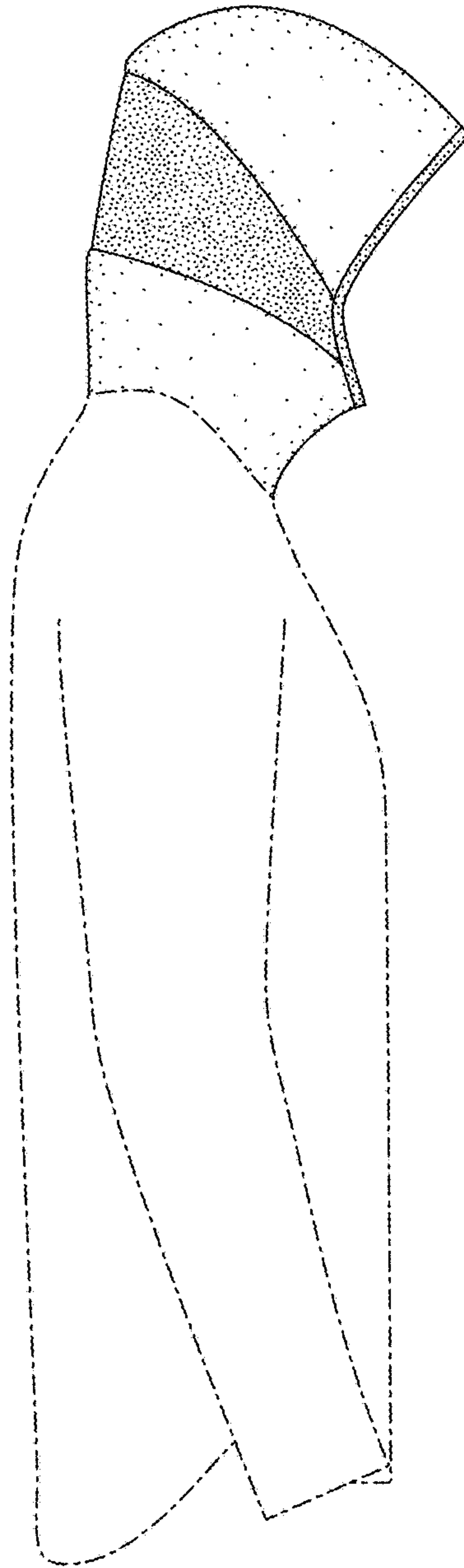
