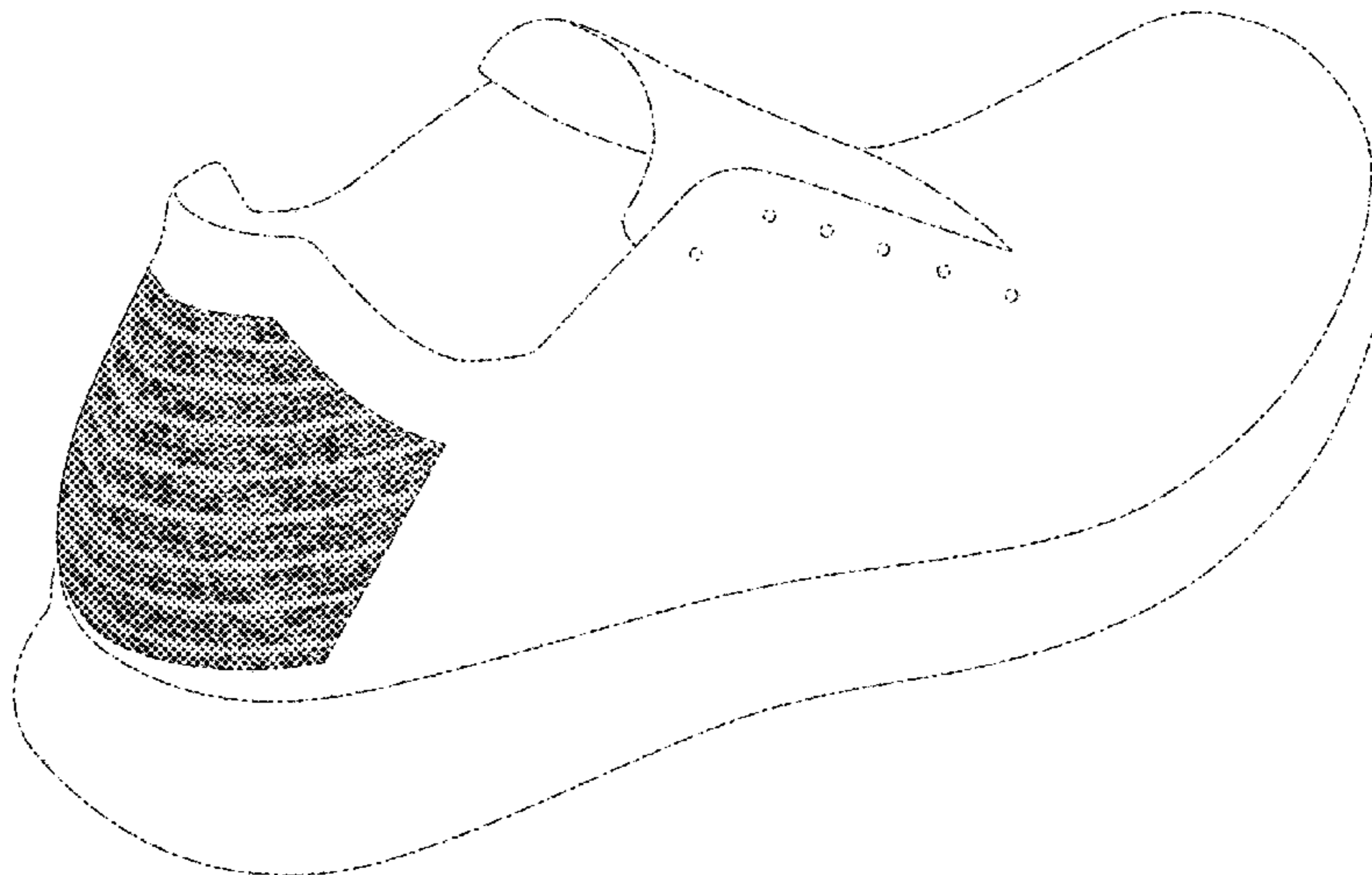
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a shoe upper showing my new design;  
FIG. 2 is a rear view thereof;  
FIG. 3 is a side view thereof; and,  
FIG. 4 is a second side view thereof.  
The broken line immediately surrounding the photographic area represents an unclaimed peripheral boundary of the design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

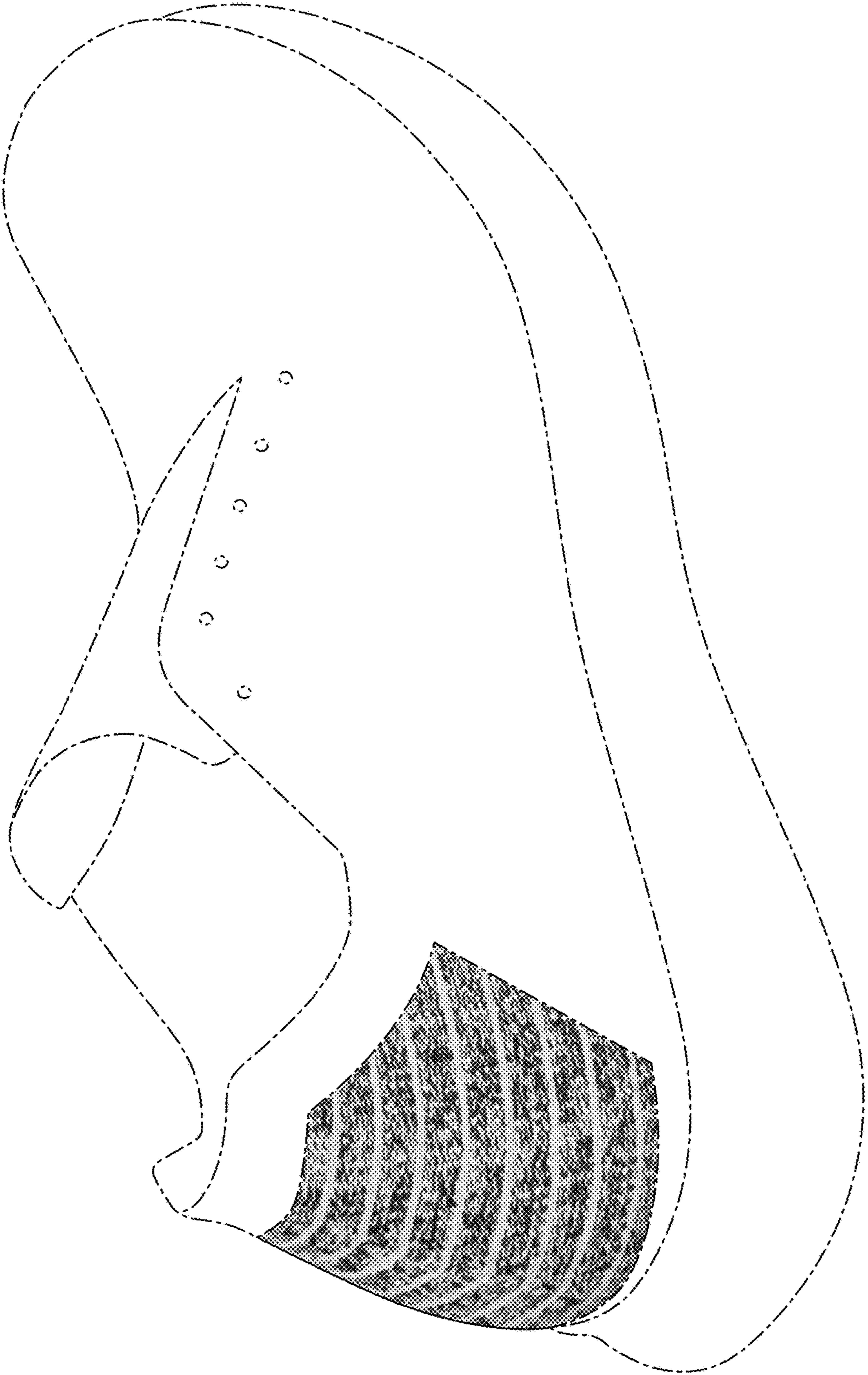

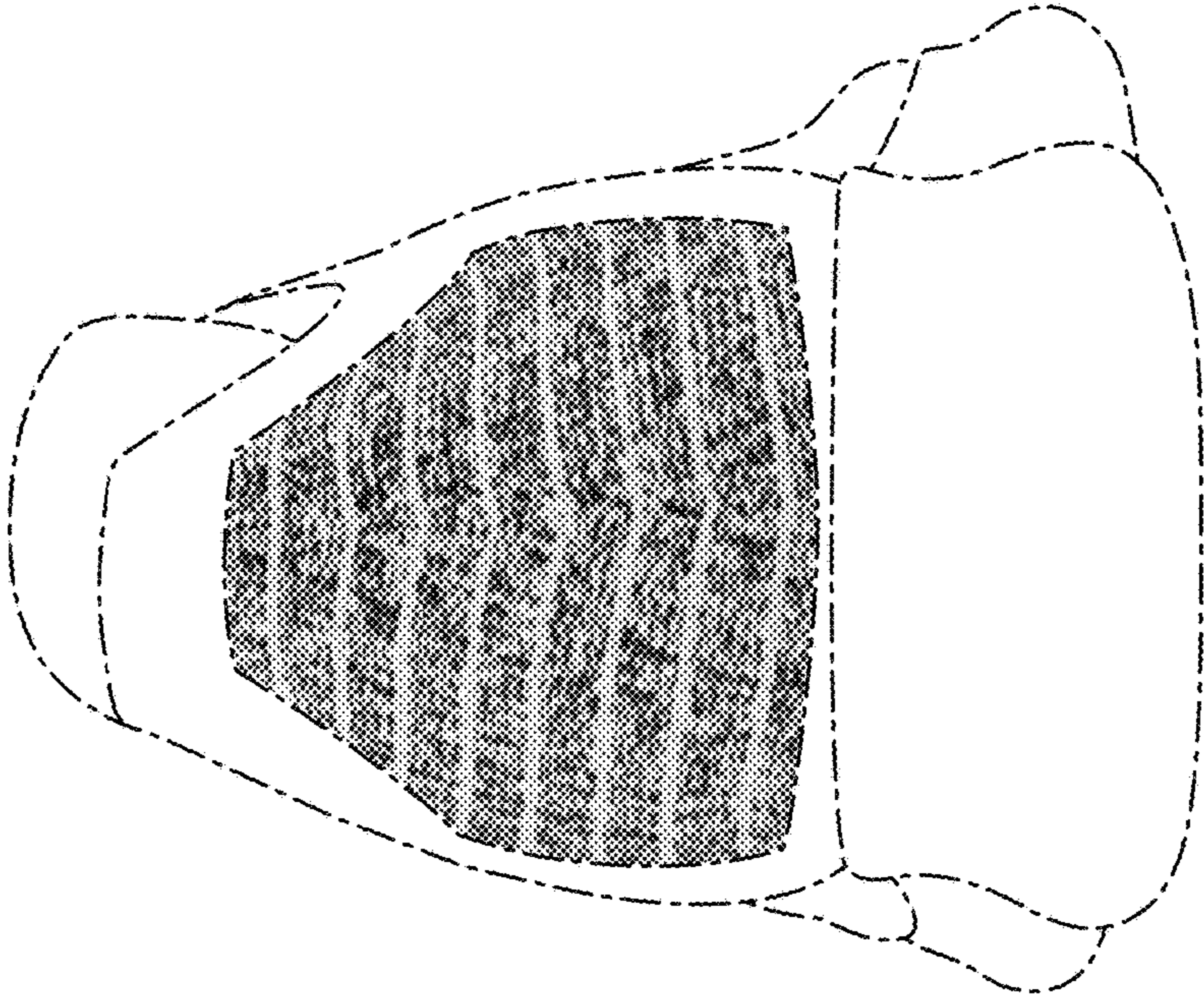

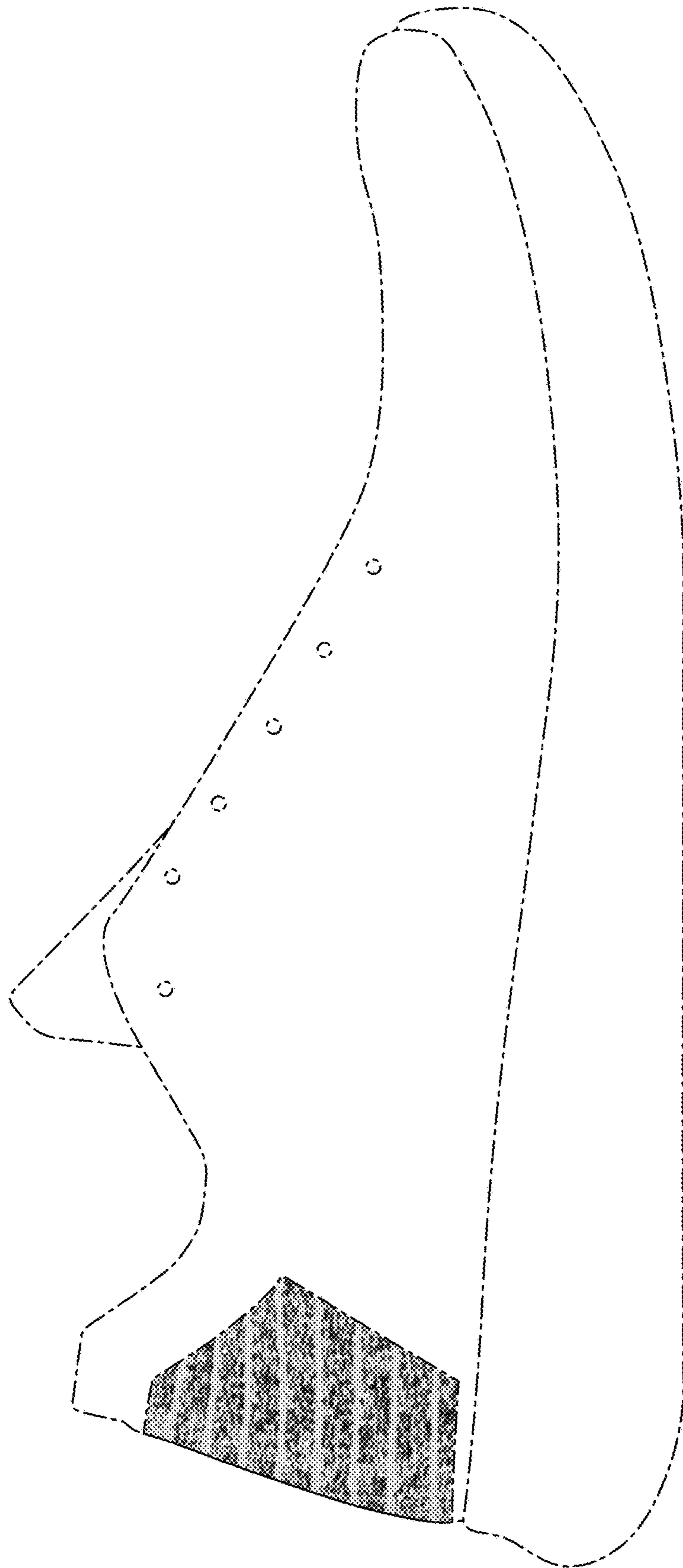

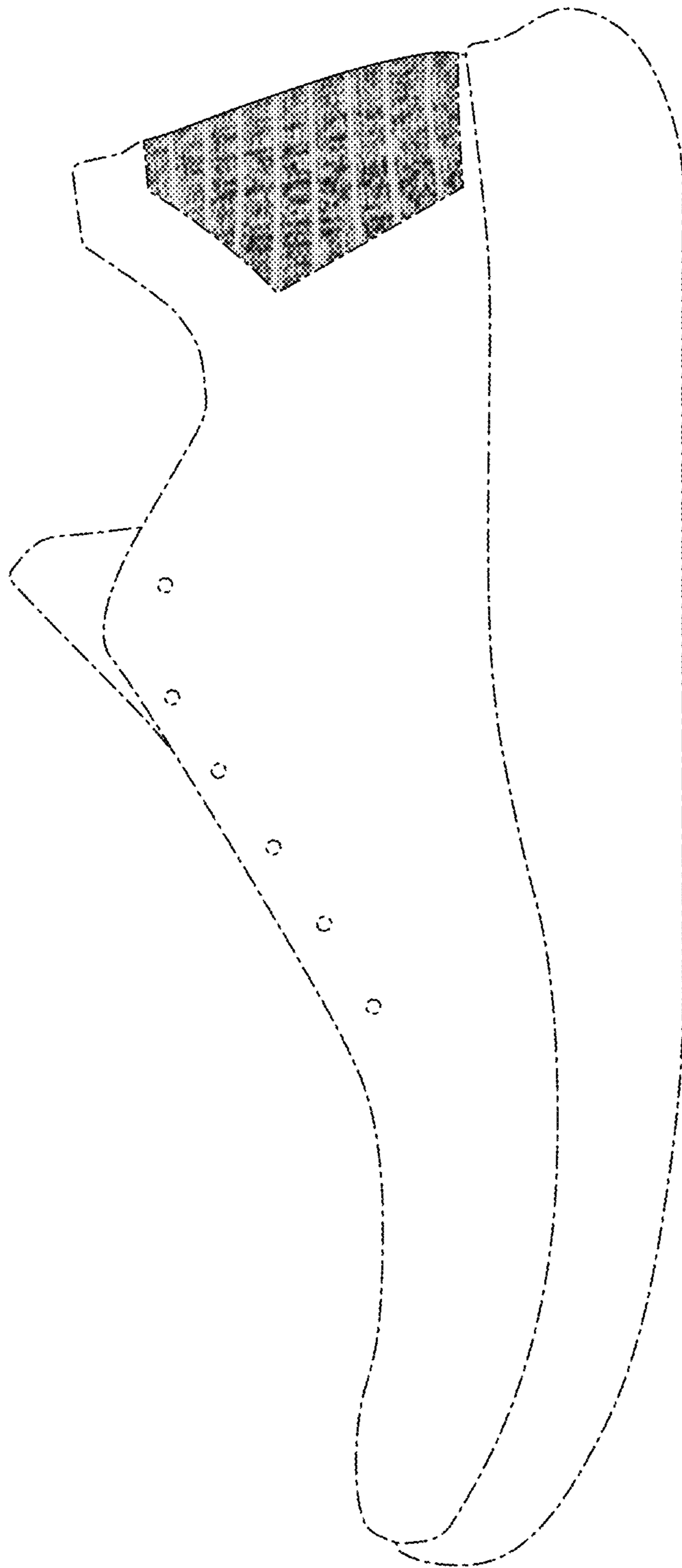
