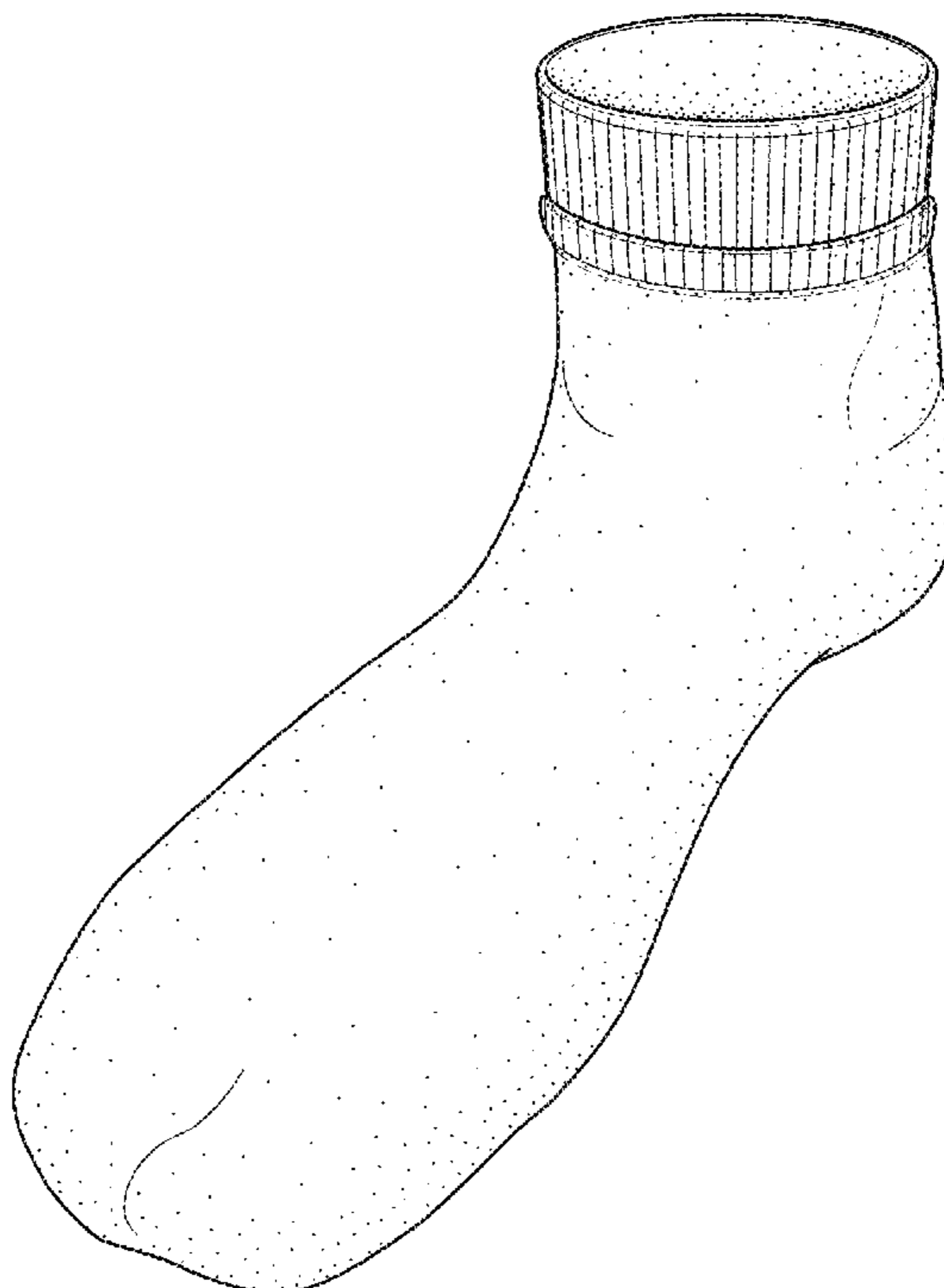

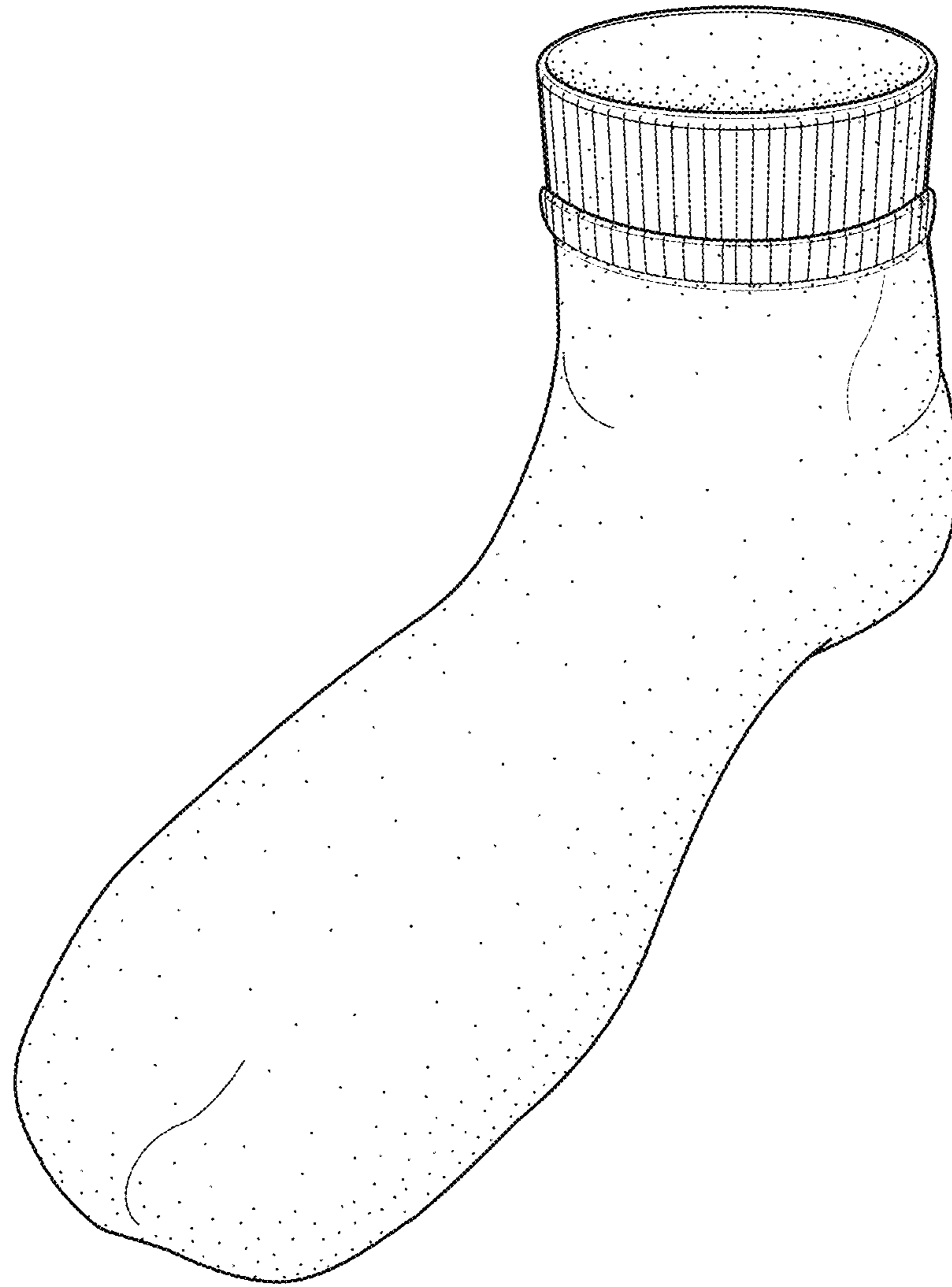
The ornamental design for a double ankle sock, as shown and described.

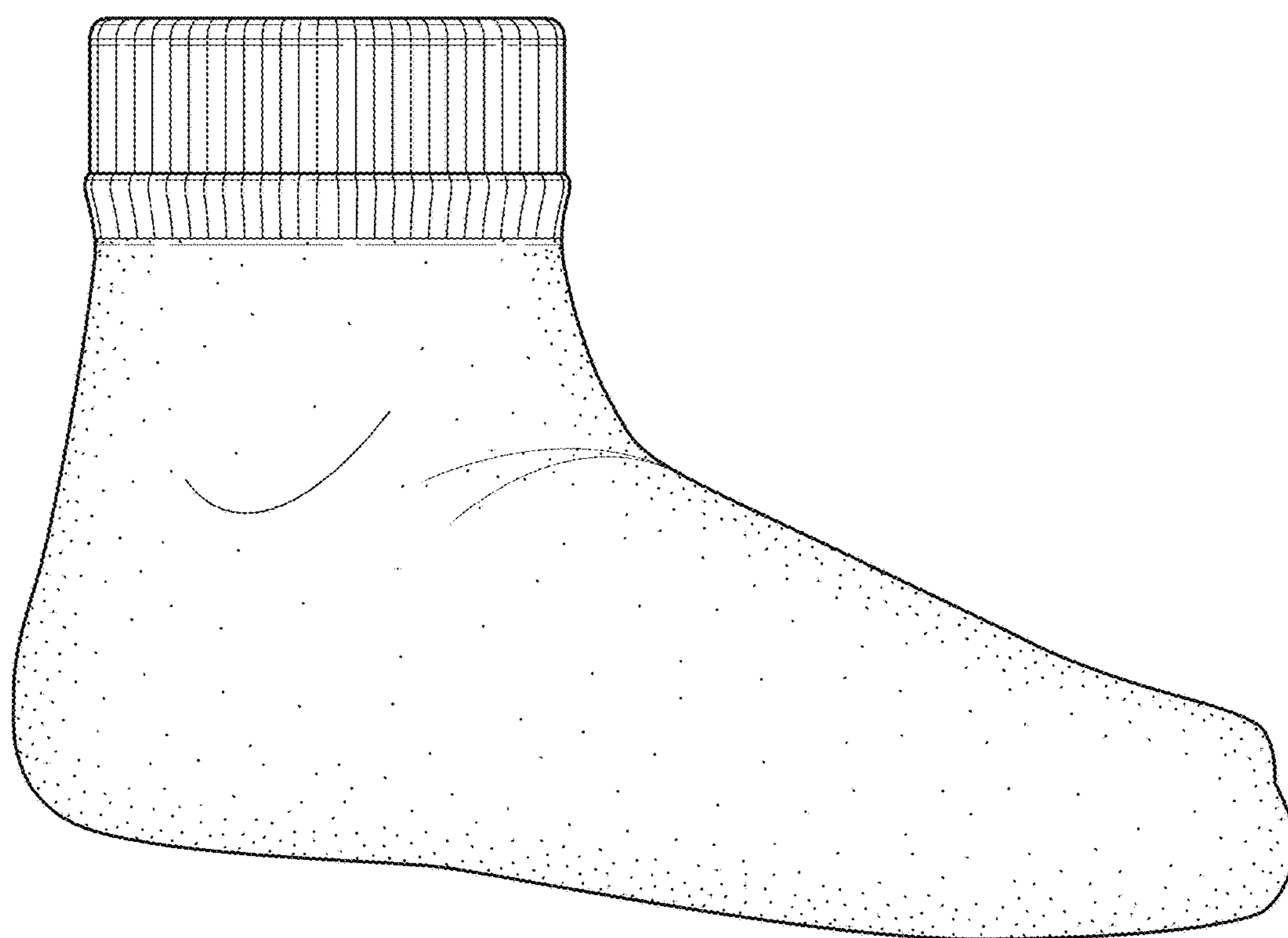

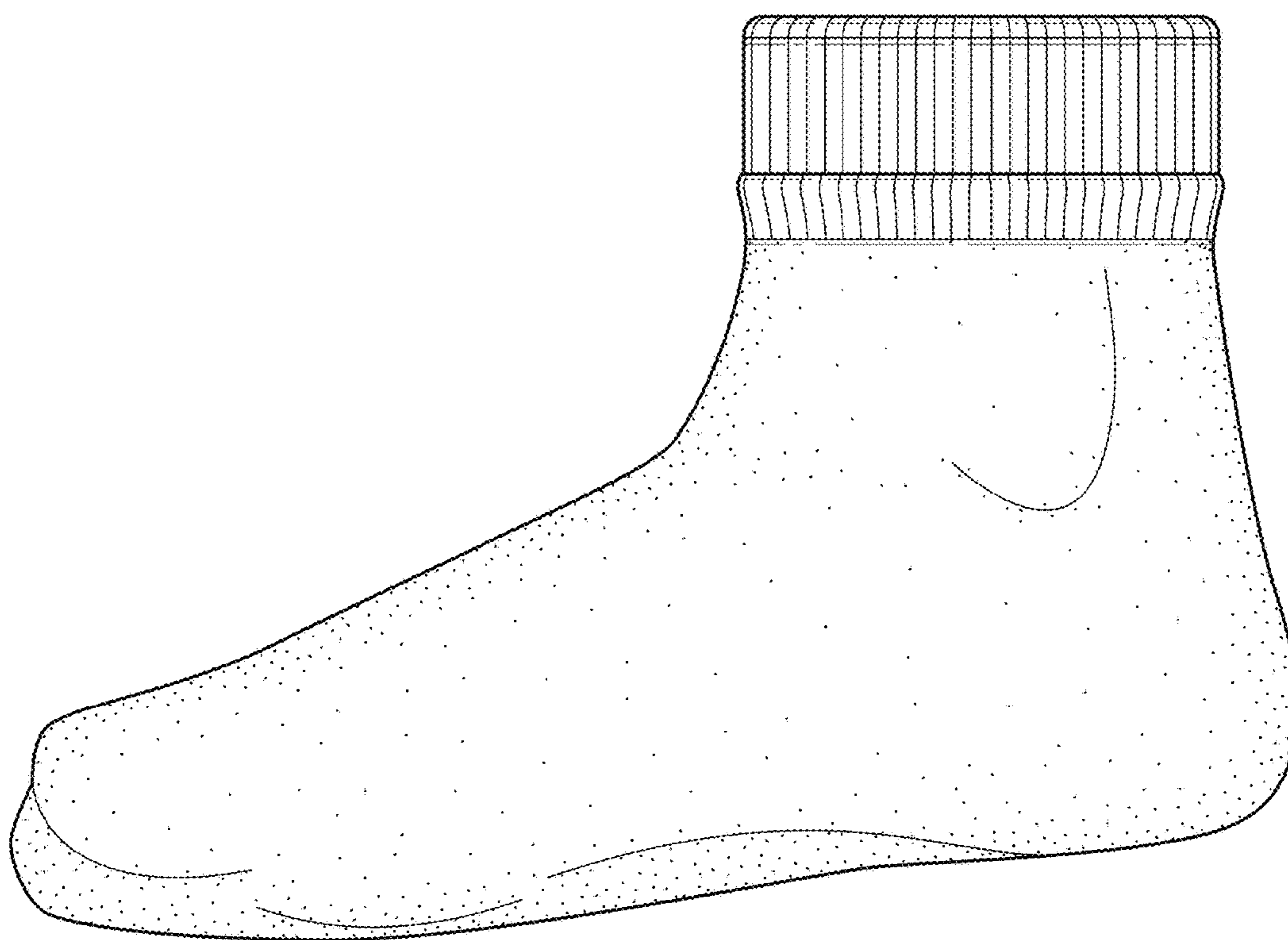

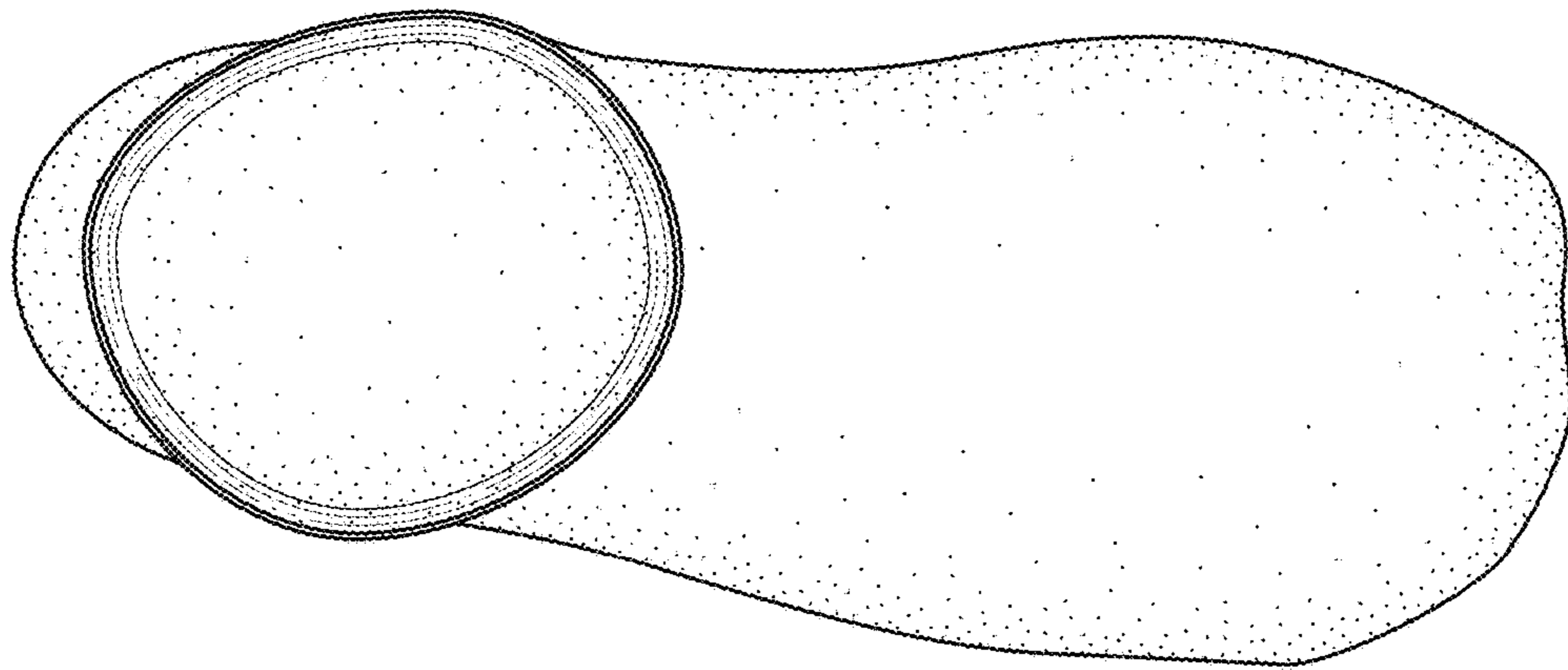

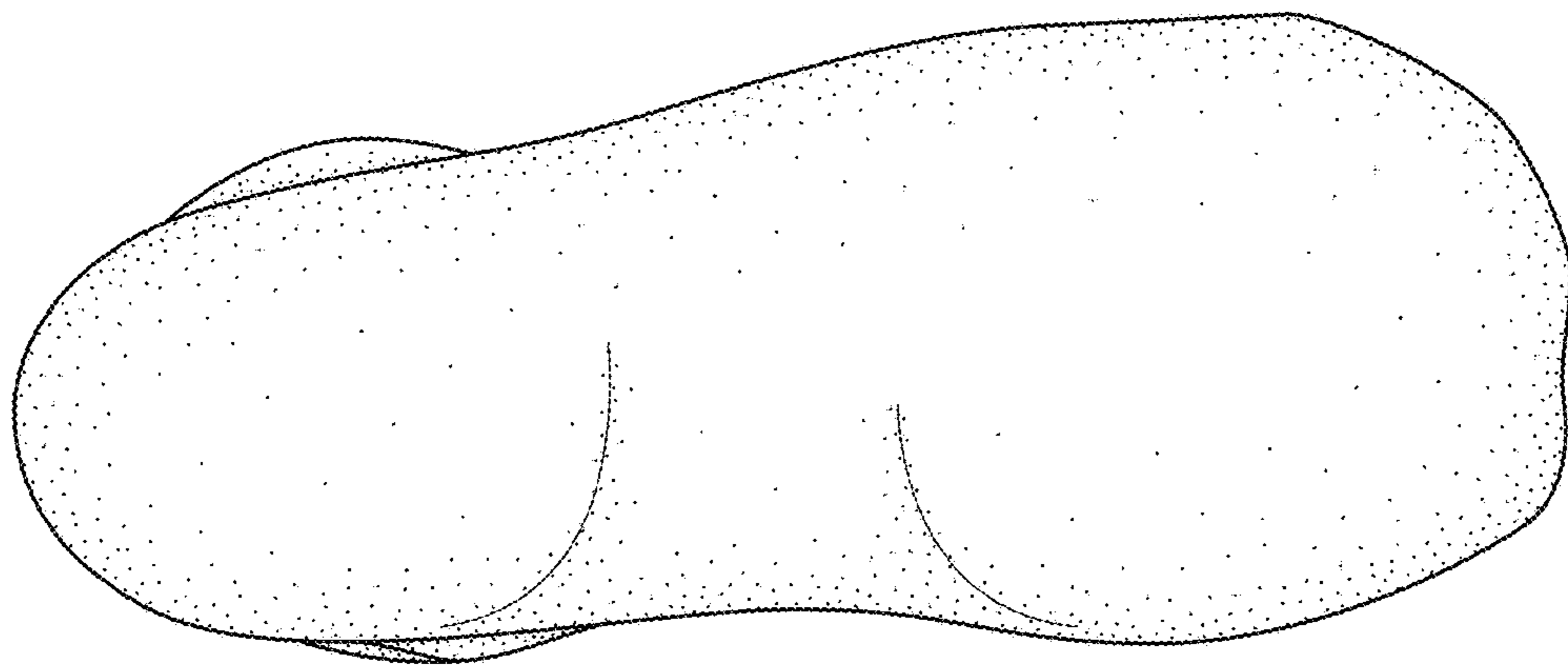

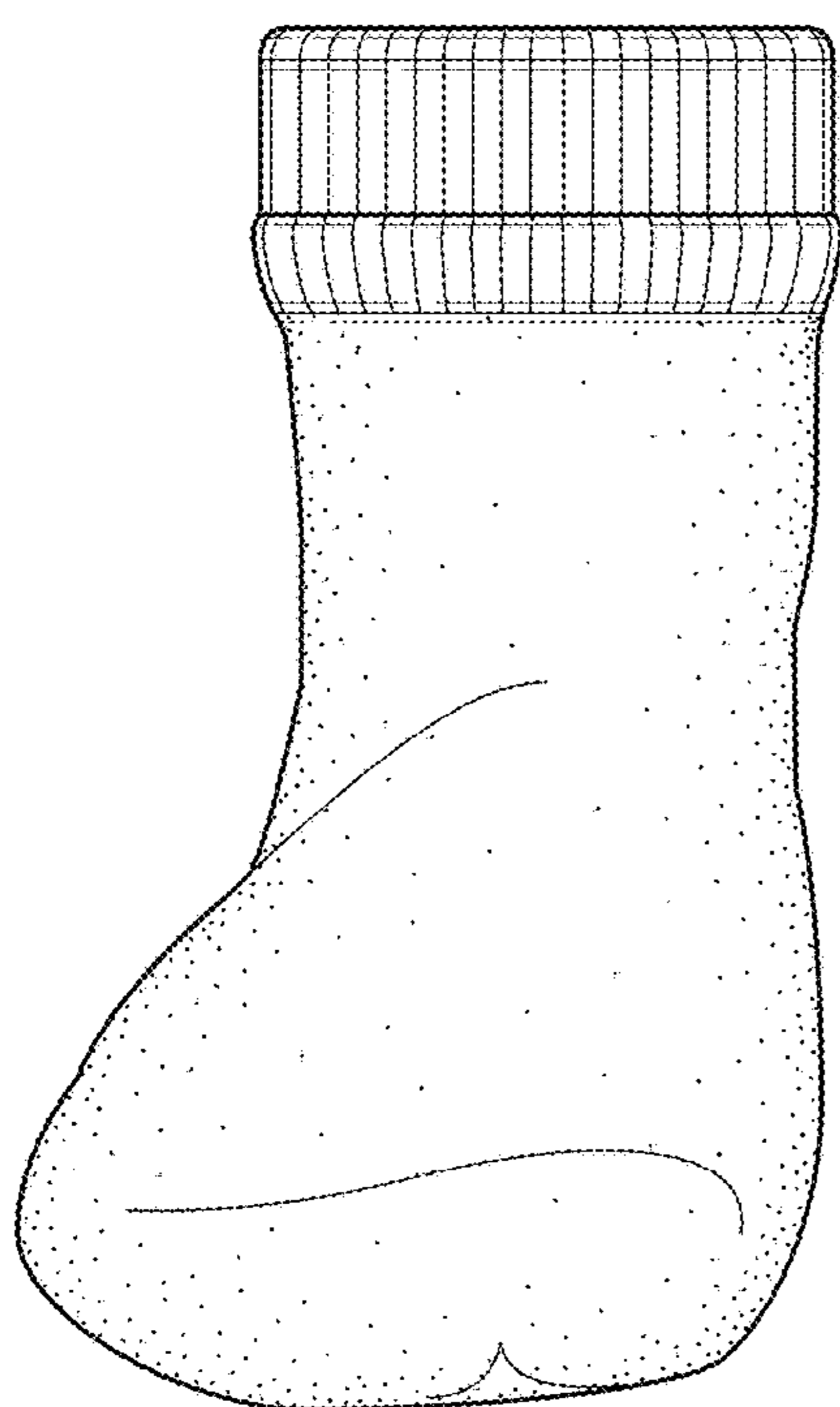

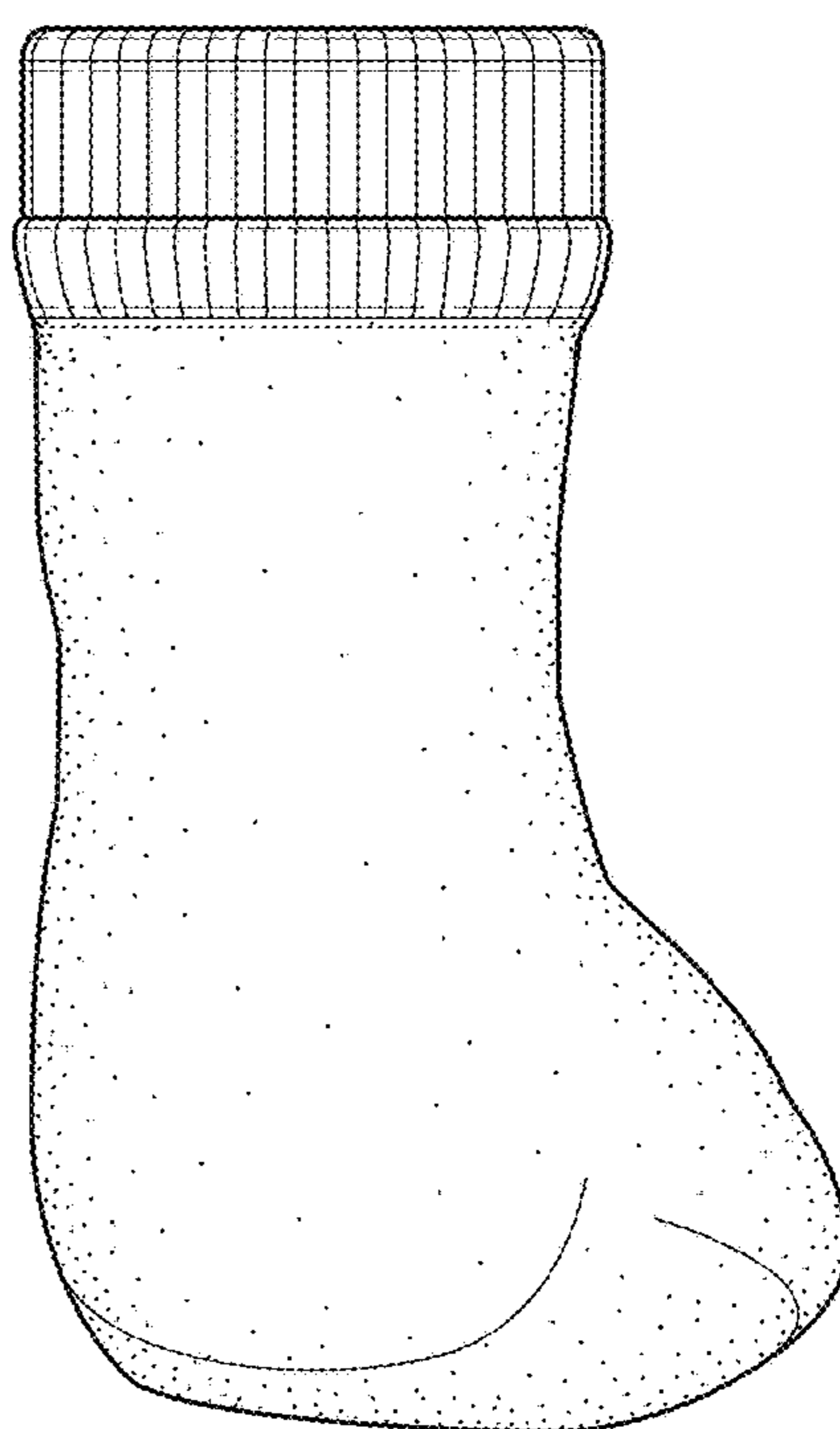
