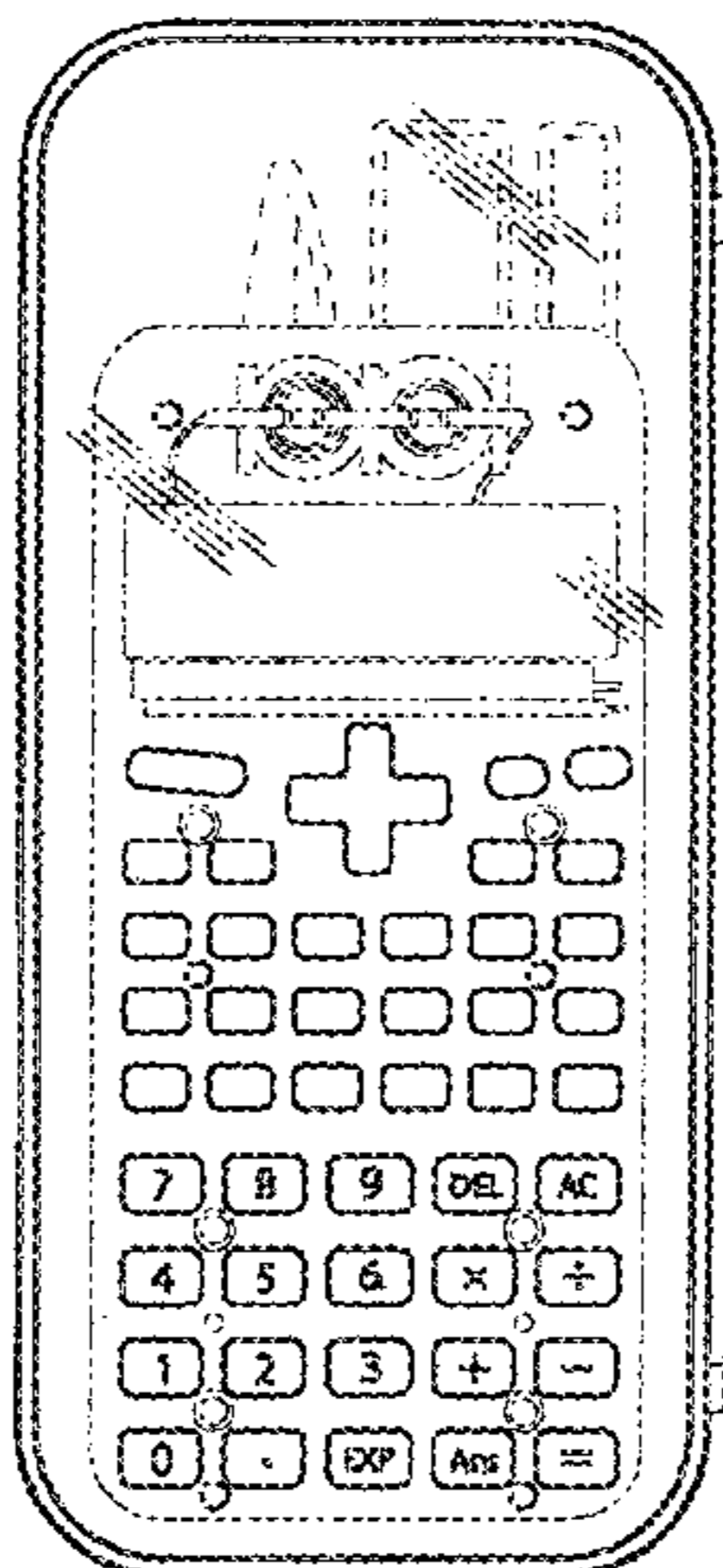
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of an instrument case in accordance with the present invention;  
FIG. 2 is a rear elevational view of the instrument case illustrated in FIG. 1;  
FIG. 3 is a right side elevational view of the instrument case illustrated in FIG. 1;  
FIG. 4 is a left side elevational view of the instrument case illustrated in FIG. 1;  
FIG. 5 is a top plan view of the instrument case illustrated in FIG. 1;  
FIG. 6 is a bottom plan view of the instrument case illustrated in FIG. 1; and,

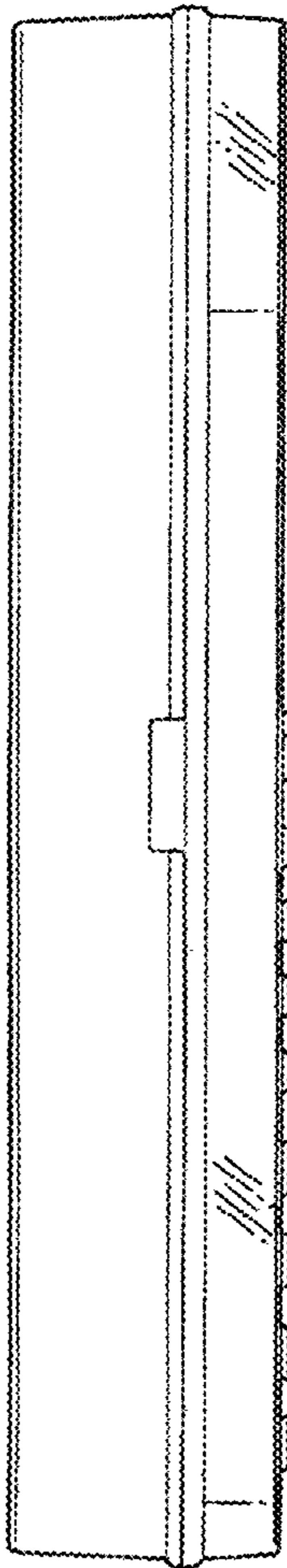

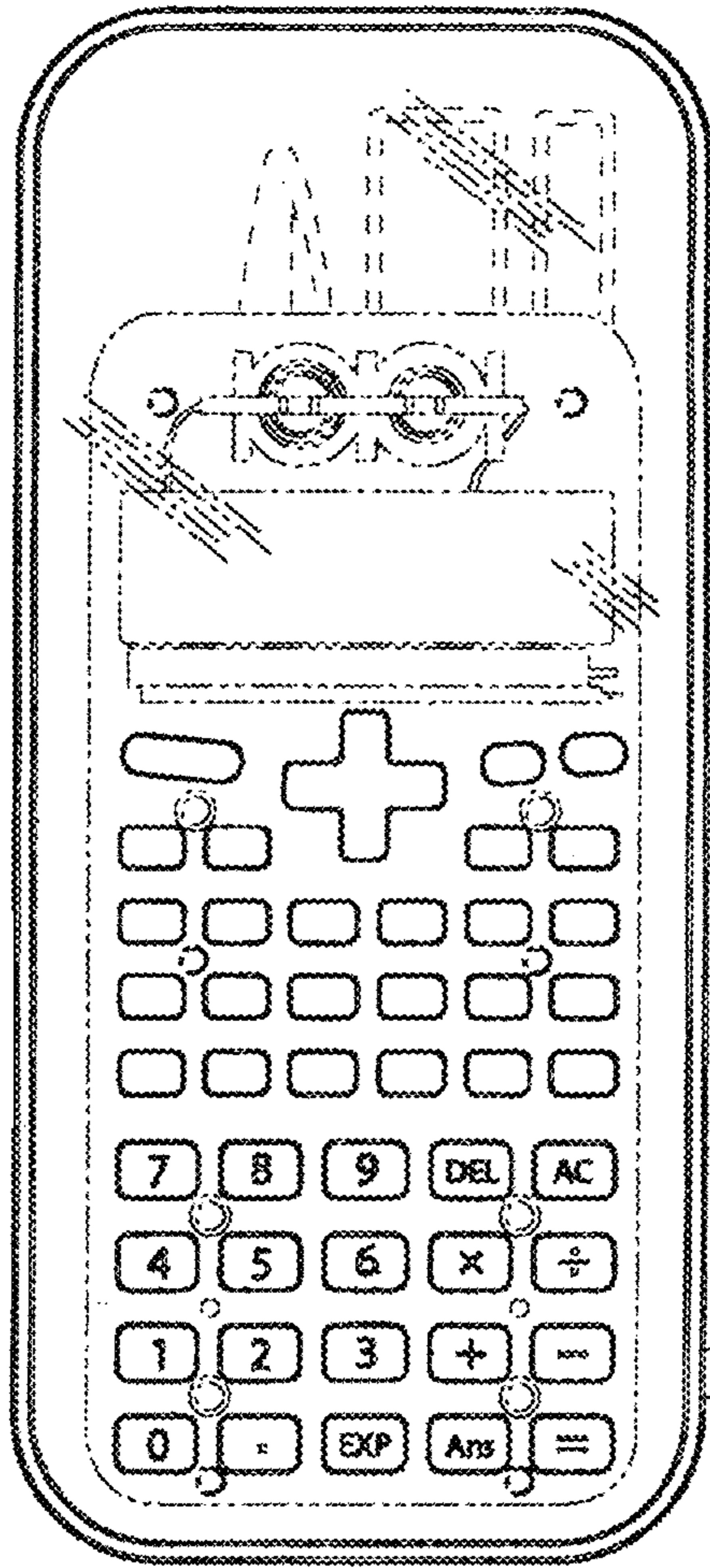

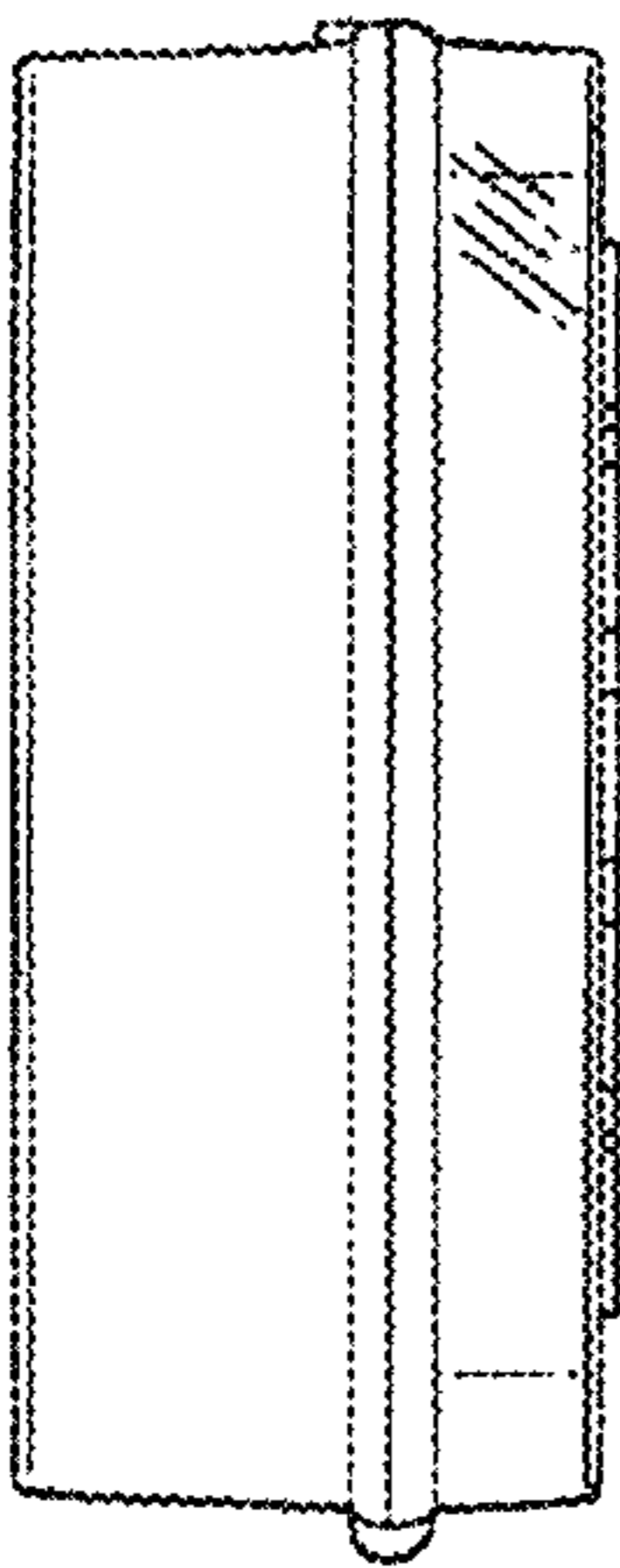

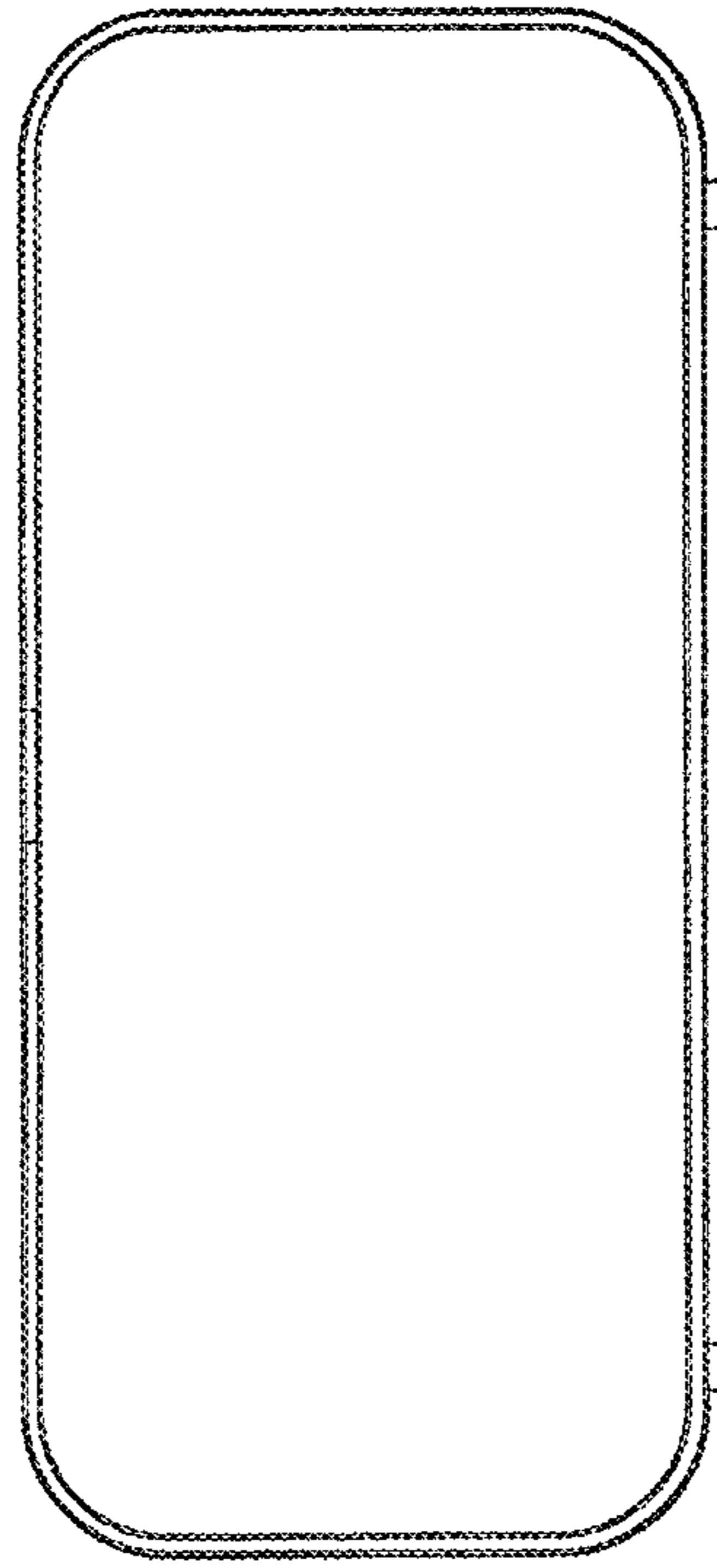

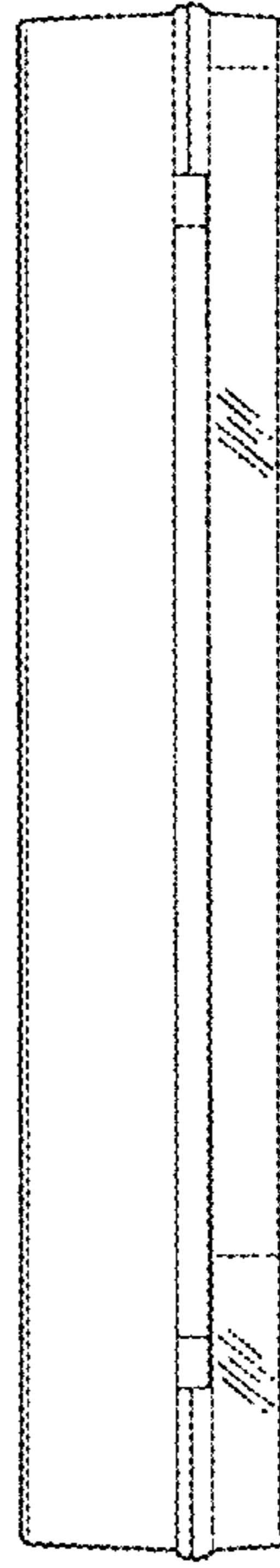

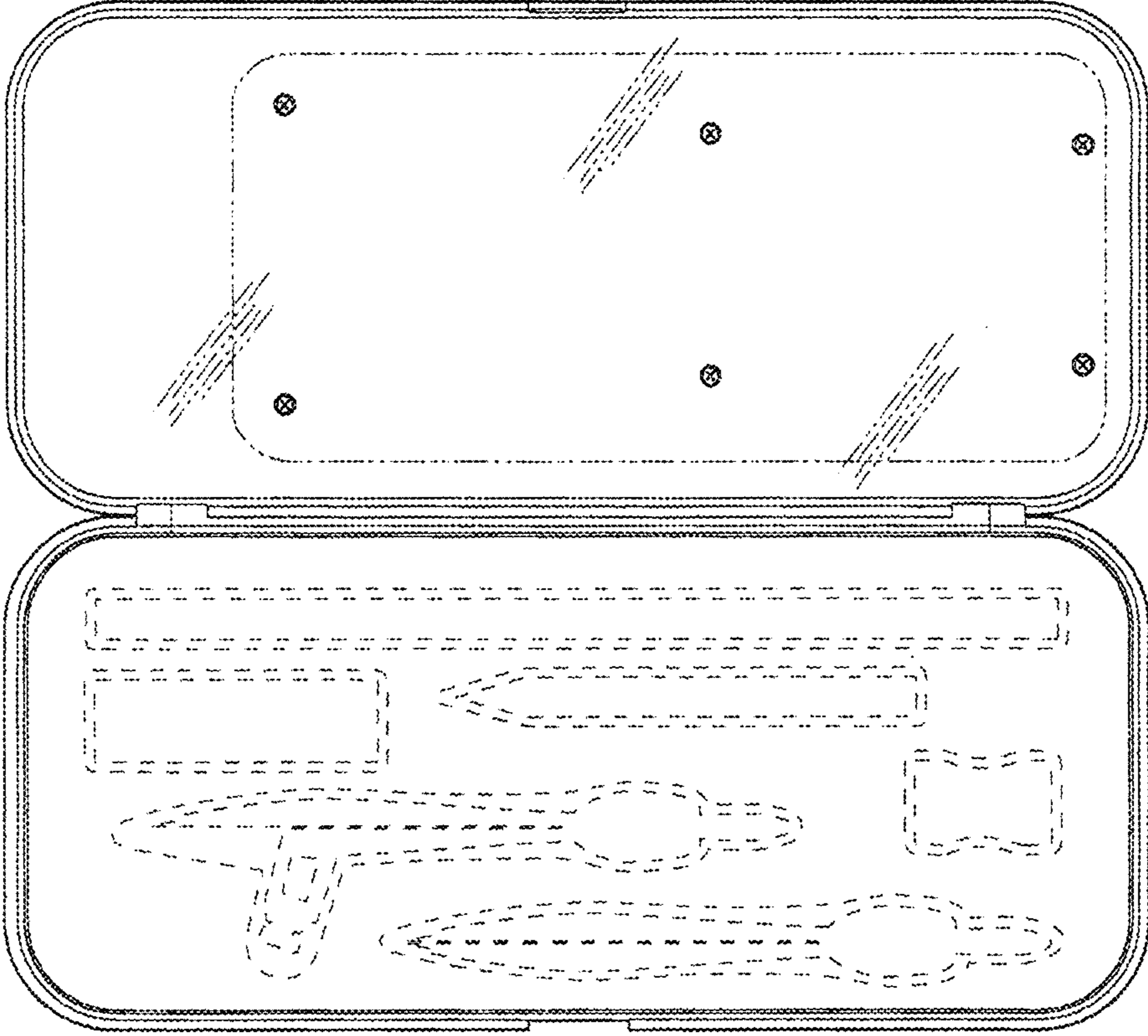
