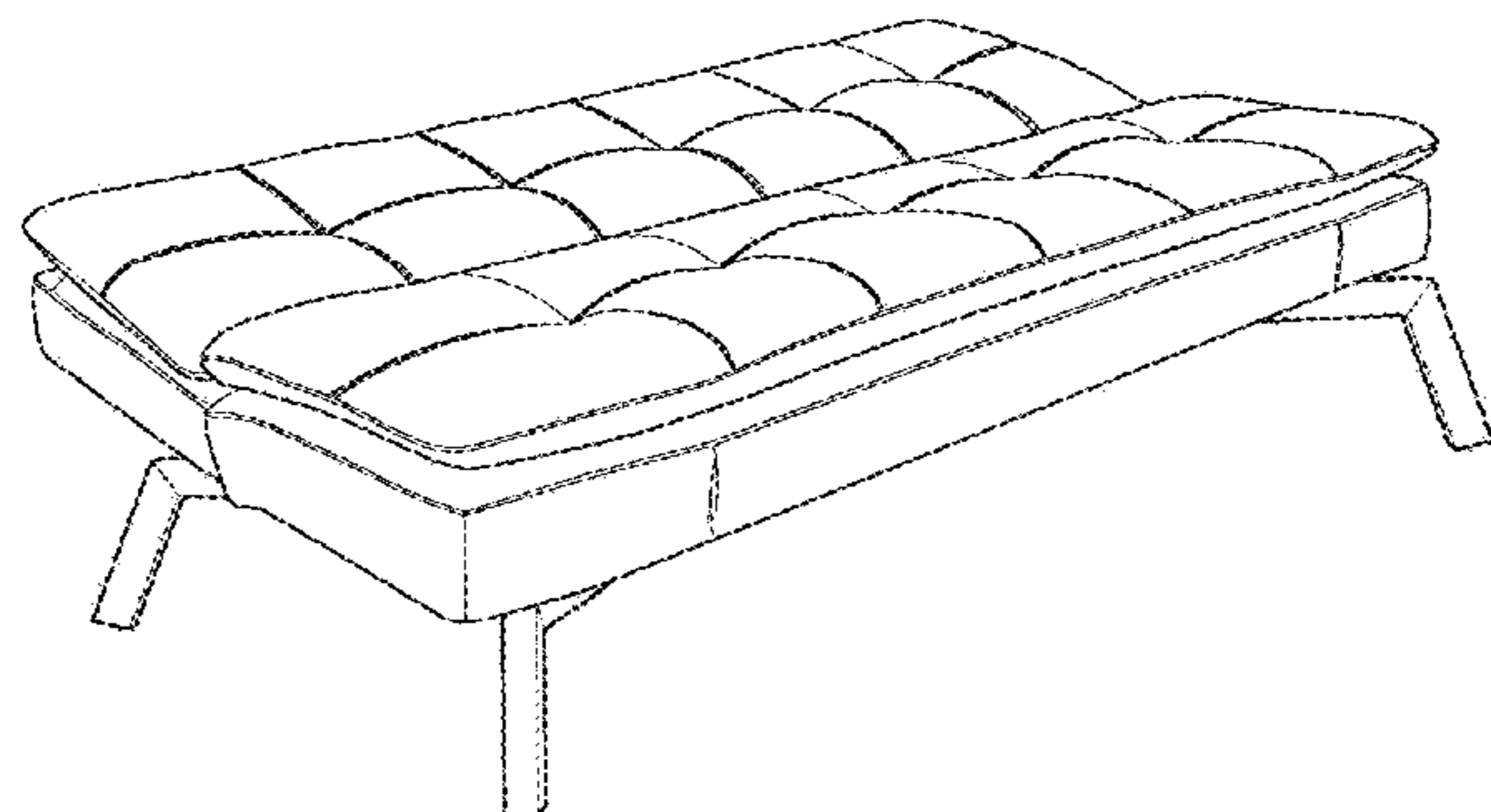
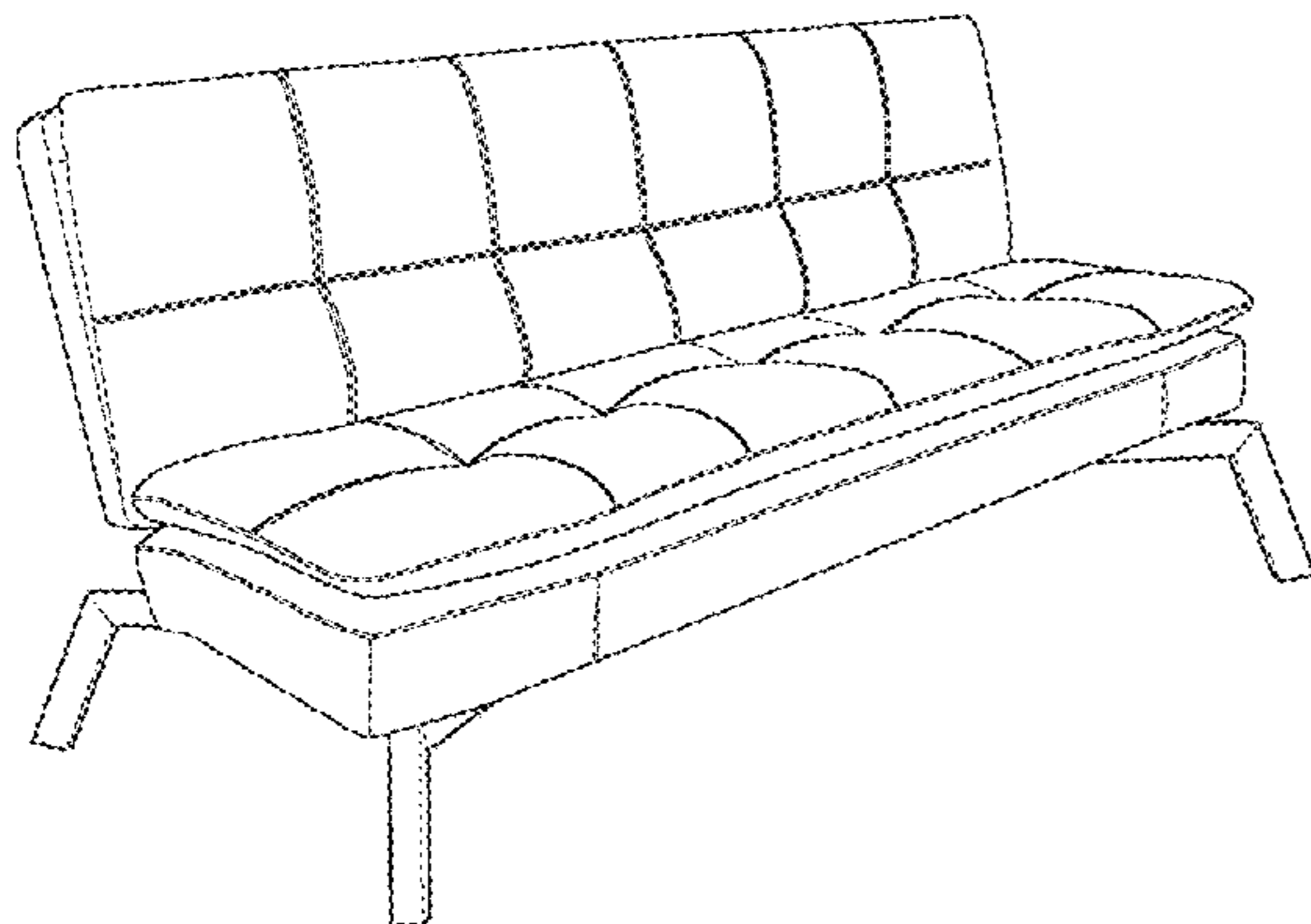
(57) **CLAIM**

The ornamental design for a convertible sofa bed, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the convertible sofa bed;  
FIG. 2 is a side view of the convertible sofa bed;  
FIG. 3 is a perspective view of the convertible sofa bed in a sofa position;  
FIG. 4 is a perspective view of the convertible sofa bed in a bed position;  
FIG. 5 is a perspective view of the convertible sofa bed in a lounge position; and,  
FIG. 6 is a perspective view of the convertible sofa bed in a sofa position with the sofa bed arms in a raised position.

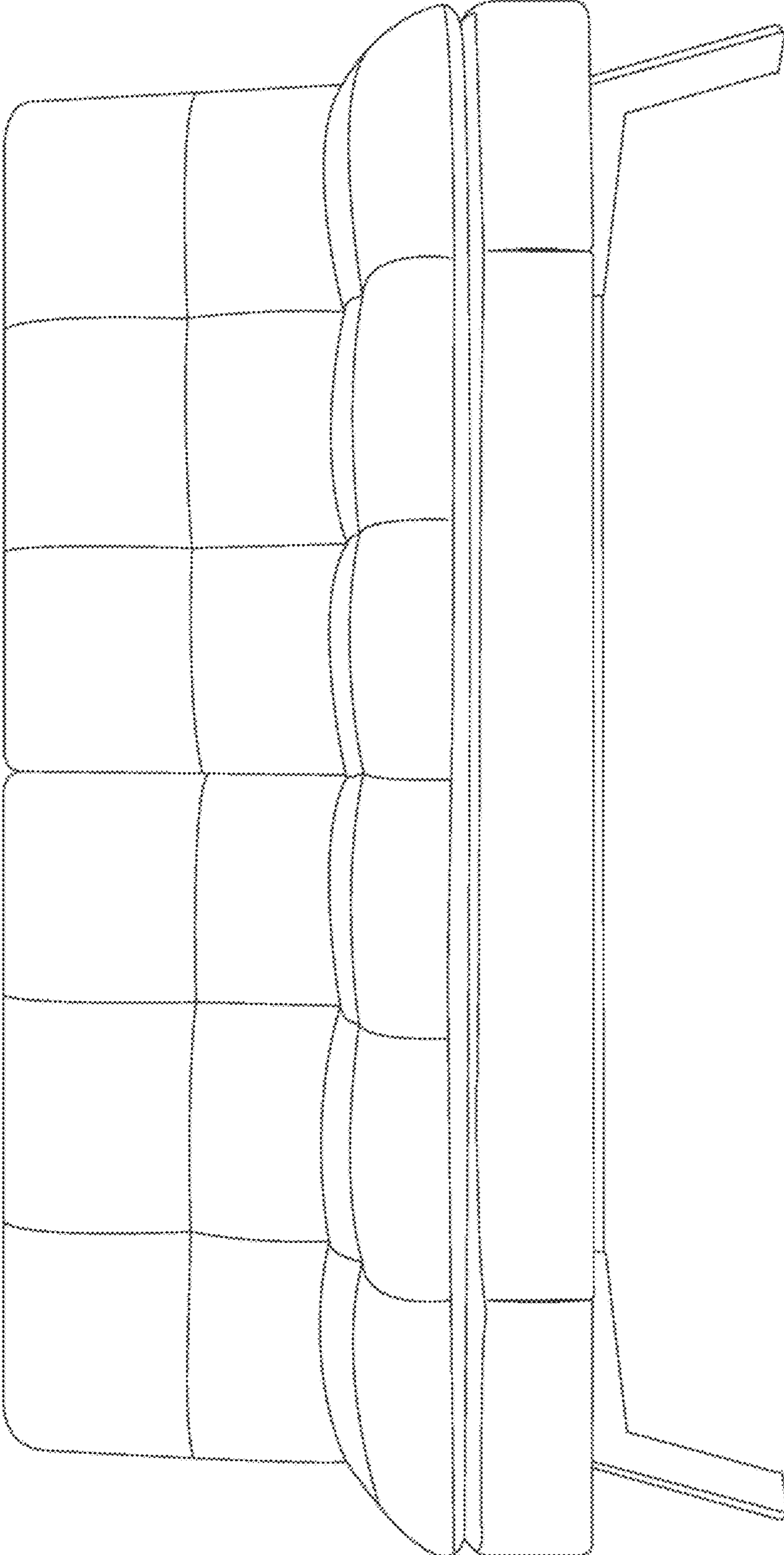

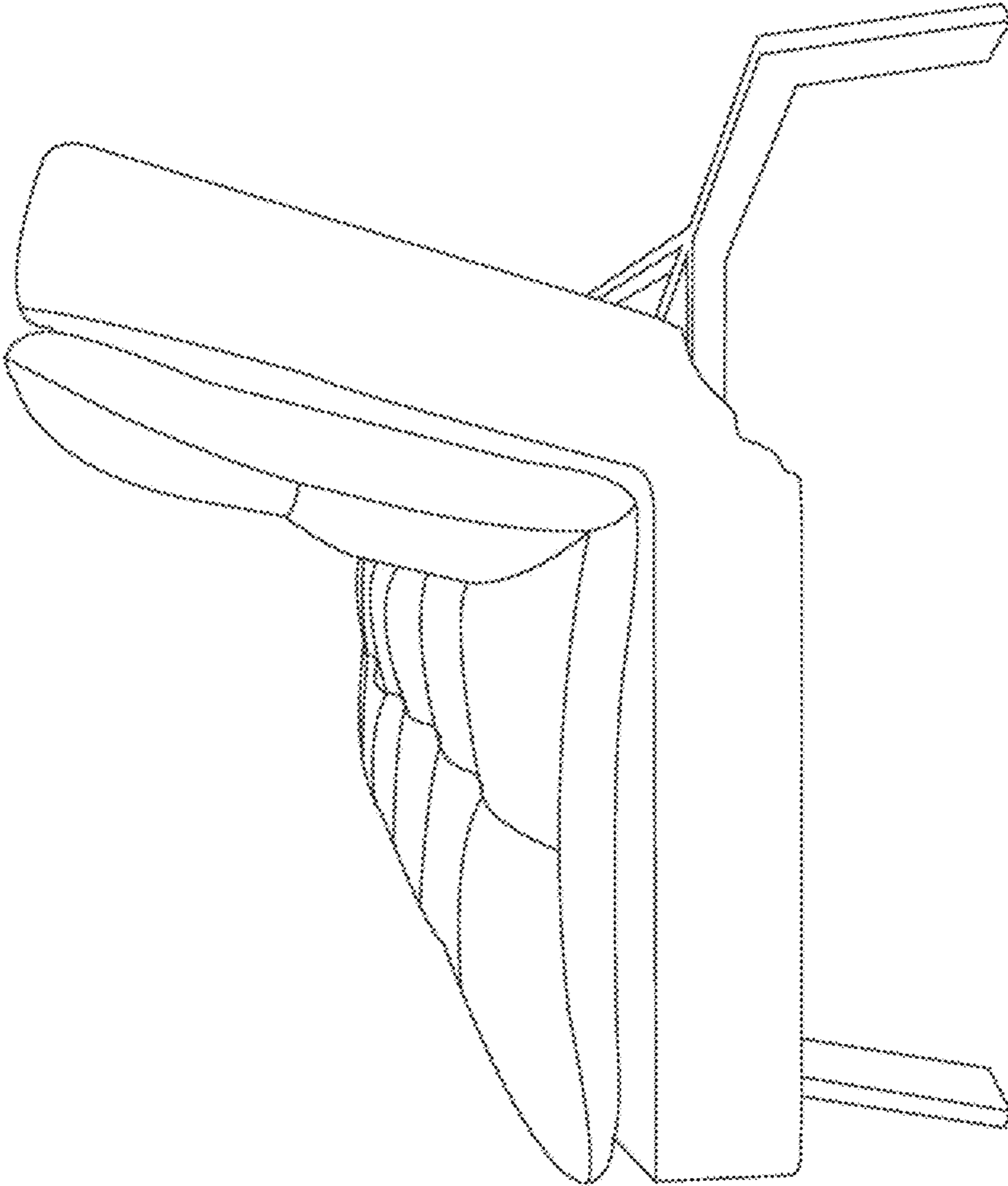

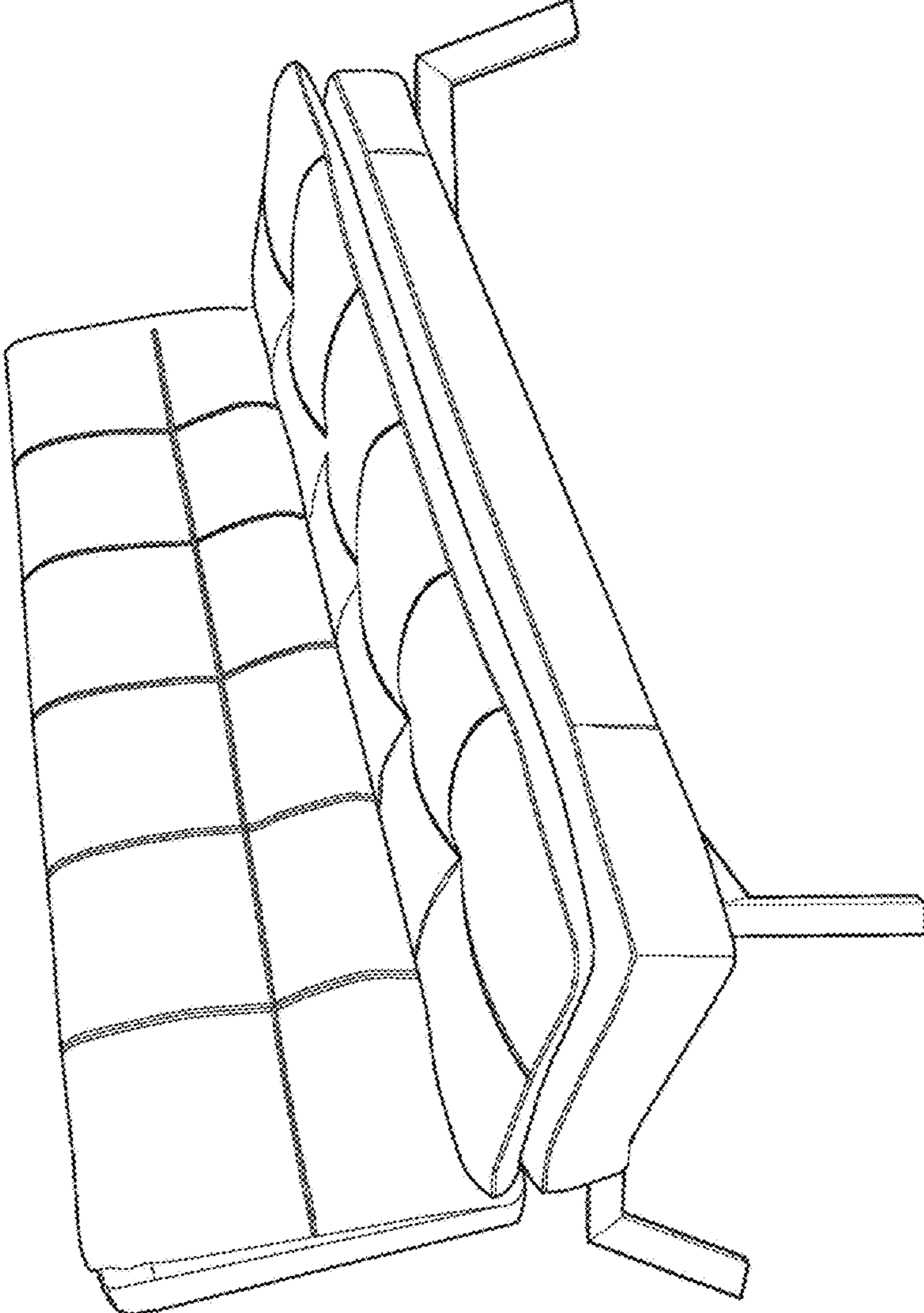

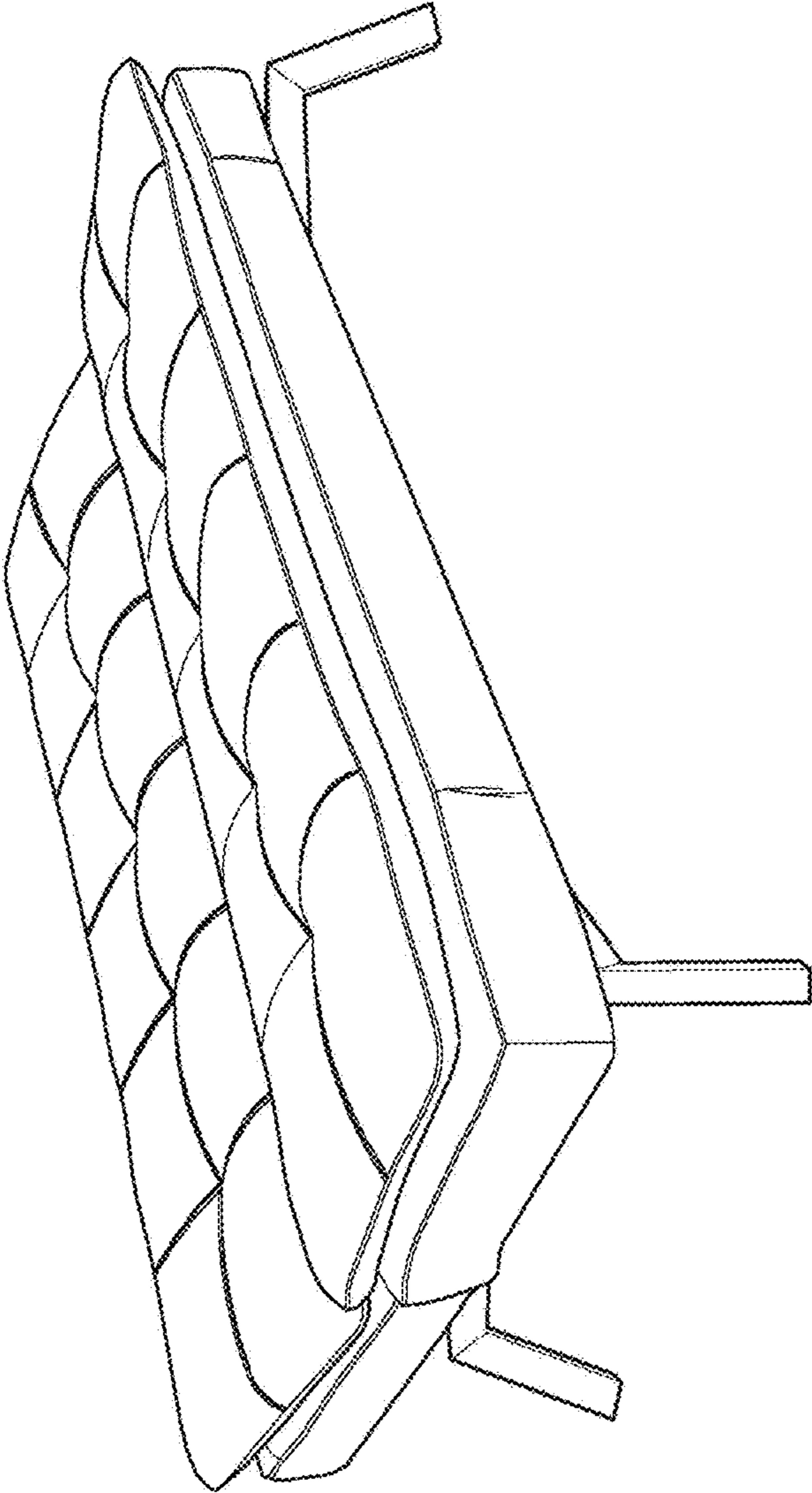

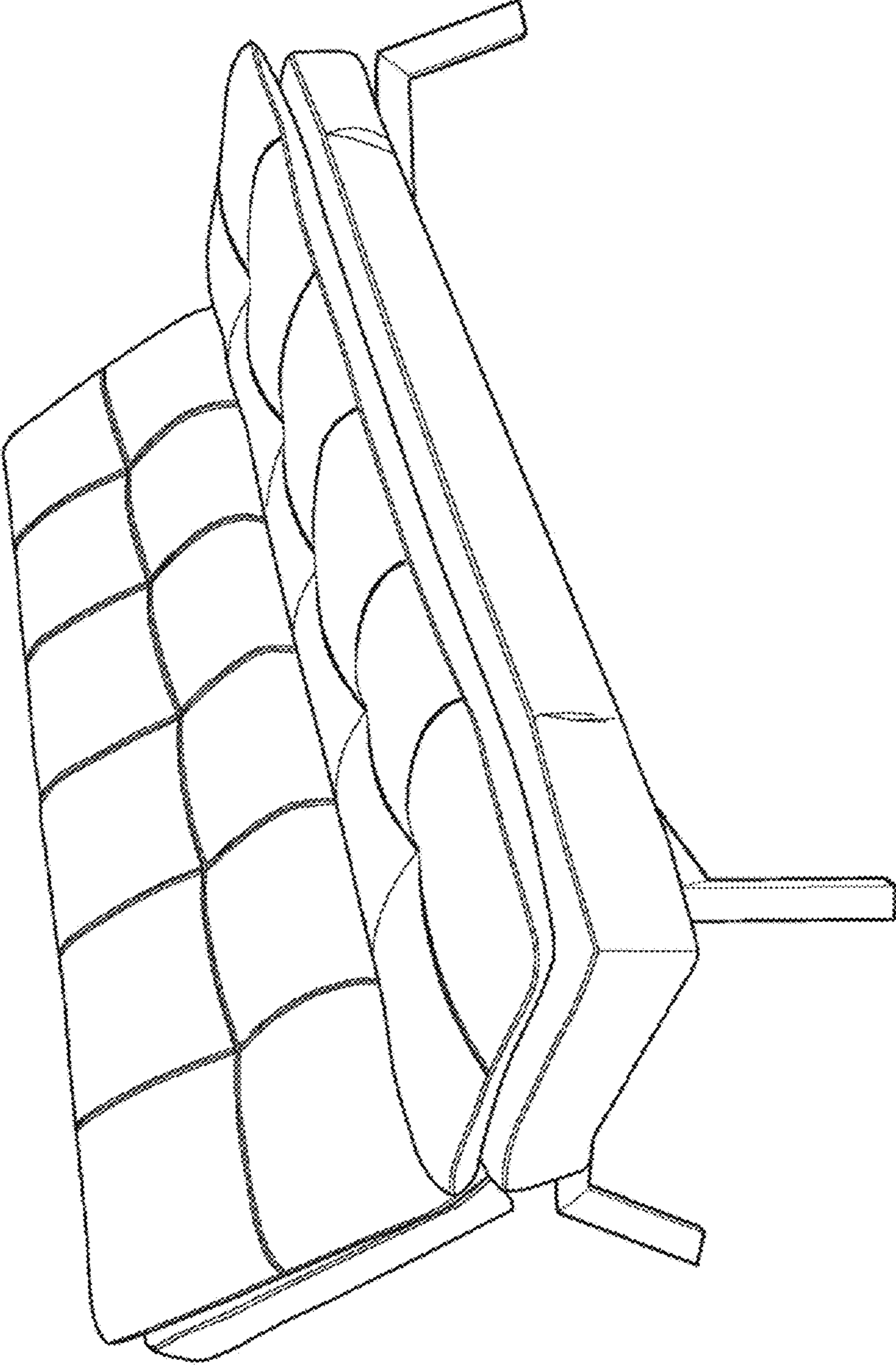

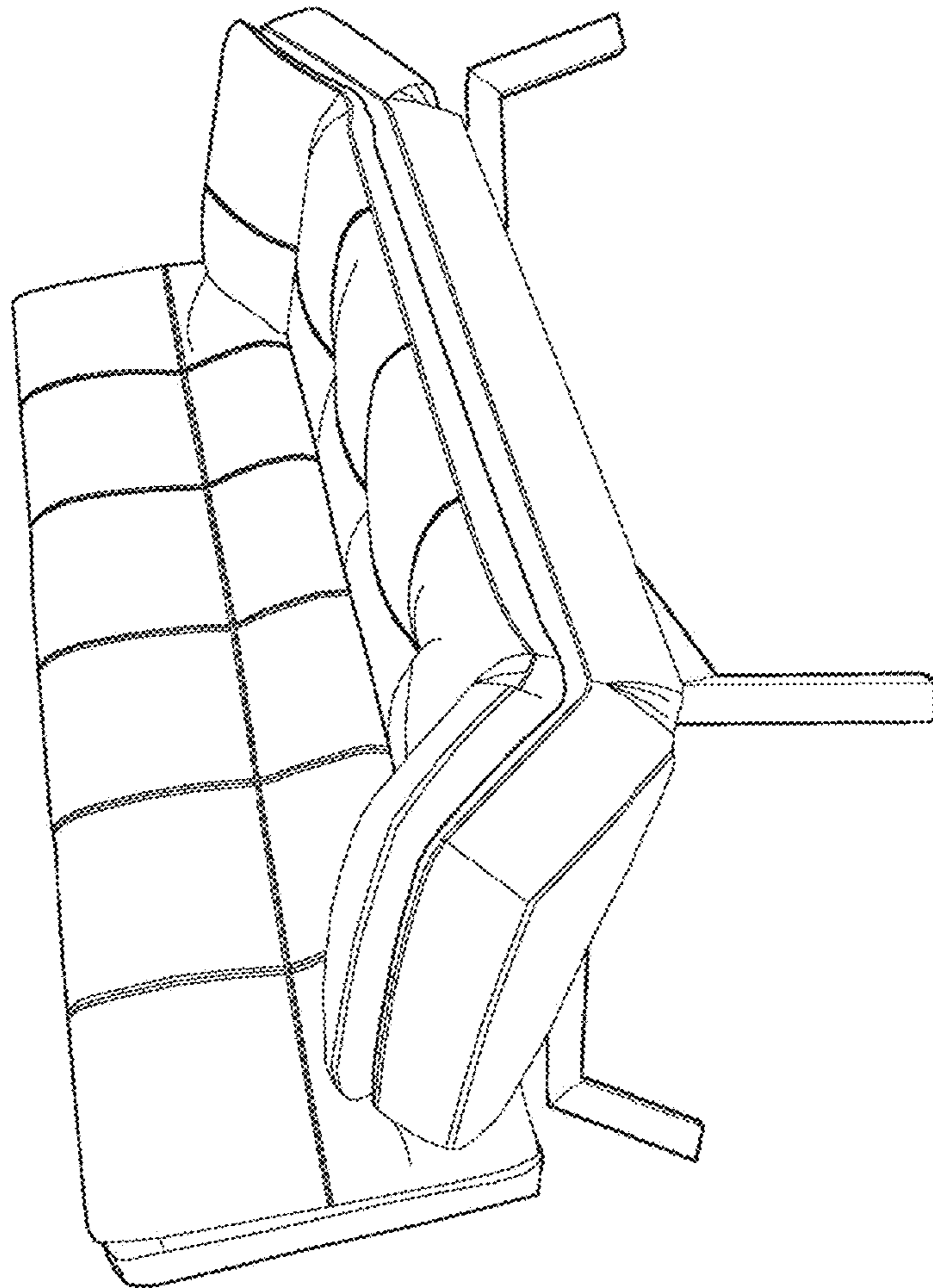
