the broken lines form no part of the claimed design.

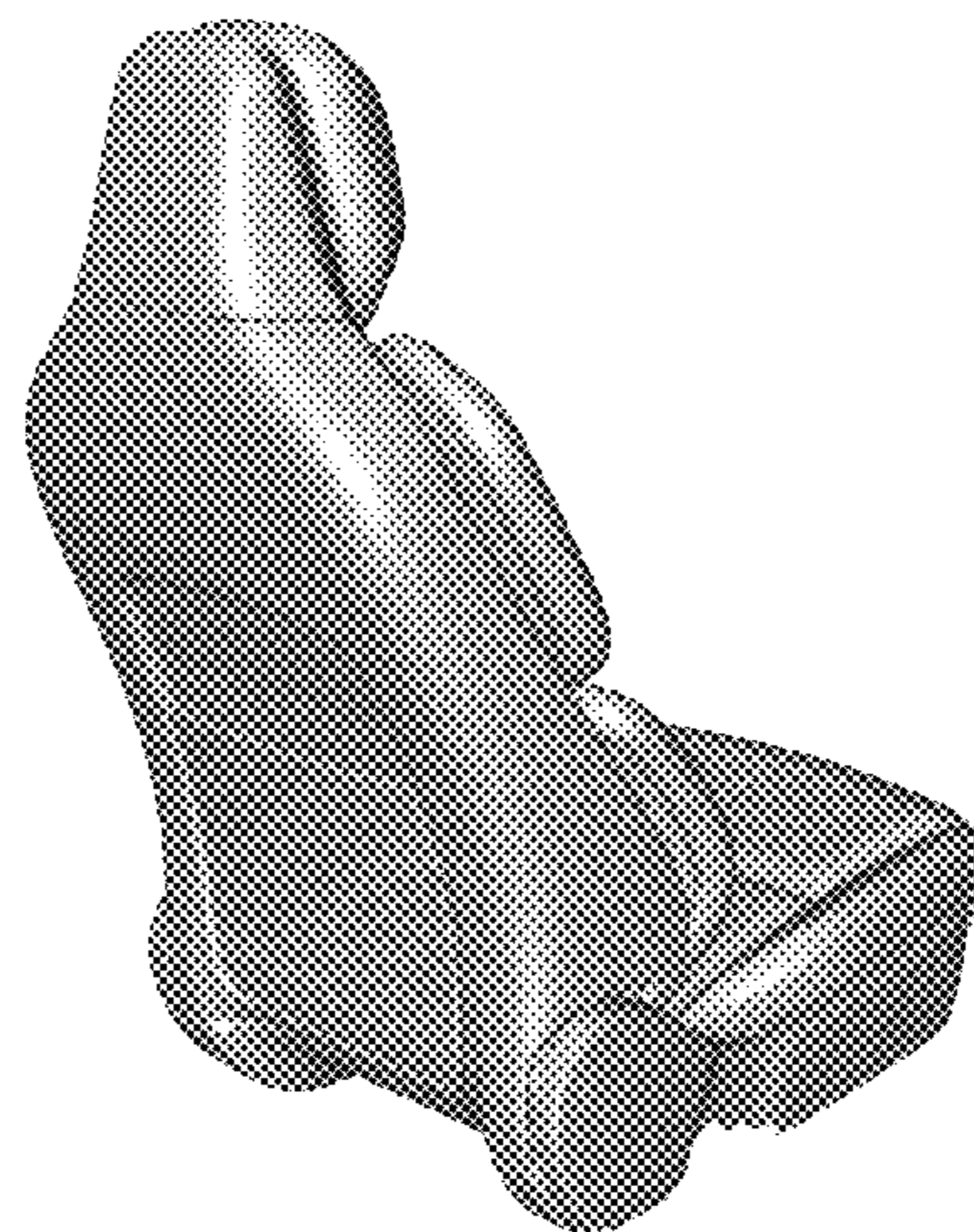

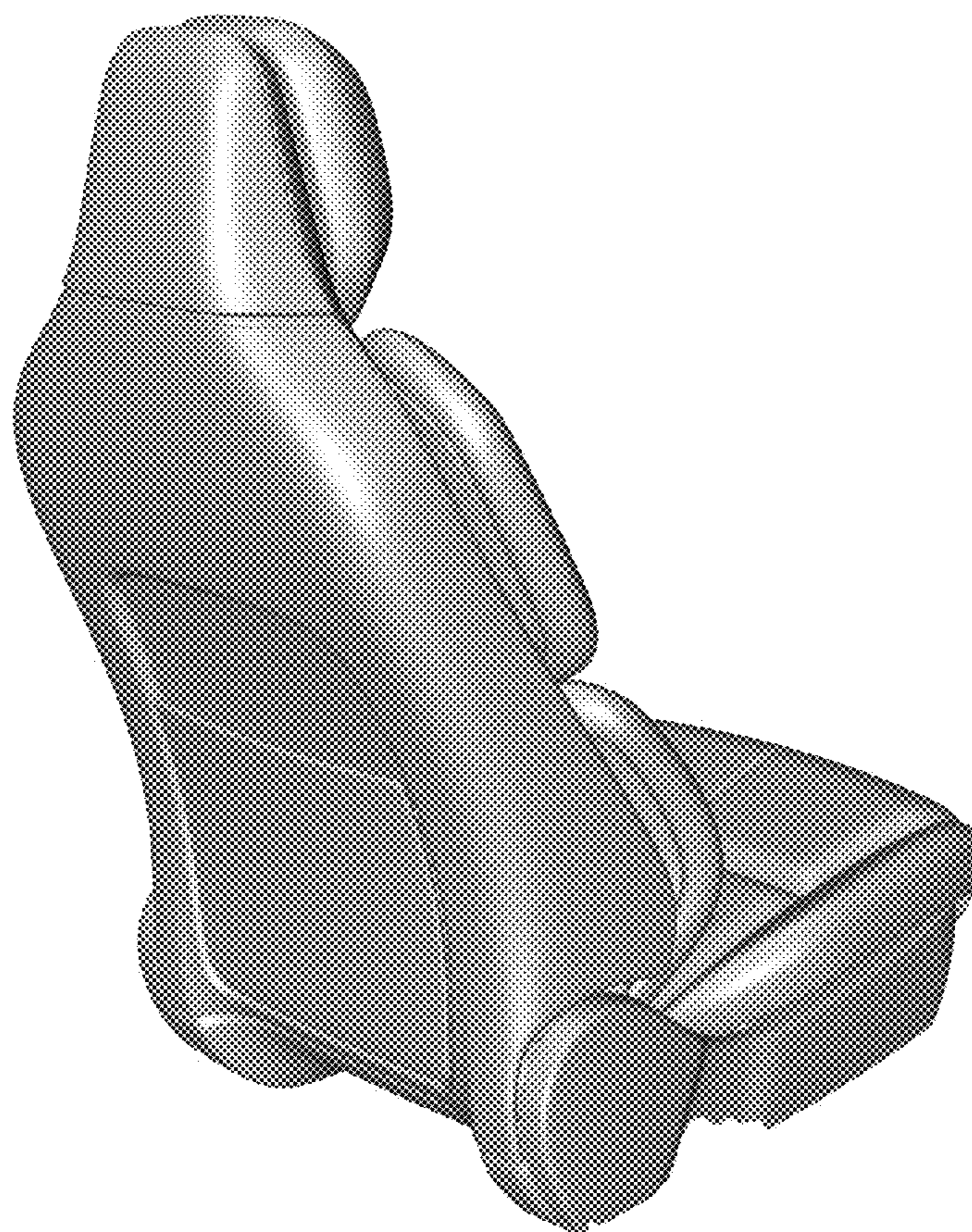

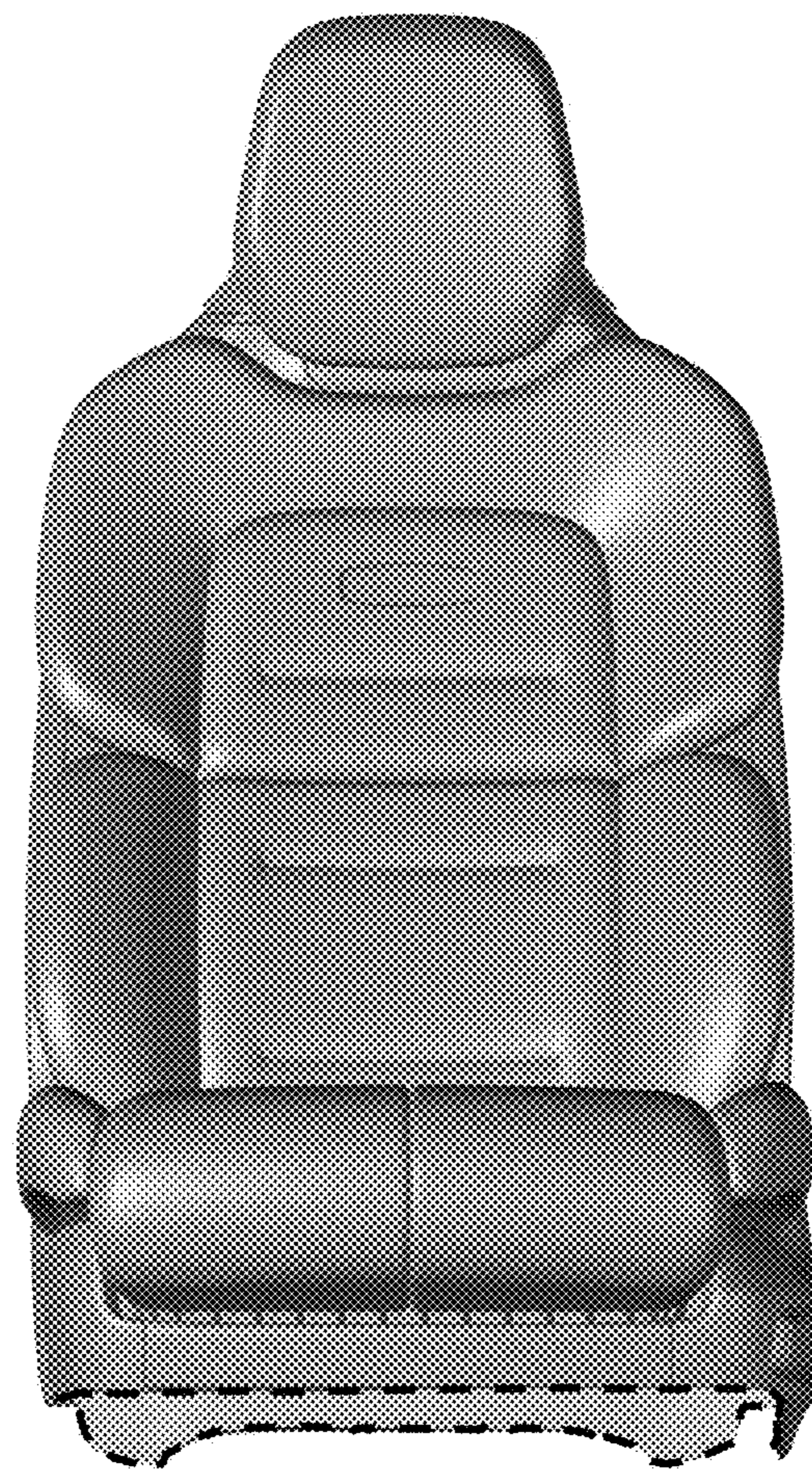

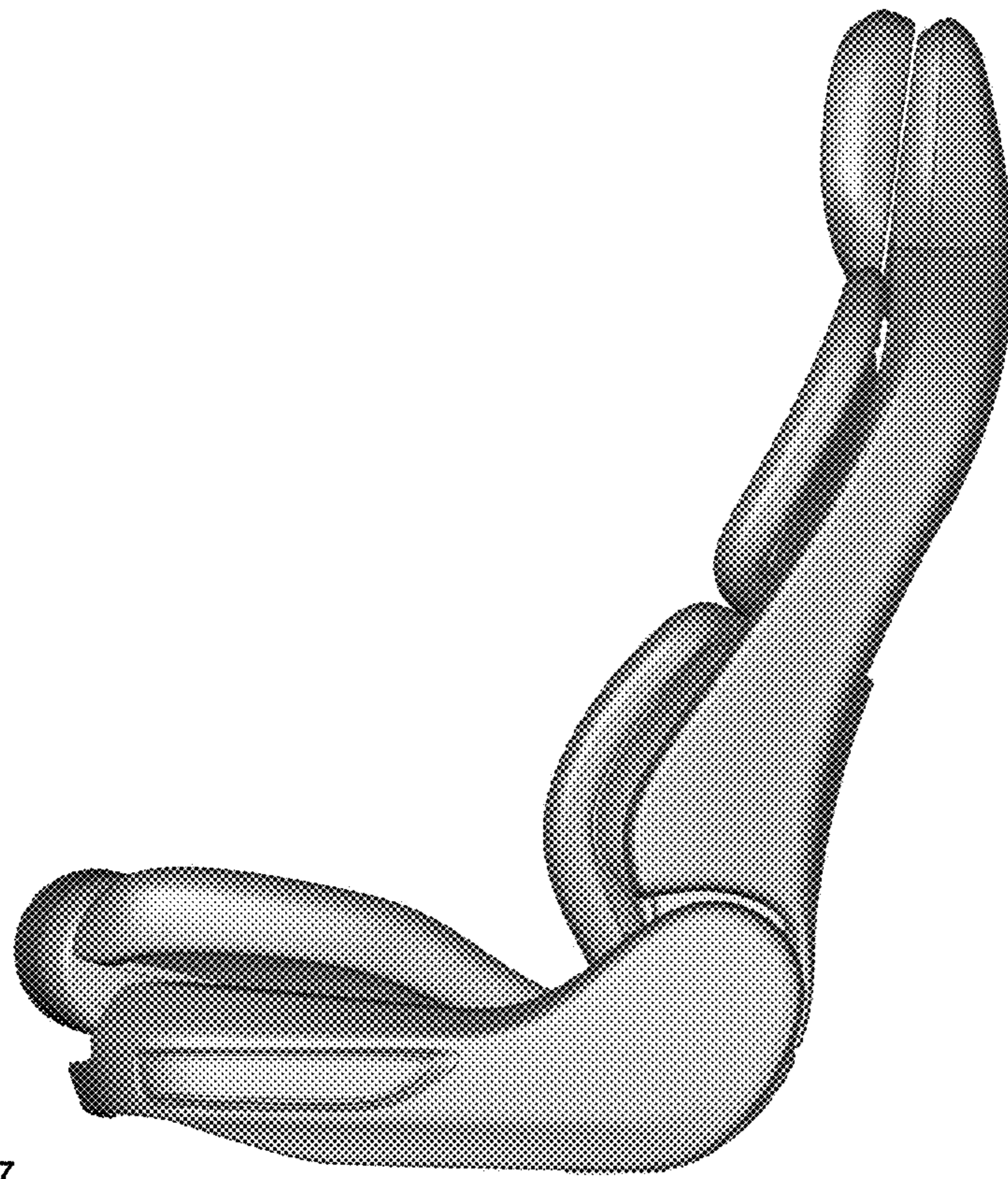

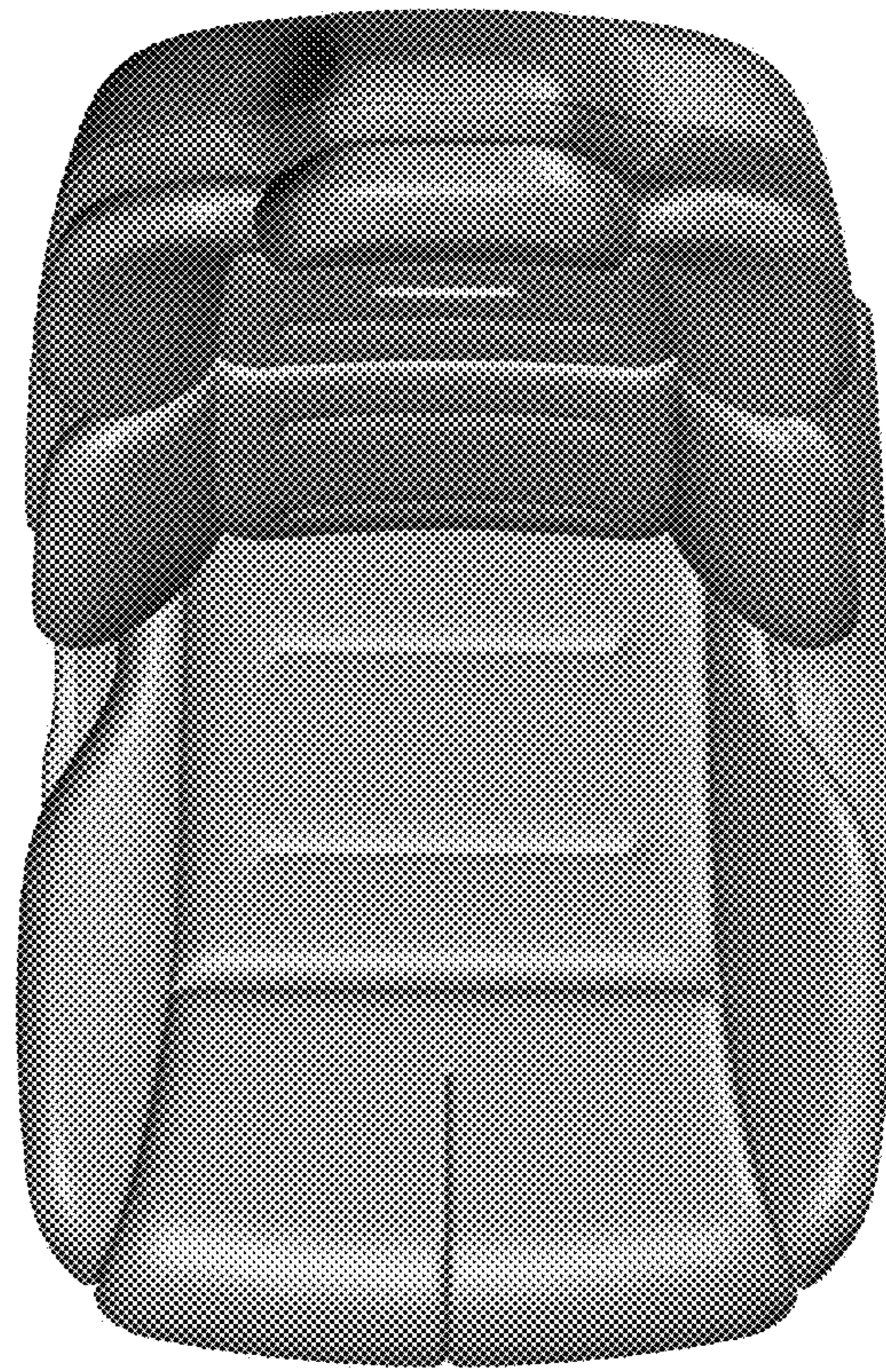
