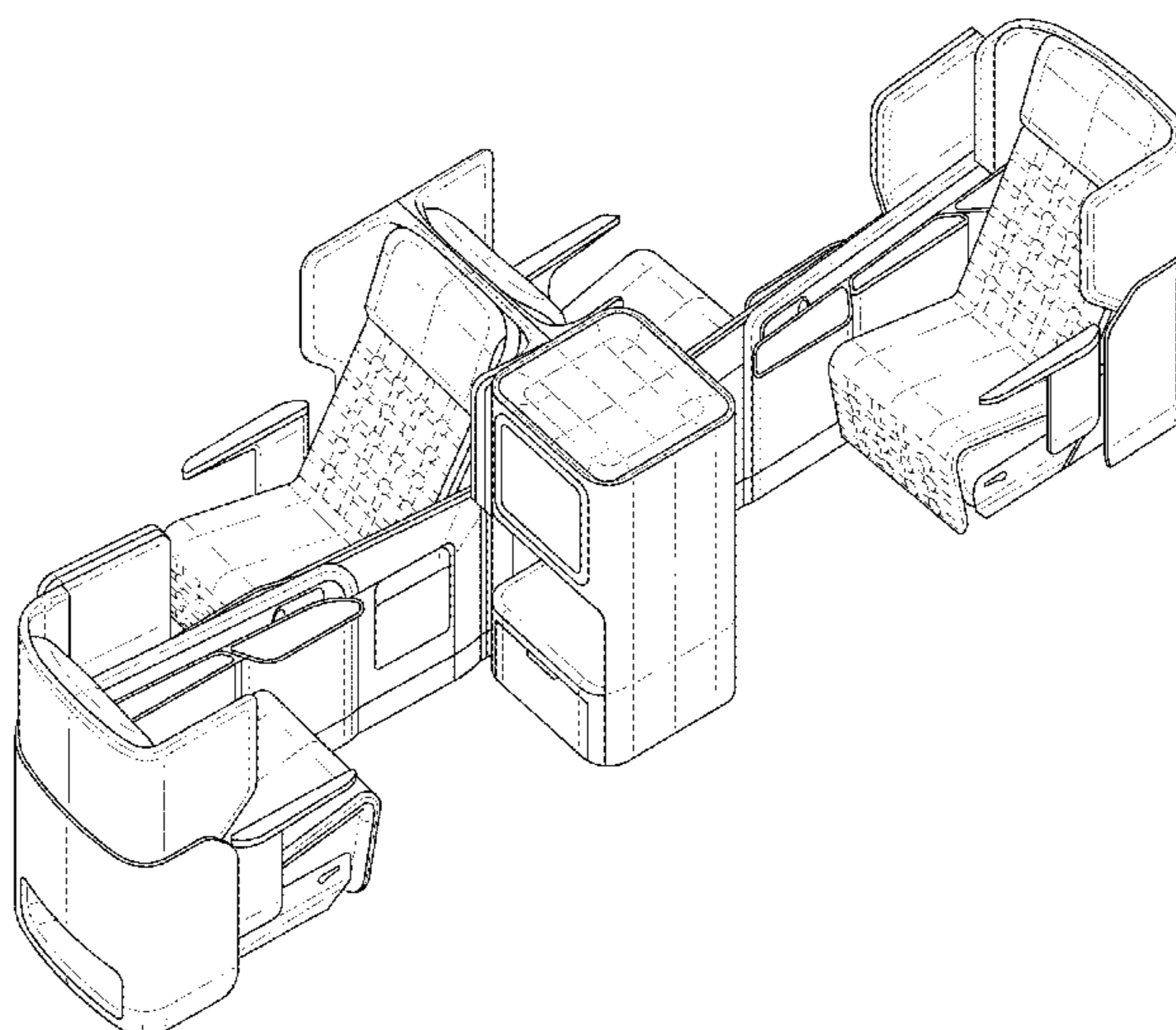
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a seating unit showing our new
design;
FIG. 2 is a top front perspective view thereof;
FIG. 3 is a side view thereof; and,
FIG. 4 is a front view thereof.
The shade lines in the figures show contour and not surface
ornamentation.
The dashed broken lines in the figures show portions of the
seating unit that form no part of the claimed design.

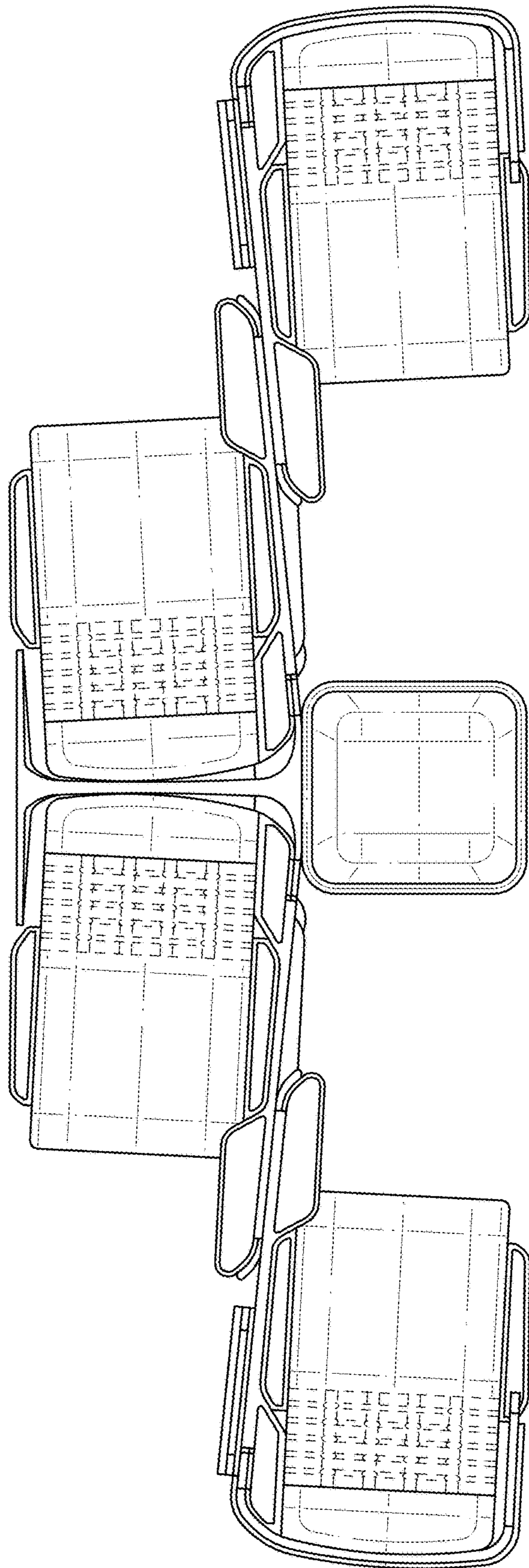

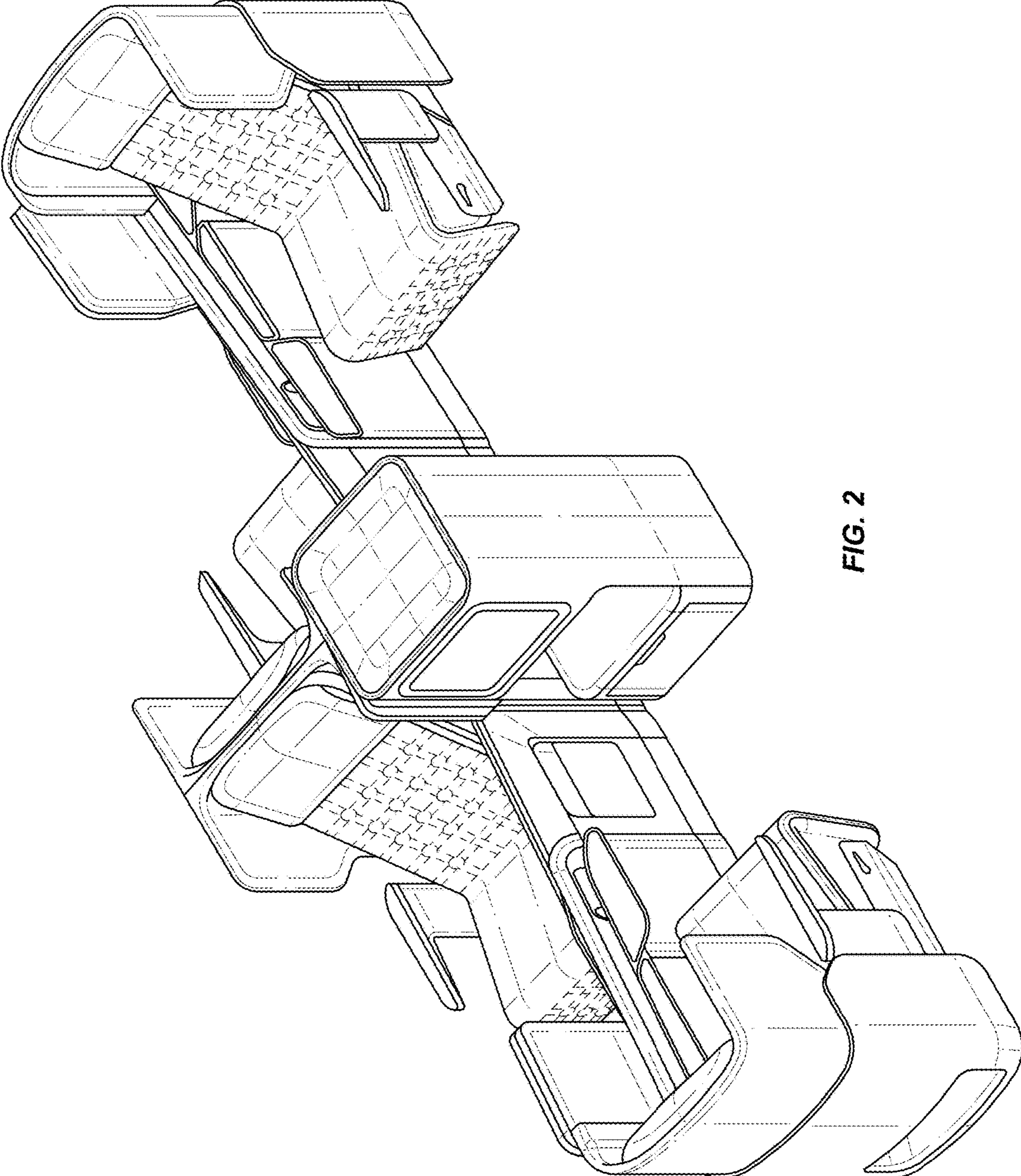

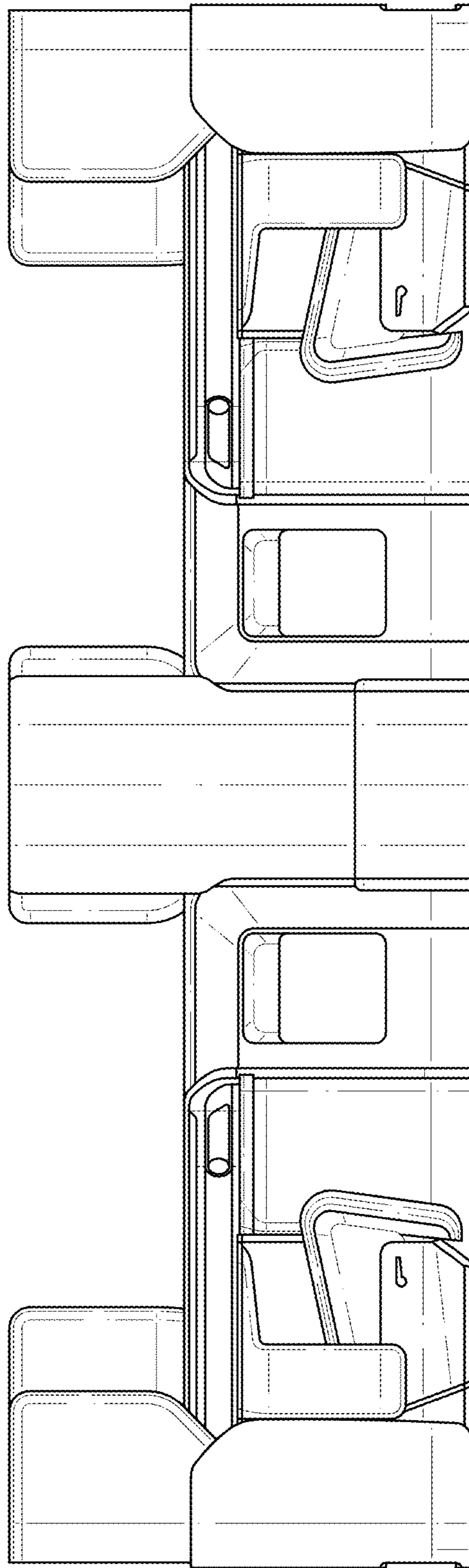

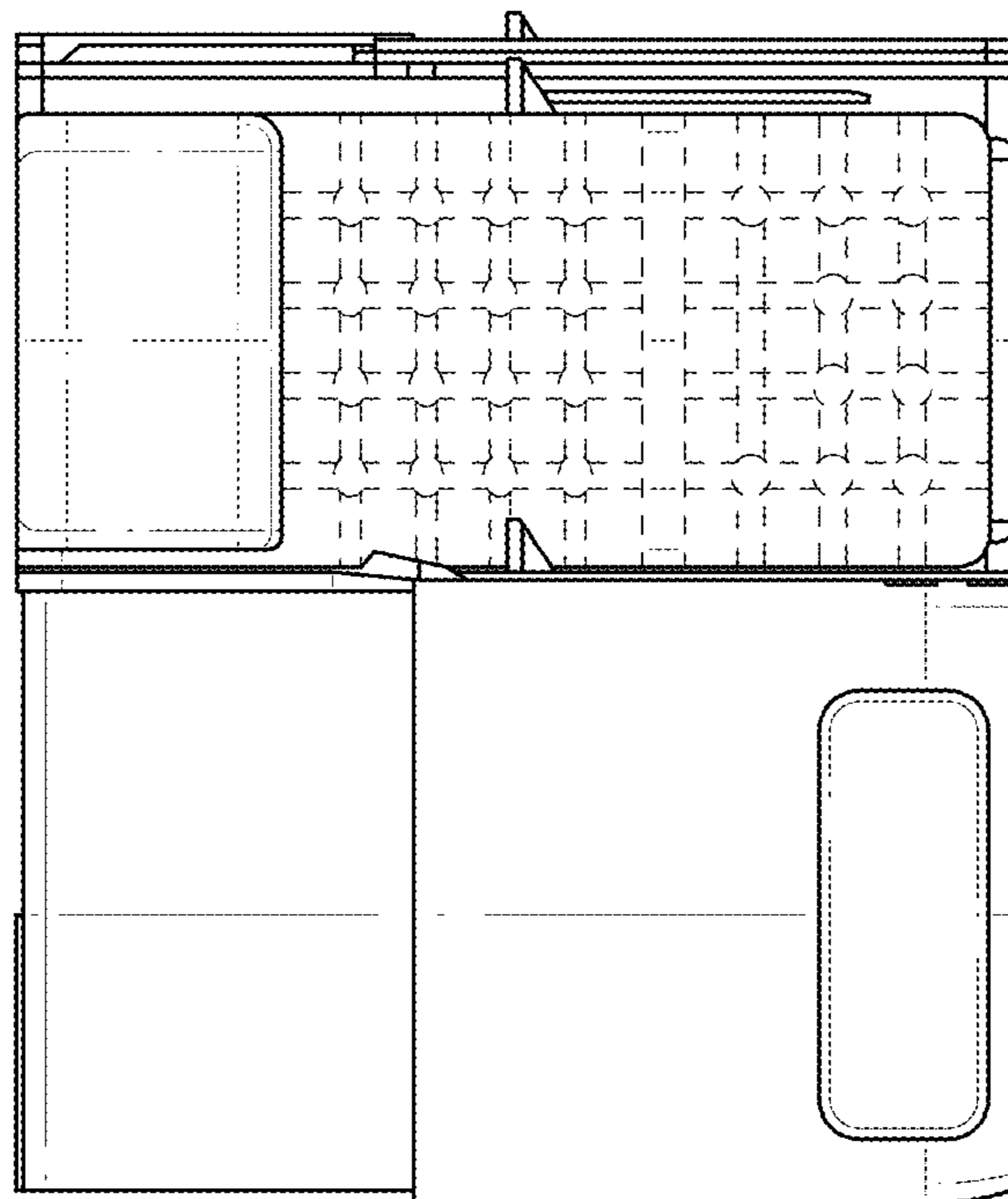
