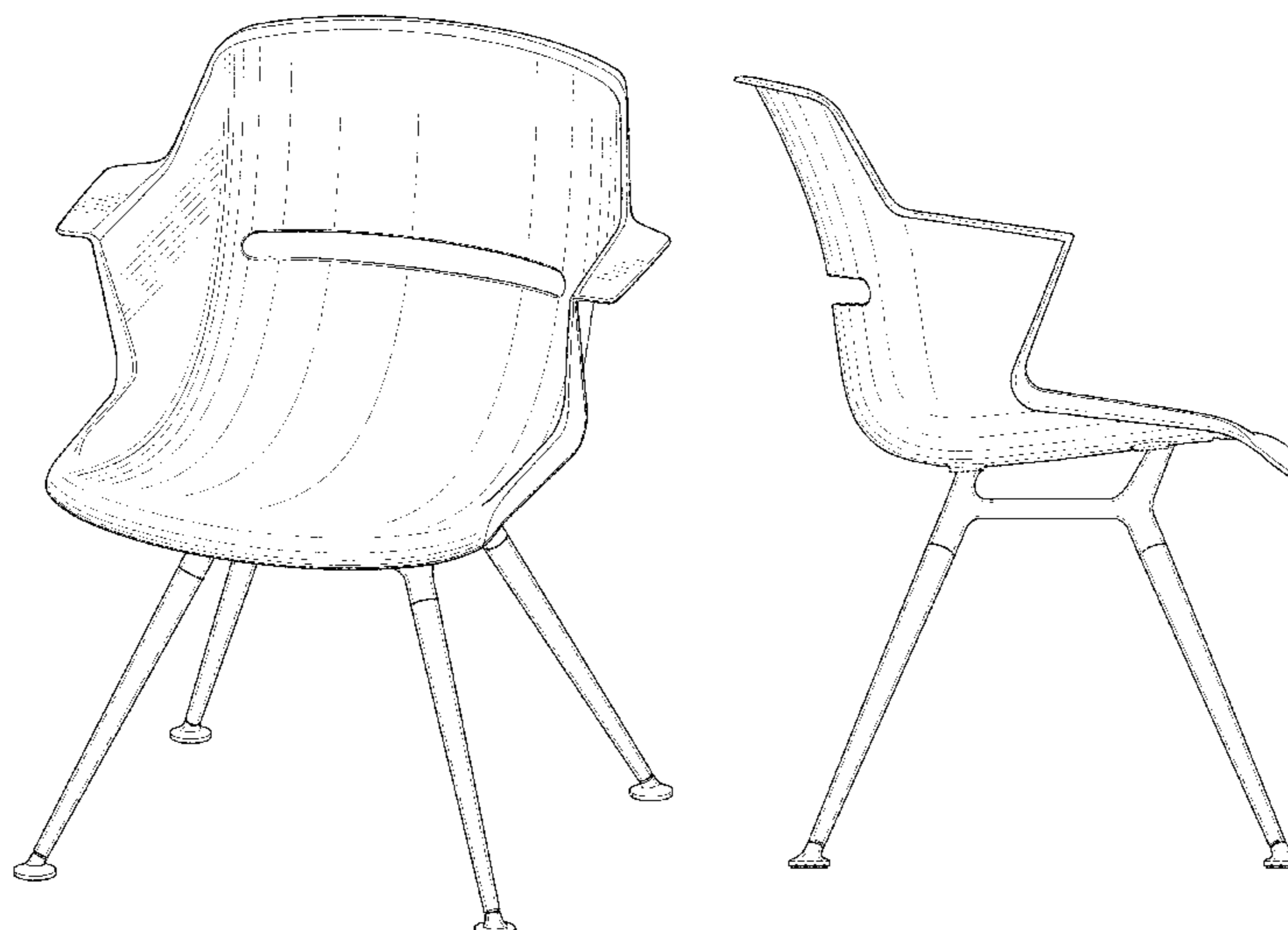
(57) **CLAIM**

The new and ornamental design for a chair with legs, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a chair with legs showing my new design;
FIG. 2 is a view in front elevation thereof;
FIG. 3 is a view in right side elevation thereof with the view in left side elevation being a mirror image of the view in right side elevation;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof; and,
FIG. 6 is a view in rear elevation thereof.
The broken lines represent unclaimed features of the chair with legs that form no part of the claimed design.

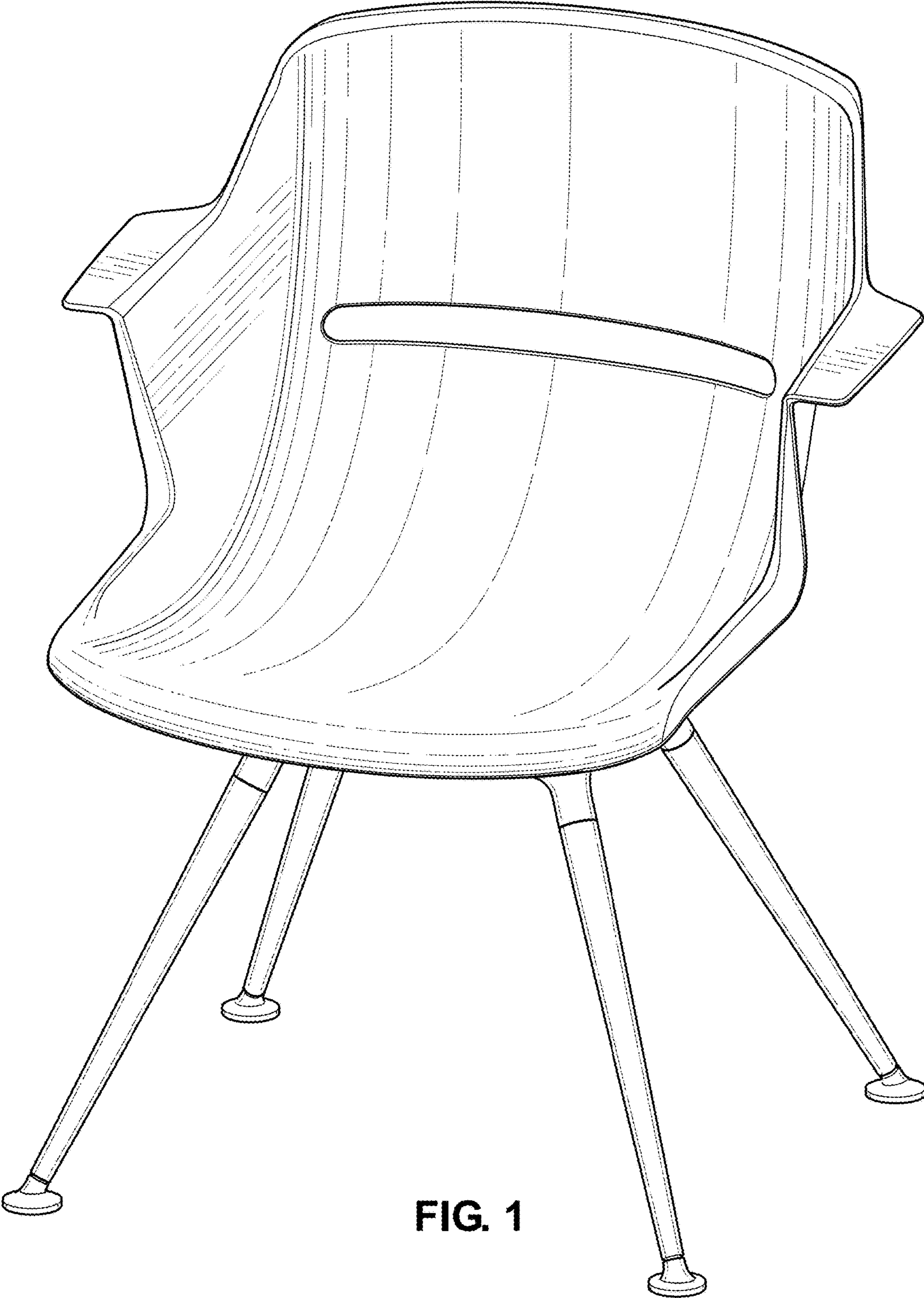

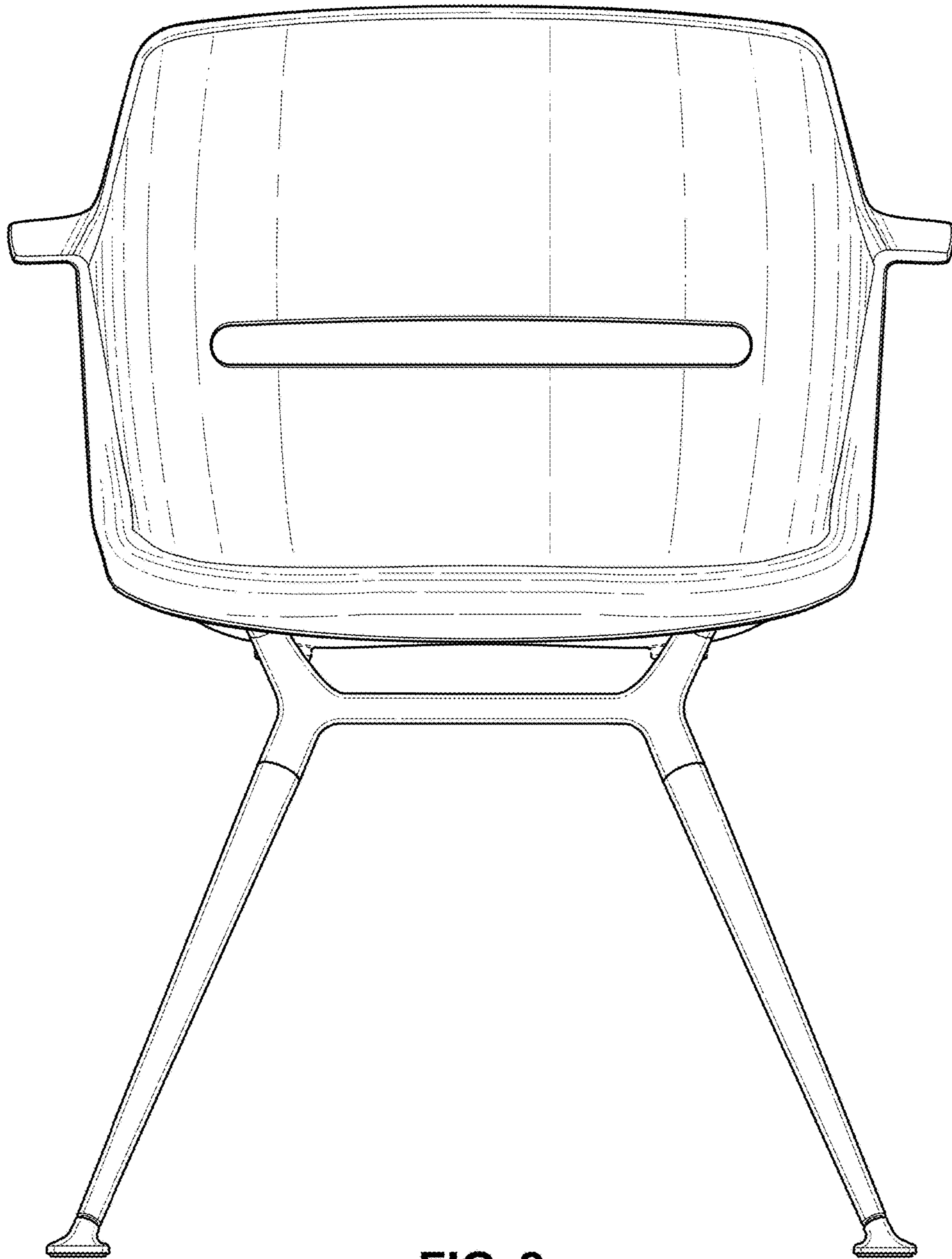

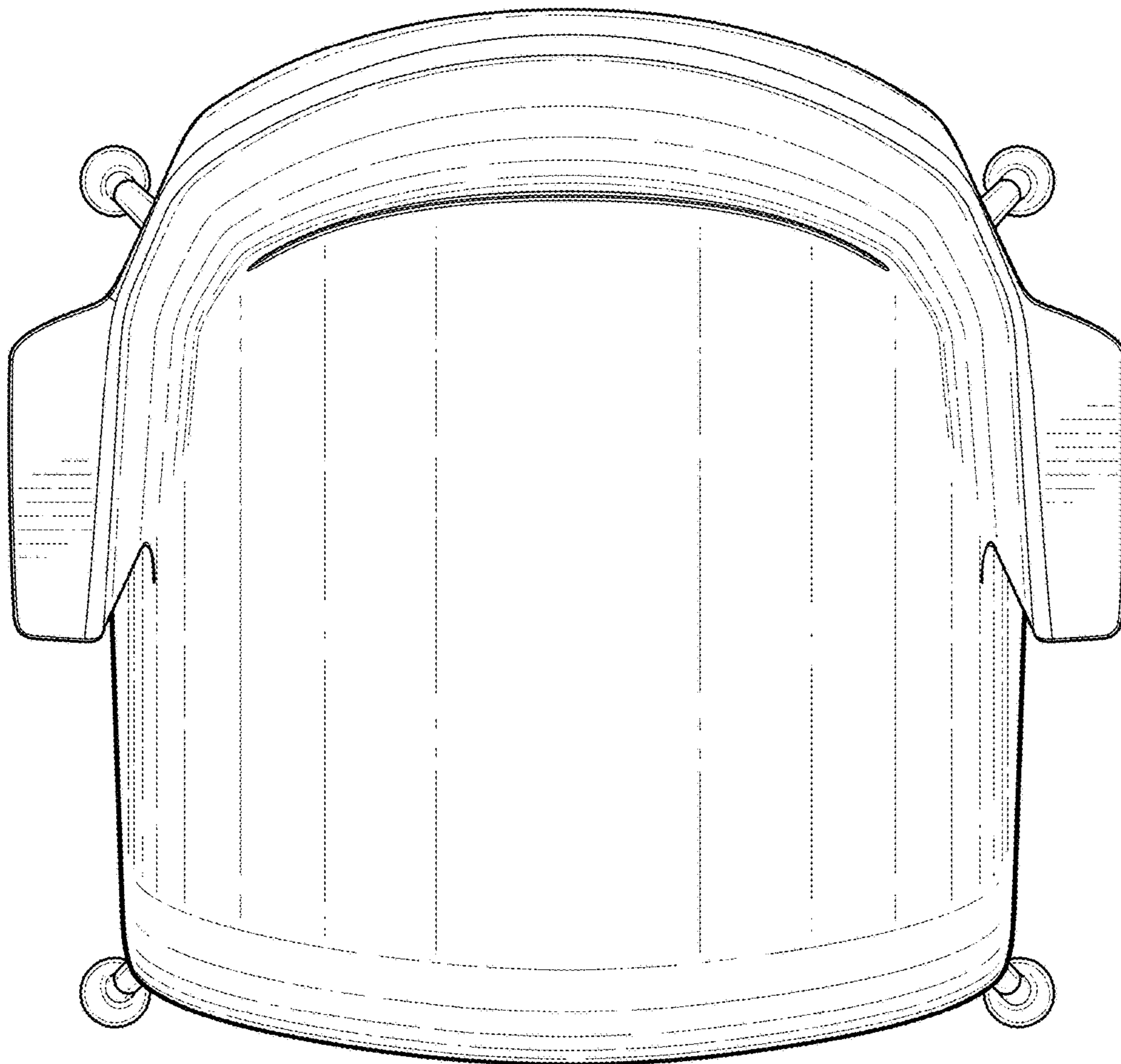

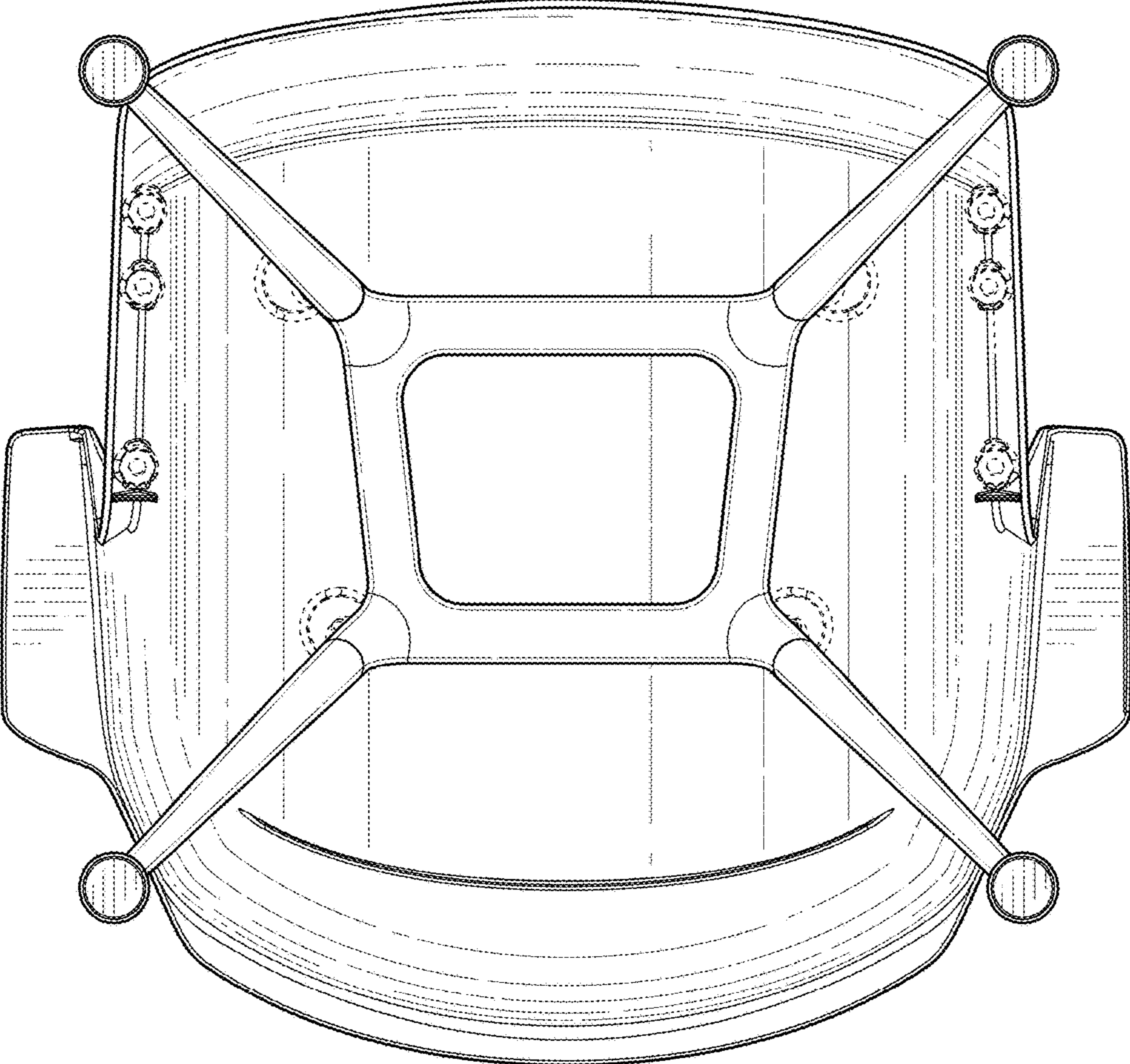
