FIG. 3 is a right side view of the grill shroud of the present invention.

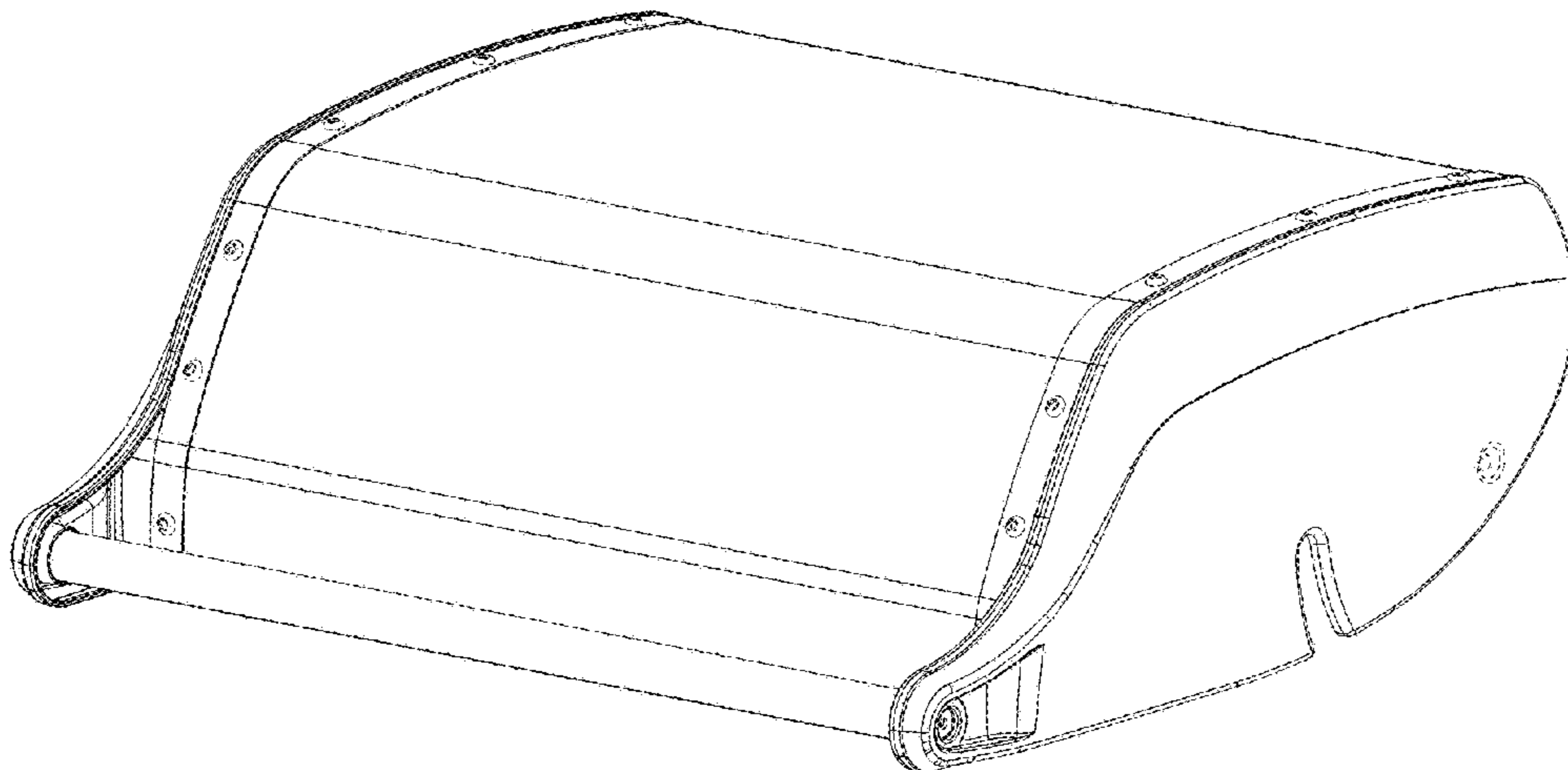
FIG. 4 is a left side view of the grill shroud of the present invention.

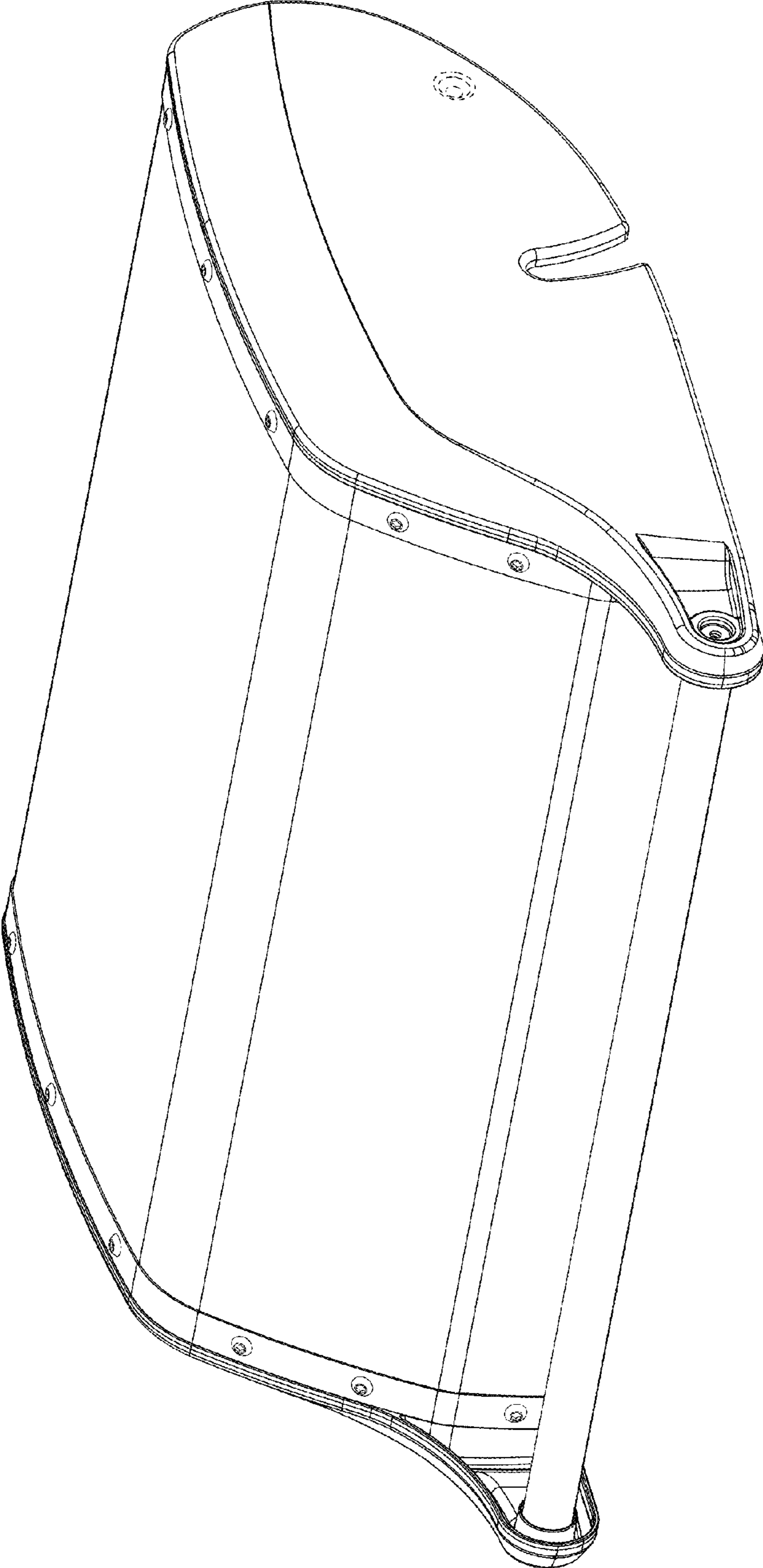

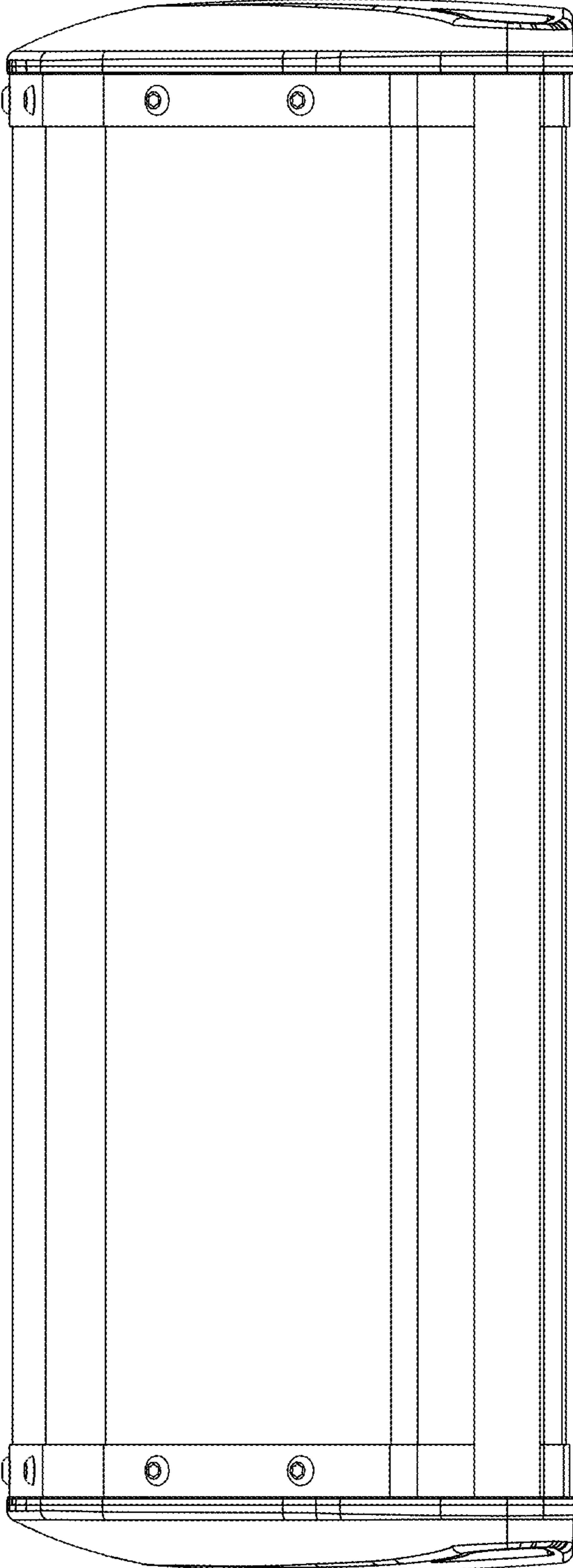

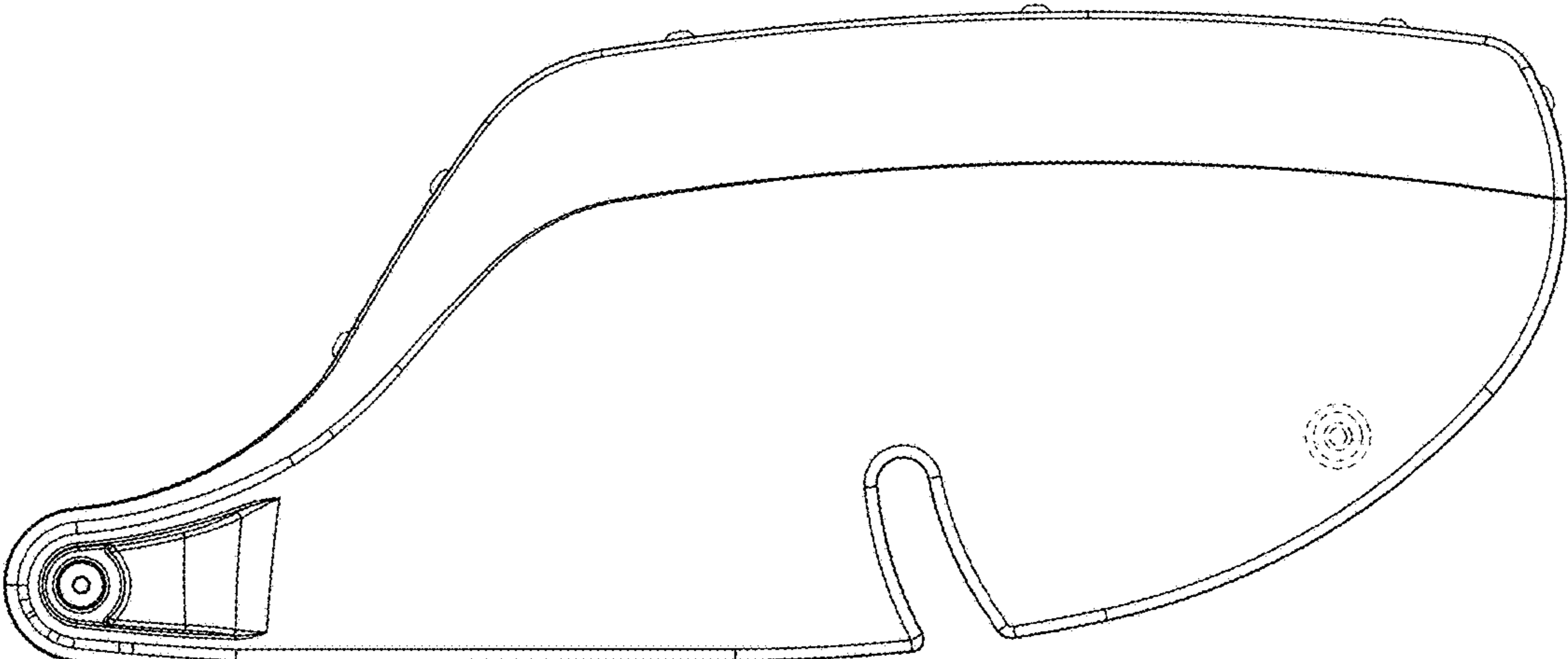
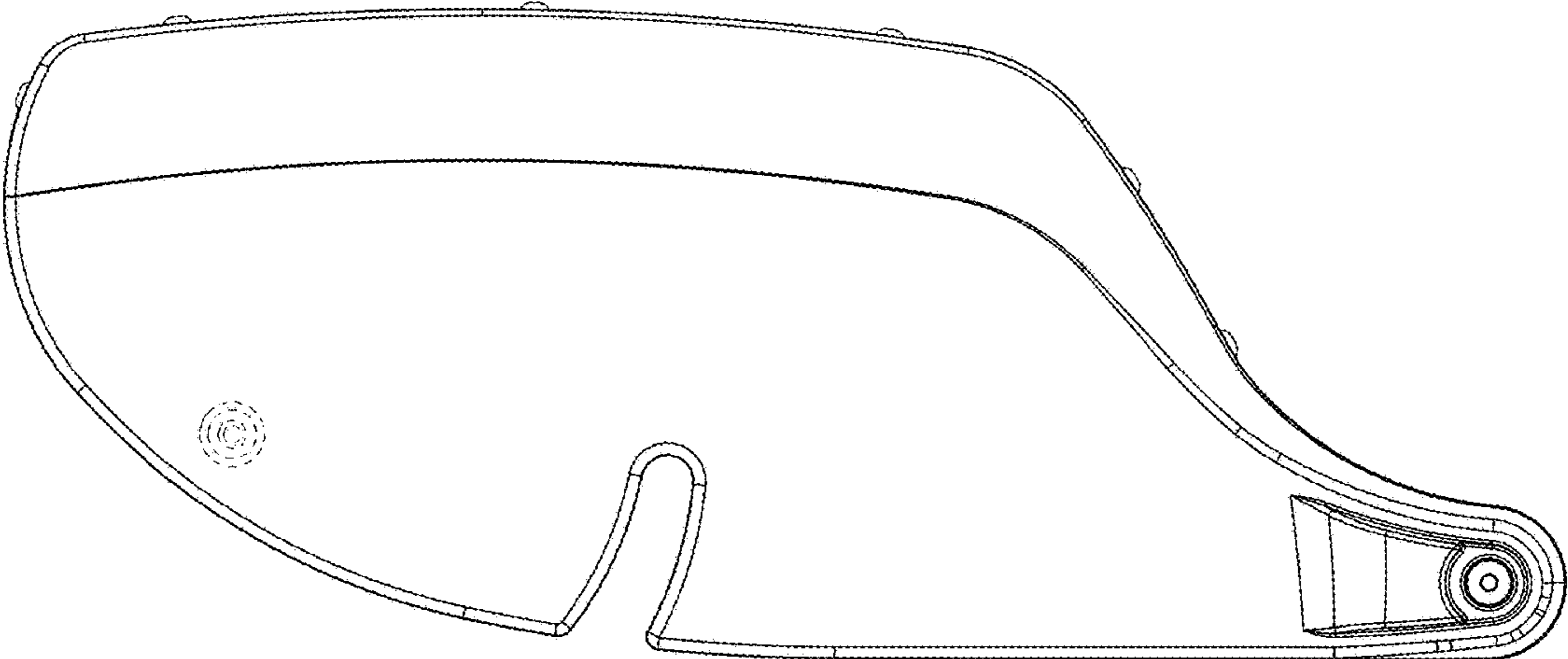

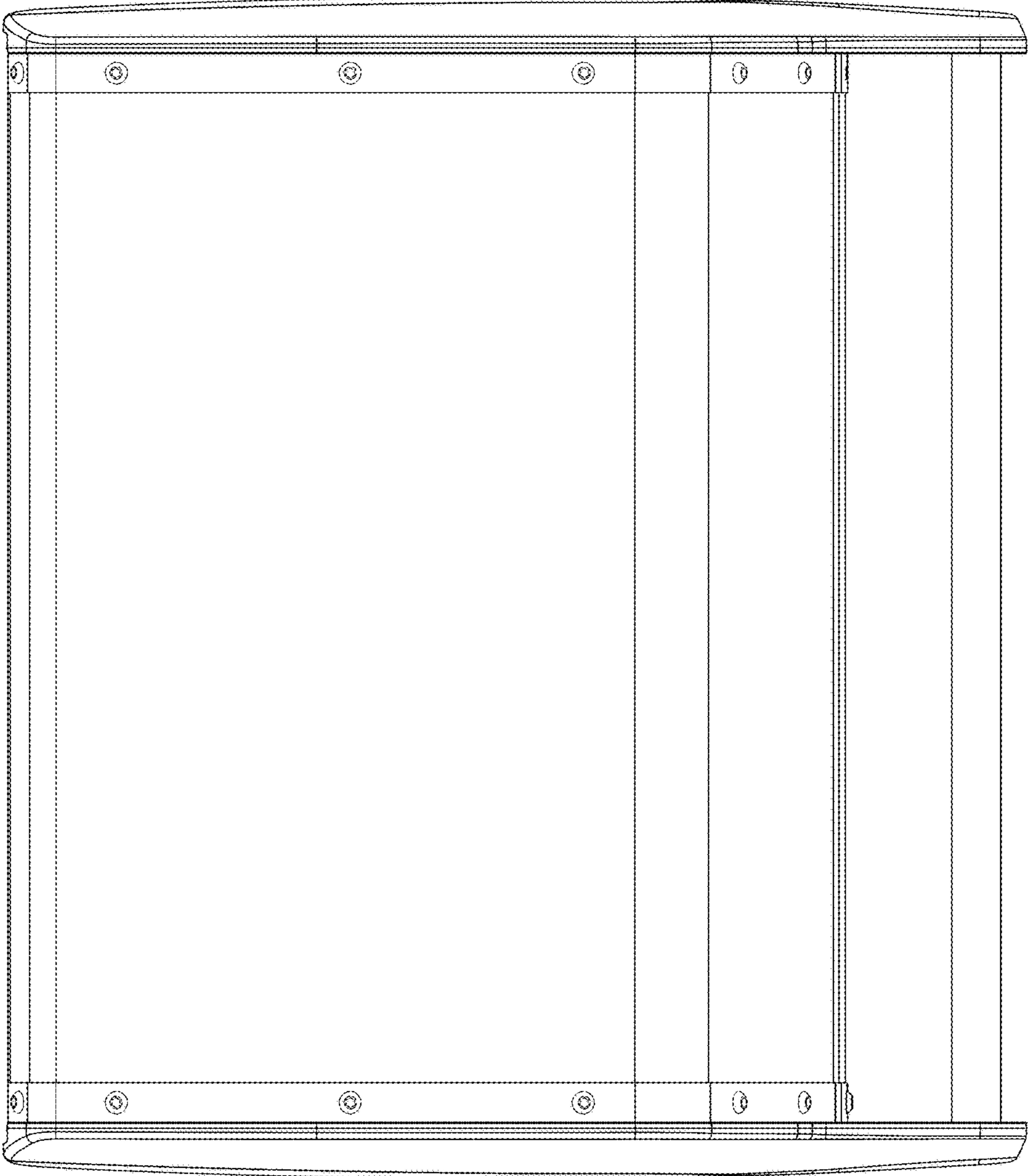
