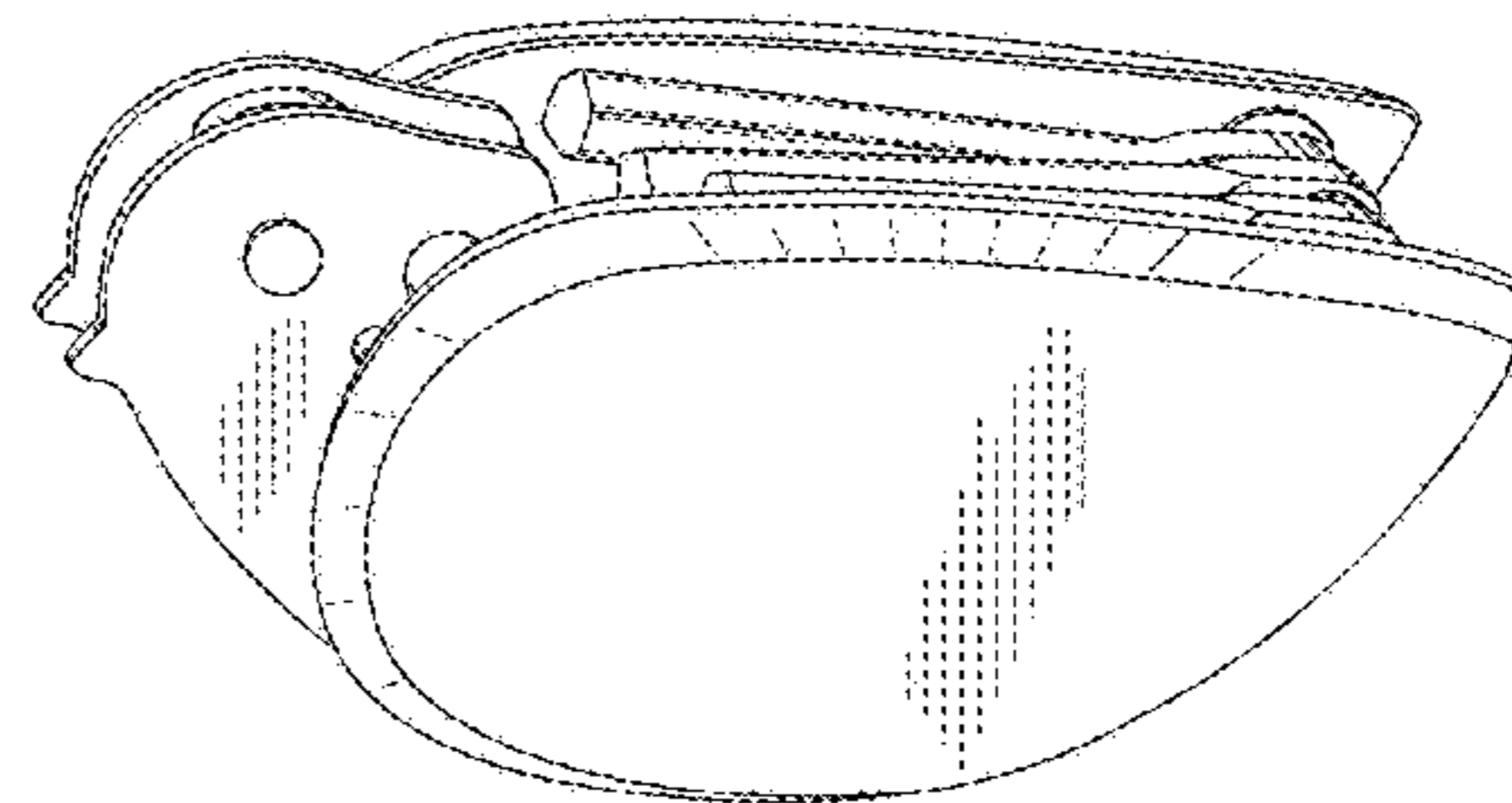
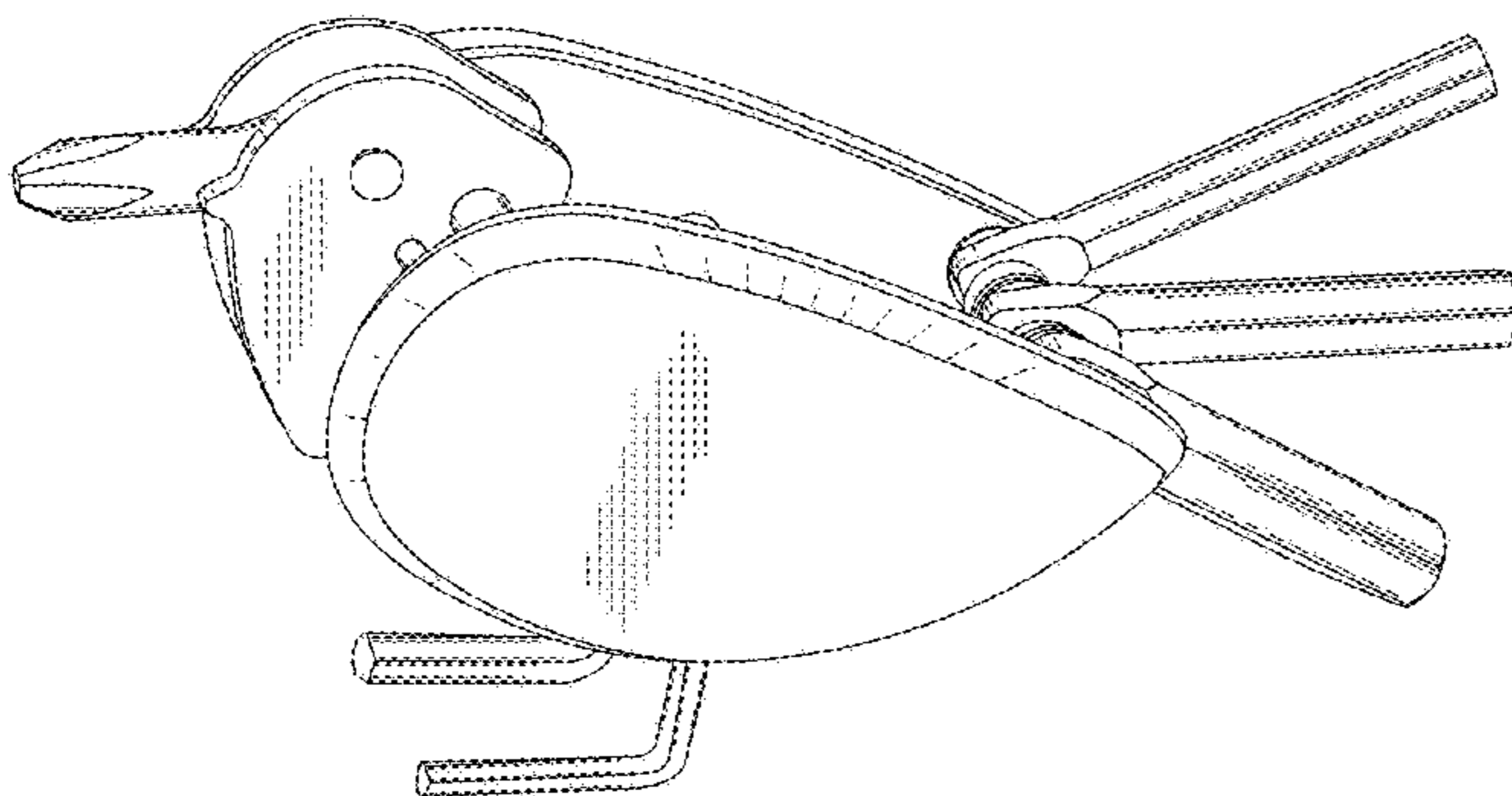
(57) **CLAIM**

The ornamental design for a bird-shaped multi-tool device, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a bird-shaped multi-tool device showing our novel design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a front perspective view thereof; and, FIG. 8 is a front perspective view thereof shown in an alternative closed position.

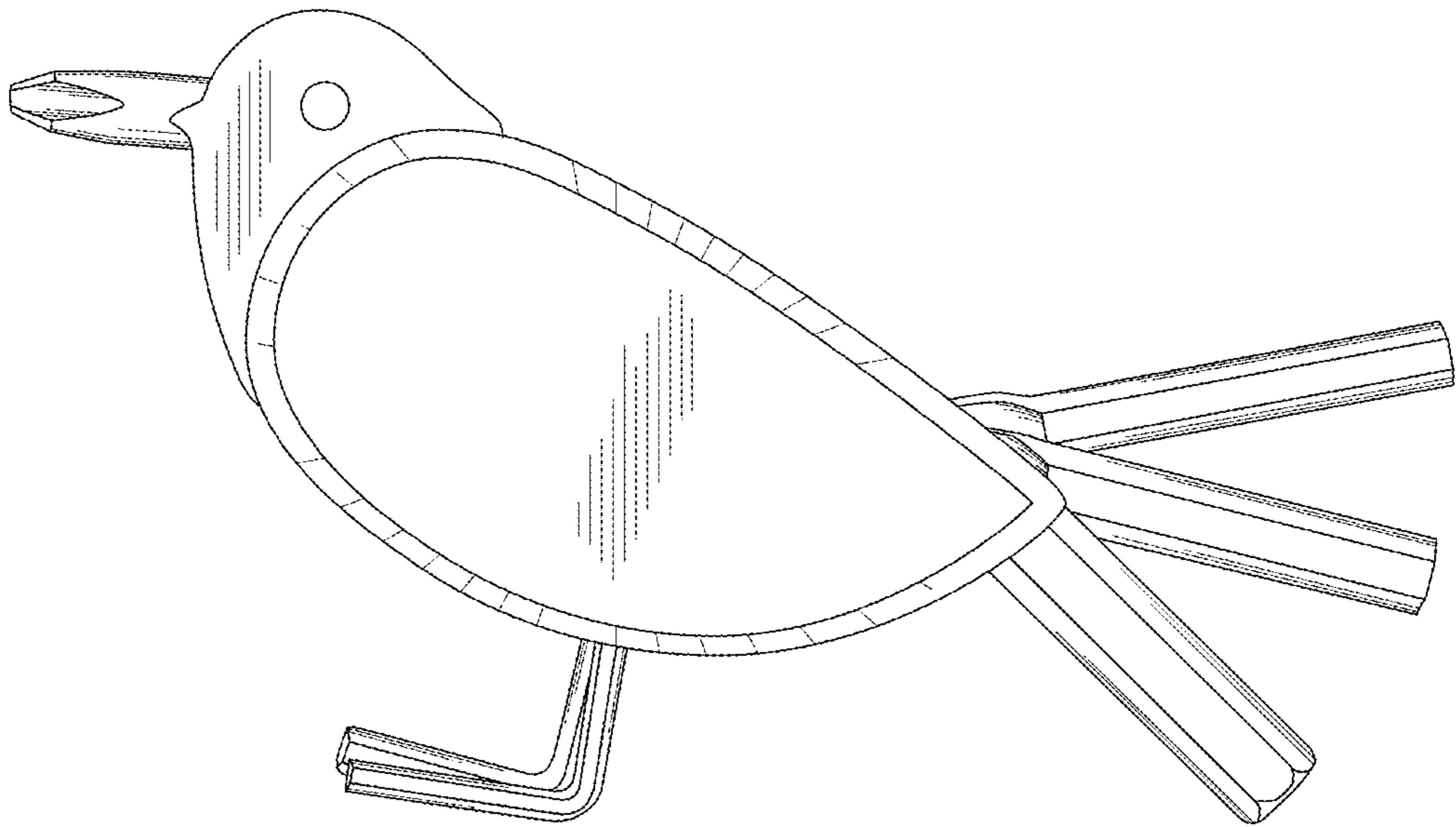

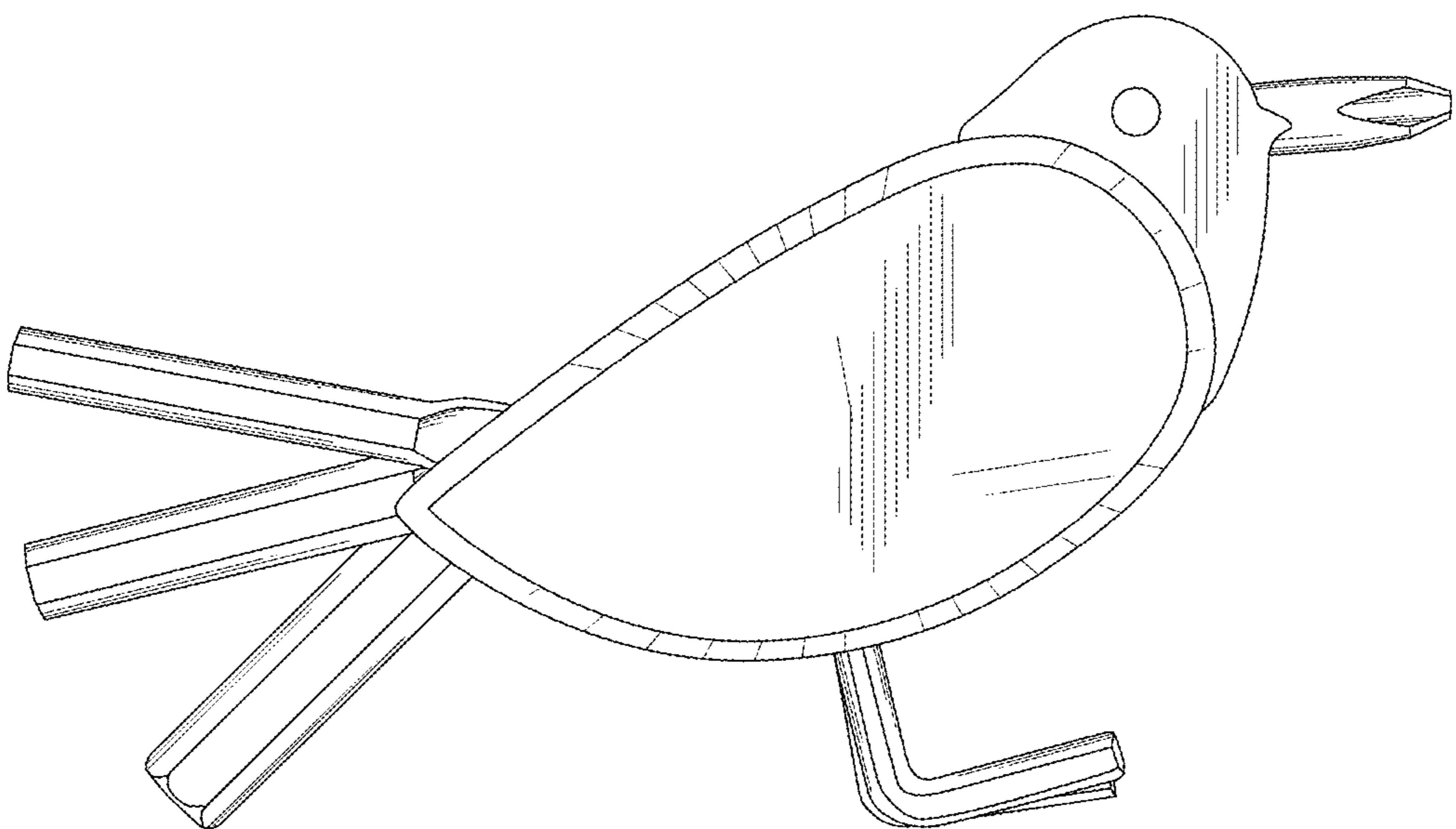

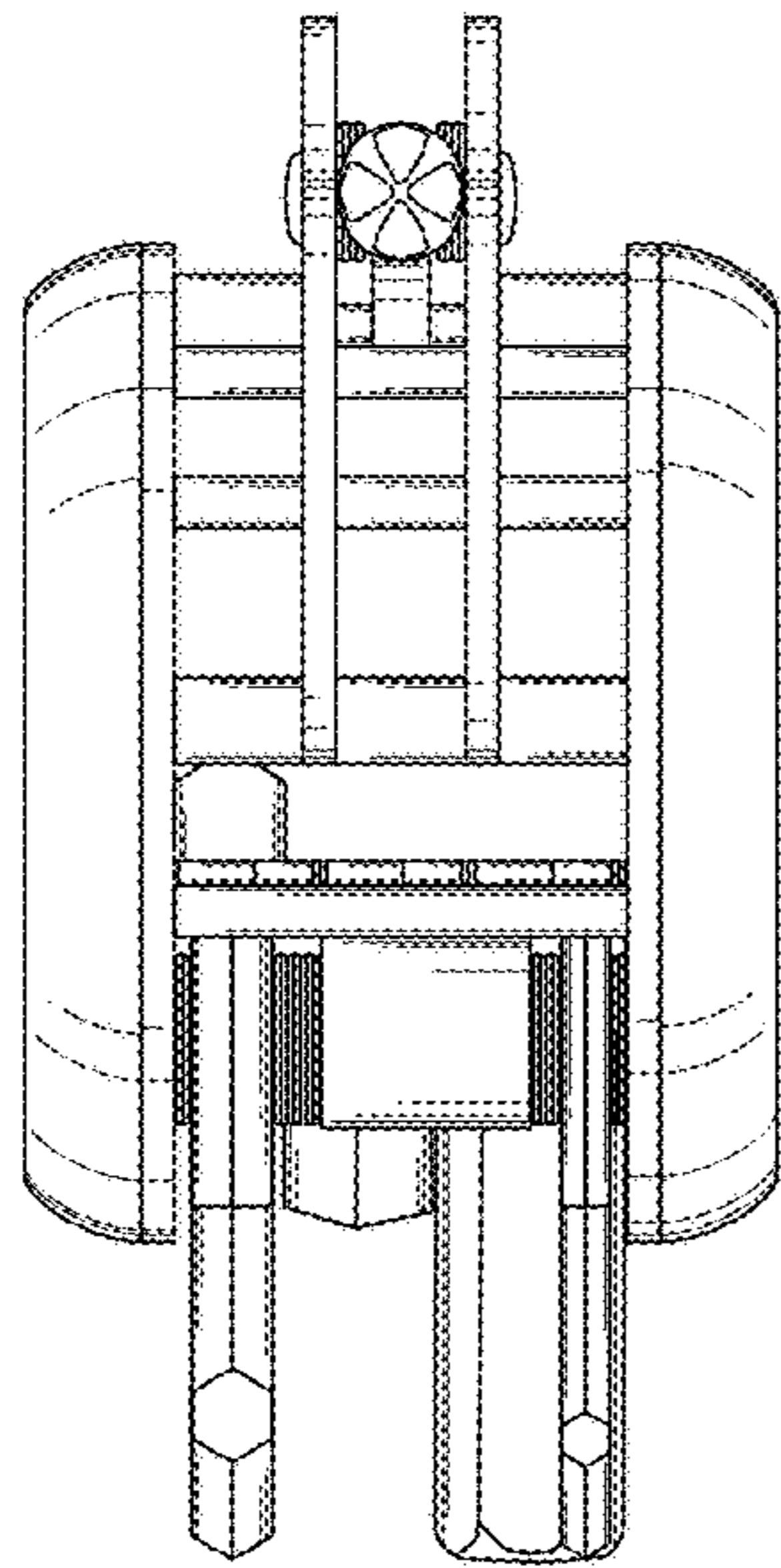

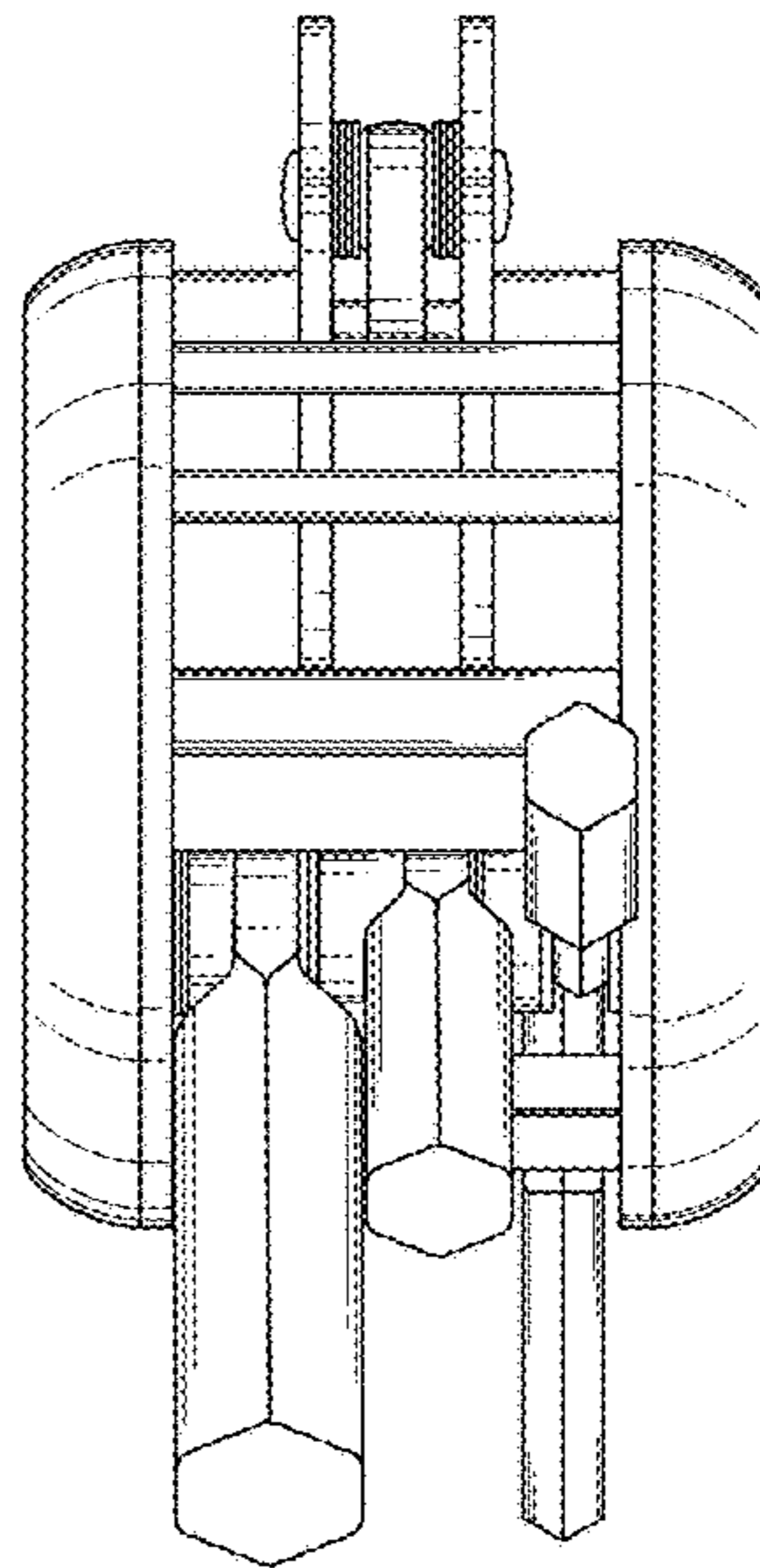

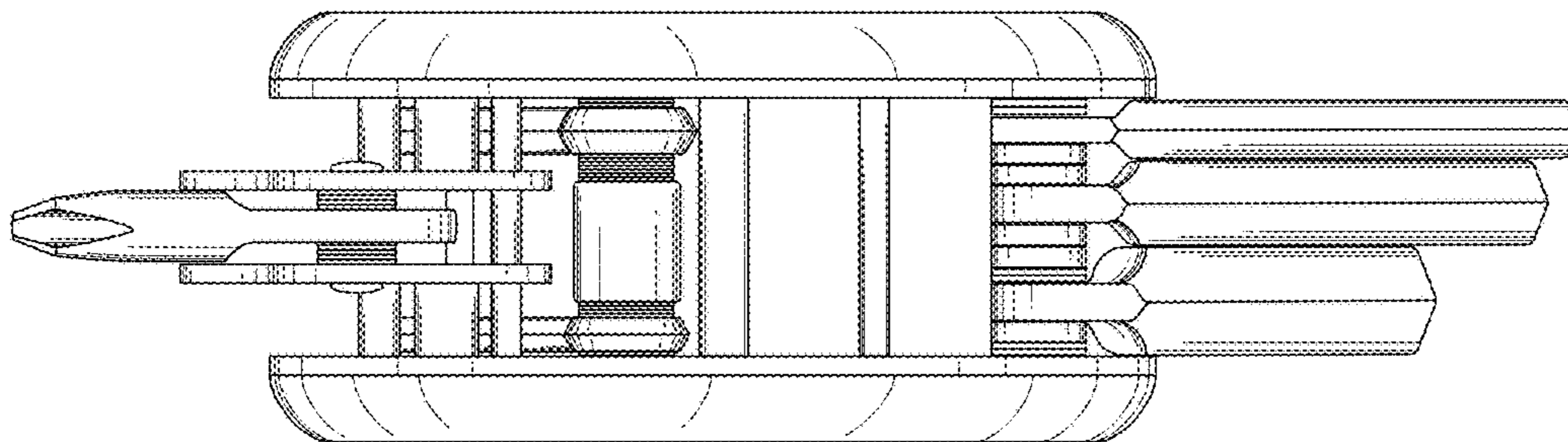

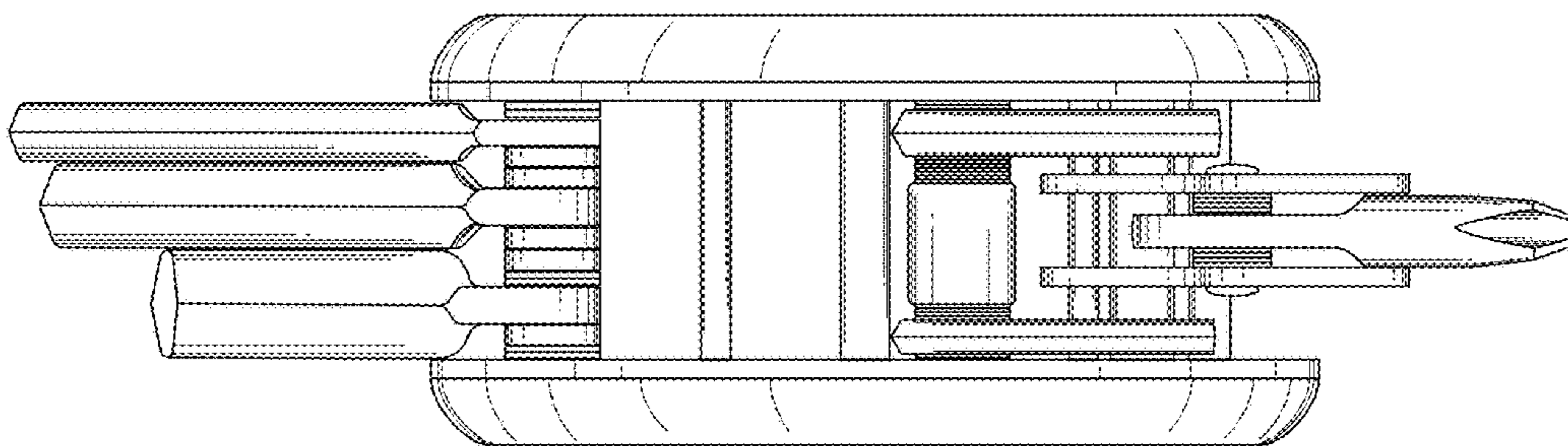

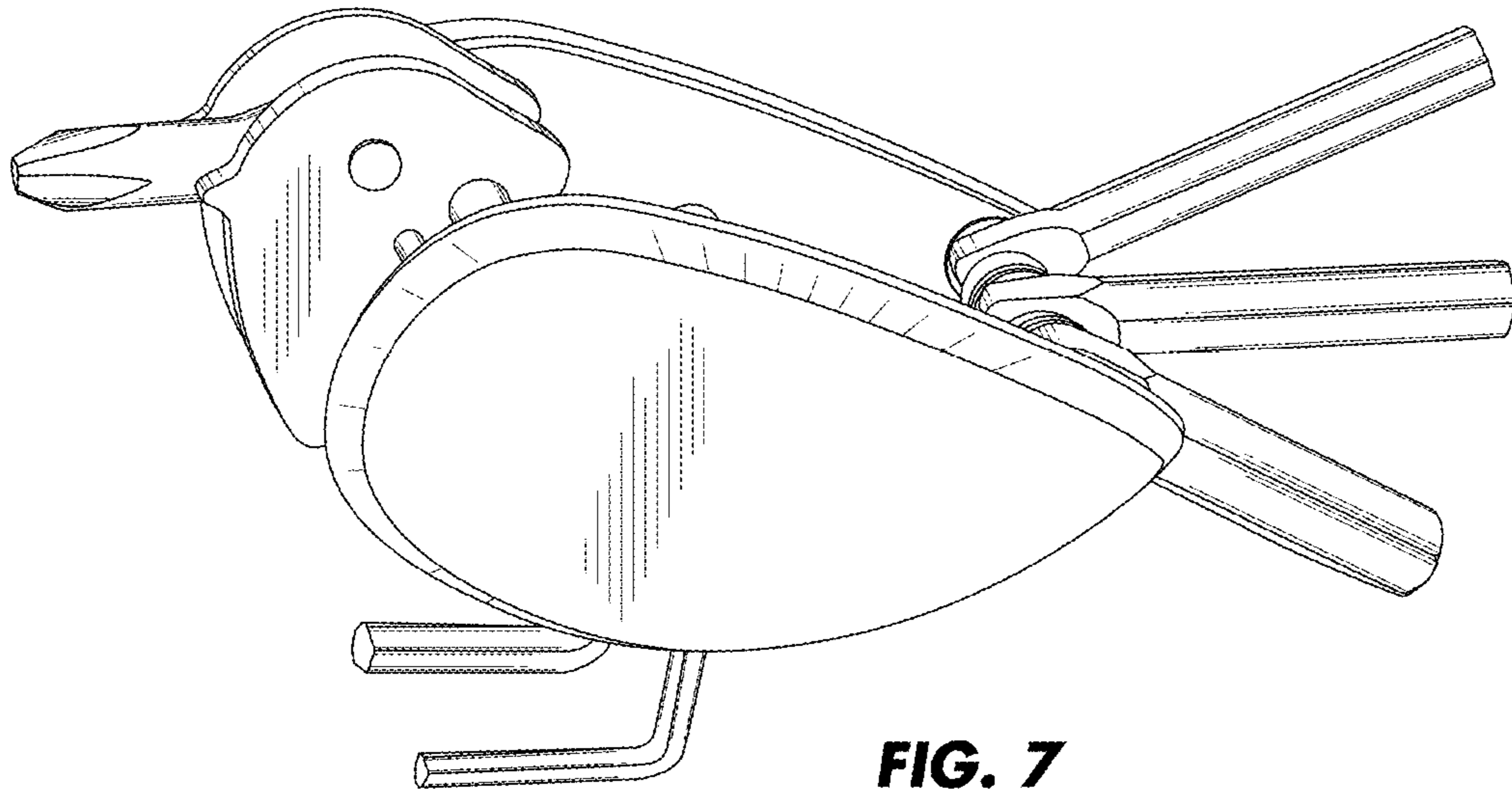

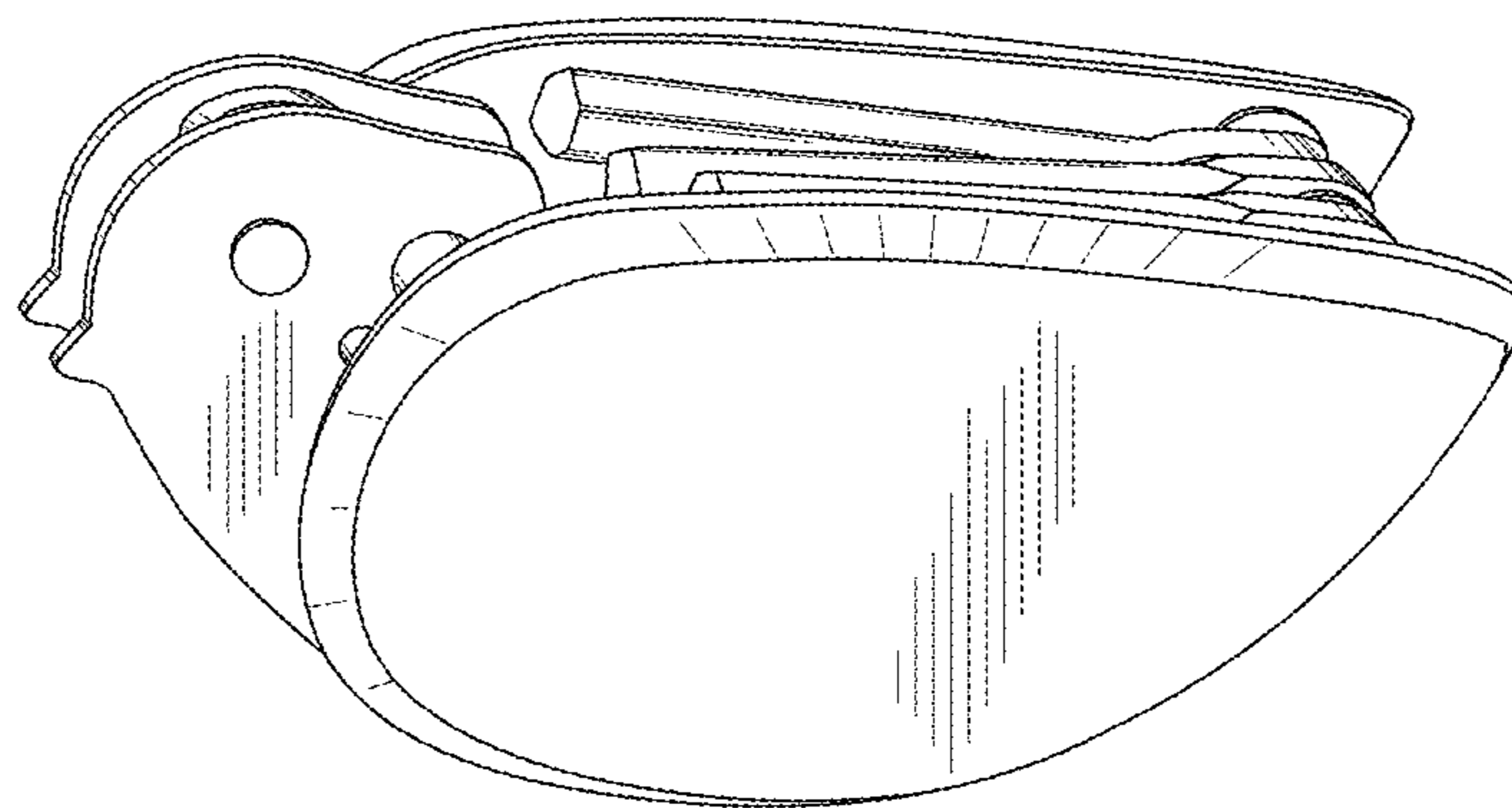
