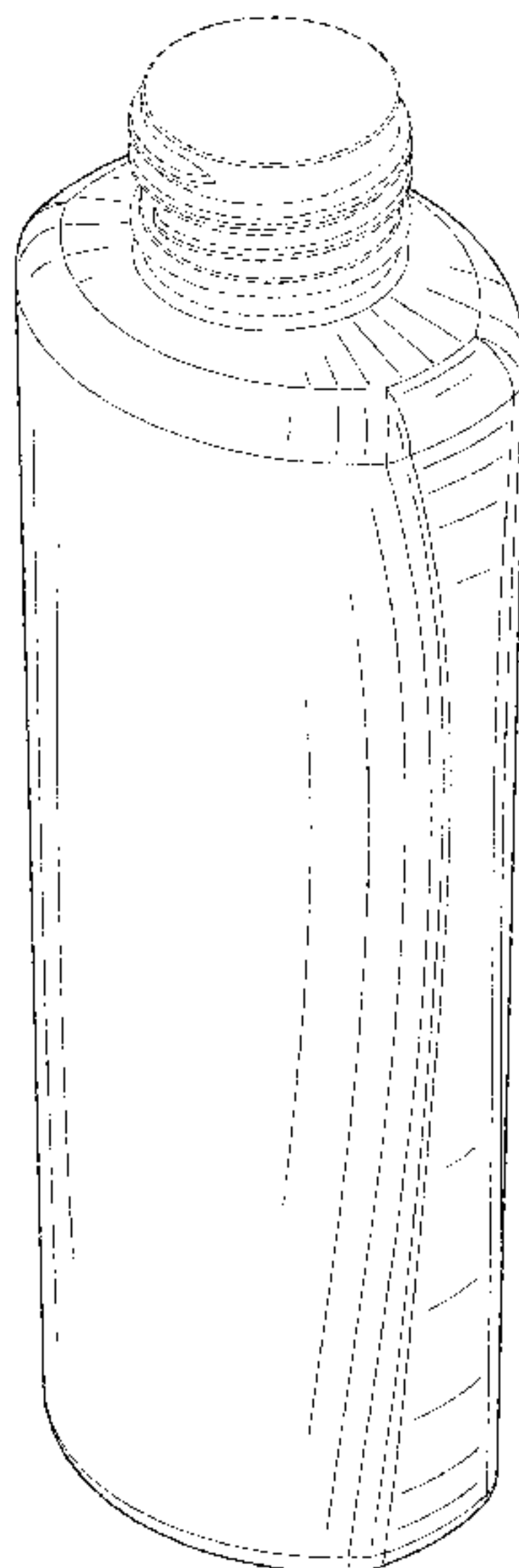
(57) **CLAIM**

The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a container, embodying our new design;
FIG. 2 is a first side view of the container of FIG. 1;
FIG. 3 is a second side view of the container of FIG. 1;
FIG. 4 is a third side view of the container of FIG. 1;
FIG. 5 is a fourth side view of the container of FIG. 1;
FIG. 6 is a top view of the container of FIG. 1; and,
FIG. 7 is a bottom view of the container of FIG. 1.
The broken line showing of portions of the bottle forms no part of the claimed design.

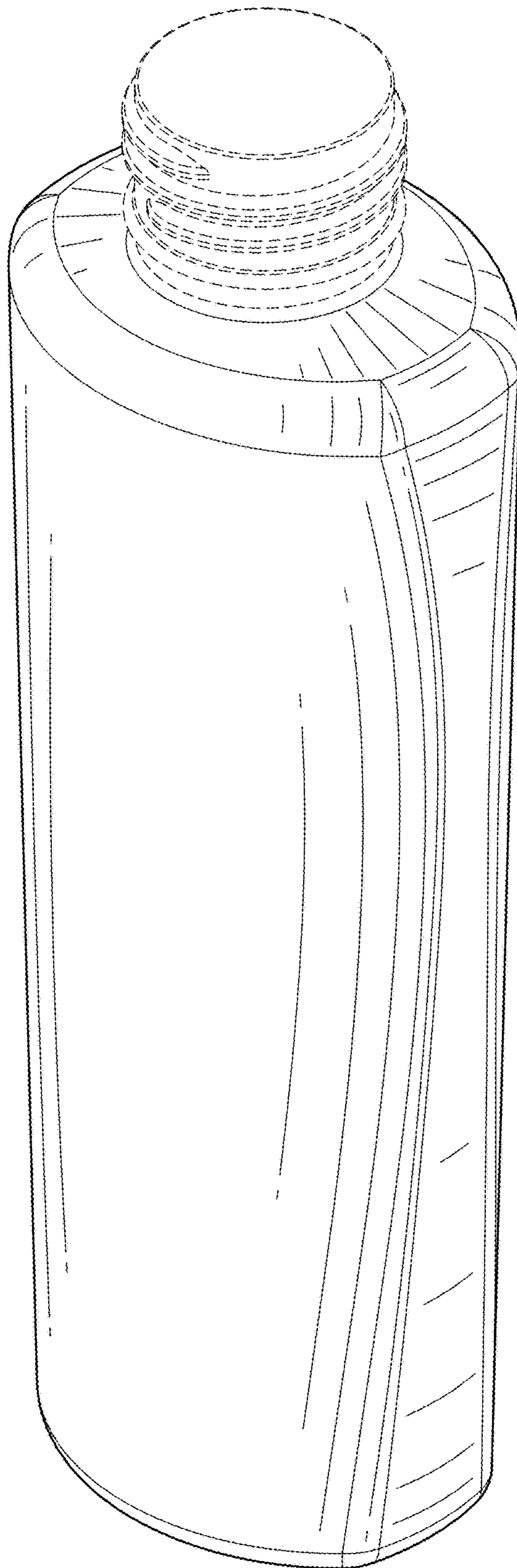

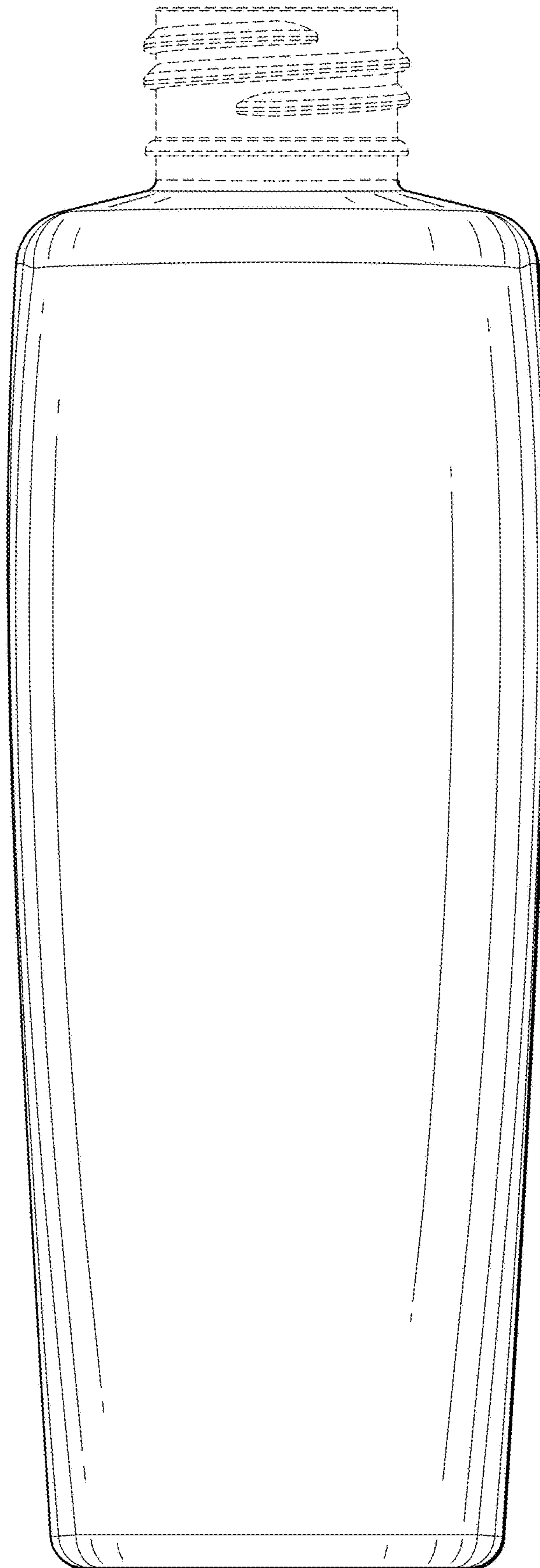

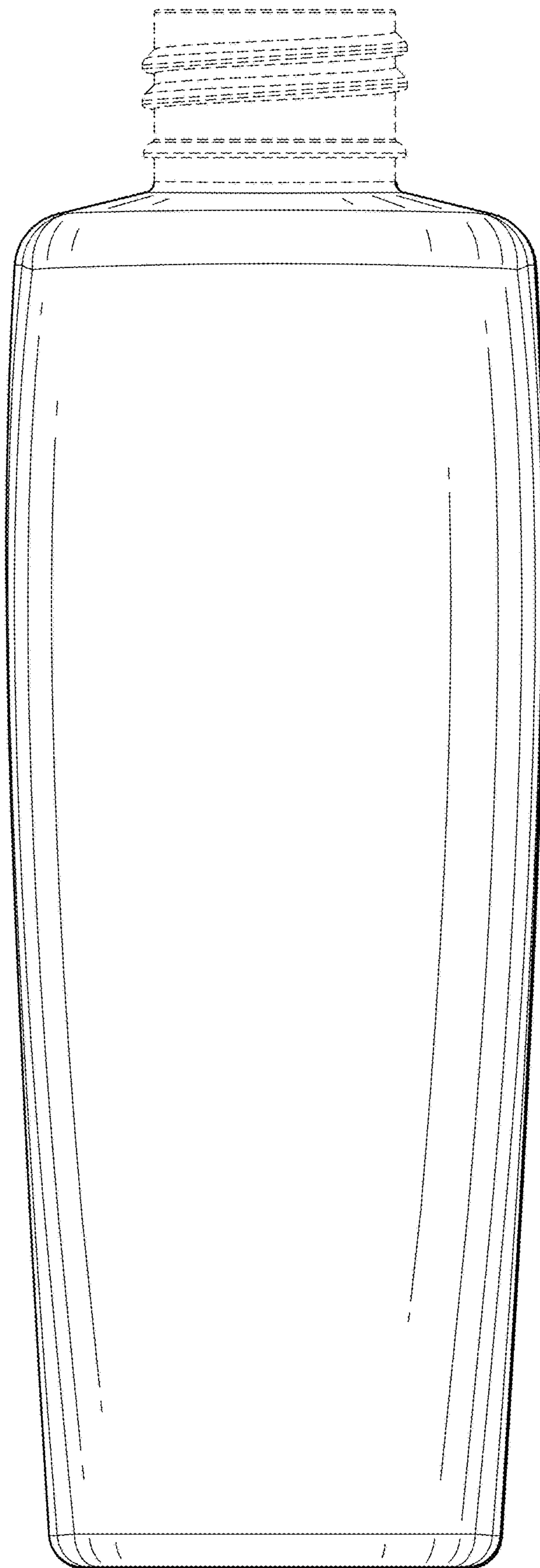

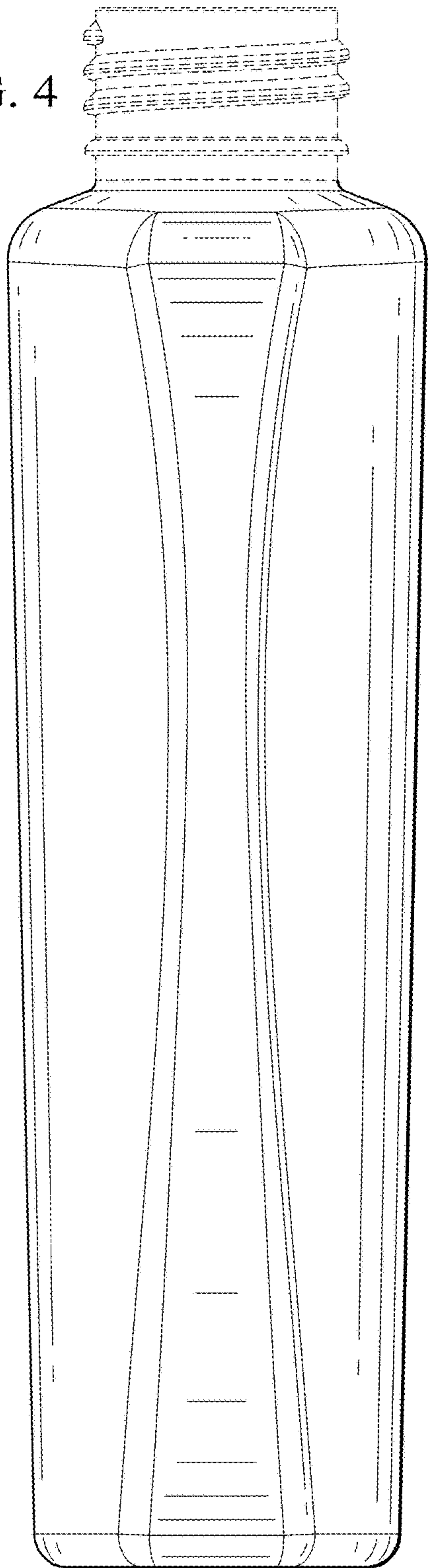
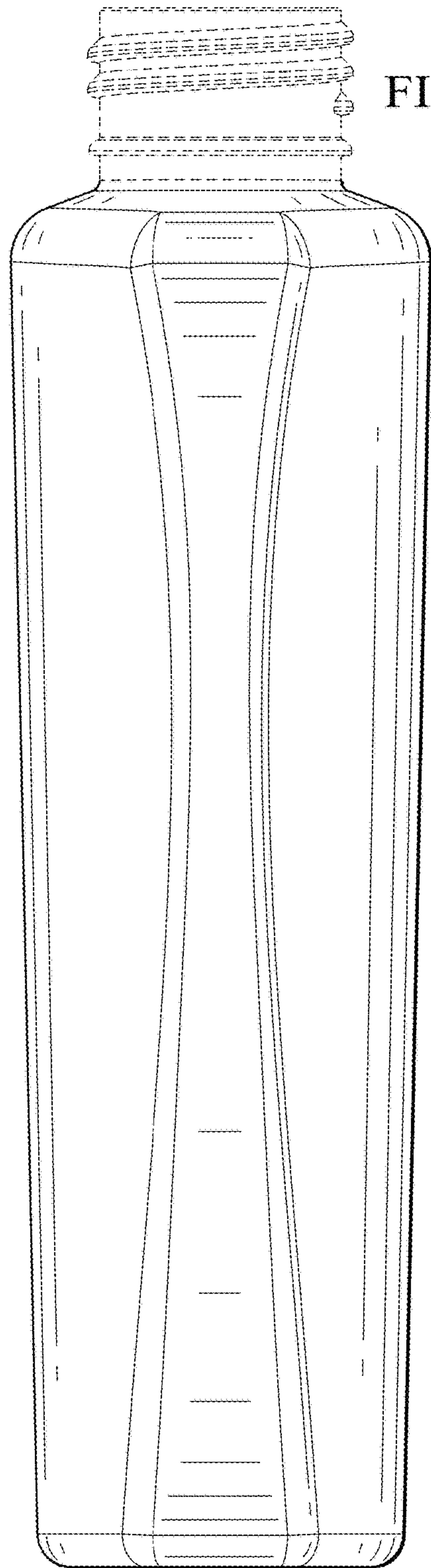

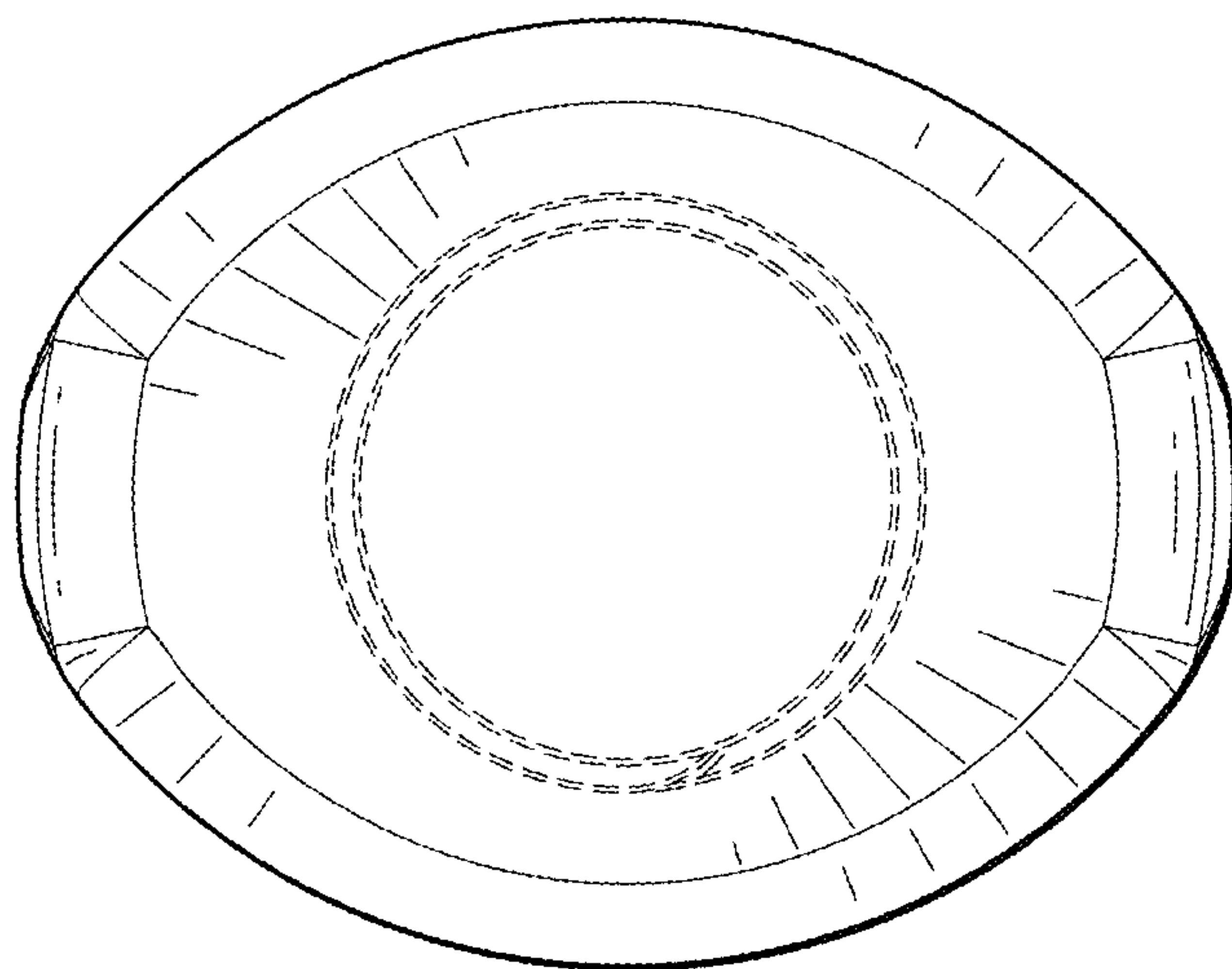

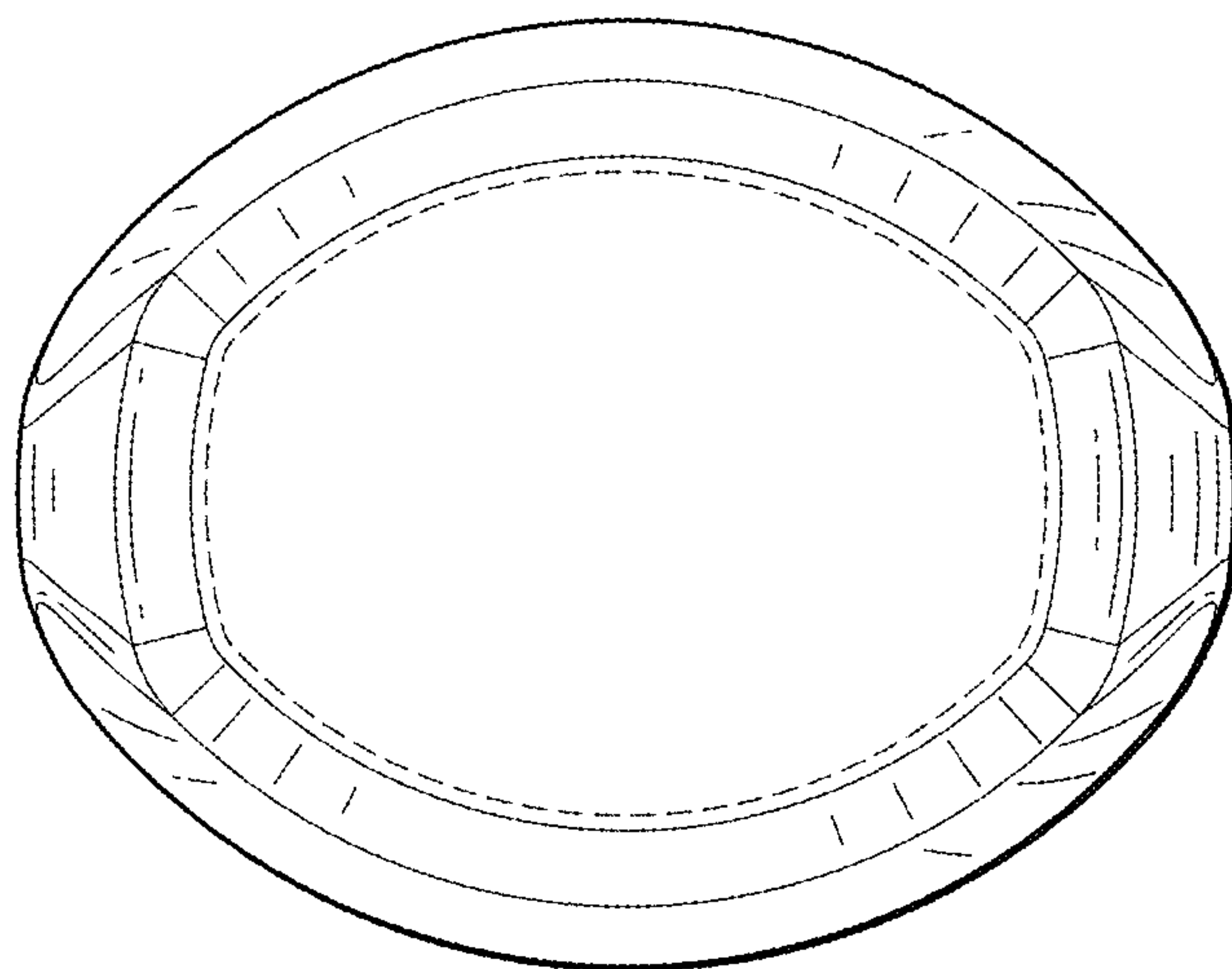
