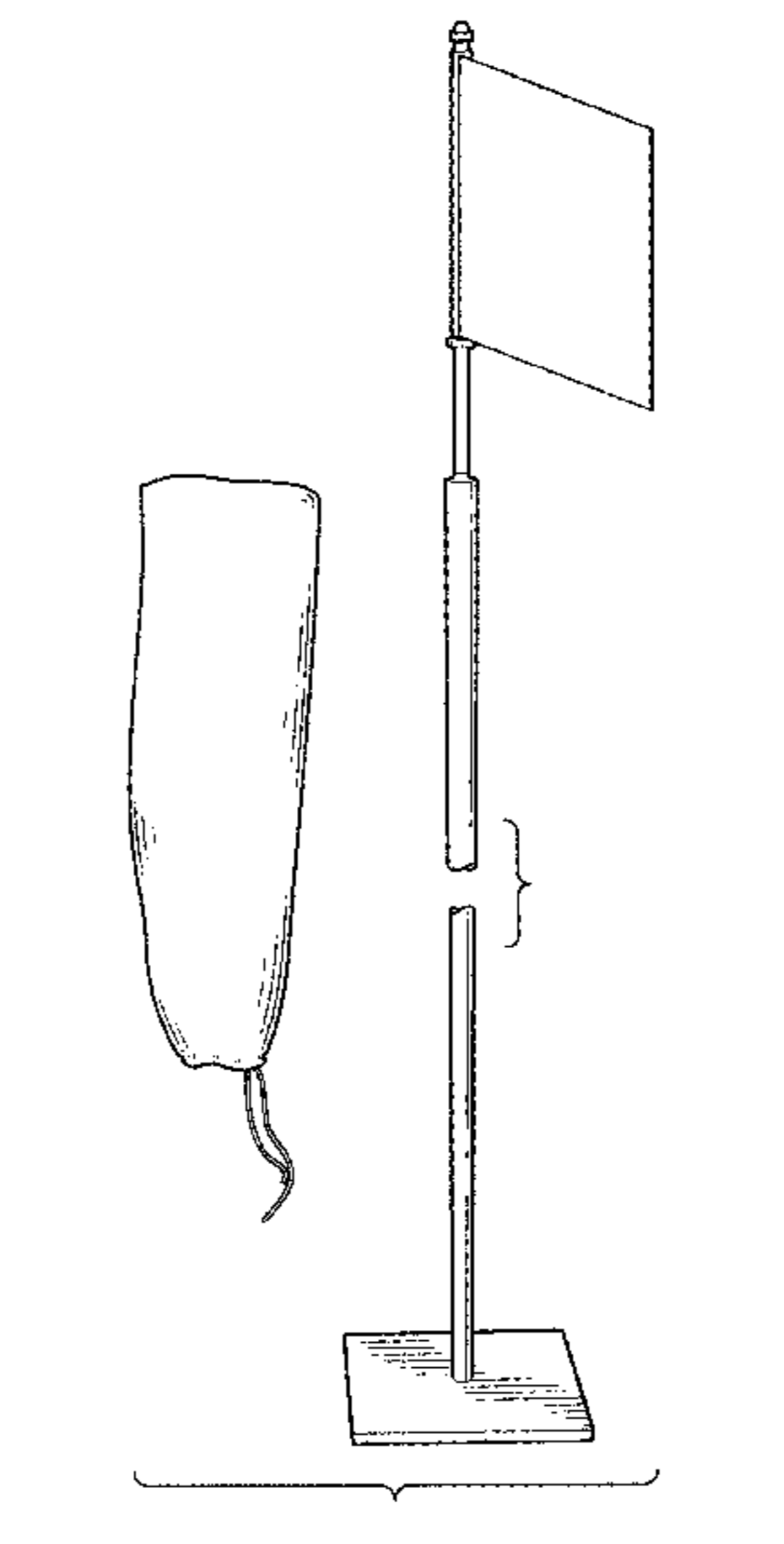

FIG. 1 is a perspective view of a combined flag pole, flag and cover, shown with the cover removed from the flag pole; FIG. 2 is a perspective view of a combined flag pole, flag and cover, shown with the cover in place on the flag pole; FIG. 3 is a front elevational view of the flag pole and flag, shown separately; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front elevation view of the cover, shown separately and folded into a rectangular configuration with the side seam at the center; FIG. 9 is a side elevation view thereof; FIG. 10 is a top plan view thereof; and, FIG. 11 is a bottom plan view thereof.

The claim is directed to the appearance of the combined flag pole, flag and cover in combination as shown in FIGS. 1 and 2. The flag pole, flag and cover have been shown separately in FIGS. 3-7 and 8-11 to show aspects of the design that may not be apparent in the other views.

The broken away symbols in the drawings indicate the appearance of any portion of the article between the break lines forms no part of the claimed design.

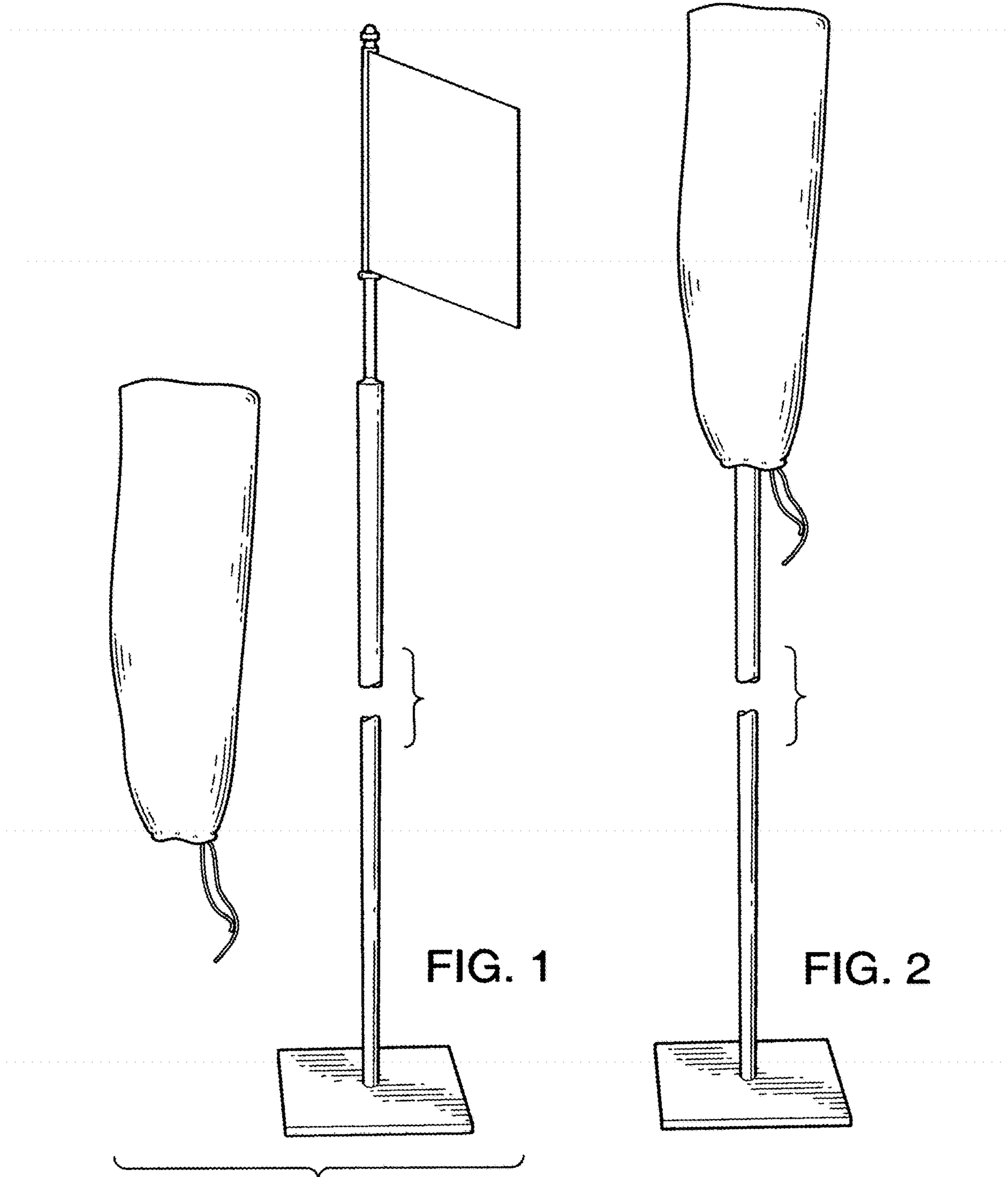

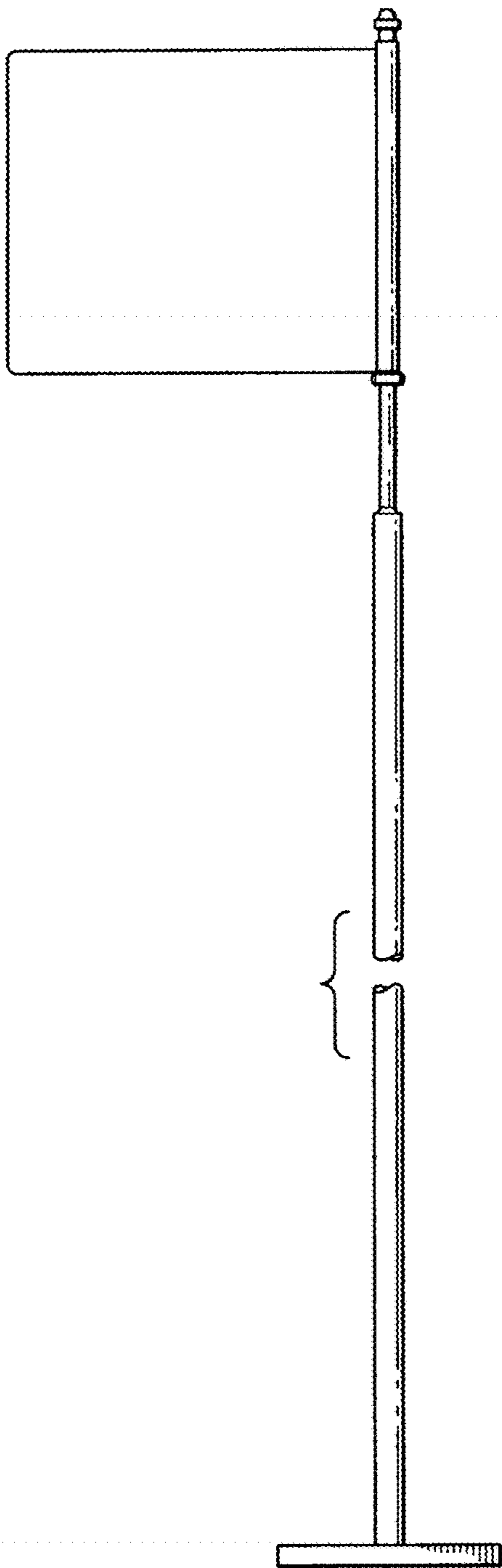

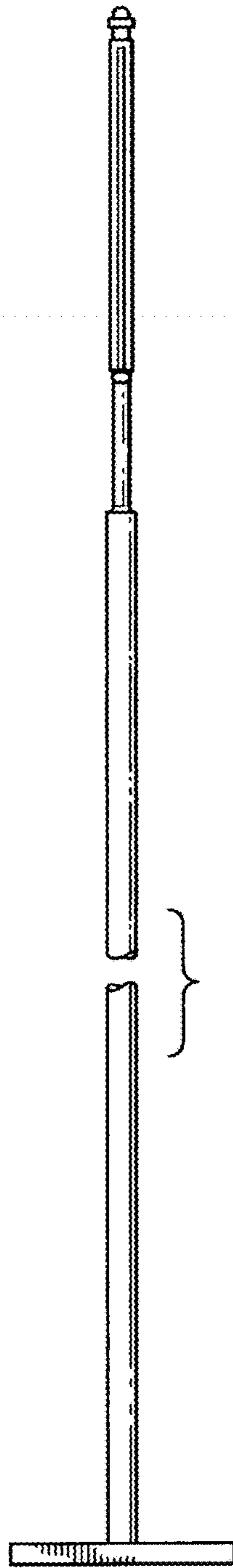

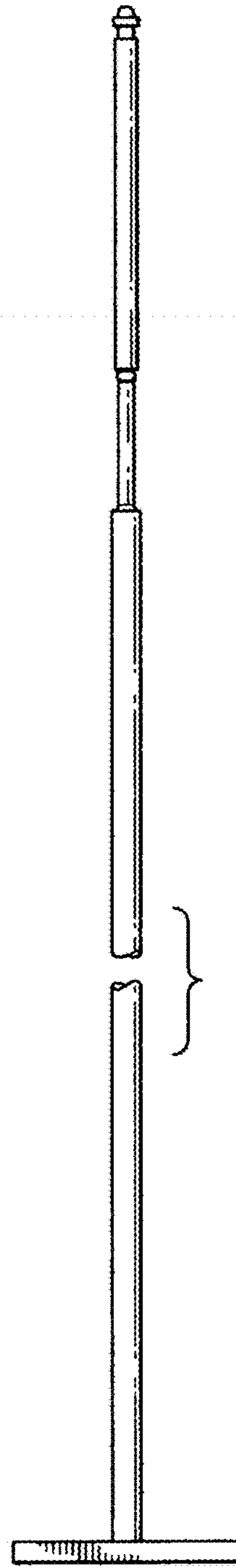

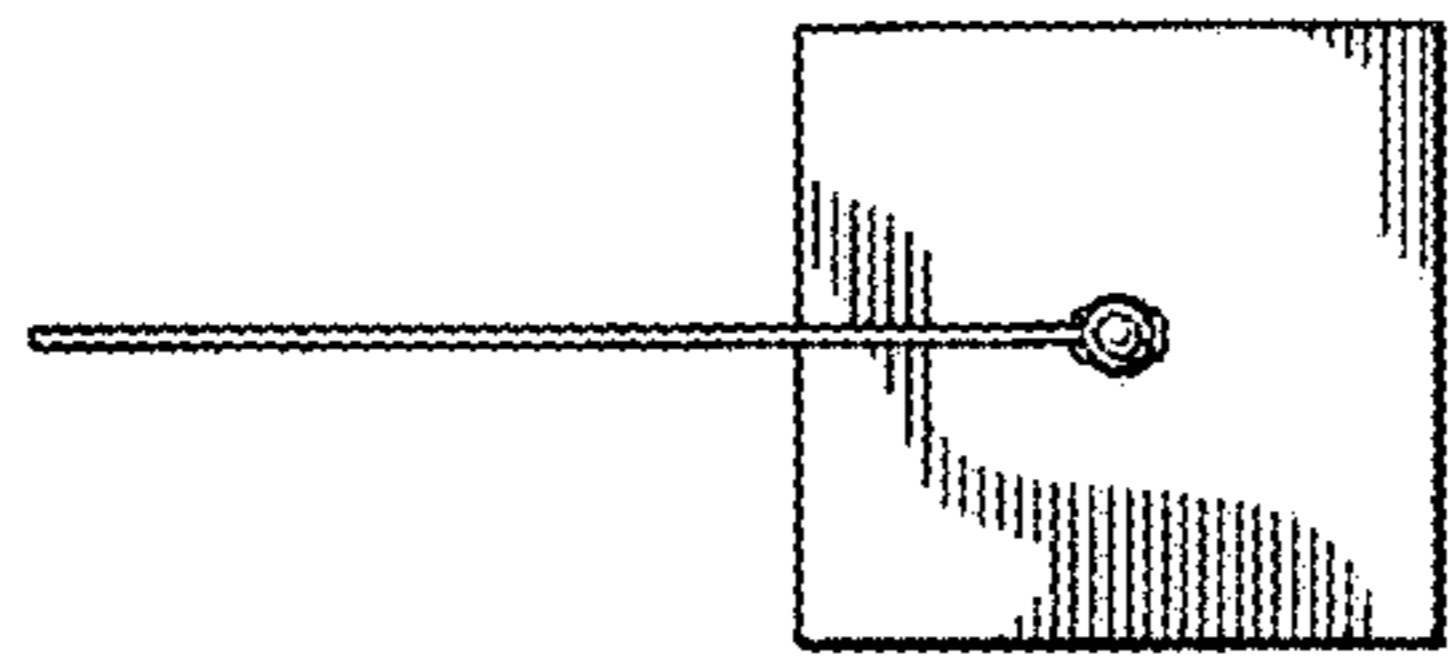

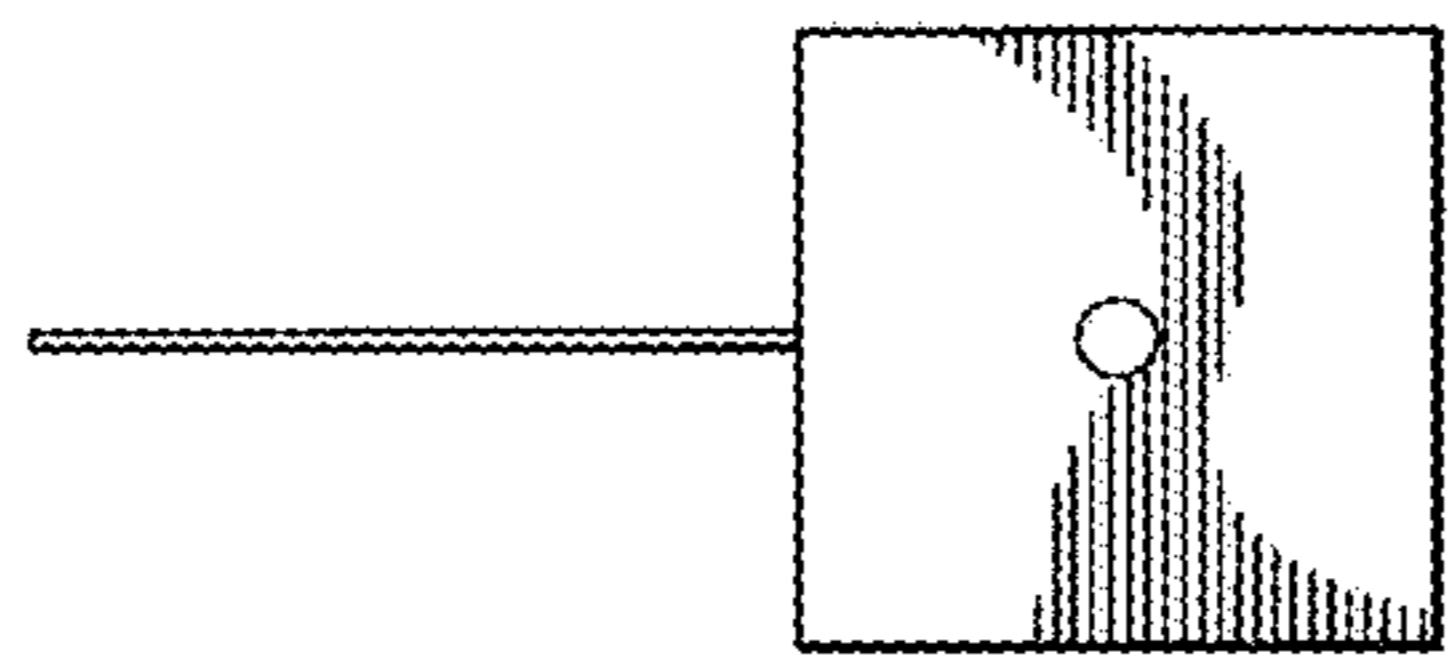

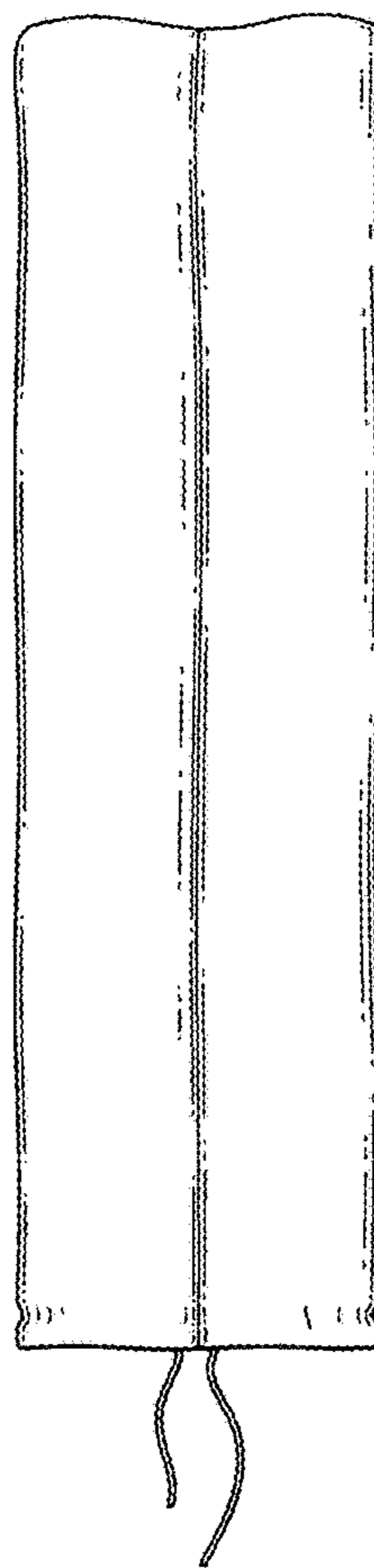

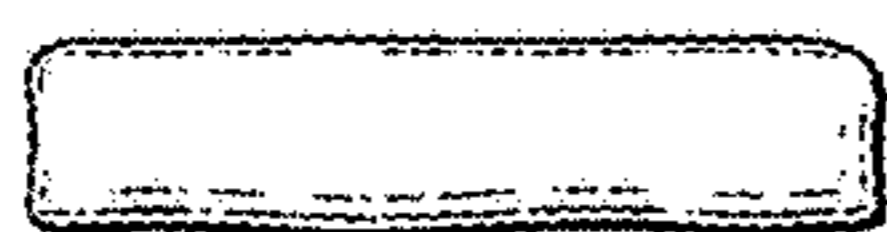
