(57) **CLAIM**

The ornamental design for a wheel for a motor vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wheel for a motor vehicle; FIG. 2 is a side elevation view of the wheel; and, FIG. 3 is a front elevation view of the wheel. The broken line areas show portions of the wheel for motor vehicle that form no part of the claimed design.

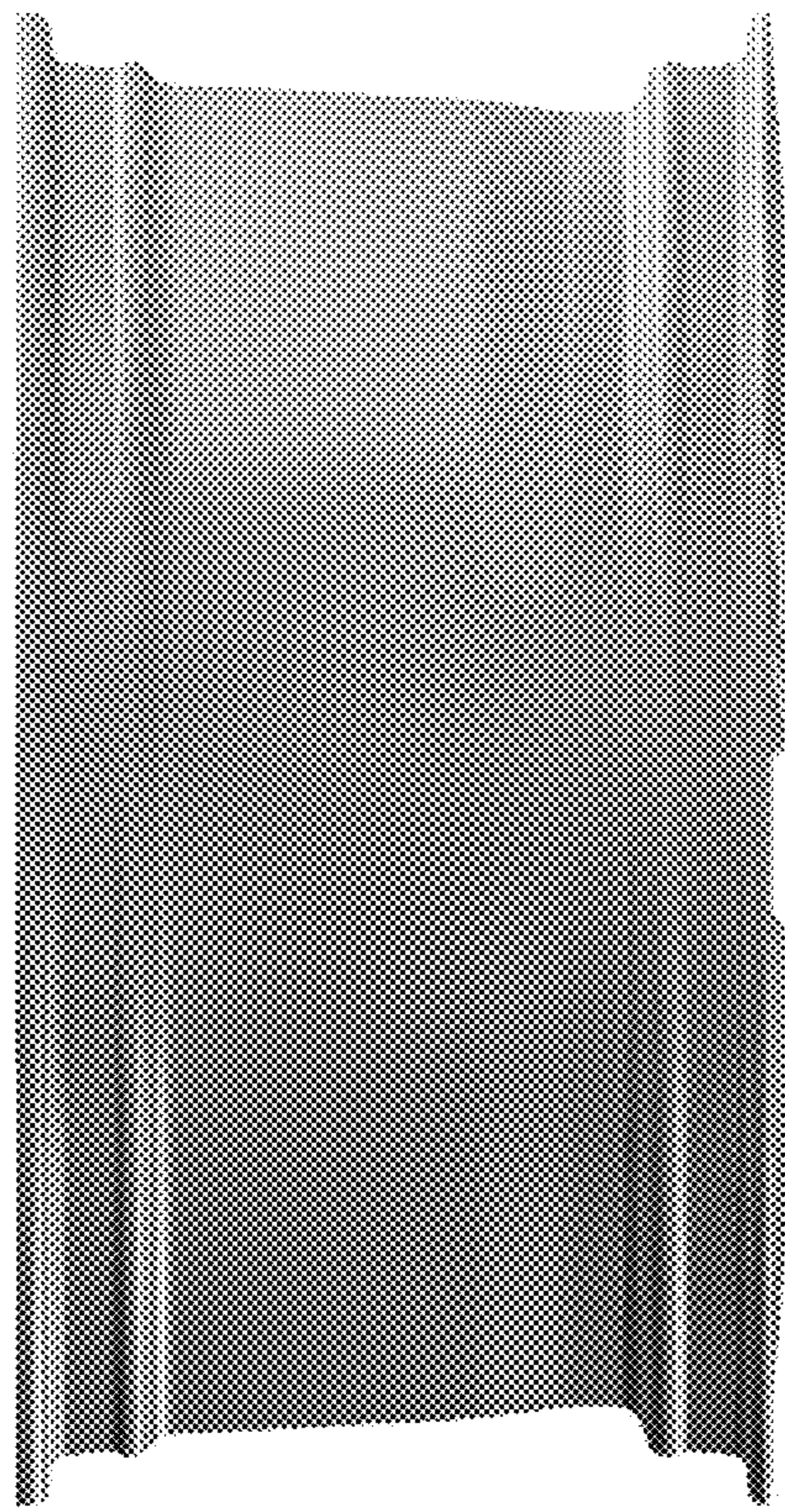
