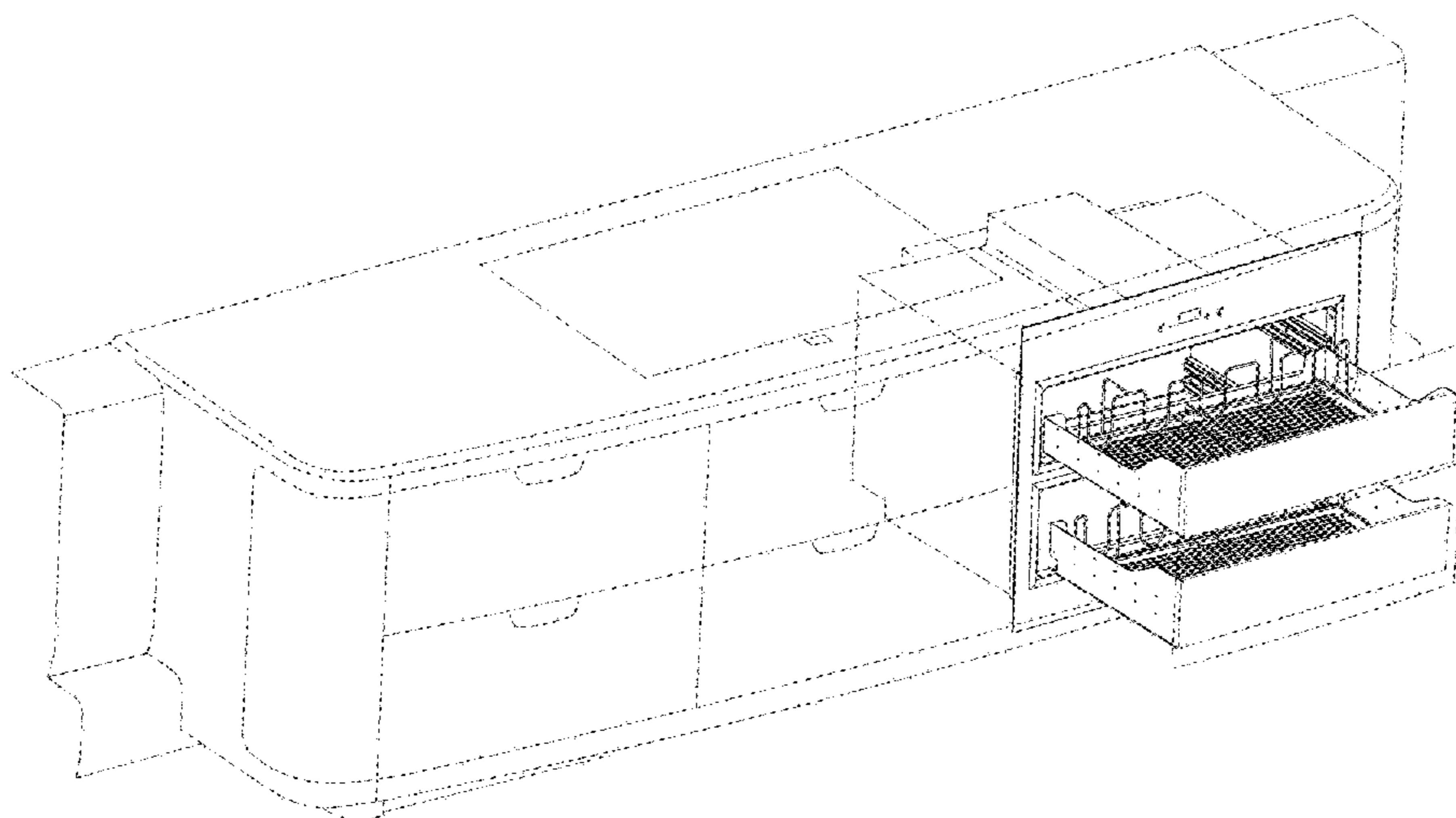
(57) **CLAIM**

The ornamental design for a wine cooler for aircraft, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a wine cooler for aircraft;  
 FIG. 2 is a front perspective view of the wine cooler removed from its environment for clarity of disclosure;  
 FIG. 3 is a front view of the wine cooler;  
 FIG. 4 is a top view of top view of the wine cooler;

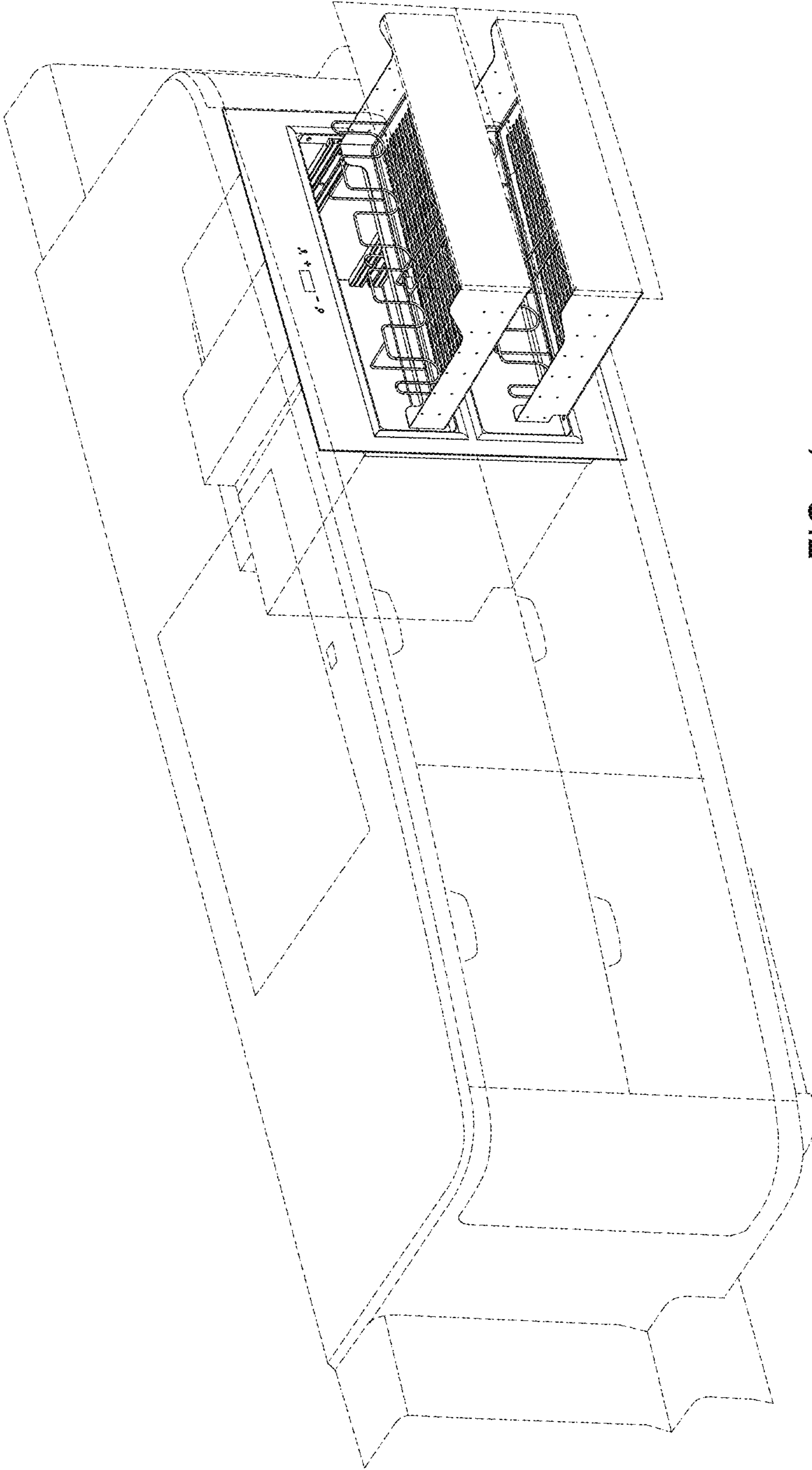

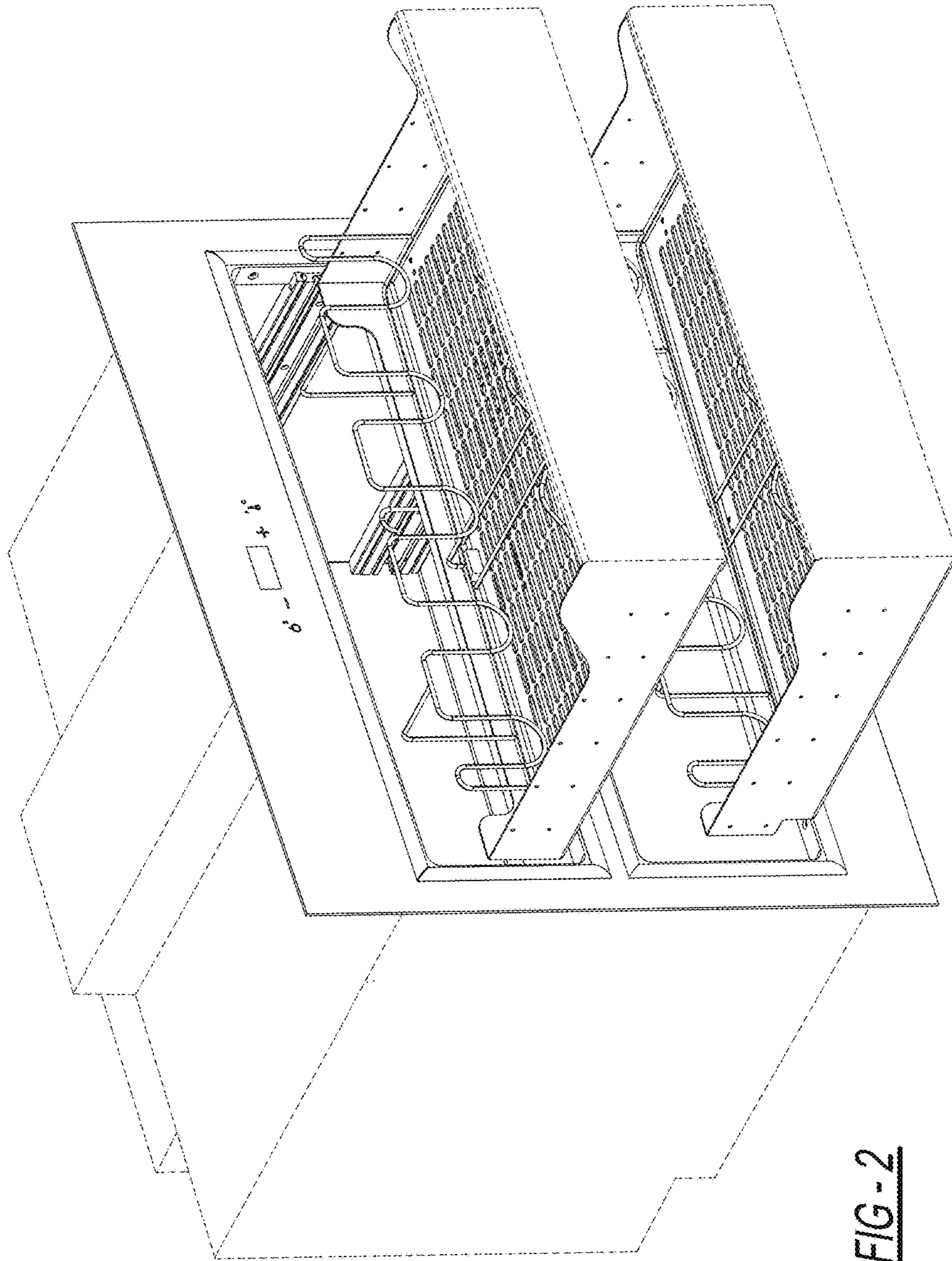

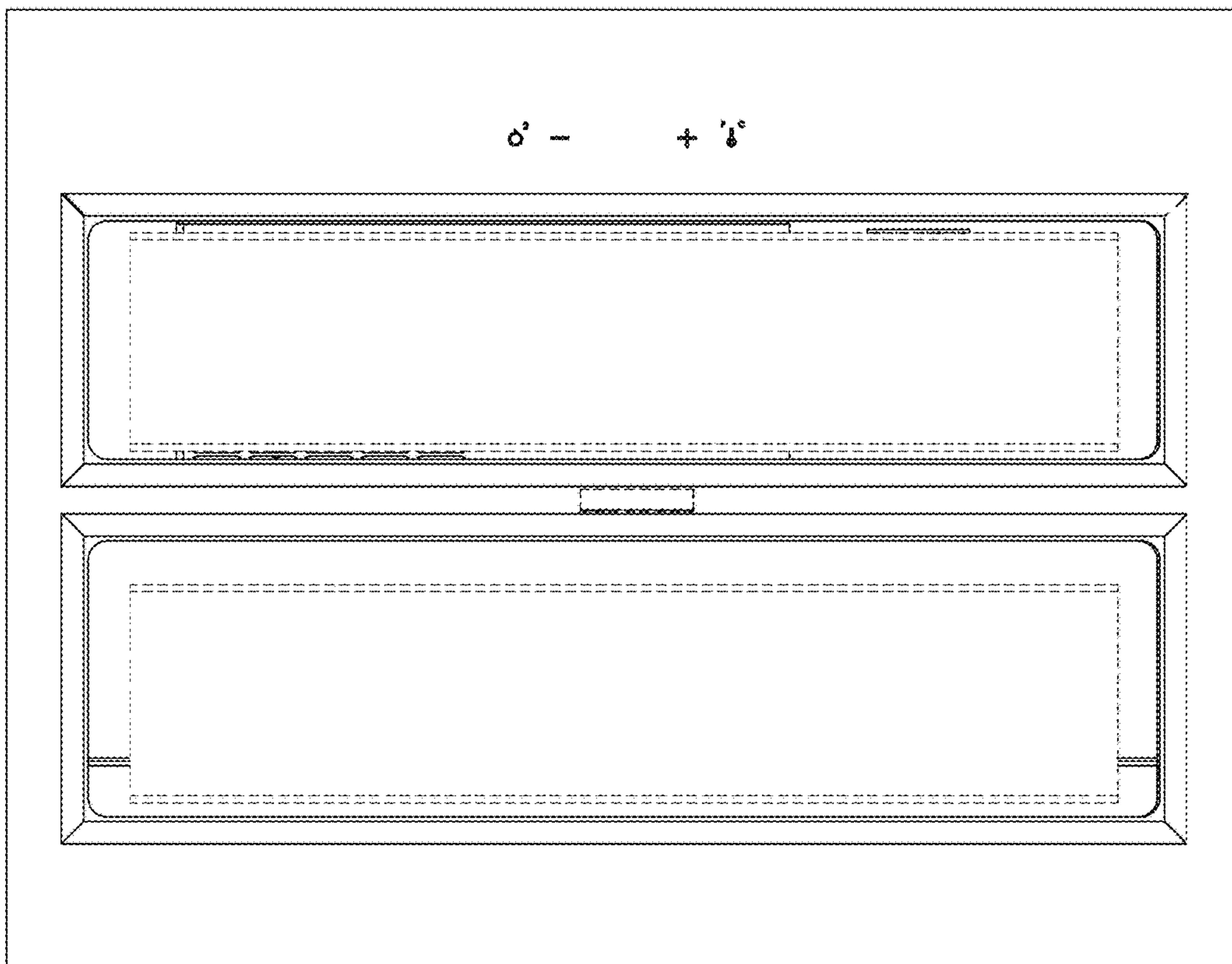

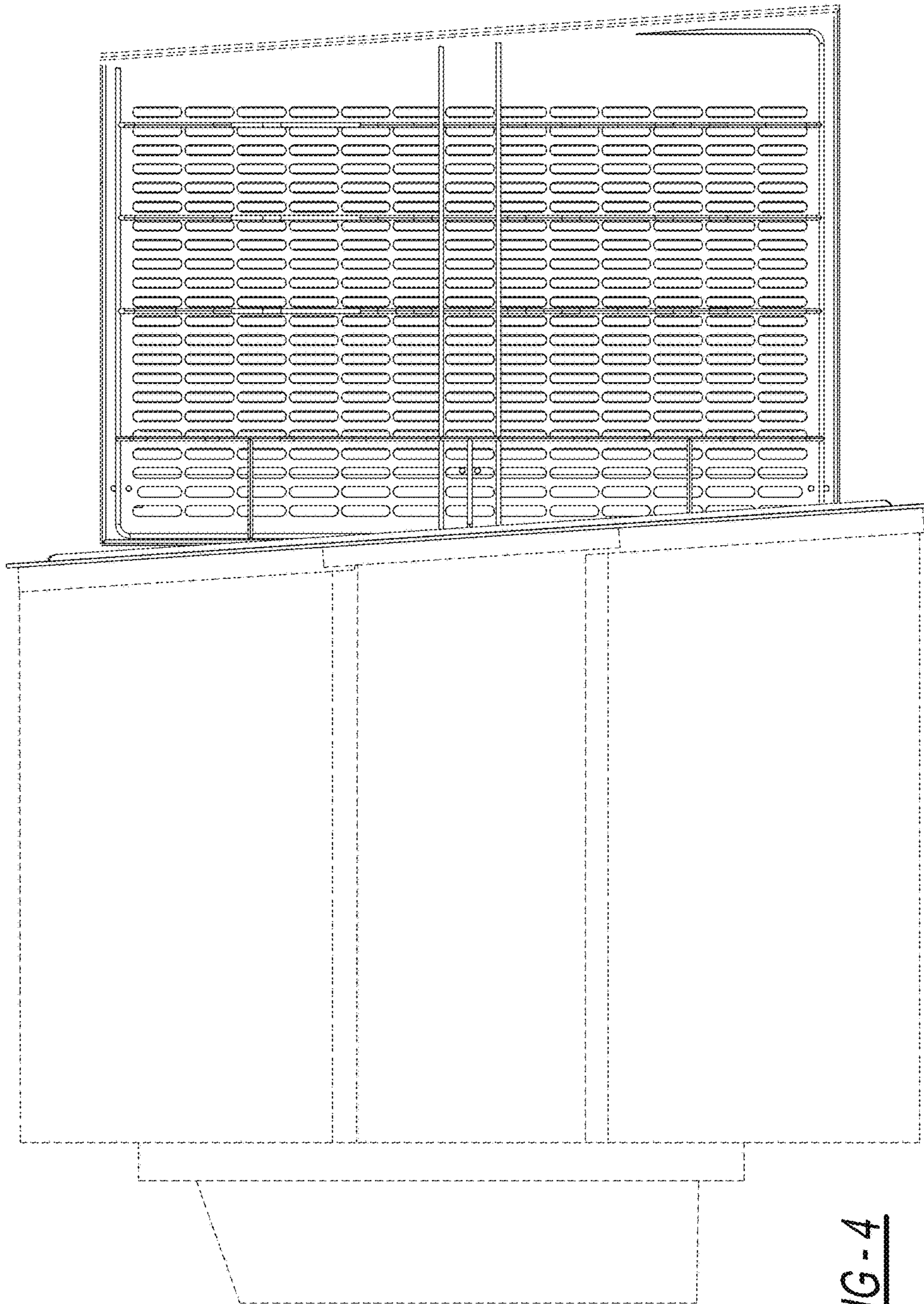

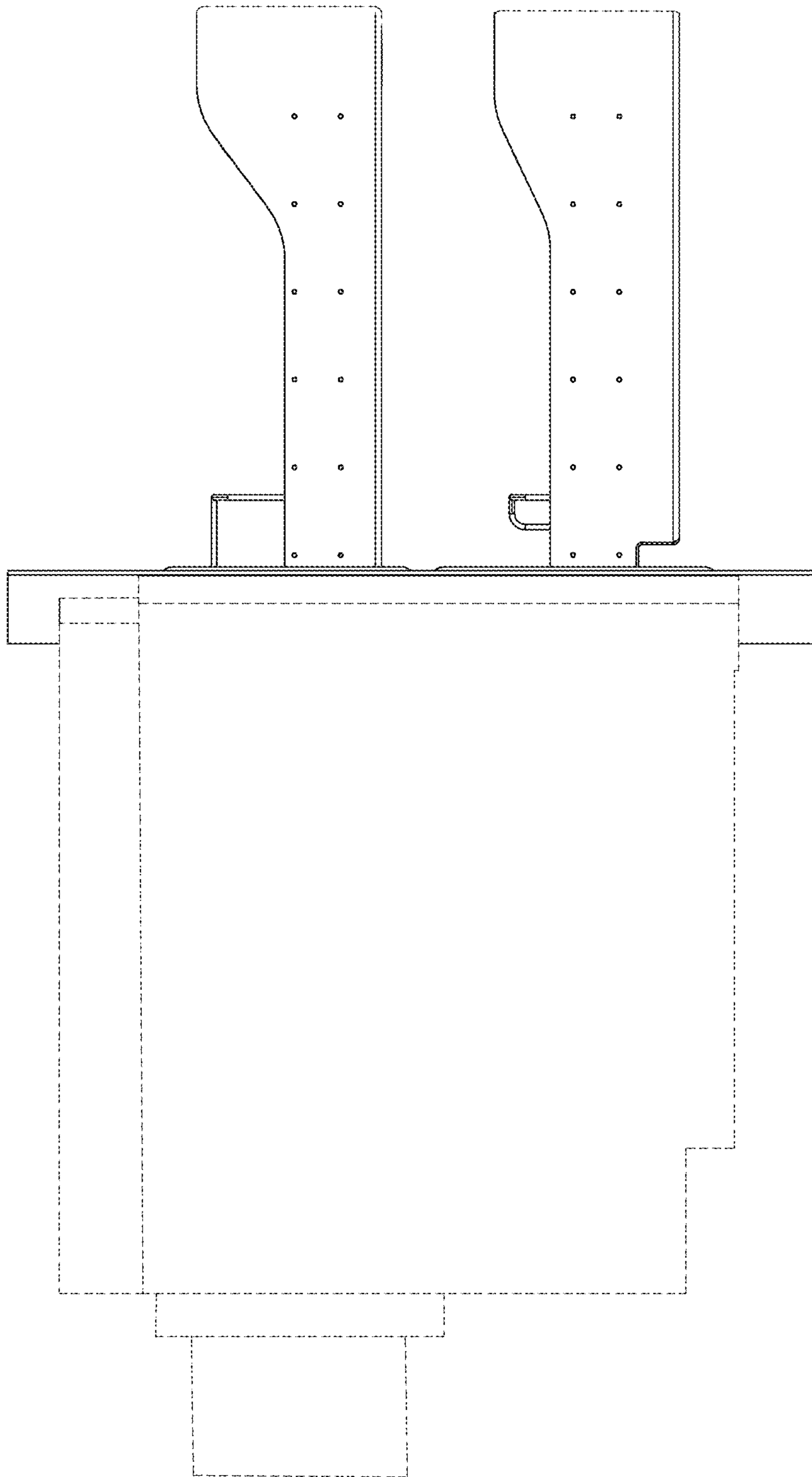

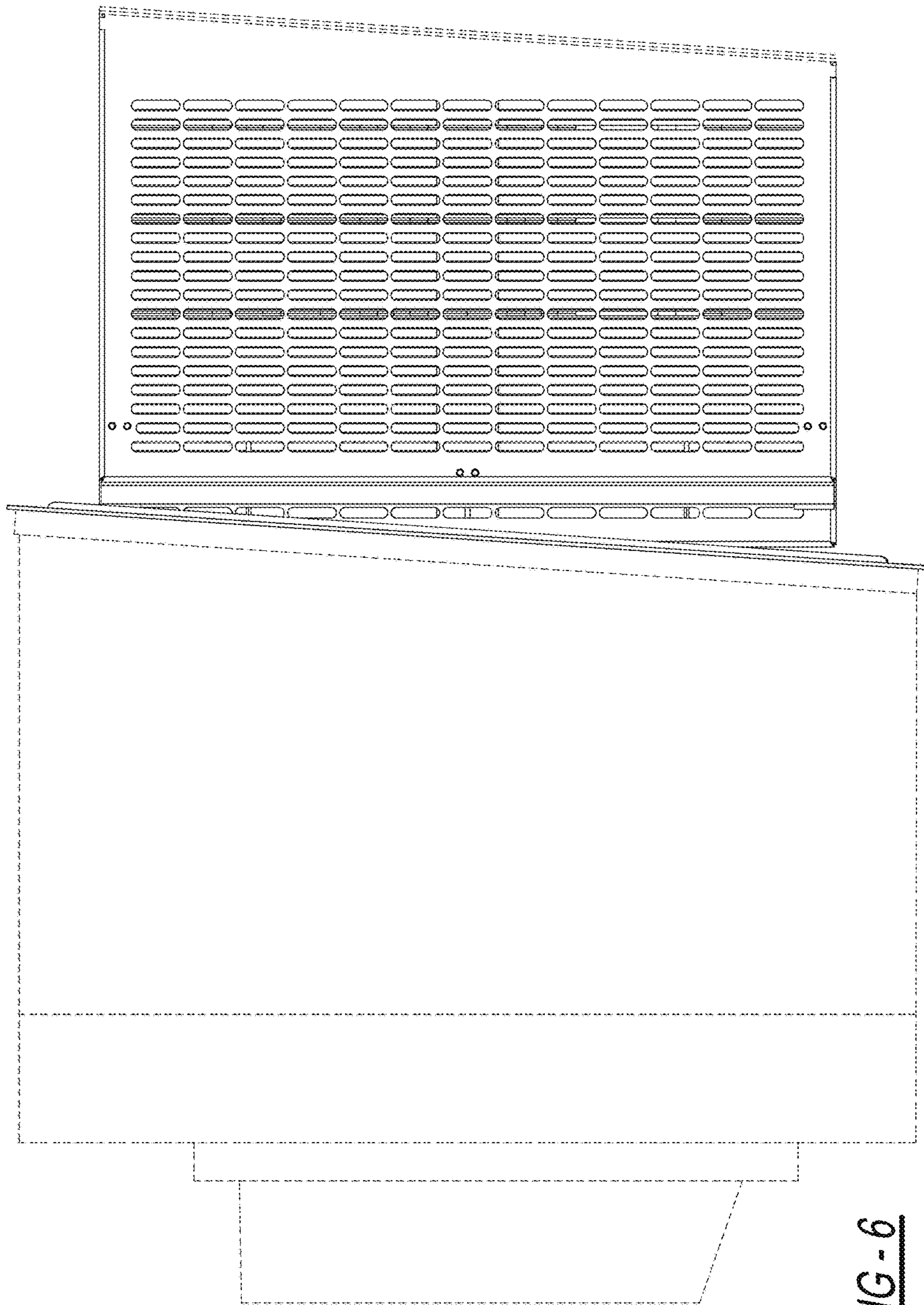

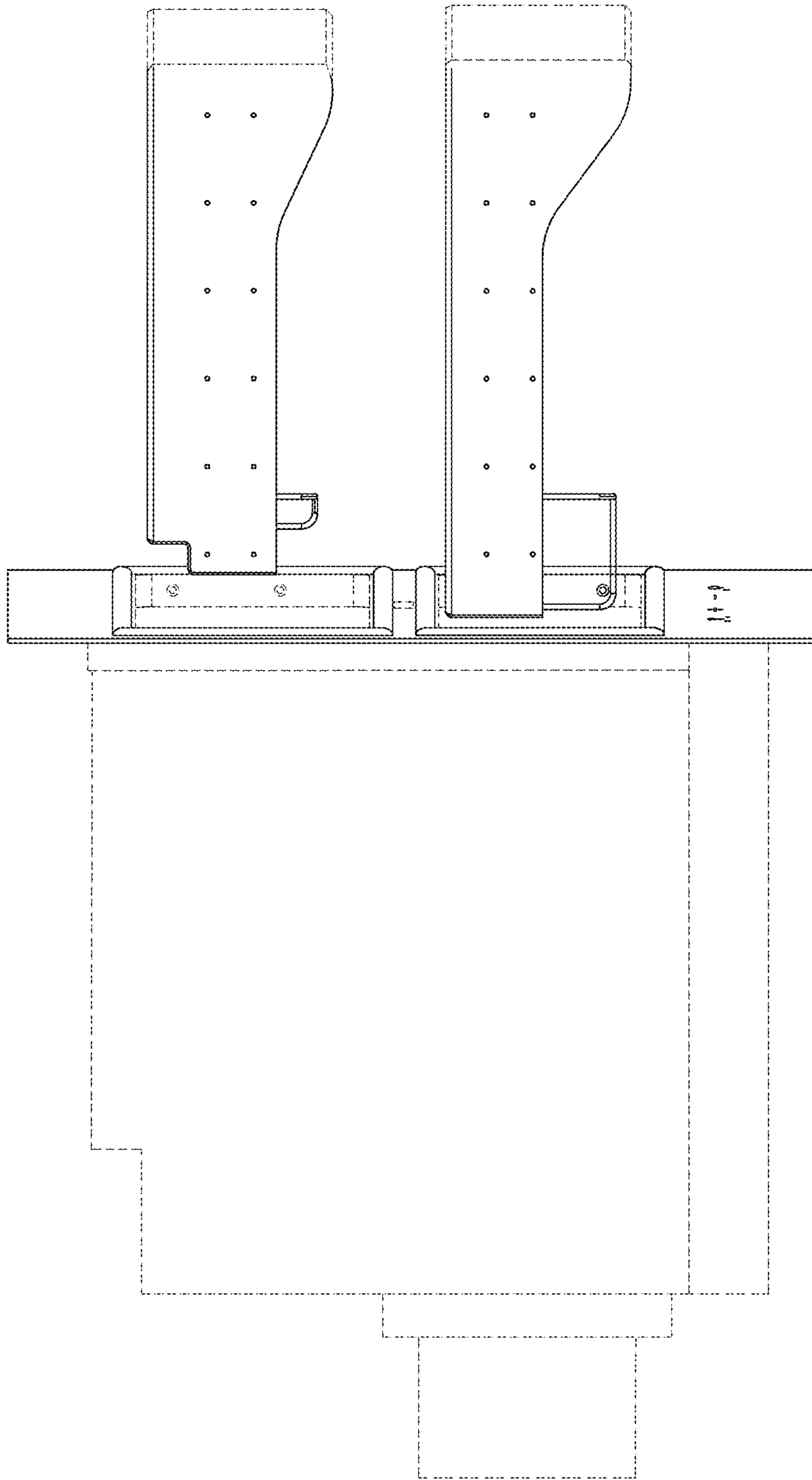
