(57) **CLAIM**

The ornamental design for a tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tire showing the claimed design;

FIG. 2 is a front view thereof, the rear view being the same; FIG. 3 is a top plan view thereof, the bottom plan view being the same;

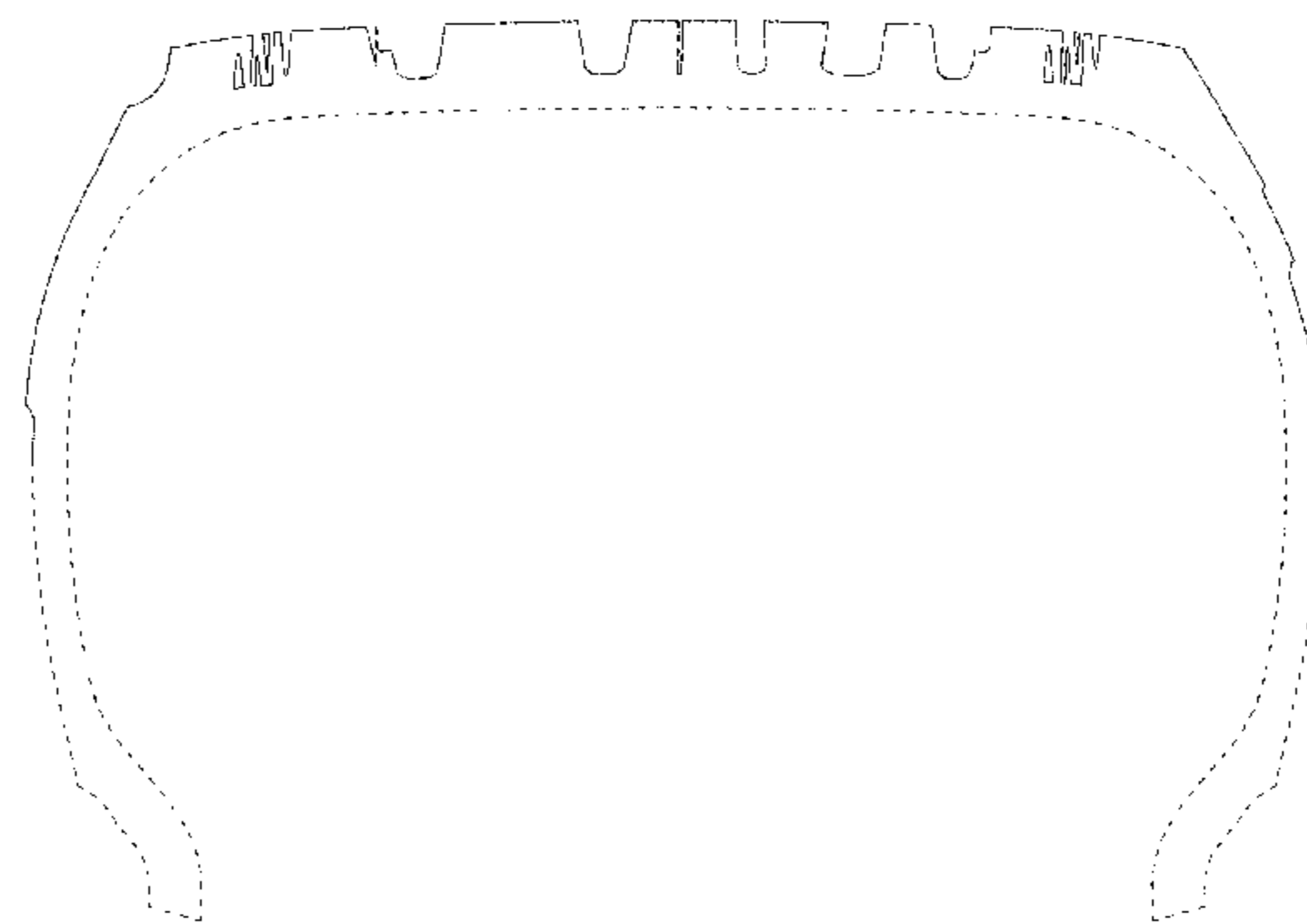
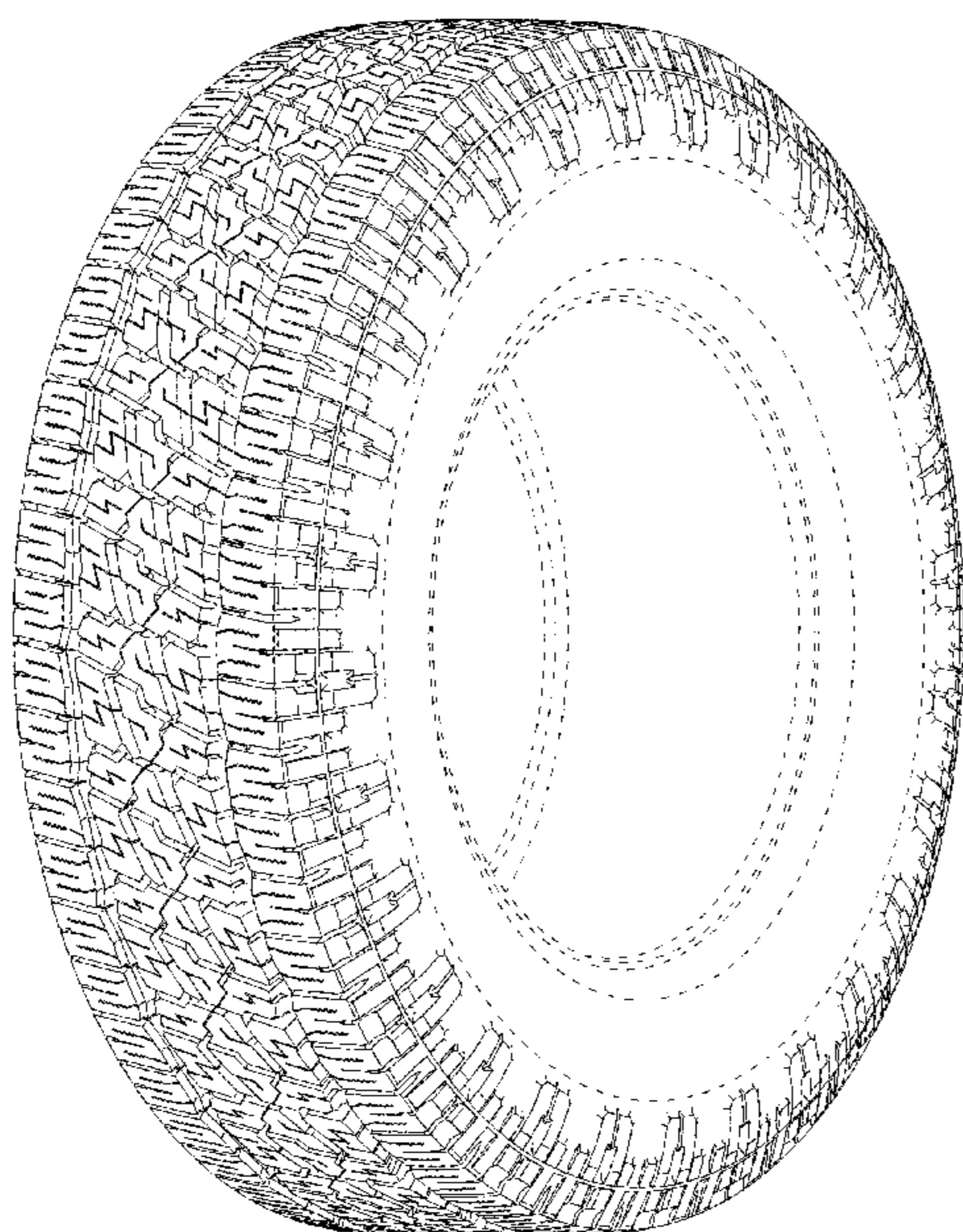
FIG. 4 is a right side view thereof, the left side view being the same;

FIG. 5 is an enlarged view of the portion 5-5 in FIG. 2; and, FIG. 6 is a cross-sectional view taken along line 6'-6' in FIG. 5 to line 6-6 in FIG. 4.

In the drawings, the broken lines showing portions of the sidewall, inner bead, and peripheral boundary depict portions of the tire that form no part of the claimed design.

The outermost broken line in FIGS. 1 and 4 is understood to represent the claim boundary.

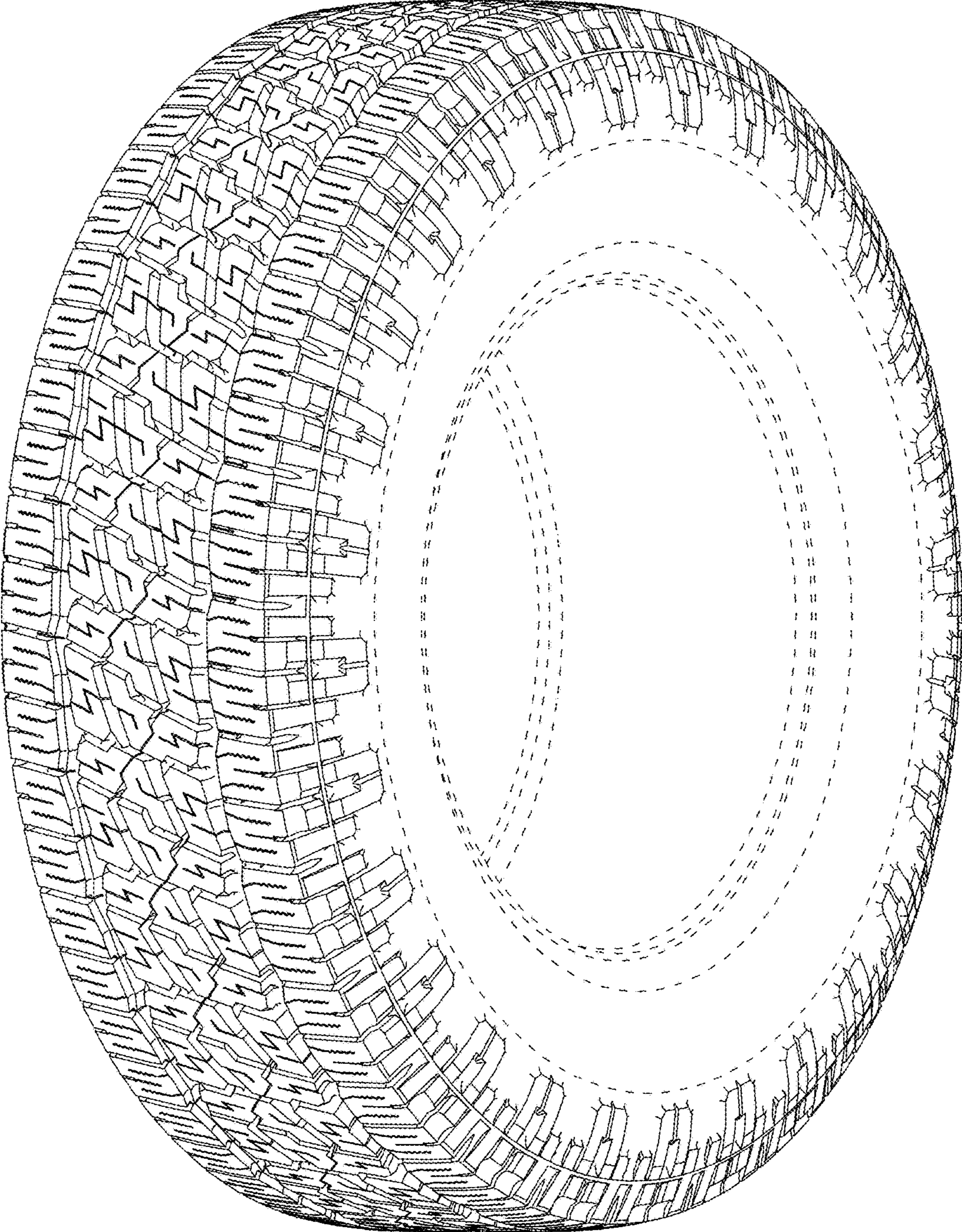

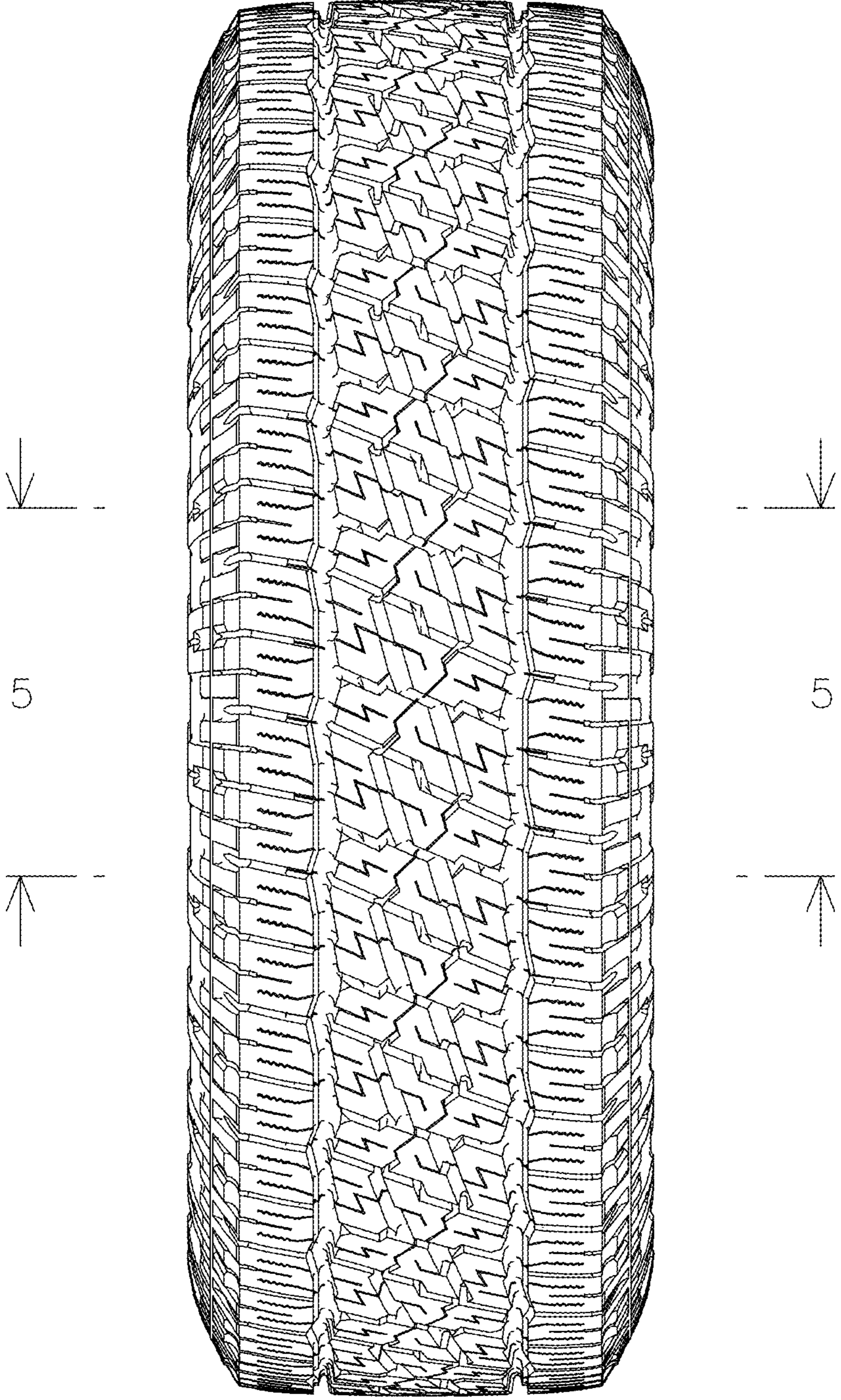

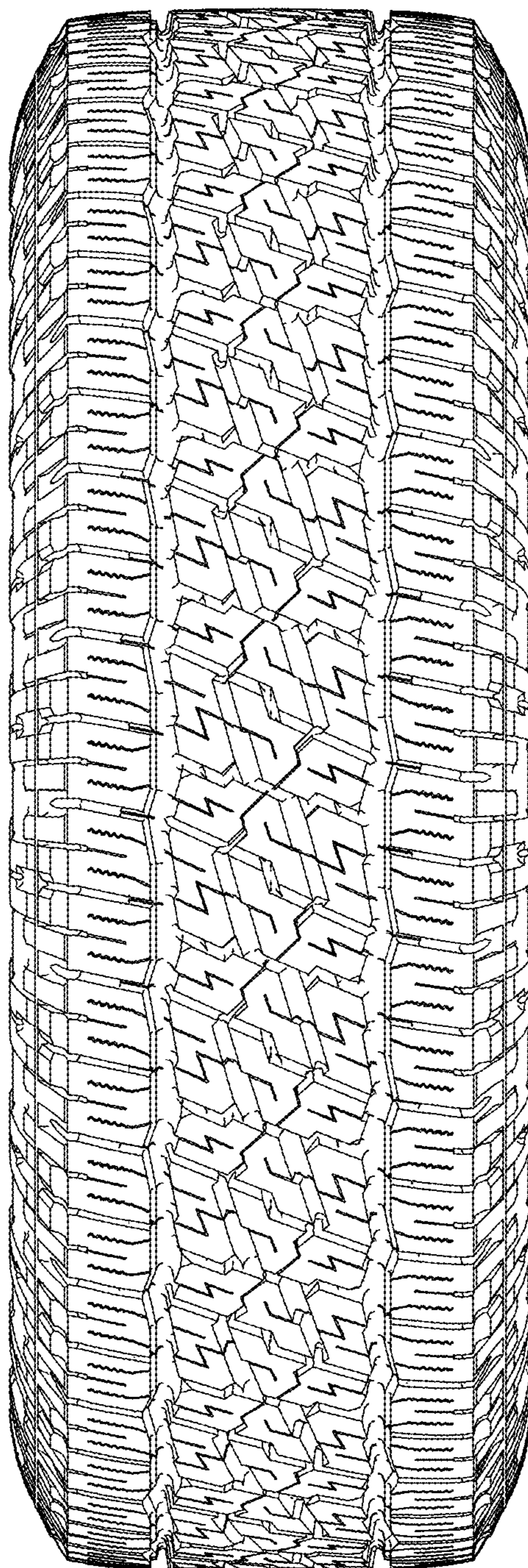

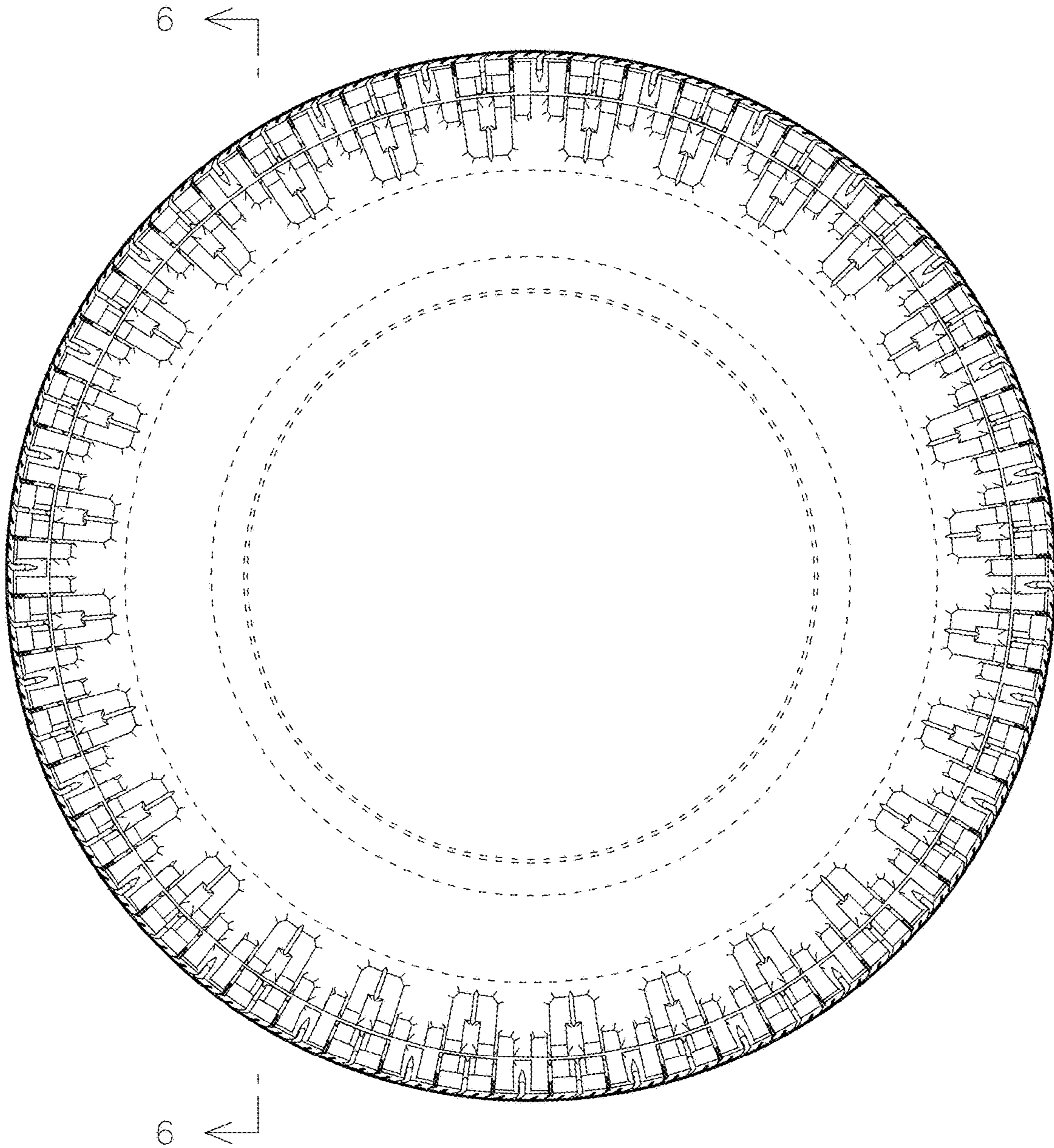

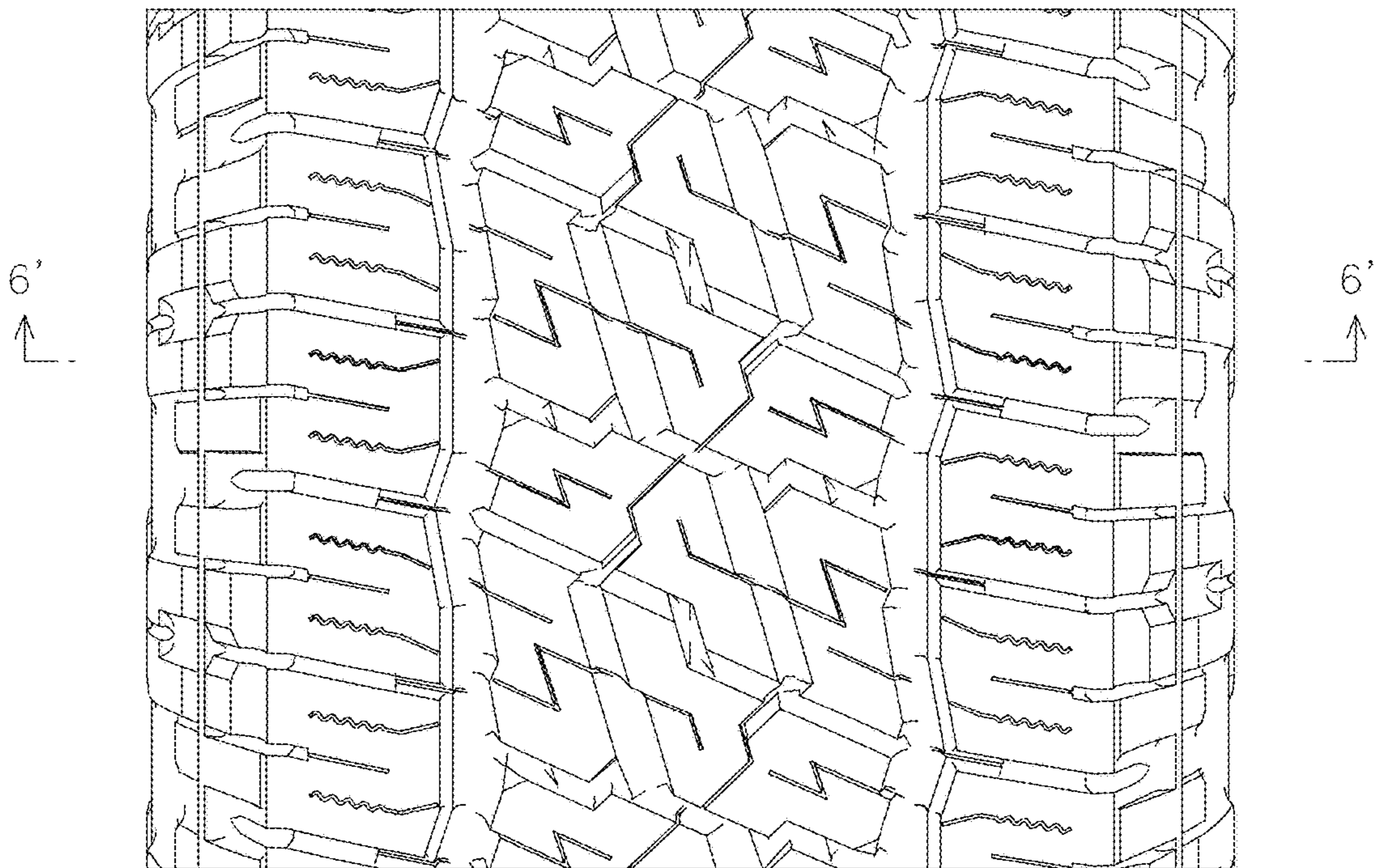

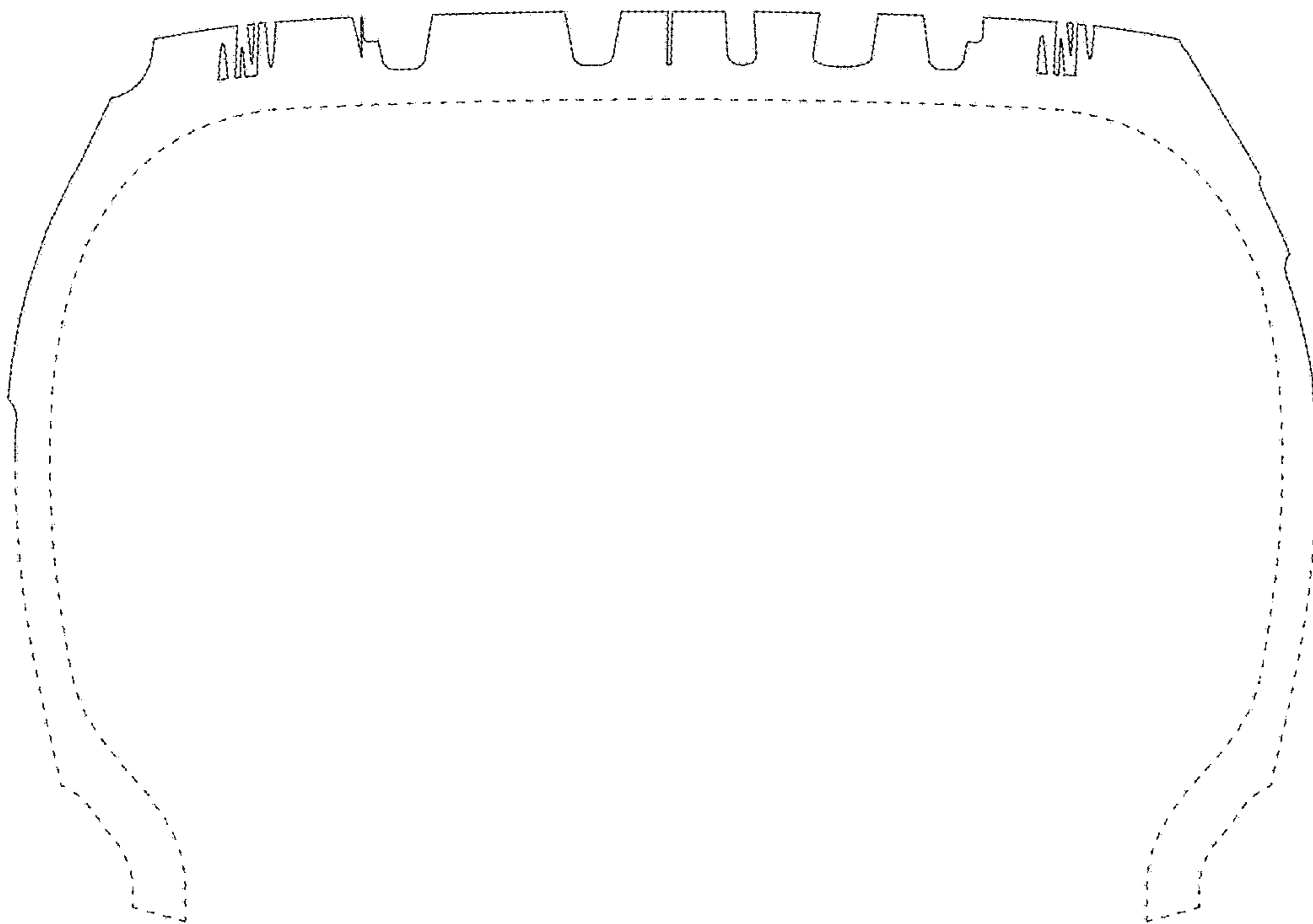
