(57) **CLAIM**

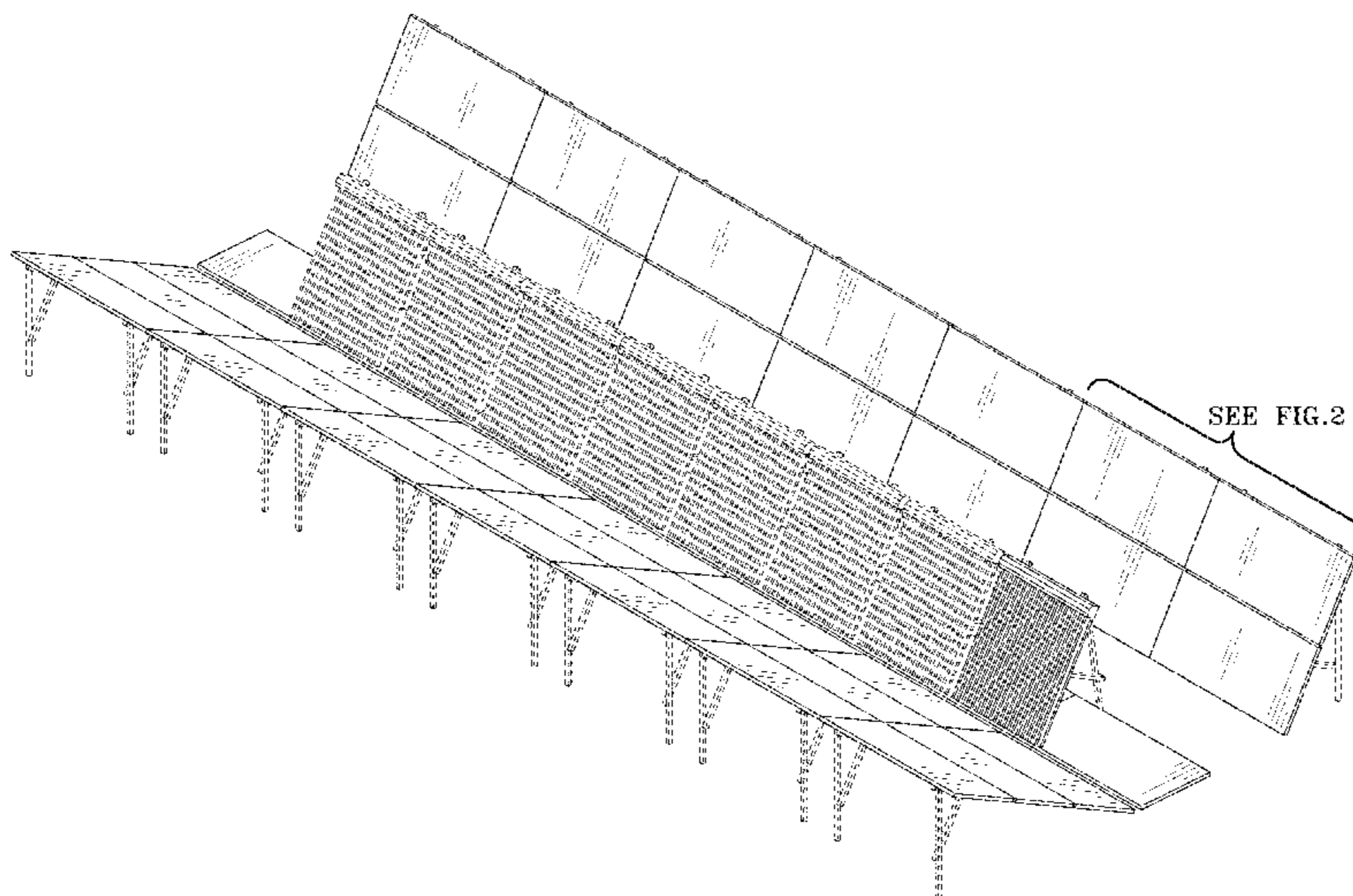
The ornamental design for a solar energy collector, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a solar energy collector showing my new design;
FIG. 2 is an enlarged perspective view of the highlighted region of FIG. 1 showing the front top and sides of the solar energy collector;
FIG. 3 is a right side elevation view of the solar energy collector; the left side elevation view being a mirror image thereof;
FIG. 4 is a front elevation view of the solar energy collector as shown in FIG. 2;
FIG. 5 is rear elevation view of the solar energy collector as shown in FIG. 2;
FIG. 6 is a top plan view of the solar energy collector as shown in FIG. 2; and,
FIG. 7 is a bottom plan view of the solar energy collector as shown in FIG. 2.

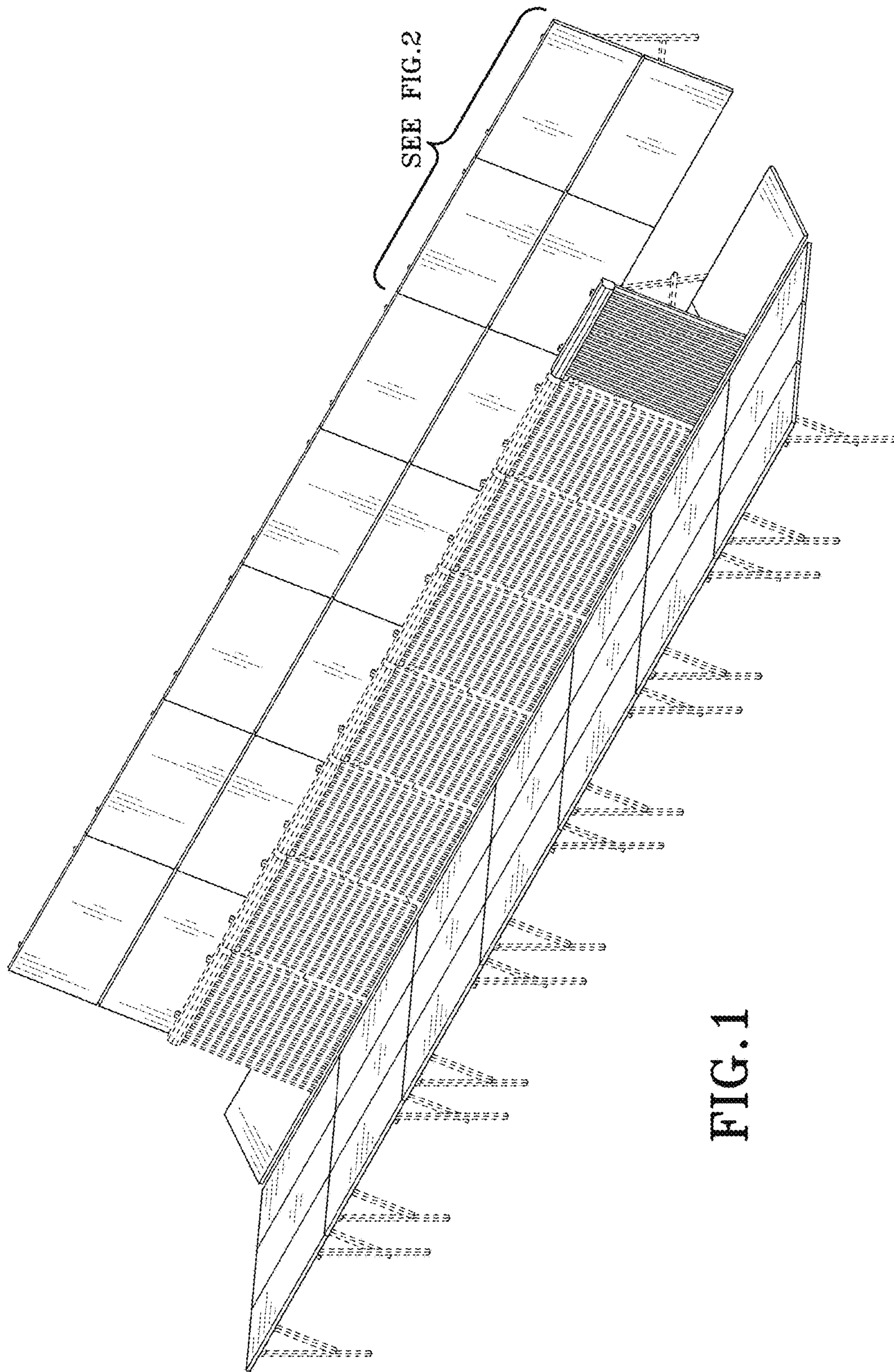

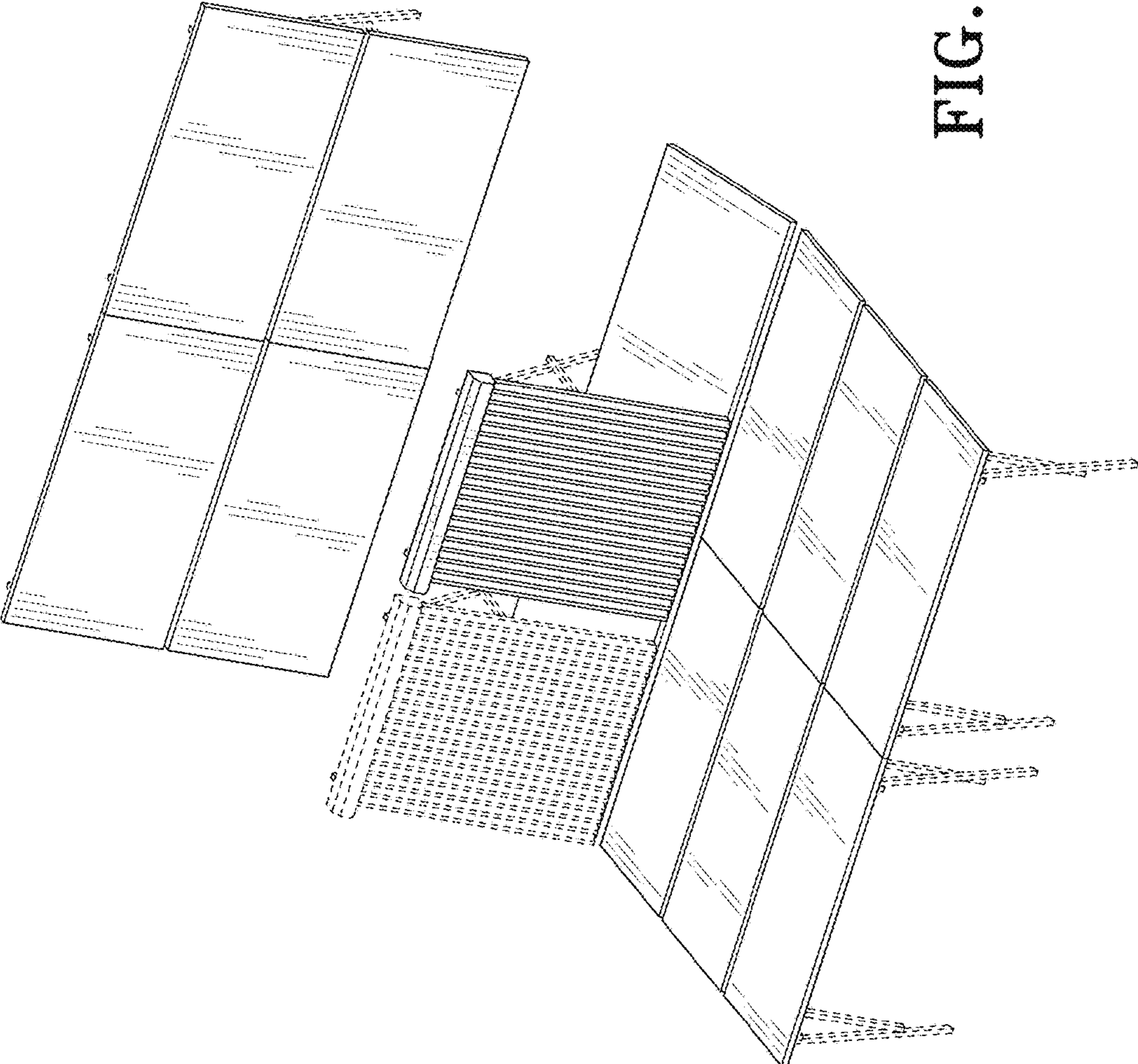

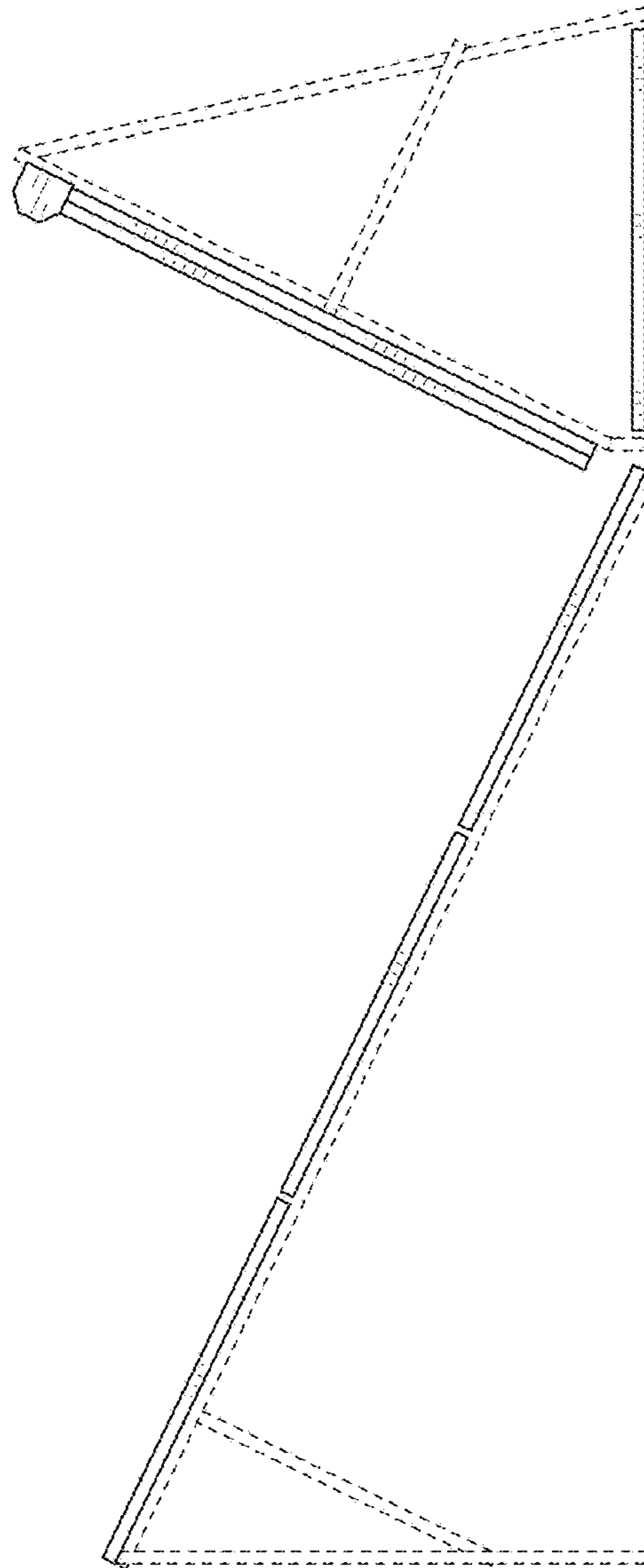
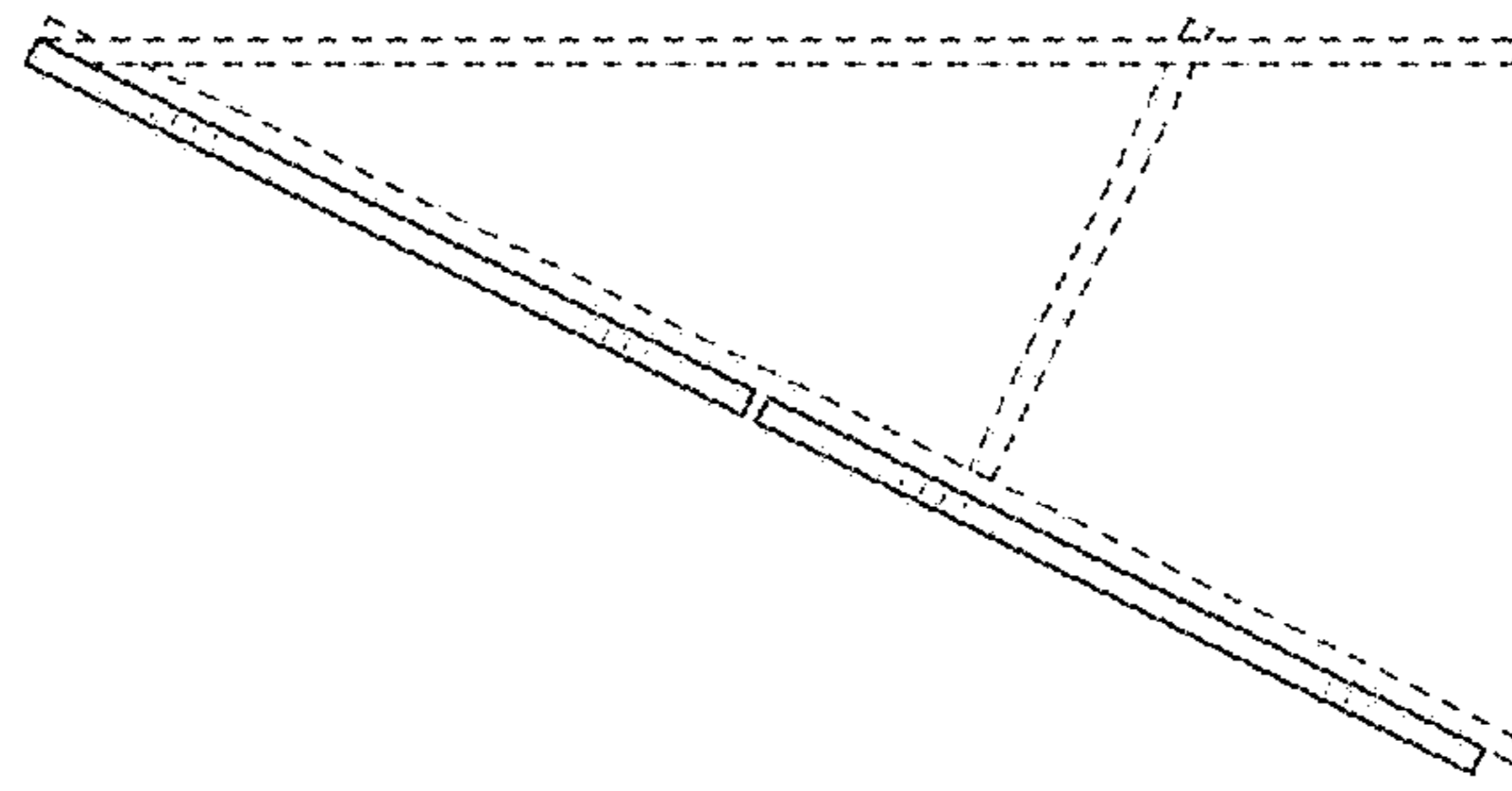

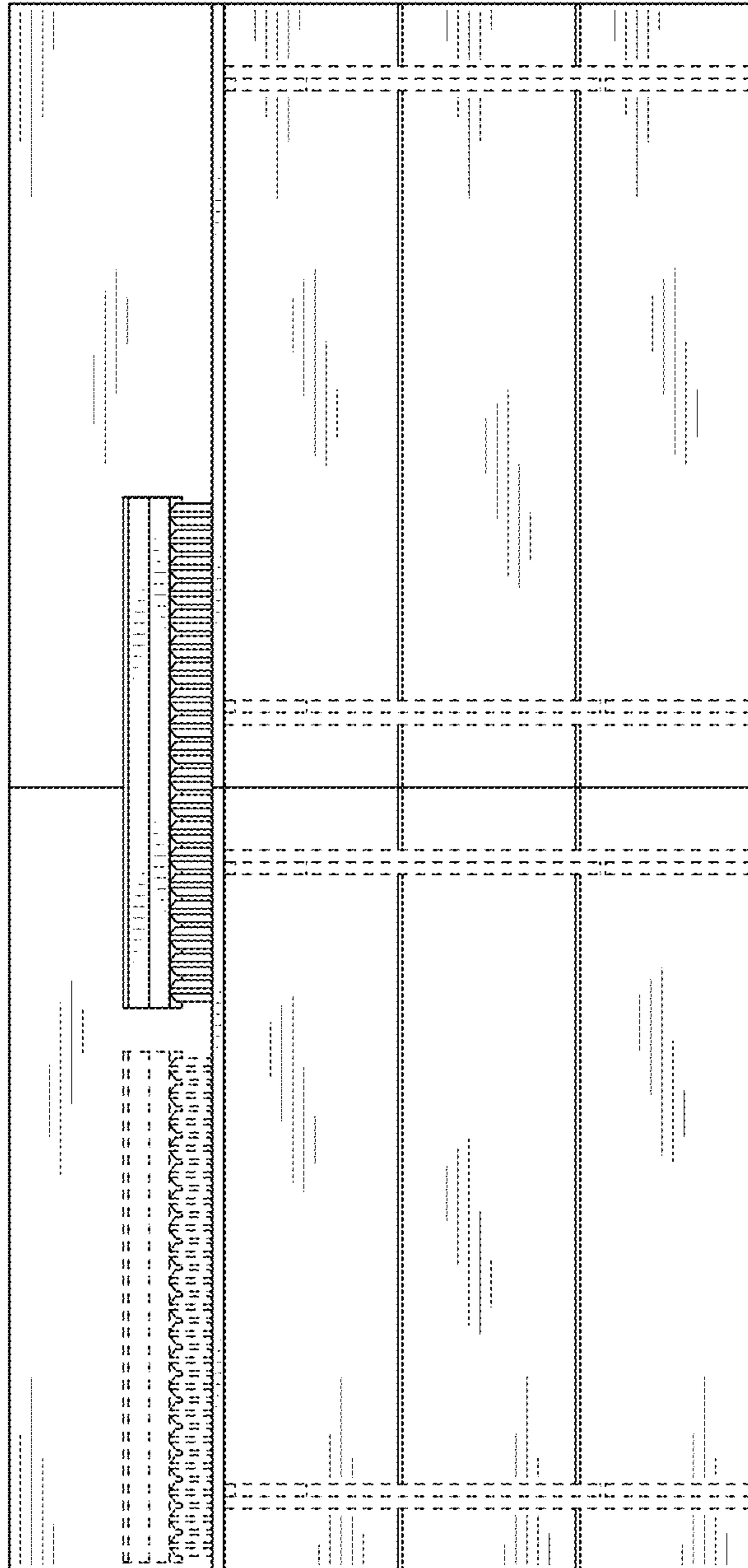

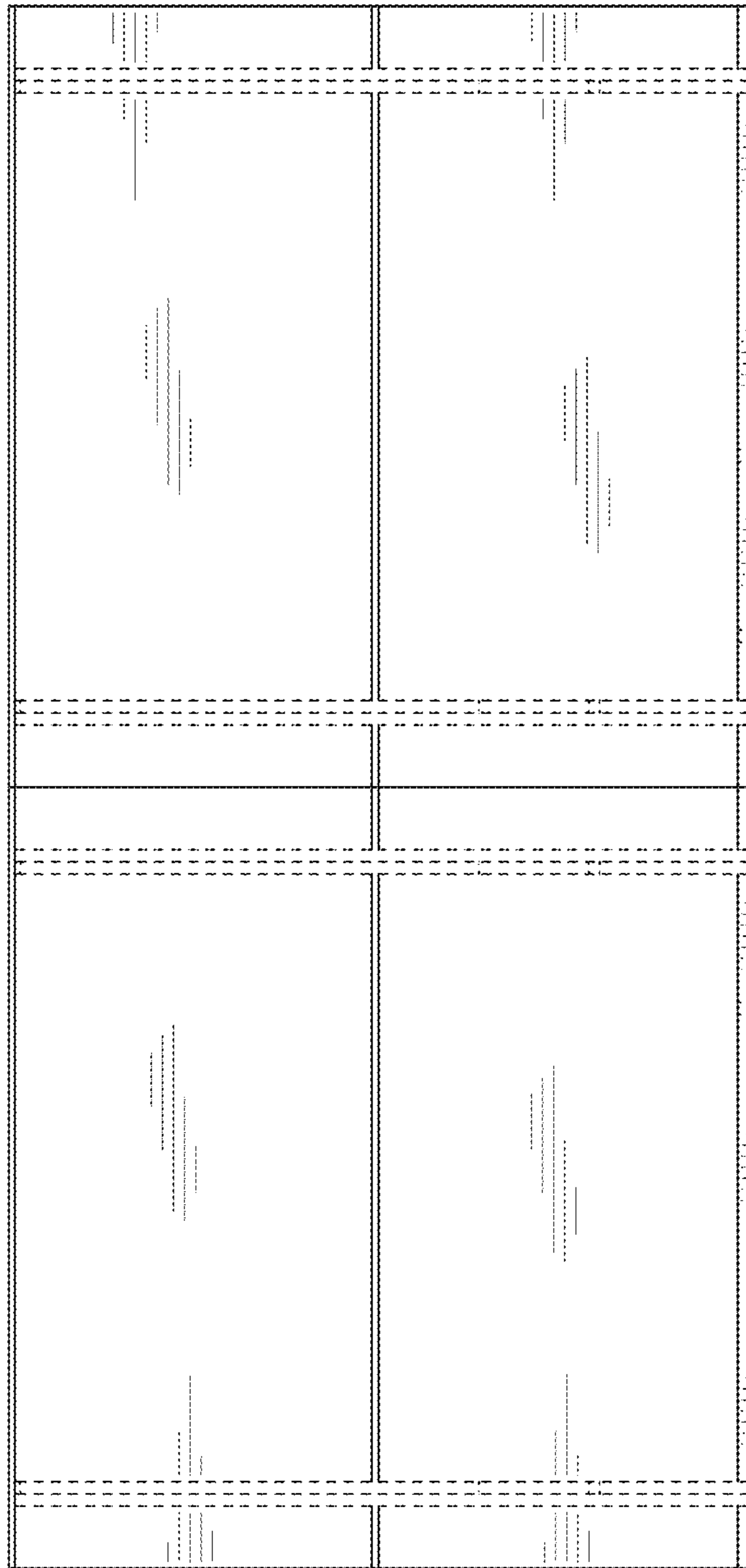

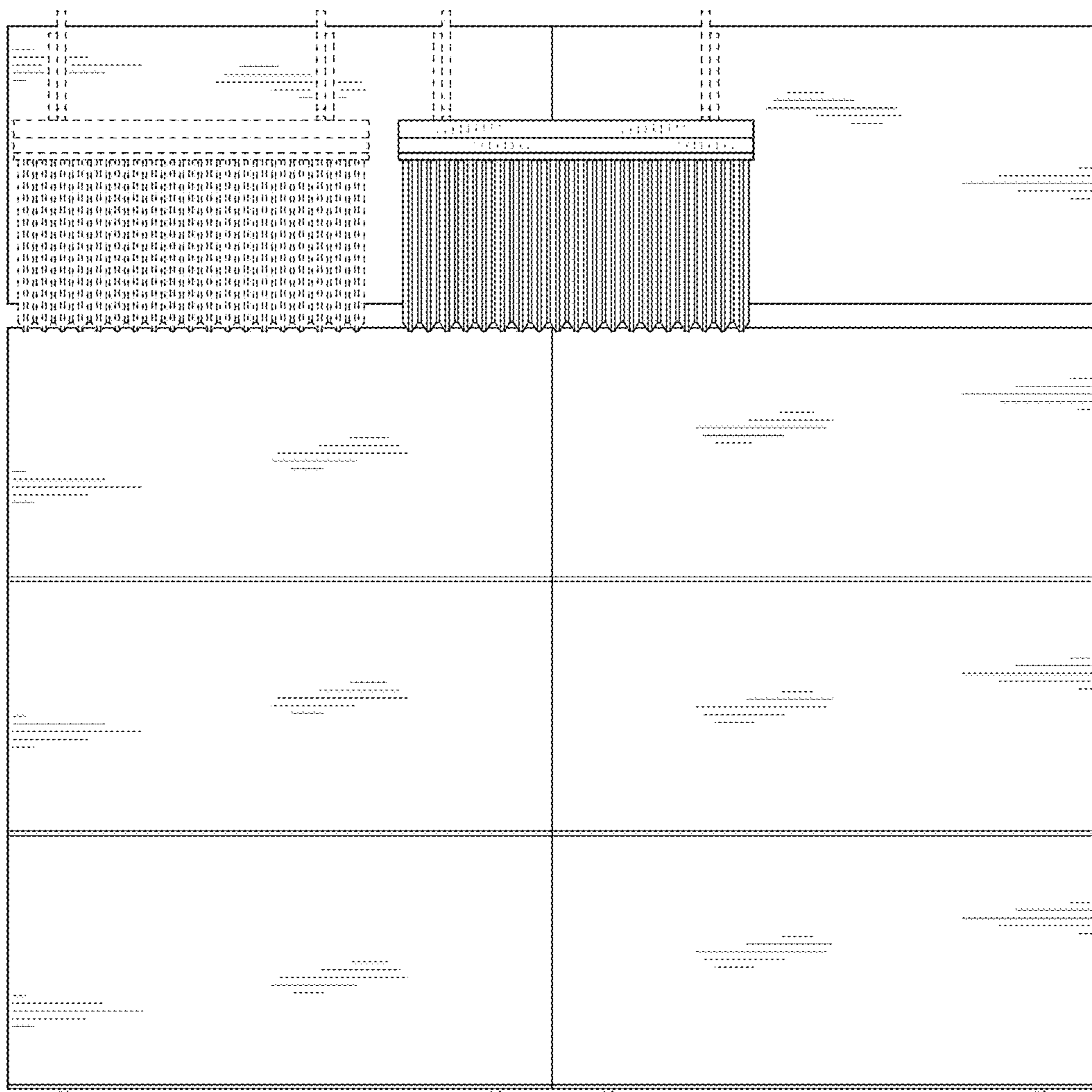
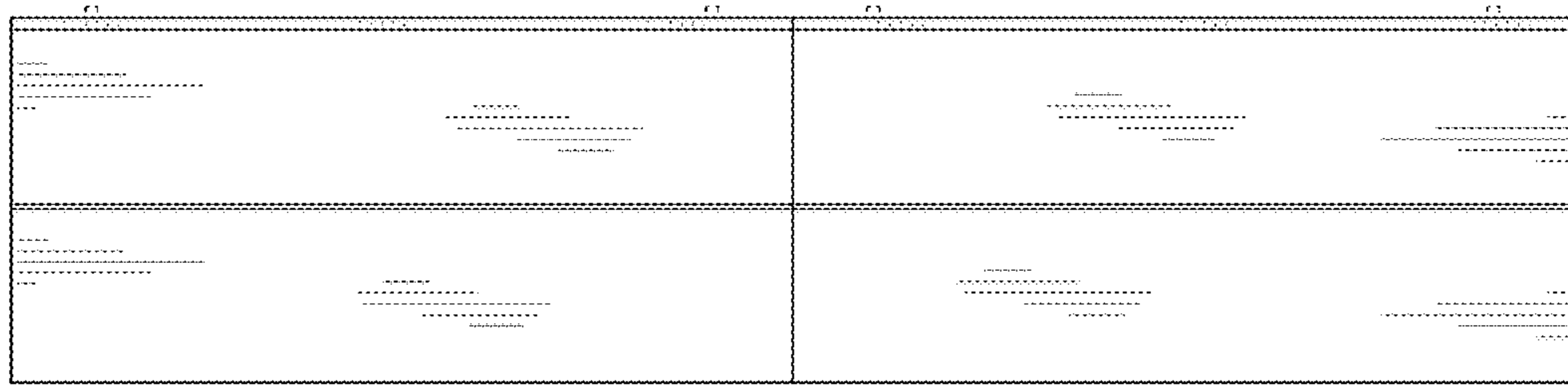
