(57) **CLAIM**

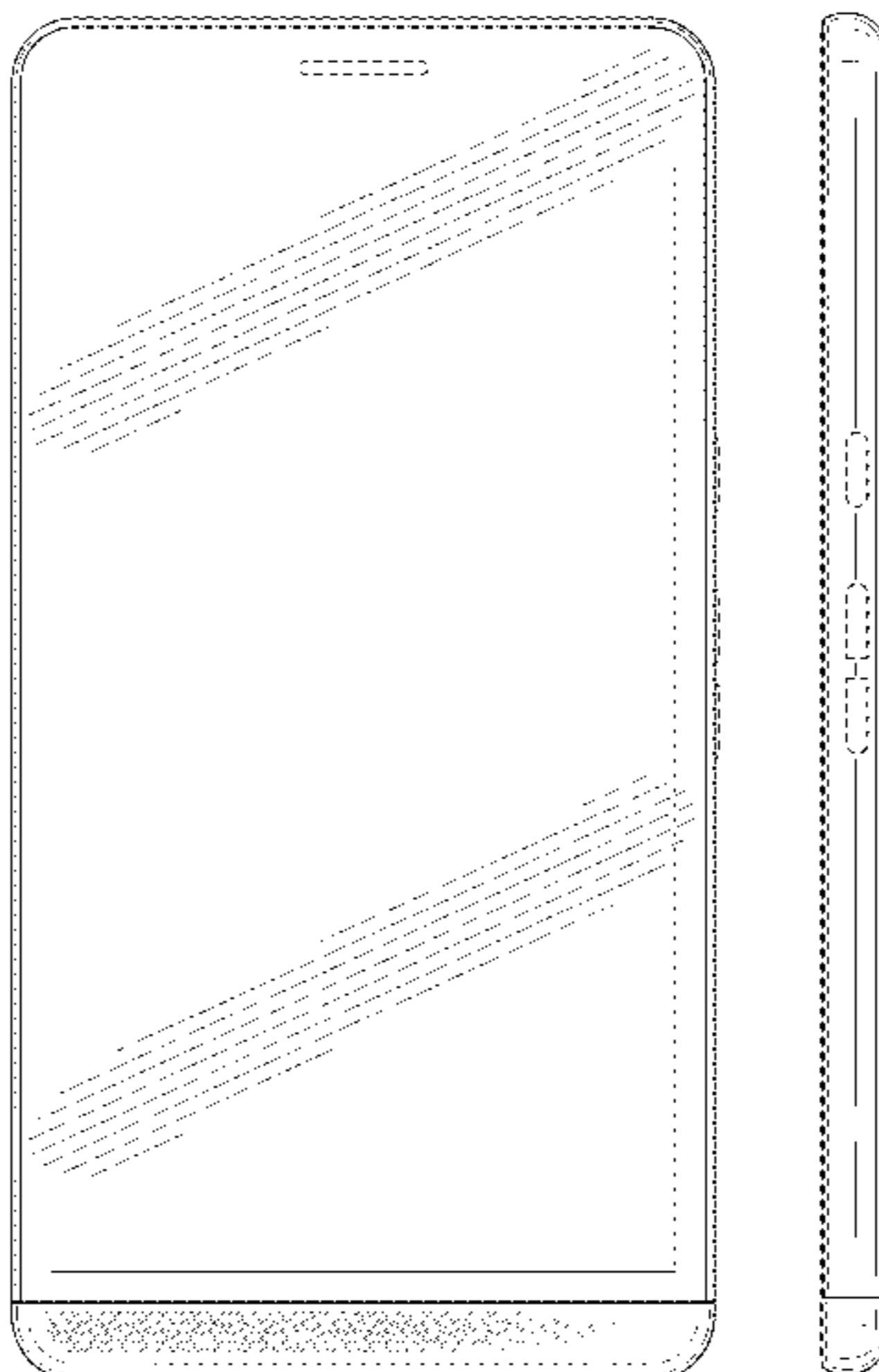
We claim the ornamental design for a mobile computing device, as shown and described.

DESCRIPTION

FIG. 1 is front, right, bottom perspective view of the claimed design according to an embodiment;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top plan view thereof.

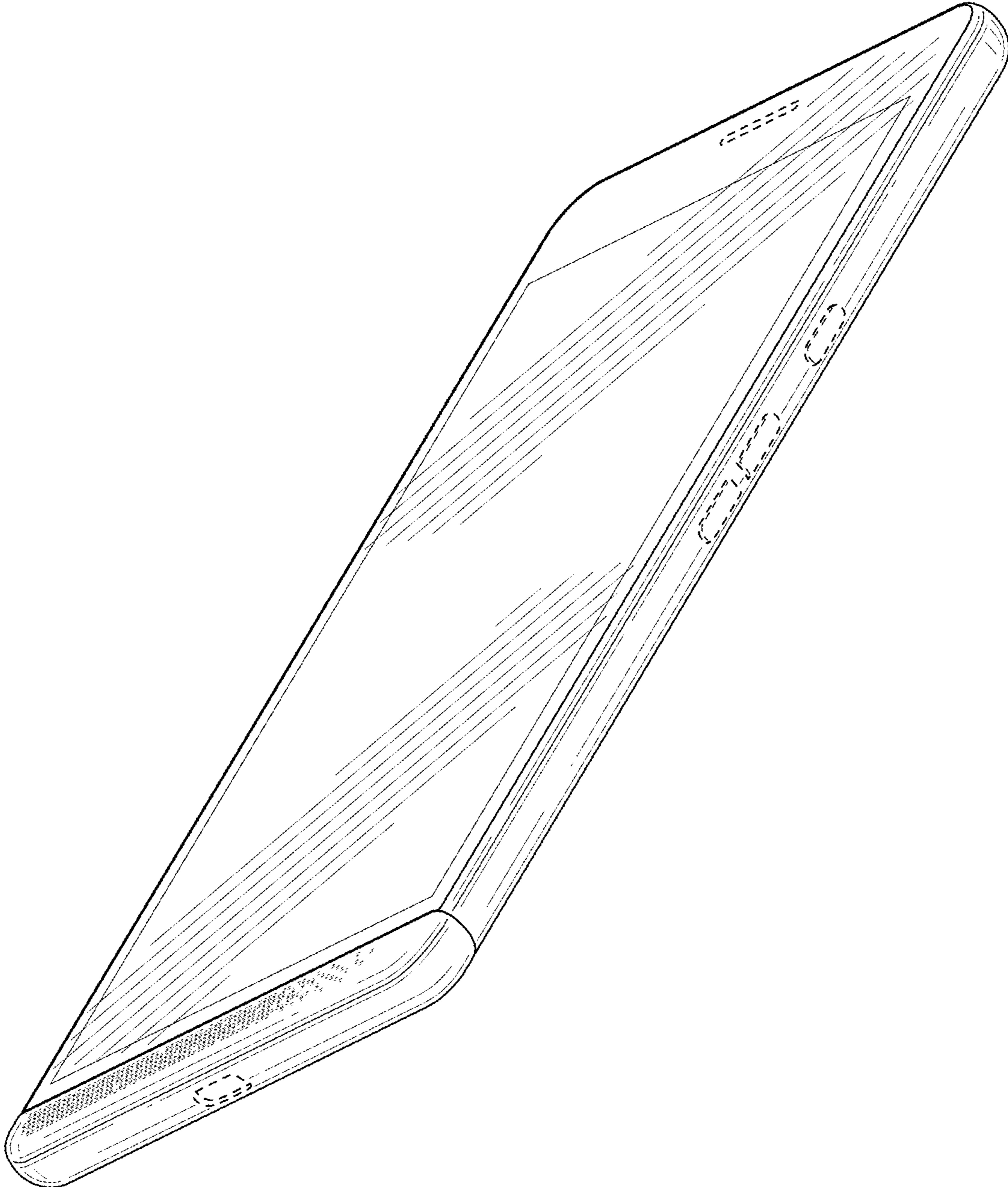

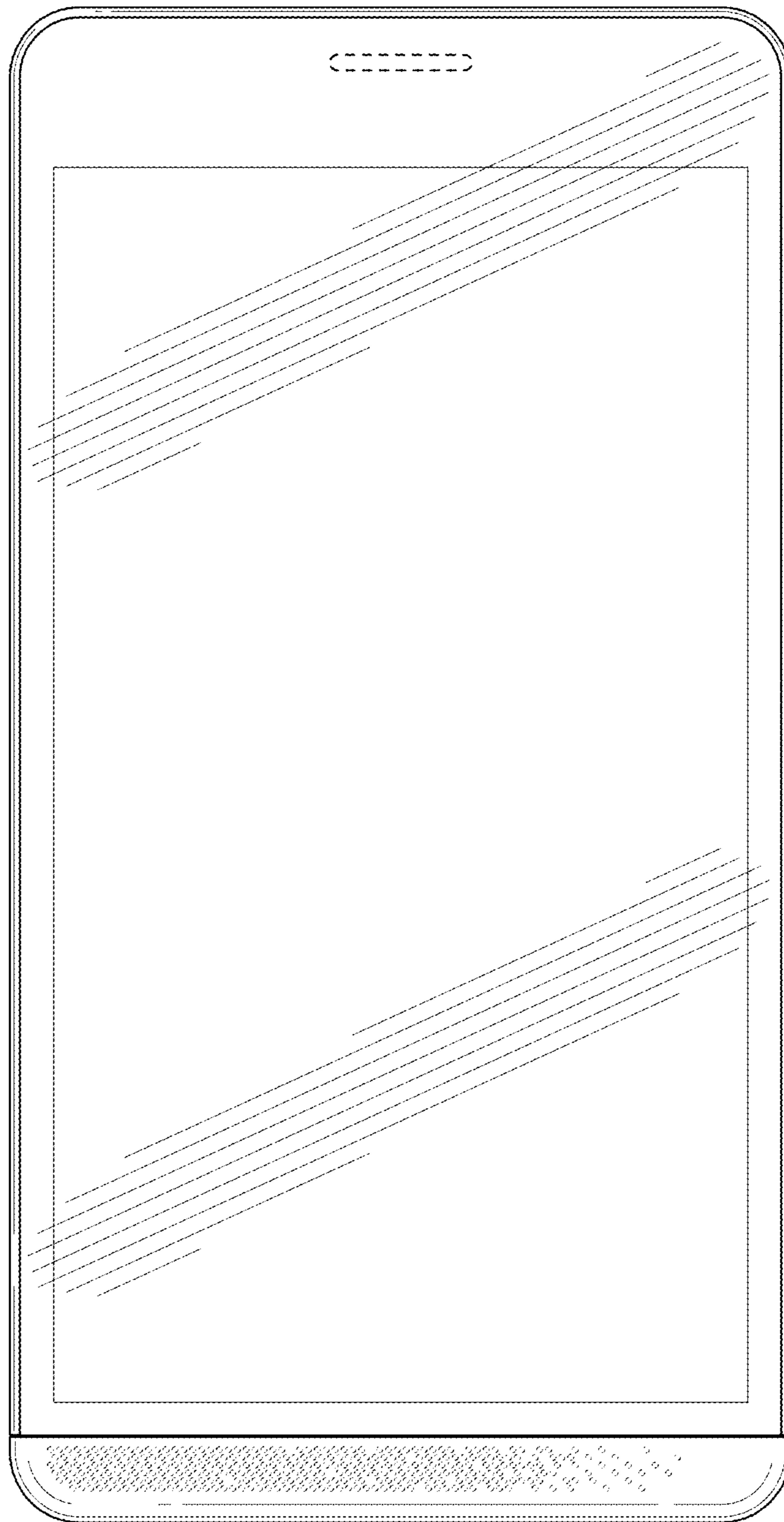

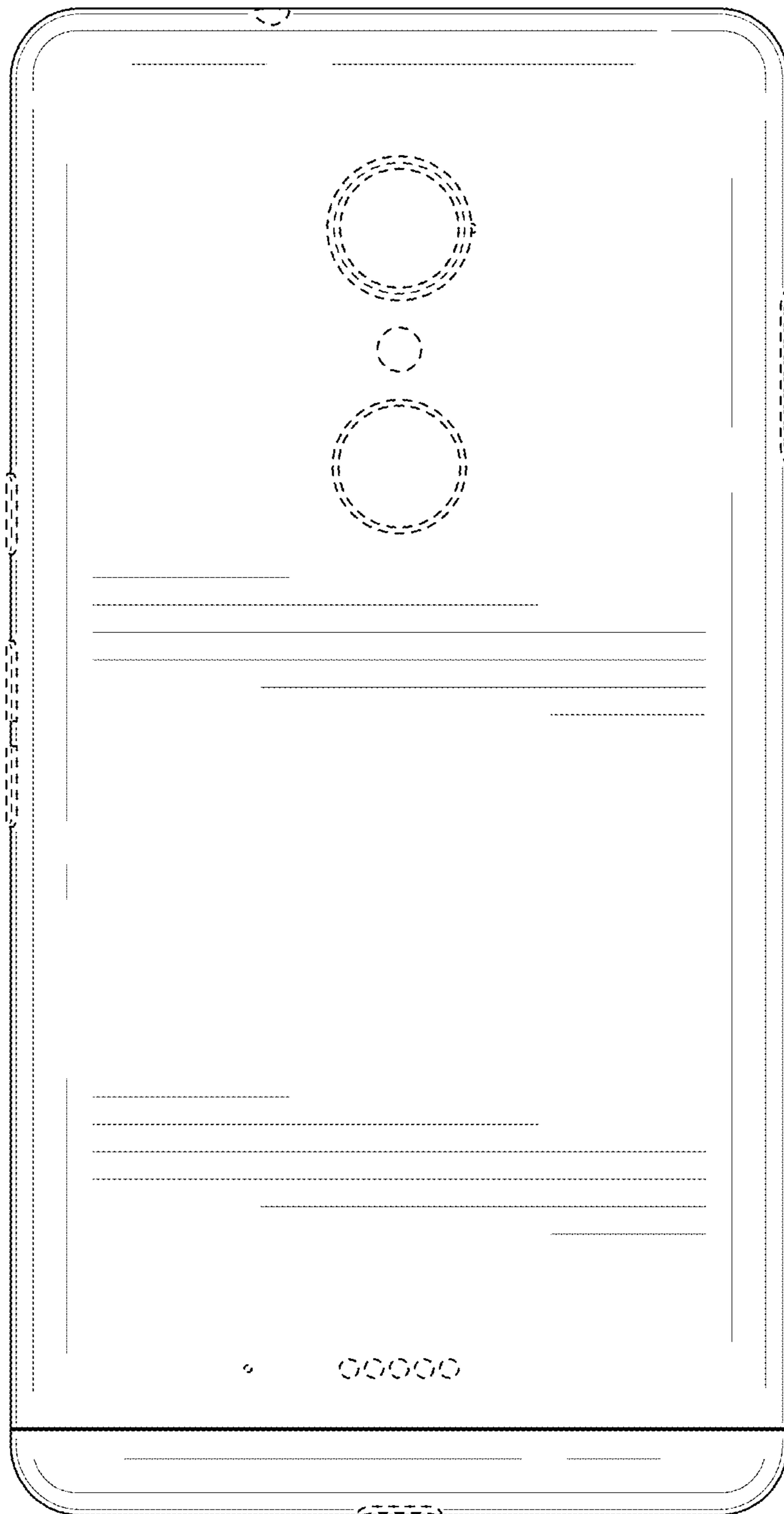

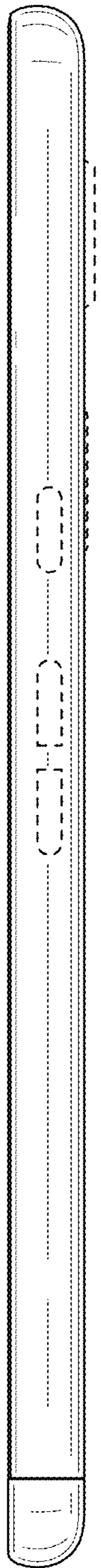

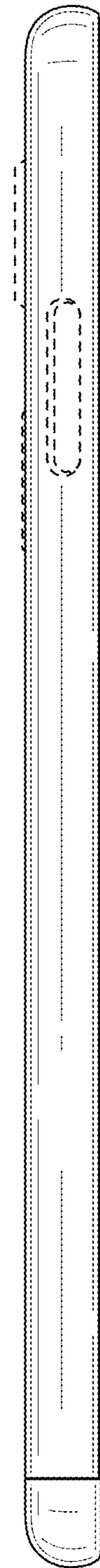

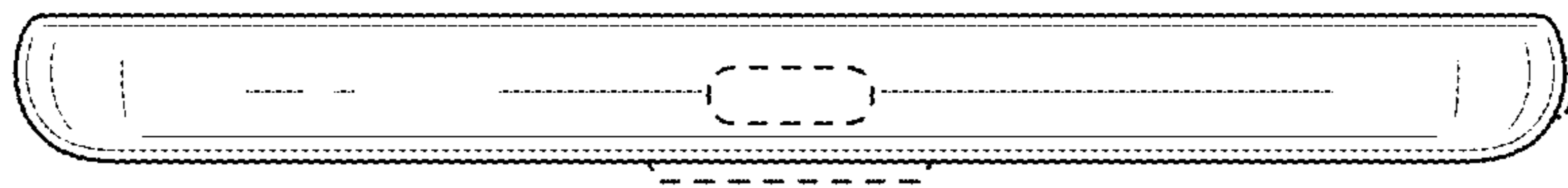

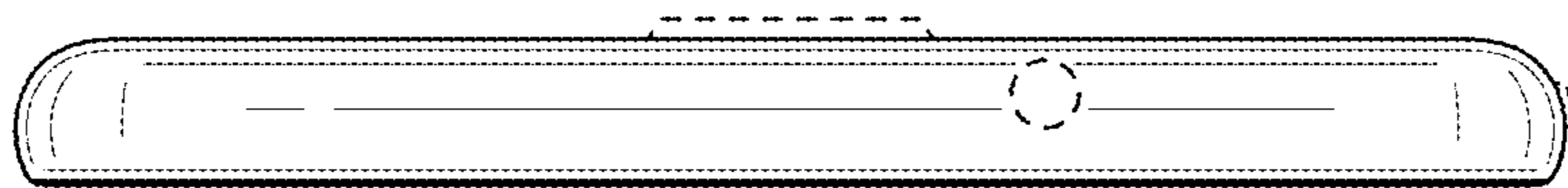
