The ornamental design for a coordinate input instrument, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a coordinate input instrument according to a first embodiment of my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a side view thereof, the side opposite of the side shown in FIG. 3 being a mirror image thereof and therefore not shown;

FIG. 4 is a front view thereof;

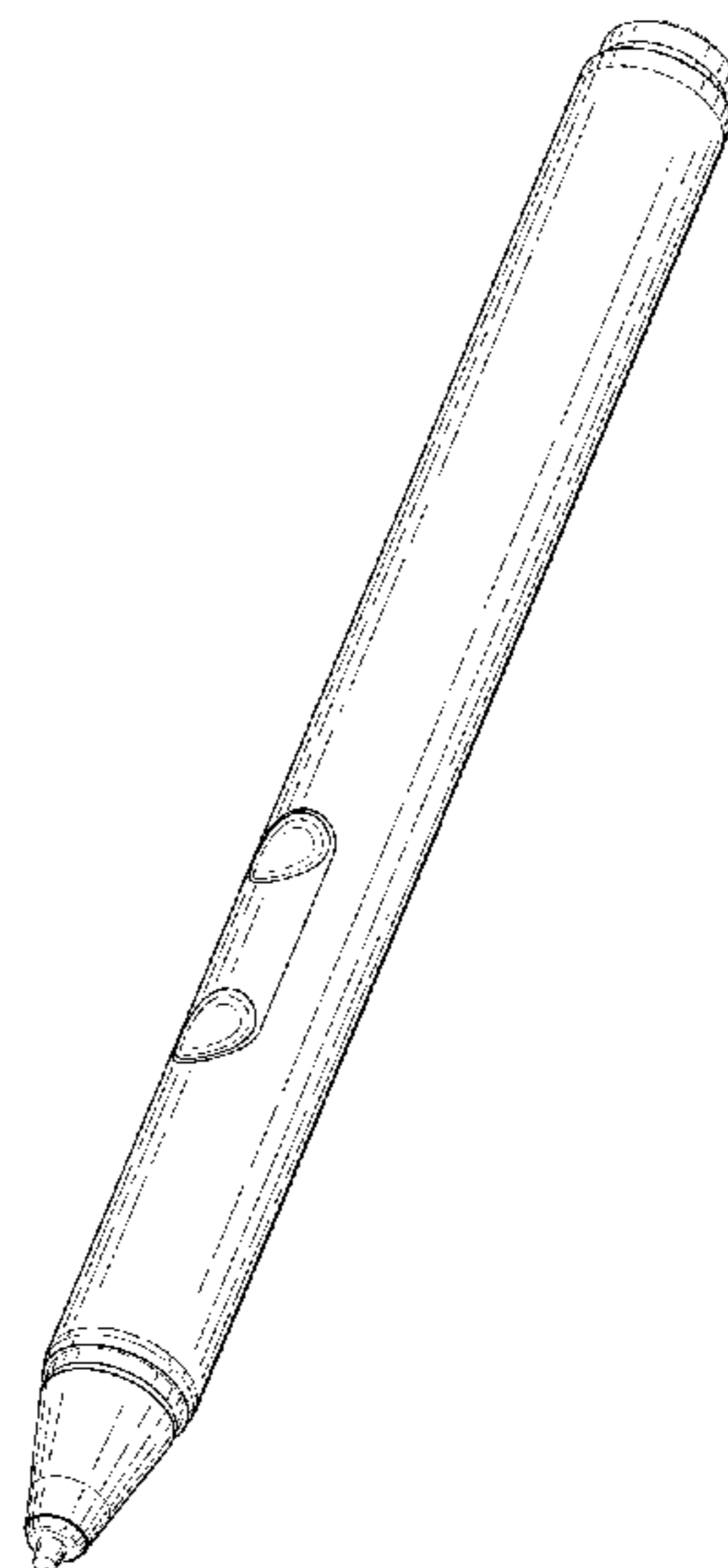
FIG. 5 is a rear view thereof;

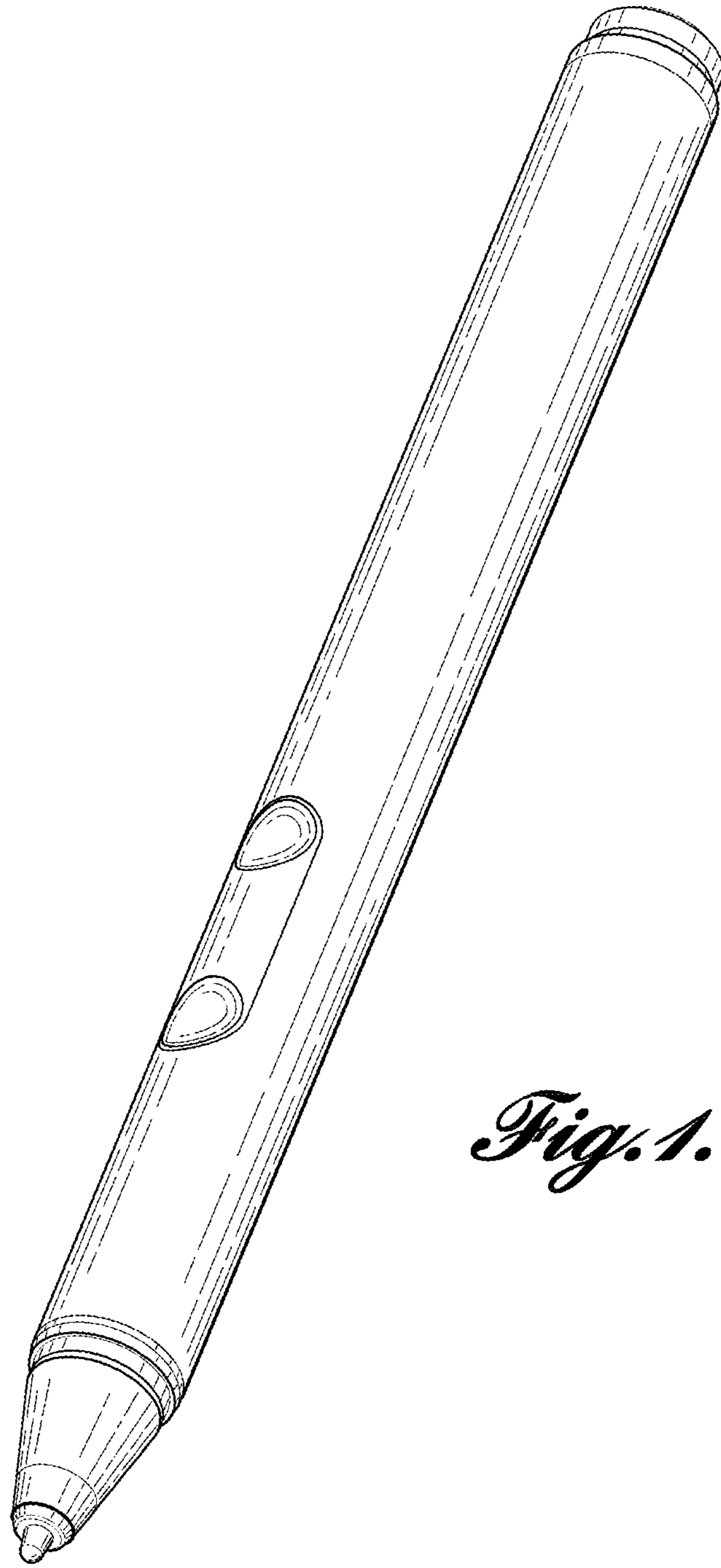

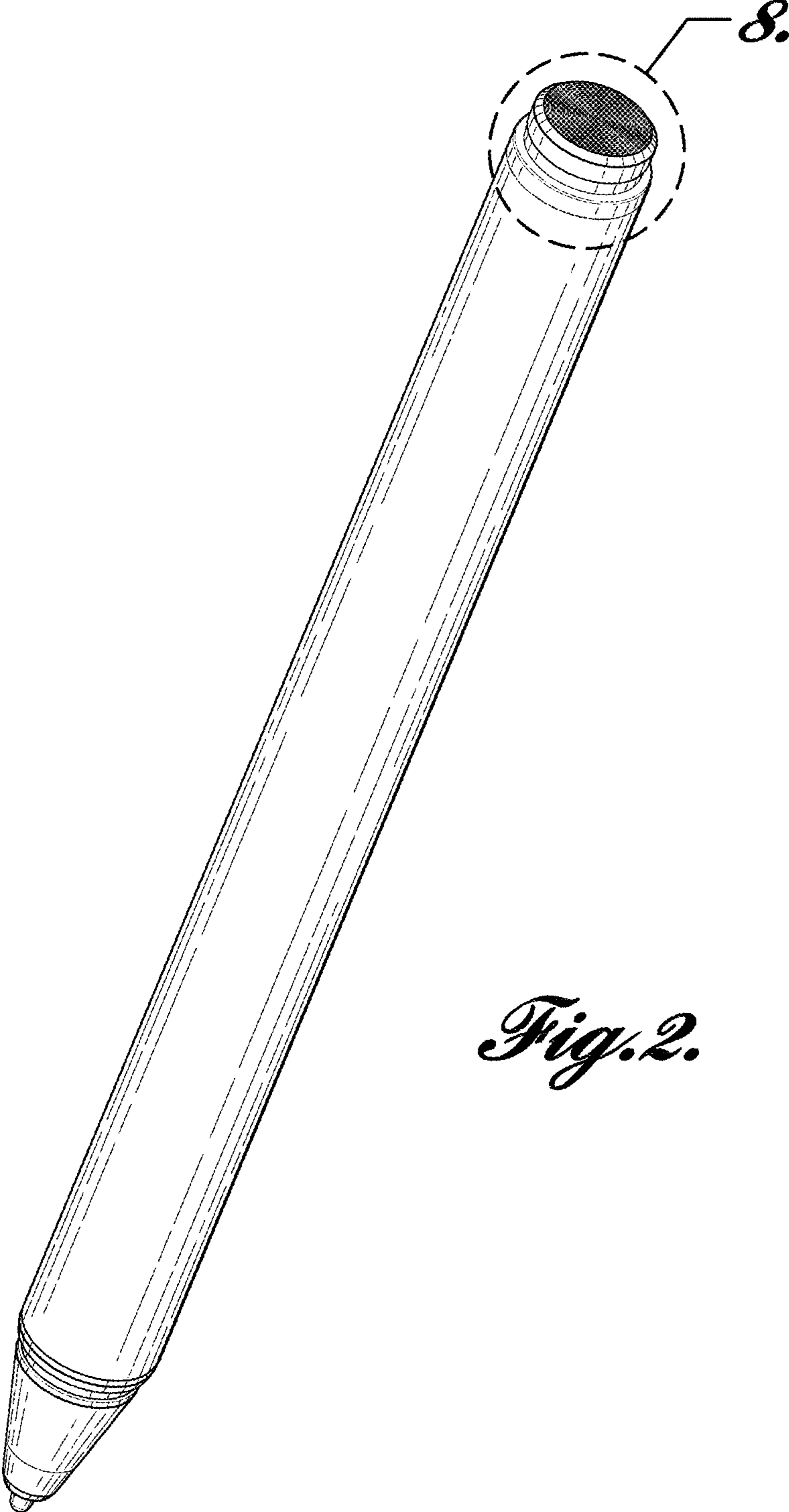

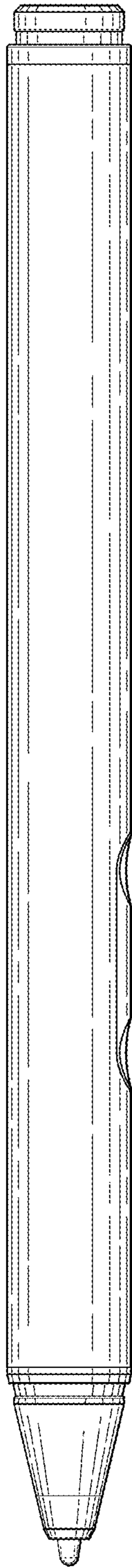

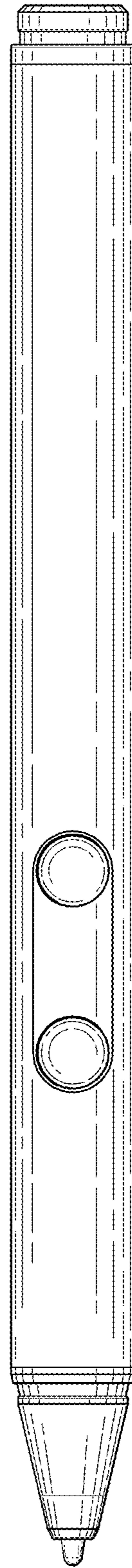

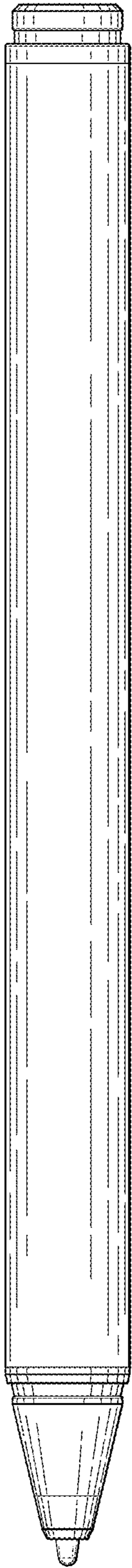

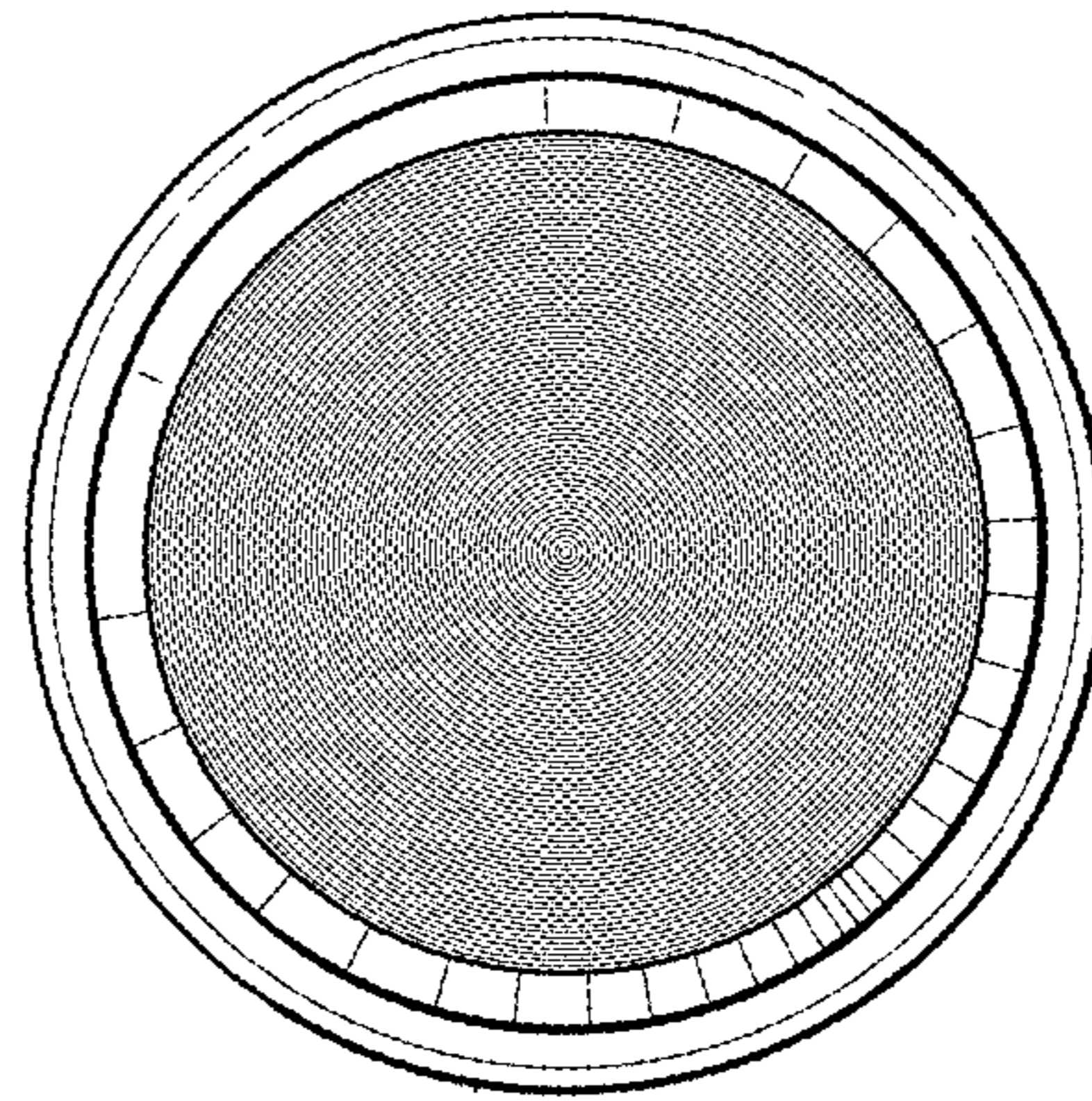

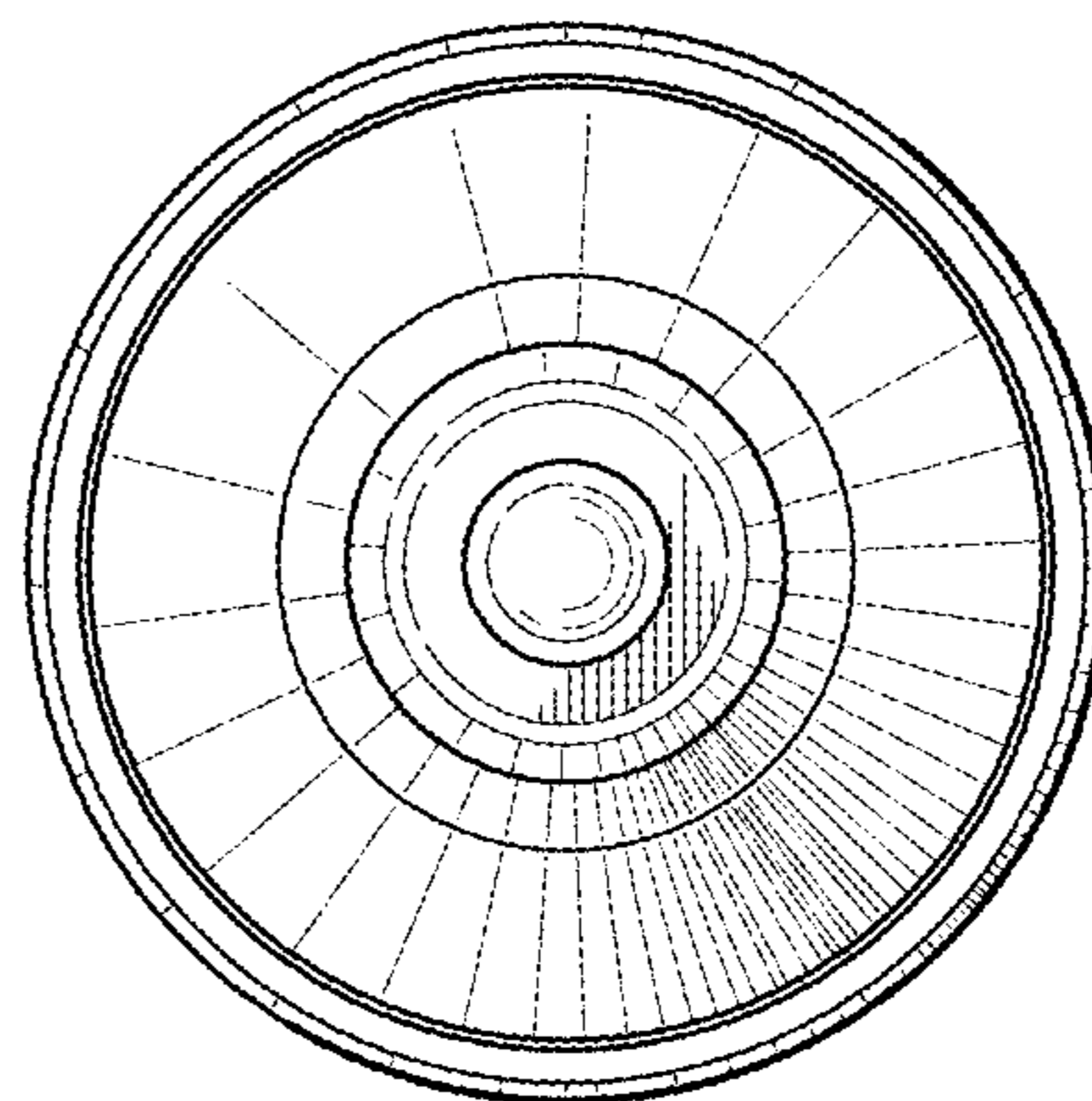

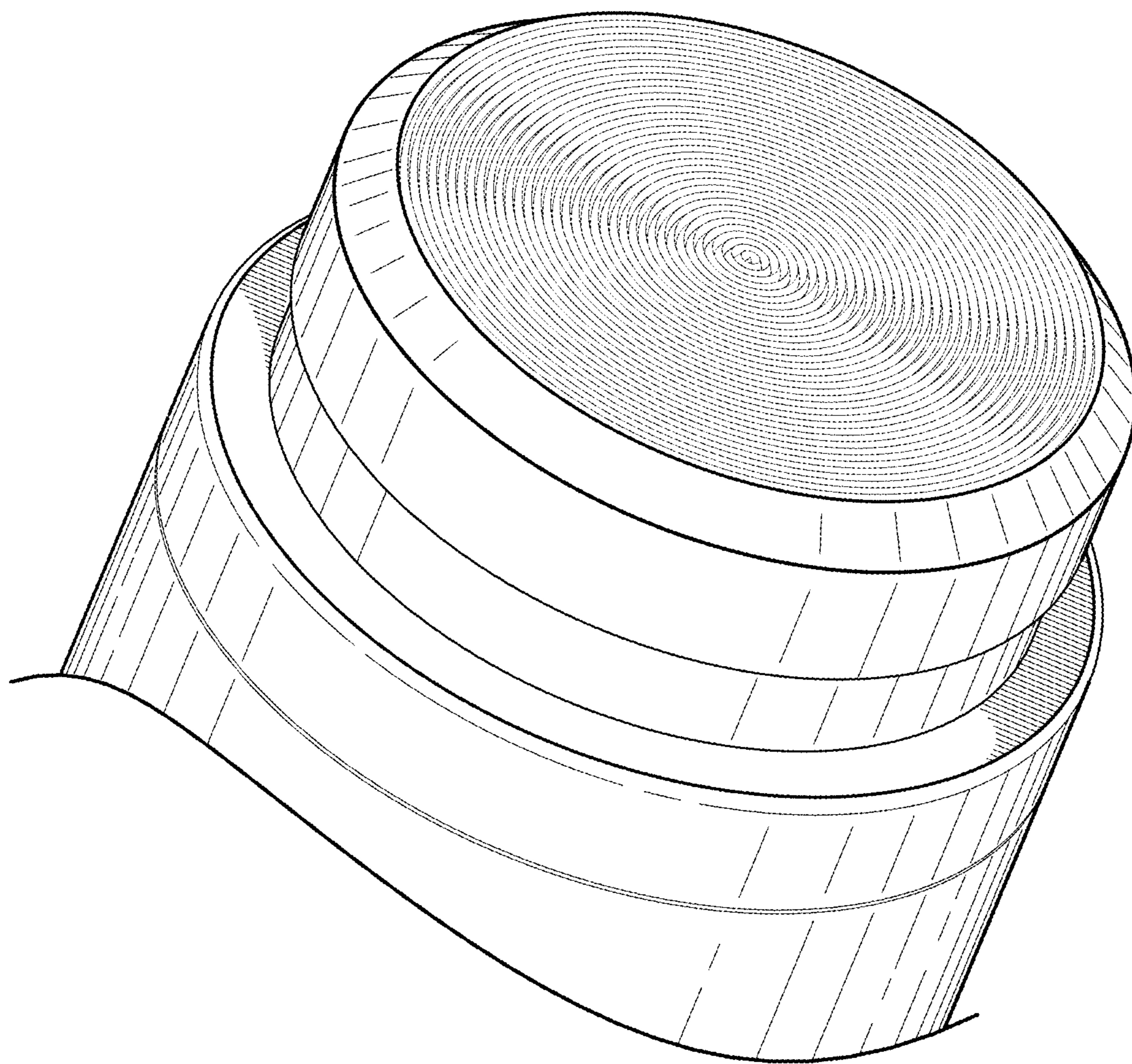
