FIG. 11 is the fourth image thereof;

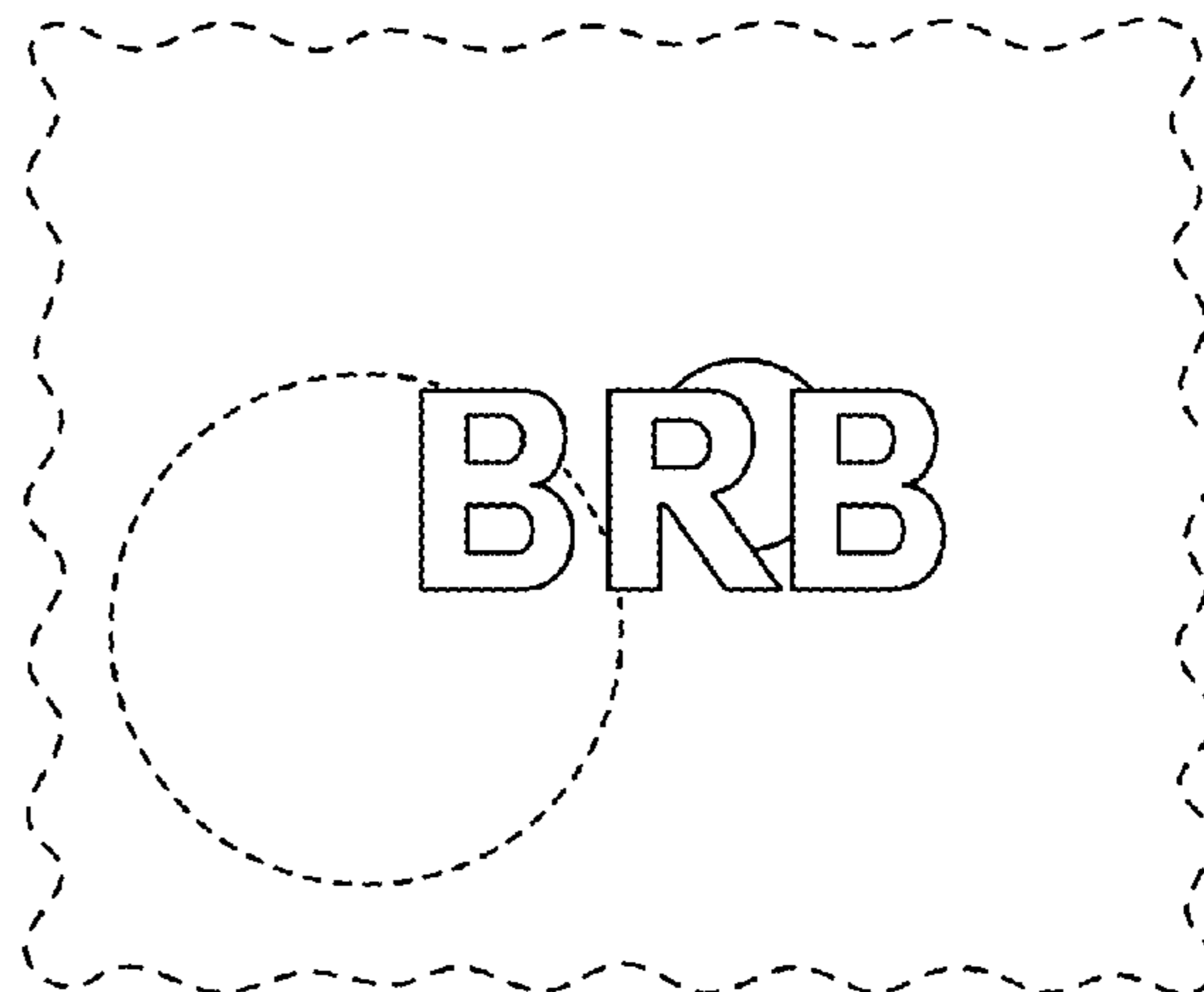
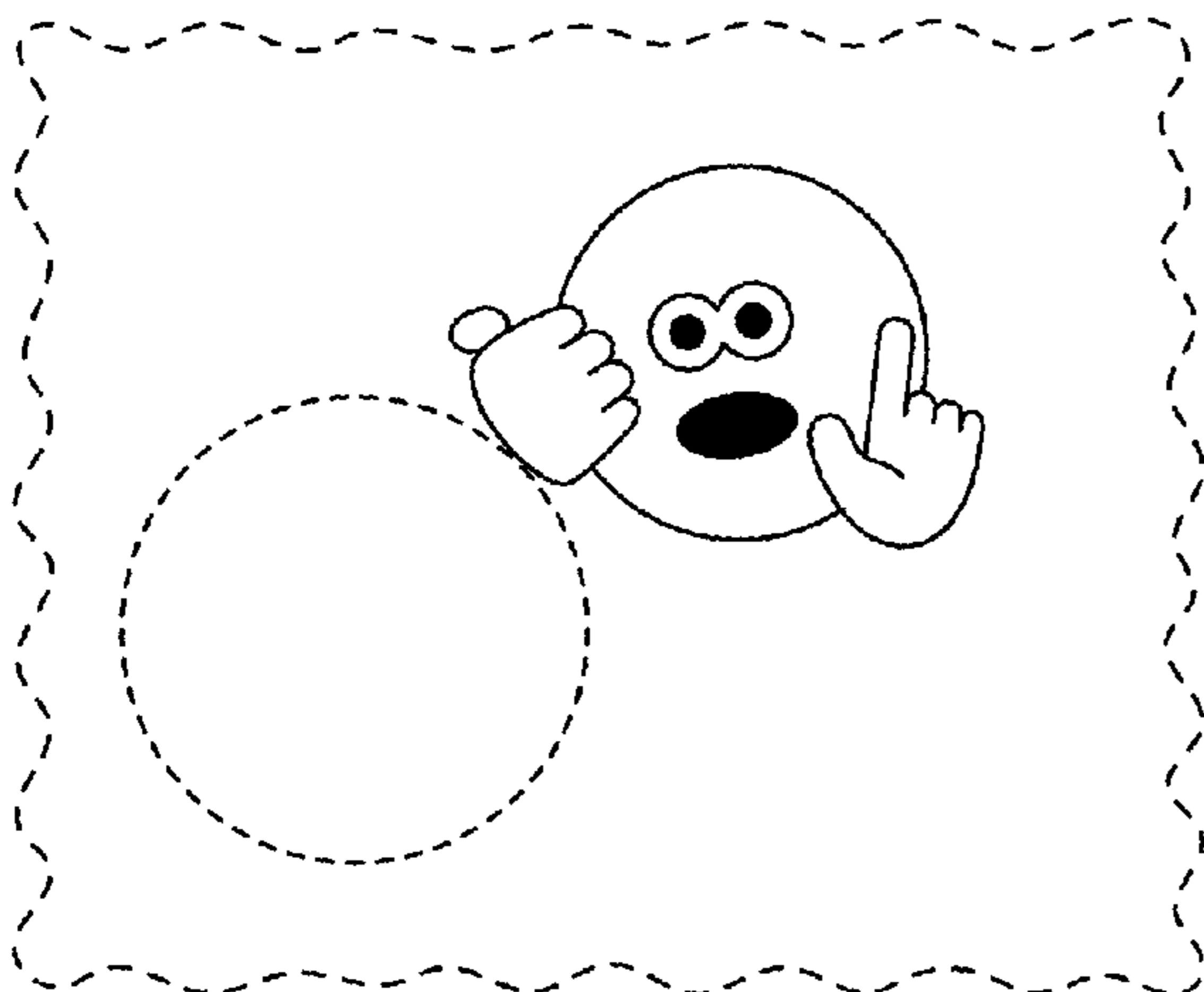
FIG. 12 is the fifth image thereof;

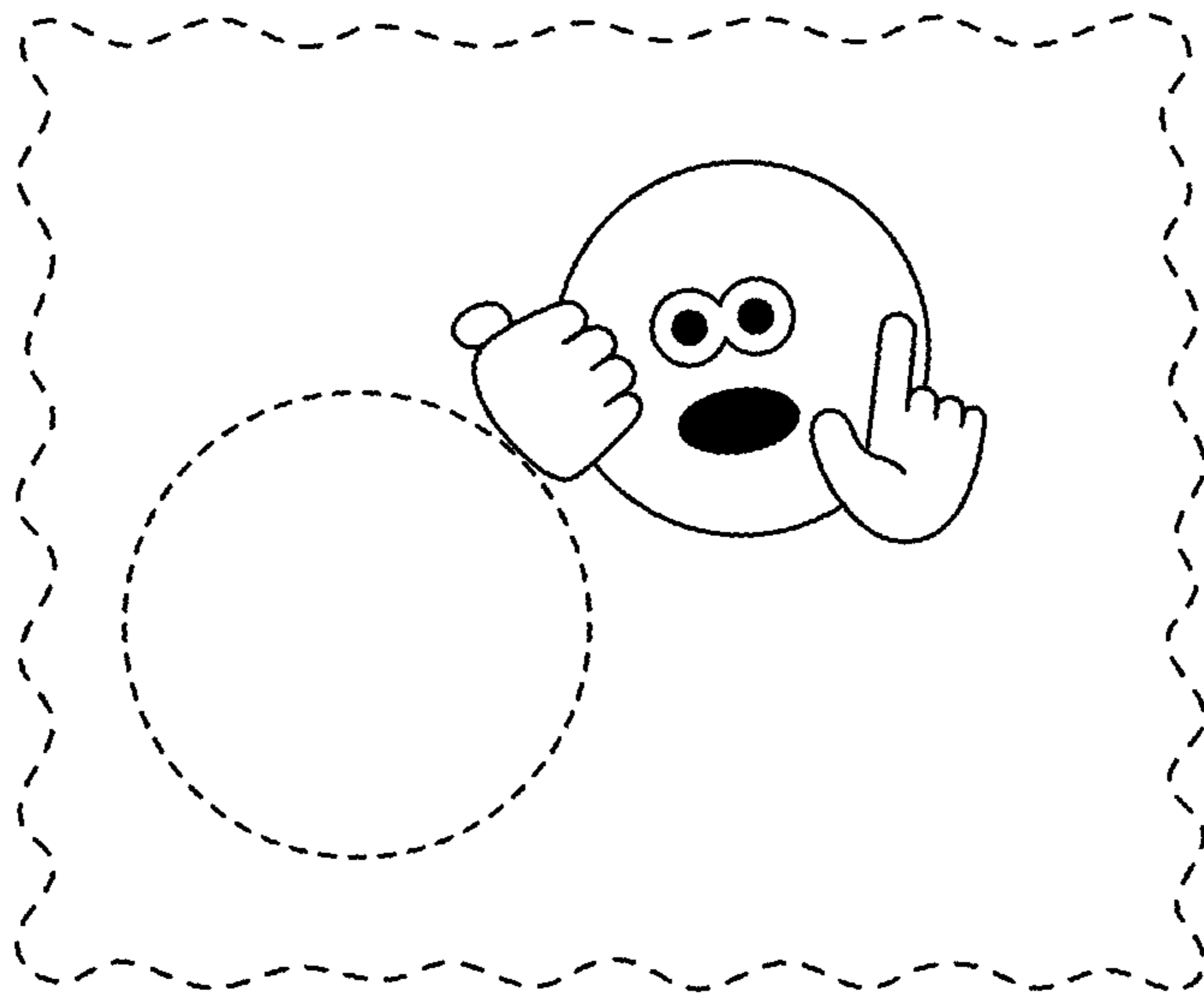

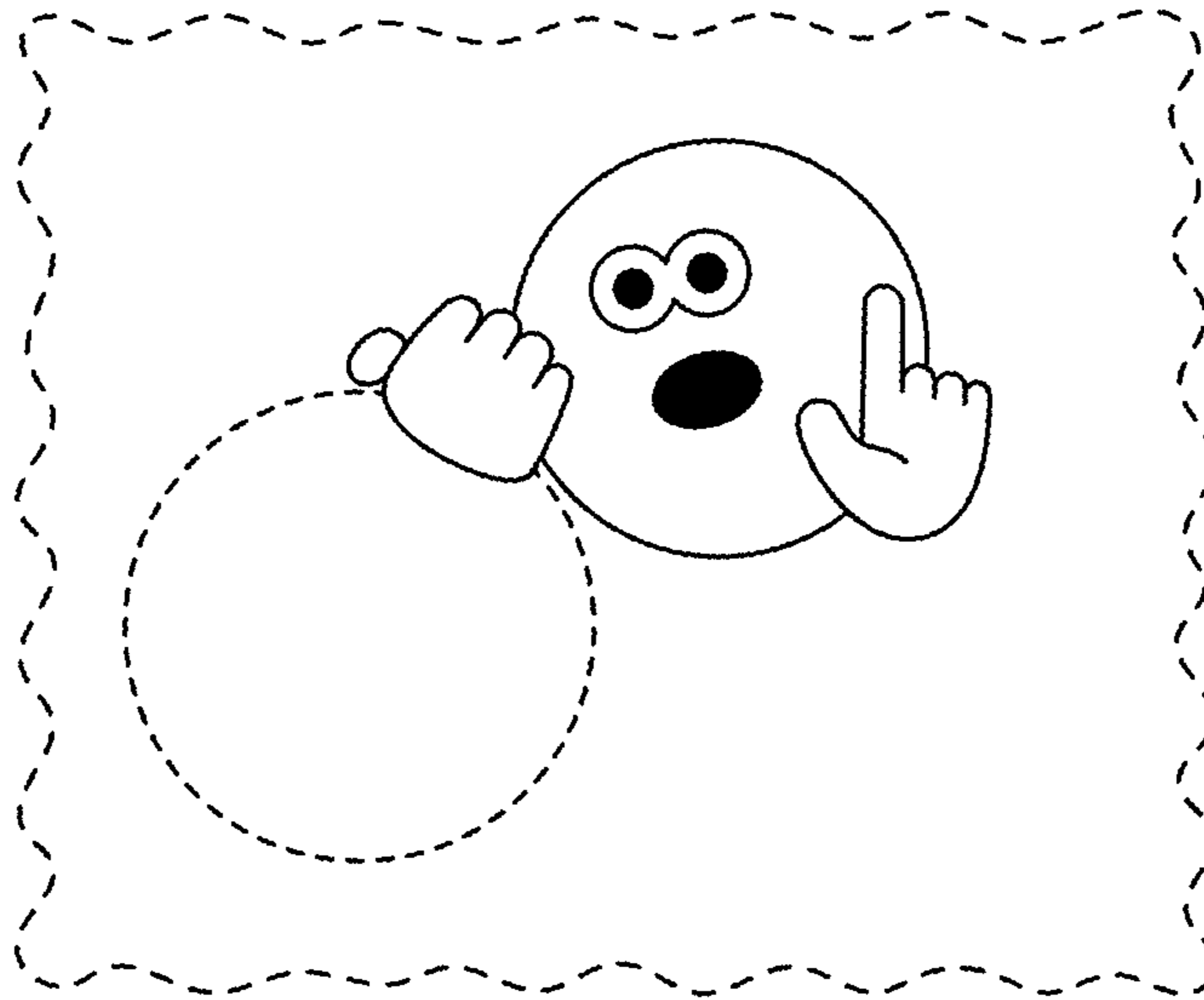

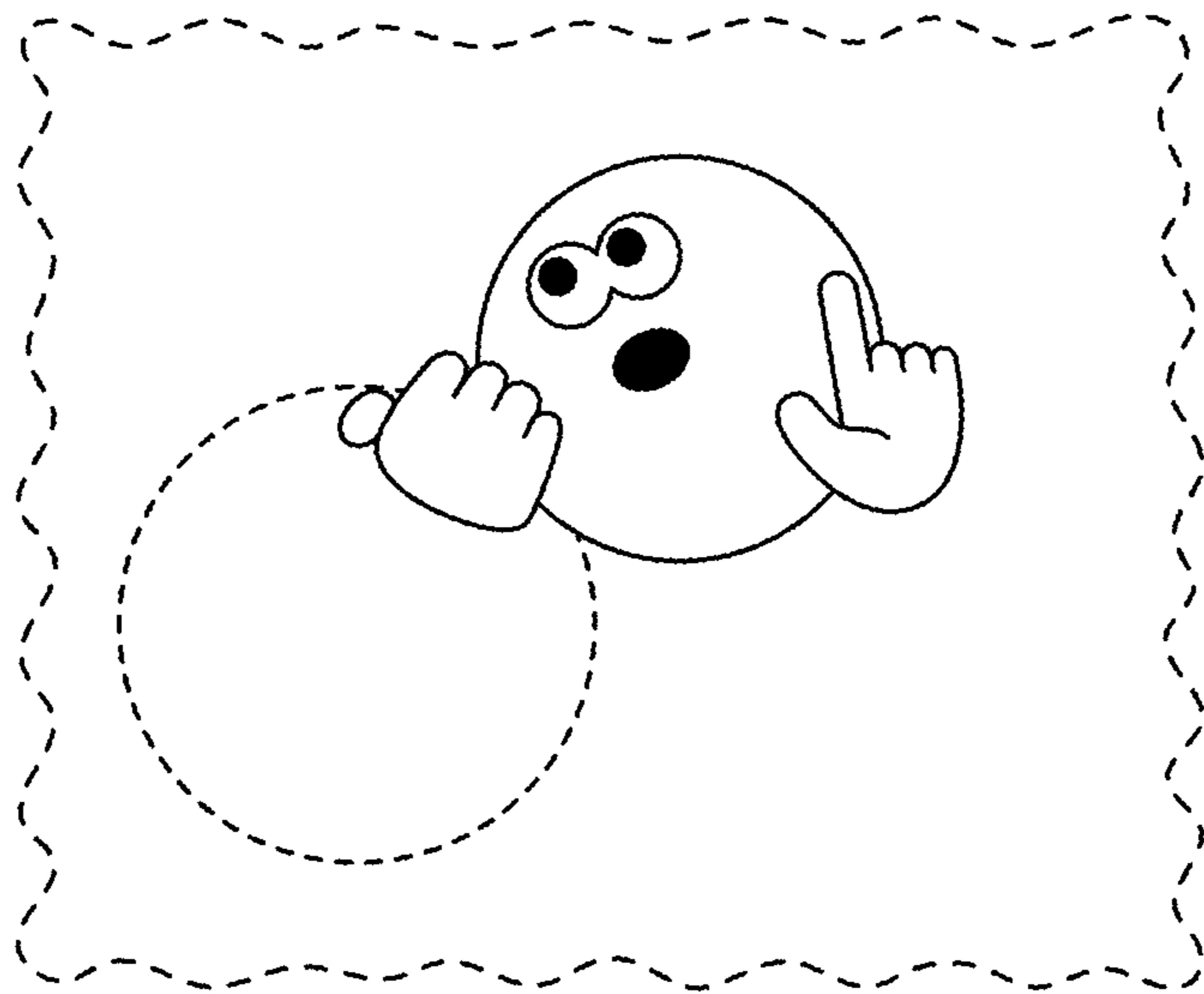

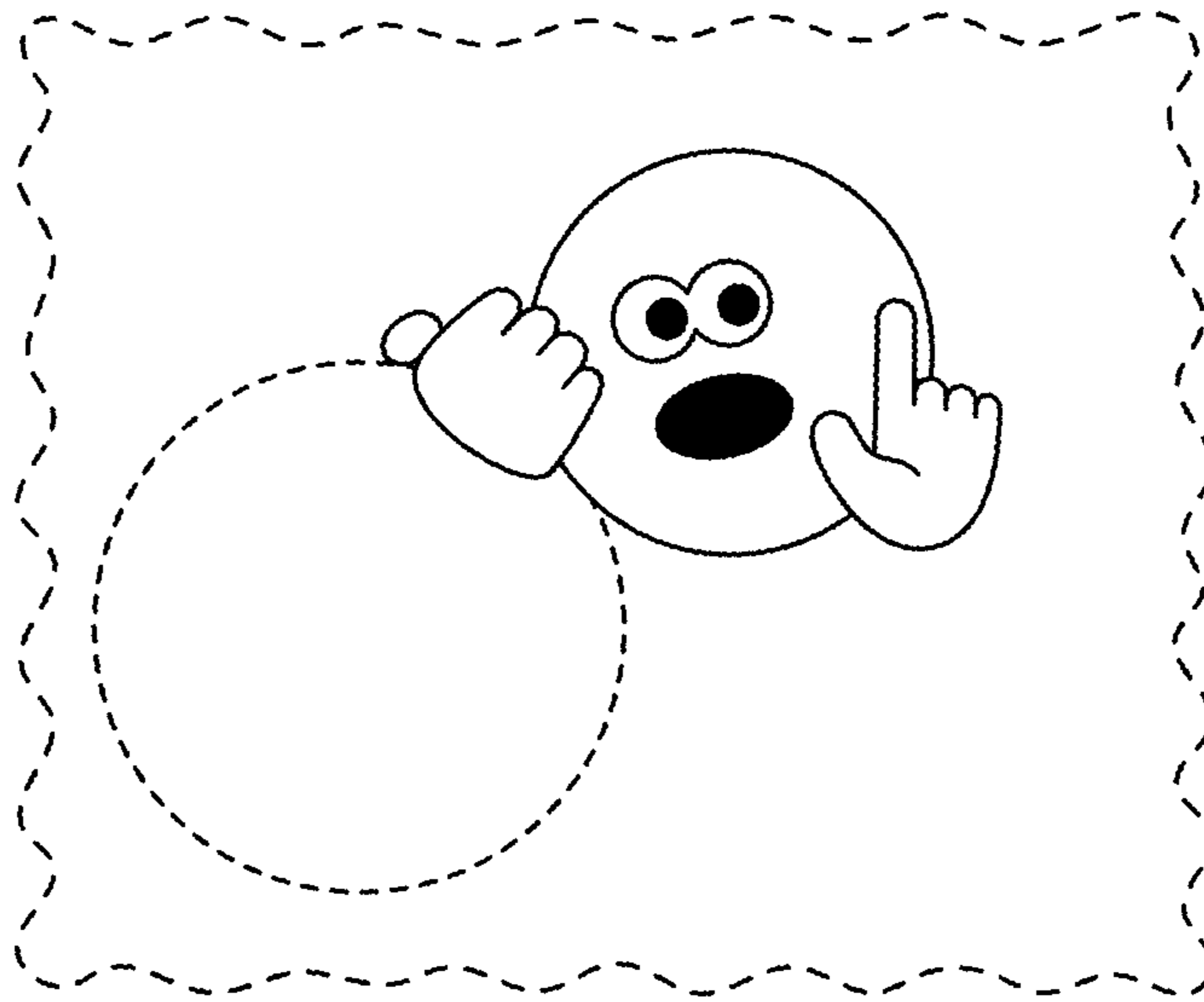

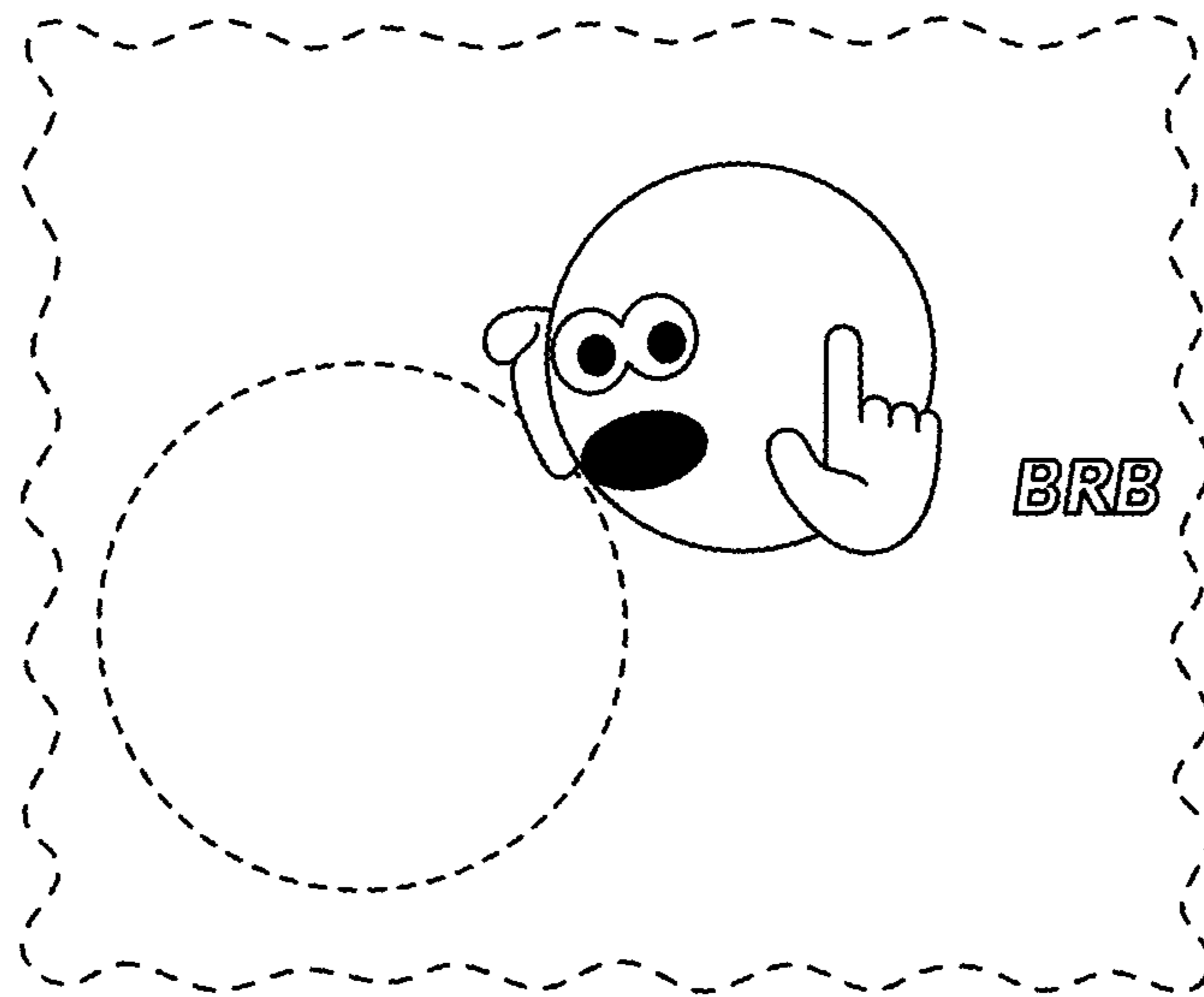

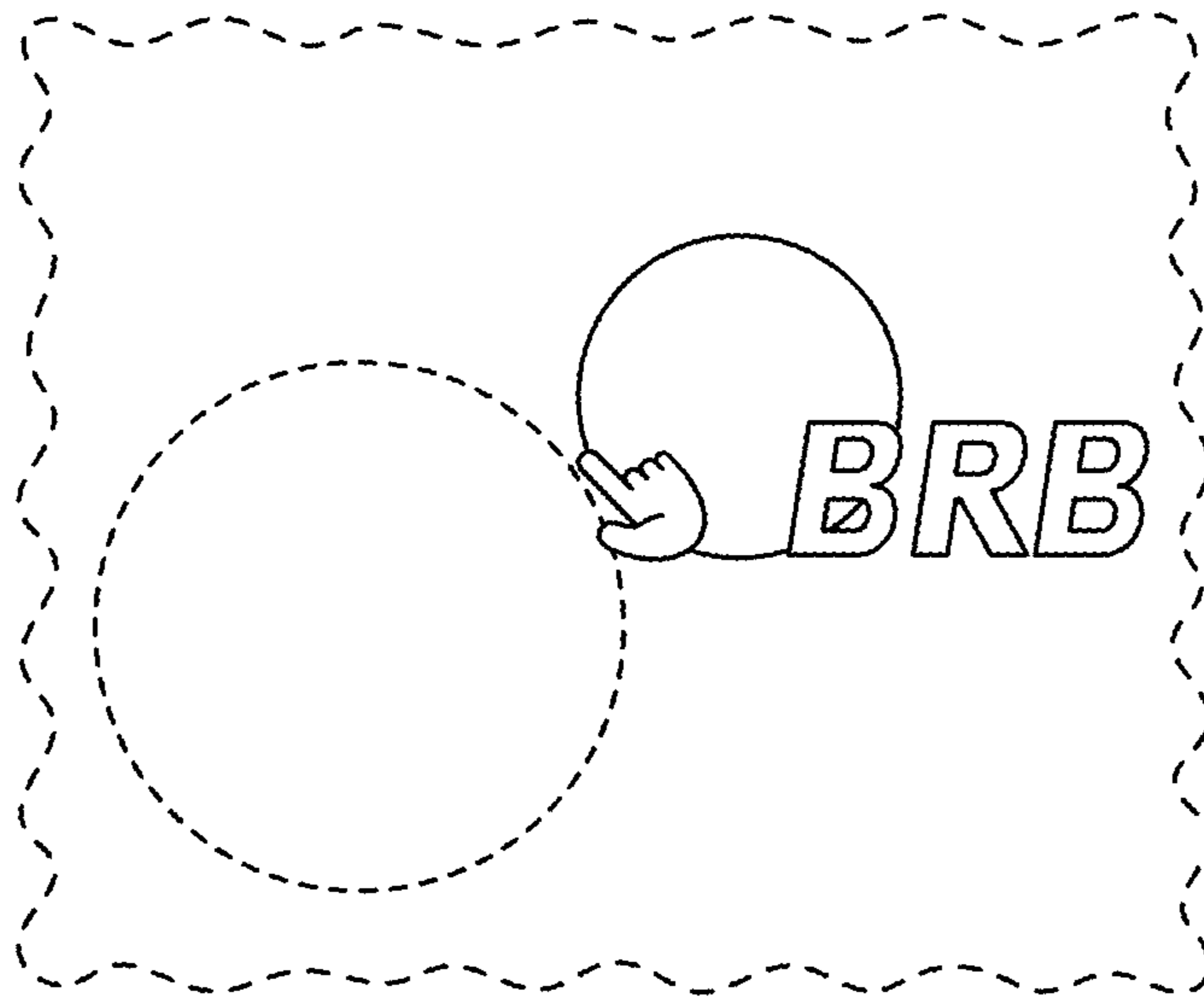

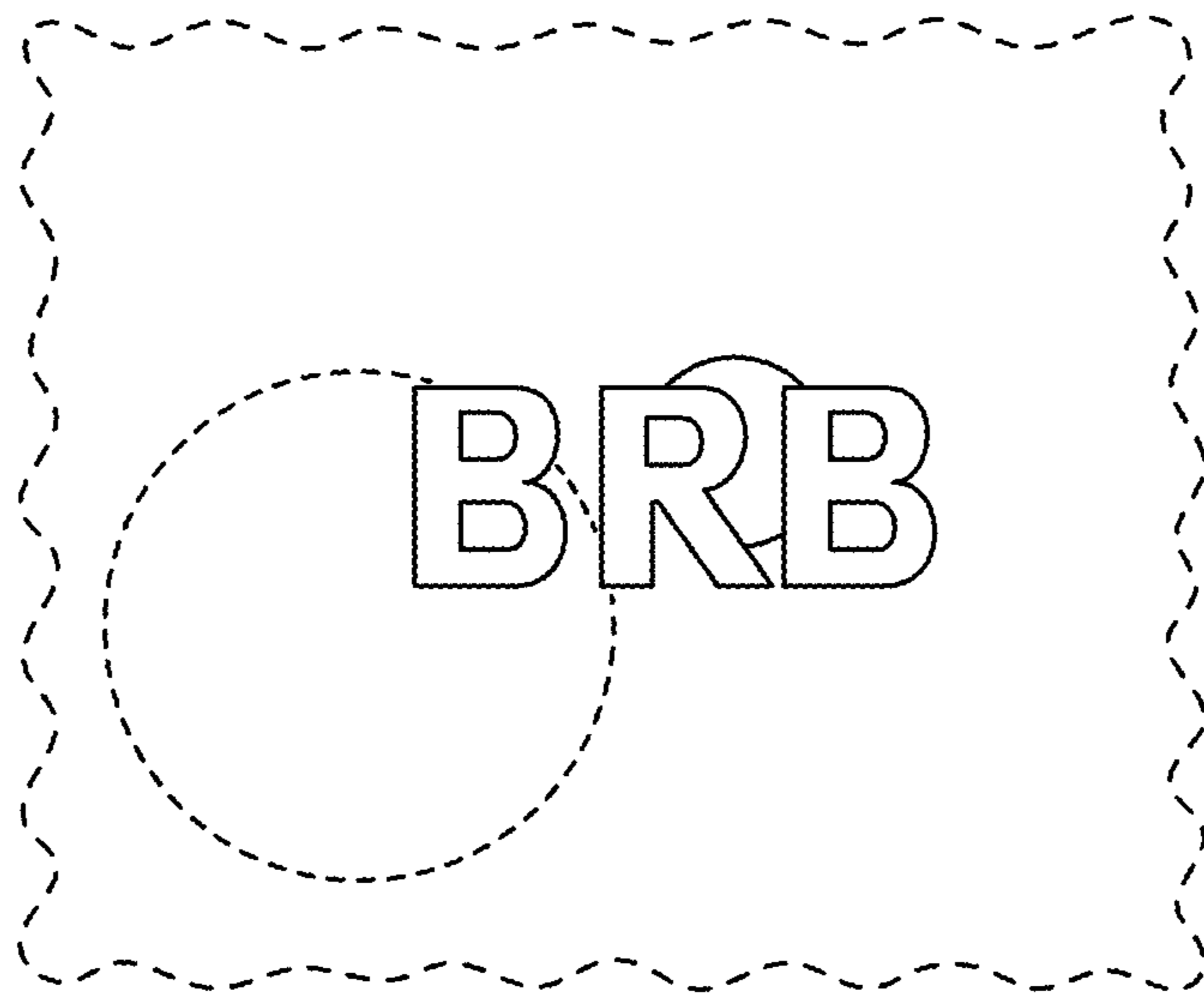

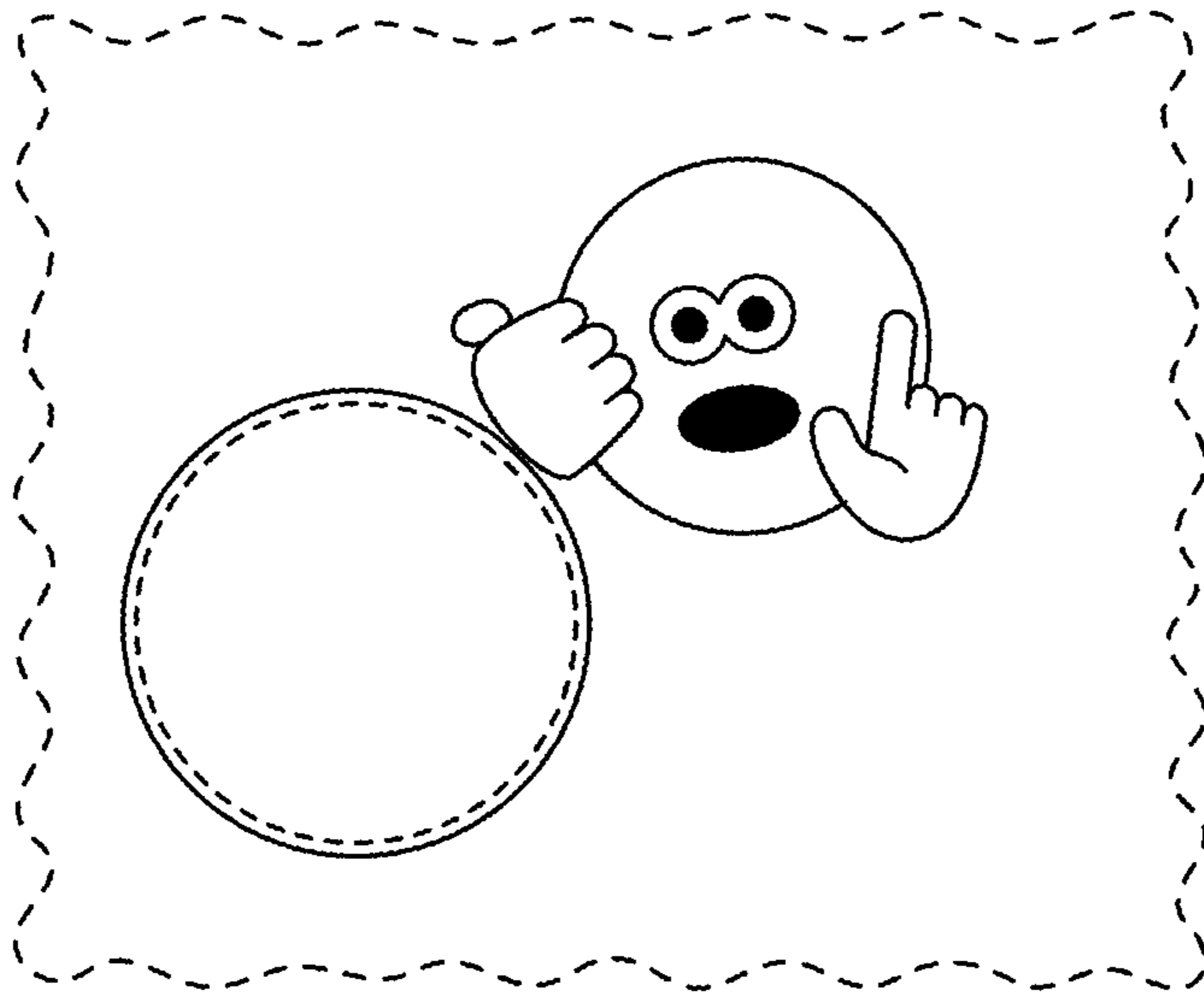

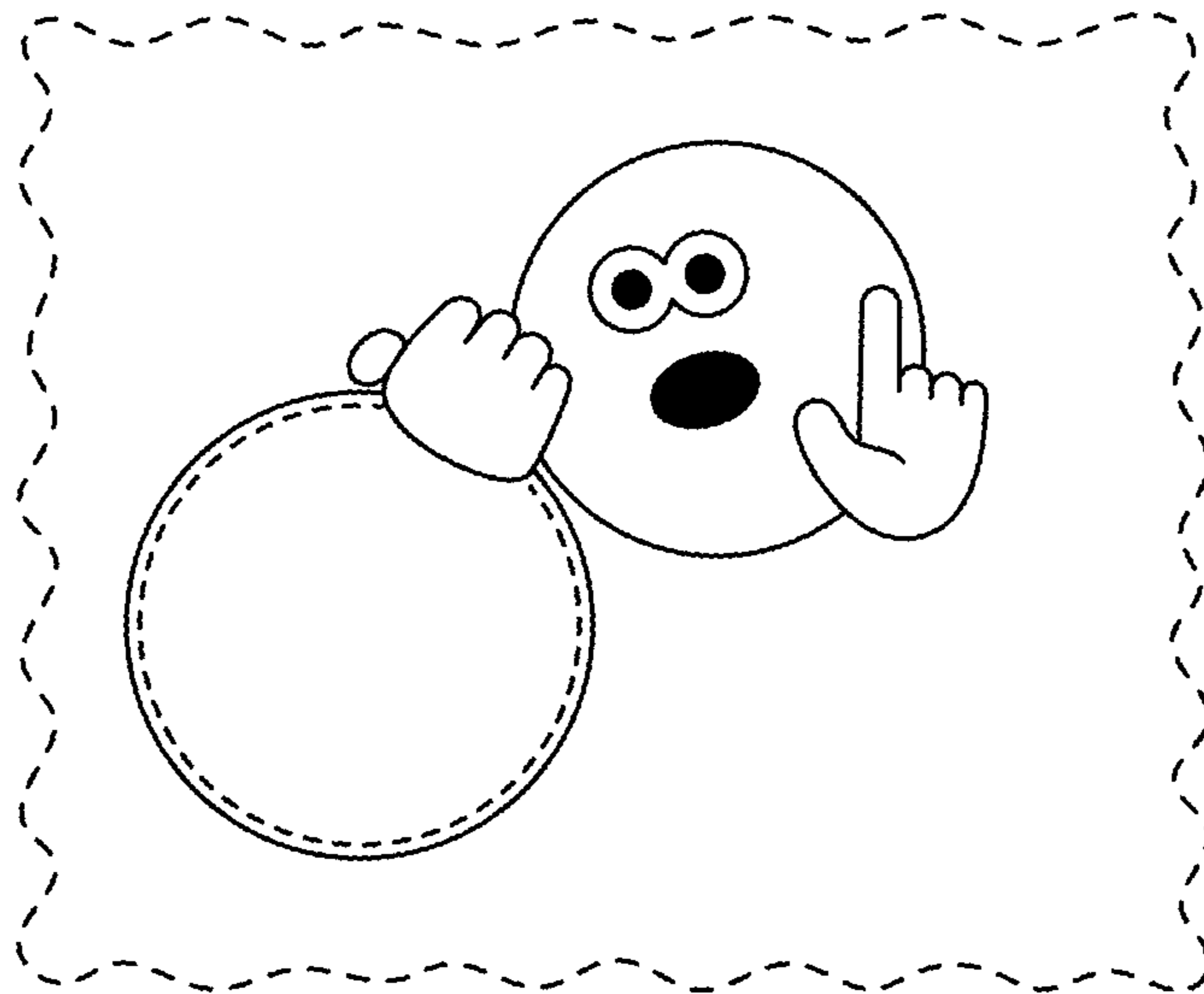

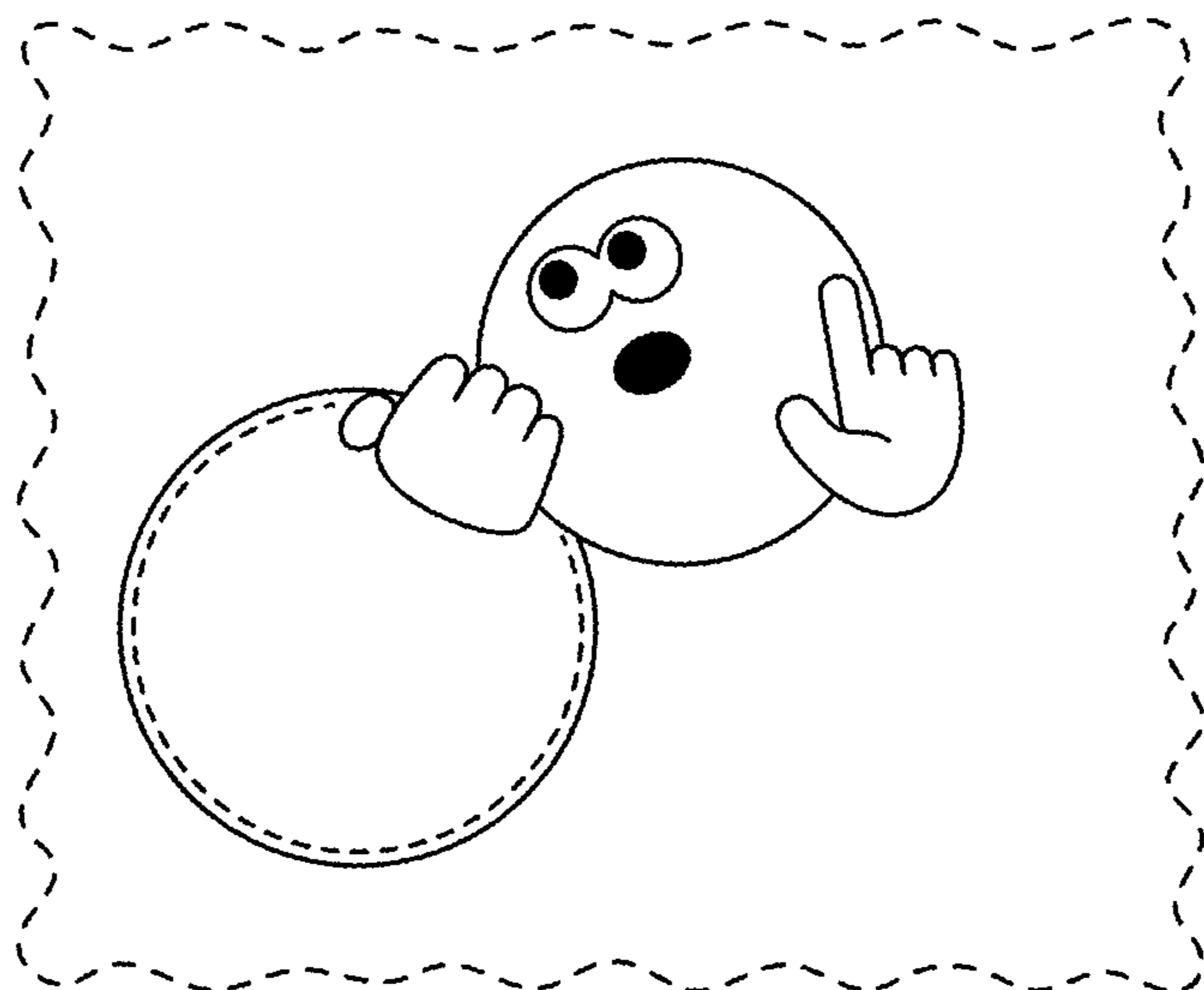

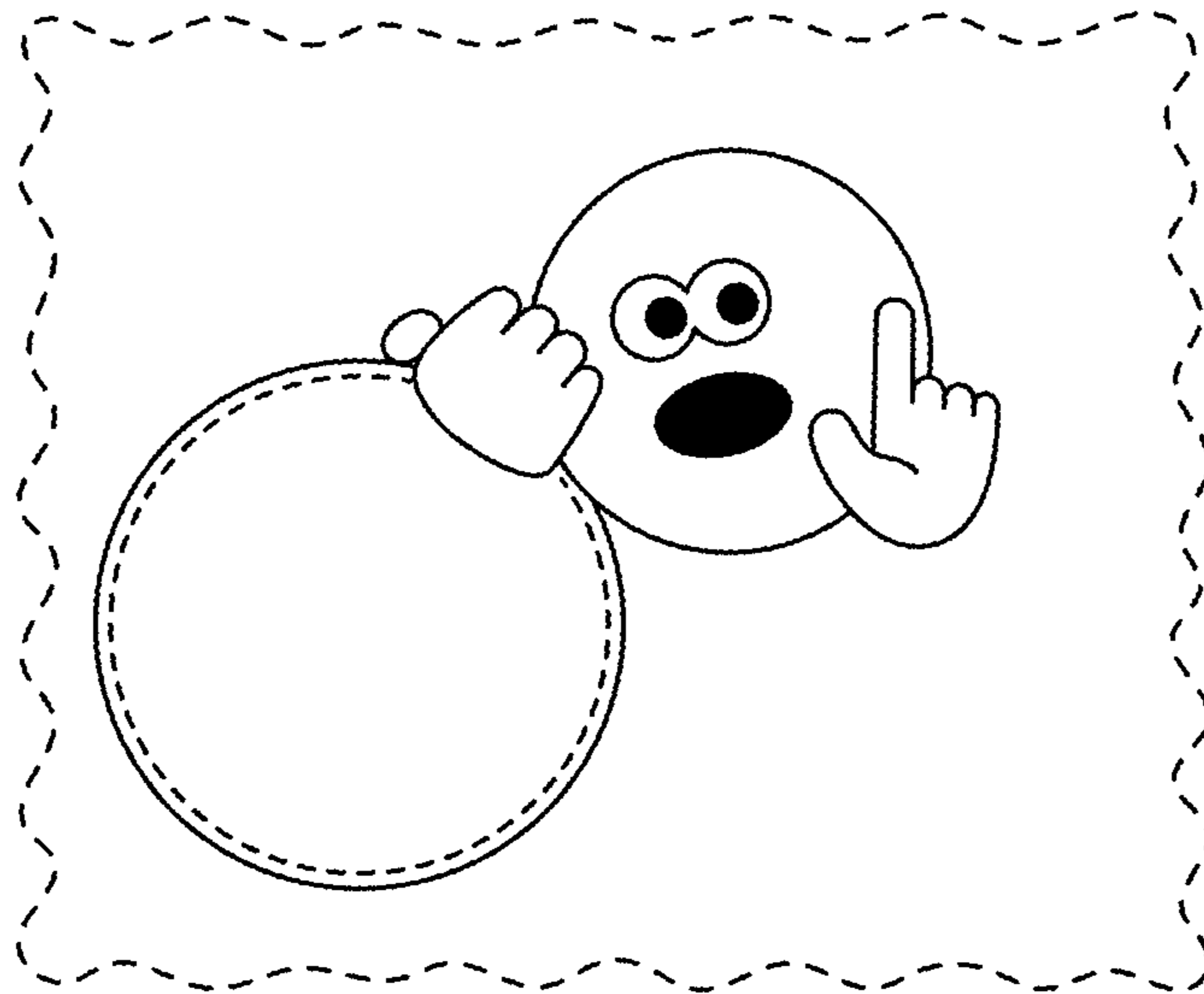

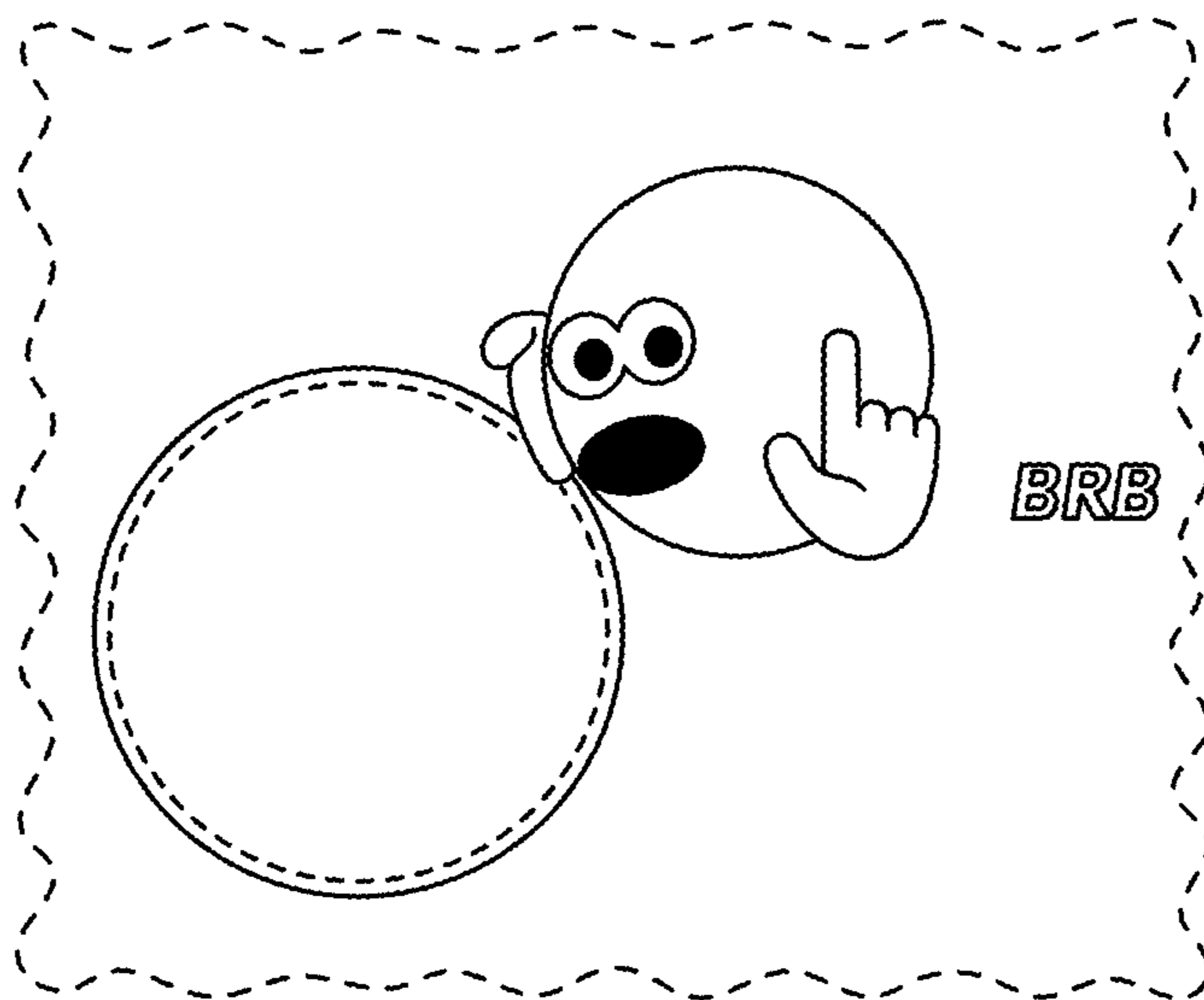

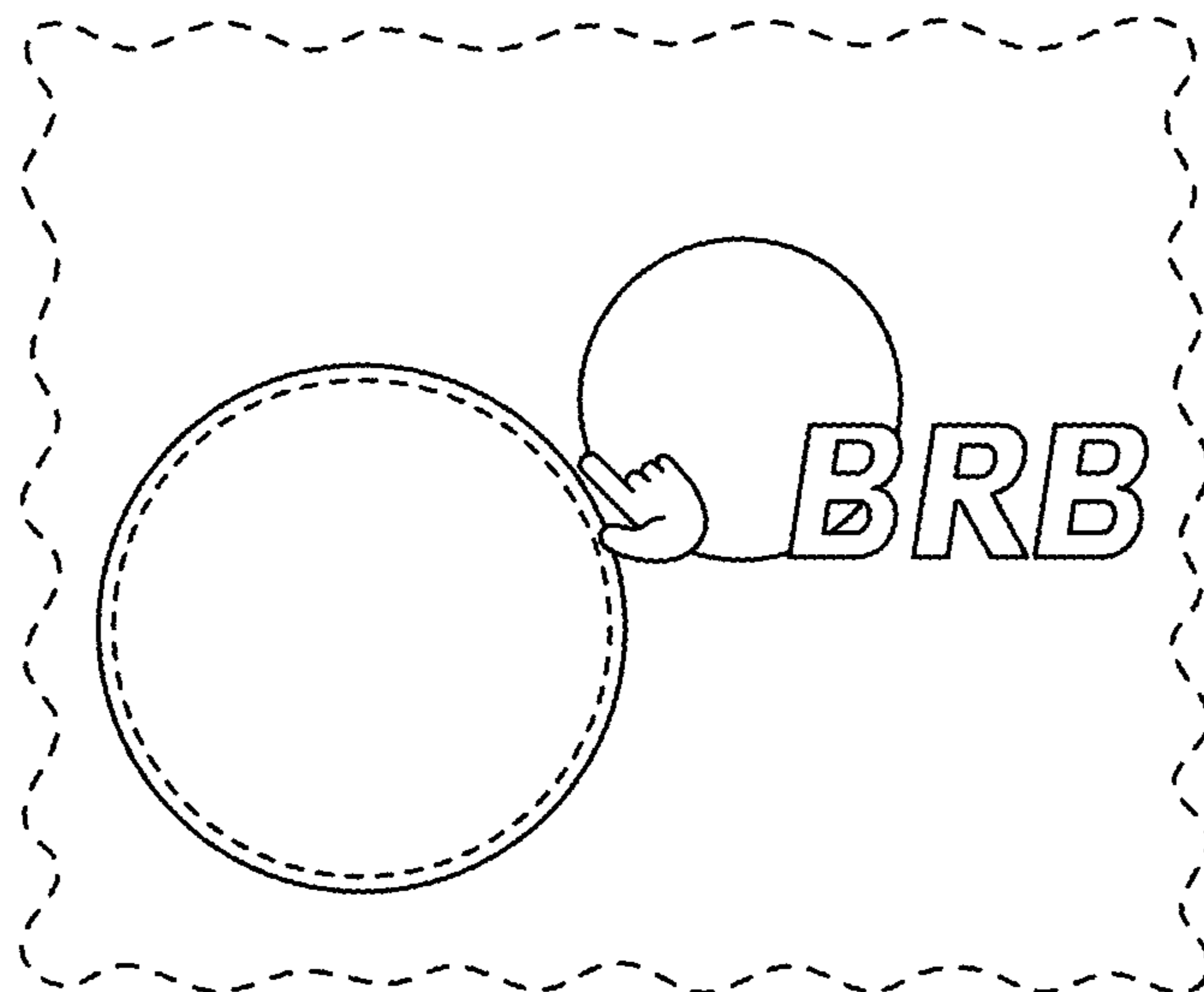

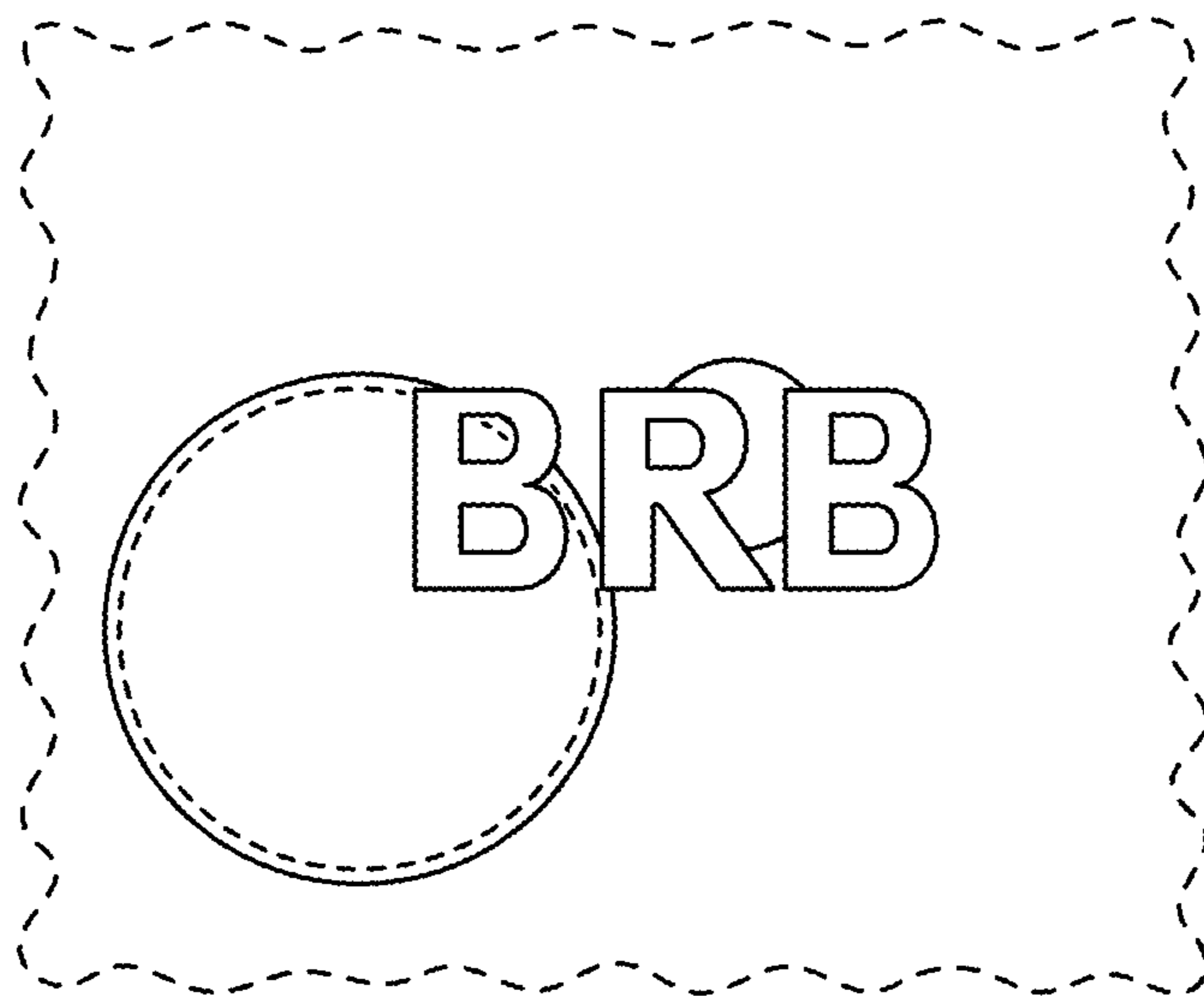
