DESCRIPTION

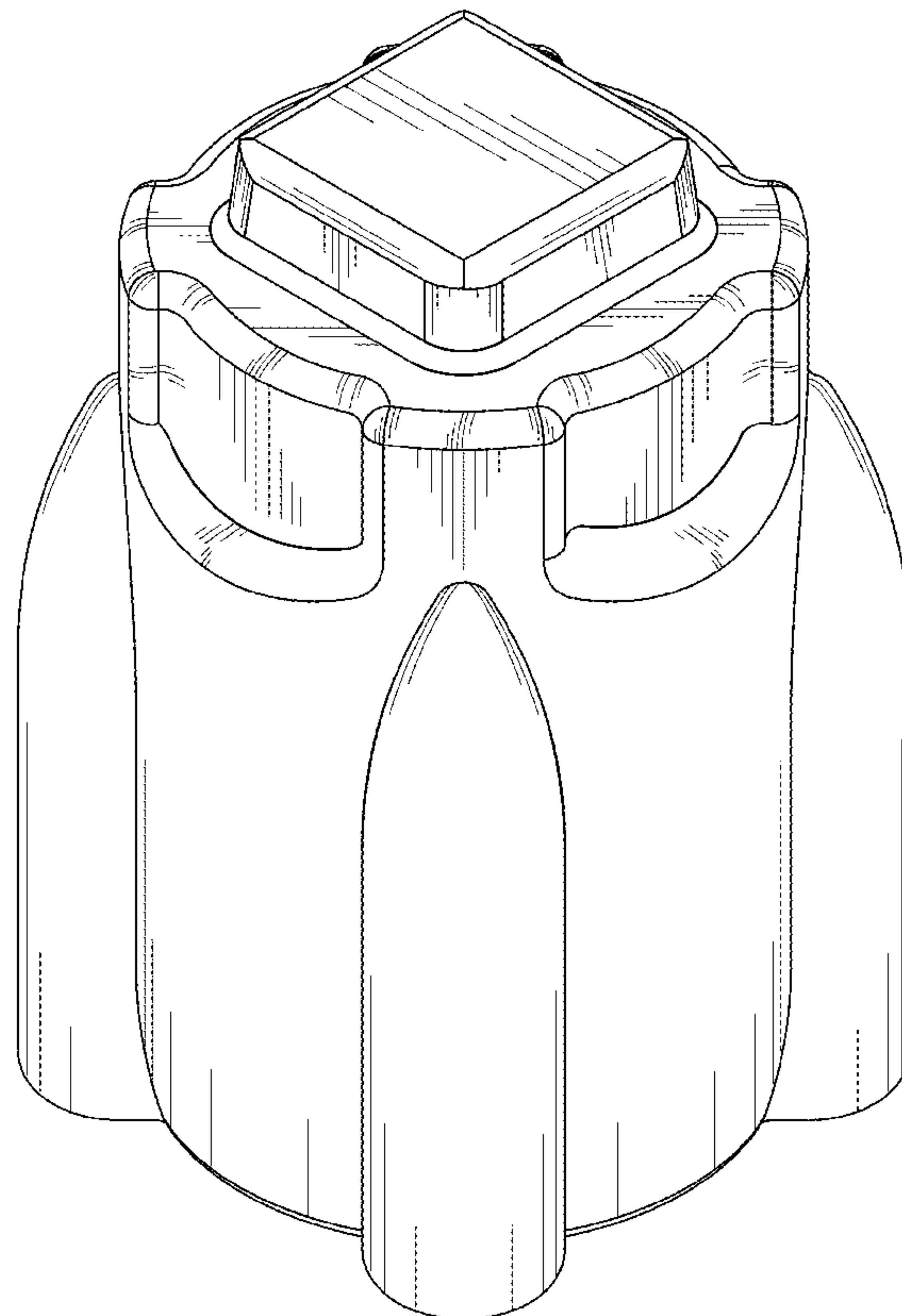
FIG. 1 is a top perspective view of the block piece from toy set;

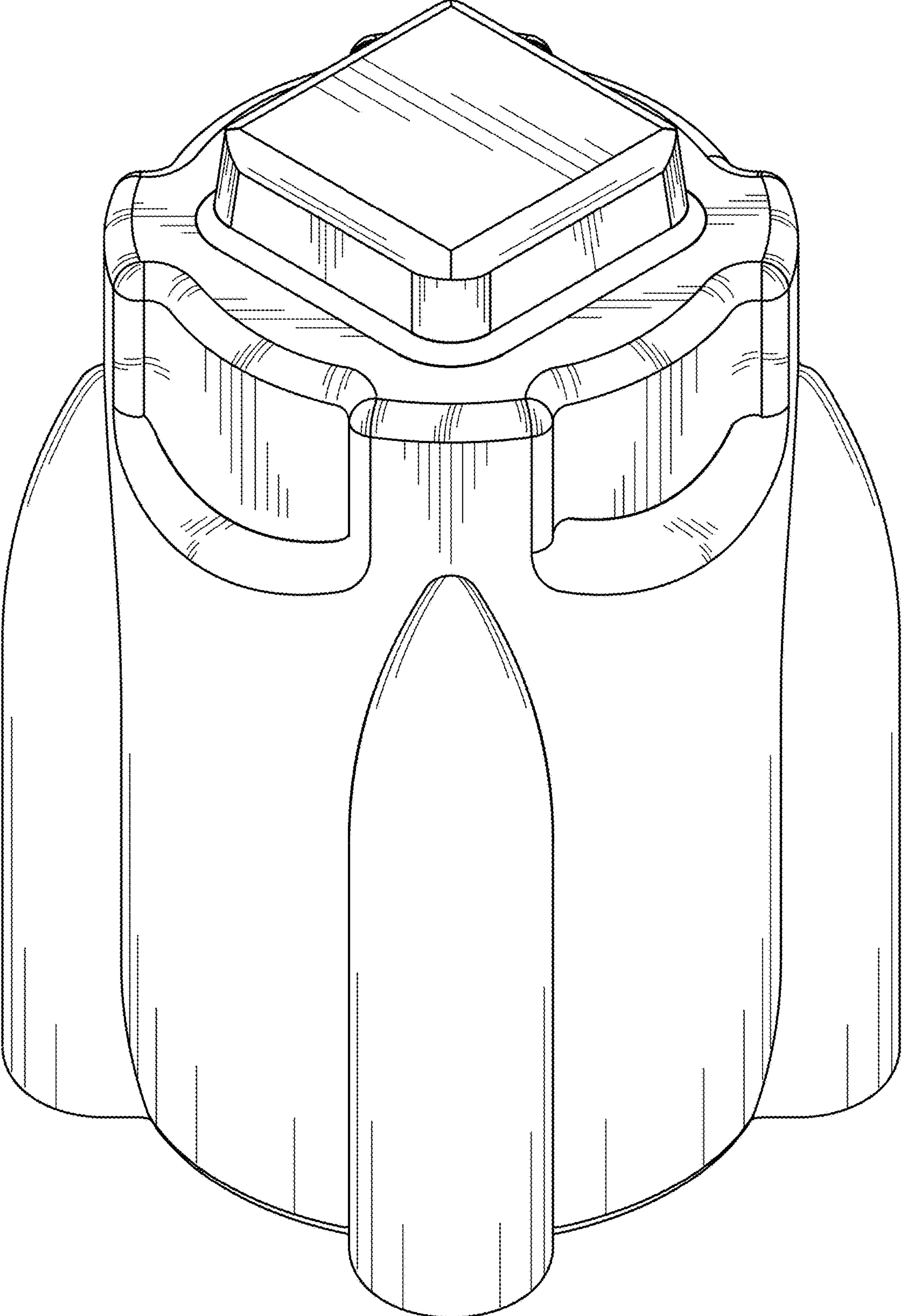

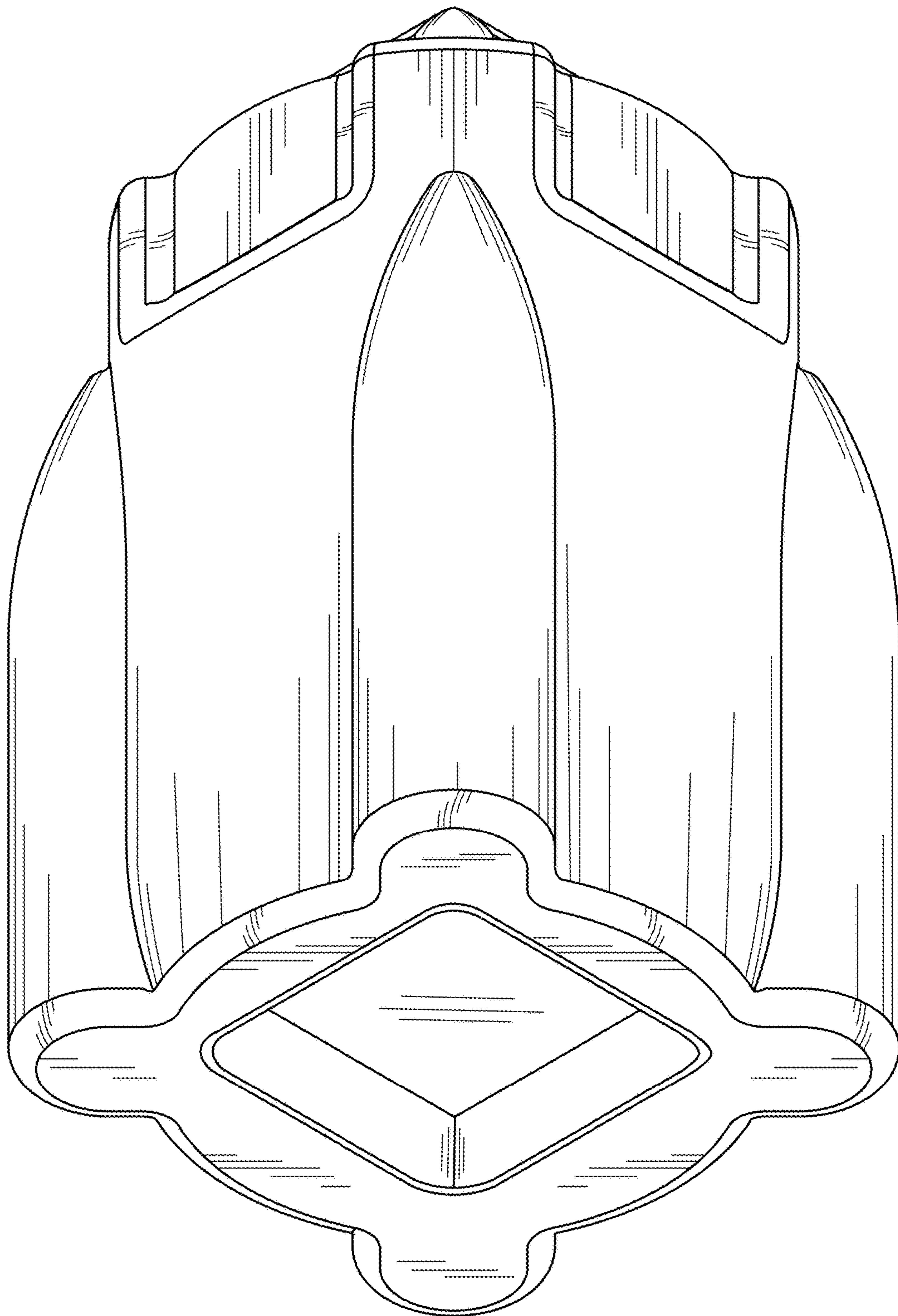

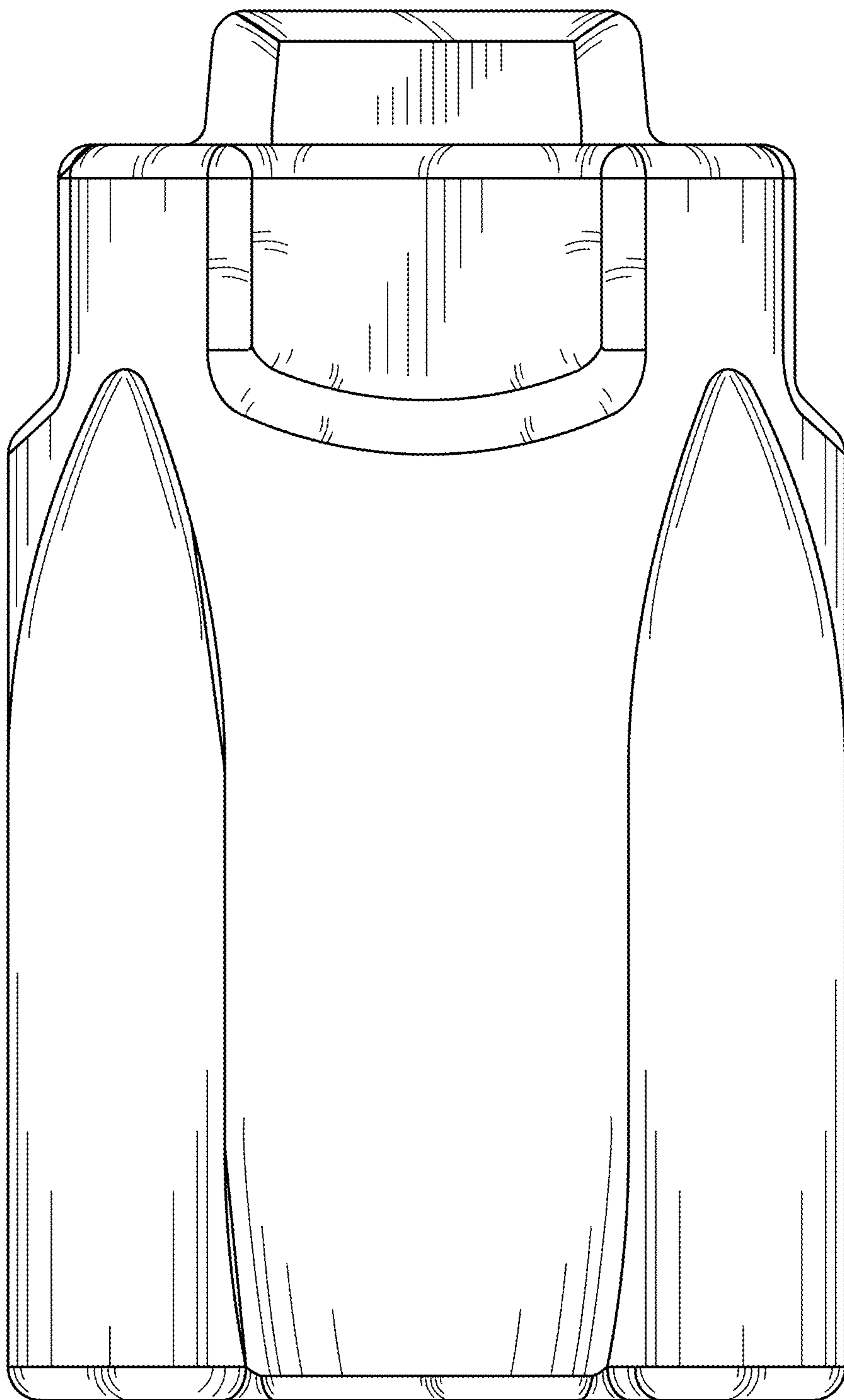

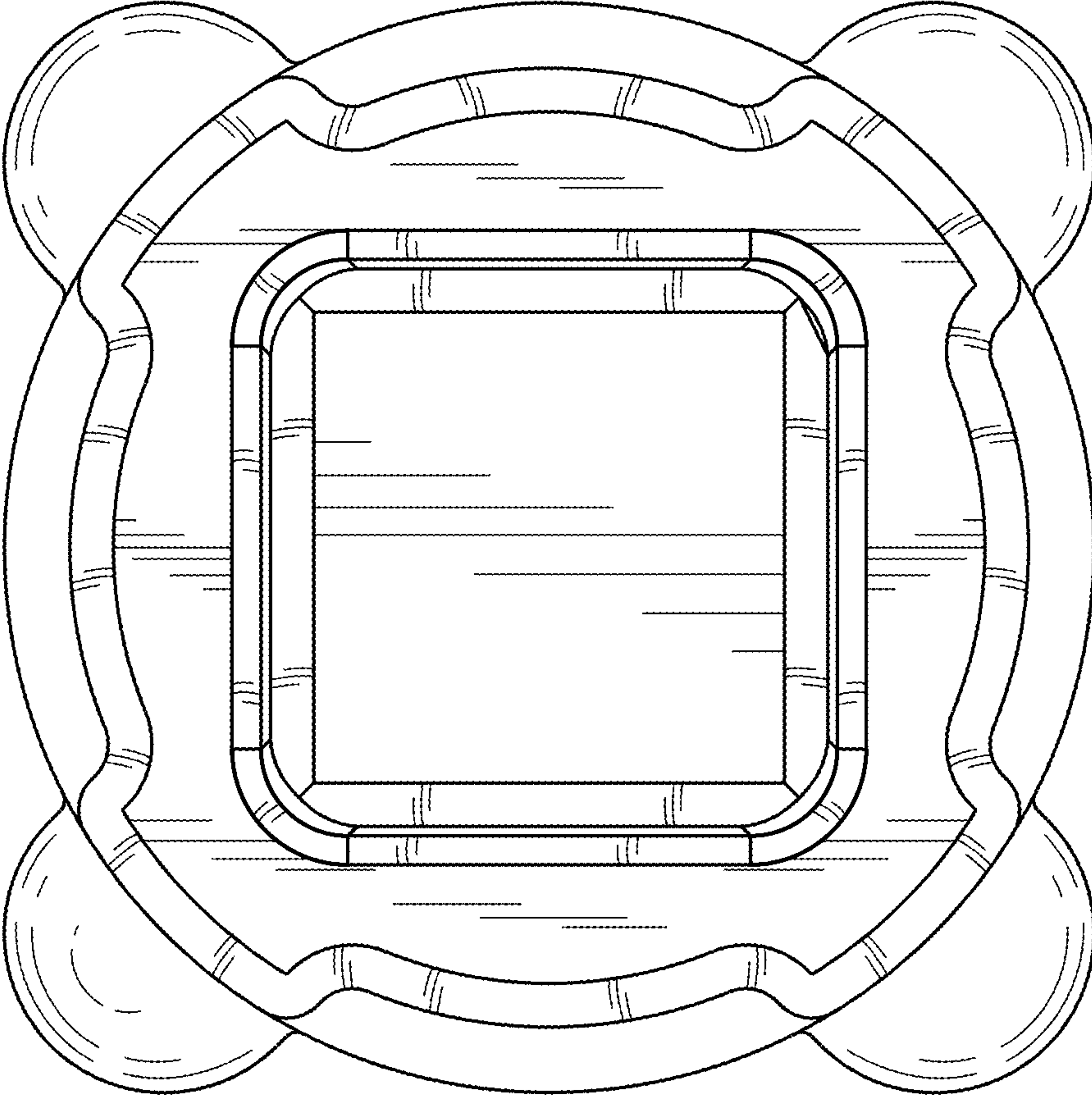

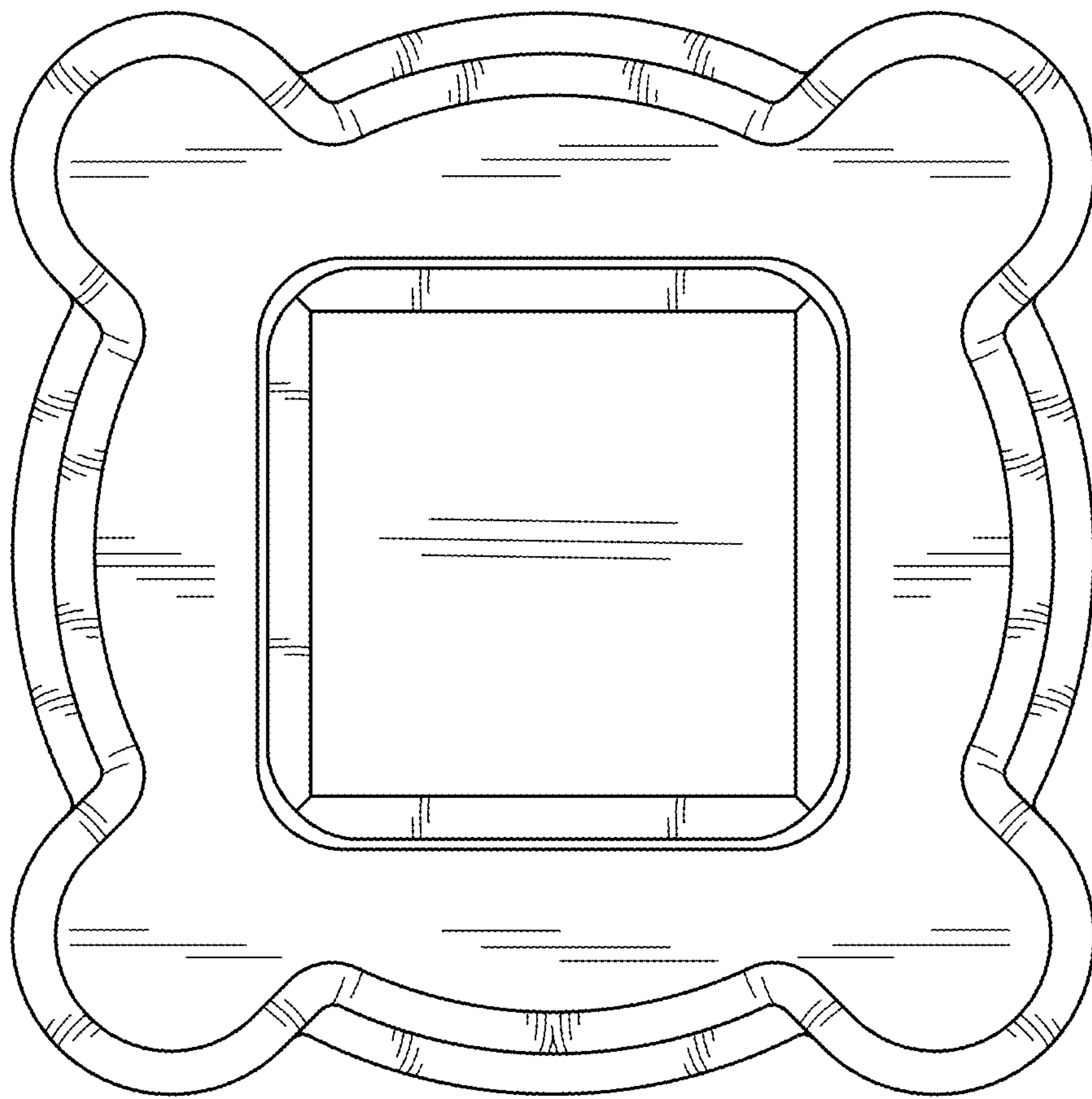

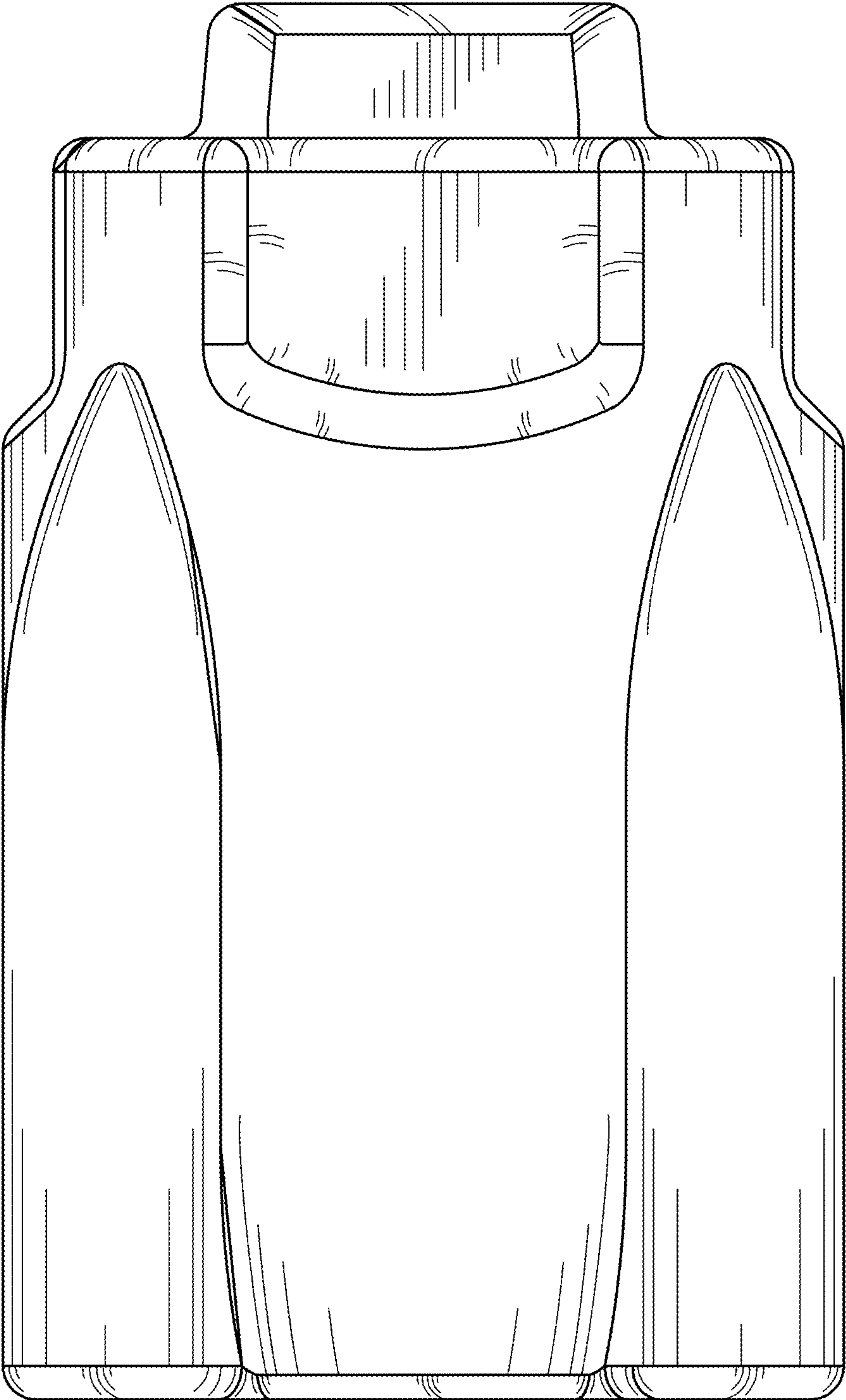
