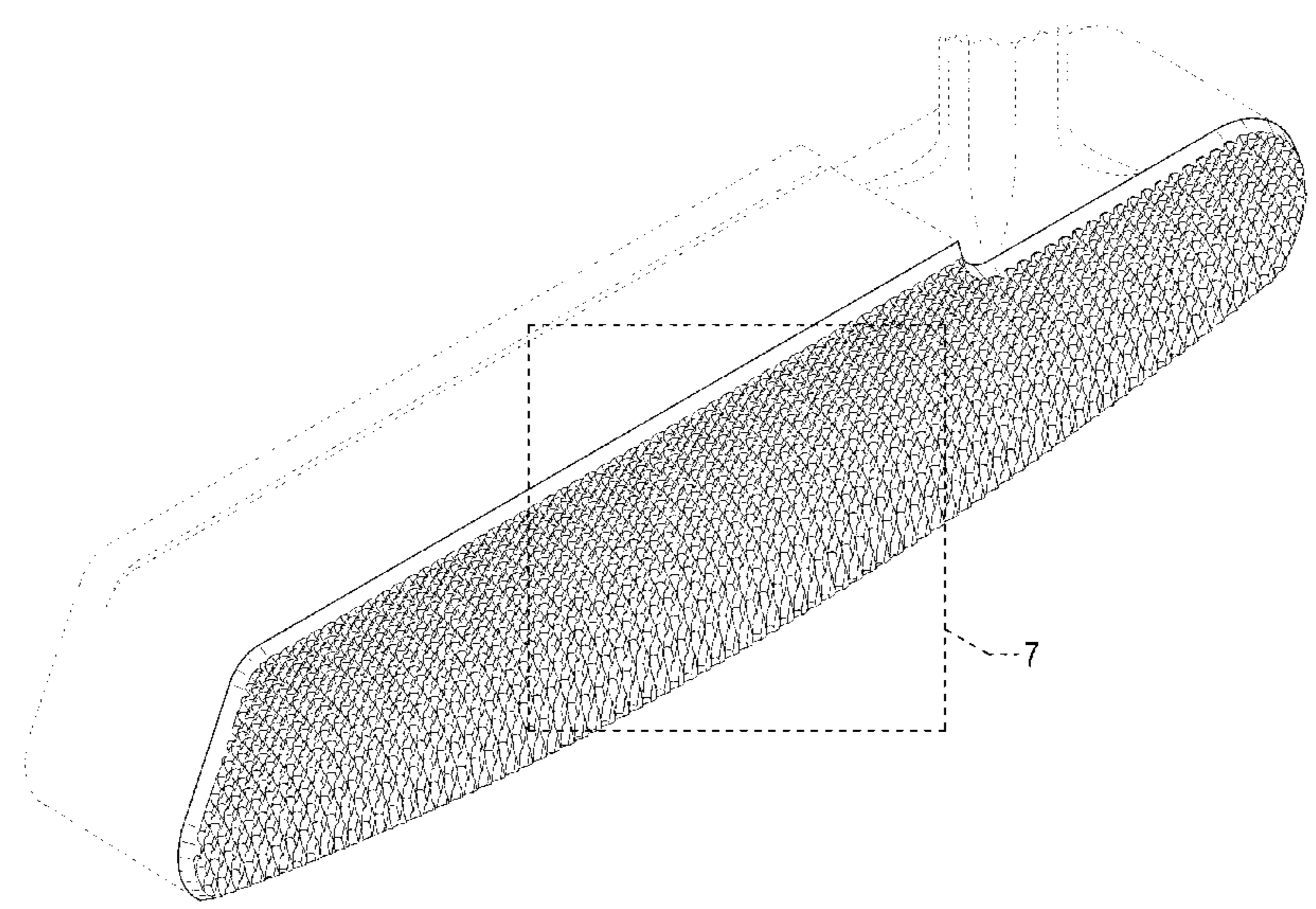

The ornamental design for a golf club head, as shown and described.

DESCRIPTION
FIG. 1 is a front, top, toe-side perspective view of a first embodiment the golf club head;
FIG. 2 is a front elevational view thereof;

FIG. 4 is a heel-side elevational view thereof;
FIG. 5 is a toe-side elevational view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is an enlargement of area 7 in FIG. 1;
FIG. 8 is an enlargement of area 8 in FIG. 2;
FIG. 9 is an enlargement of area 9 in FIG. 2;
FIG. 10 is an enlargement of area 10 in FIG. 3;
FIG. 11 is an enlargement of area 11 in FIG. 3;
FIG. 12 is an enlargement of area 12 in FIG. 6;

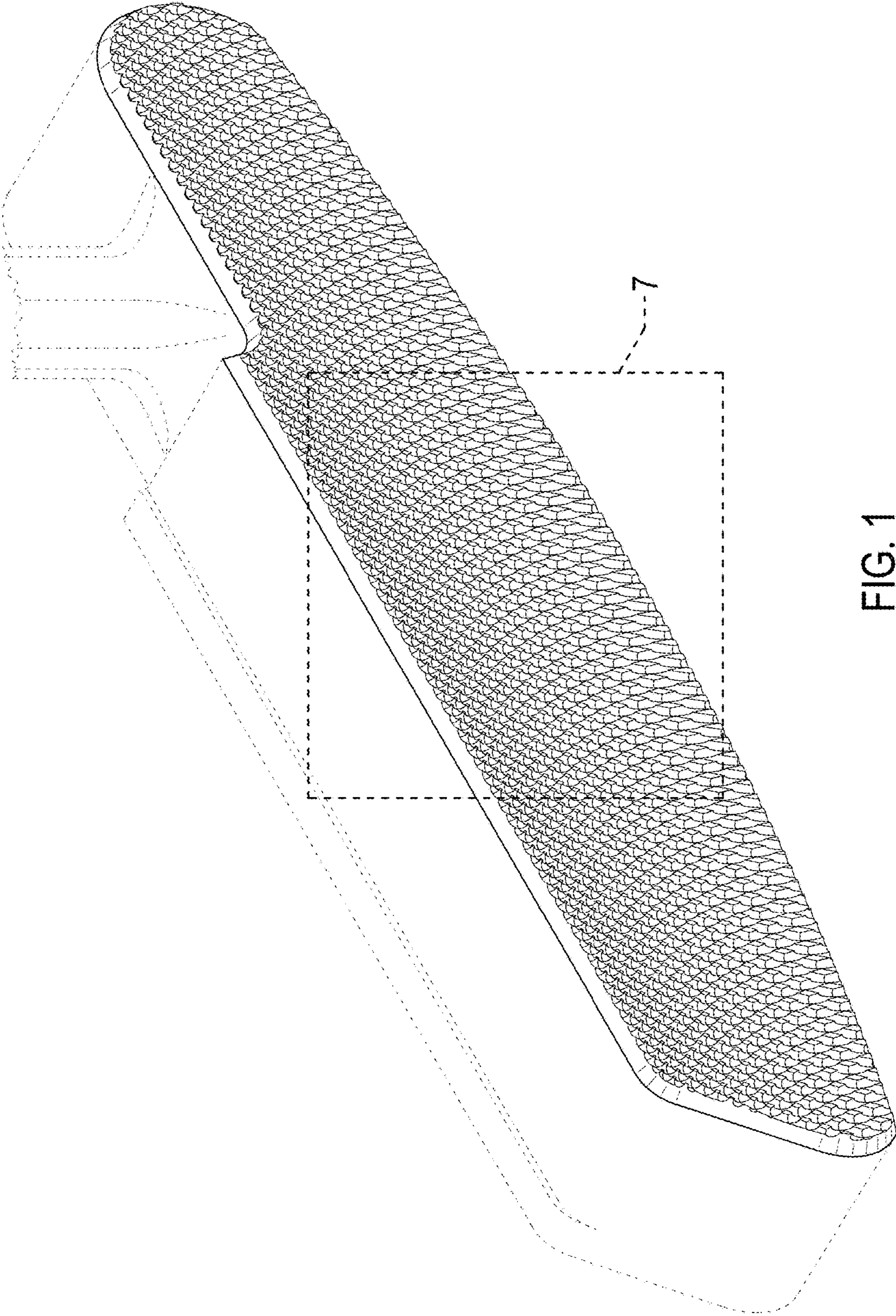

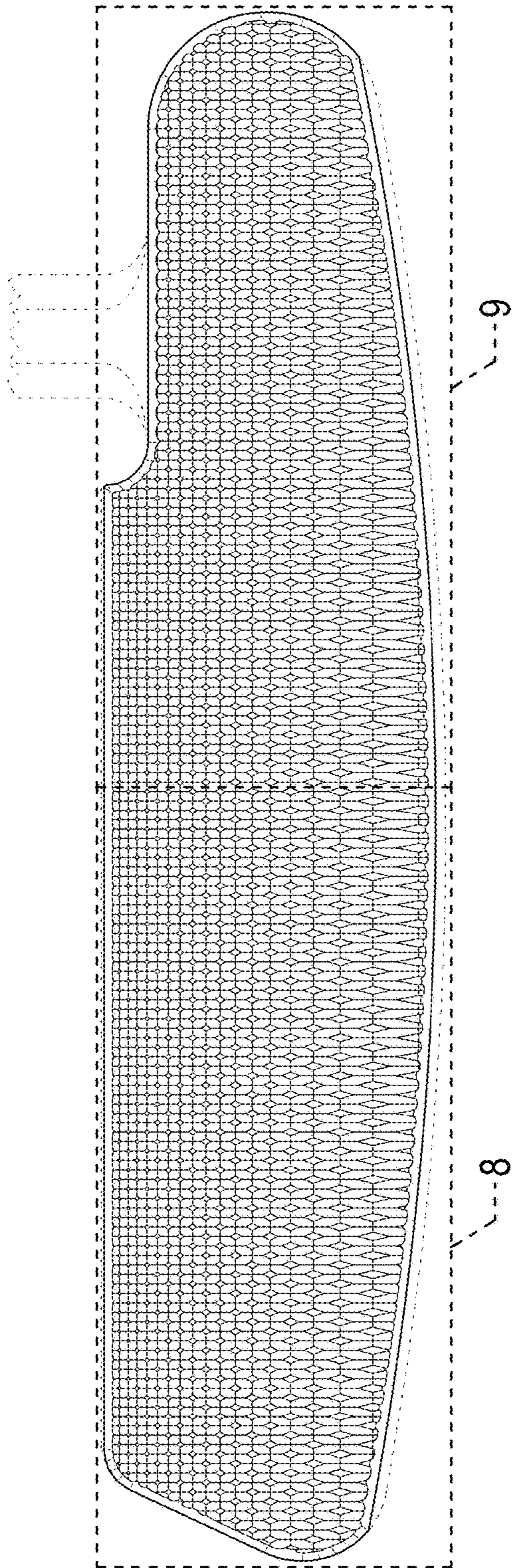

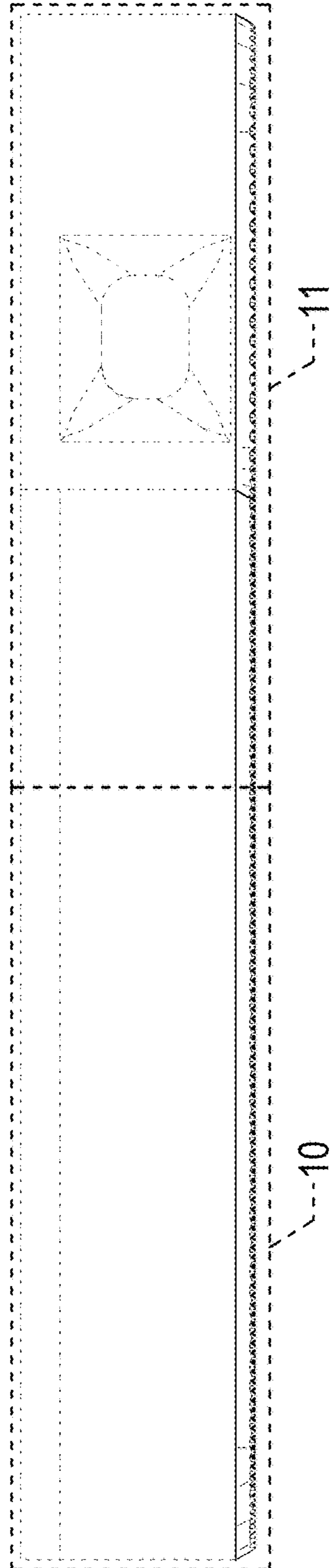

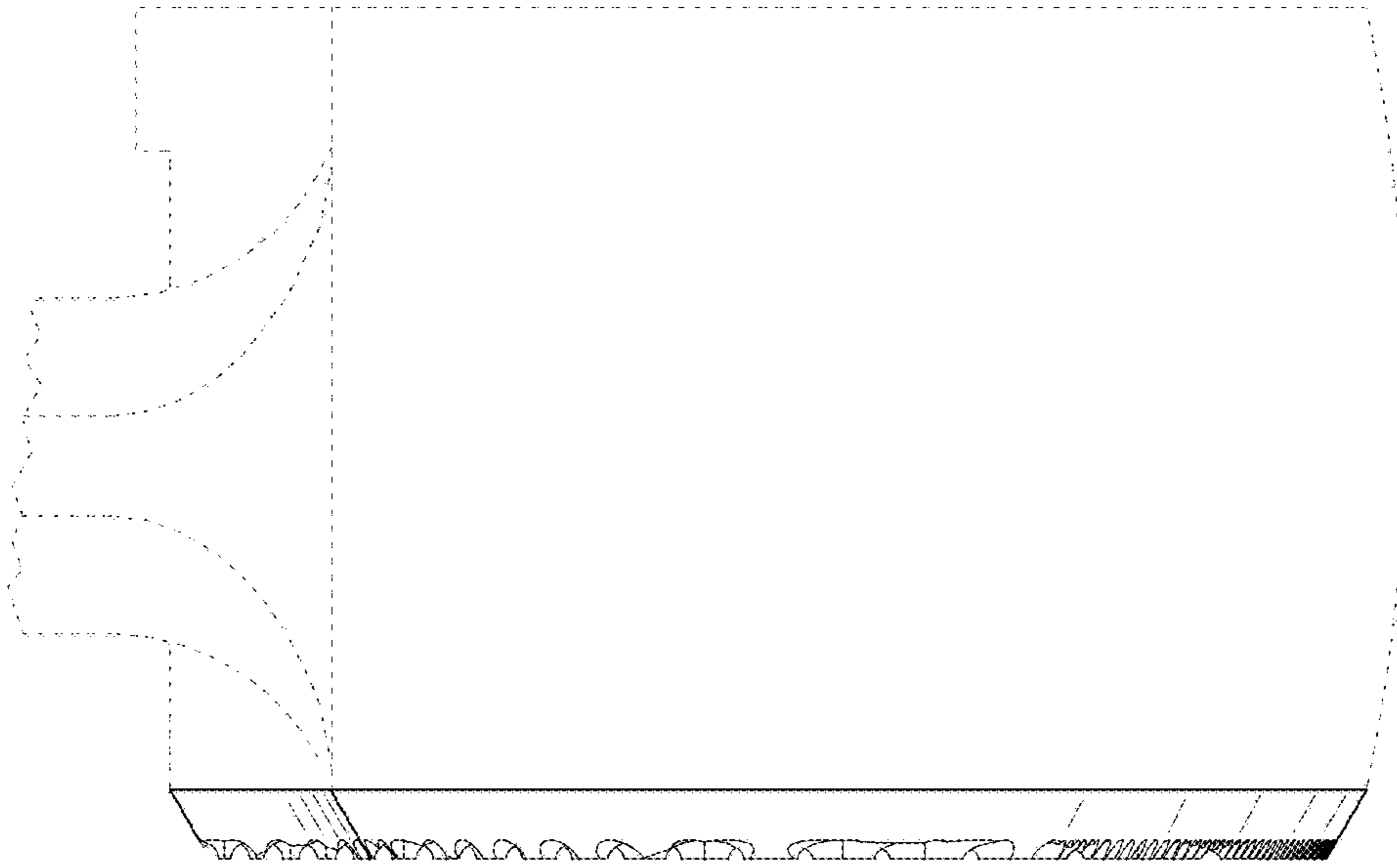

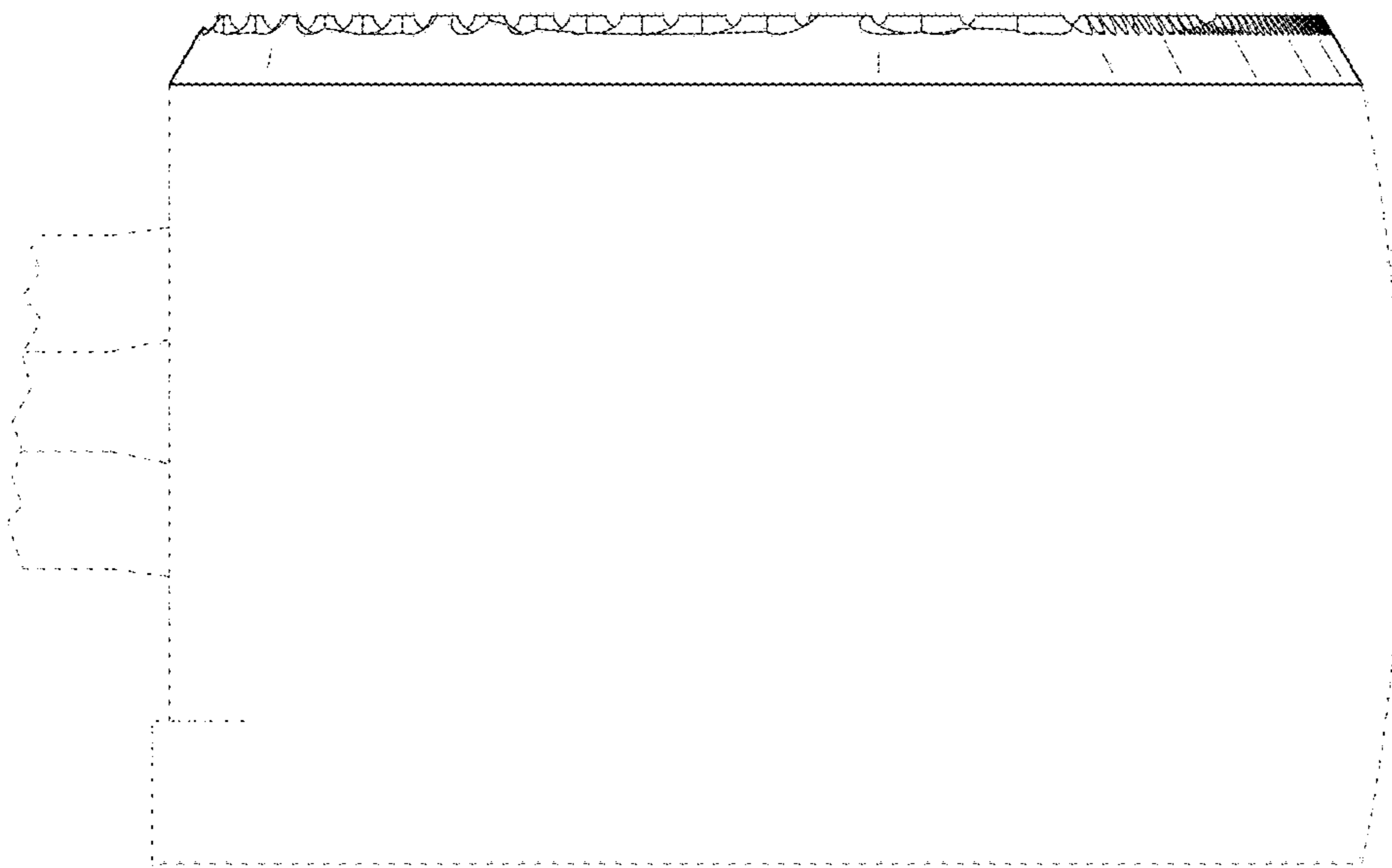

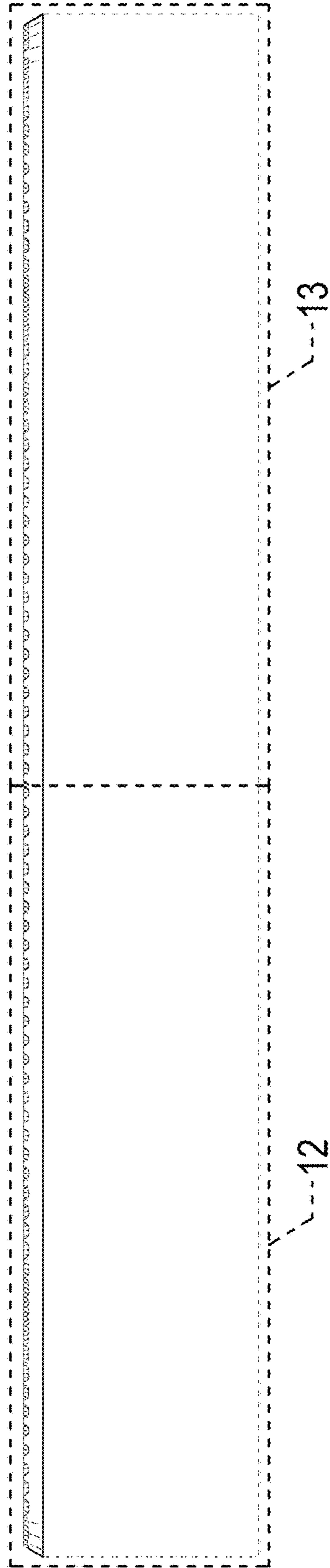

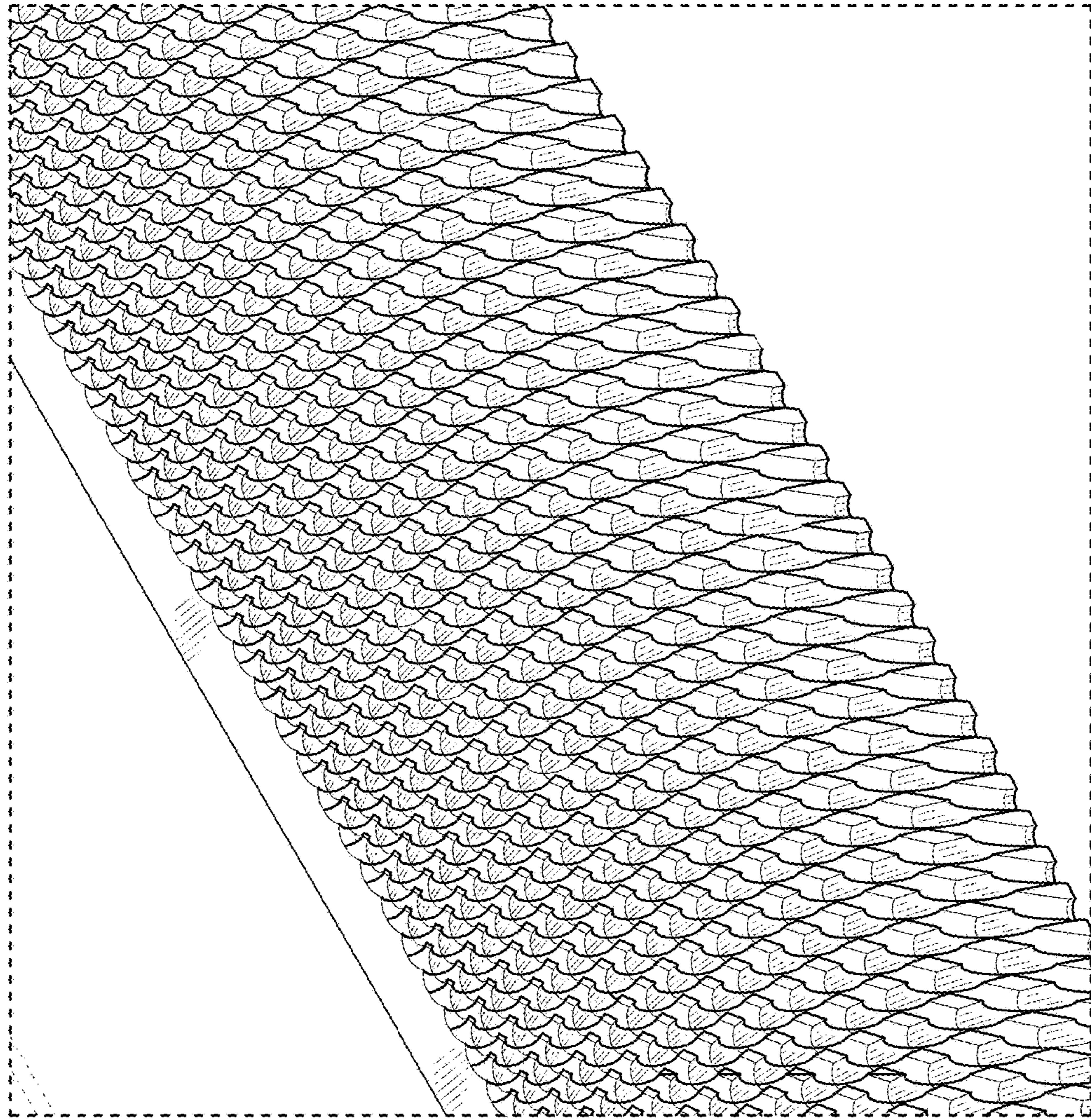

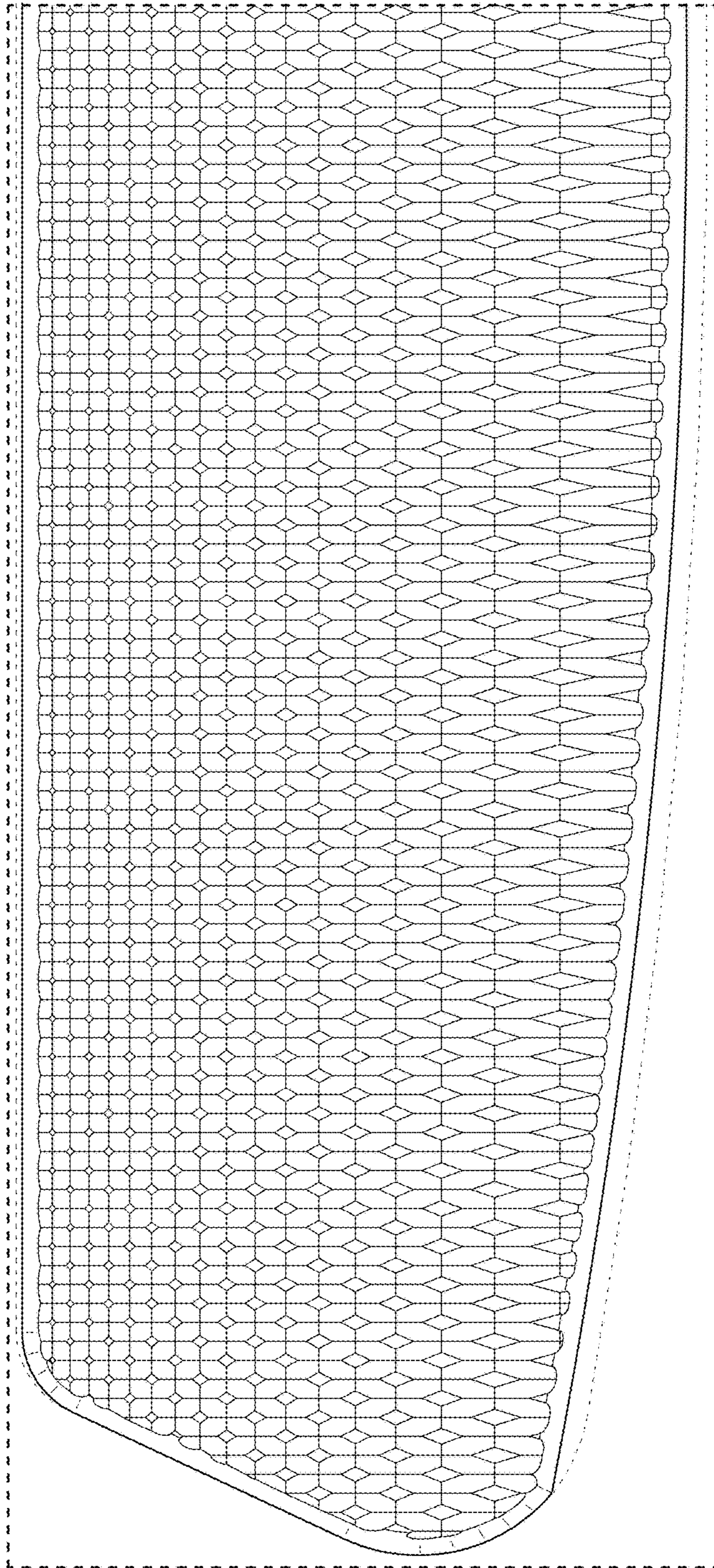

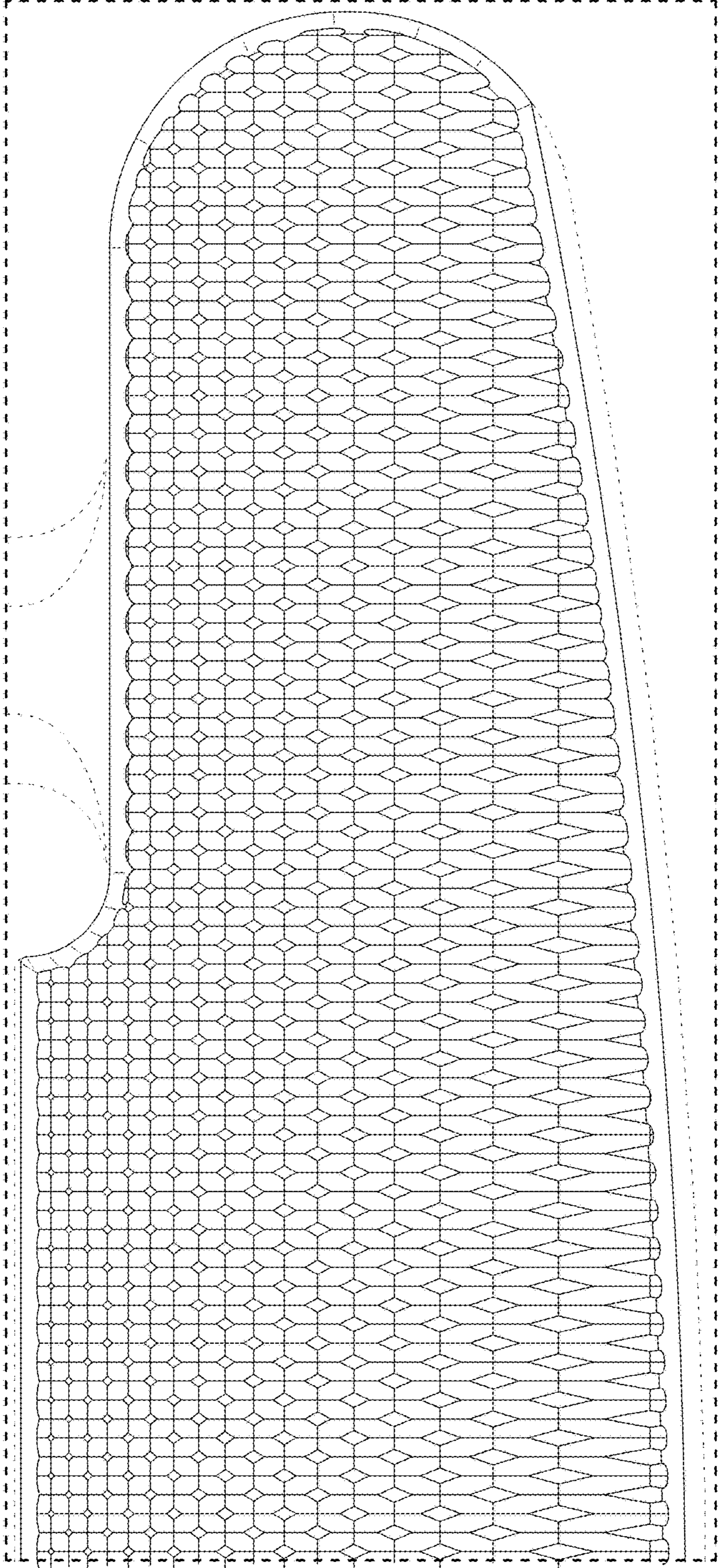

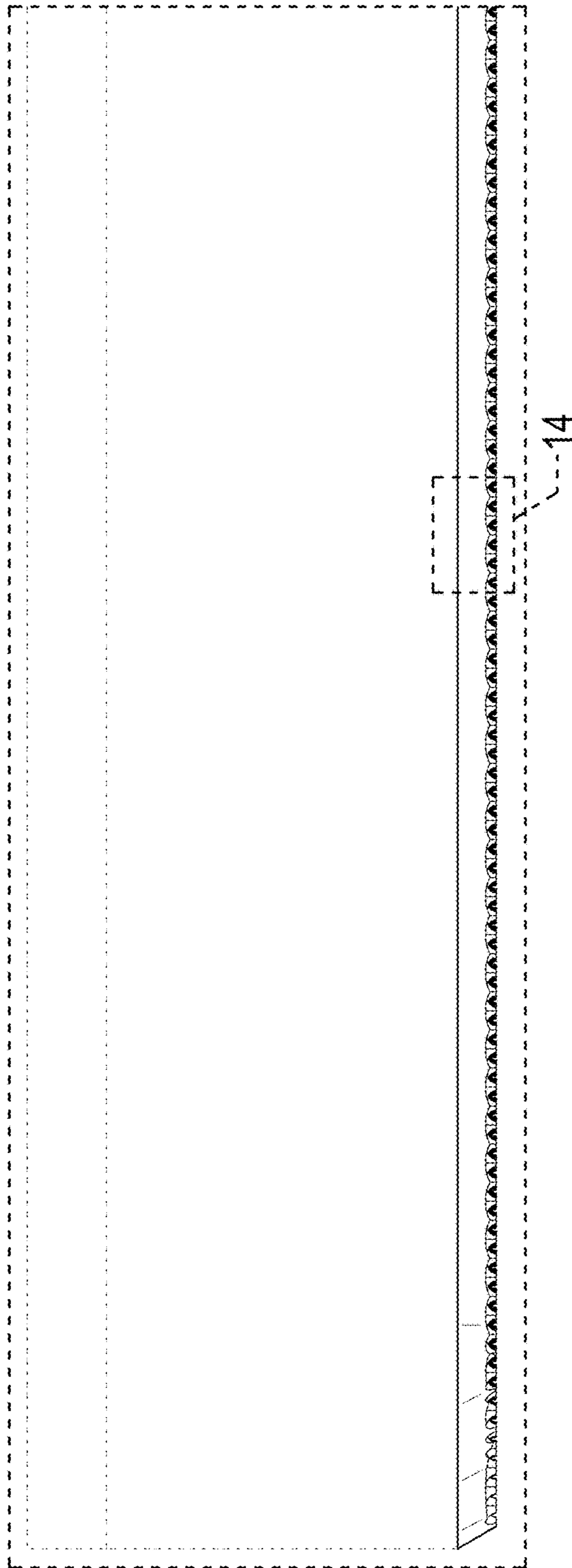

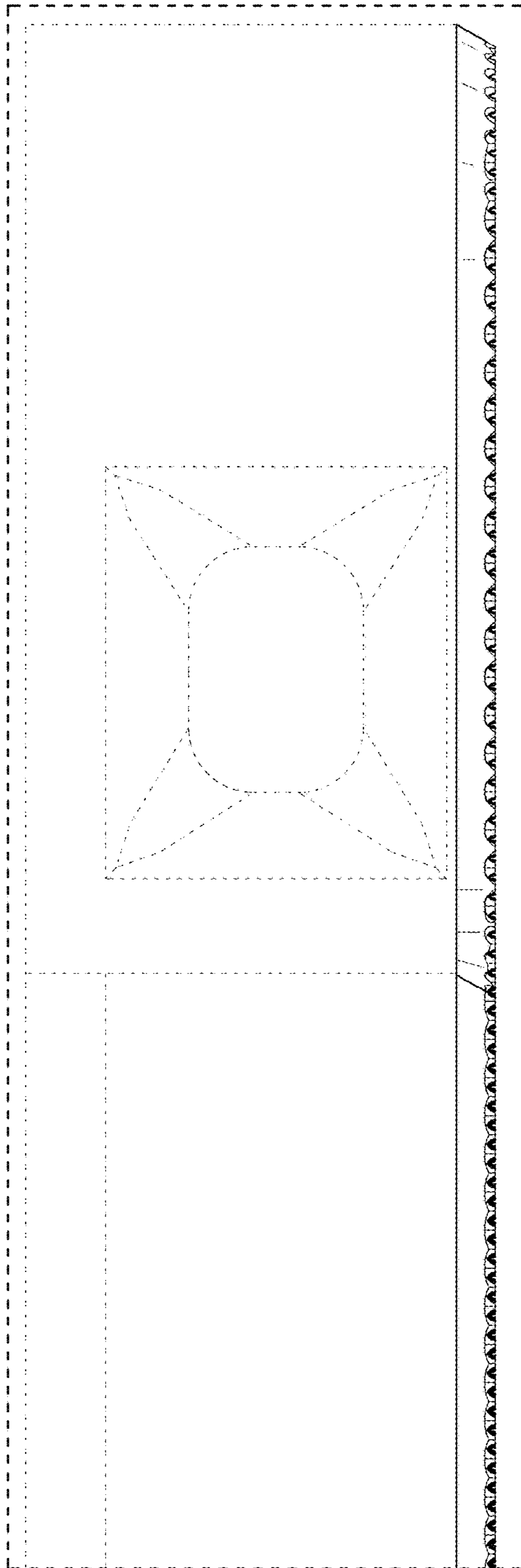

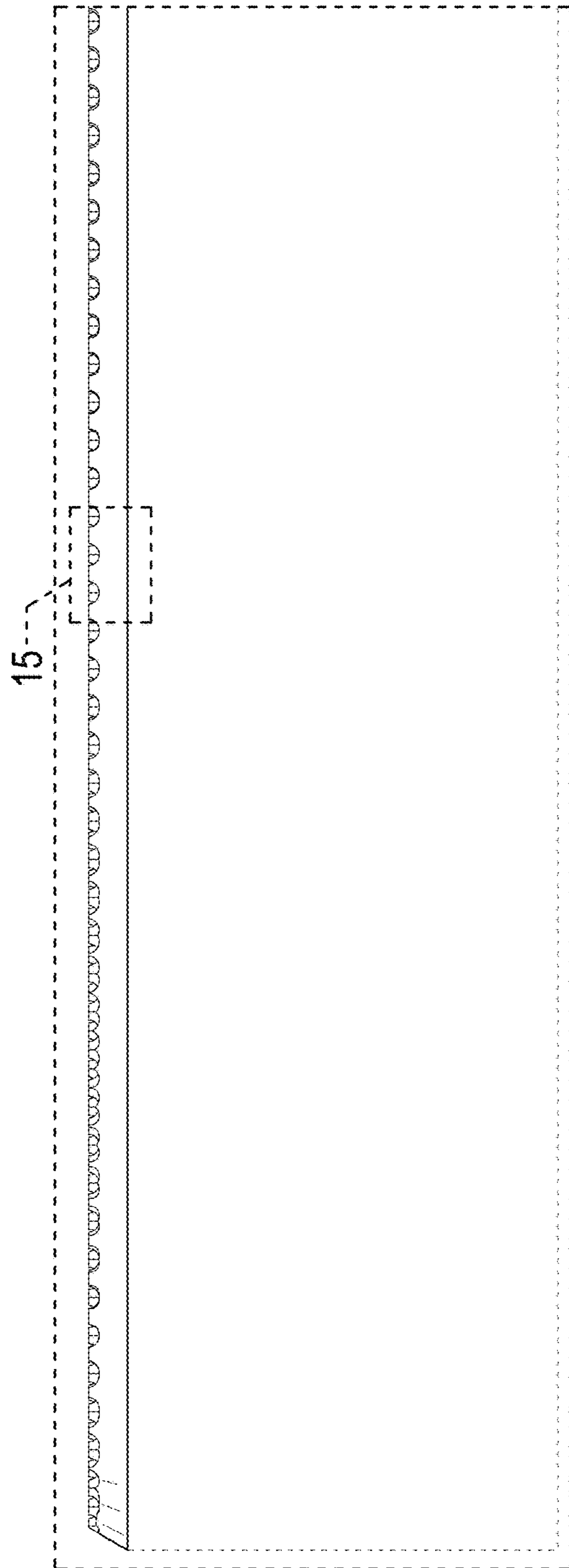

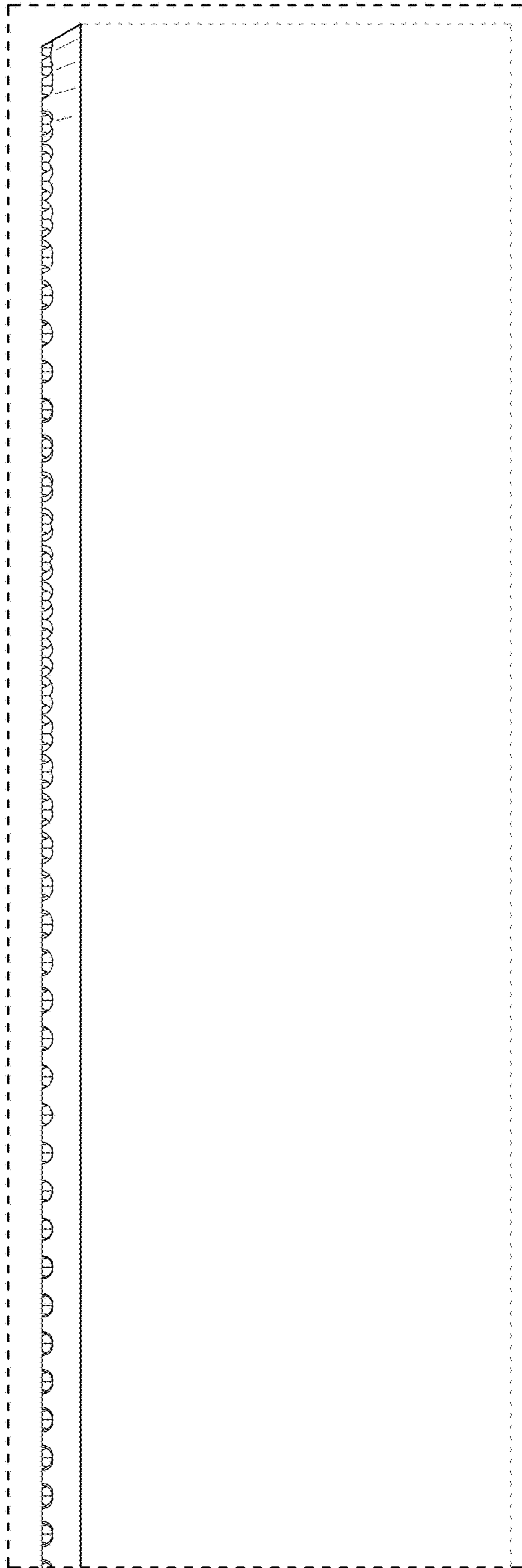

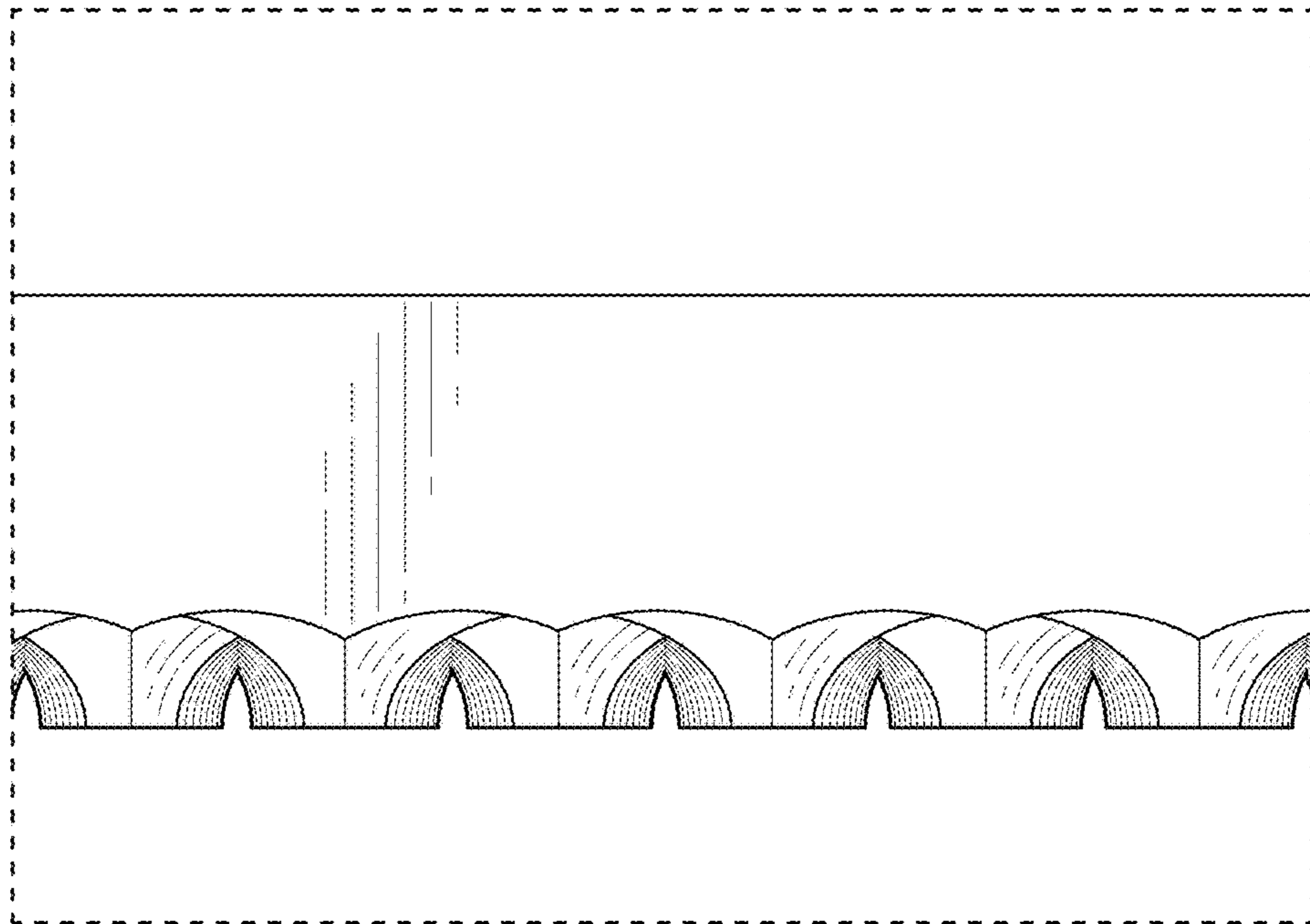

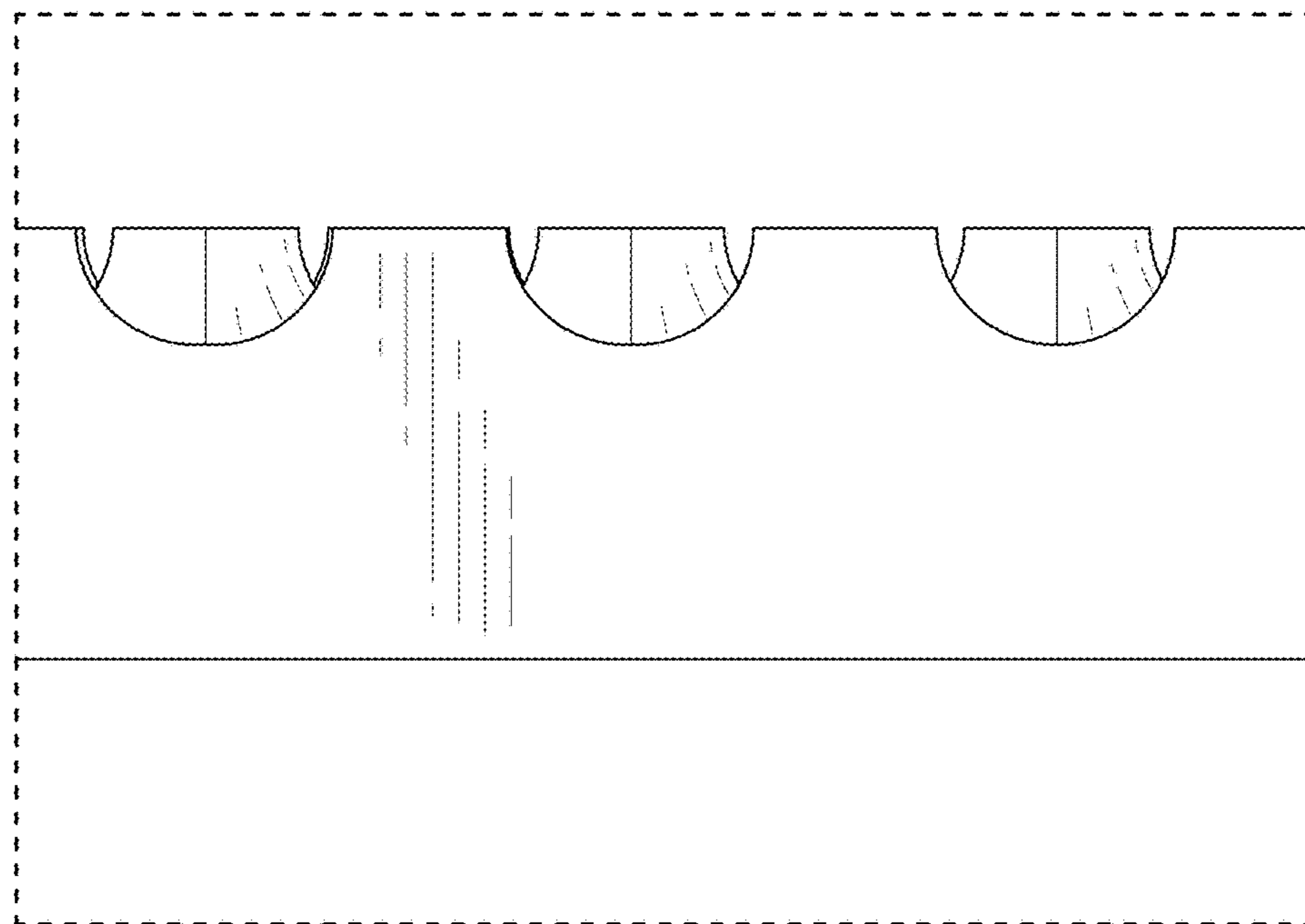
