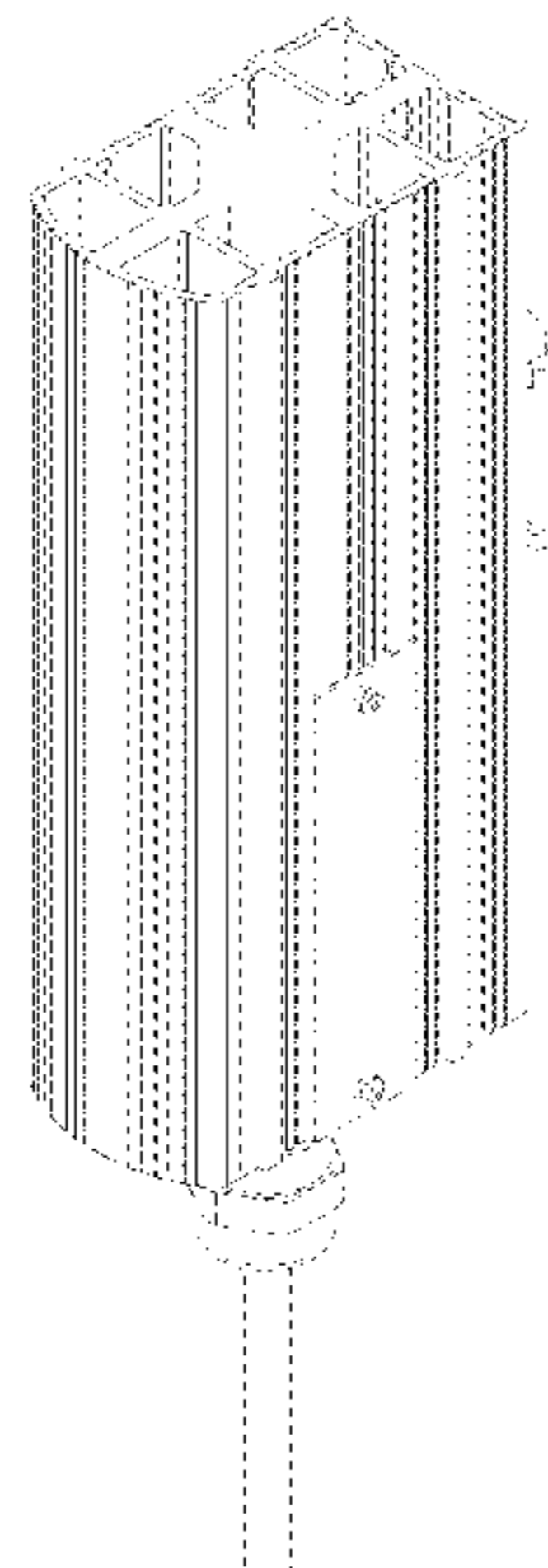


FIG. 19 is a right-side view of the third embodiment of the convector;

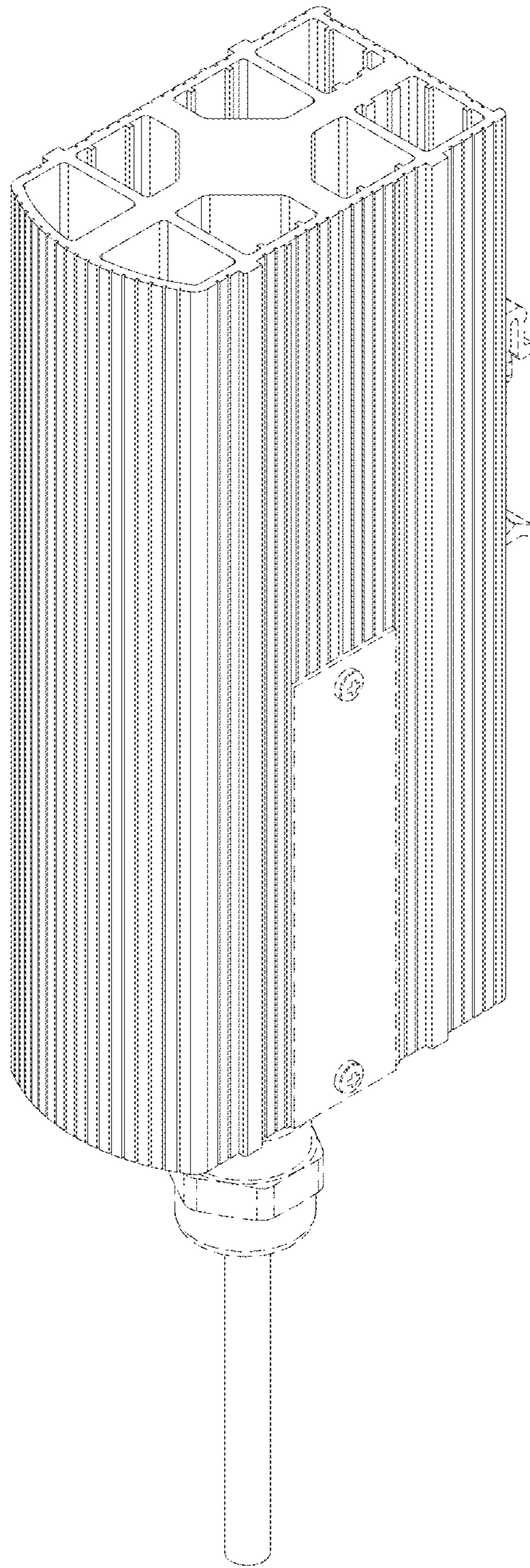

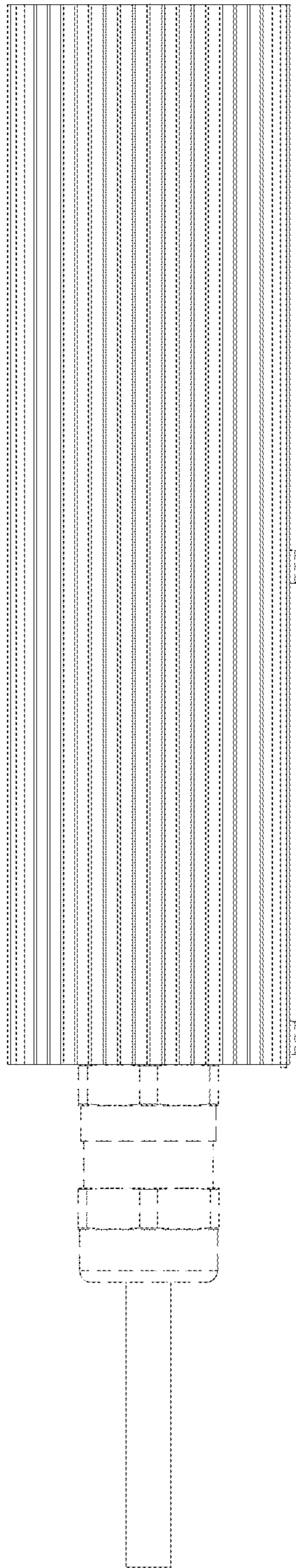

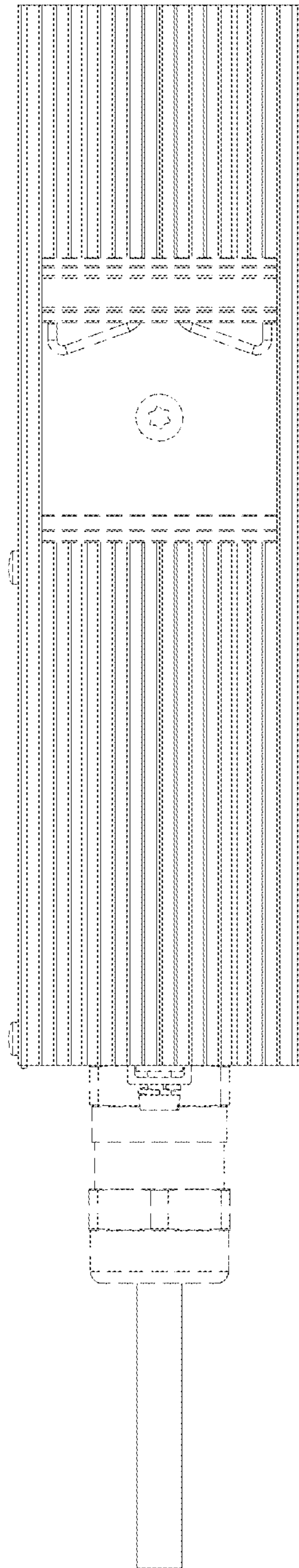

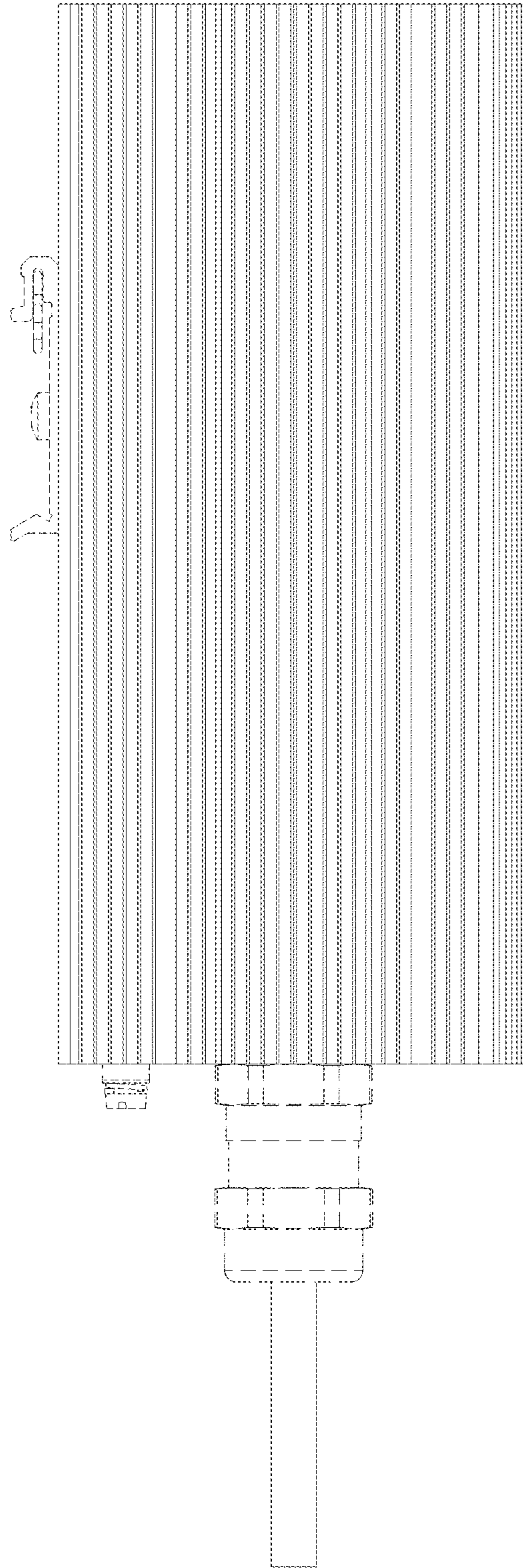

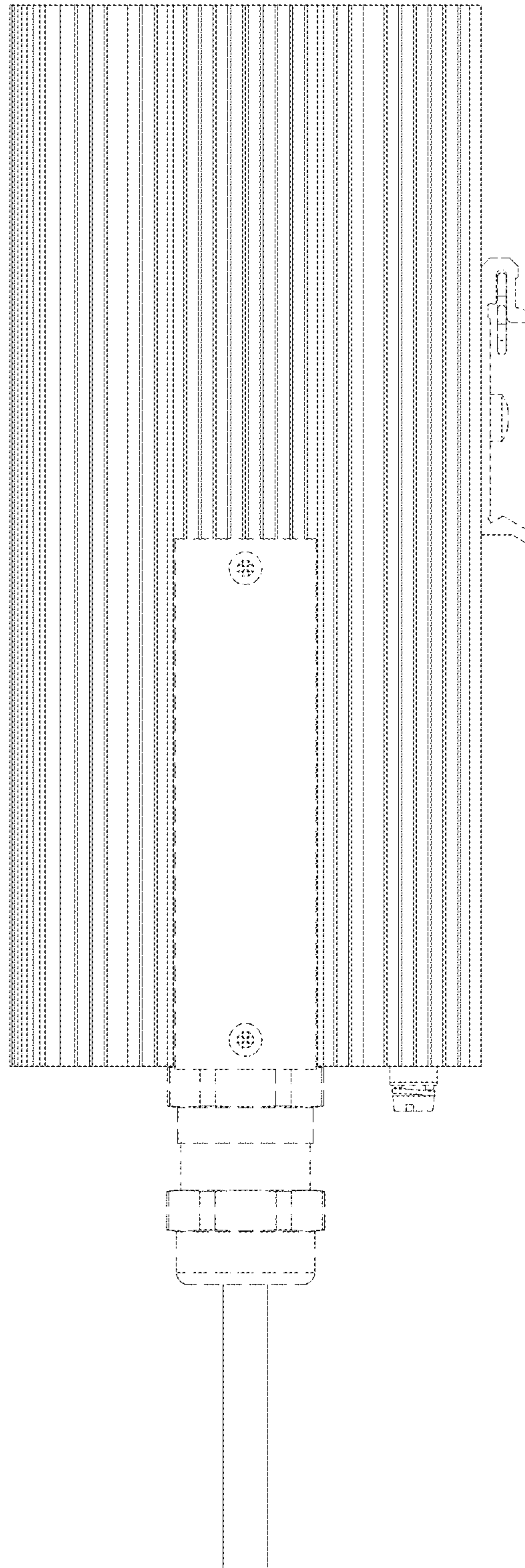

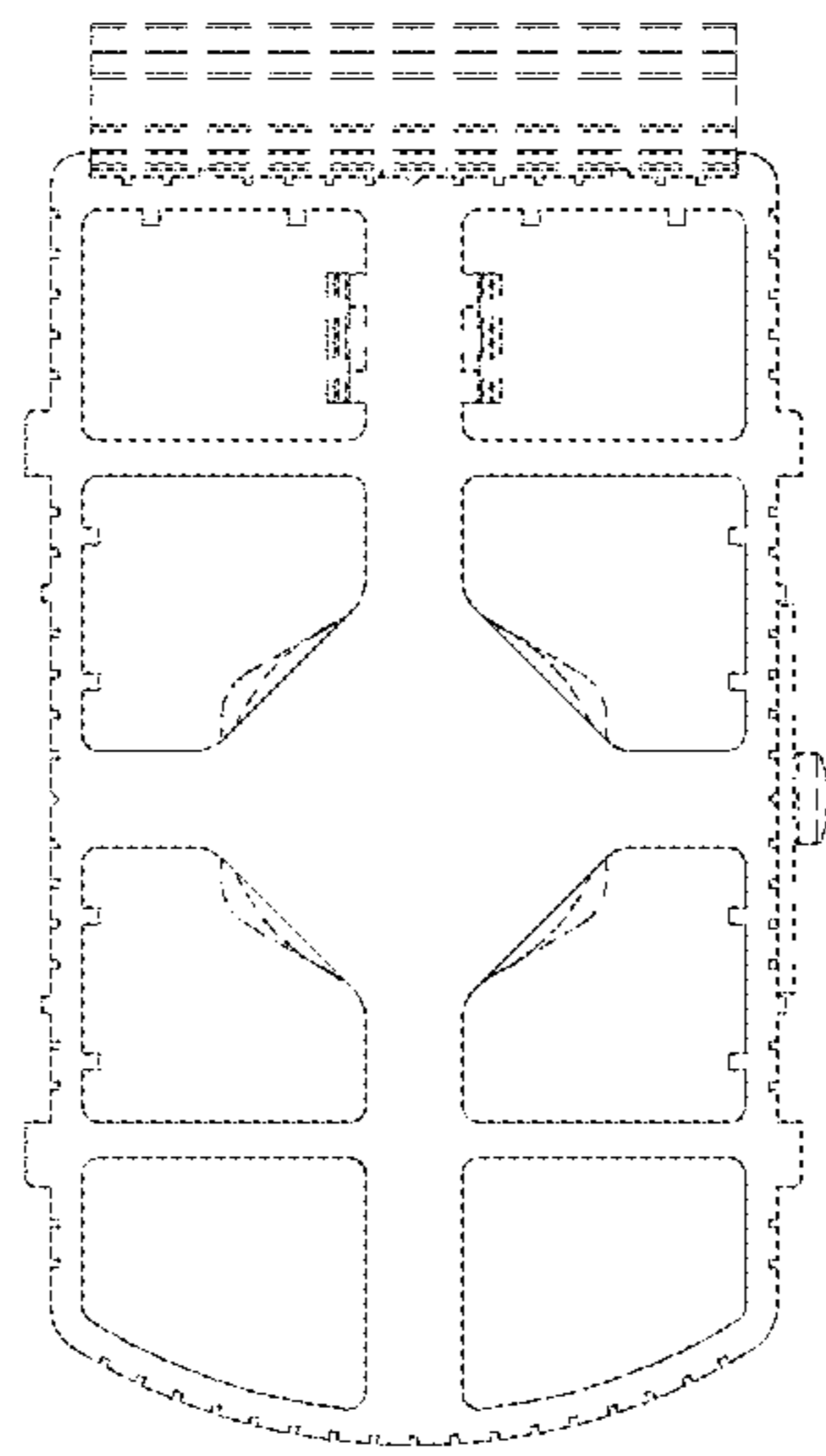

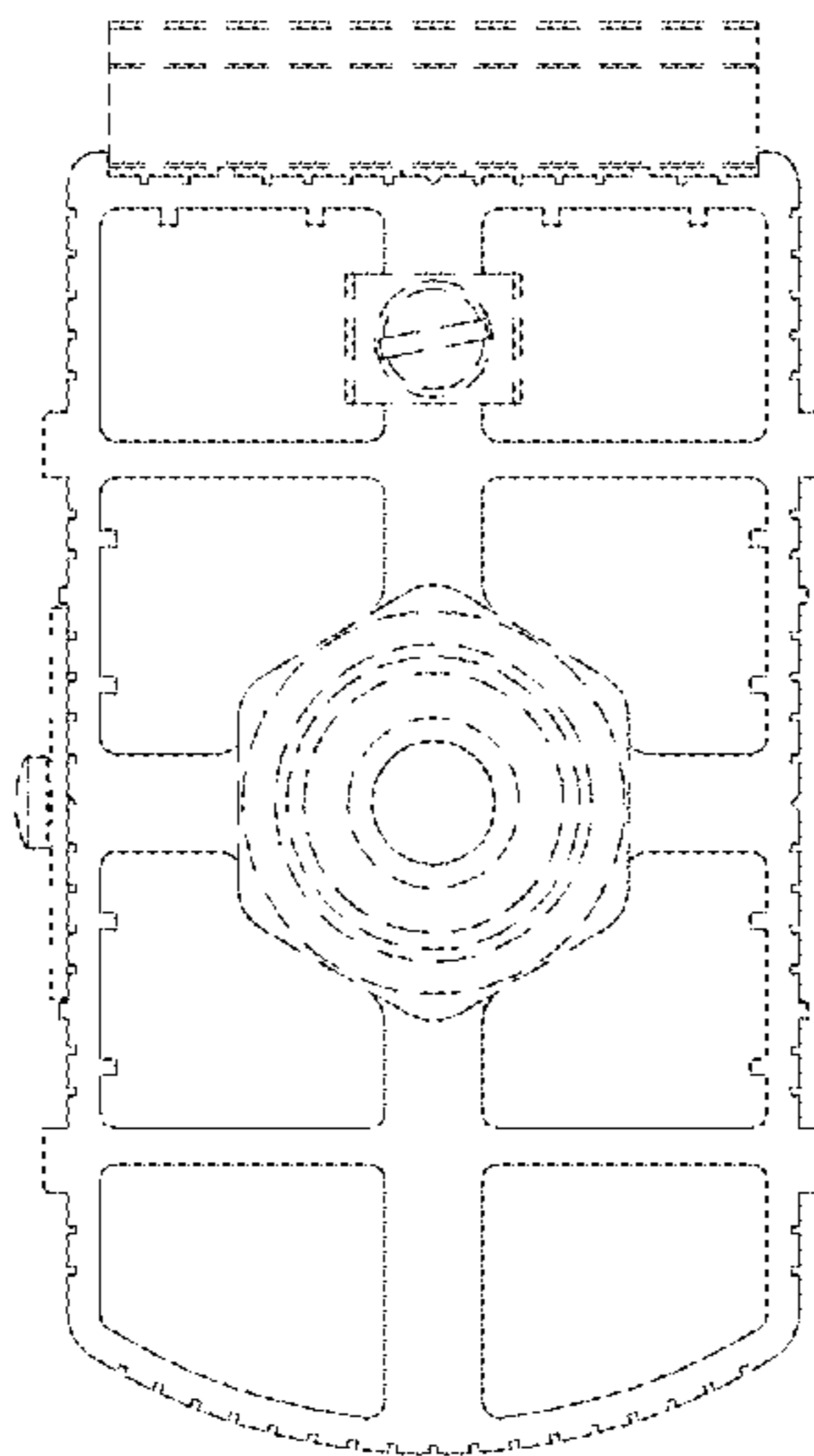

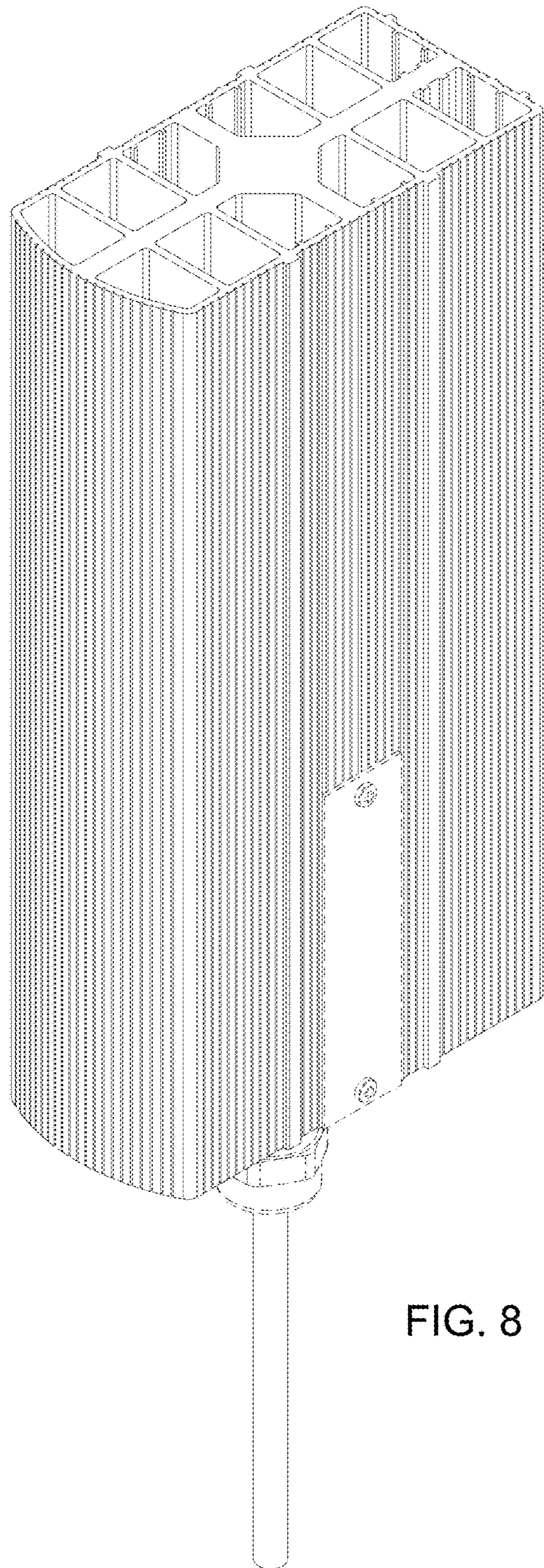

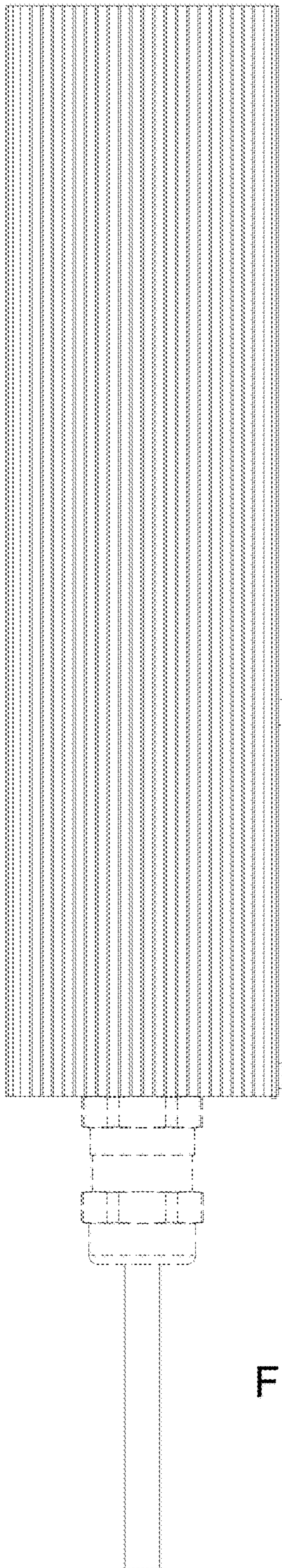

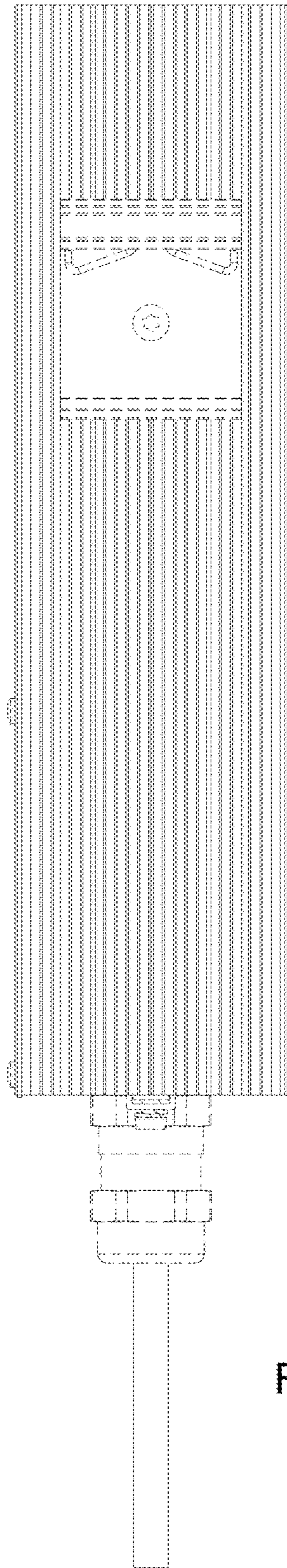

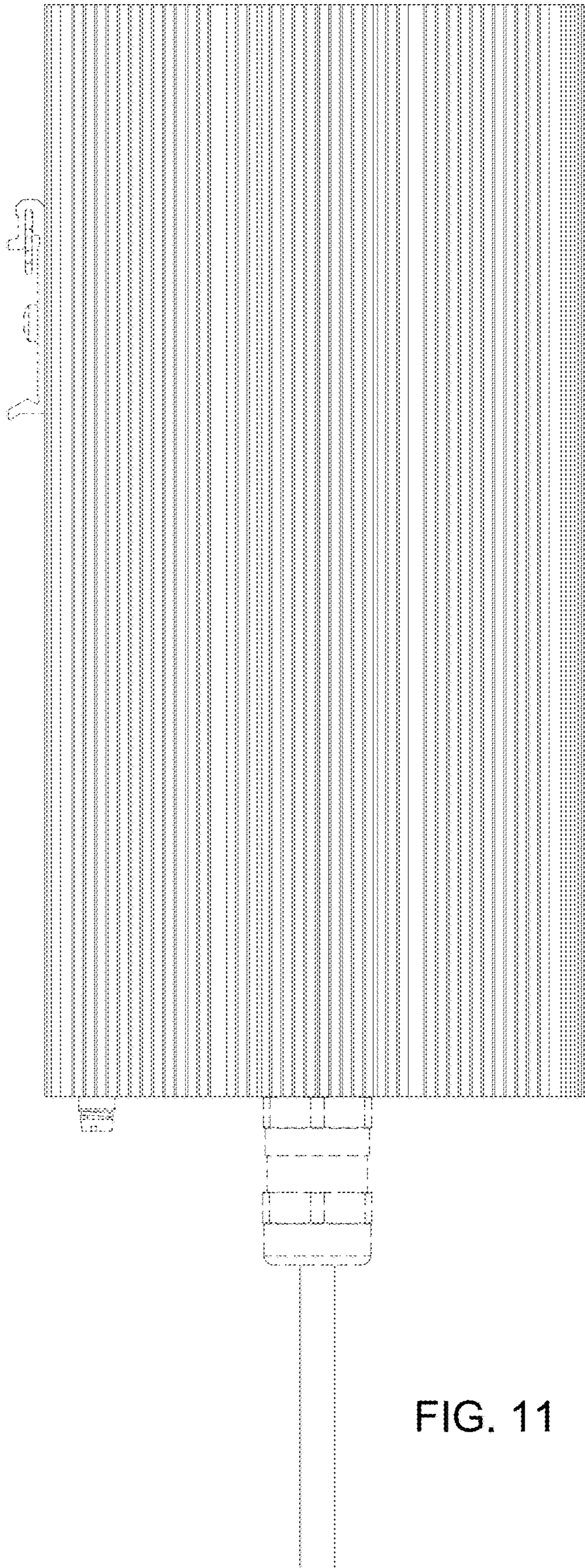
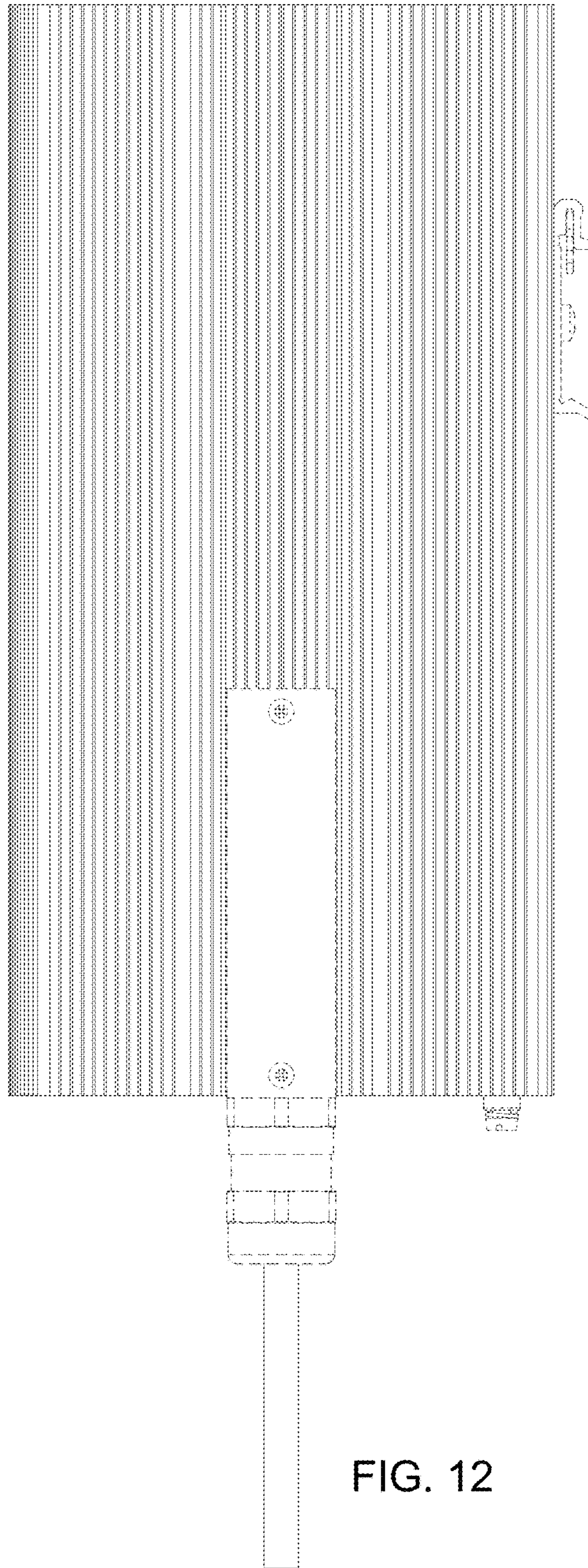

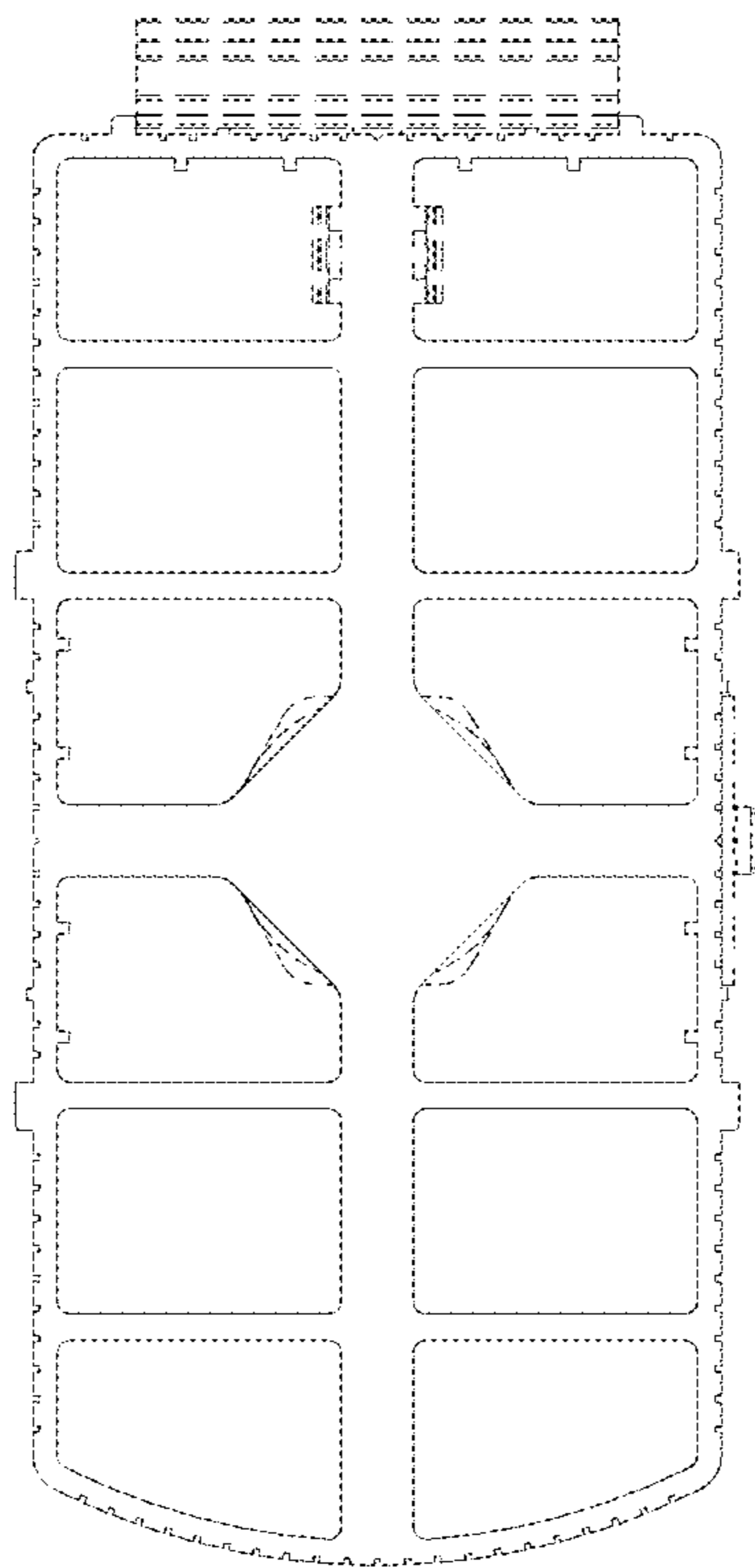

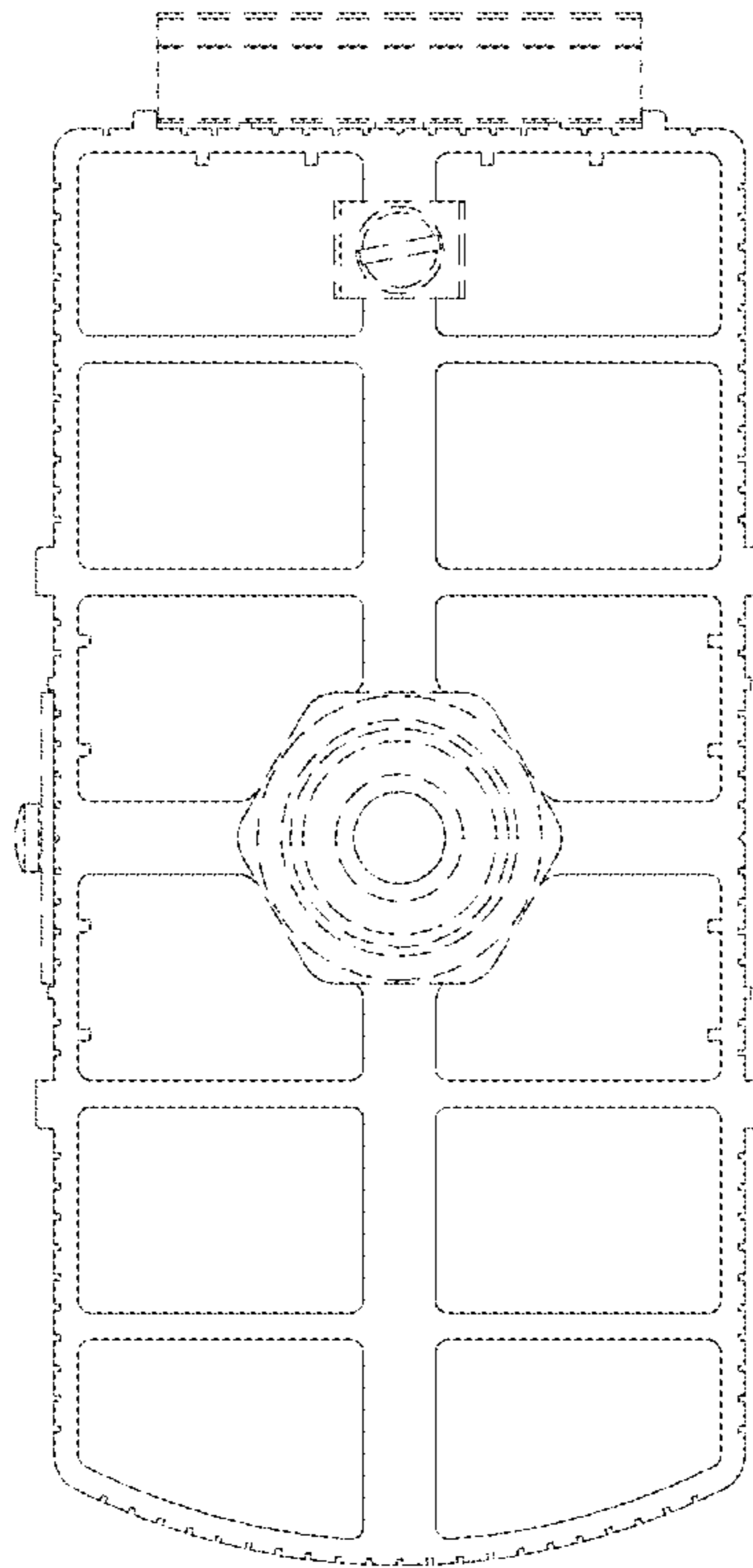

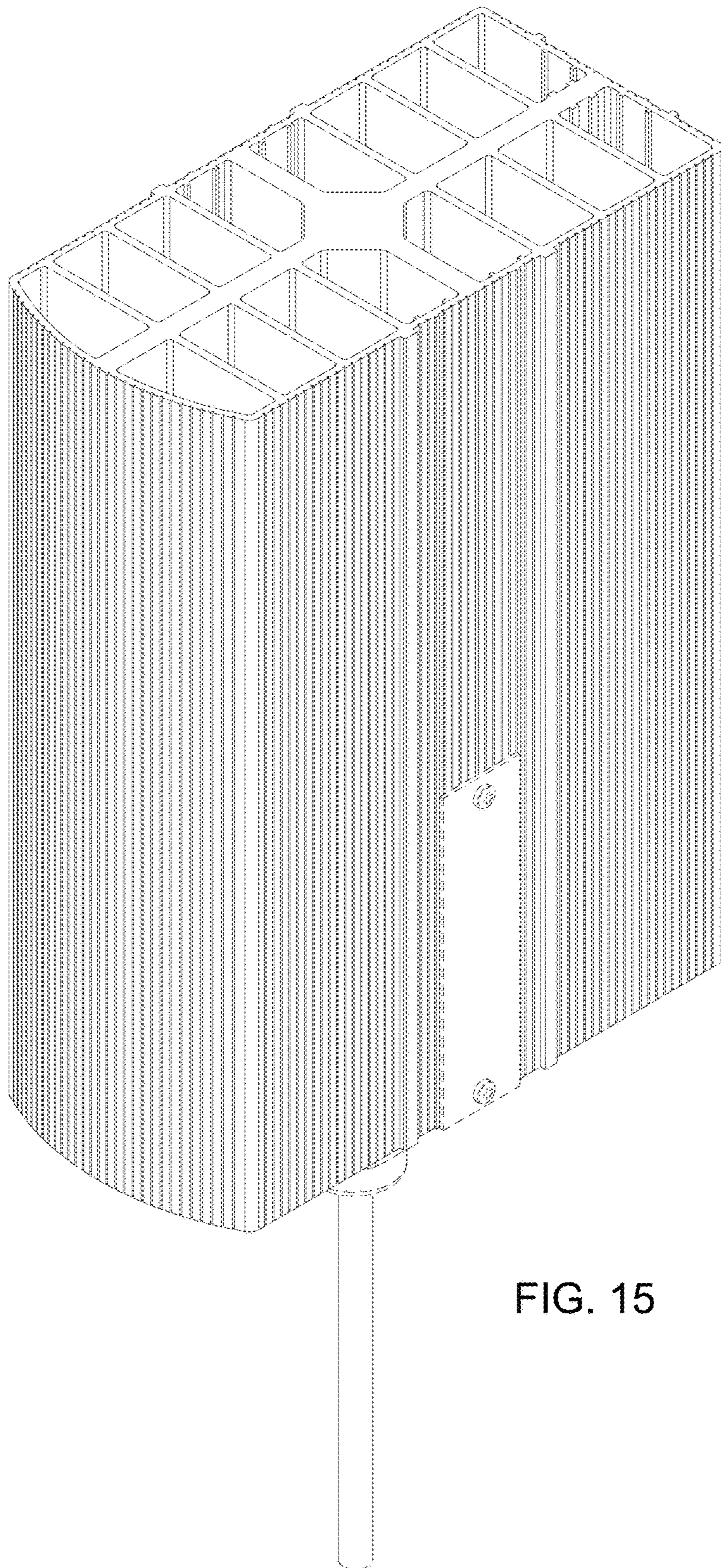

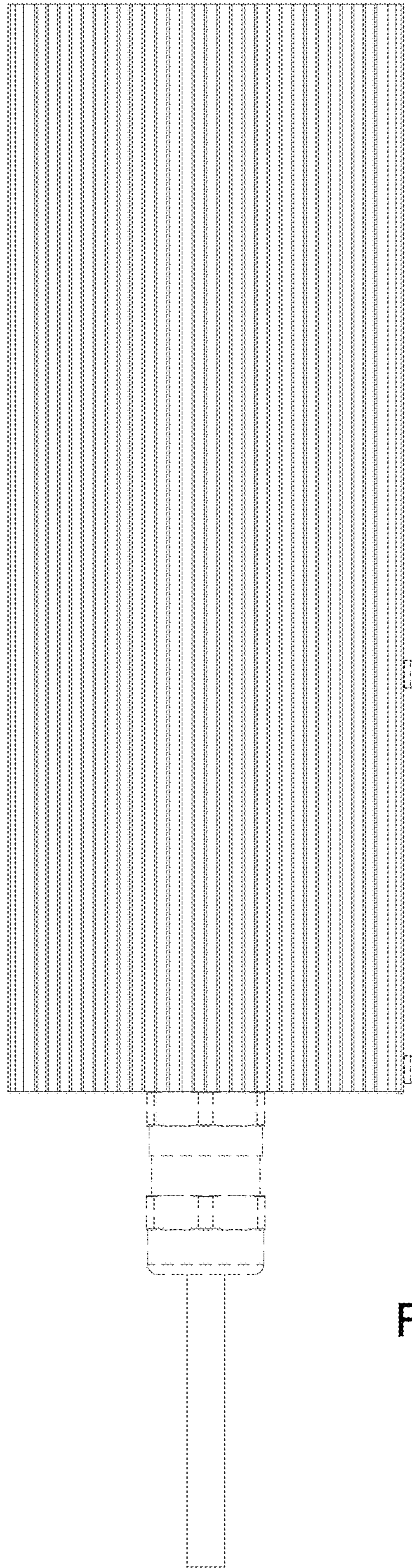

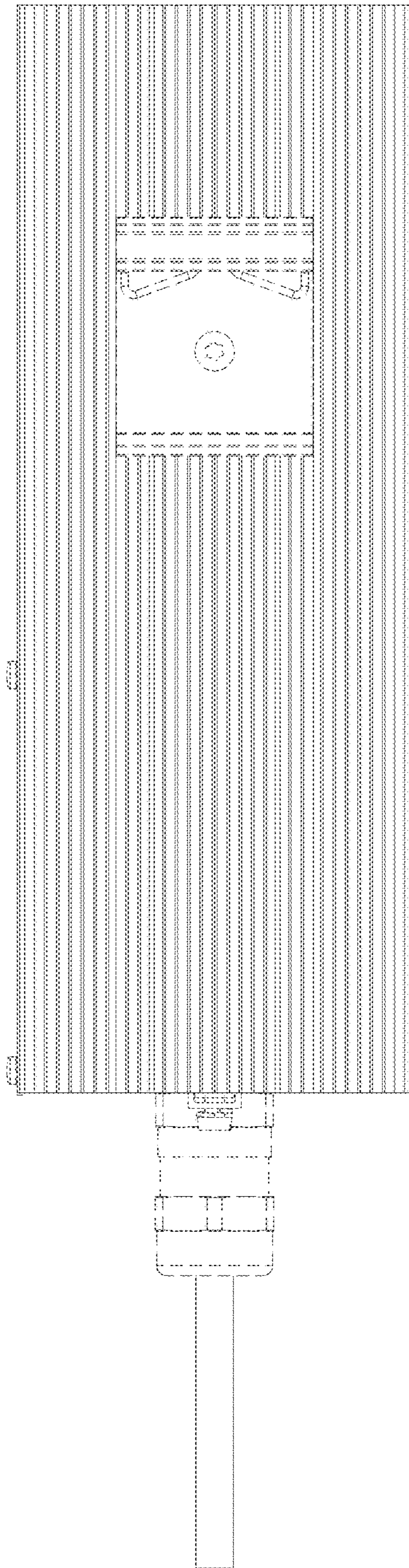

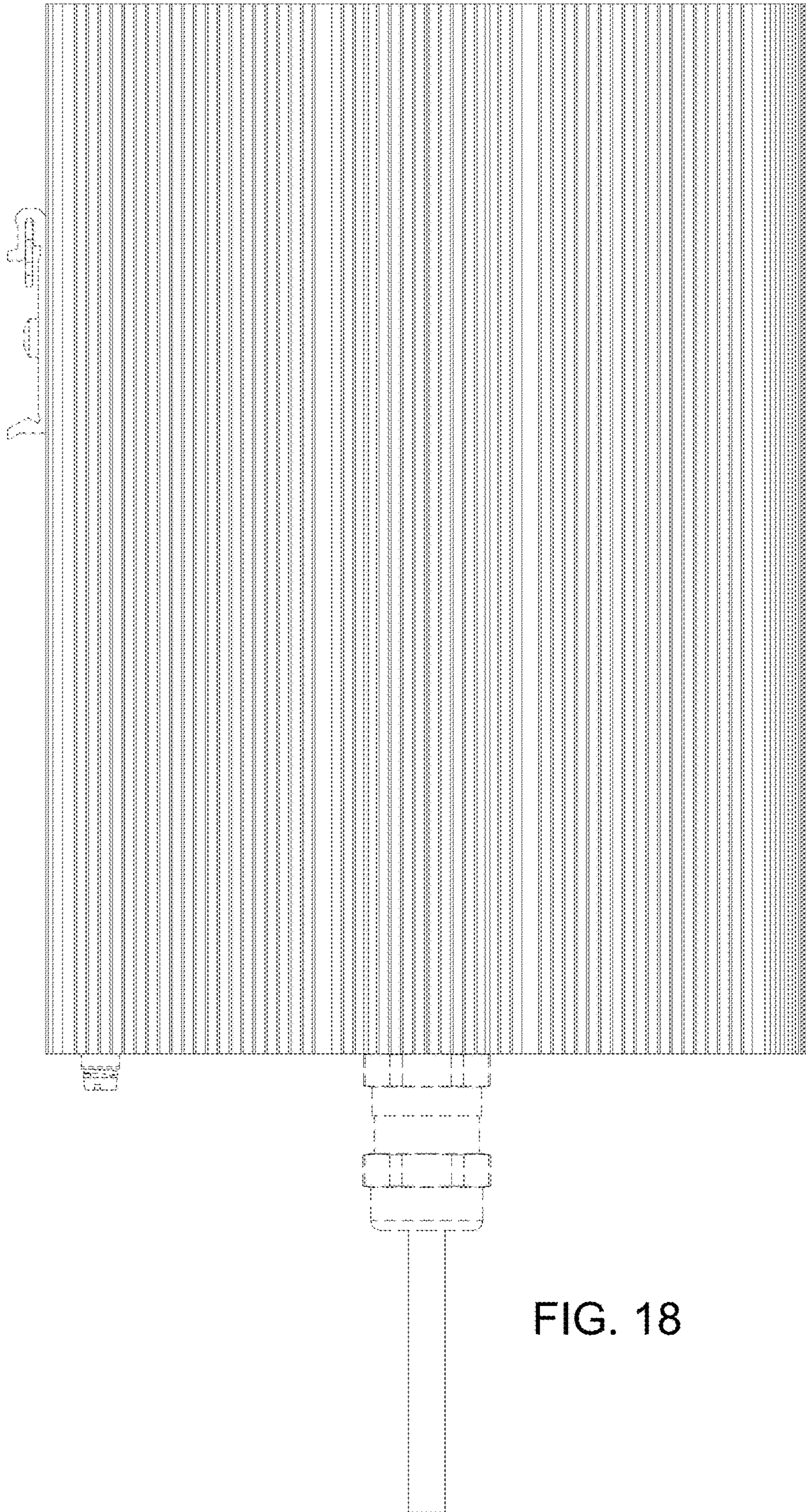

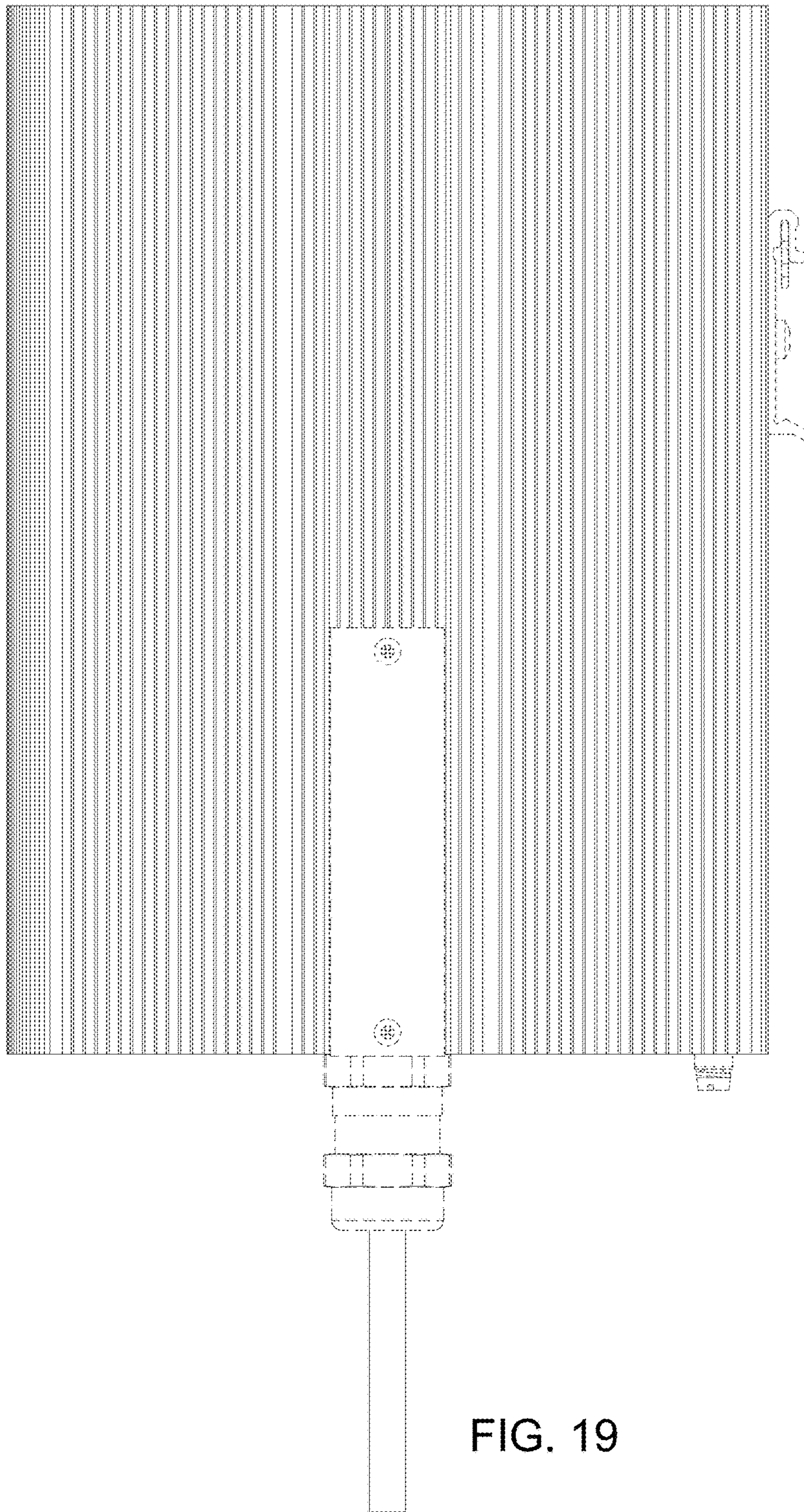

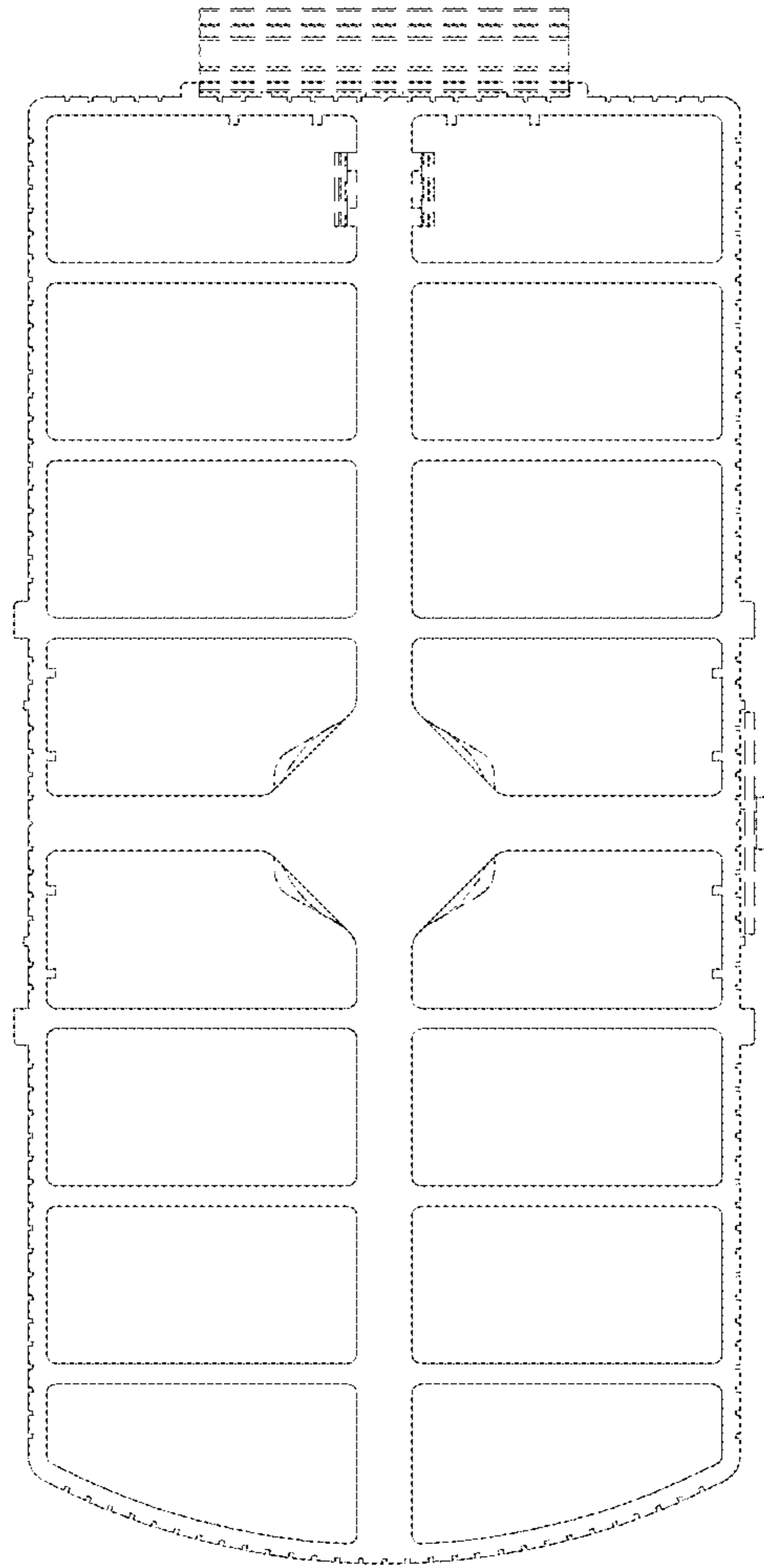

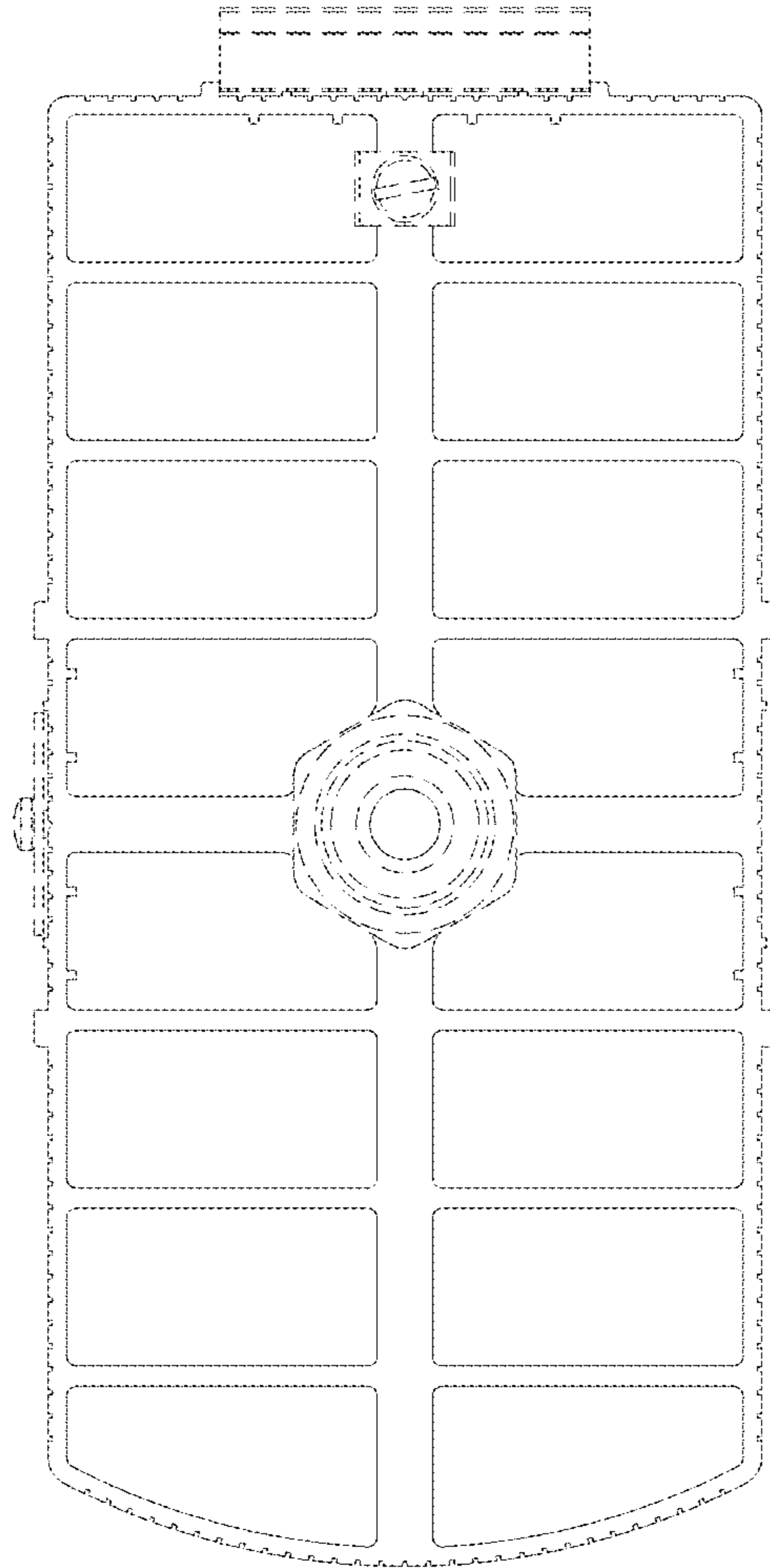
