The ornamental design for grille, as shown and described.

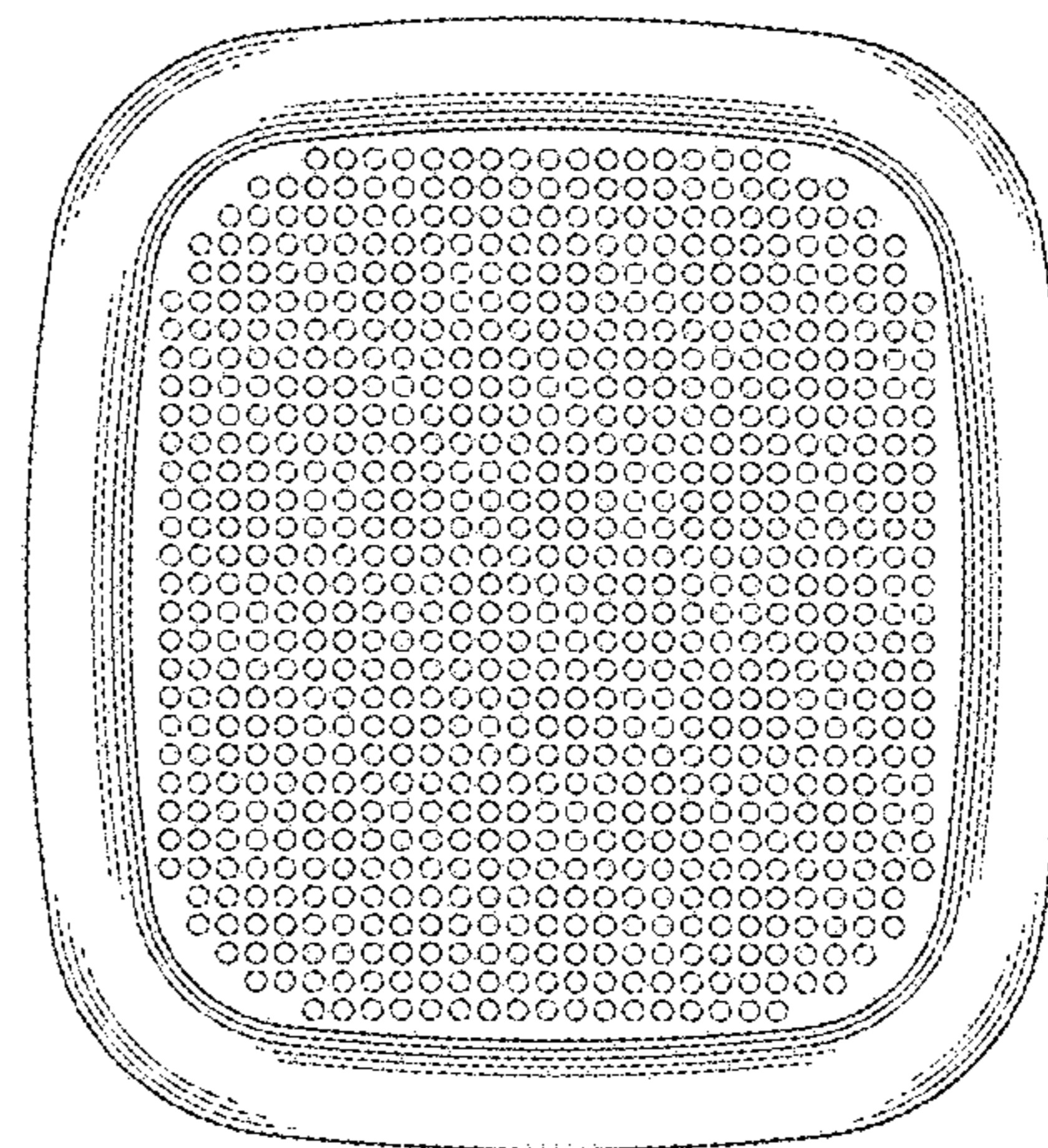
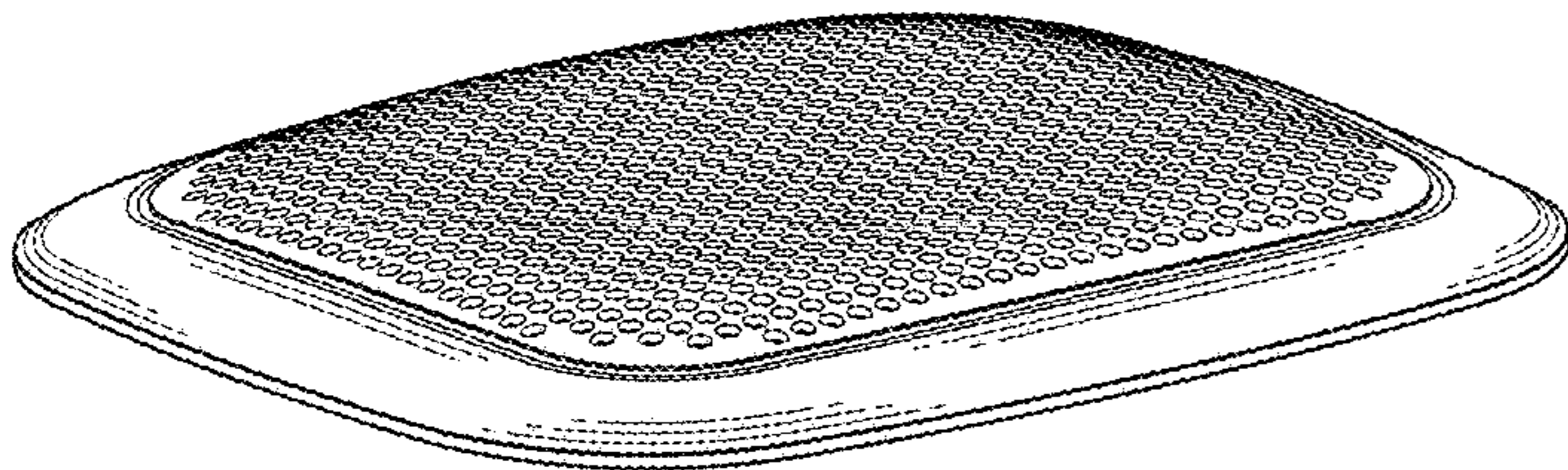
**DESCRIPTION**

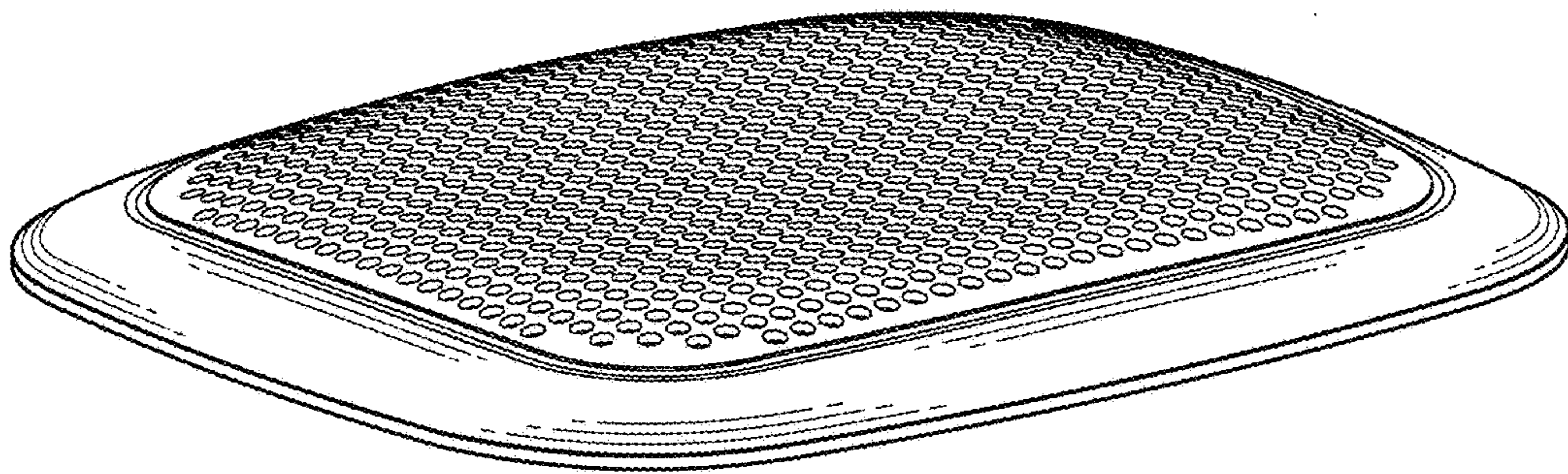

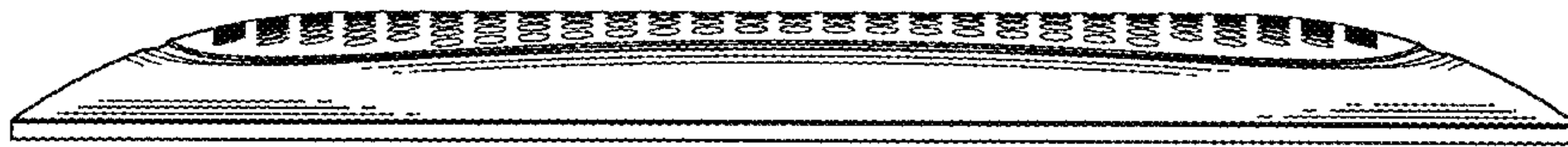

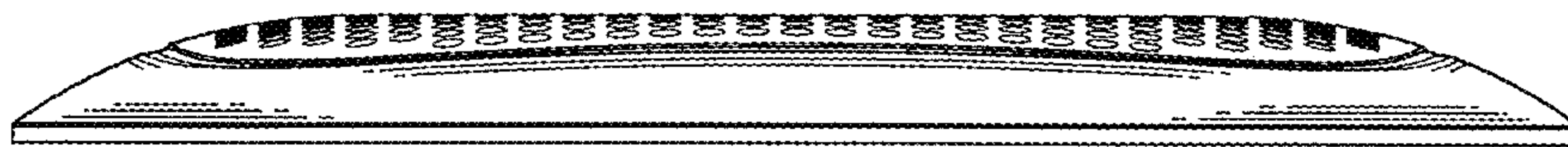

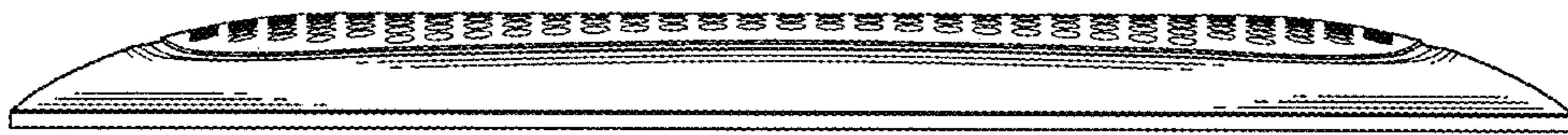

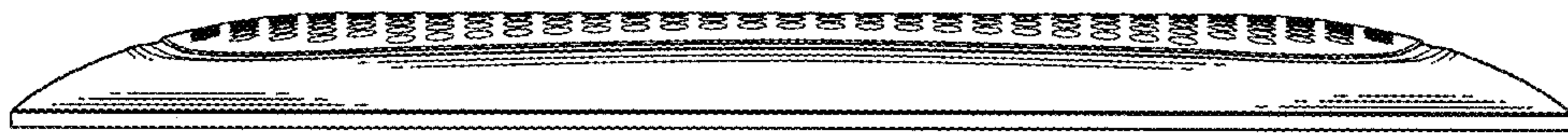

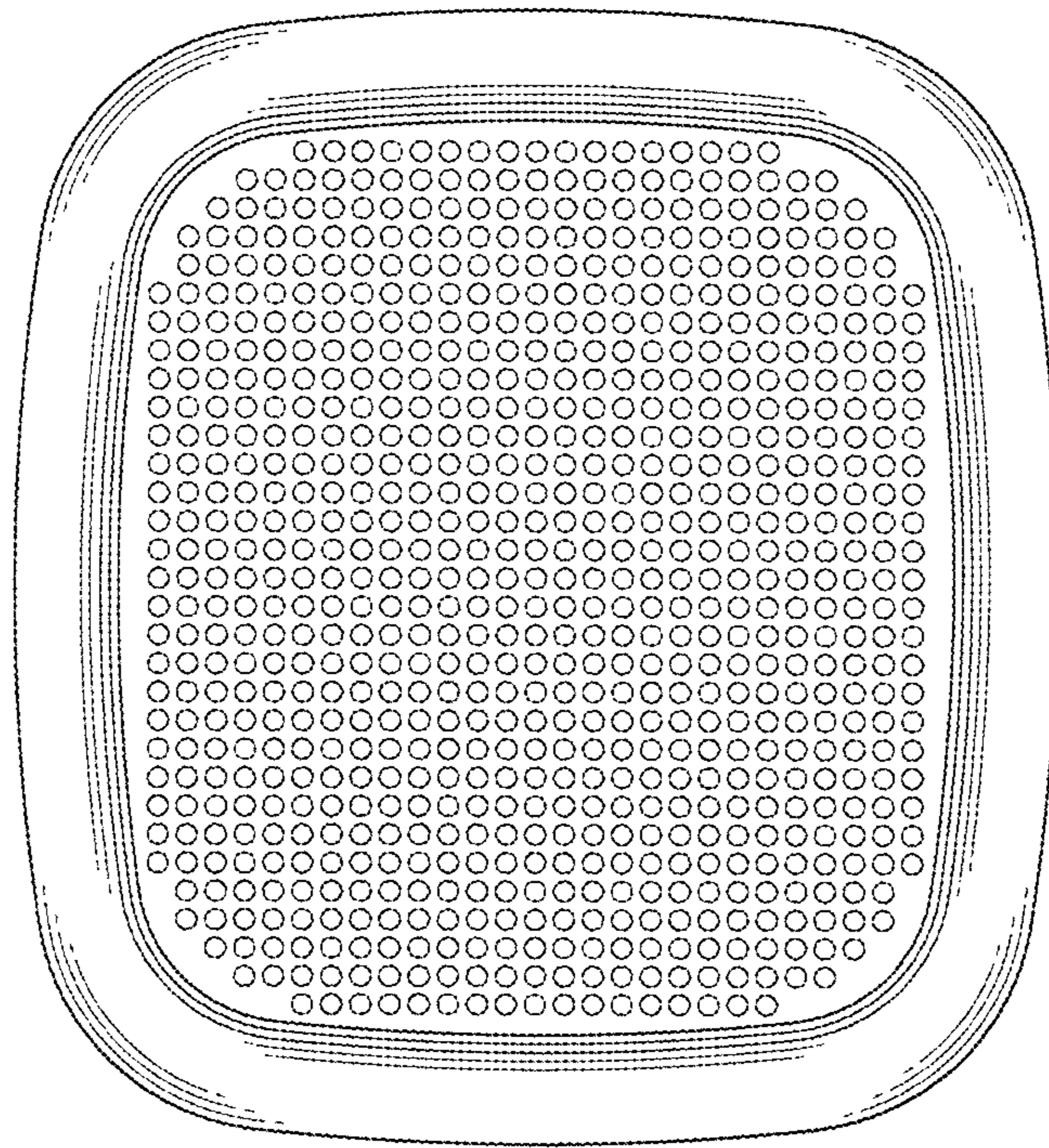
